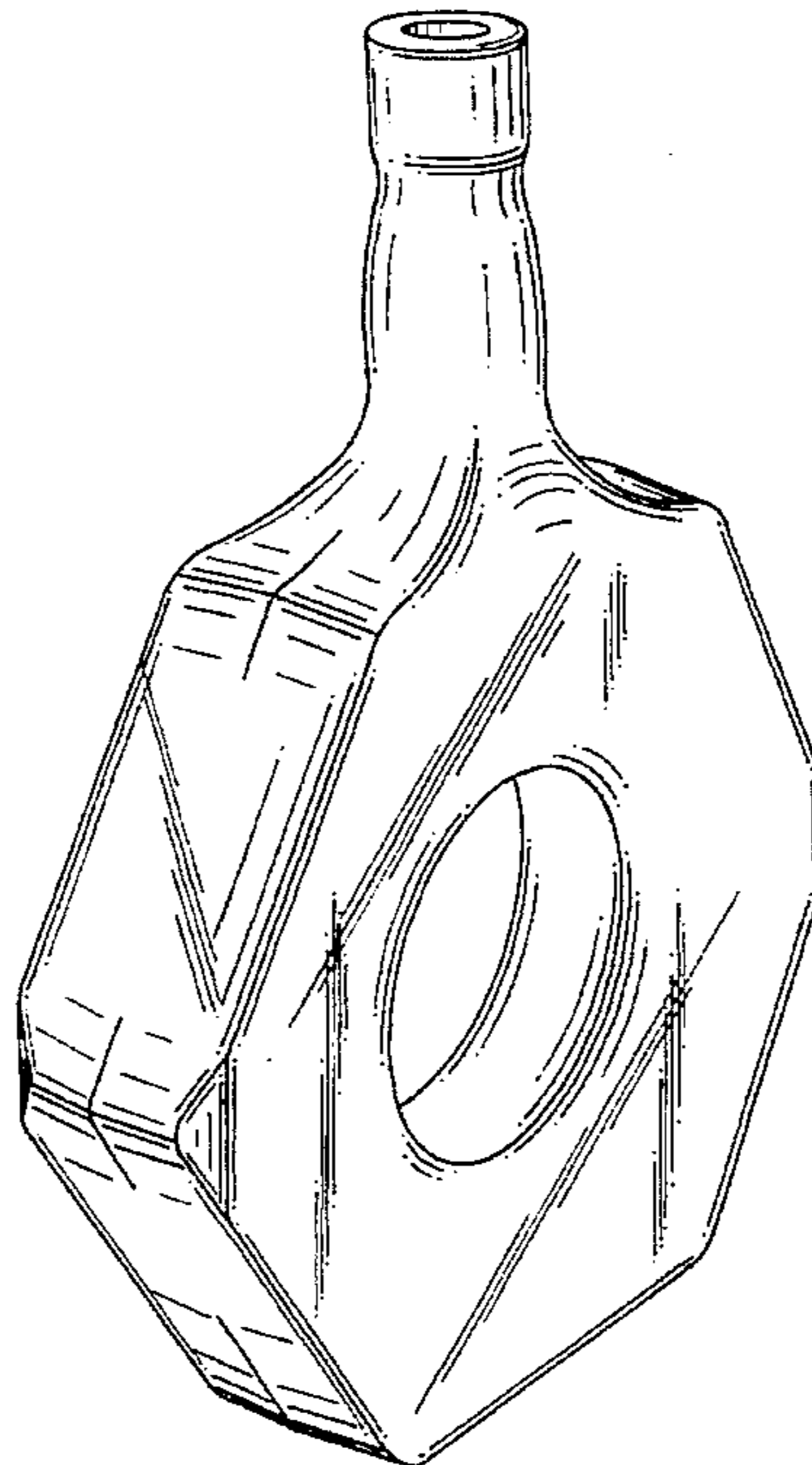
[57] **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bottle showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a front elevational view thereof, the rear elevational view being a mirror image; and,  
FIG. 5 is a left end elevational view thereof, the right end elevational view being a mirror image.

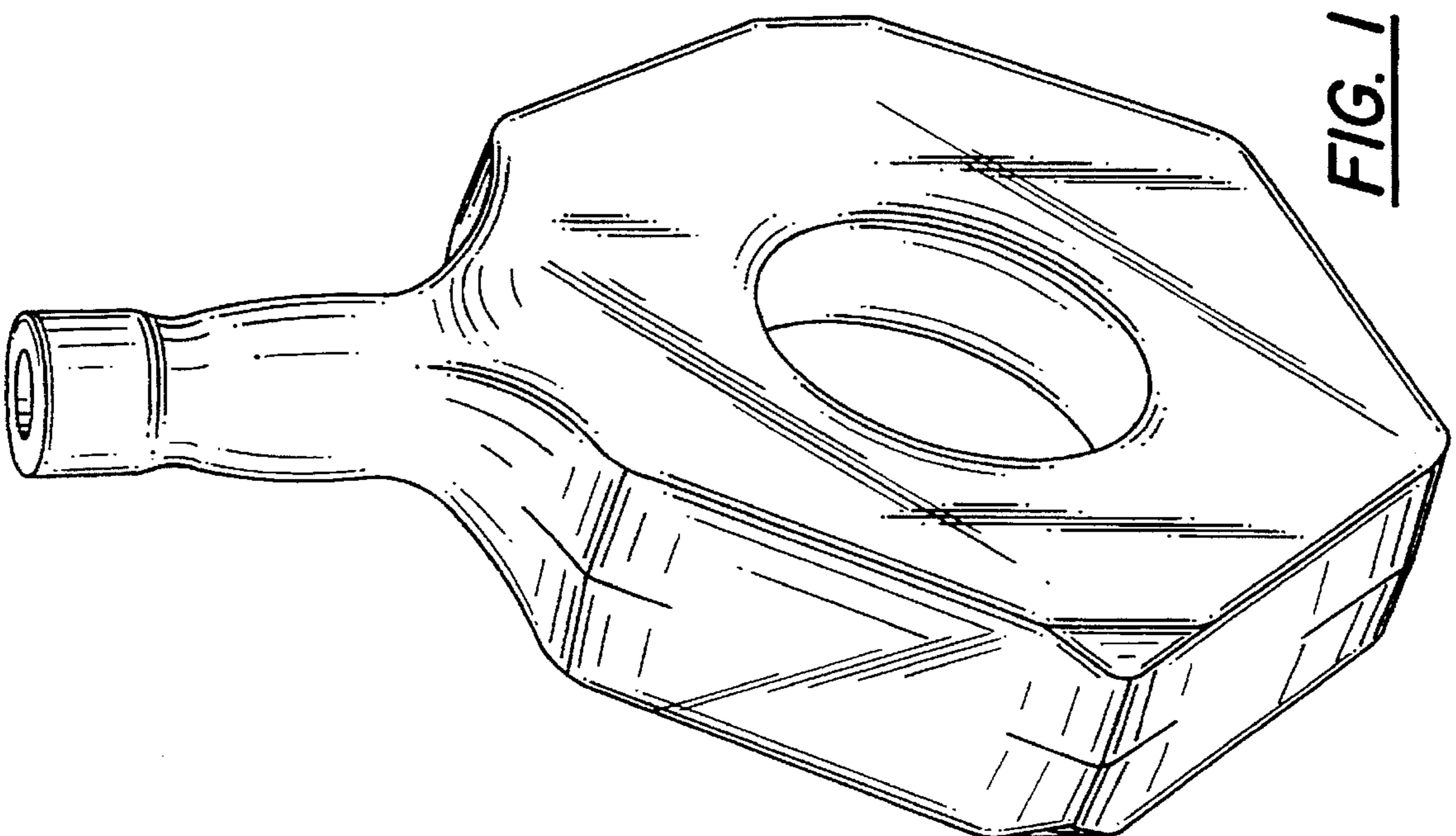

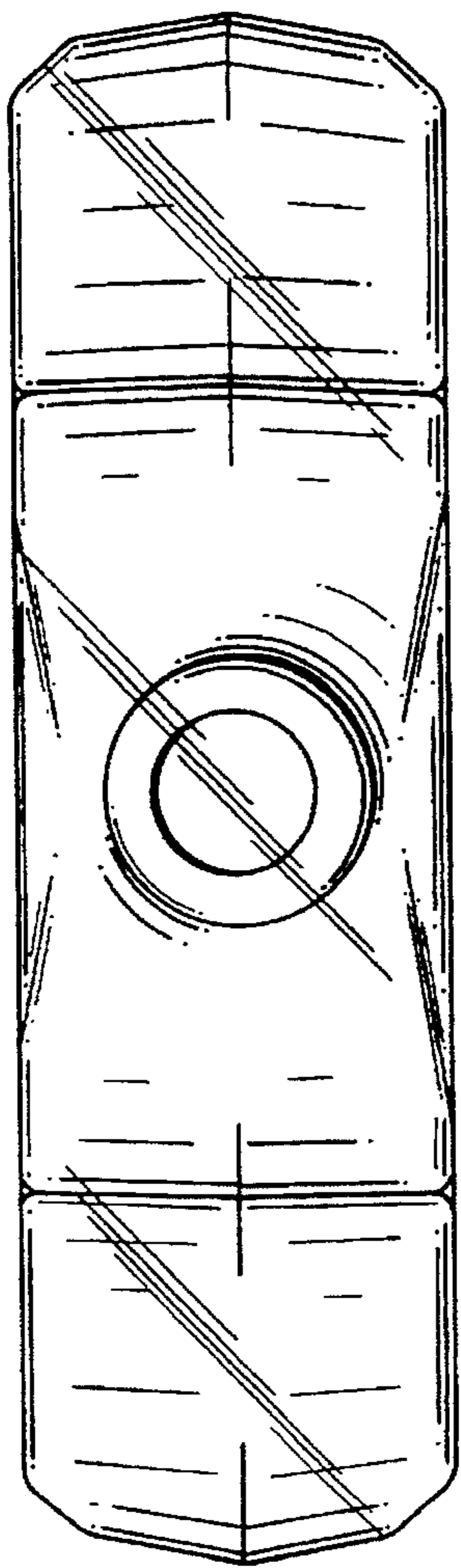

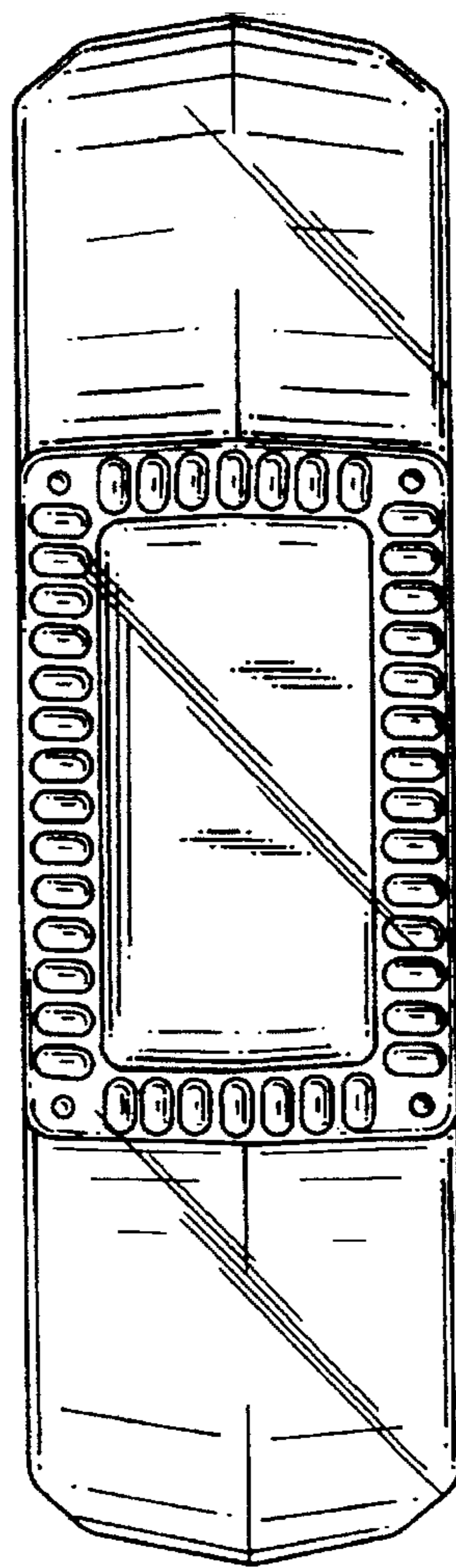

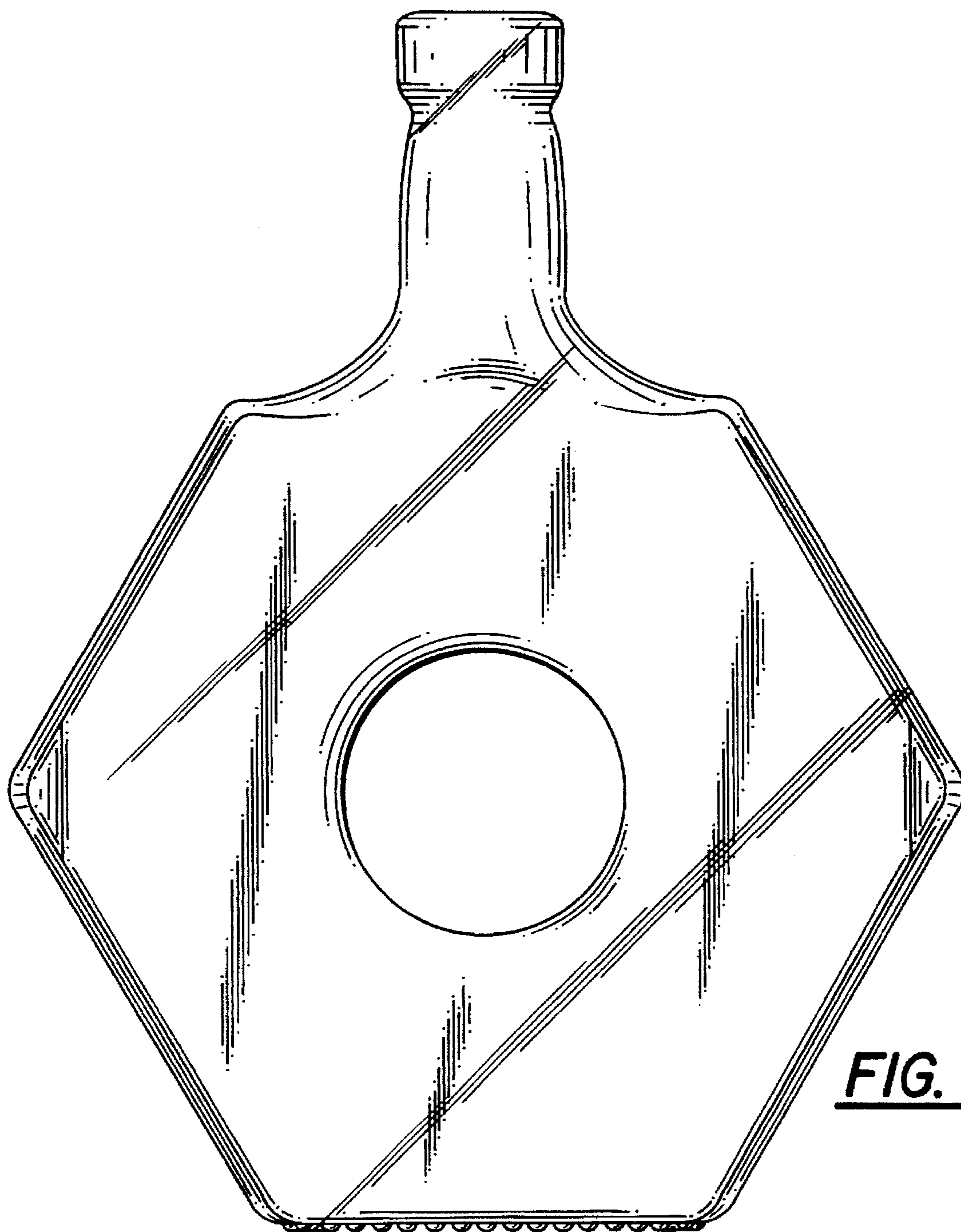

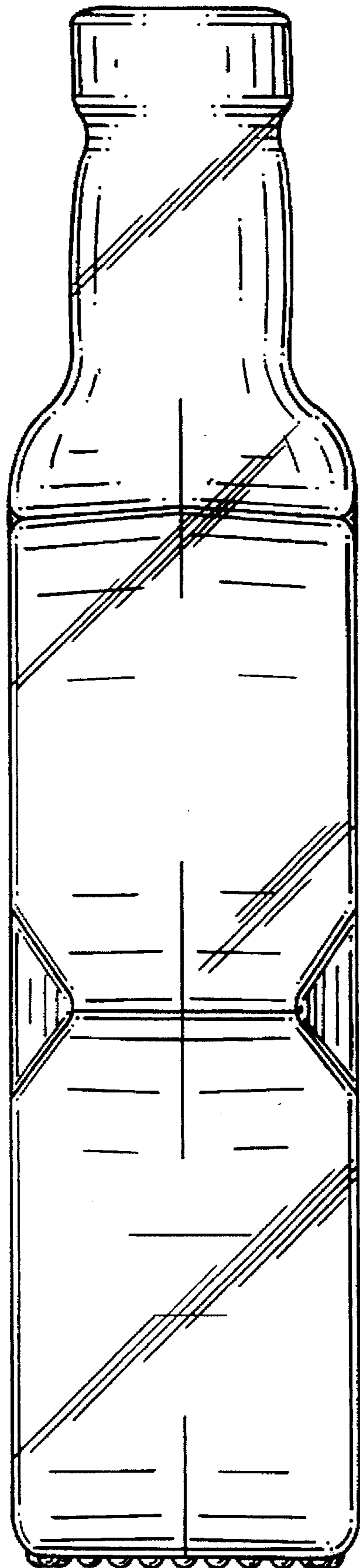
