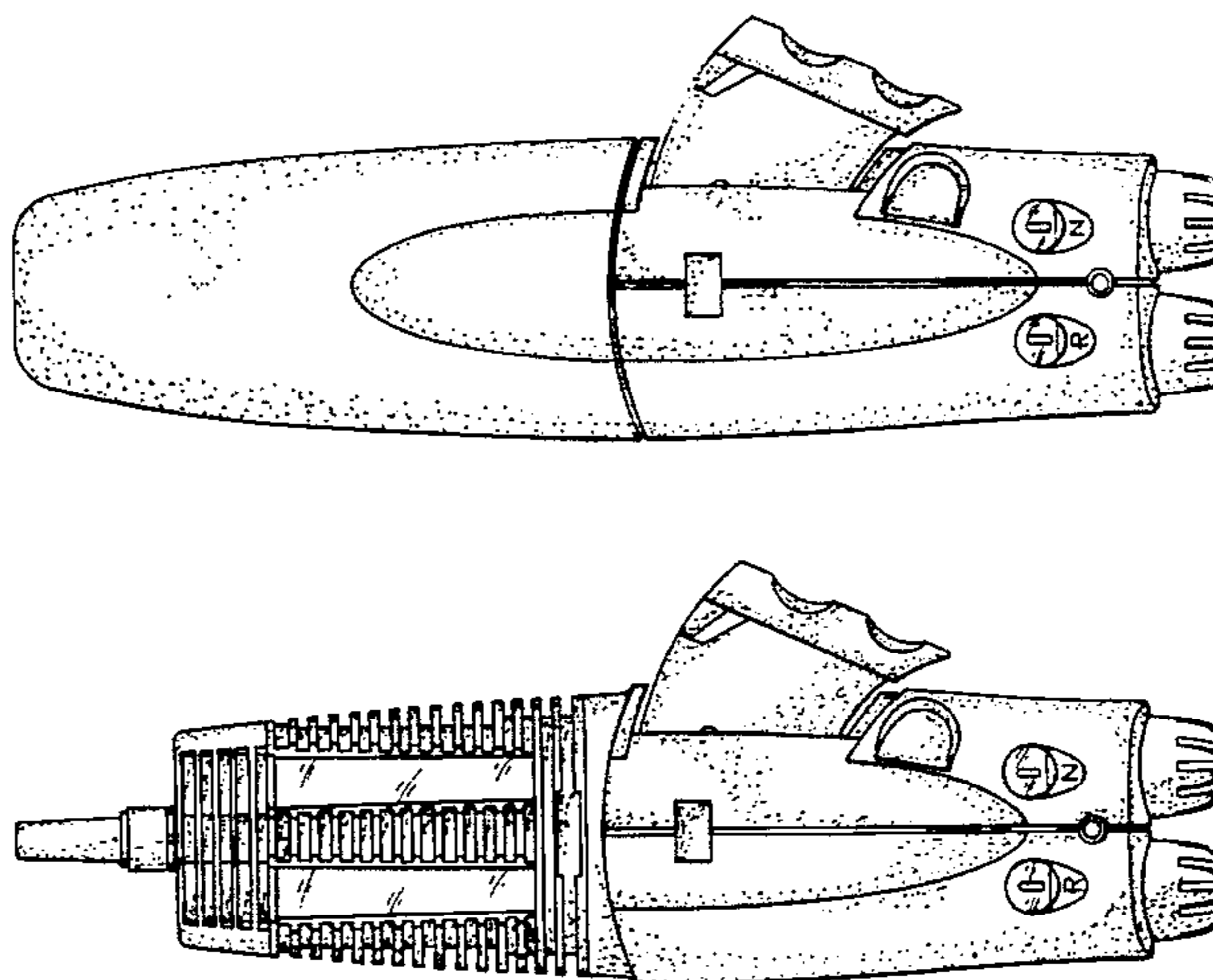
[57] **CLAIM**

The ornamental design for a multi-cartridge medication injector, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a multi-cartridge medication injector with the actuator lever in a cocked position showing our new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a side view thereof;
FIG. 4 is a side view thereof as seen from the side opposite of FIG. 3;
FIG. 5 is a rear end view thereof;
FIG. 6 is a top plan view of a multi-cartridge medication injector with the actuator lever closed;
FIG. 7 is a bottom view thereof;
FIG. 8 is a side view thereof;
FIG. 9 is a top plan view of a multi-cartridge medication injector with the cap removed;
FIG. 10 is a front end view thereof;
FIG. 11 is a bottom view thereof;
FIG. 12 is a side view thereof; and,
FIG. 13 is a side view thereof as seen from the side opposite of FIG. 12 .

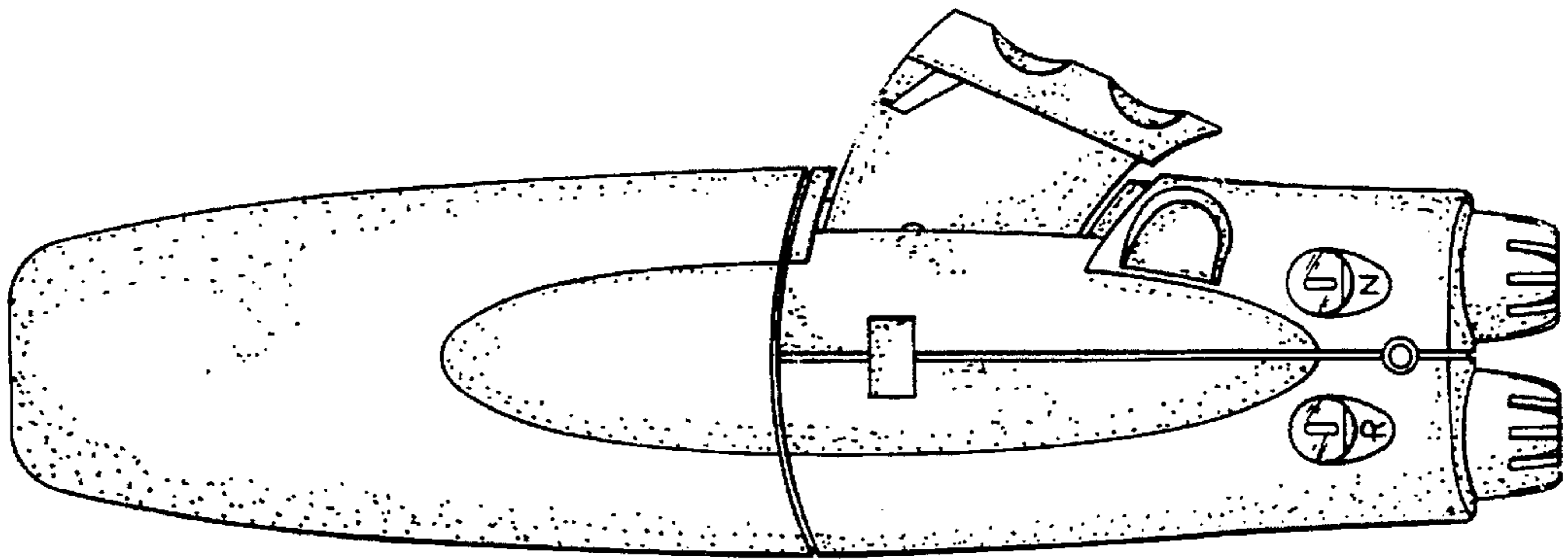

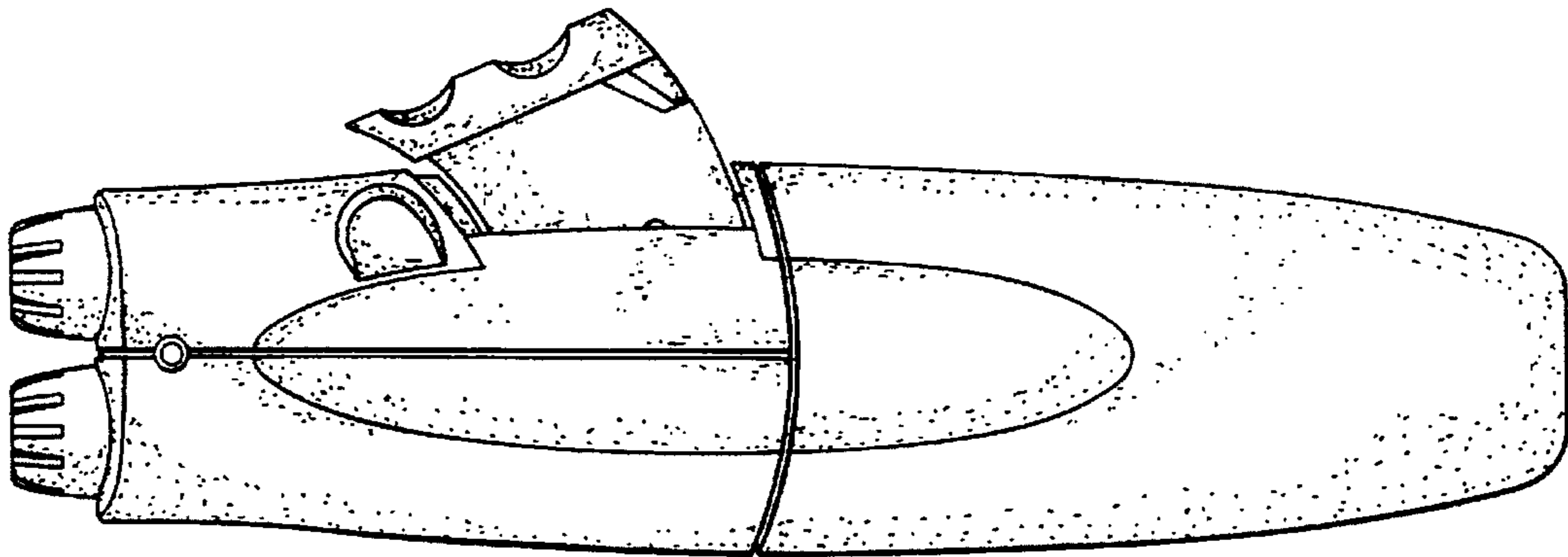

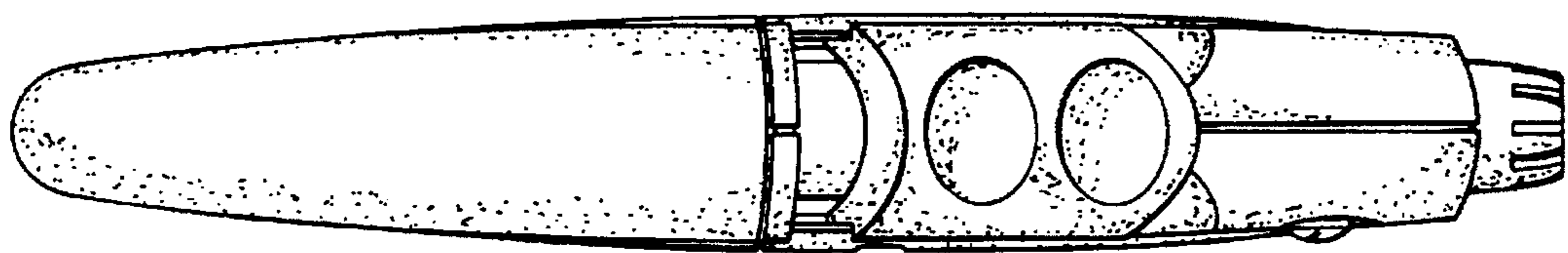

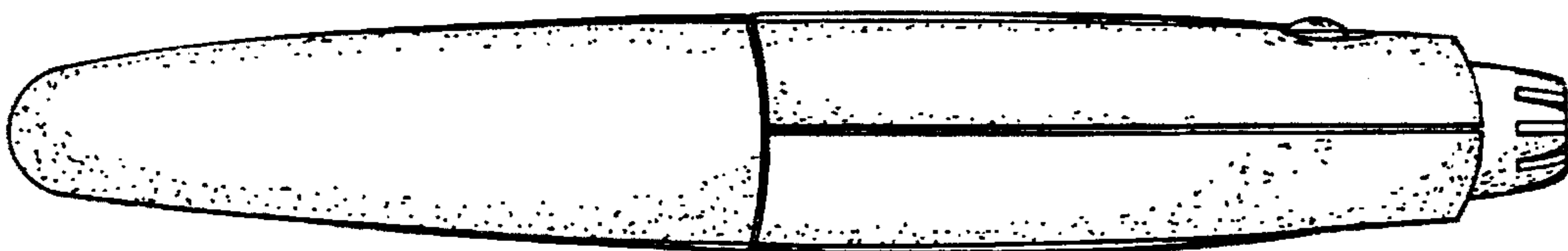

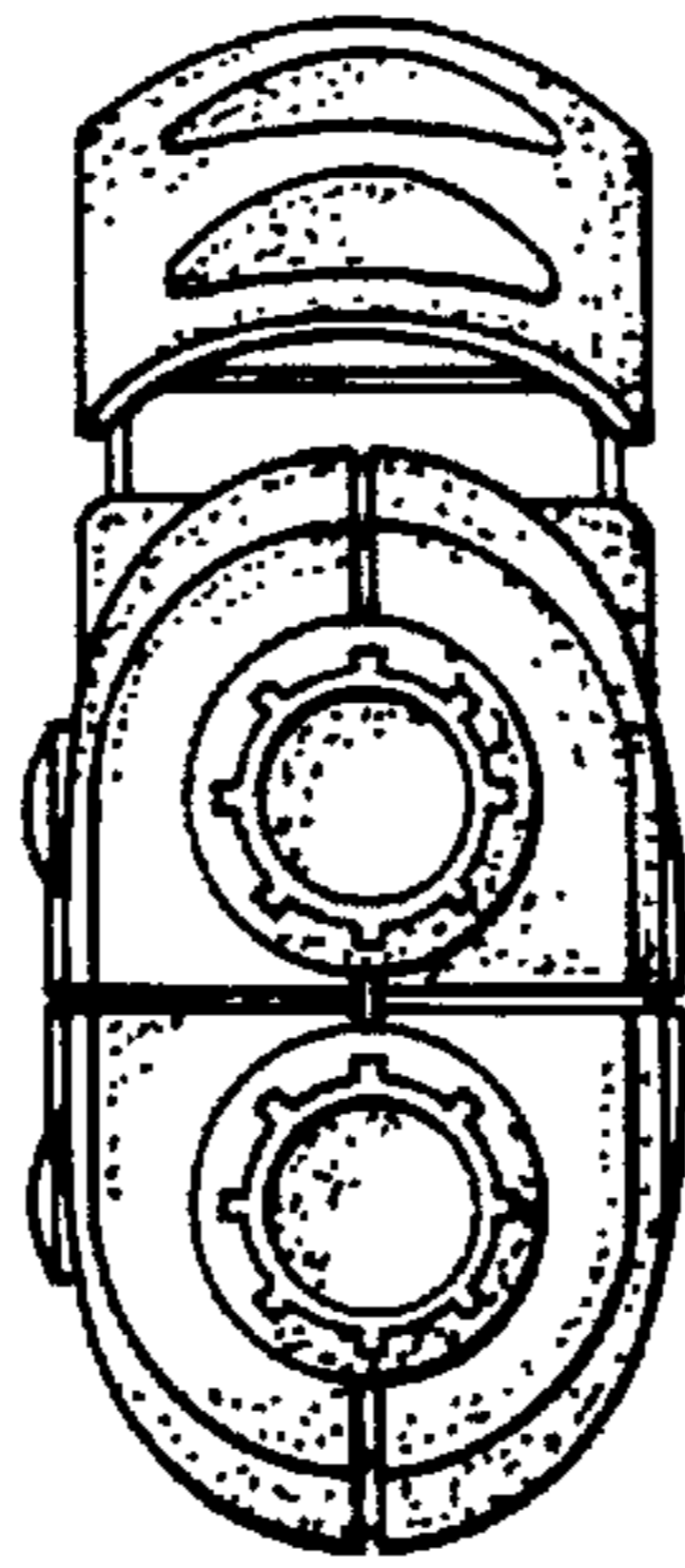

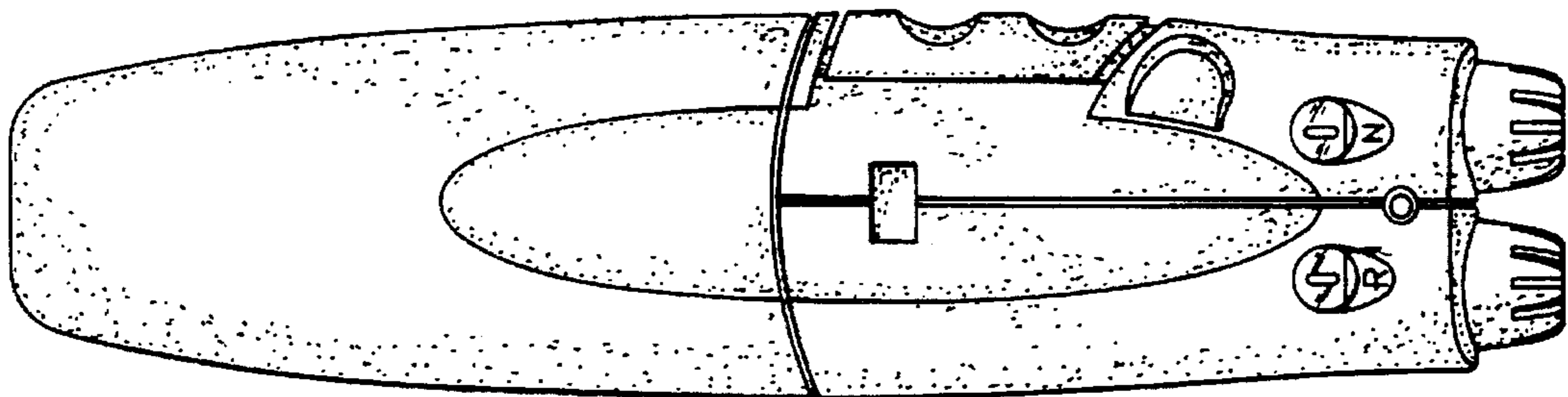

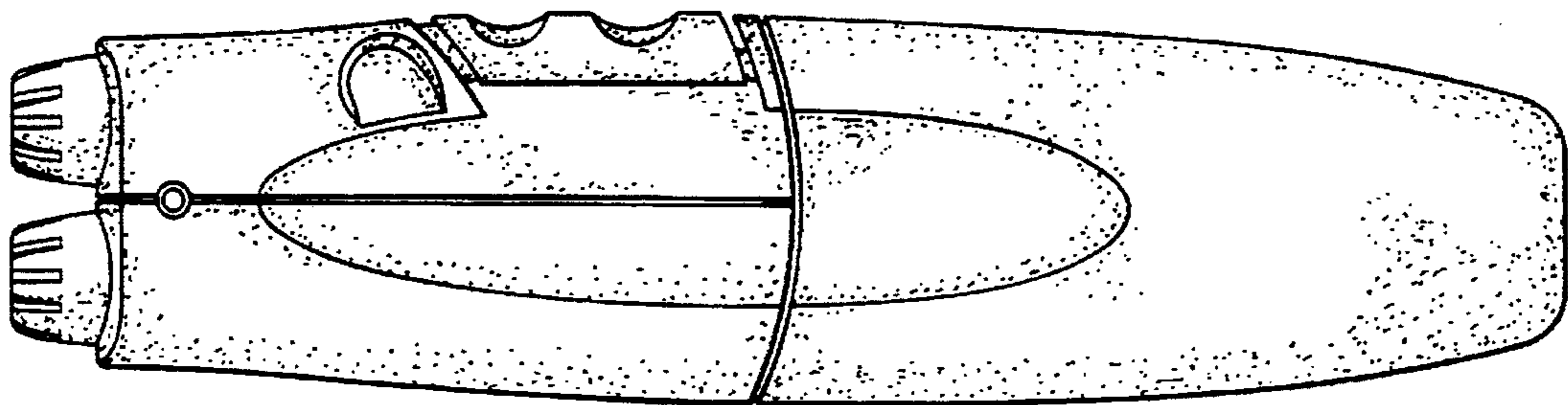

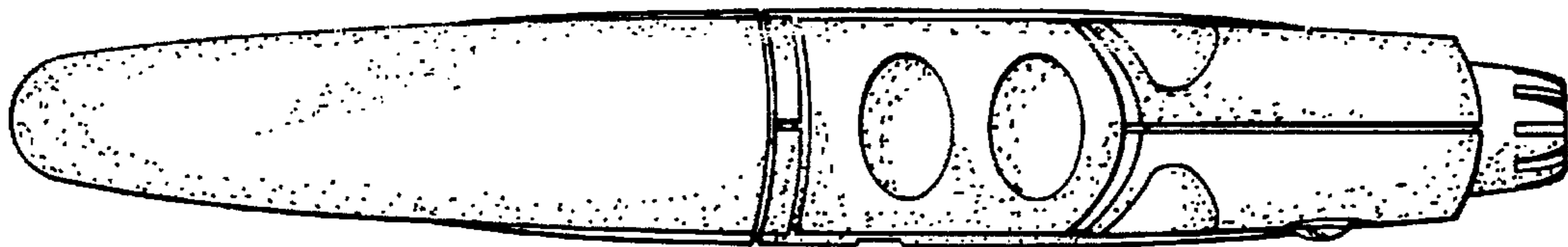

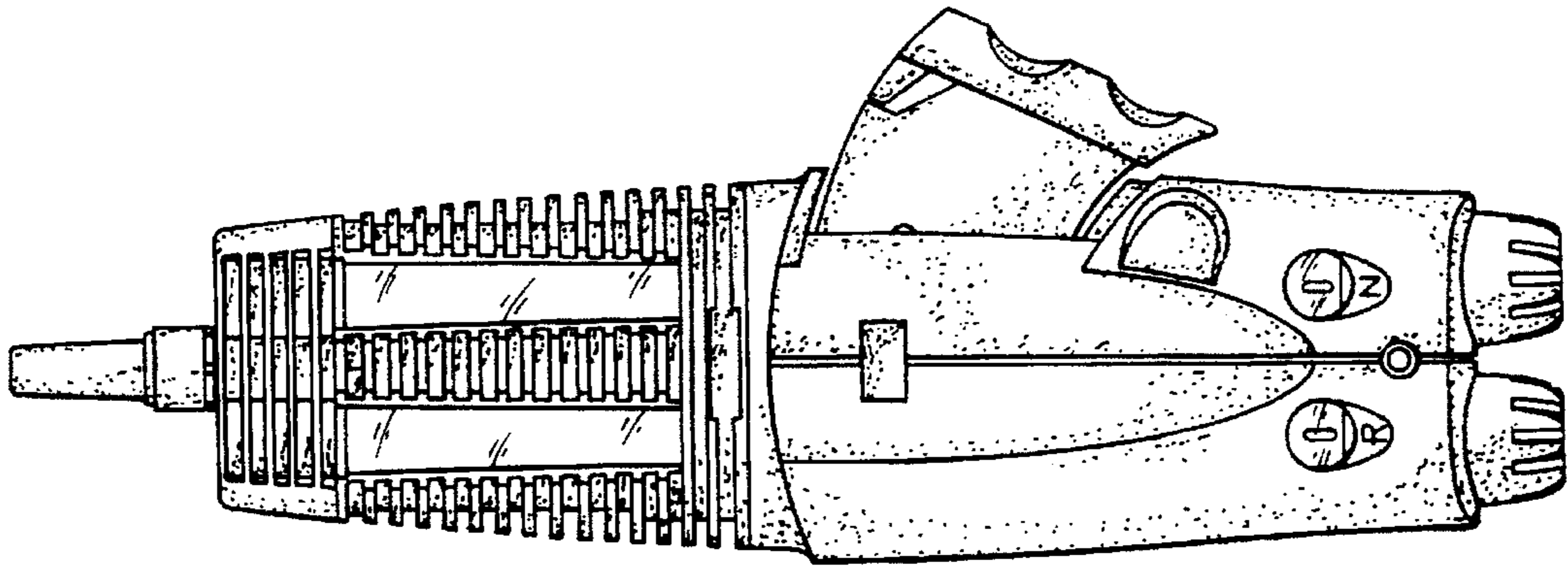

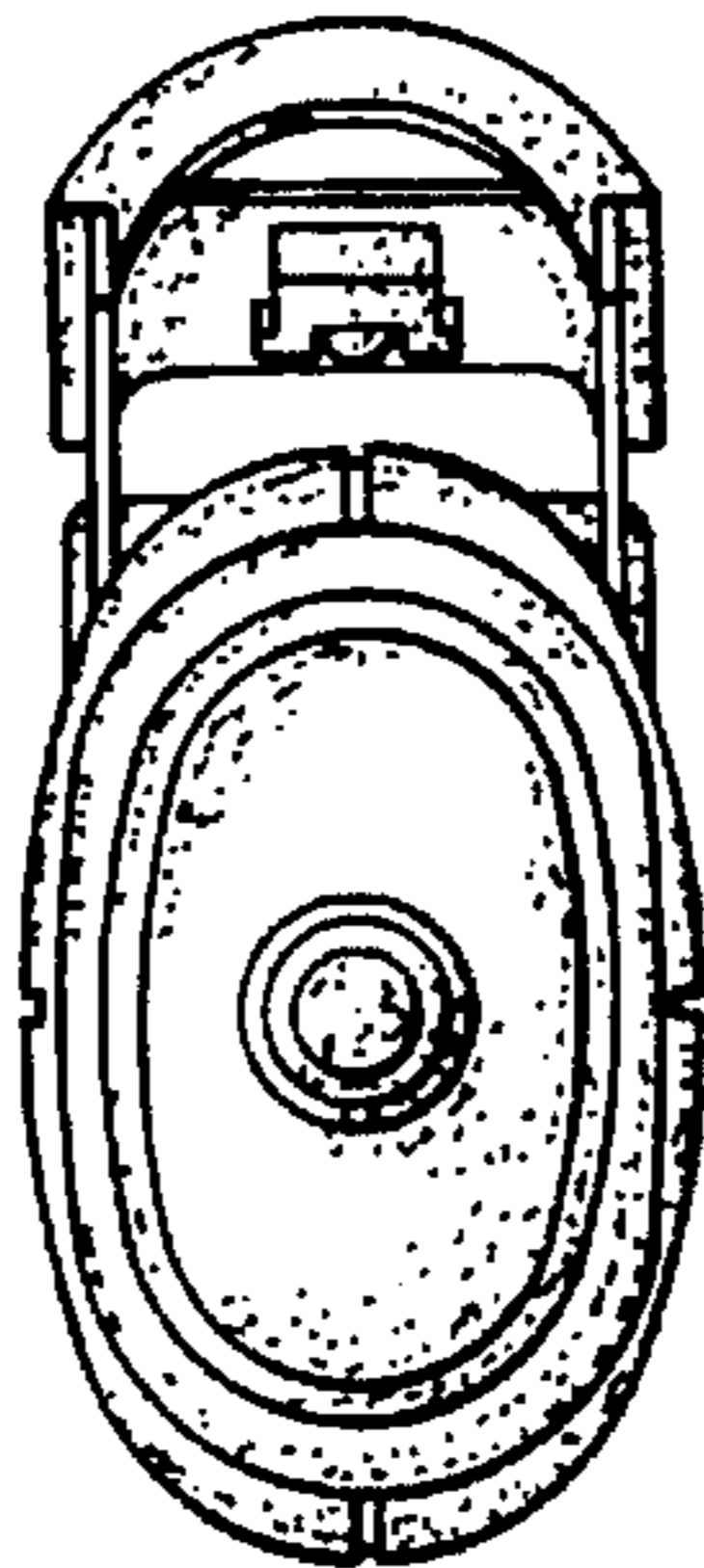

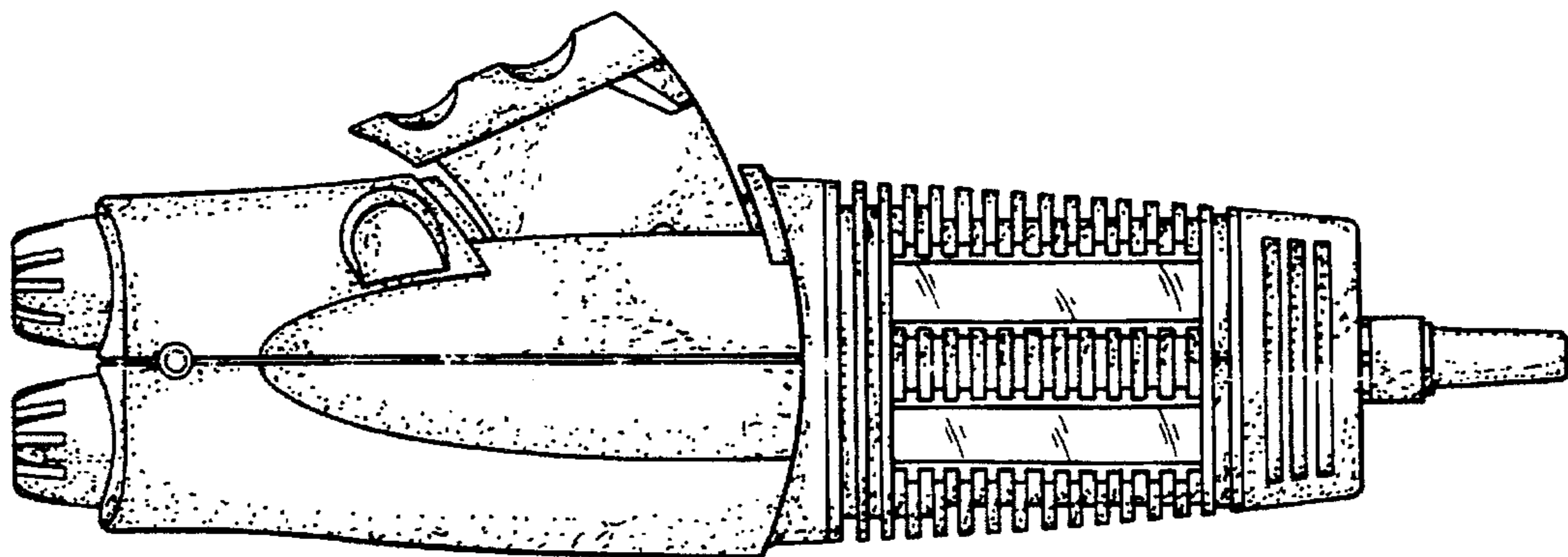

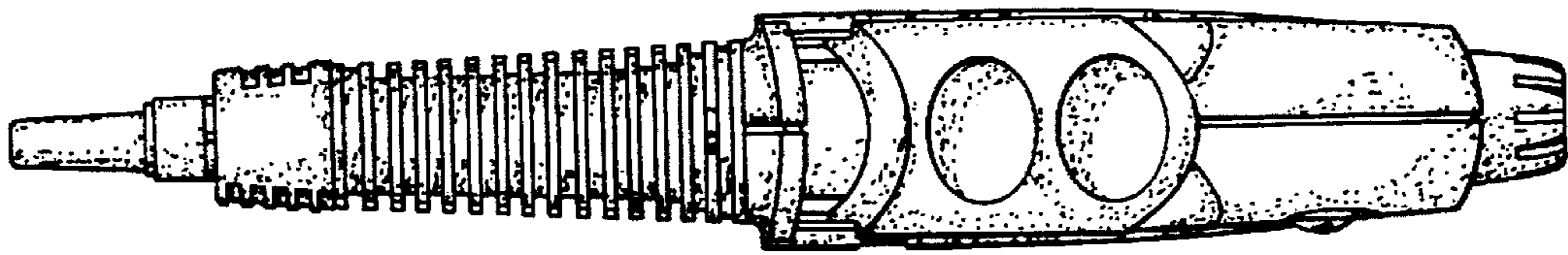

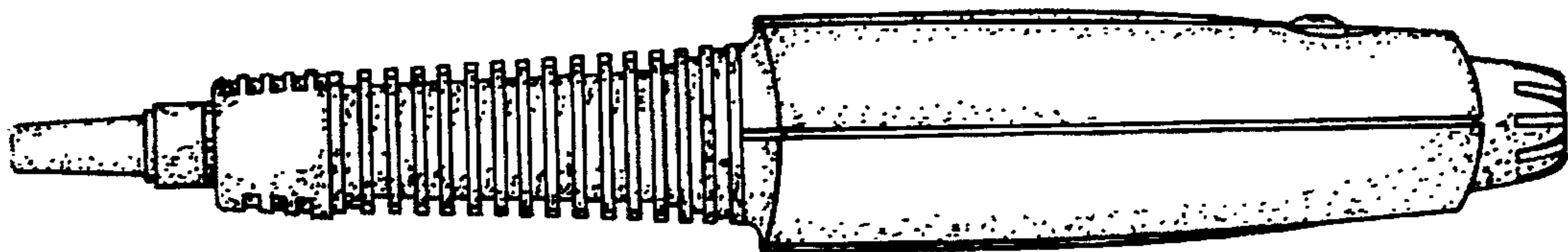
