[57] CLAIM

The ornamental design for a decorative nail covering, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of our decorative nail covering;

FIG. 2 is a left side elevational view of the first embodiment of our decorative nail covering, which is a mirror image of its right side elevational view.

FIG. 3 is a front end elevational view of the first embodiment of our decorative nail covering shown on an enlarged scale;

FIG. 4 is a top plan view of a second embodiment of our decorative nail covering;

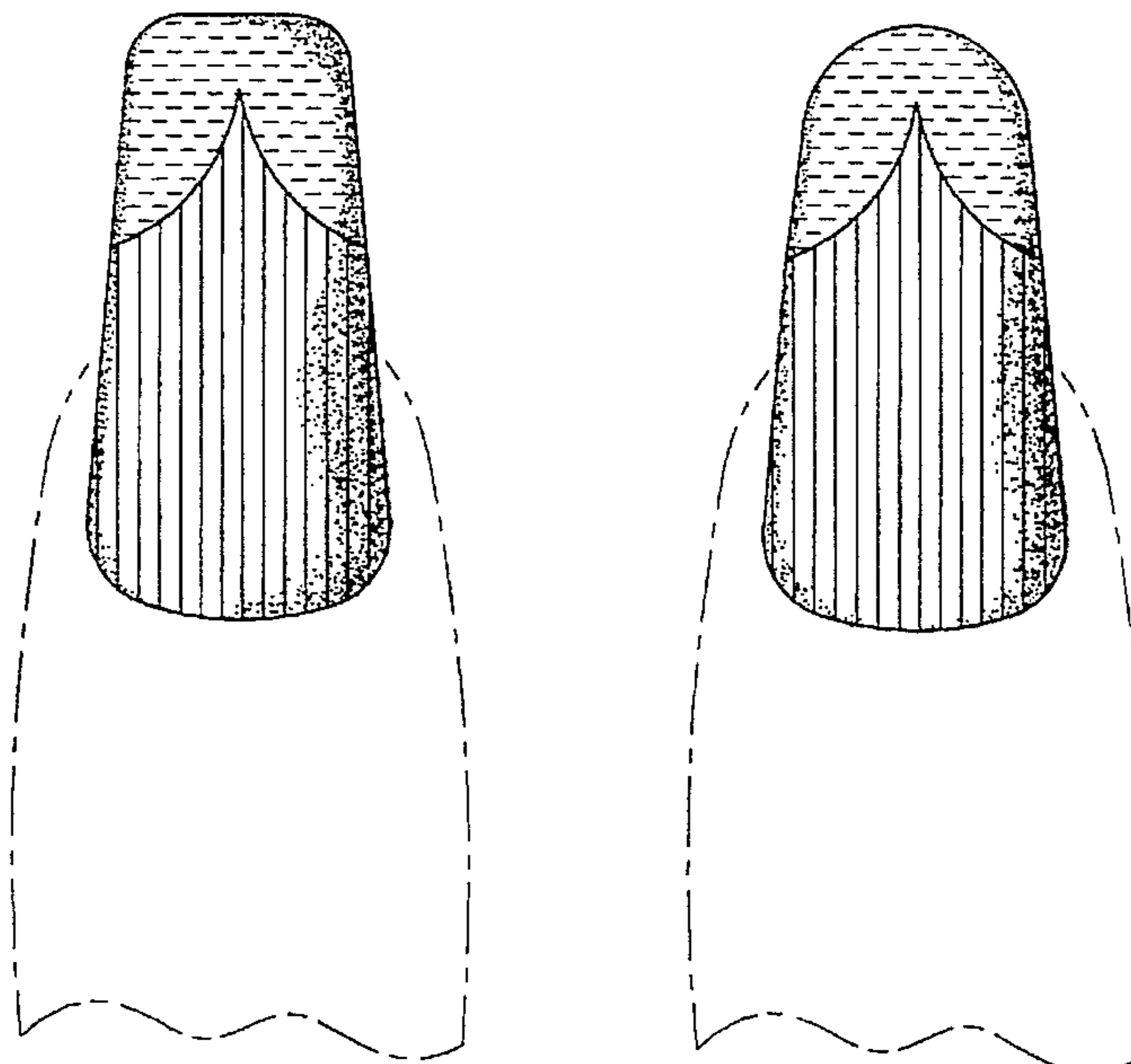
FIG. 5 is a left side elevational view of the second embodiment of our decorative nail covering, which is a mirror image of its right side elevational view; and,

FIG. 6 is a front end elevational view of the second embodiment of our decorative nail covering shown on an enlarged scale.

The broken line showing of the finger in FIGS. 1-6 and fingernail in FIGS. 3 and 6 is for illustrative purposes only and forms no part of the claimed design.

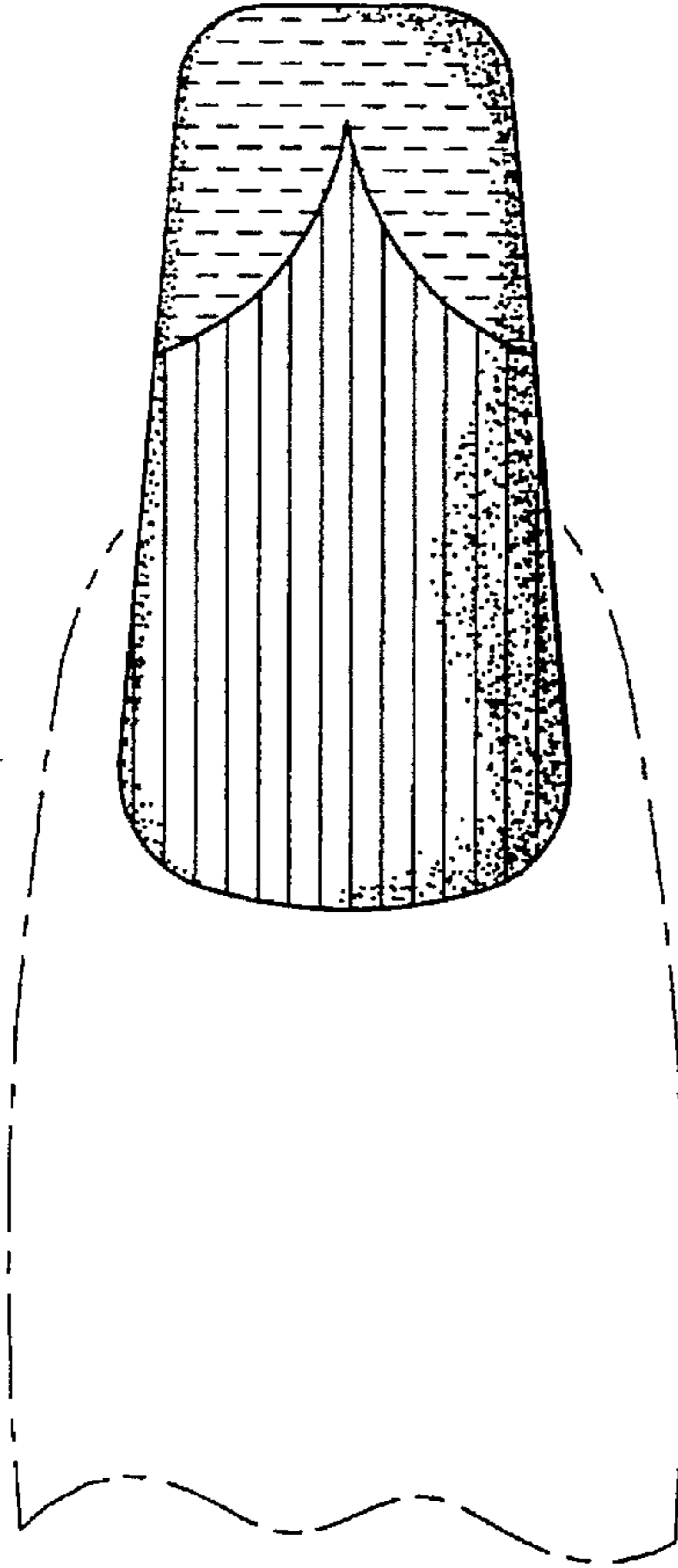

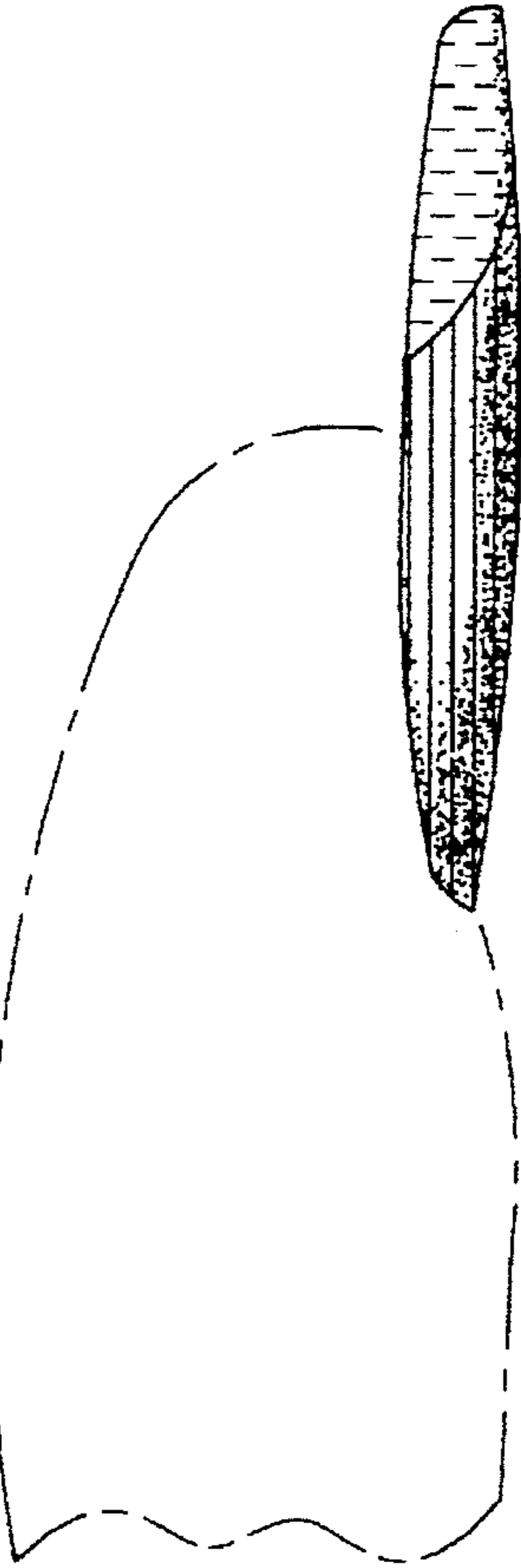

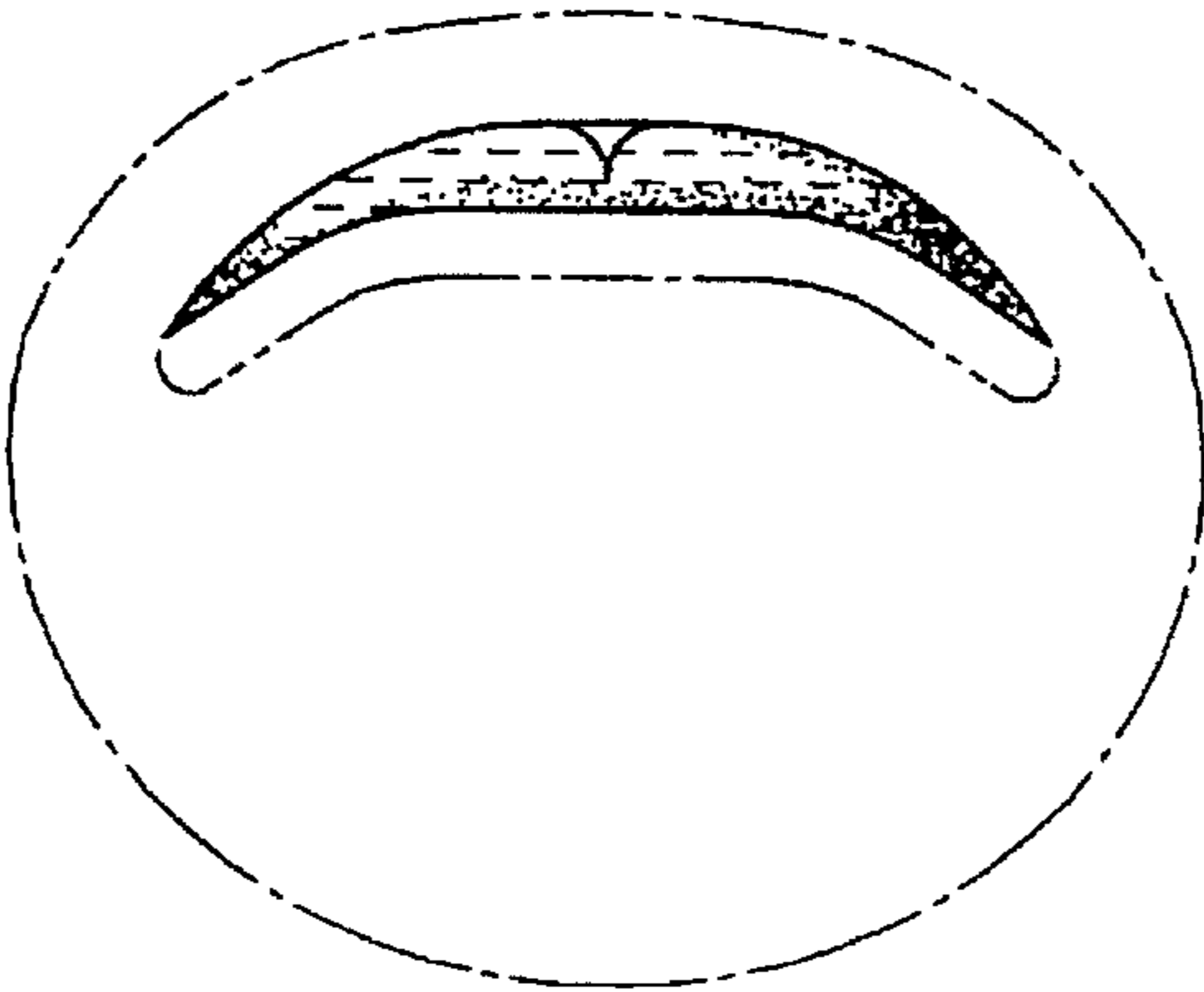

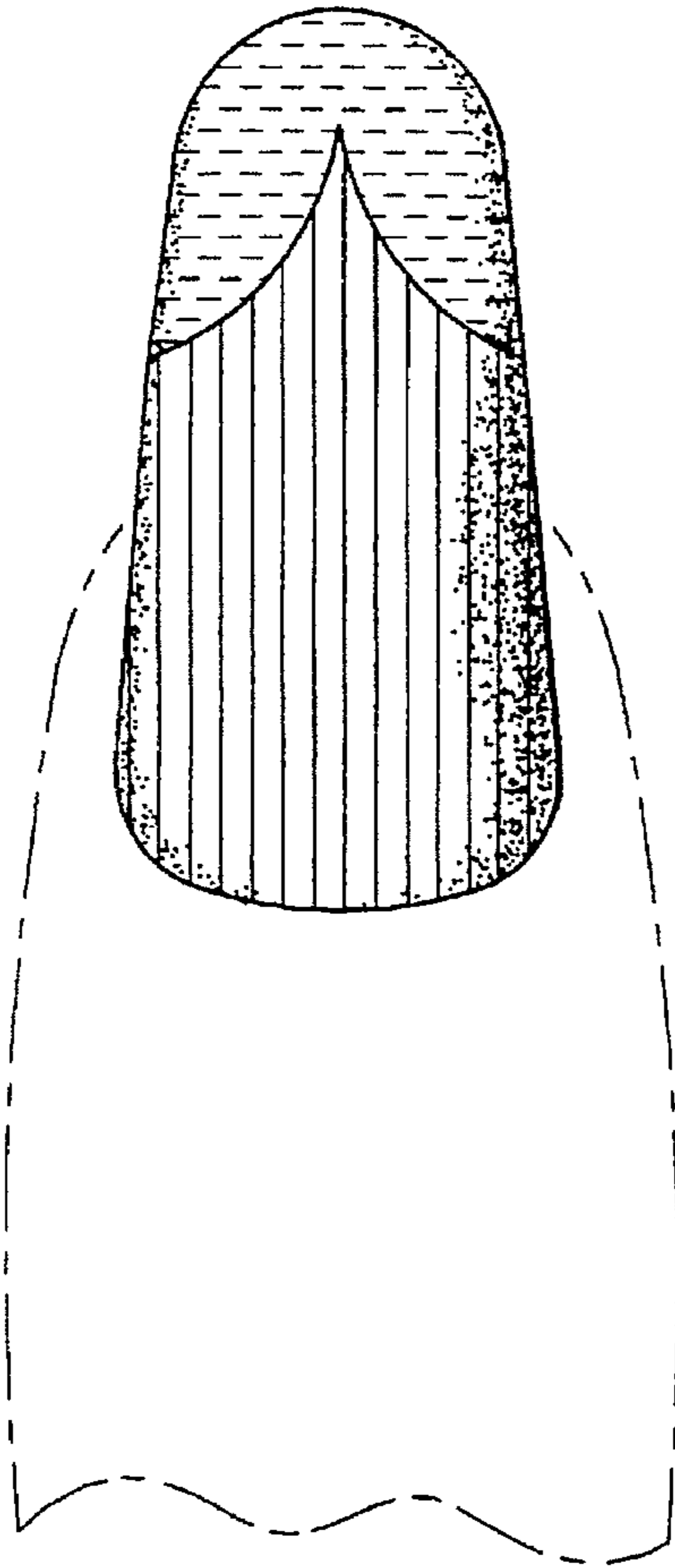

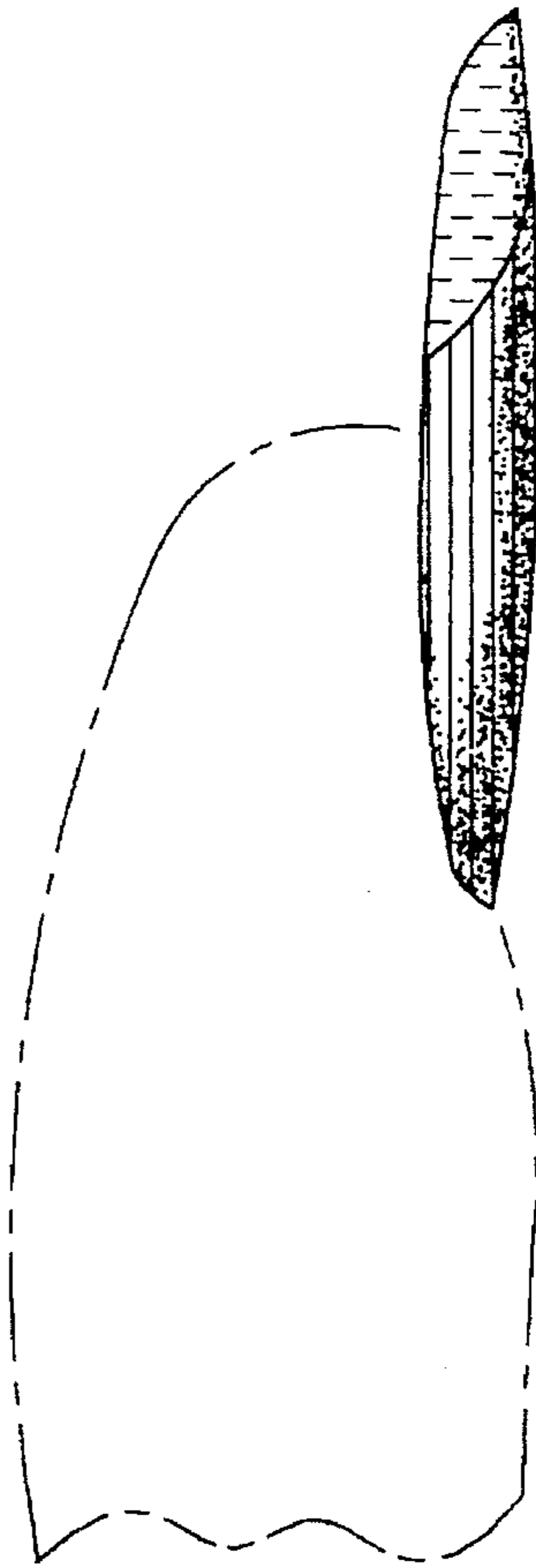

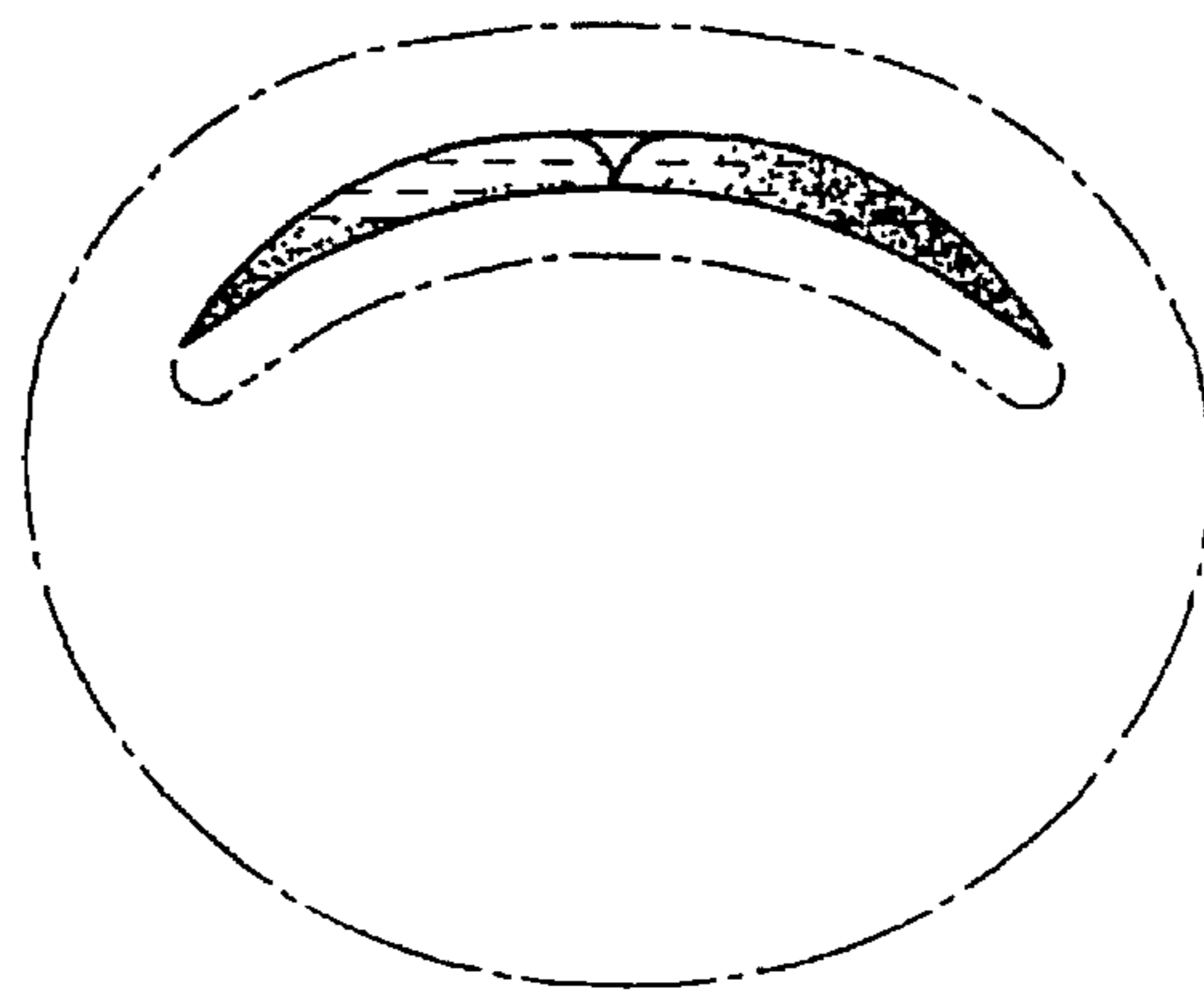
