DESCRIPTION

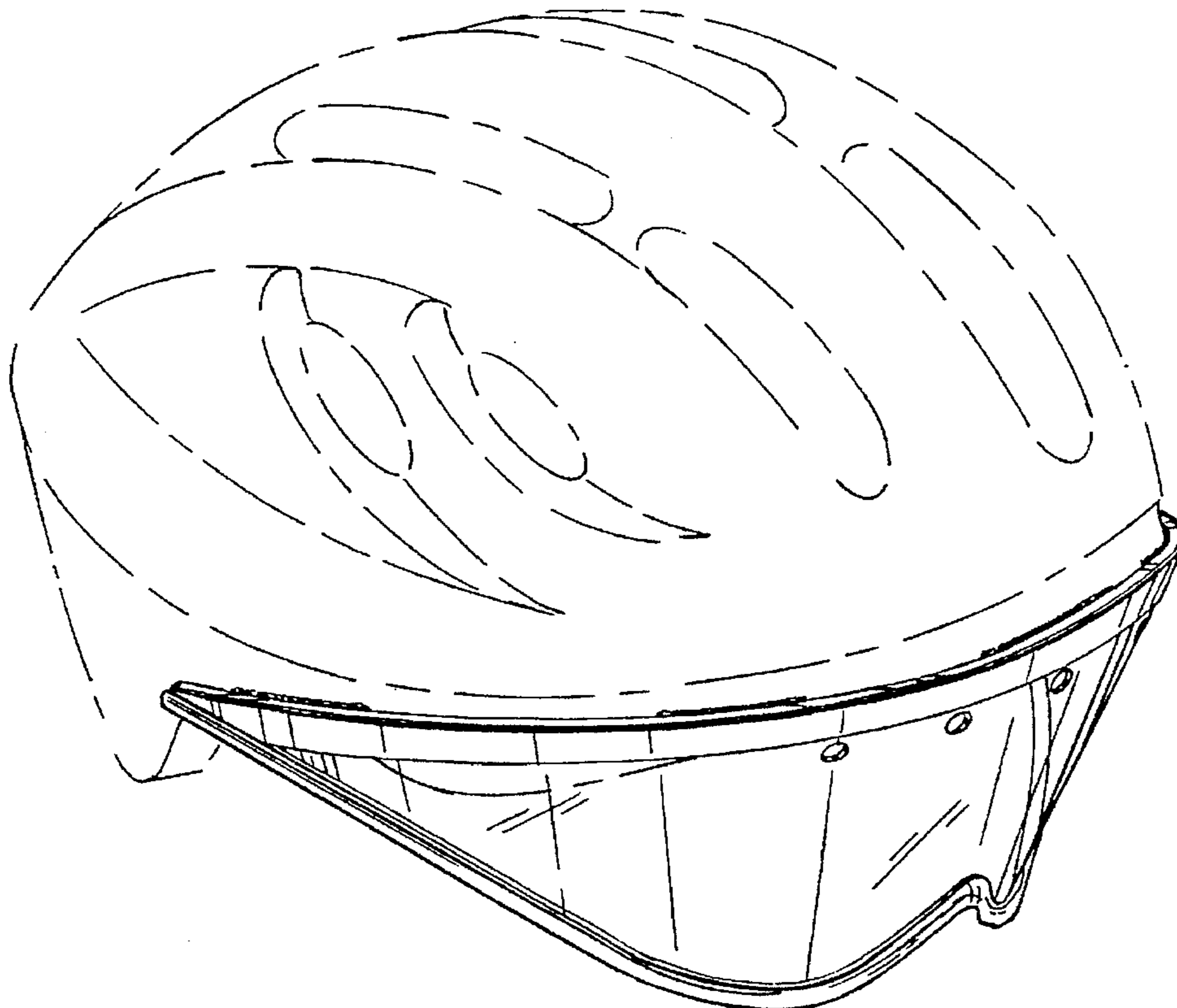

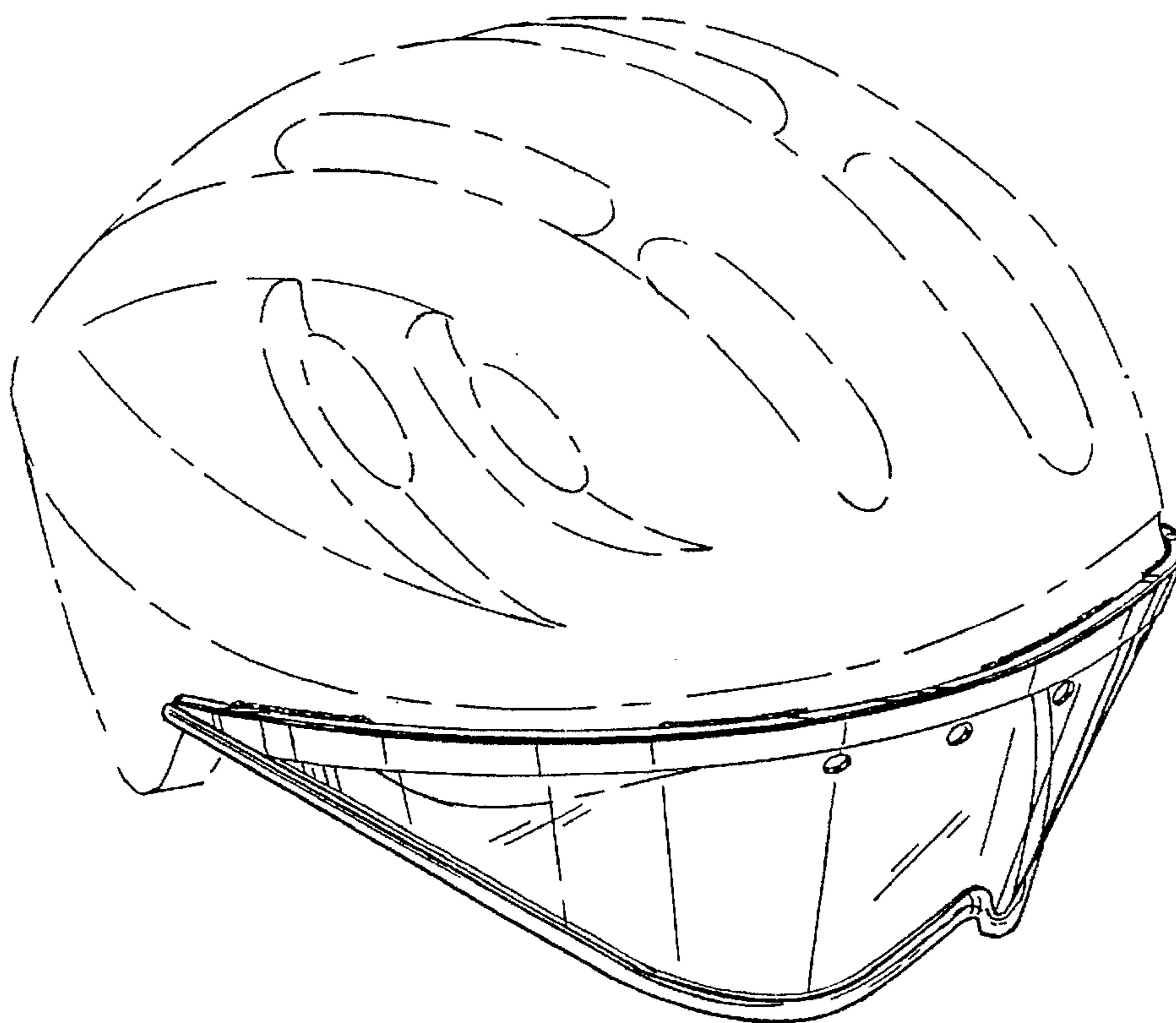

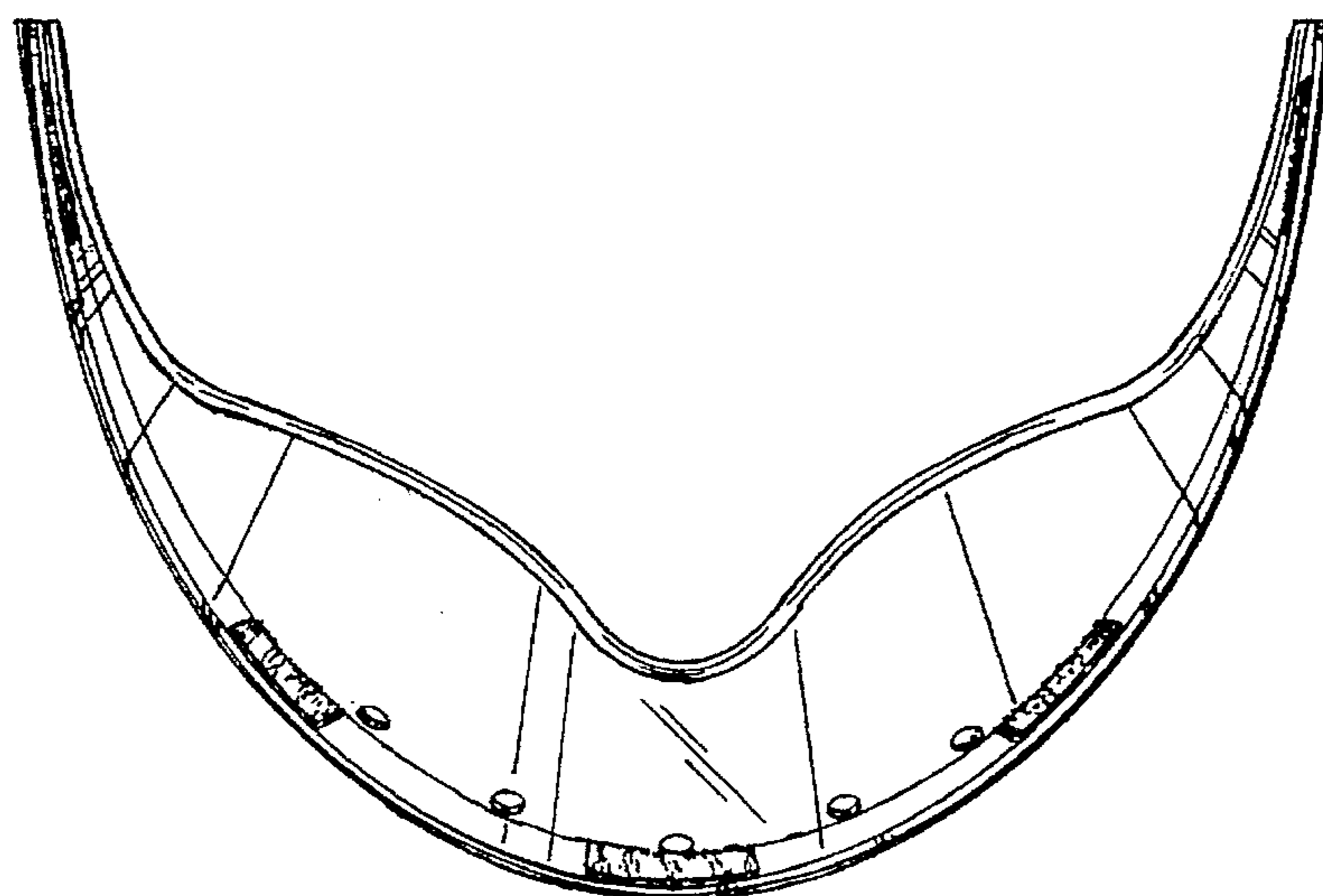

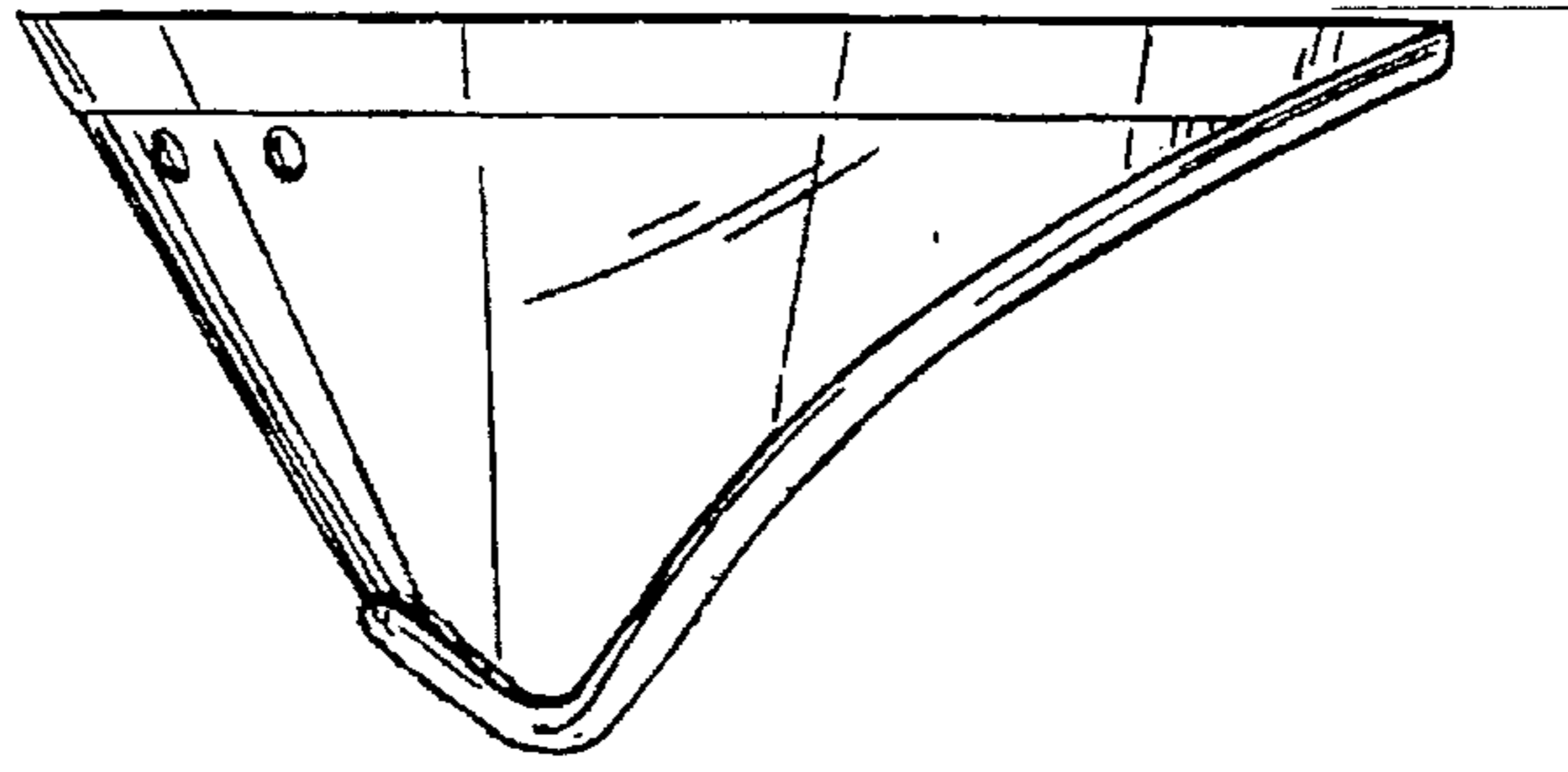

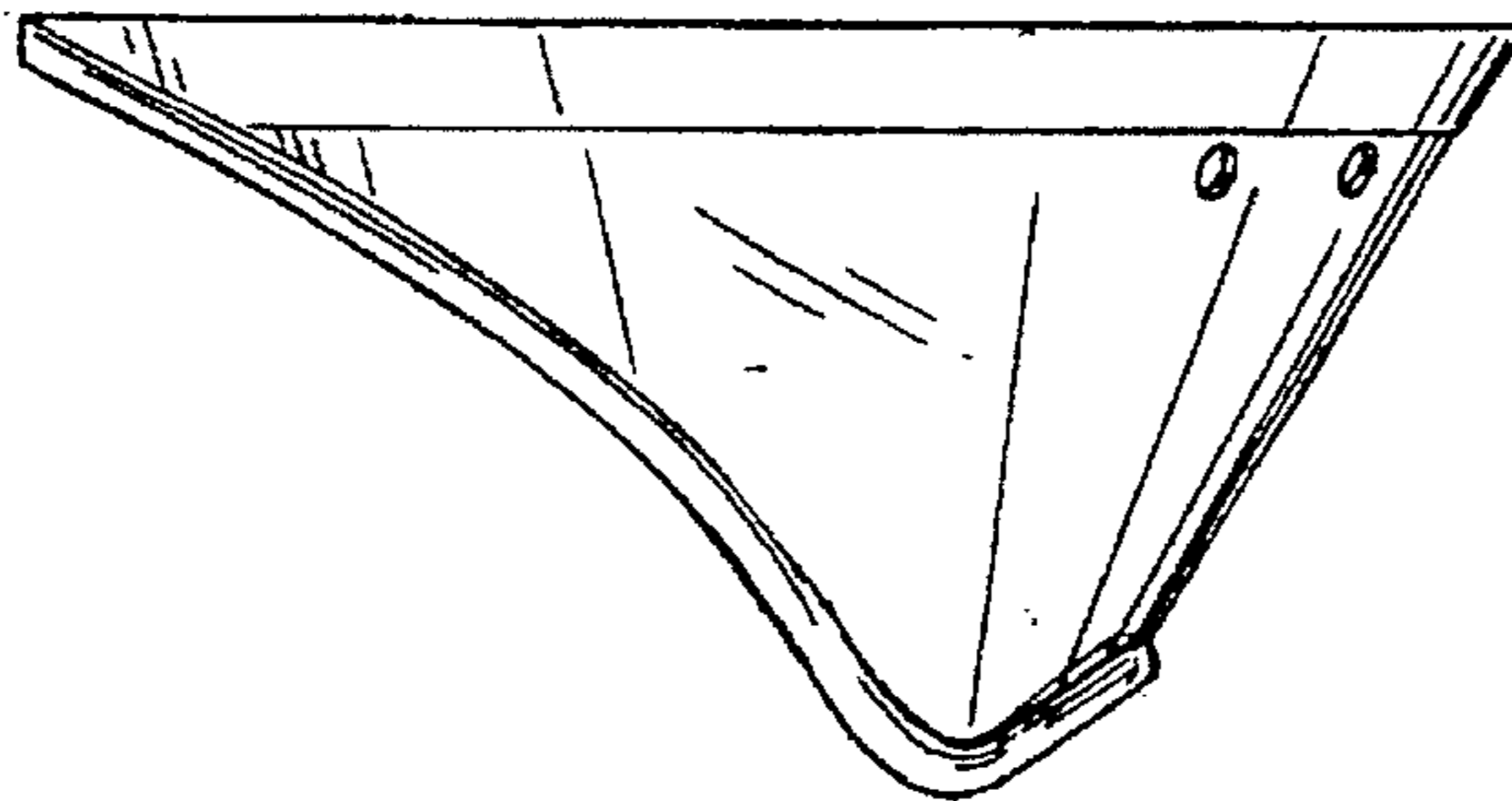

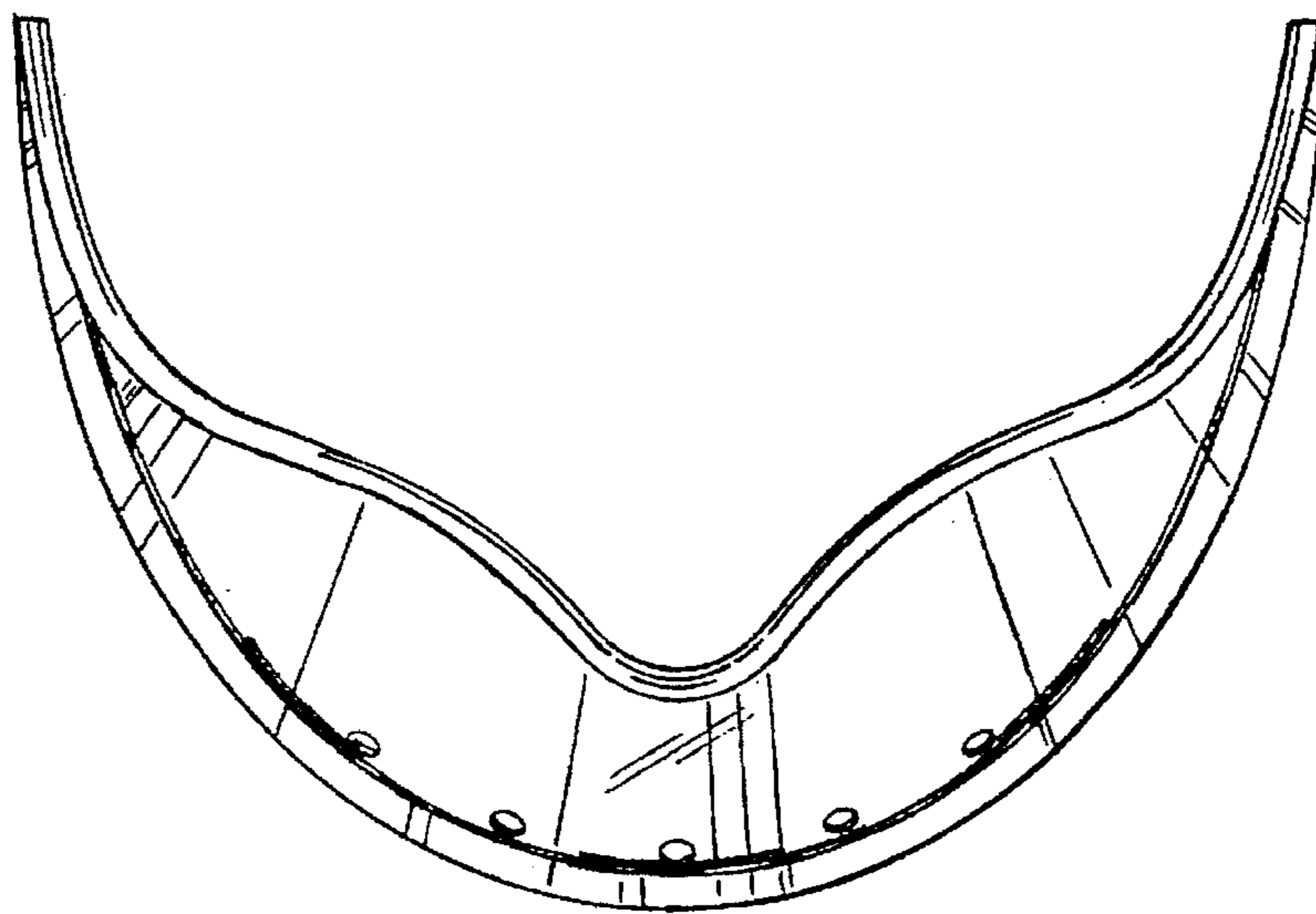
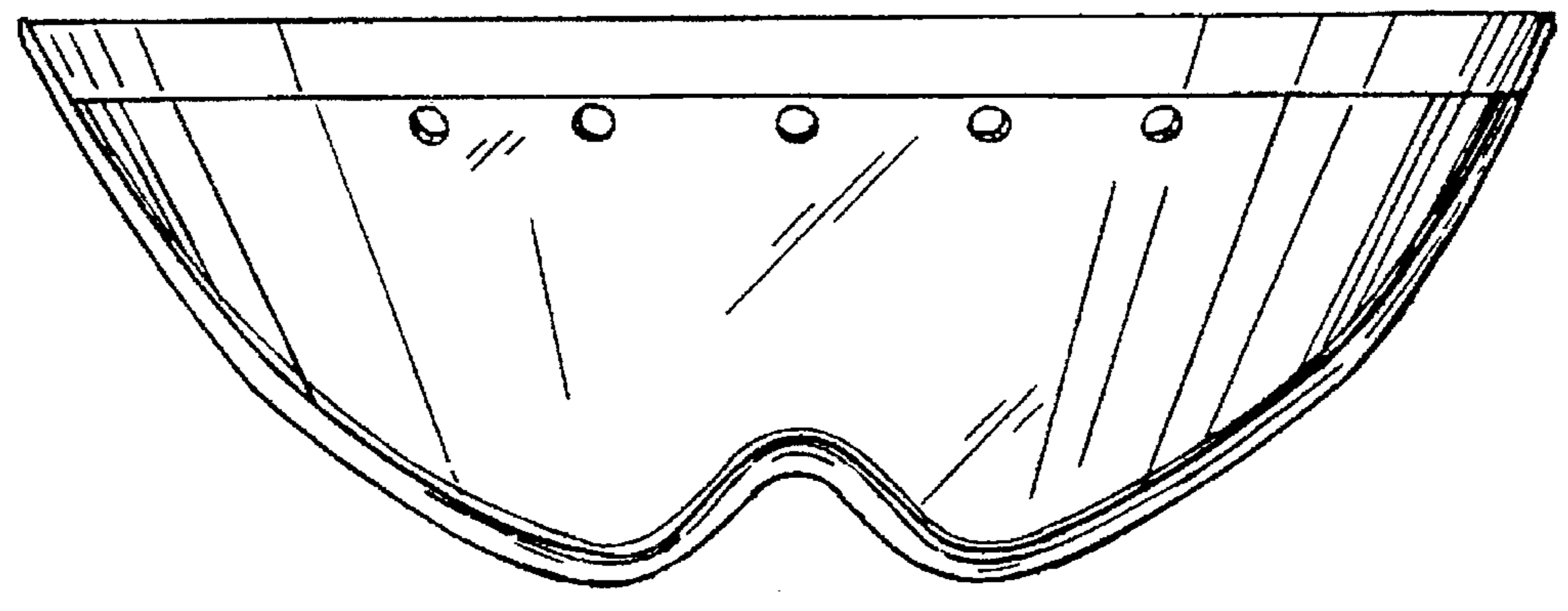
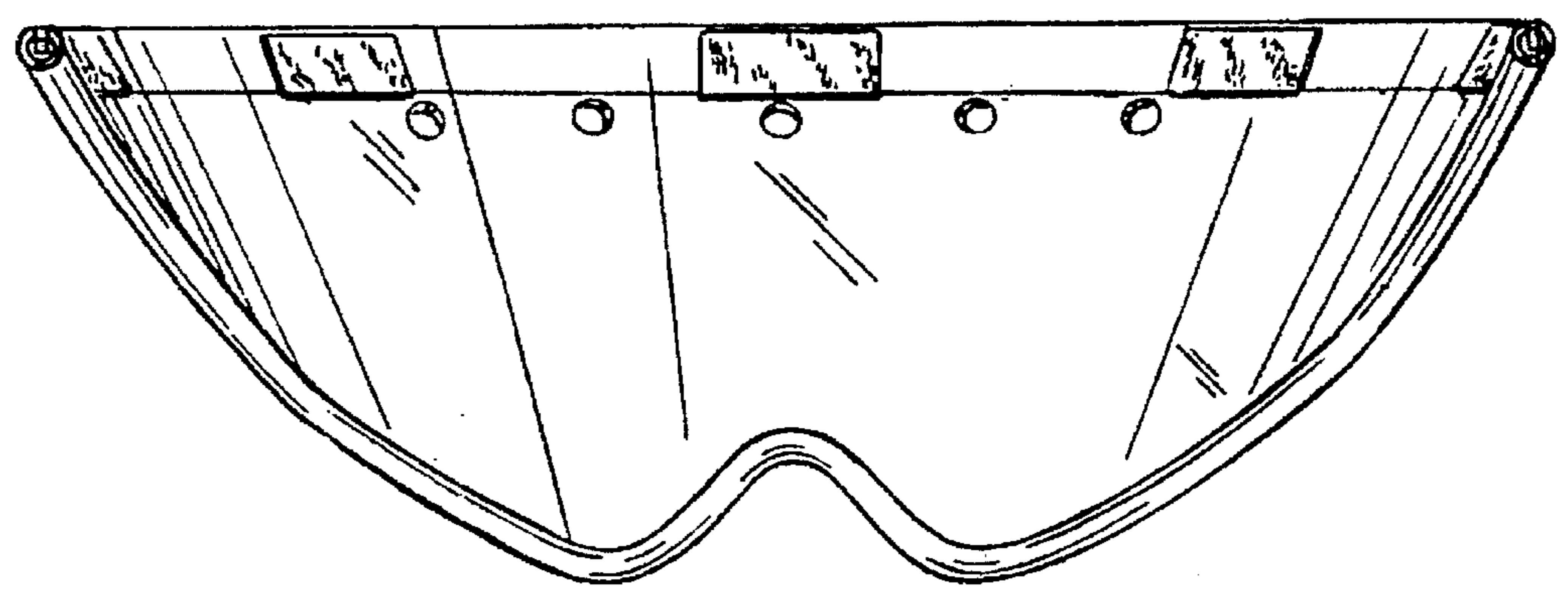
