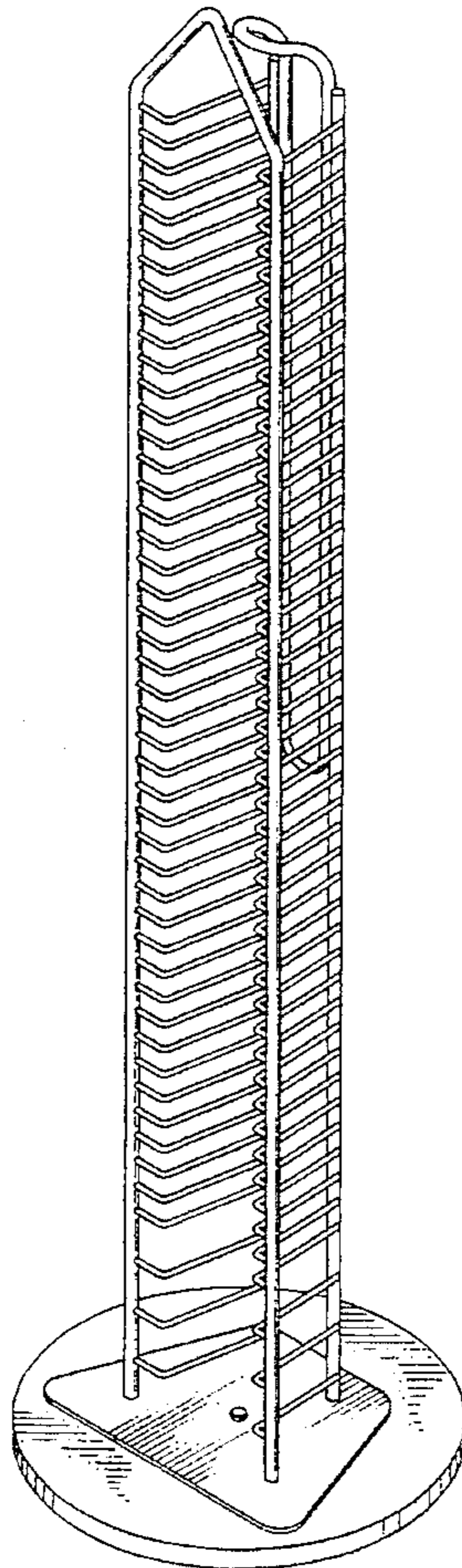
[57] **CLAIM**

The ornamental design for a rack for compact disks, as shown.

DESCRIPTION

FIG. 1 is a perspective view from the front, top and right side of a rack for compact disks showing my design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

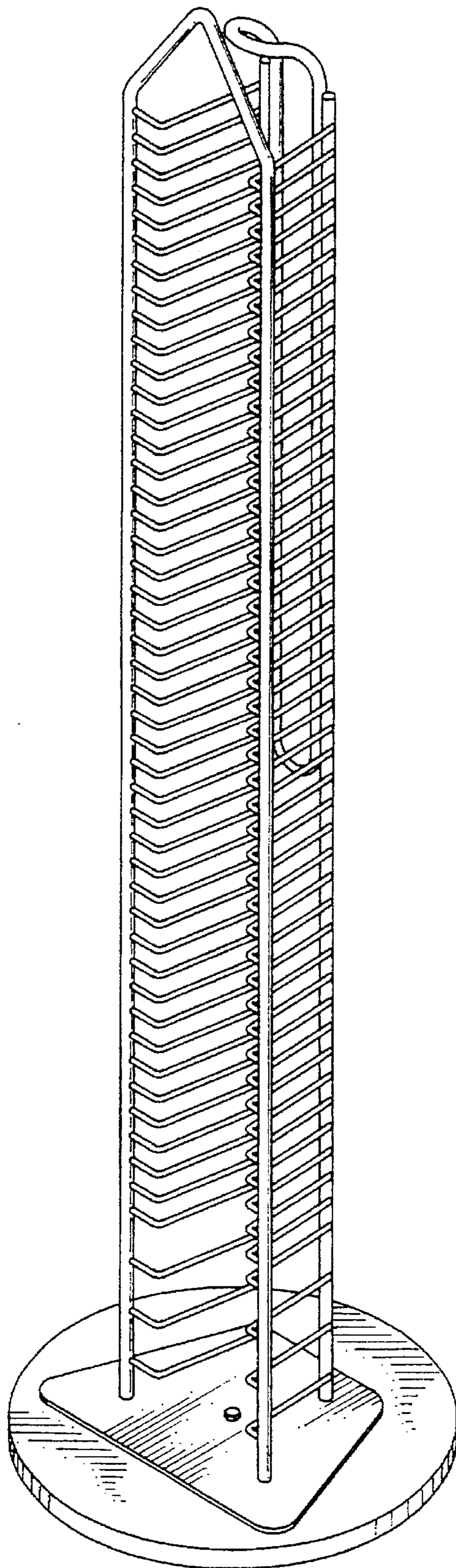

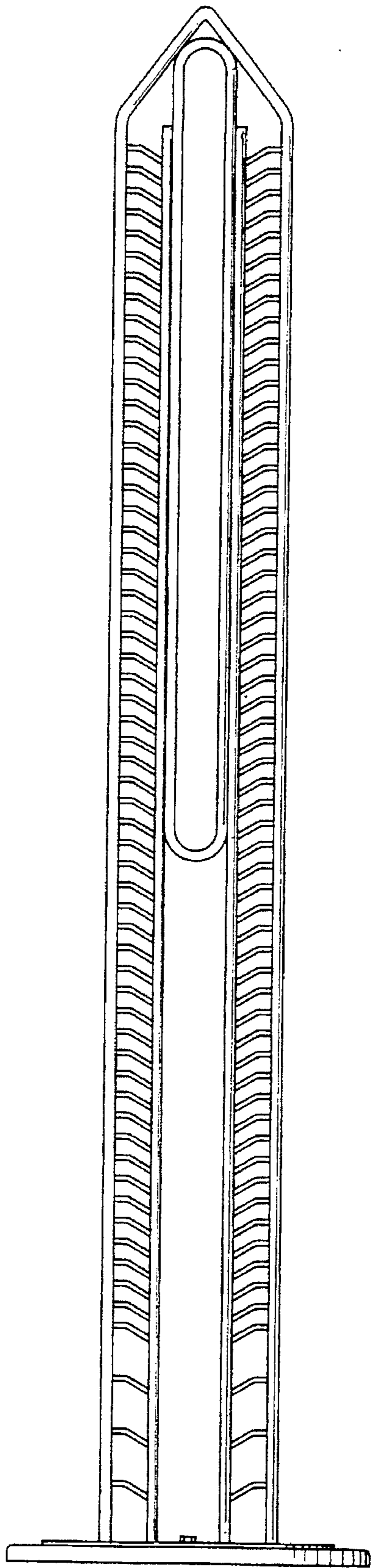

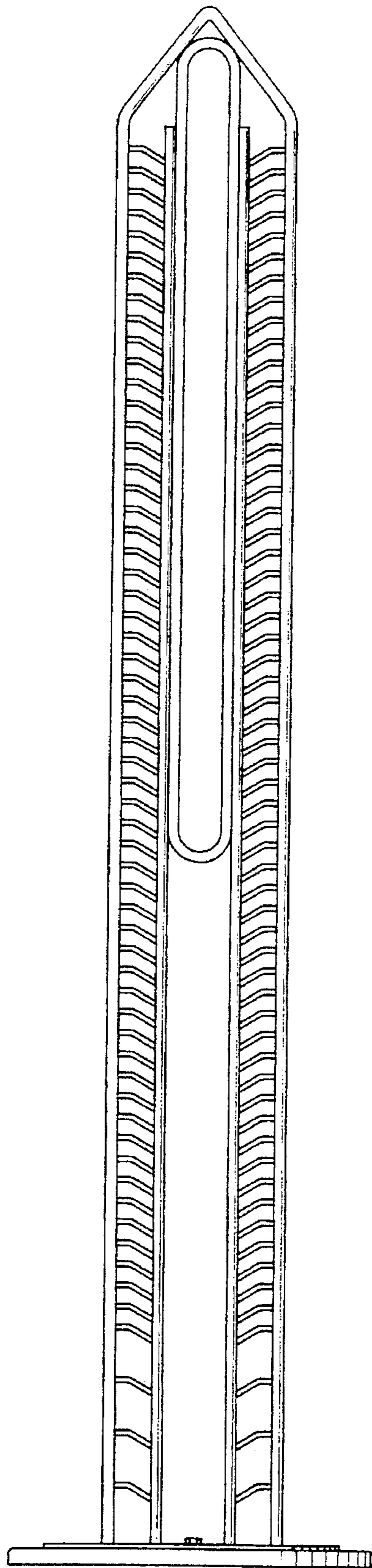

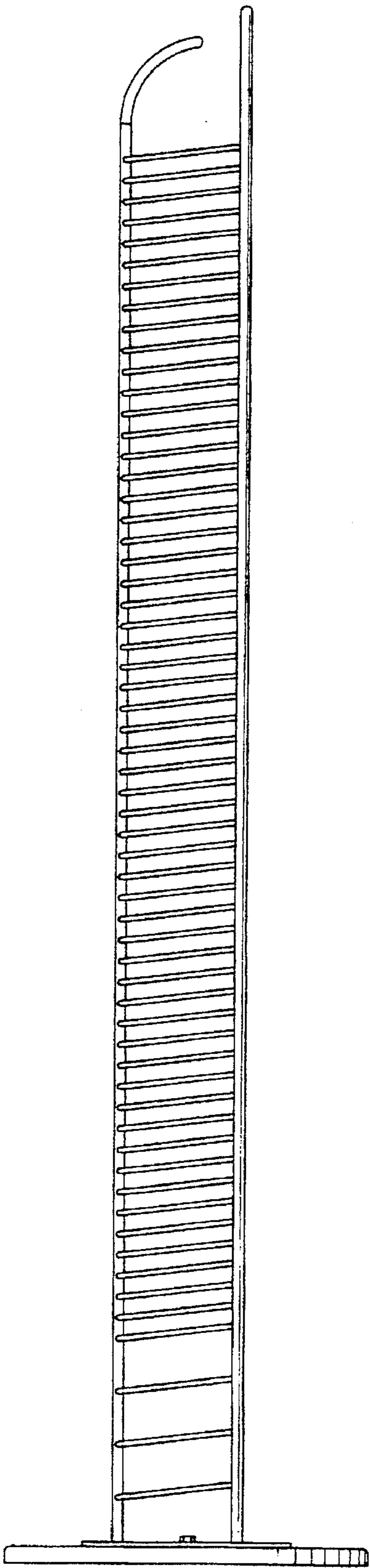

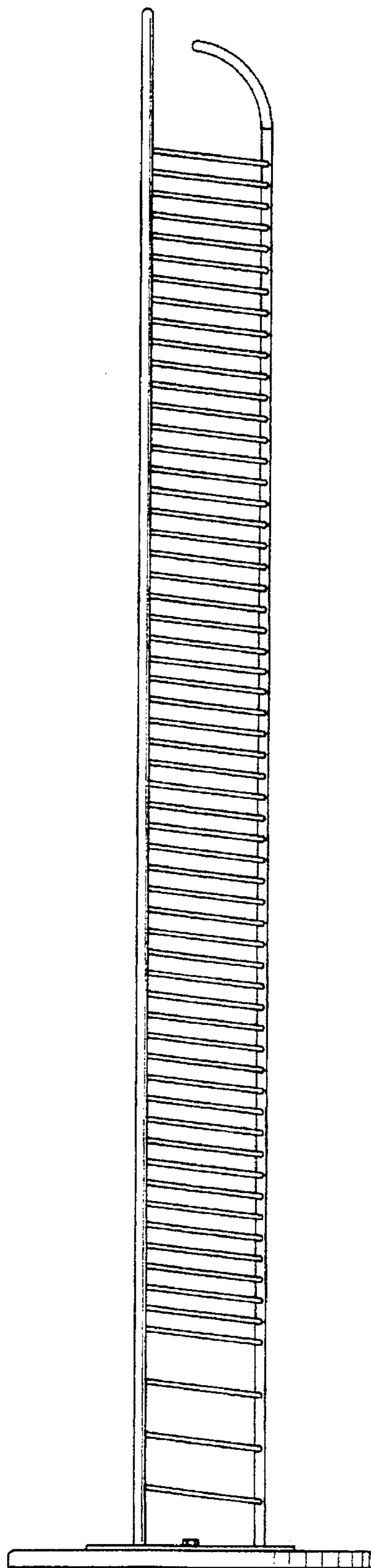

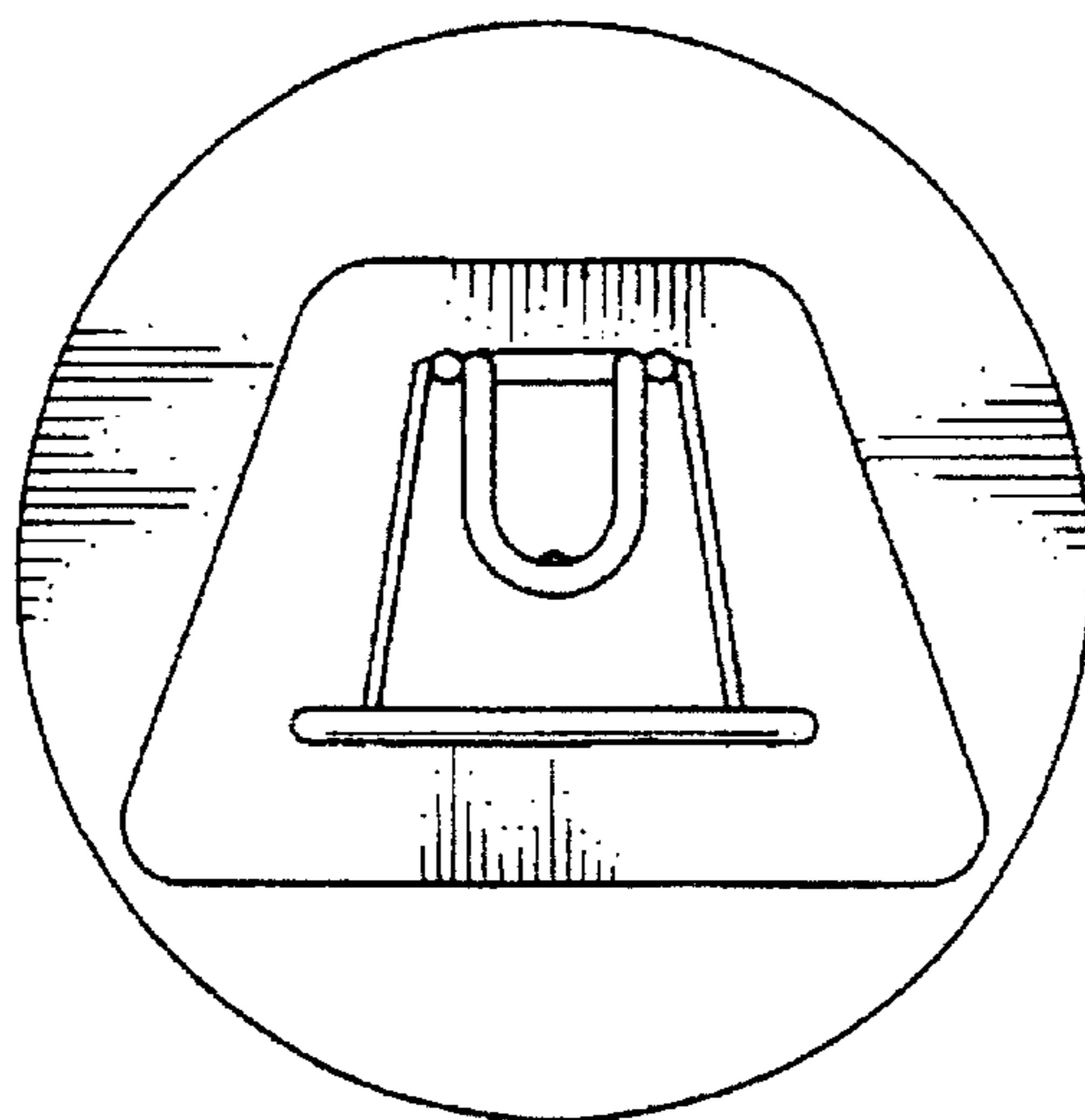

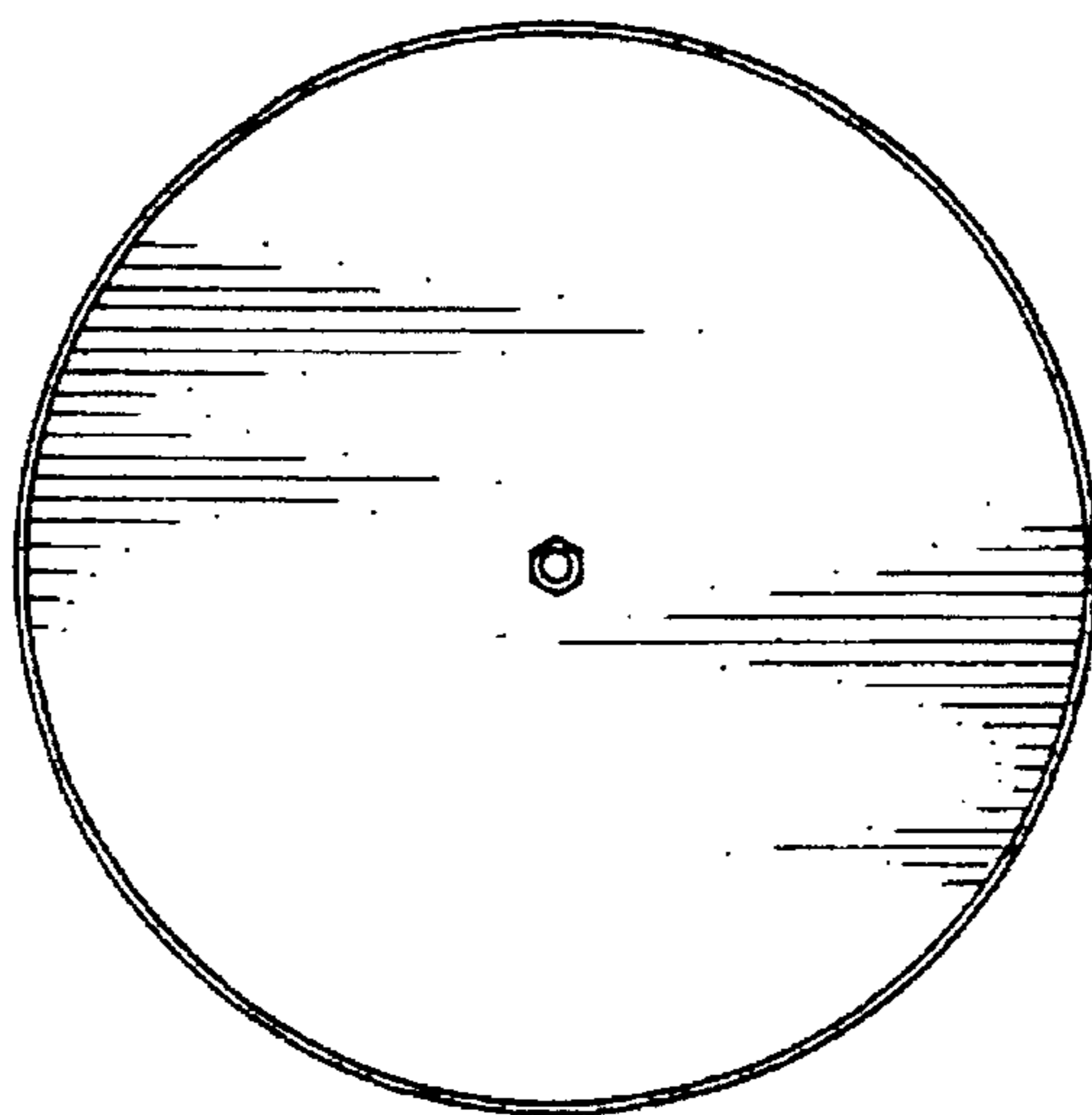
