[57] CLAIM

The ornamental design for protective goggles, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view from the left side of the protective goggles in accordance with the invention; FIG. 2 shows a perspective view from the right side of the goggles of FIG. 1;

FIG. 3 shows a front elevation view of the goggles of FIG. 1;

FIG. 4 shows an elevation view from the right side of the goggles of FIG. 1, it being understood that an elevation view from the left side would be a mirror image thereof; FIG. 5 shows a top view of the goggles of FIG. 1; FIG. 6 shows a bottom view of the goggles of FIG. 1; and, FIG. 7 shows a rear view of the goggles of FIG. 1.













