The ornamental design for a sunshade device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the first embodiment; FIG. 2 is a rear perspective view of the first embodiment; FIG. 3 is a right side view of the first embodiment, the side opposite being a mirror image; FIG. 4 is a top plan view of the first embodiment; FIG. 5 is a front perspective view of the second embodiment; FIG. 6 is a rear perspective view of the second embodiment; FIG. 7 is a right side view of the second embodiment, the side opposite being a mirror image; FIG. 8 is a top plan view of the second embodiment; FIG. 9 is a front perspective view of a third embodiment; FIG. 10 is a rear perspective view of the third embodiment; FIG. 11 is a right side view of the third embodiment, the side opposite being a mirror image; and, FIG. 12 is a top plan view of the third embodiment.

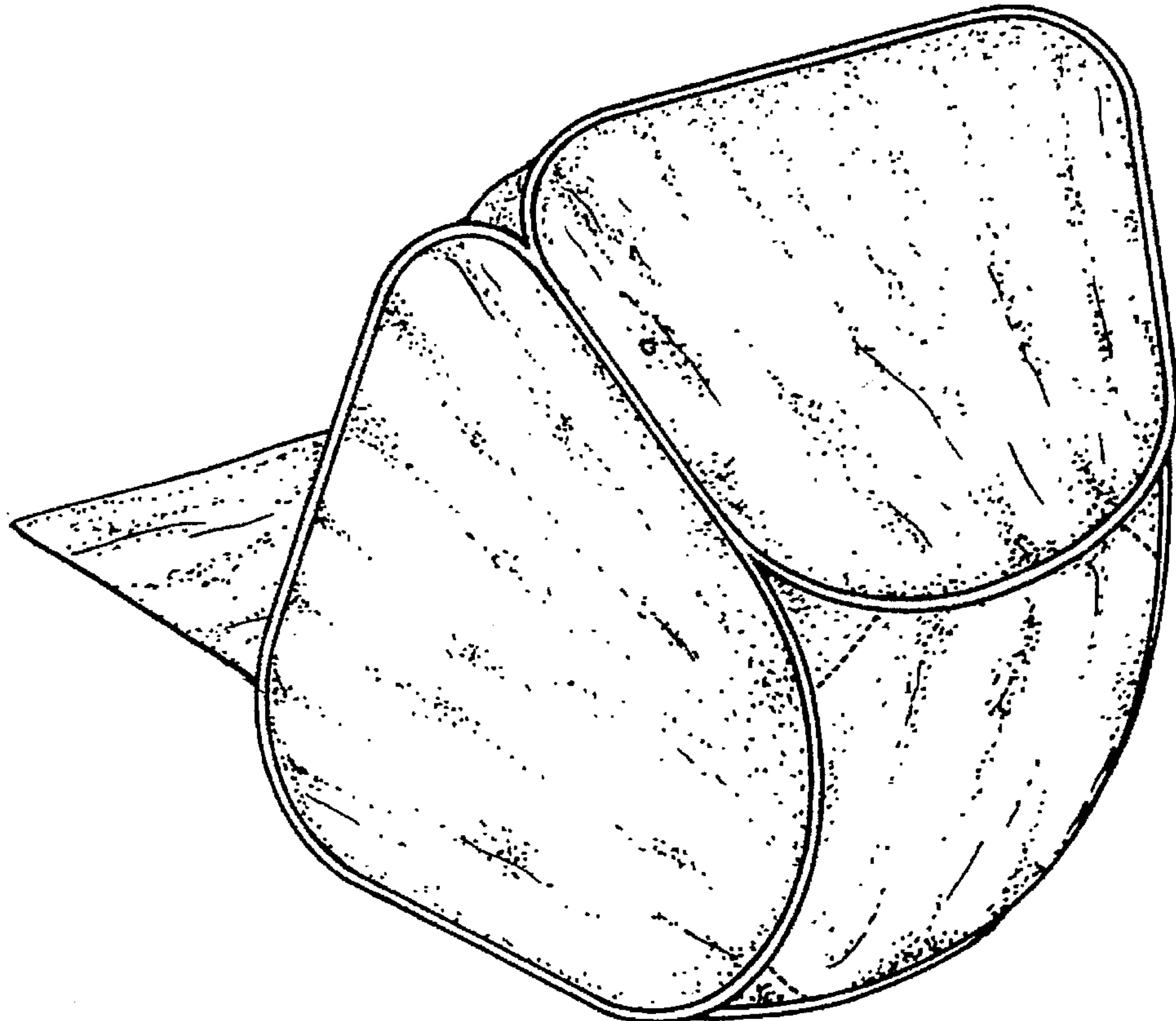

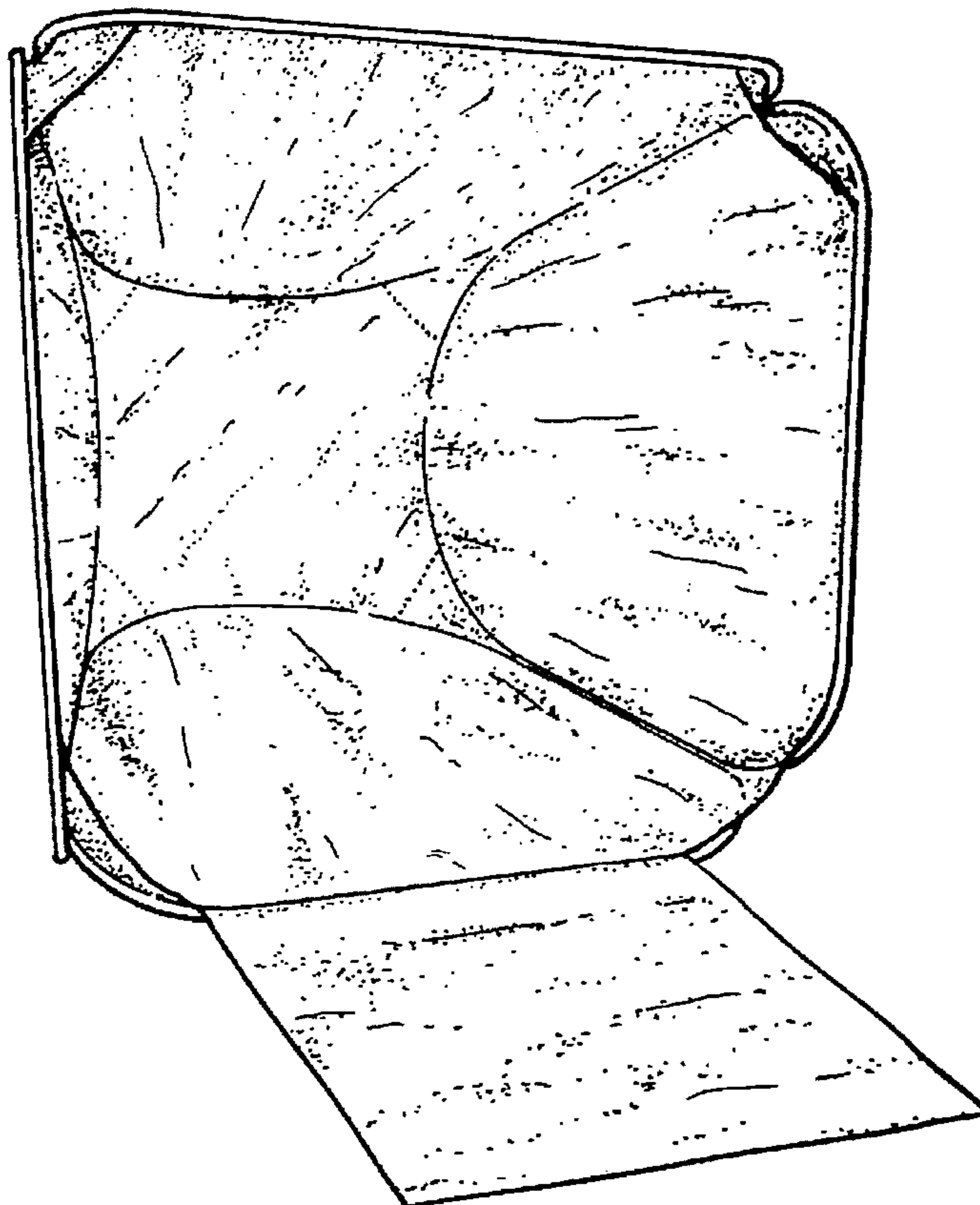

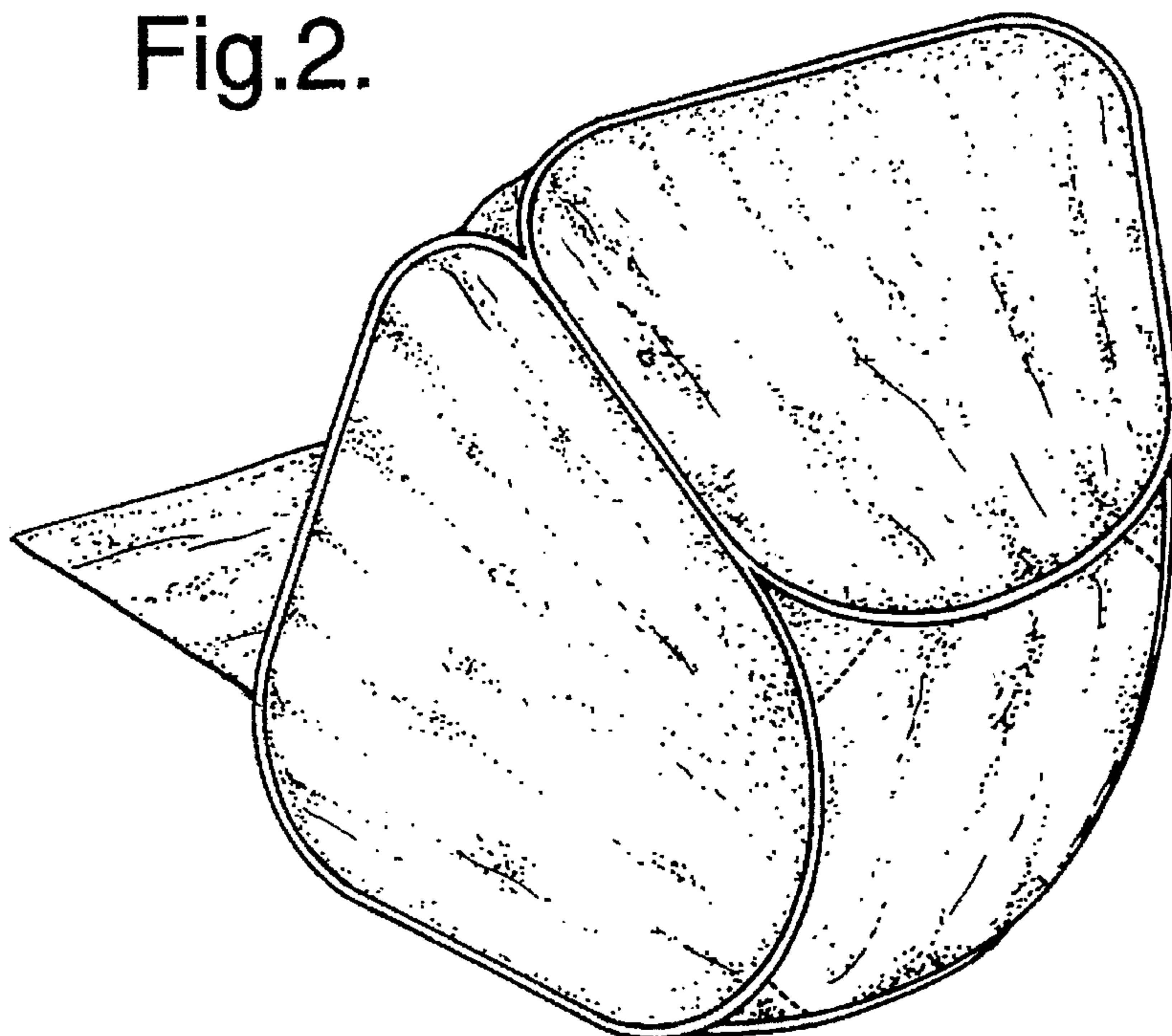

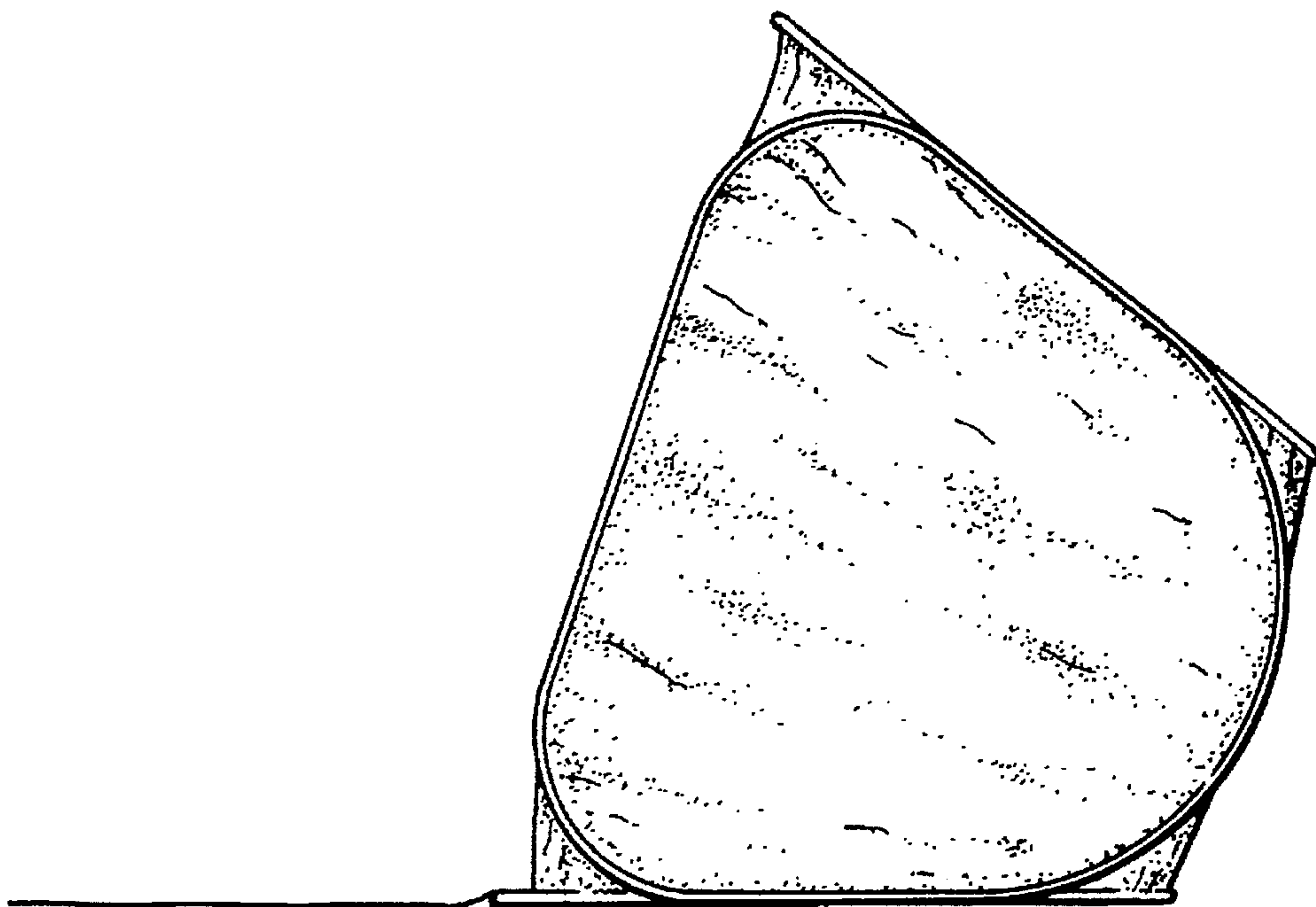

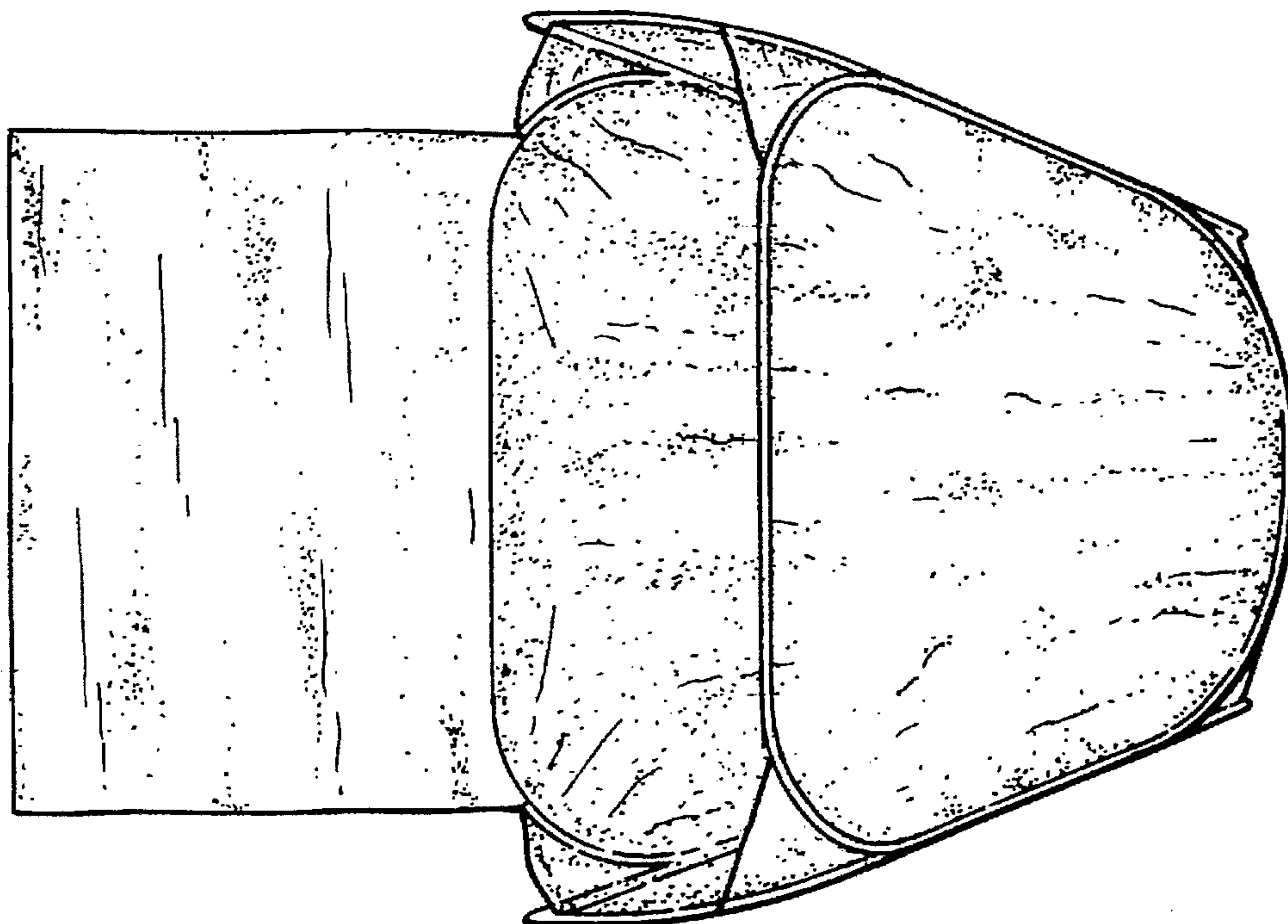

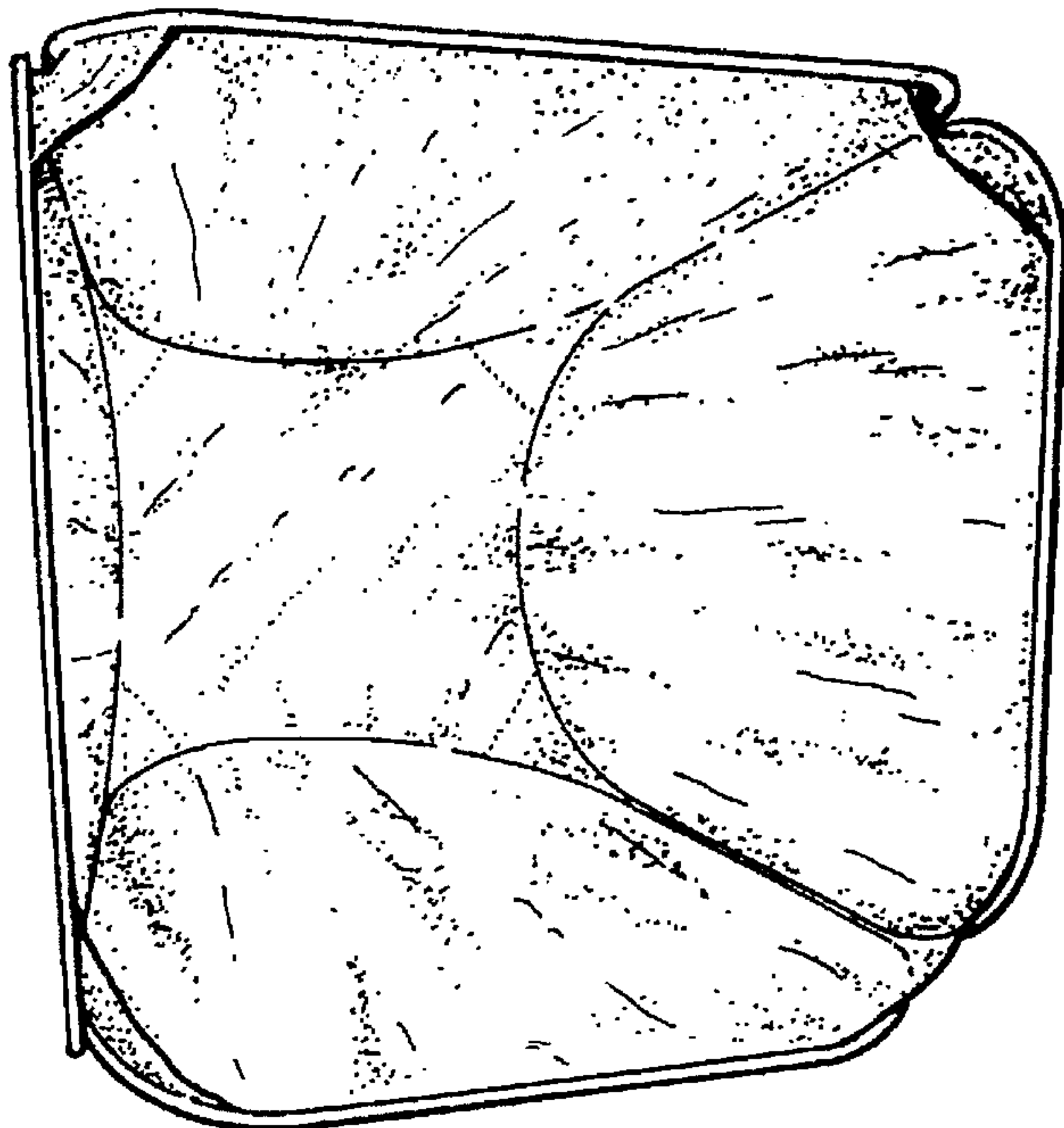

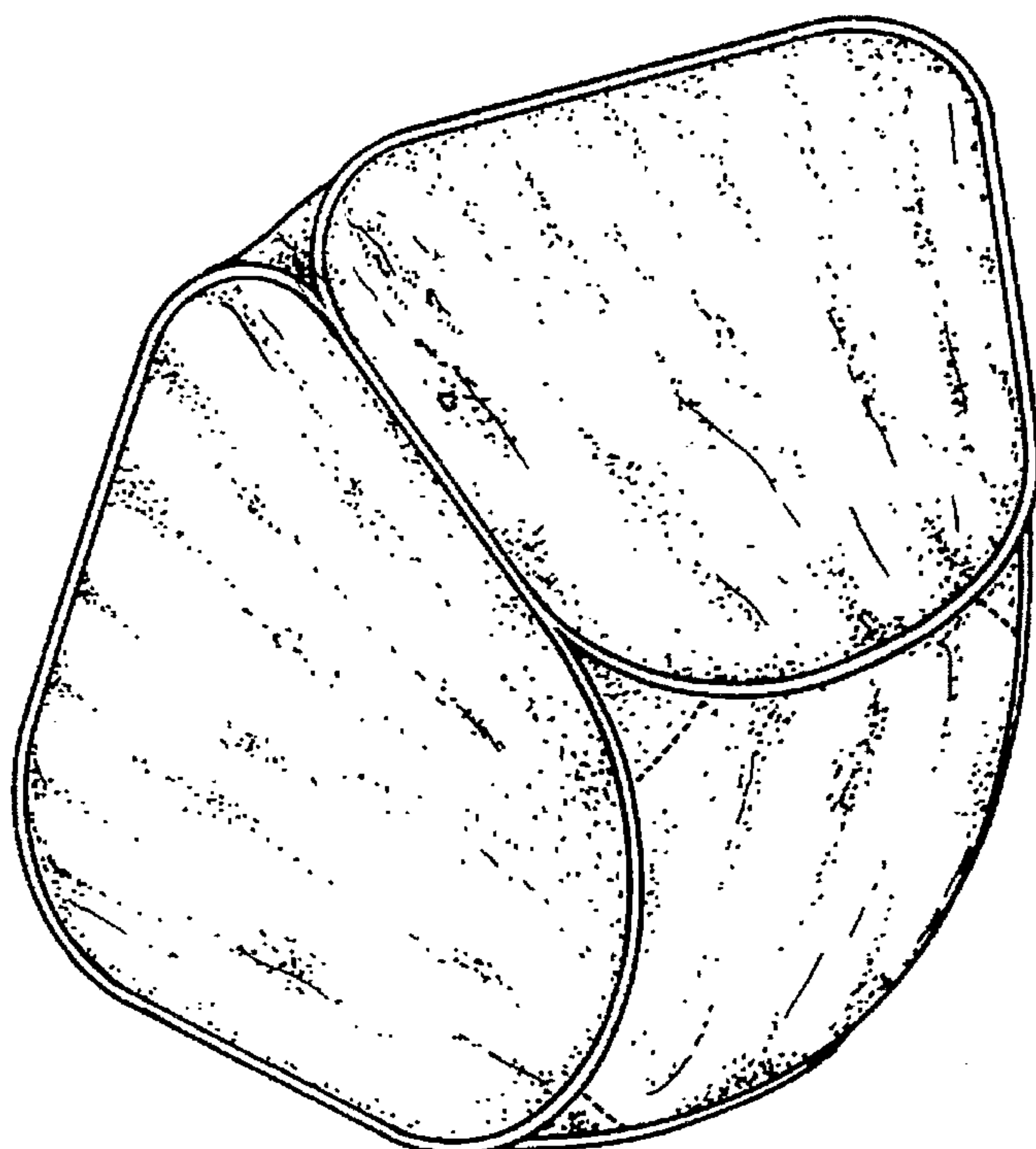

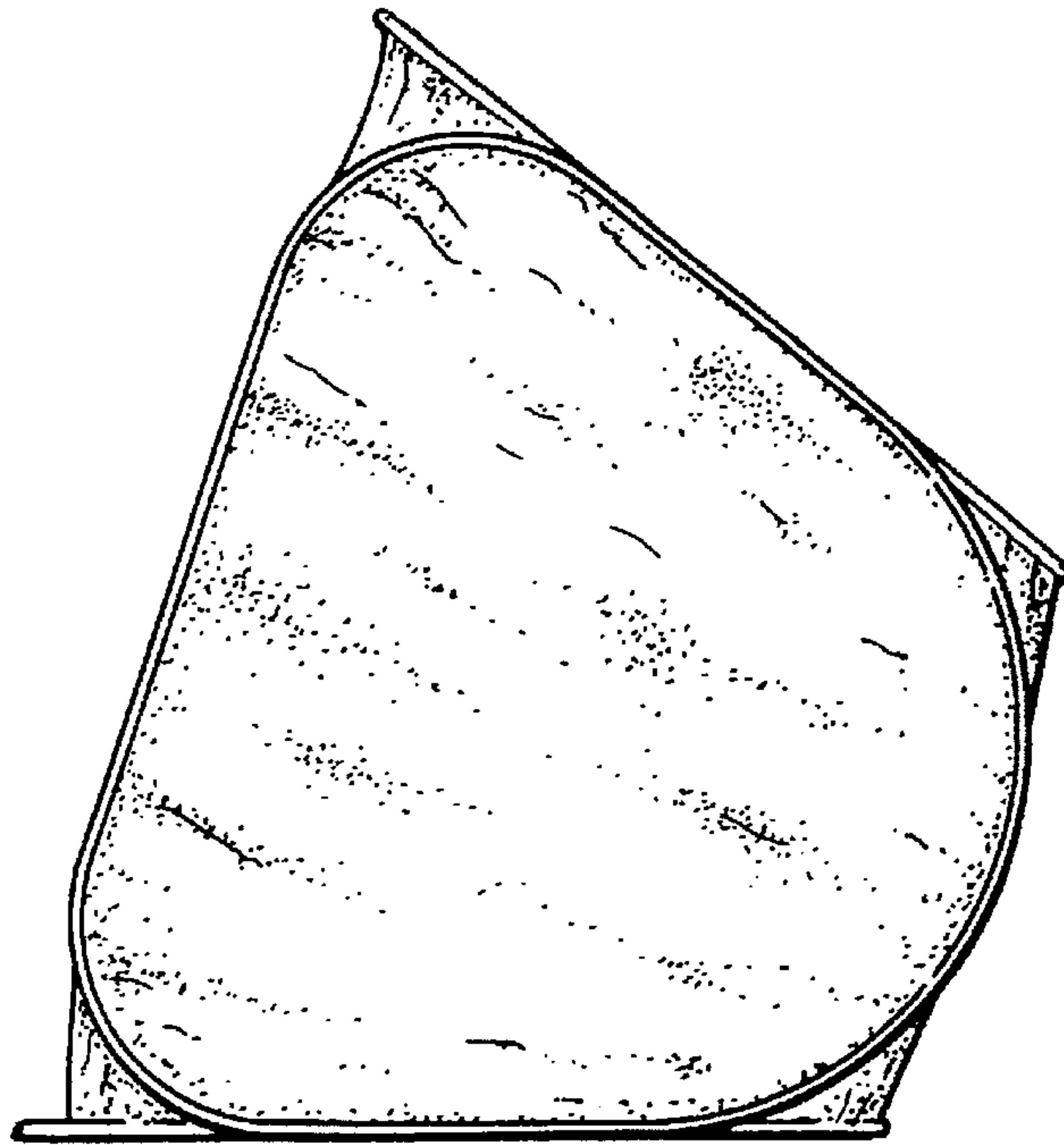

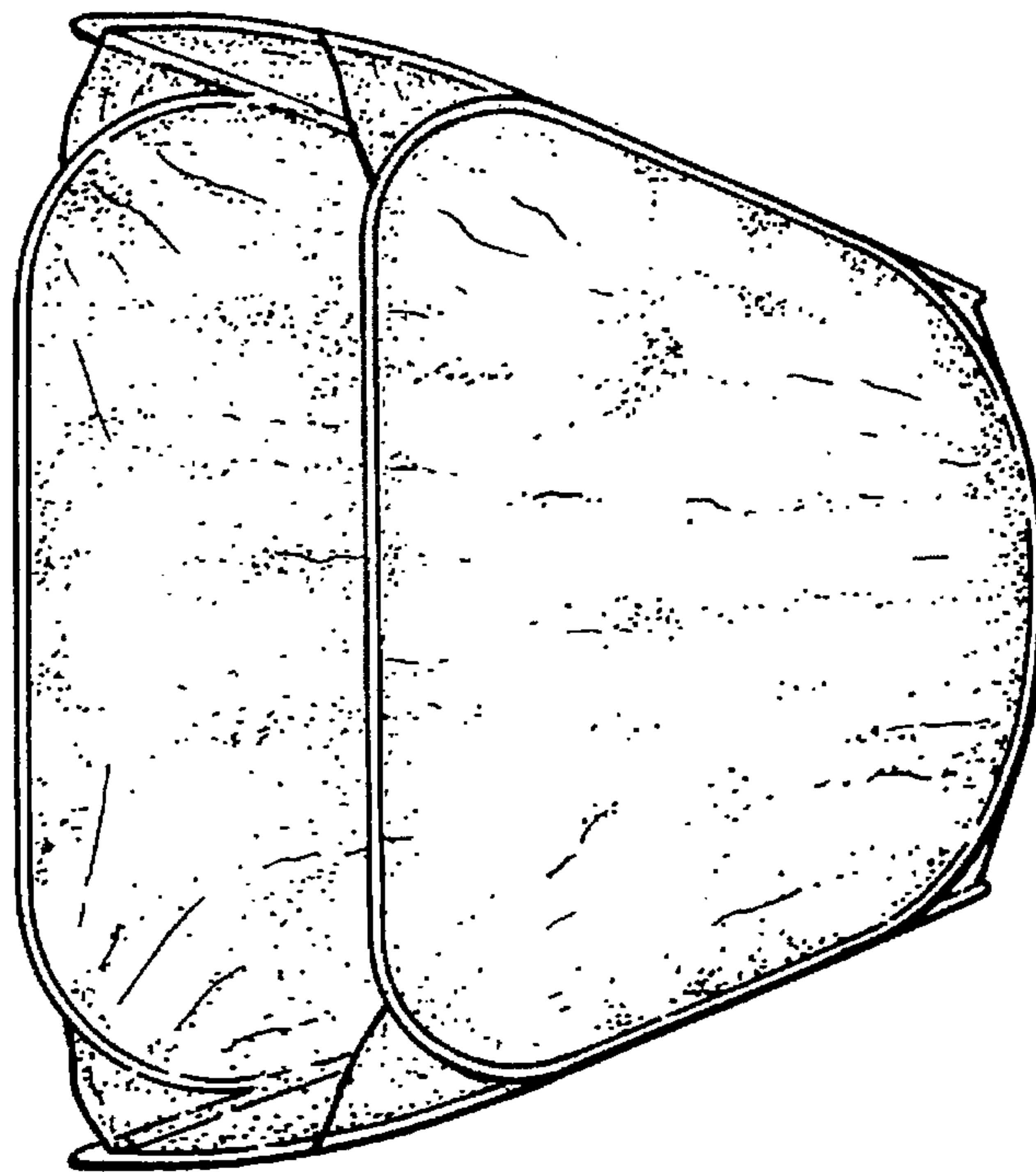

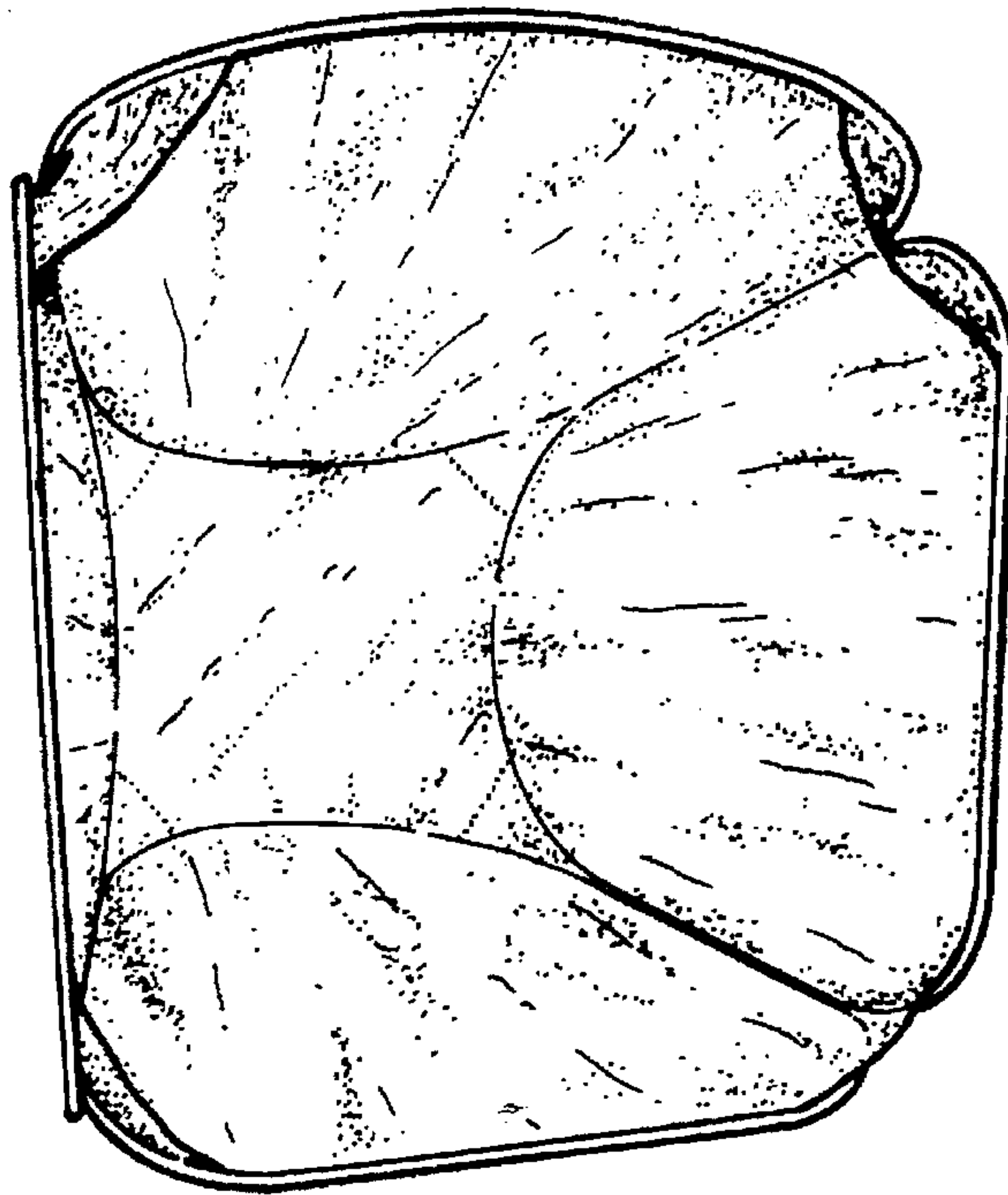

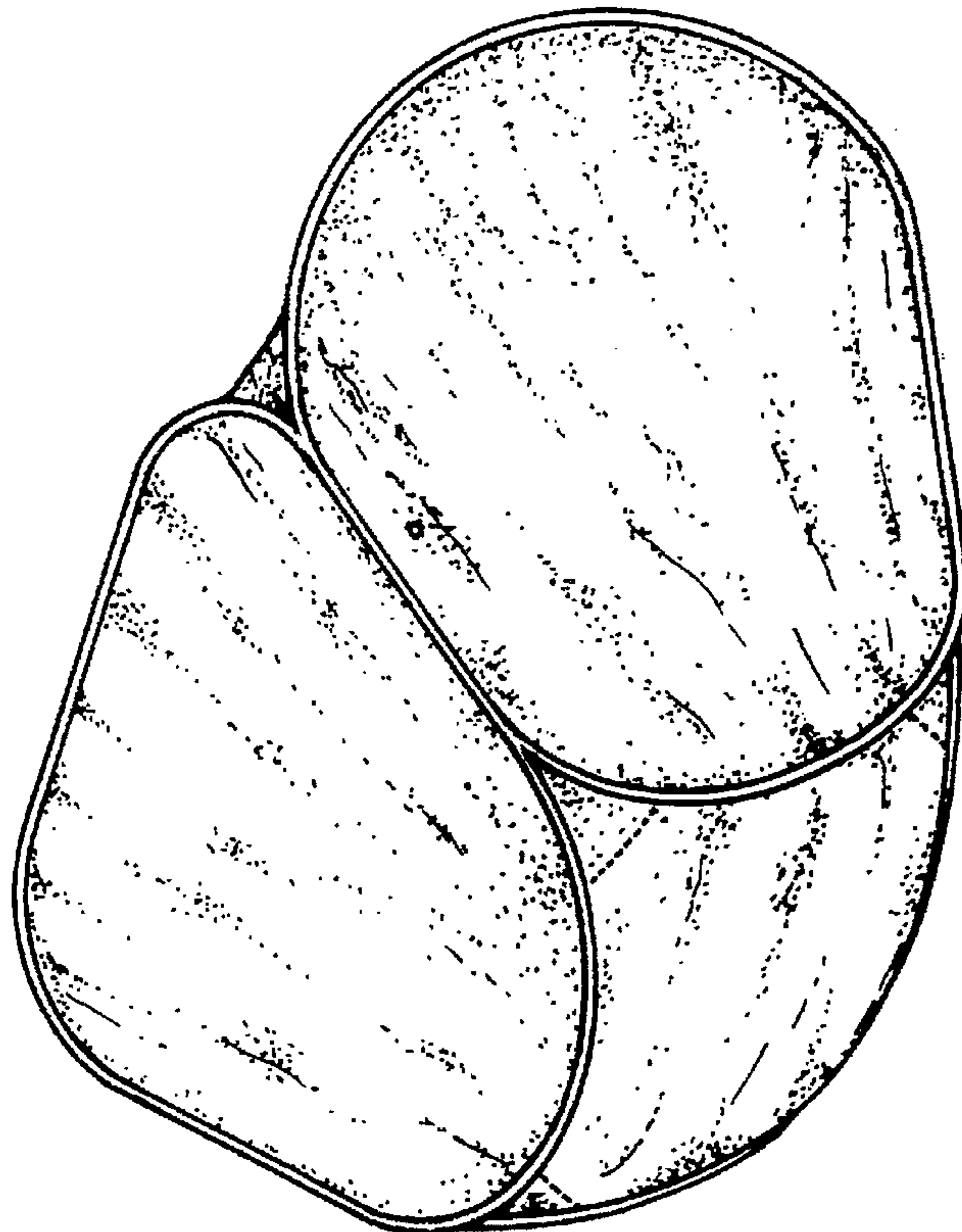

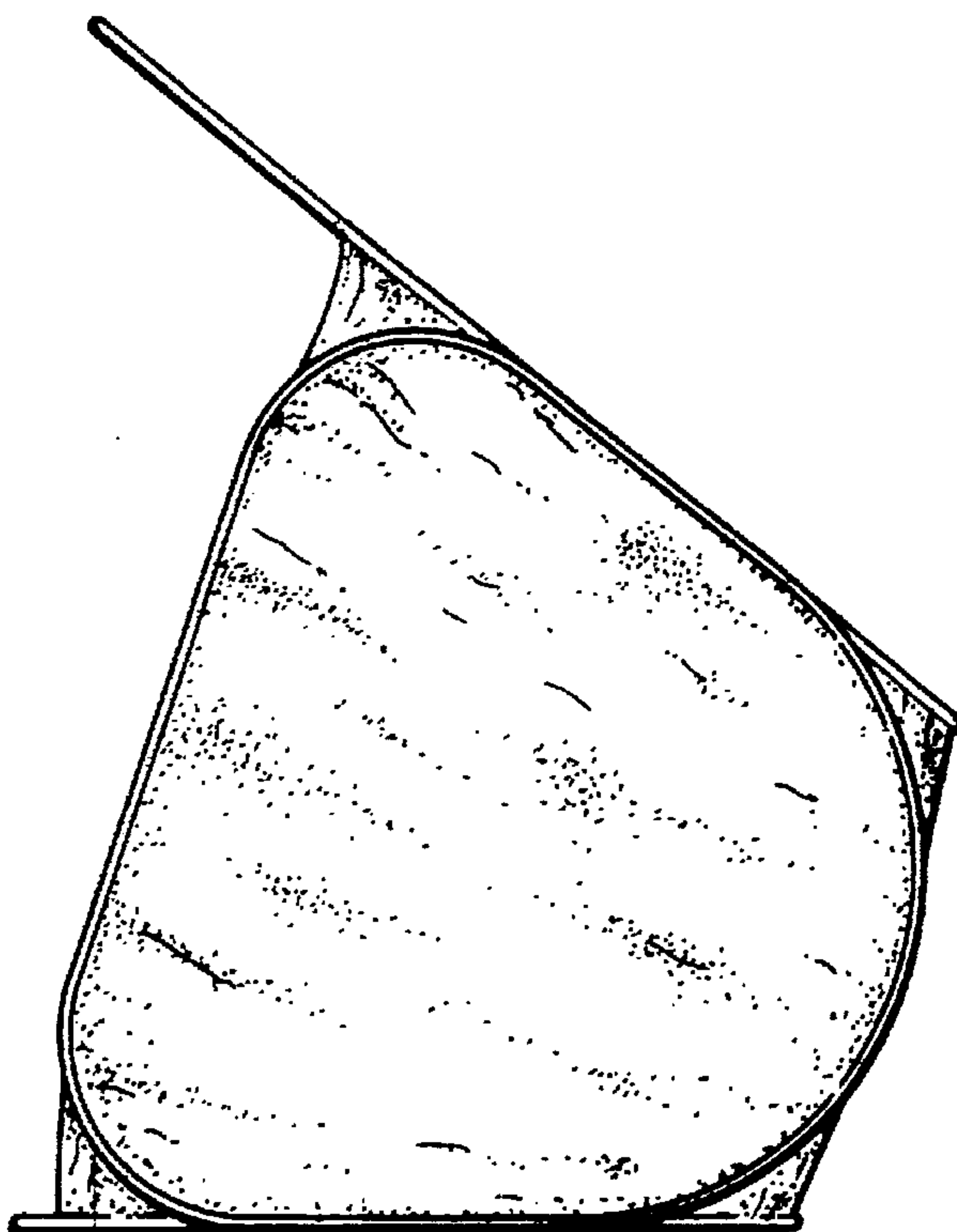
