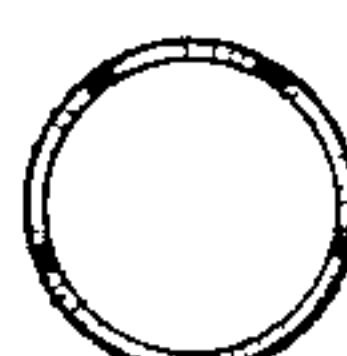
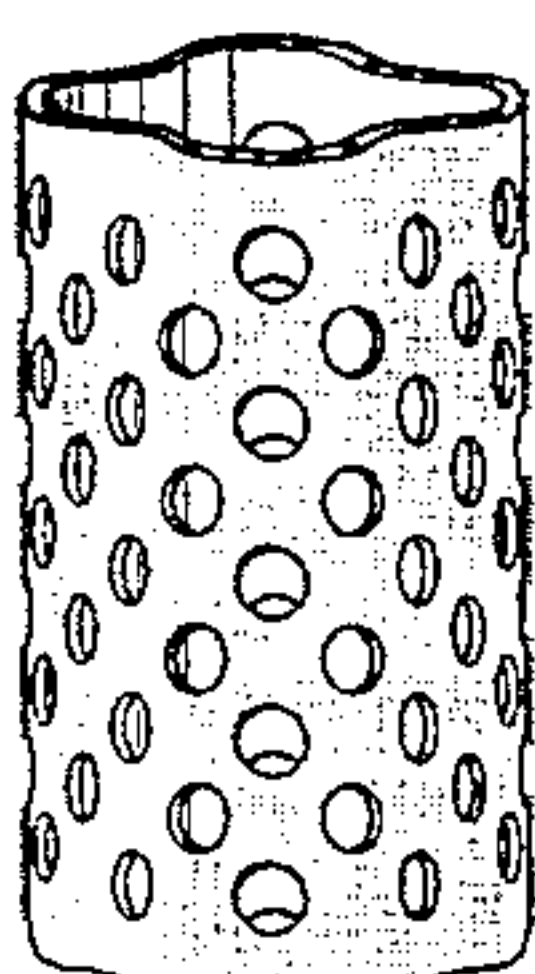
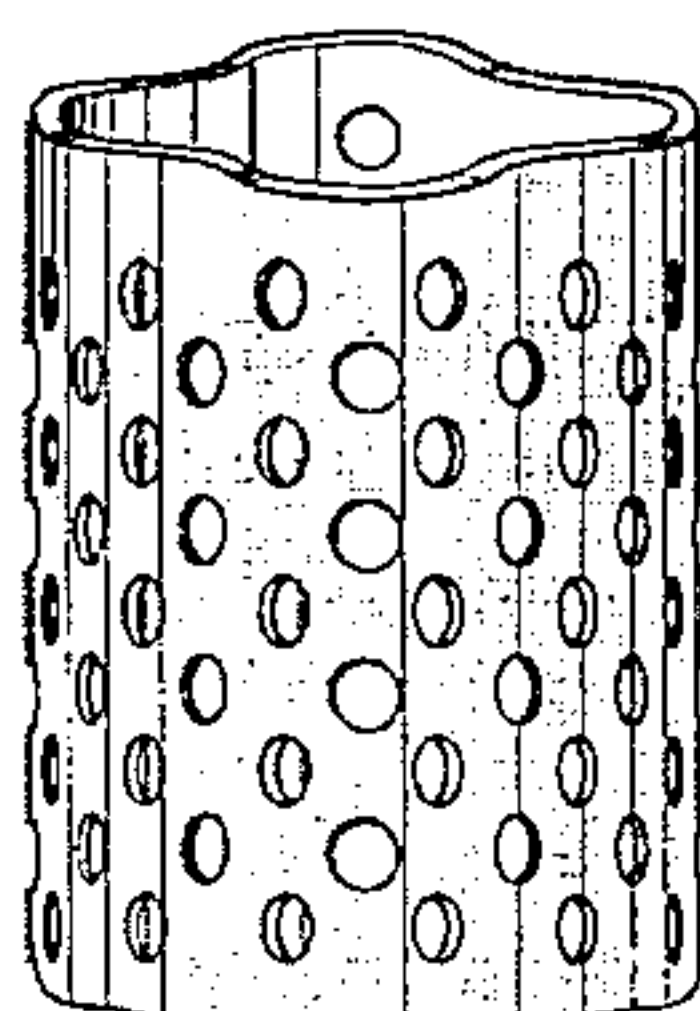
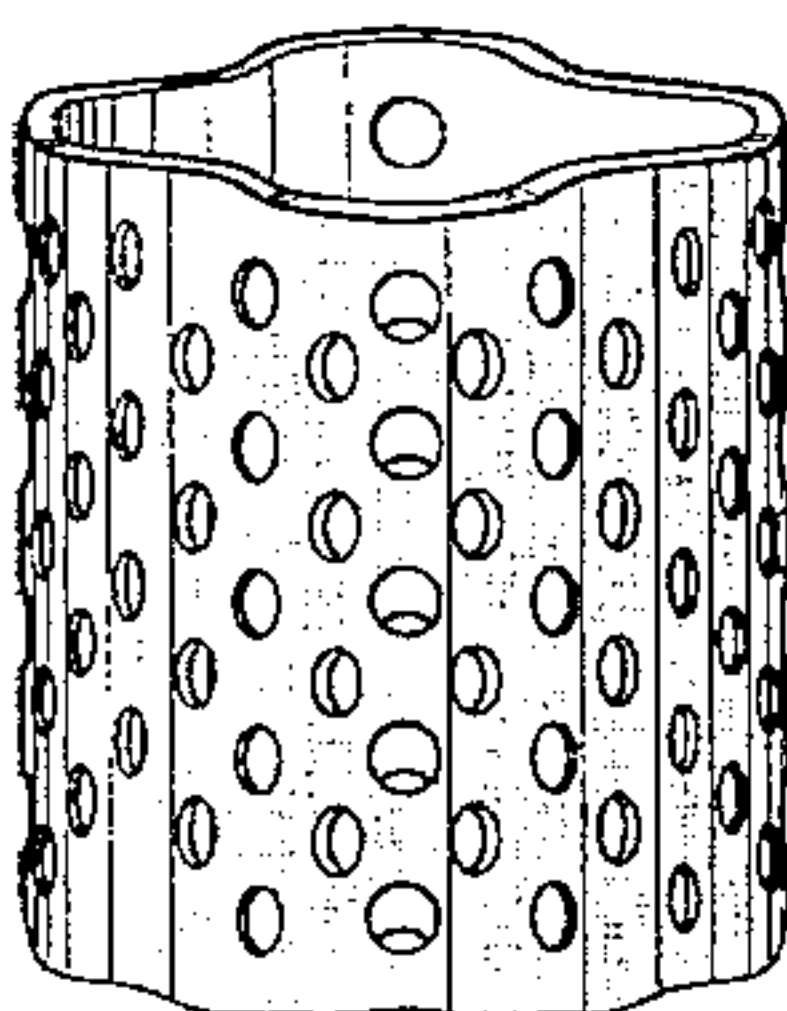
## [57] CLAIM

The ornamental design for a hair roller, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective drawing of our new design; FIG. 2 is a front elevational view thereof, with the rear elevational view being identical thereto; FIG. 3 is a bottom plan view, with the top plan view being identical thereto; FIG. 4 is a left side elevational view thereof, with the right side elevational view being identical thereto; FIG. 5 is a perspective view of a second embodiment of our new design; FIG. 6 is a front elevational view thereof, with the rear elevational view being identical thereto; FIG. 7 is a top plan view thereof, with the bottom plan view being identical thereto; FIG. 8 is a right side elevational view, with the left side elevational view being identical thereto; FIG. 9 is a top plan view of a third embodiment, the bottom plan view being identical thereto; FIG. 10 is a perspective view thereof; FIG. 11 is a front elevational view thereof, with the rear elevational view, right side elevational view, and left side elevational view being identical thereto; FIG. 12 is a perspective view of a fourth embodiment of our design; FIG. 13 is a top plan view thereof, with the bottom plan view being identical thereto; FIG. 14 is a front elevational view thereof, with the rear elevational view, right side elevational view, and left side elevational view being identical thereto; FIG. 15 is a perspective view of a fifth embodiment of our new design; FIG. 16 is a top plan view thereof, with the bottom plan view being identical thereto; and, FIG. 17 is a front elevational view thereof, with the rear elevational view, right elevational view, and left elevational view being identical thereto.

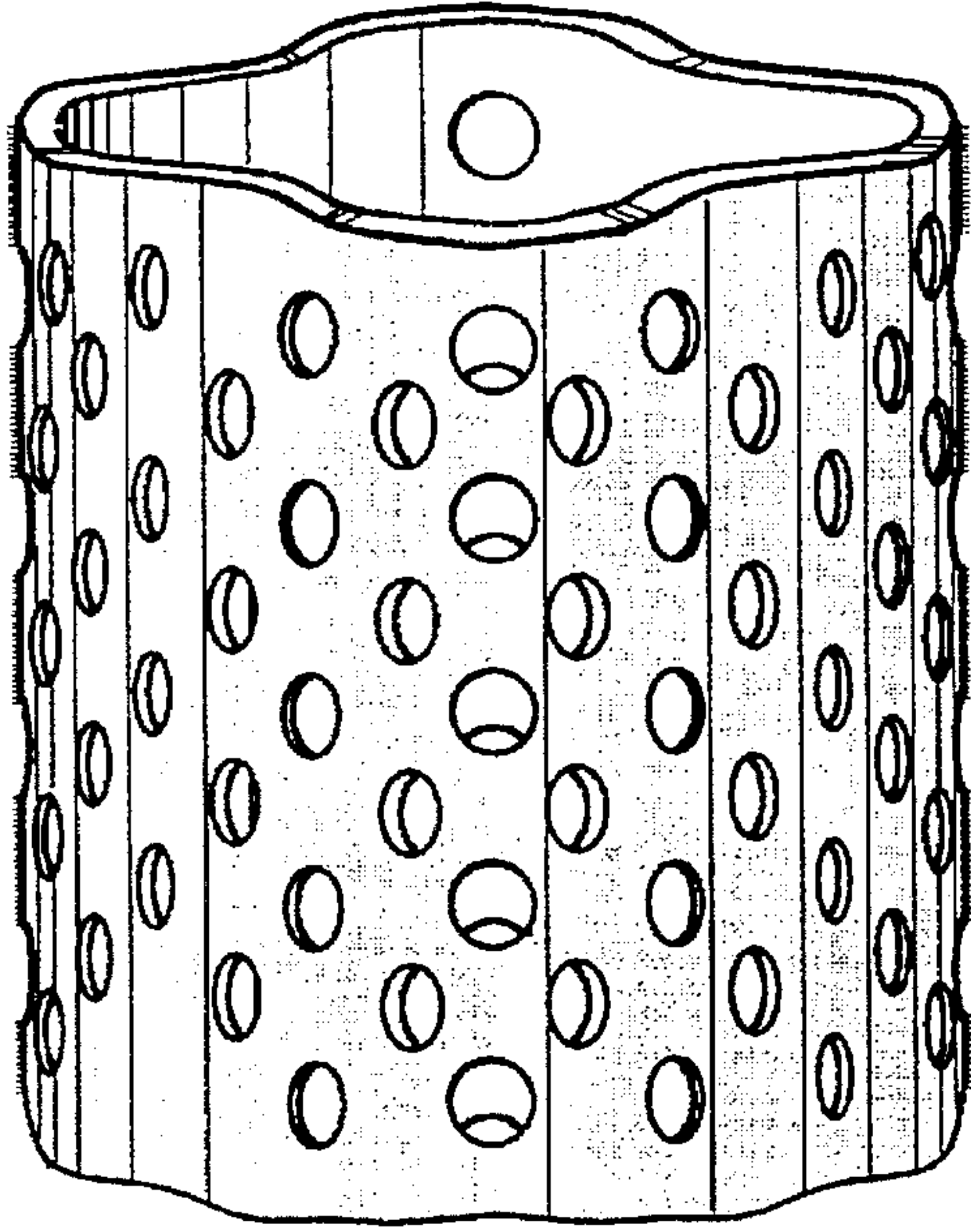

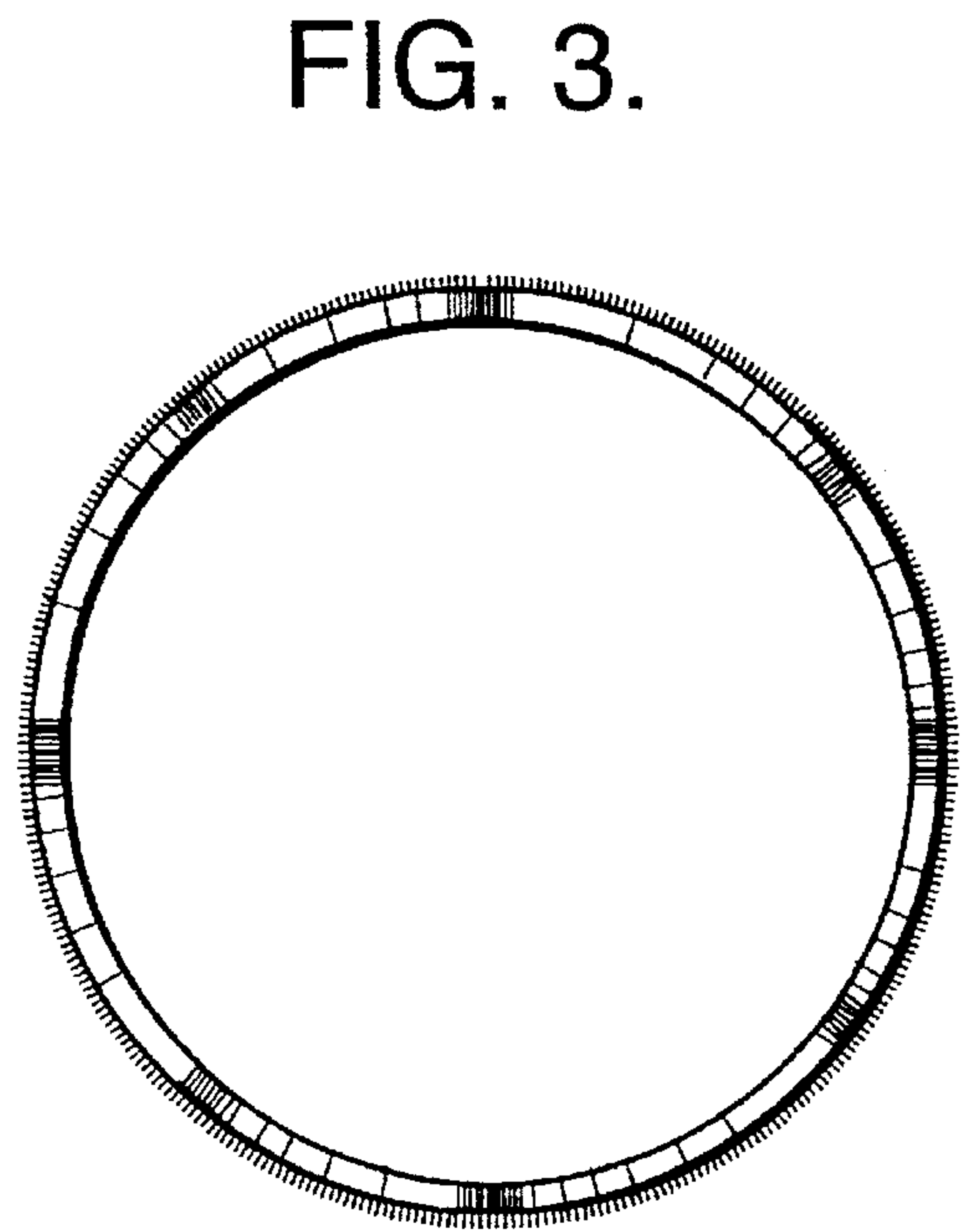
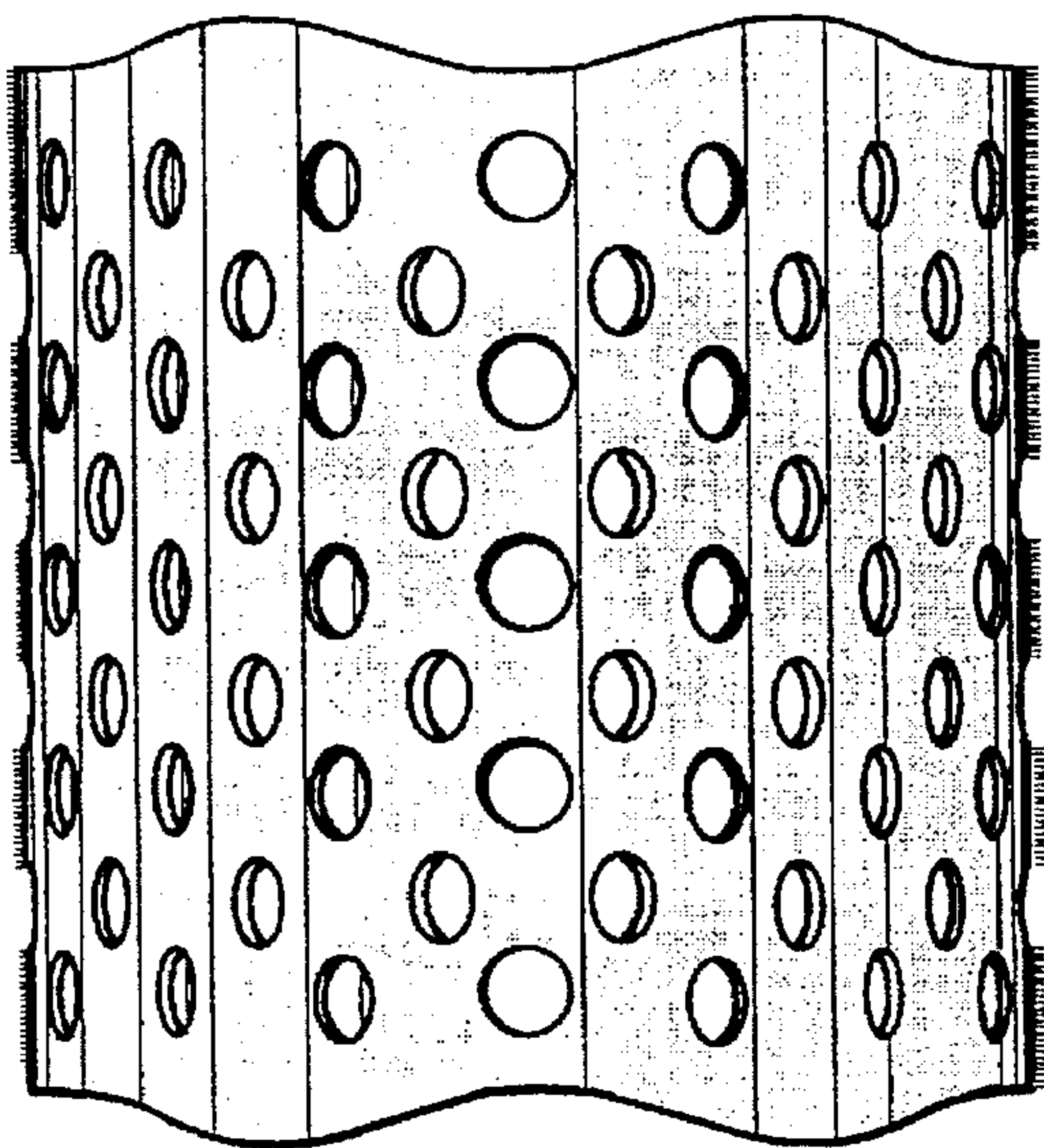

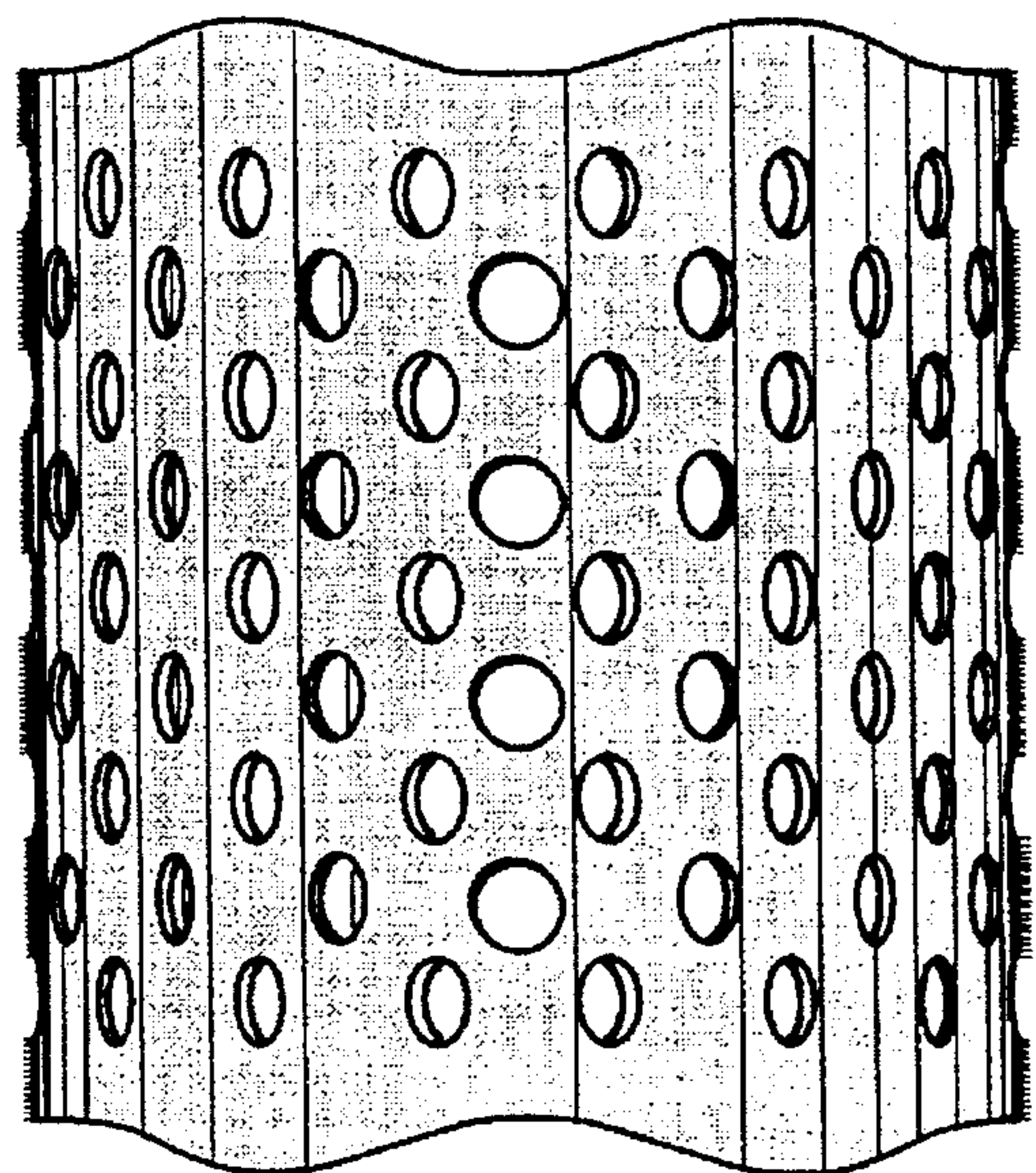

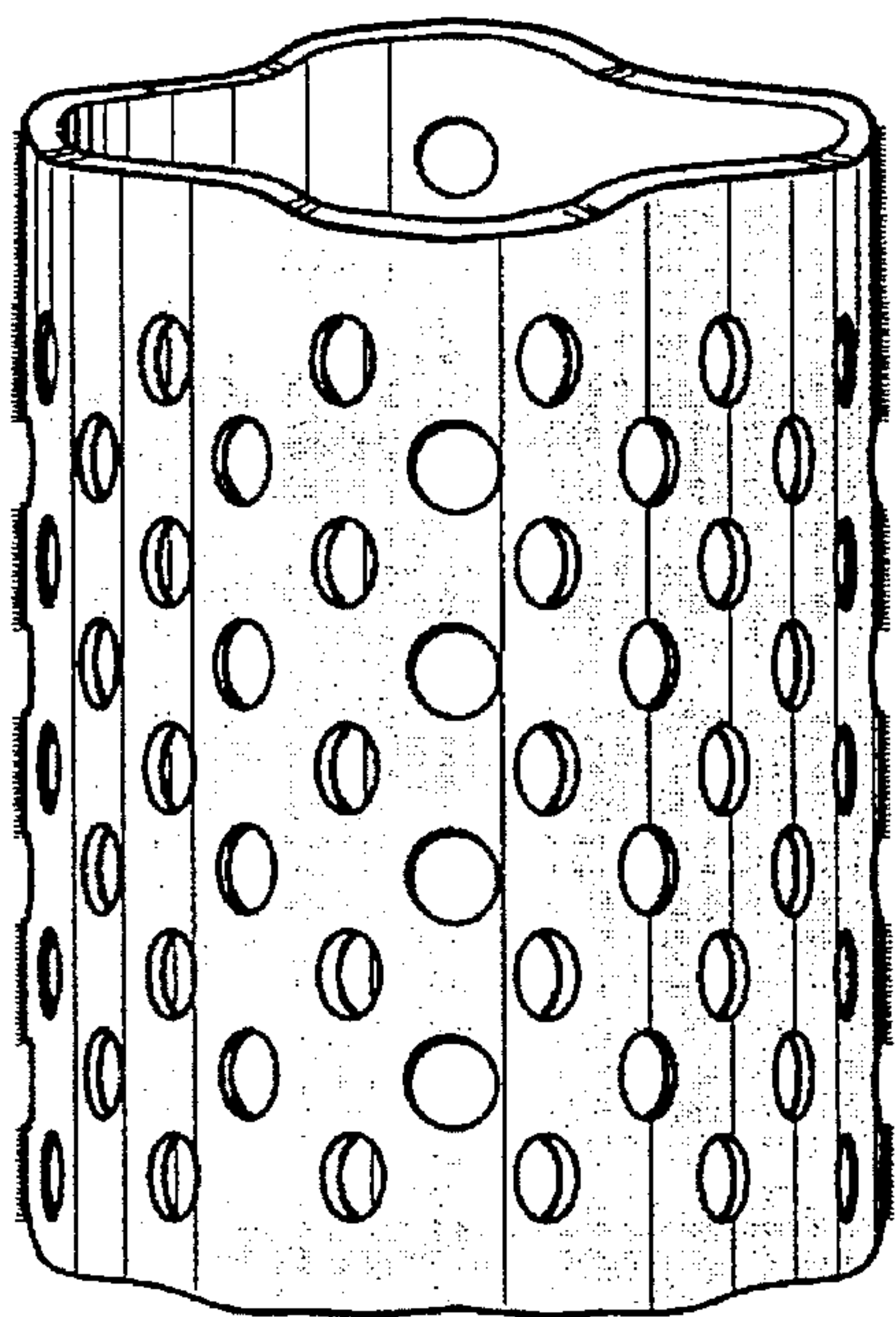

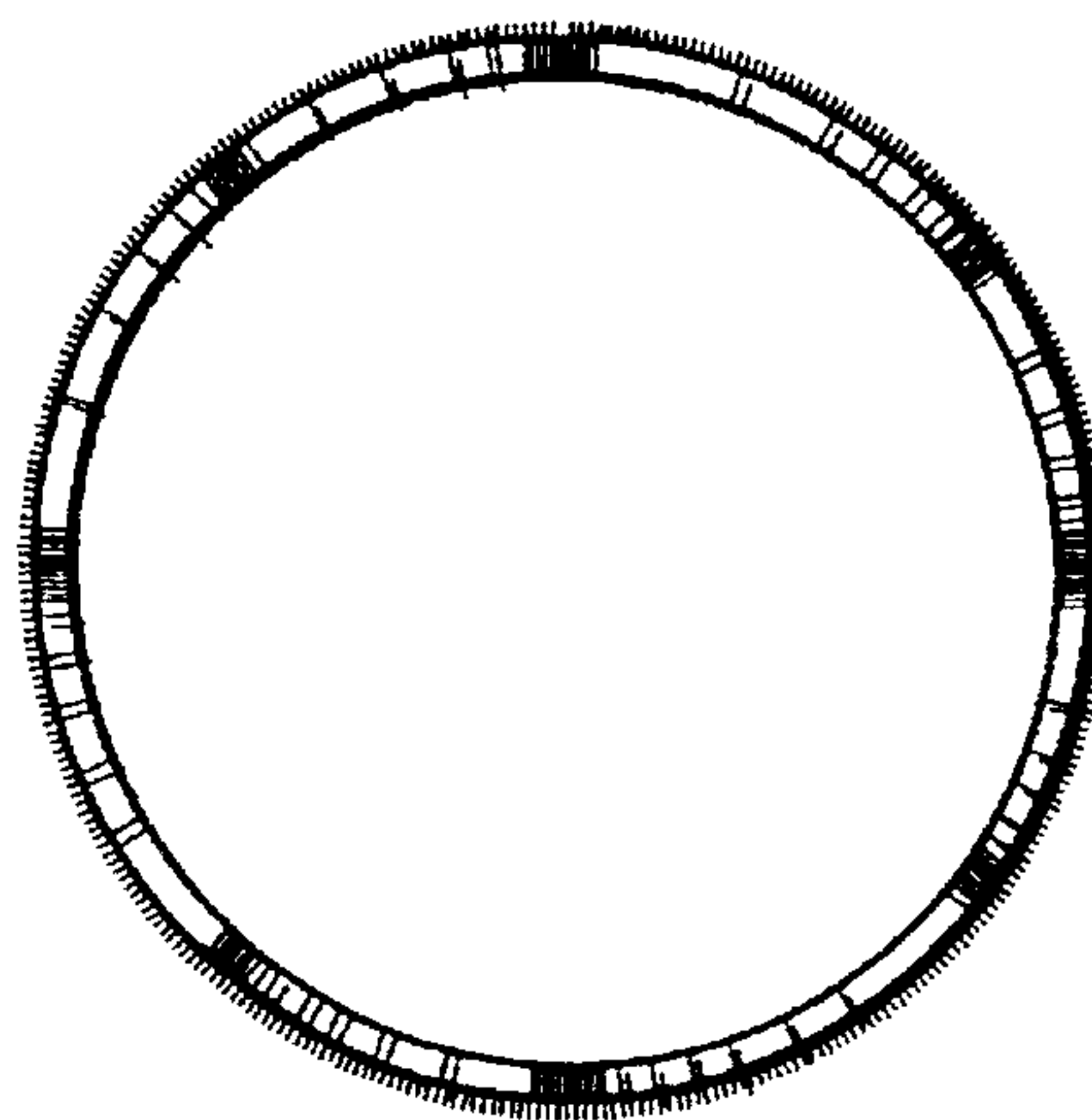

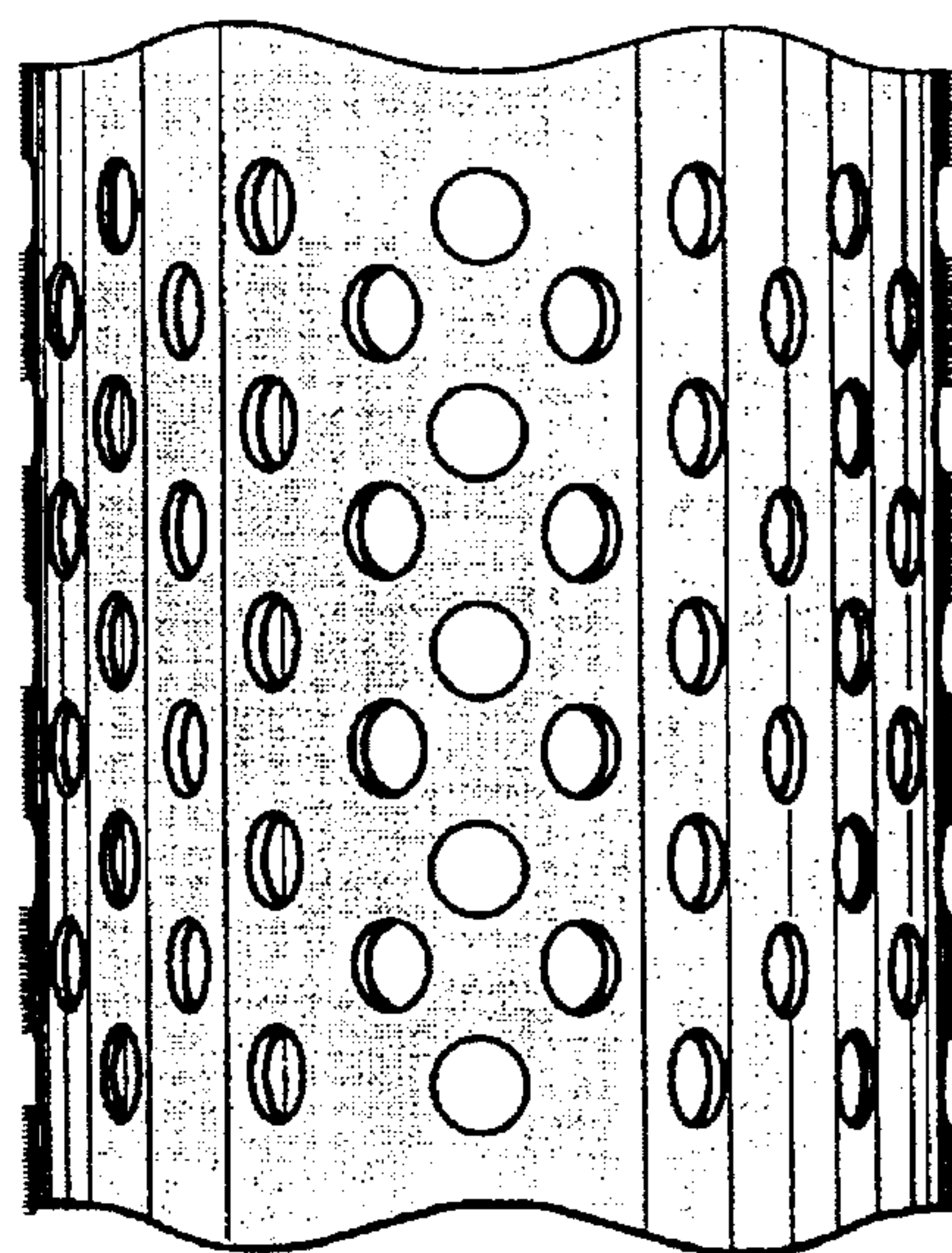
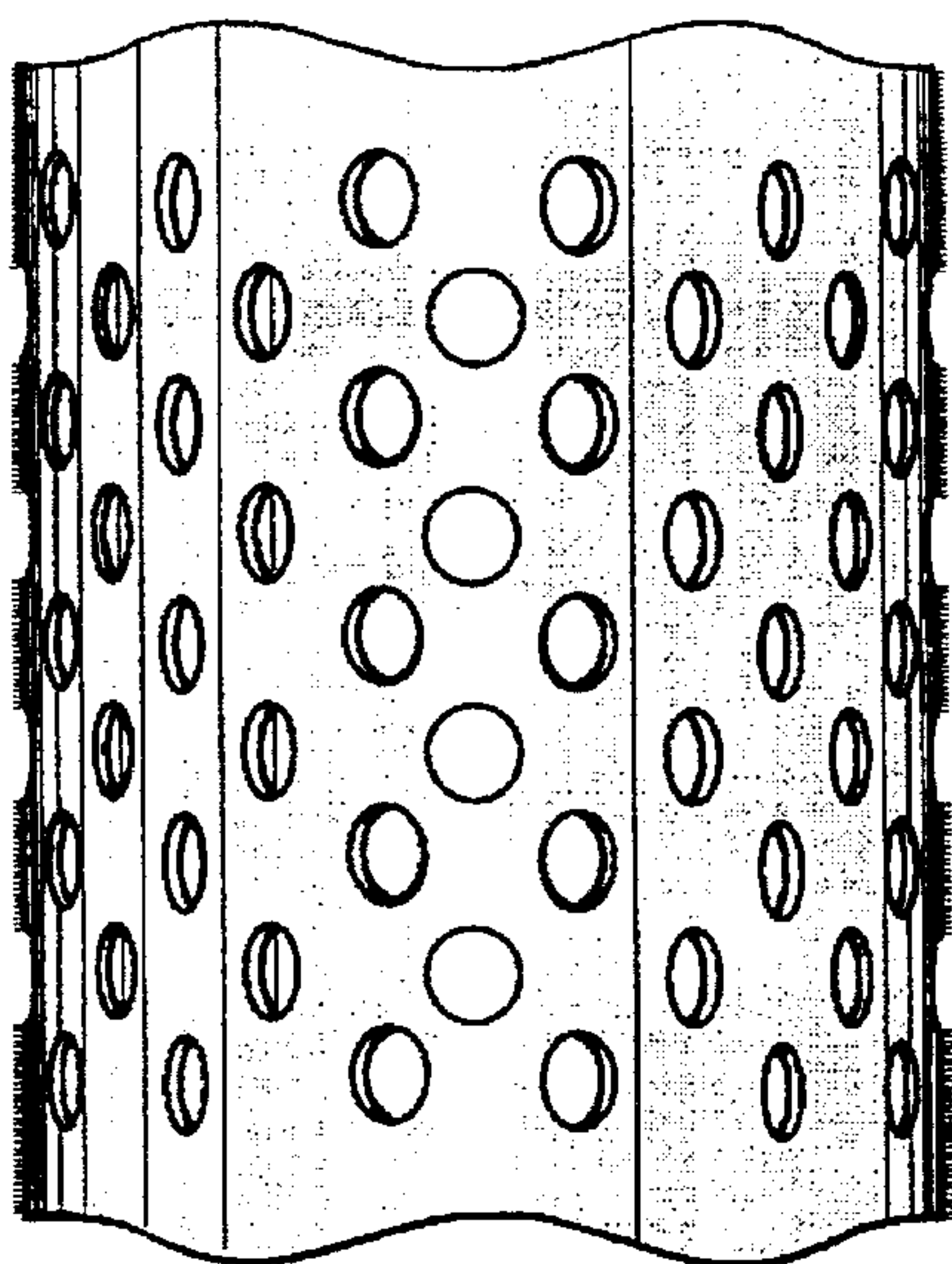

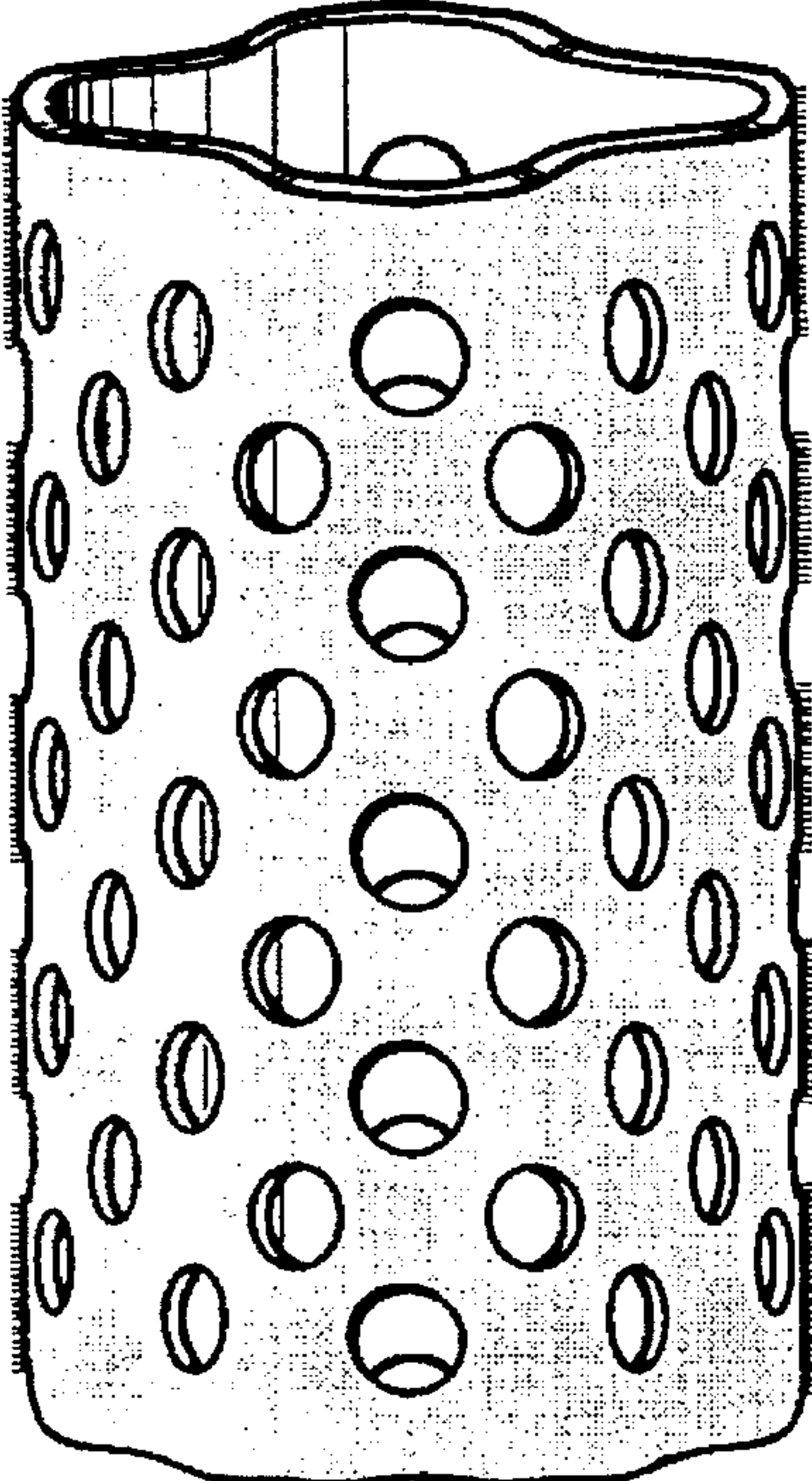
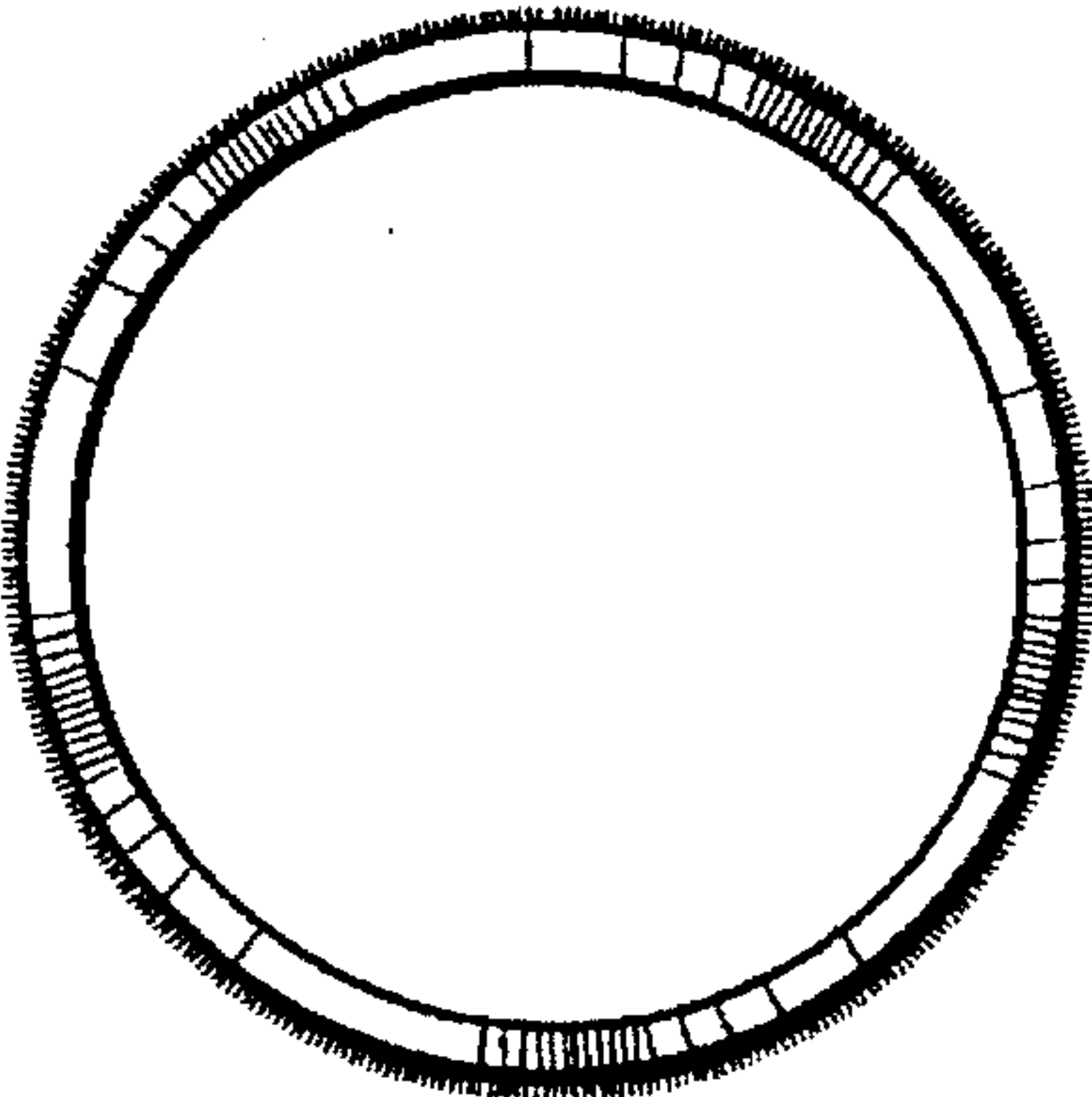

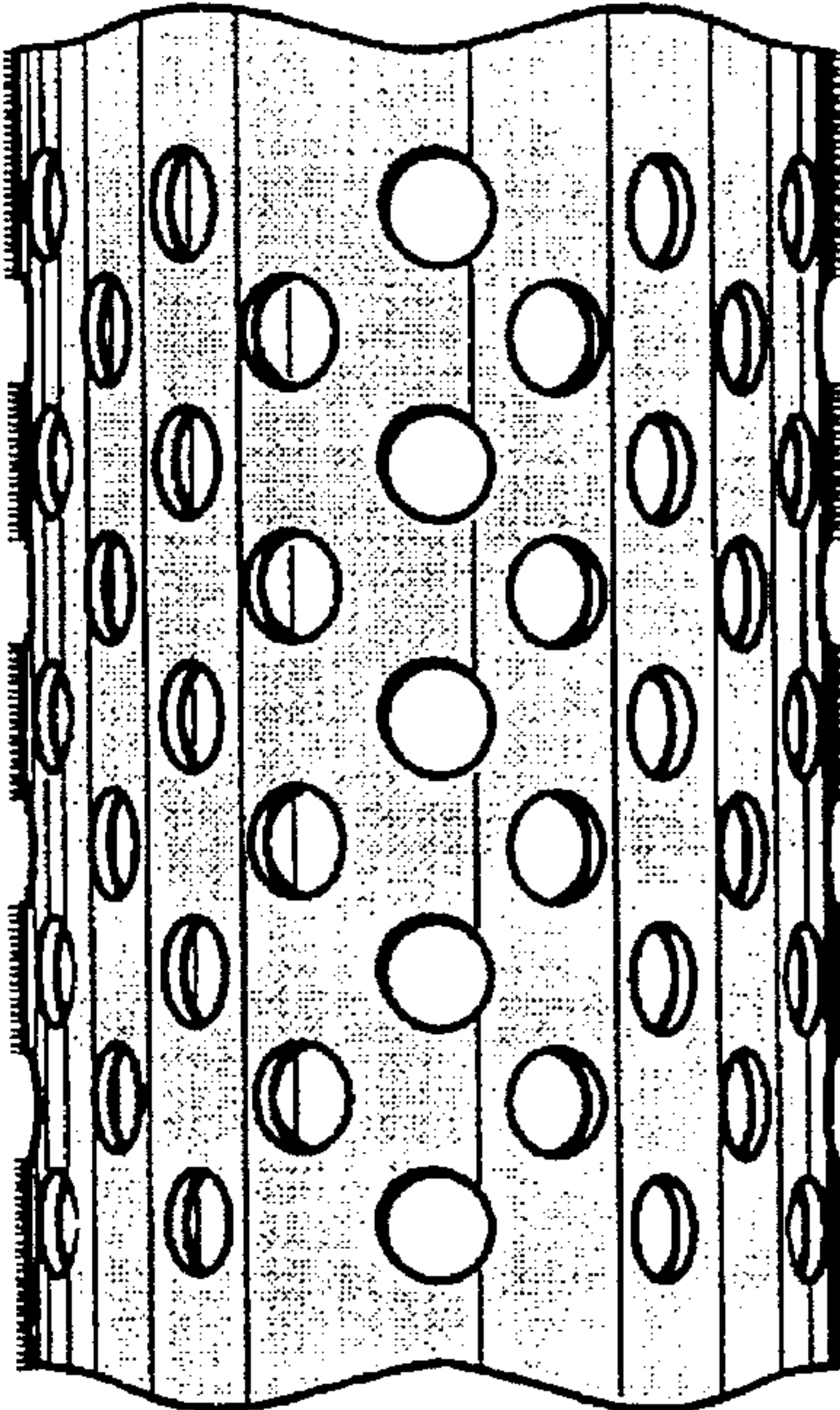

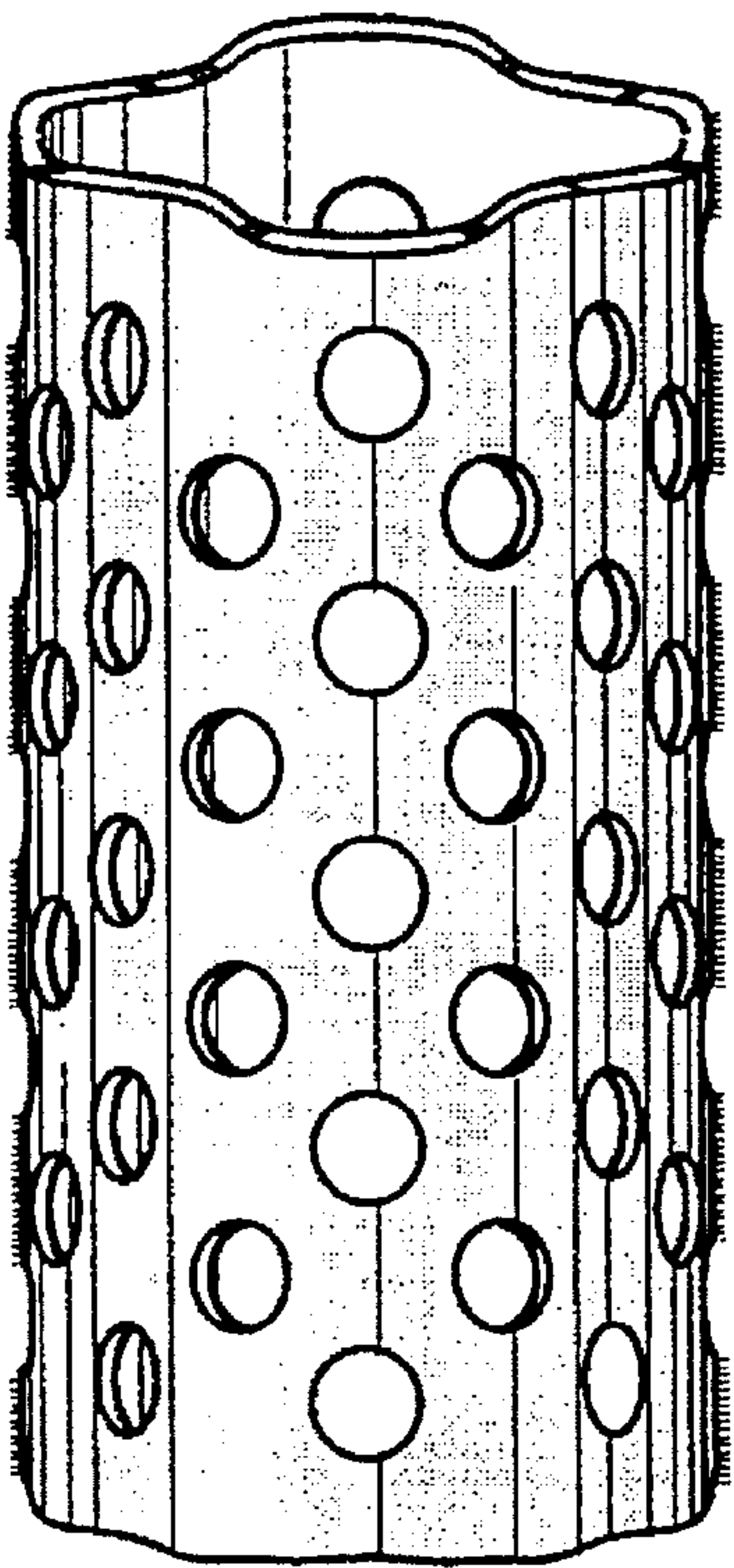
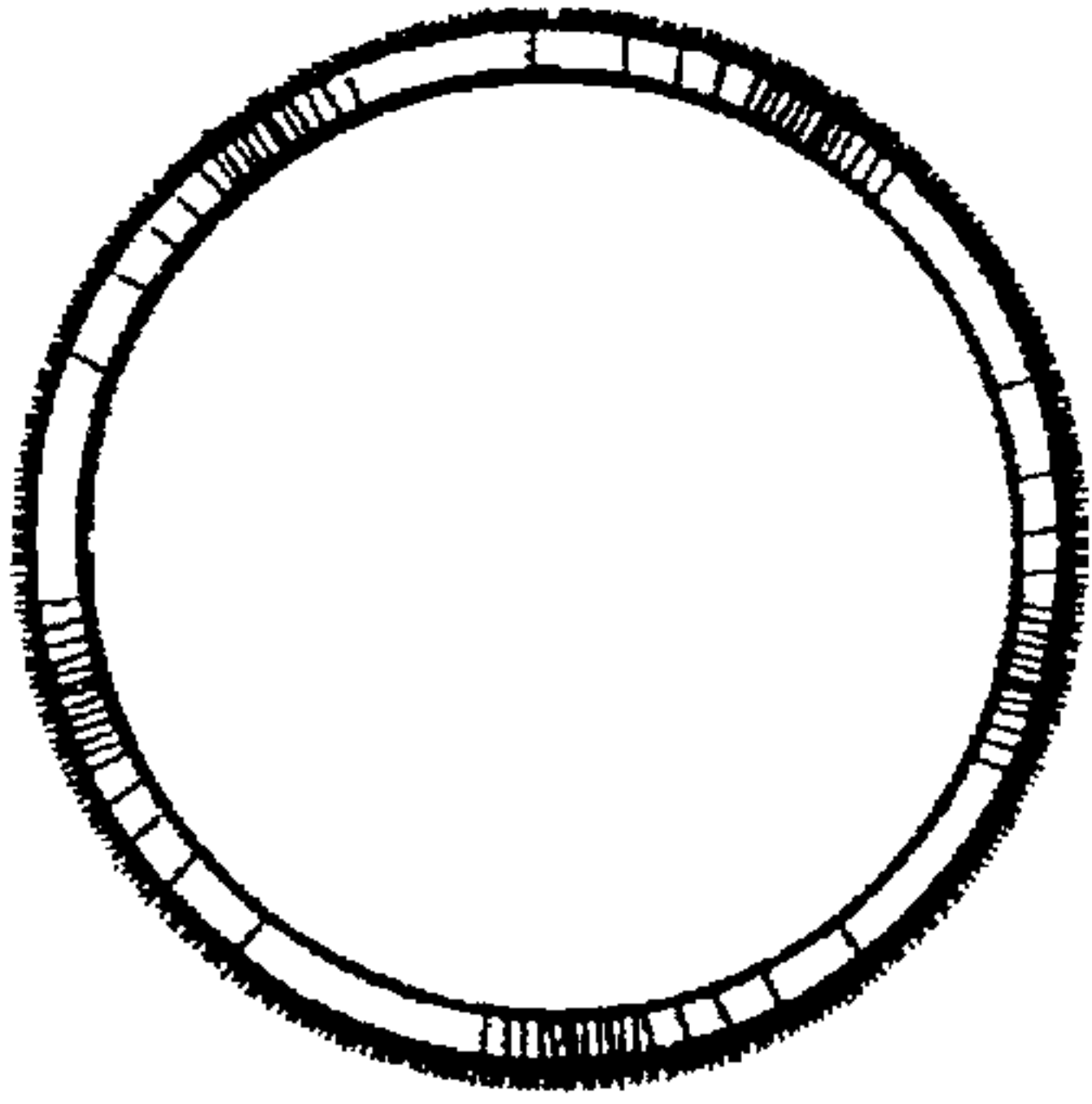

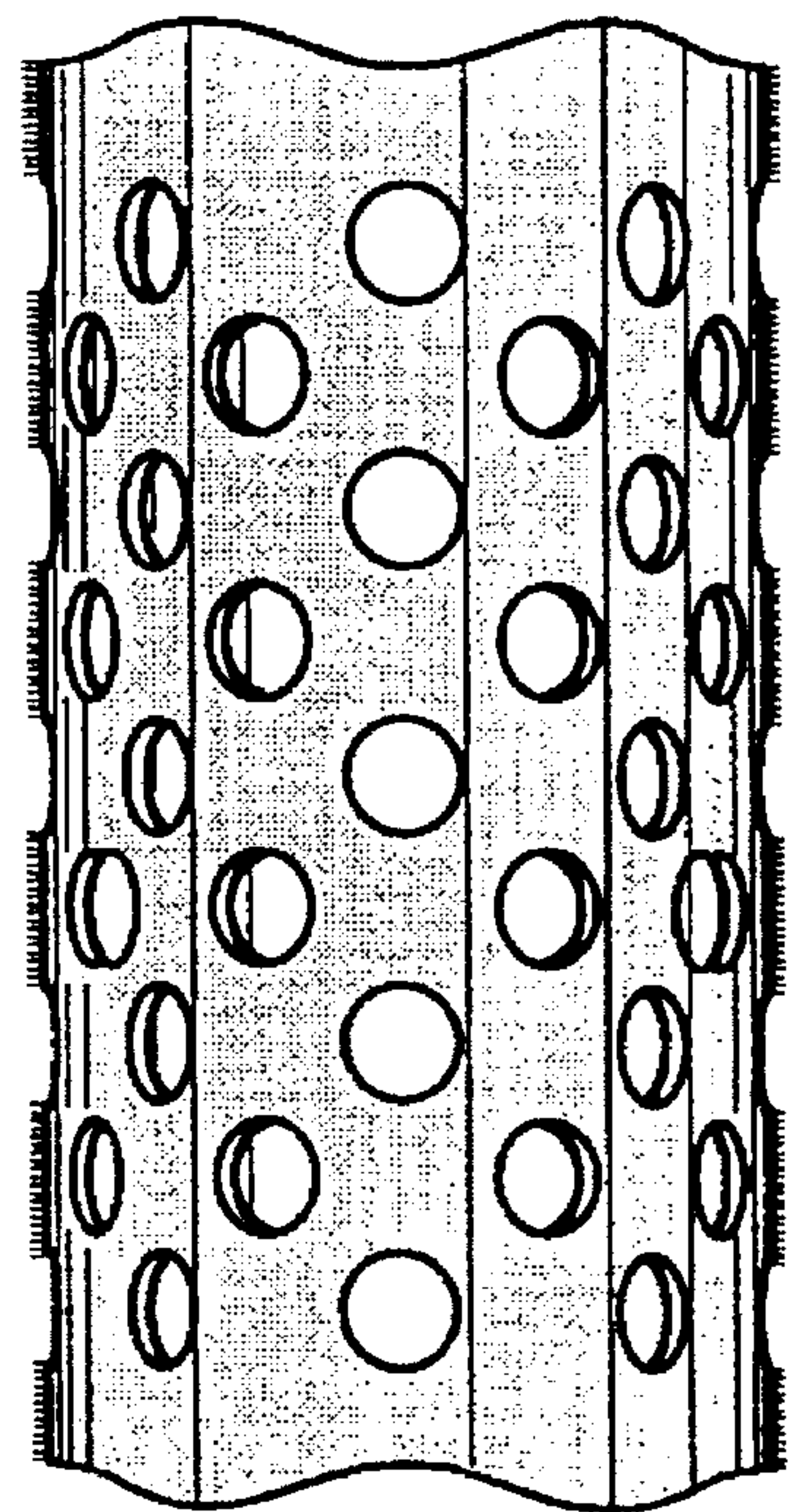

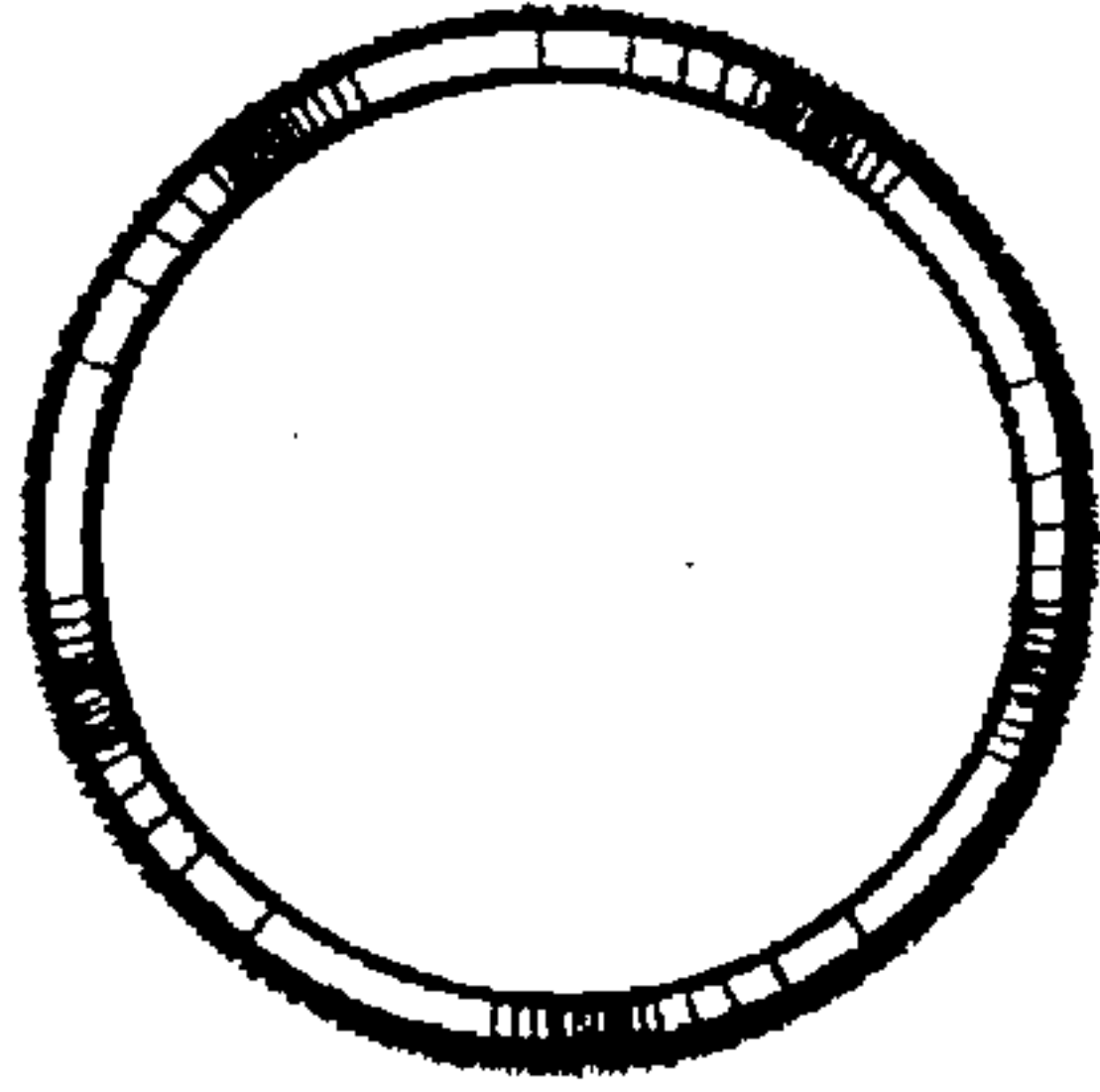

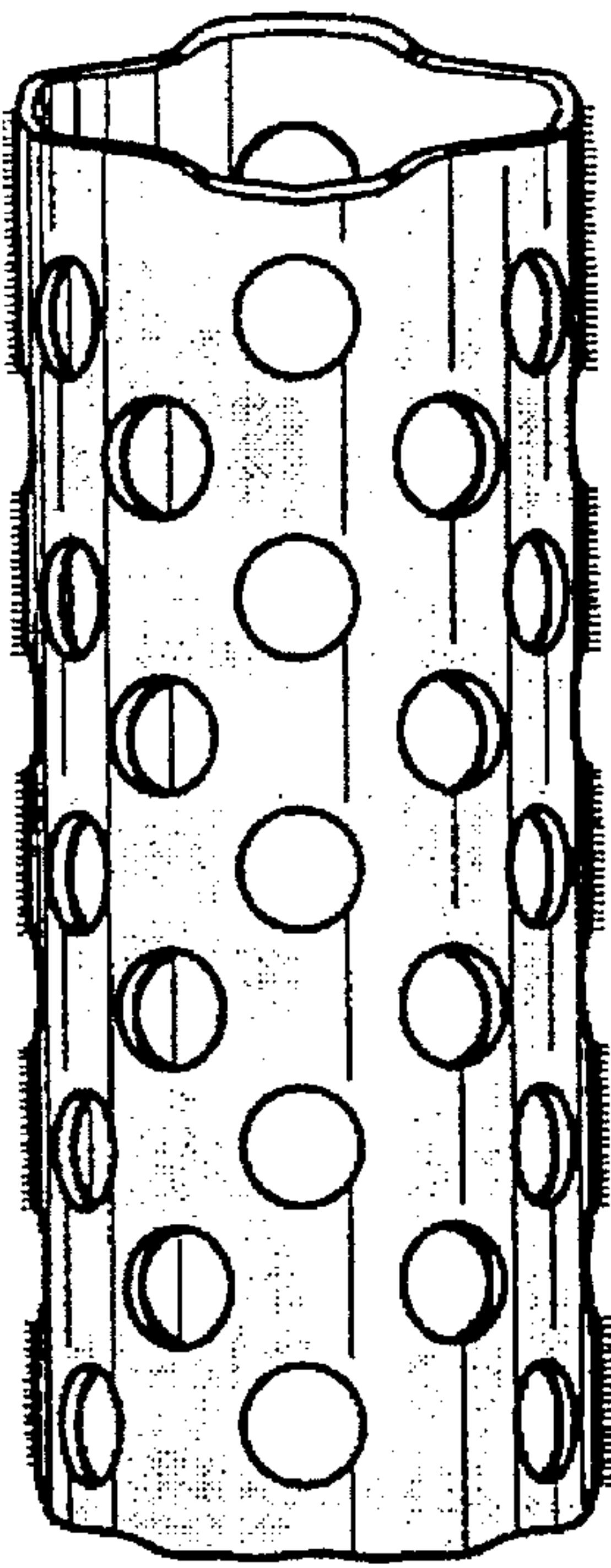
