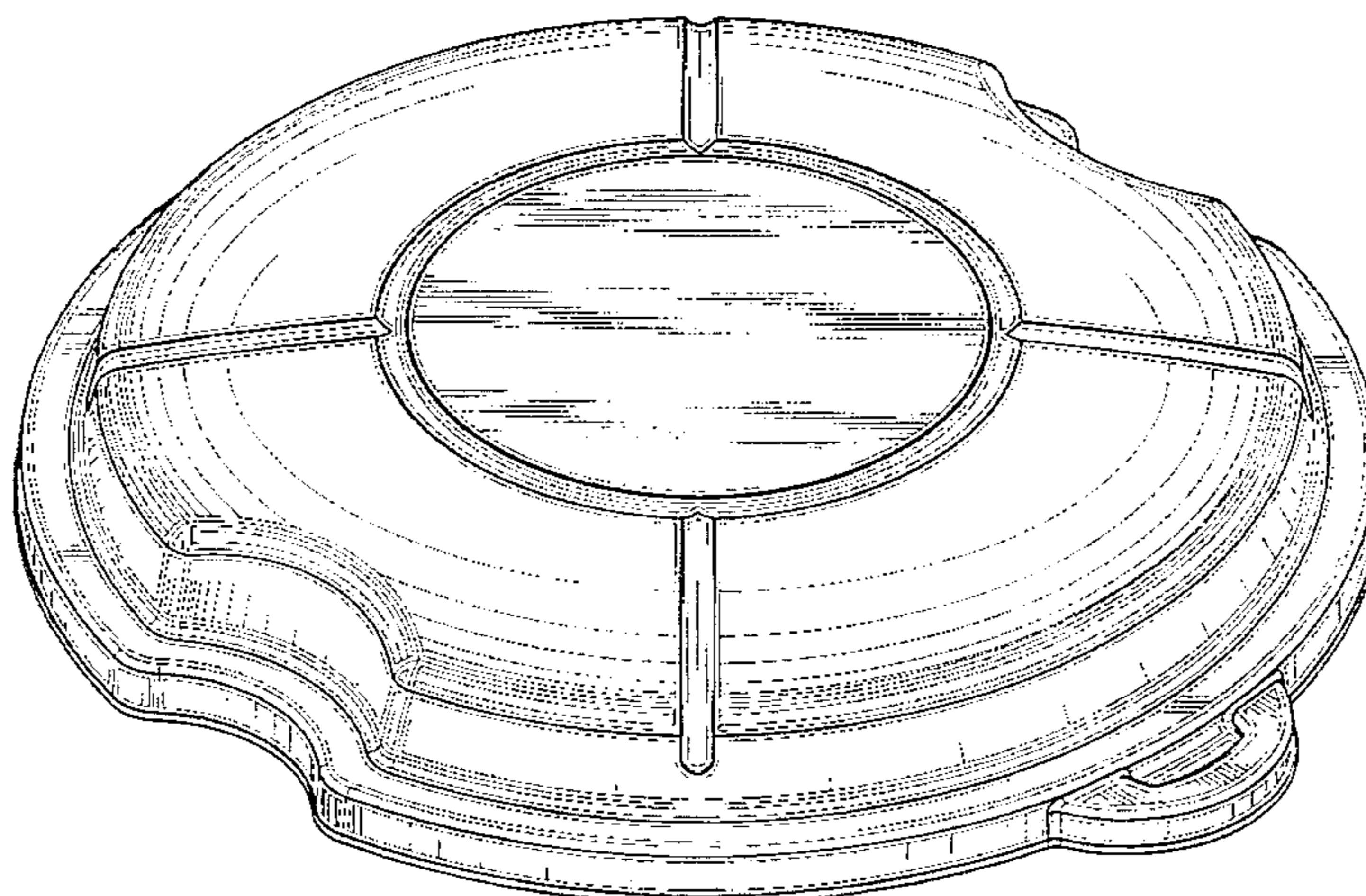
[57] CLAIM

The ornamental design for a refuse container lid, as shown and described.

DESCRIPTION

- FIG. 1 is a top right front perspective view of a refuse container lid showing our new design;
- FIG. 2 is a top plan view thereof;
- FIG. 3 is a right side elevational view thereof;
- FIG. 4 is a front elevational view thereof; the rear elevational view being a mirror image; and,
- FIG. 5 is a left side elevational view thereof;

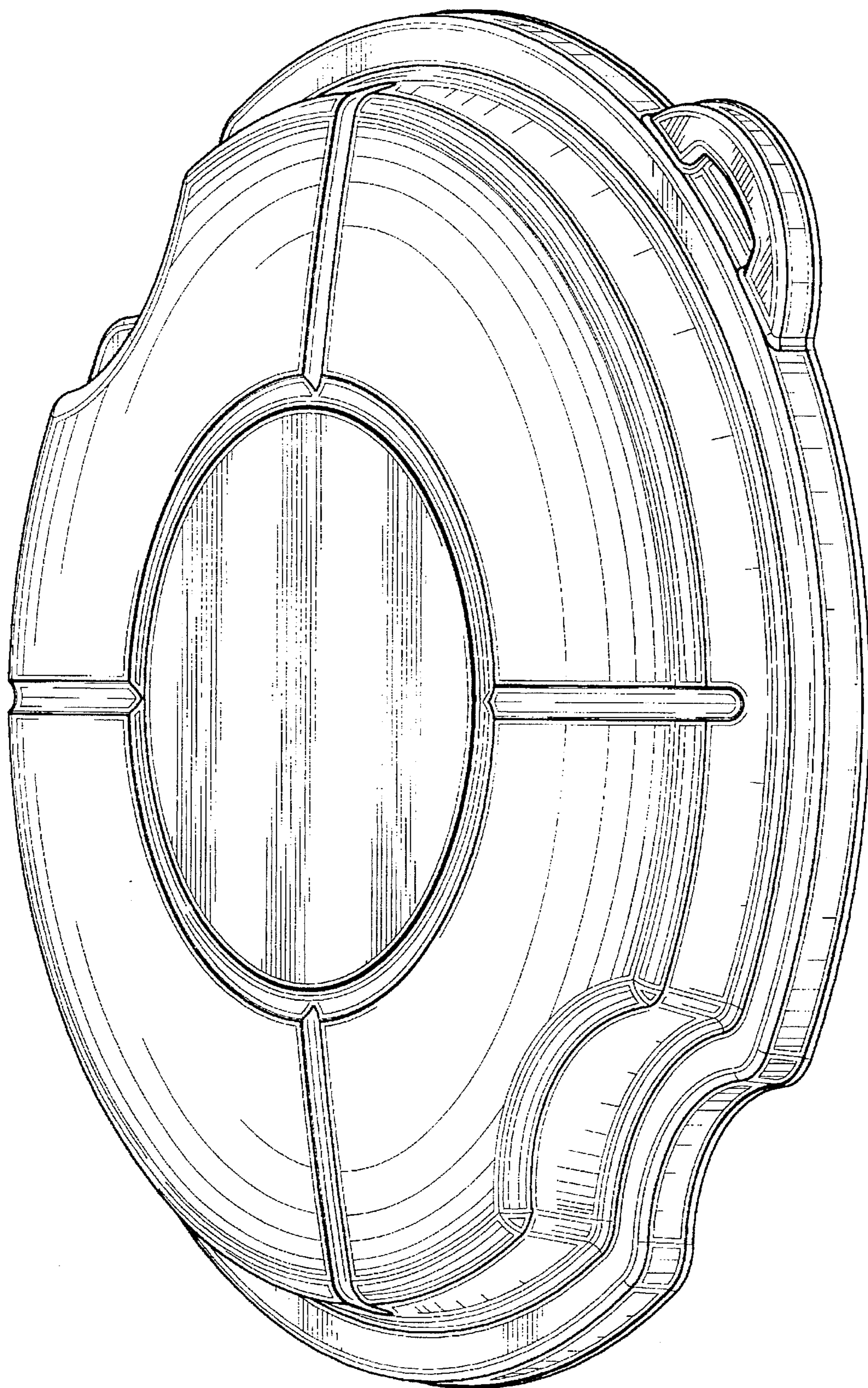

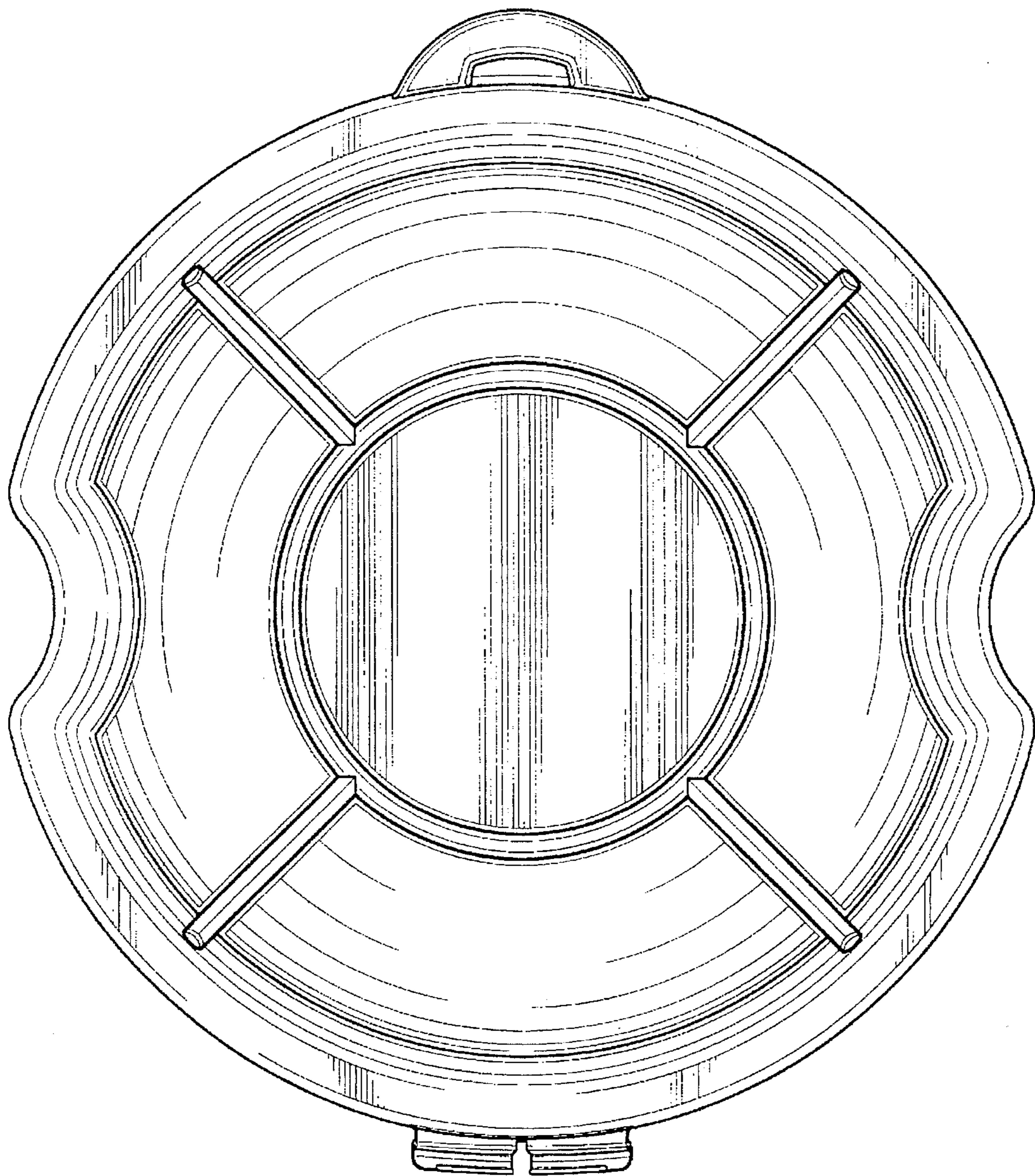

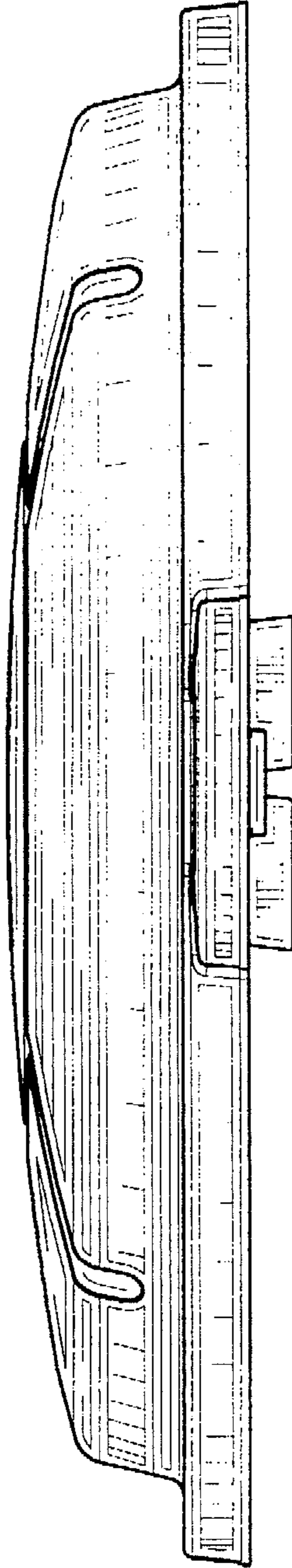

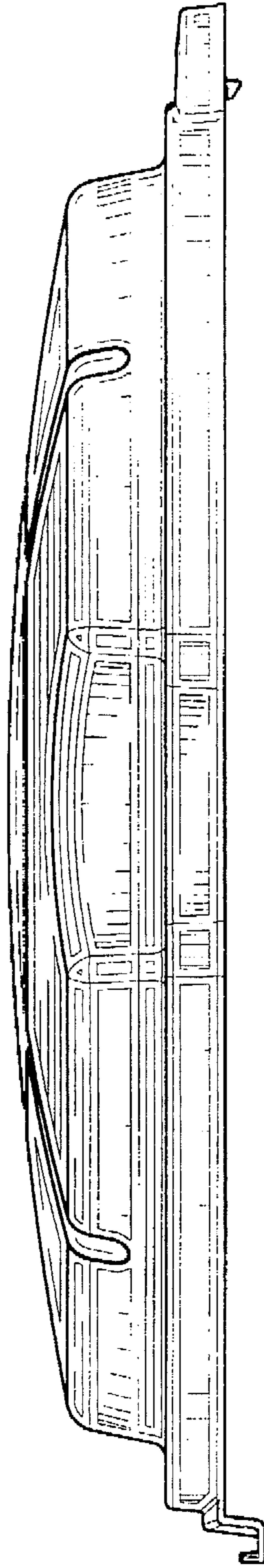

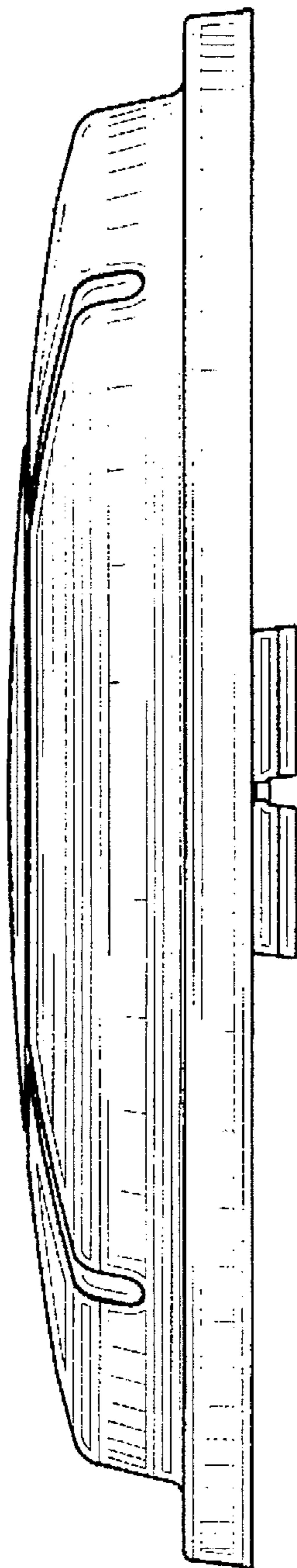
