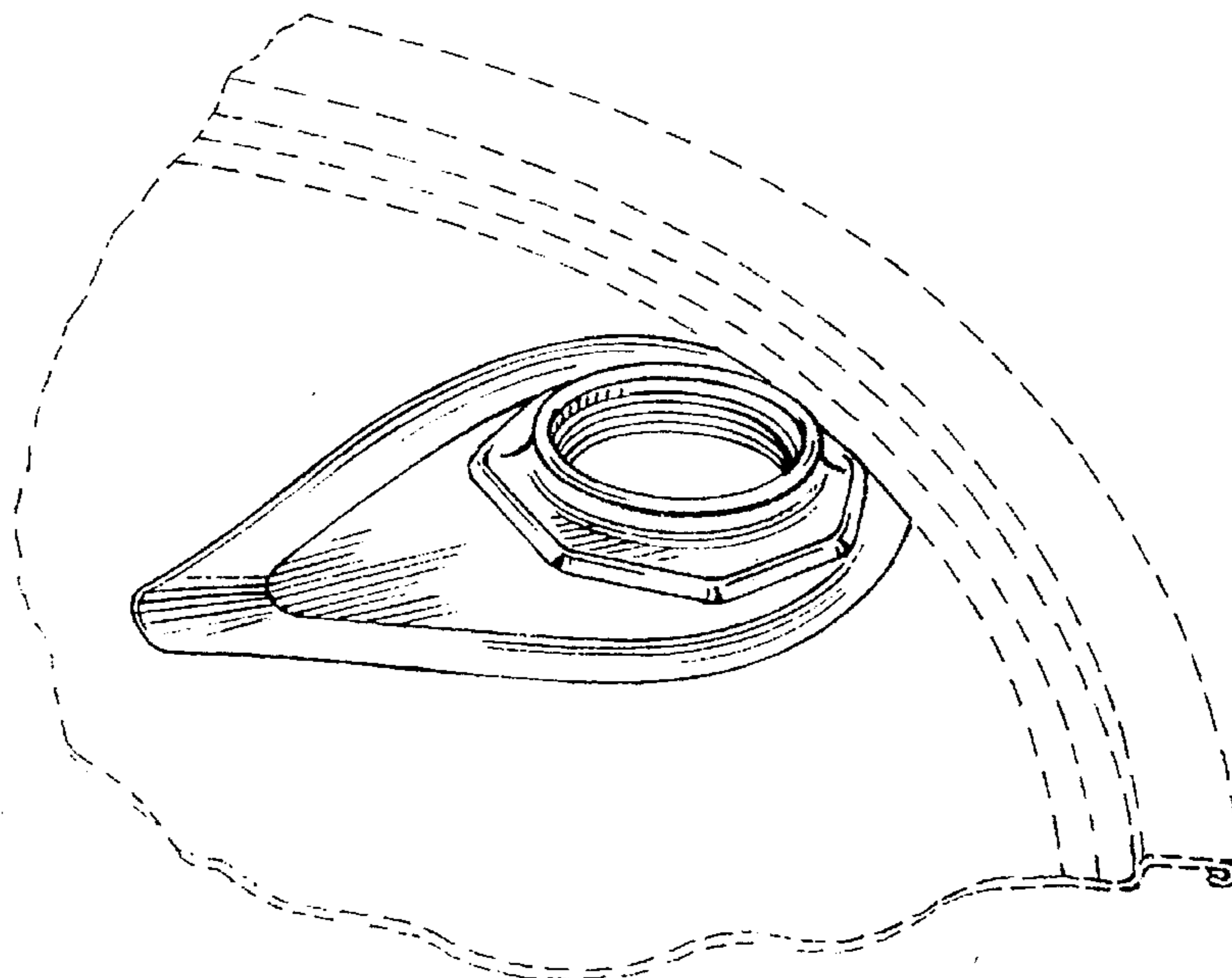
[57] CLAIM

The ornamental design for a drain outlet hole and residue drain, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the drain outlet hole and residue drain embodying my new design;
FIG. 2 is an enlarged fragmentary vertical cross sectional view taken along line 2—2 of FIG. 1;
FIG. 3 is a bottom plan view; and,
FIG. 4 is a perspective view of the invention.
The broken lines showing a drum head in FIGS. 1, 3 and 4 are for illustrative purposes only and do not form part of the claimed design.

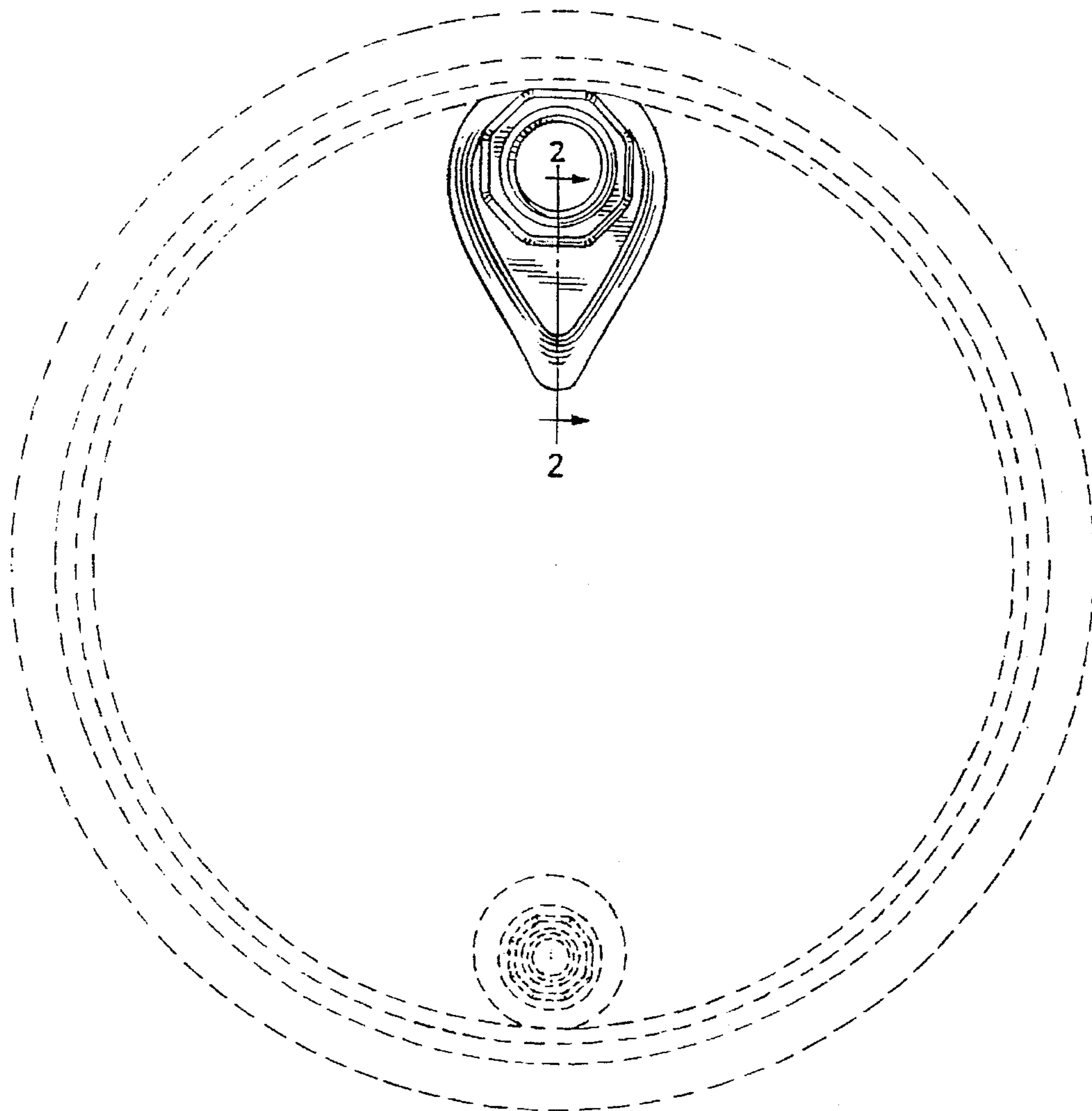

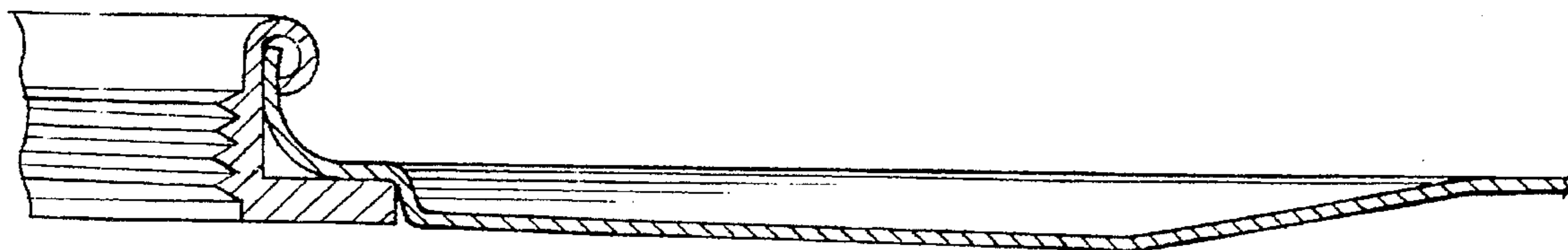

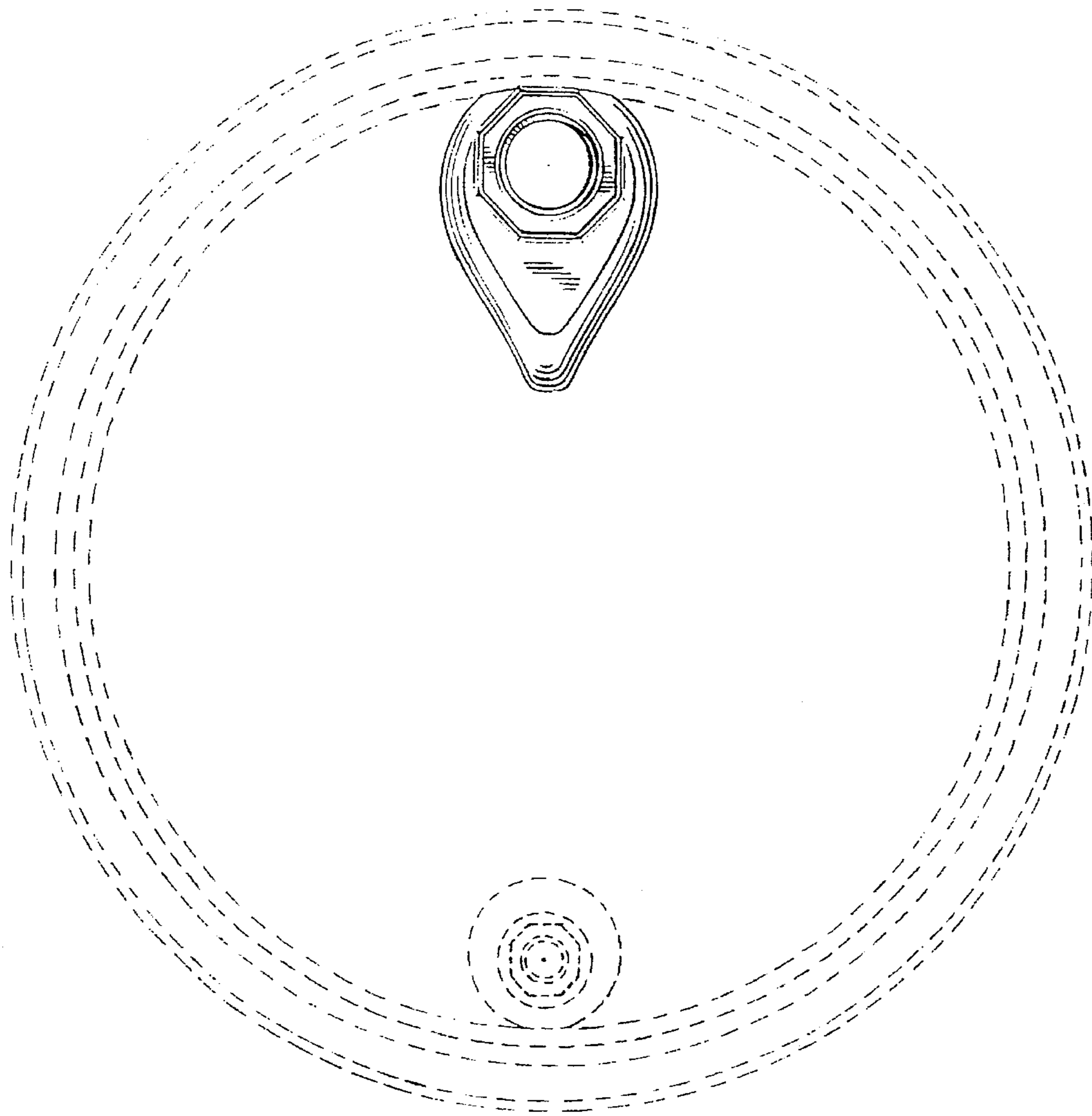

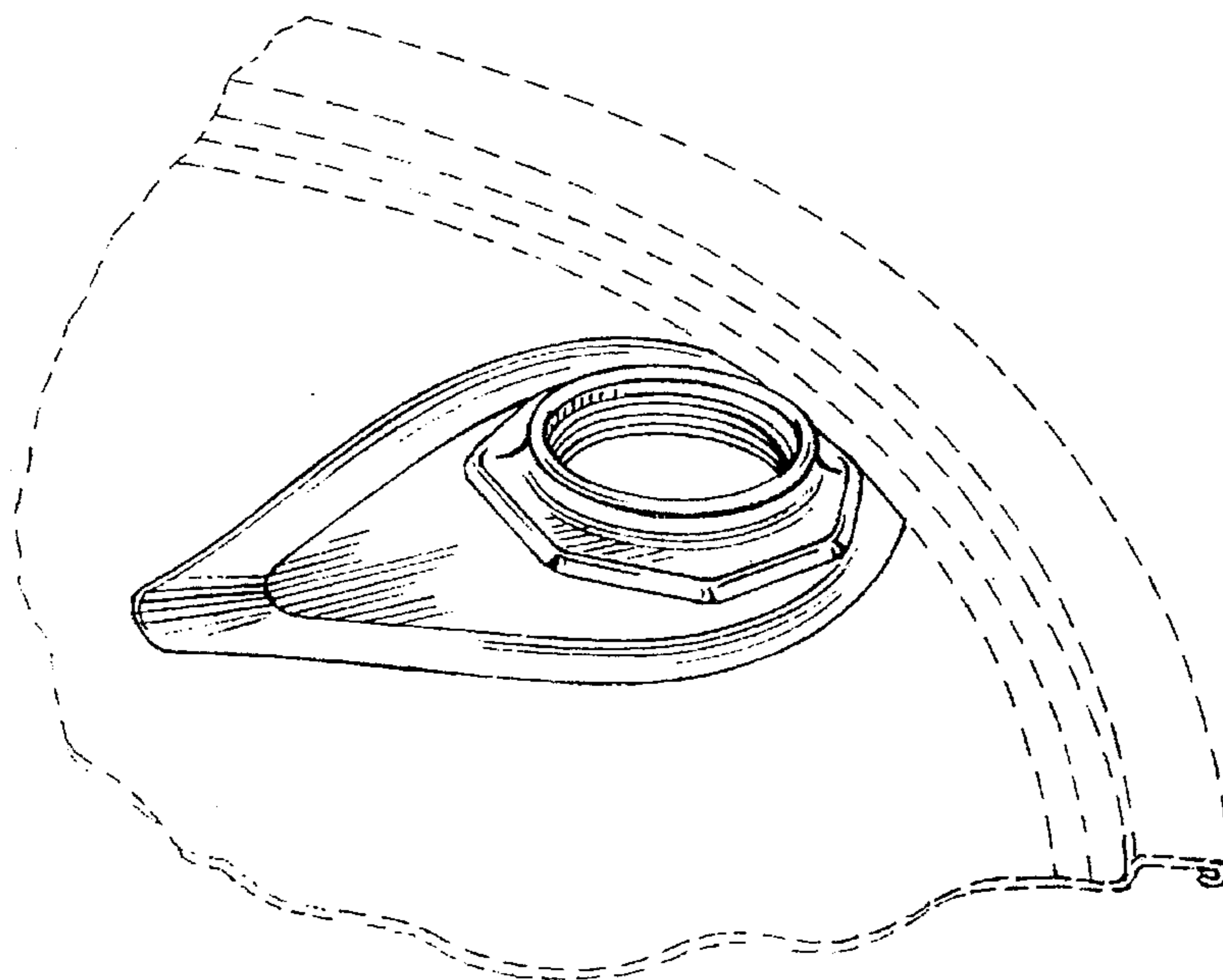
