The ornamental design for a cup lid, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective view of the cup lid showing our new design;  
FIG. 2 is a side elevational view of the cup lid of FIG. 1;  
FIG. 3 is a top plan view of the cup lid of FIG. 1;  
FIG. 4 is a bottom plan view of the cup lid of FIG. 1; and  
FIG. 5 is an enlarged cross sectional view taken diametrically across the cup lid of FIG. 1 and broken away in the middle for convenience of illustration.

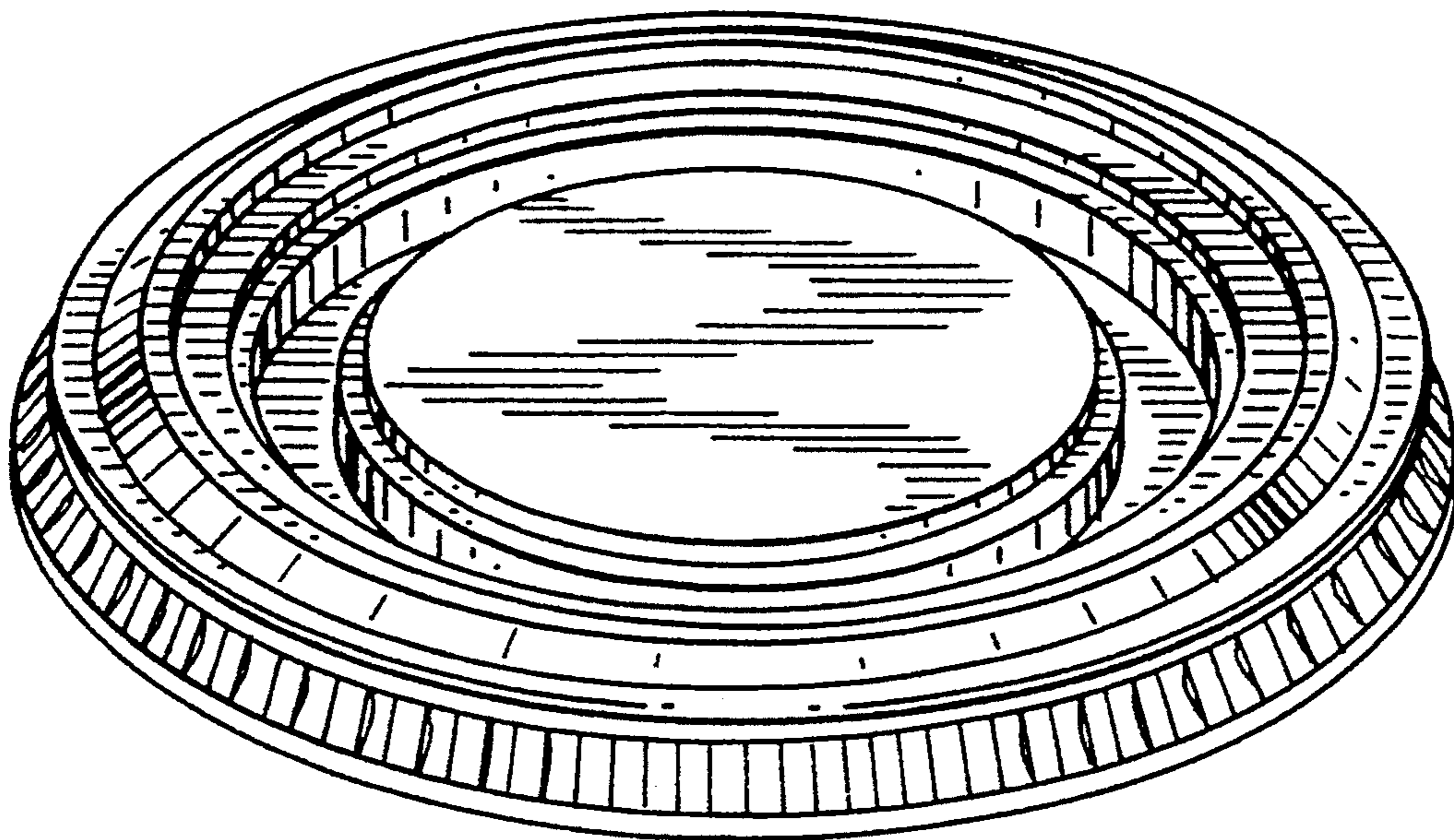

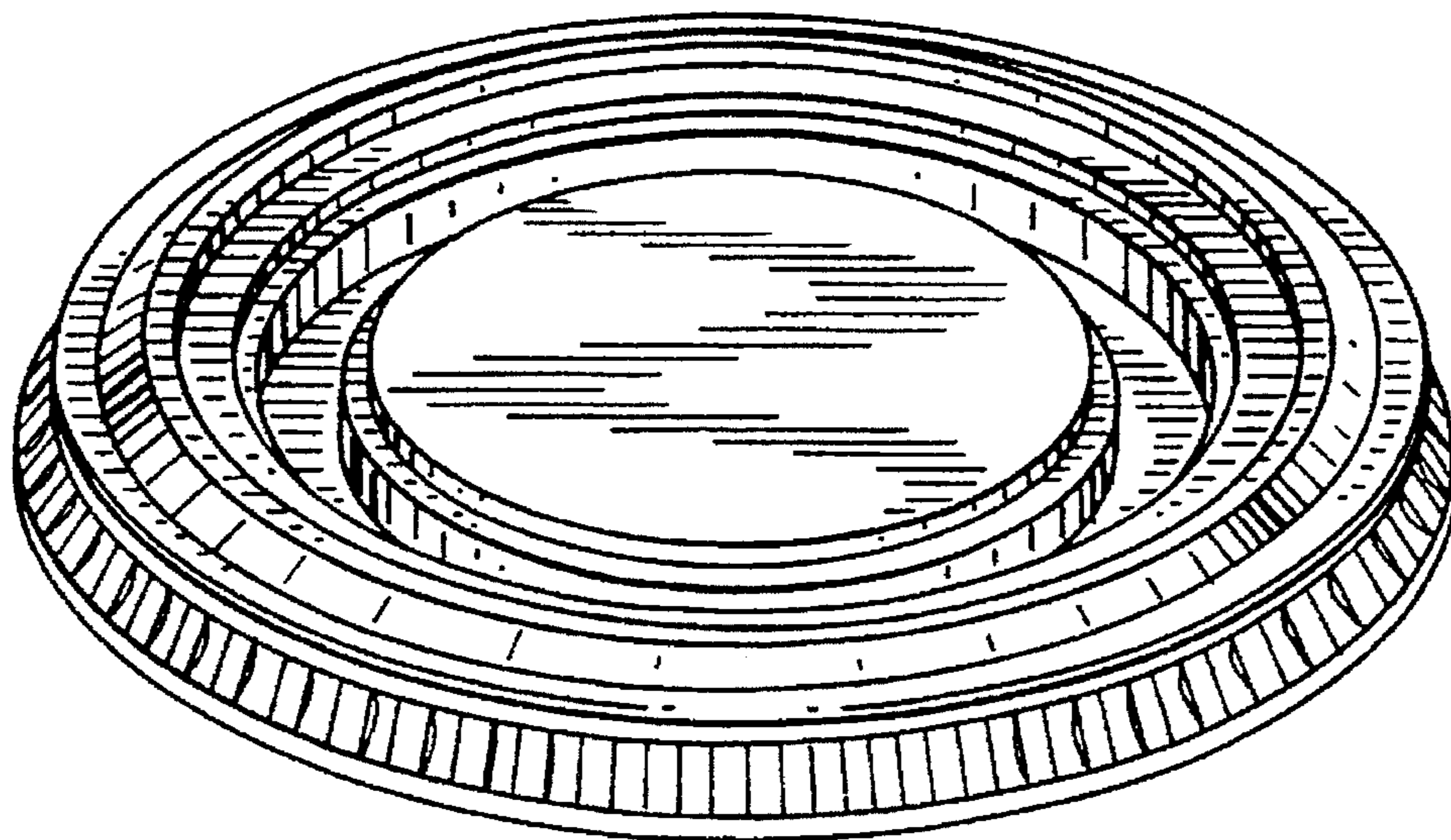

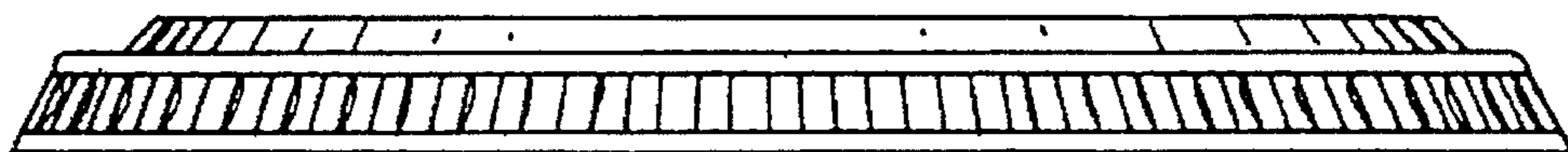

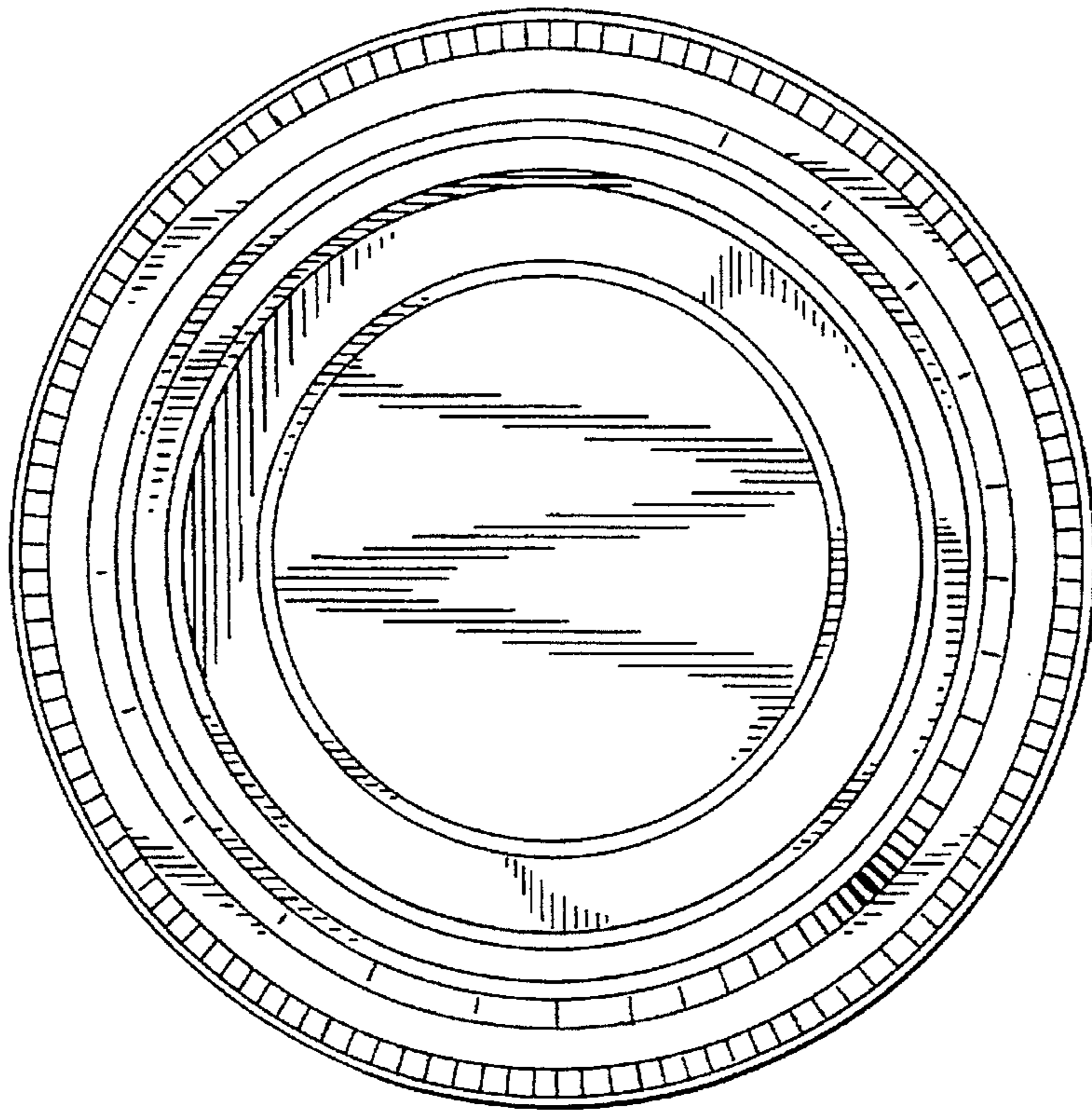

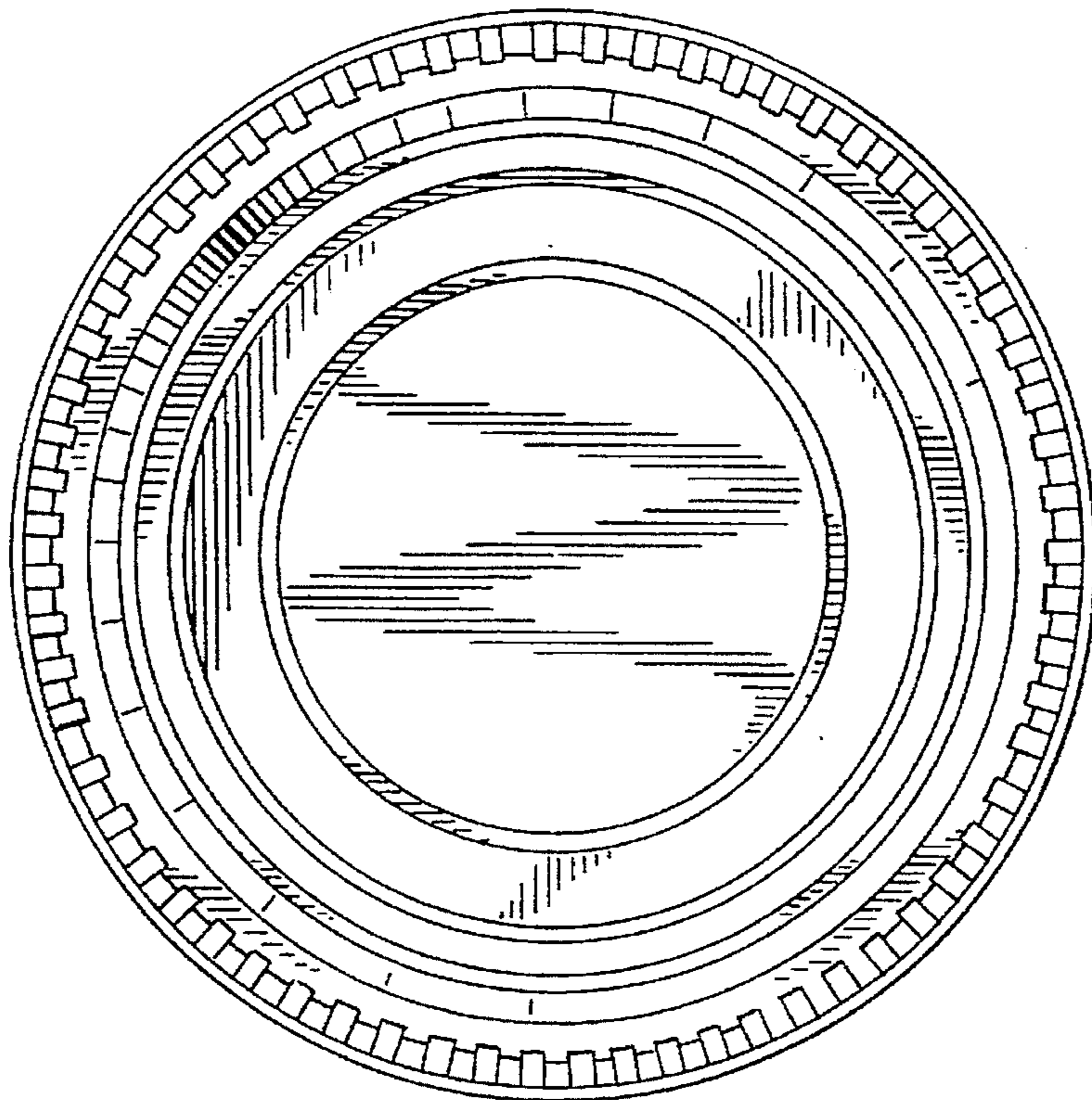
