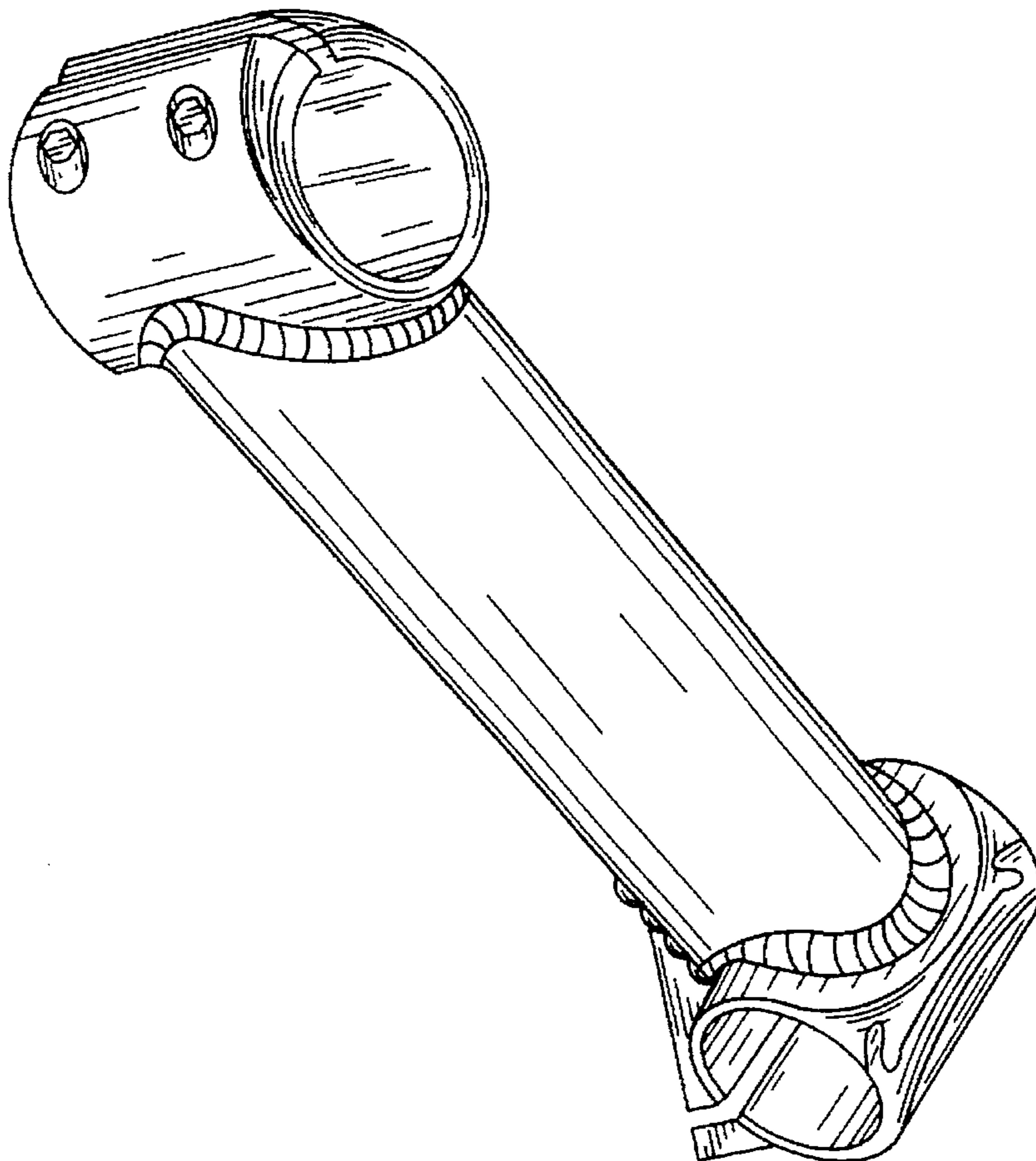
[57] **CLAIM**

The ornamental design for a bicycle stem, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bicycle stem;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a front elevational view thereof;  
 FIG. 7 is a rear elevational view thereof;  
 FIG. 8 is a fragmentary perspective view thereof, with its detachable part removed;  
 FIG. 9 is an opposite fragmentary perspective view of FIG. 8;  
 FIG. 10 is a front elevational view of the removed detachable part in FIGS. 8 and 9;  
 FIG. 11 is a side elevational view of FIG. 10;  
 FIG. 12 is a top plan view of FIG. 10; and  
 FIG. 13 is a bottom plan view of FIG. 10.

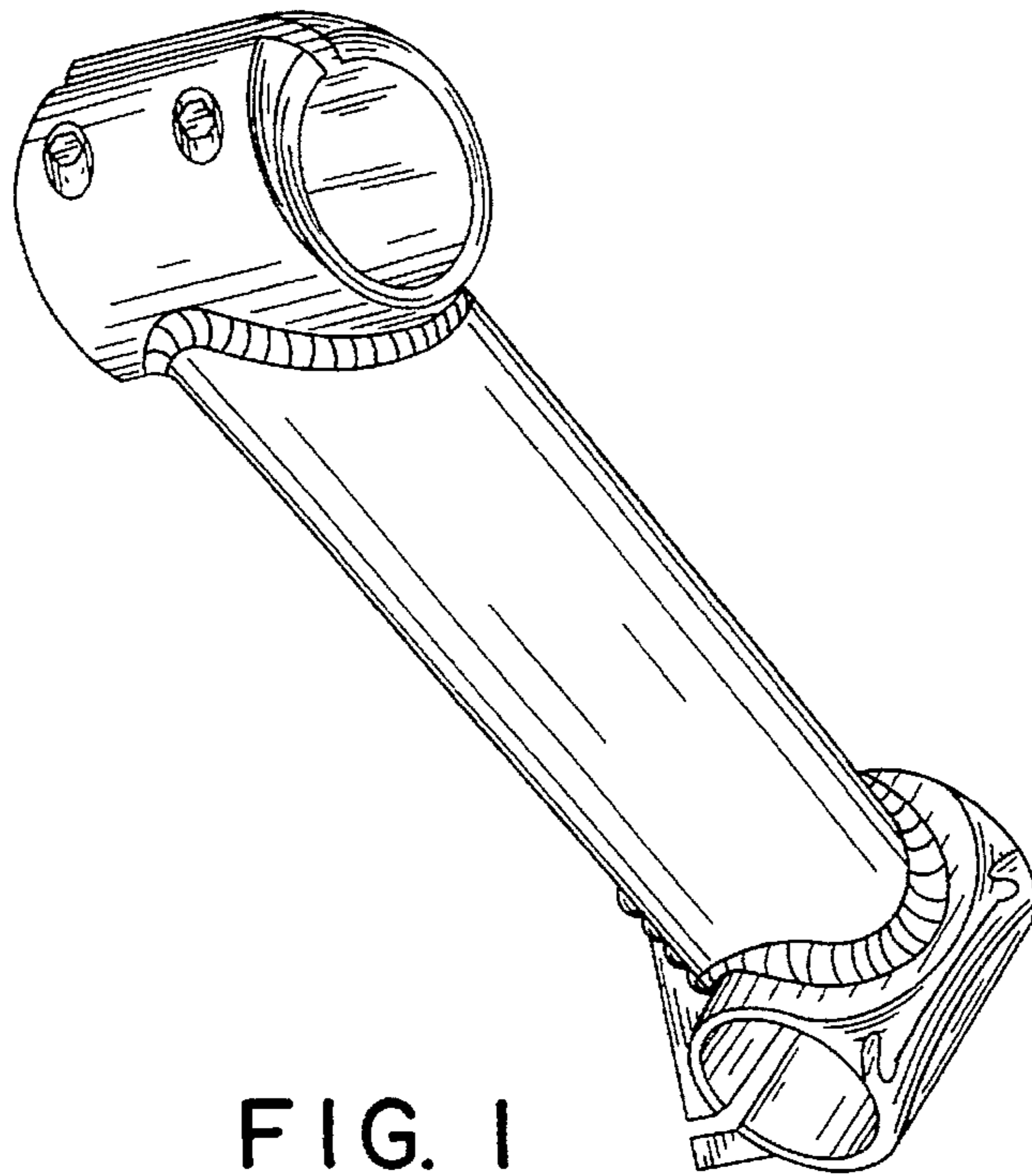

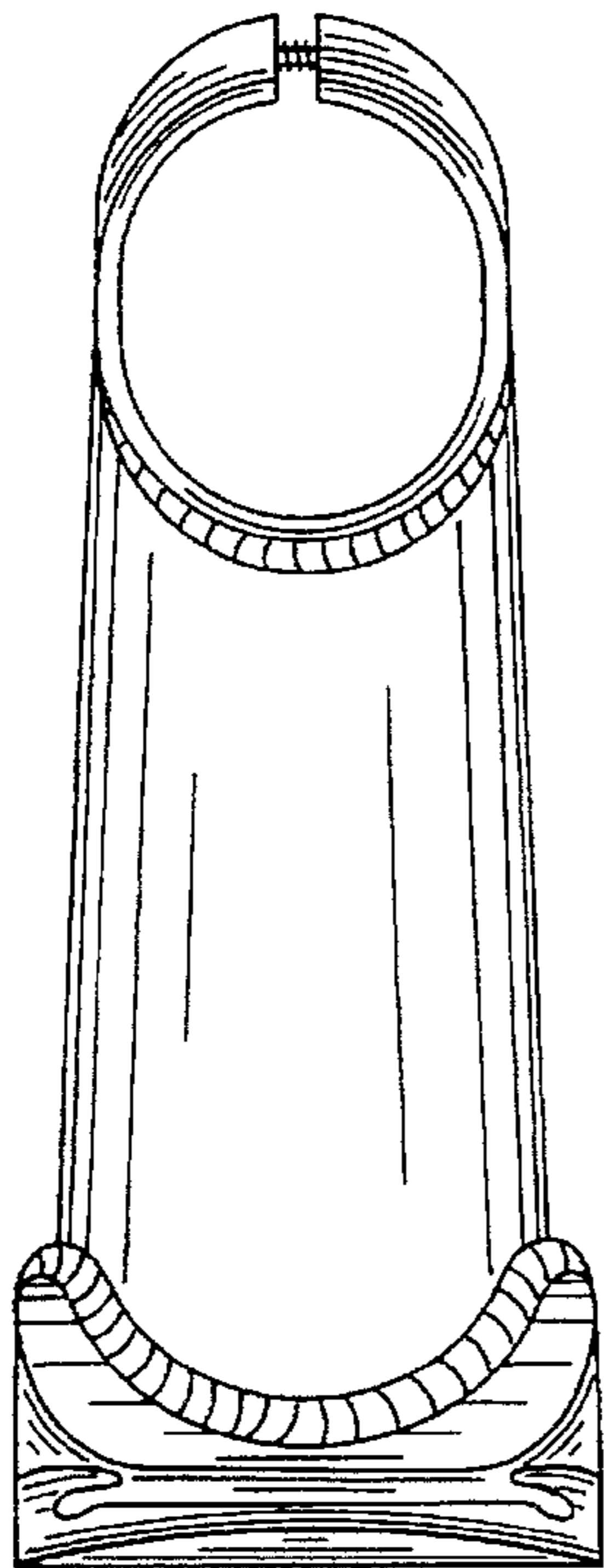

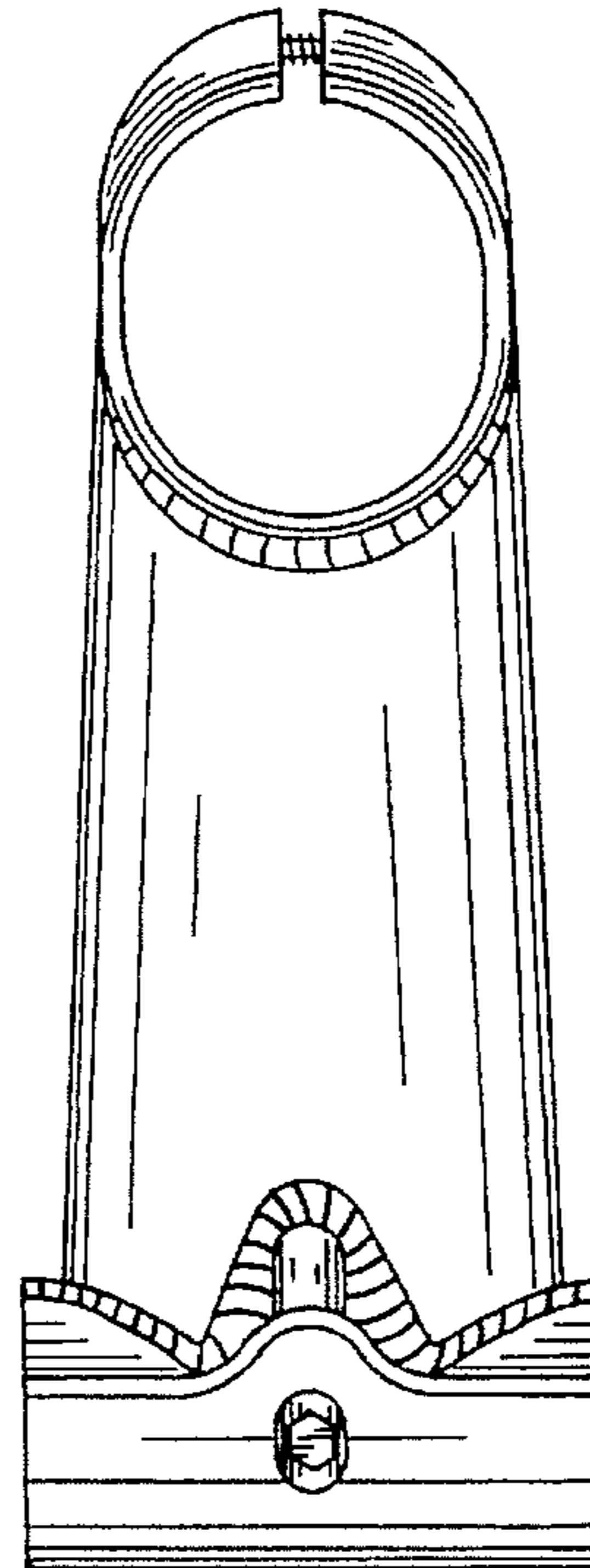

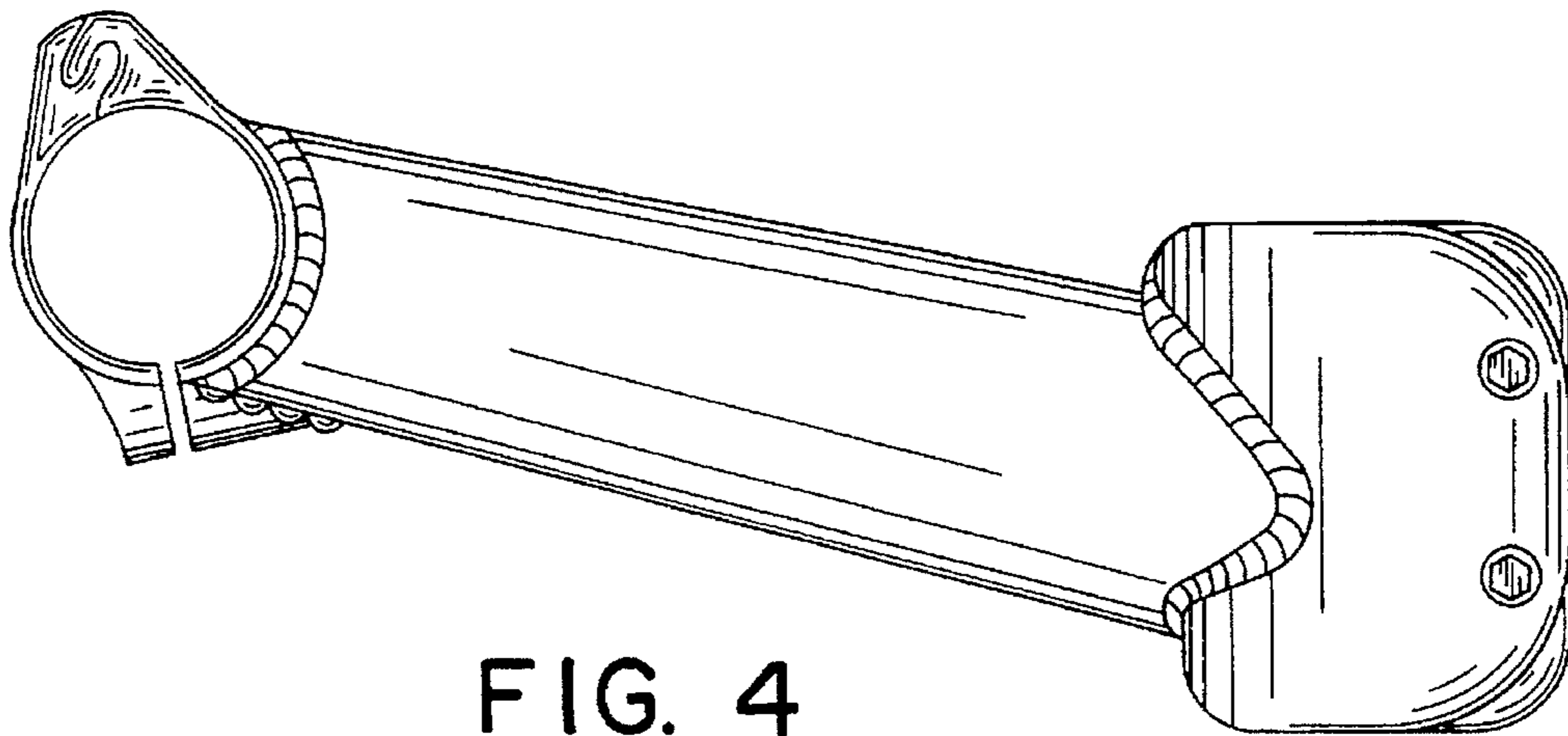

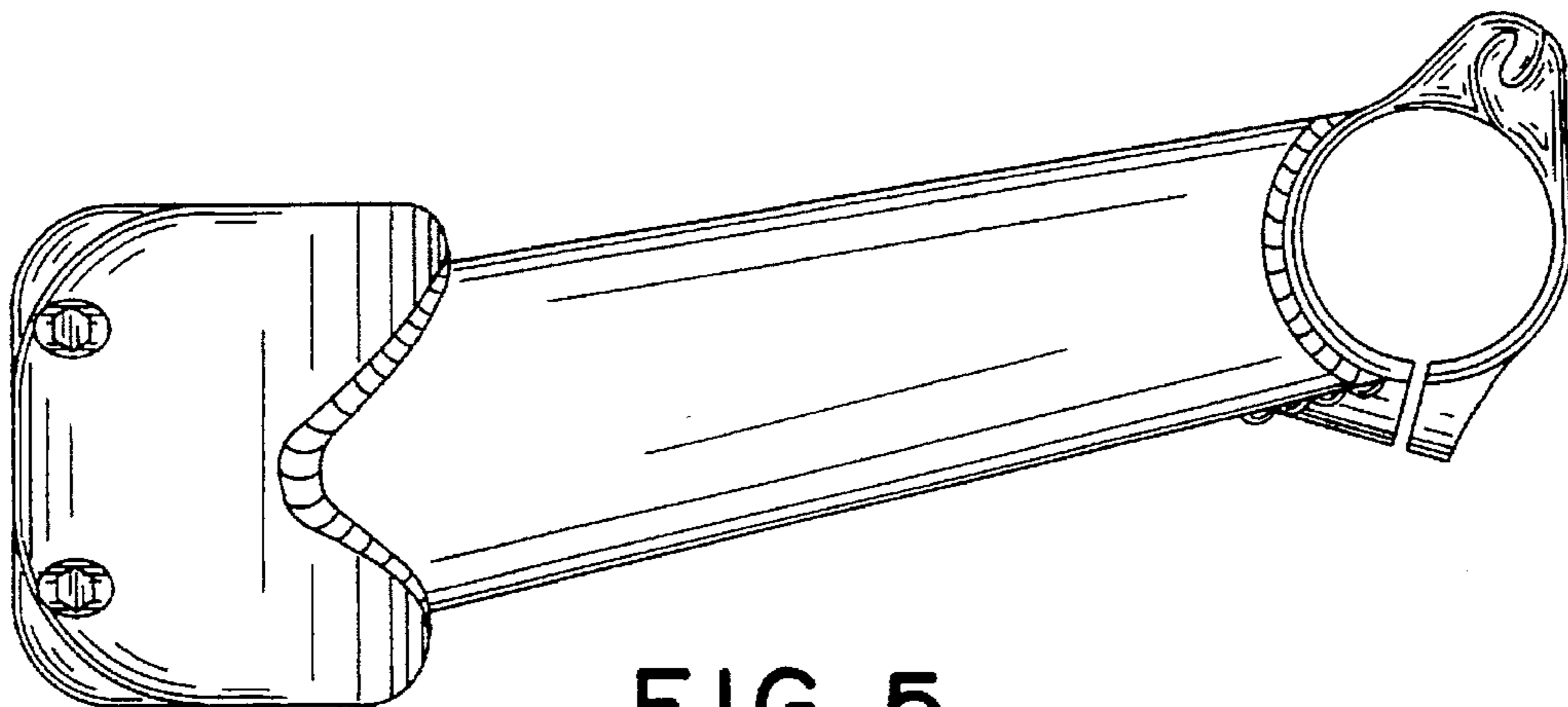

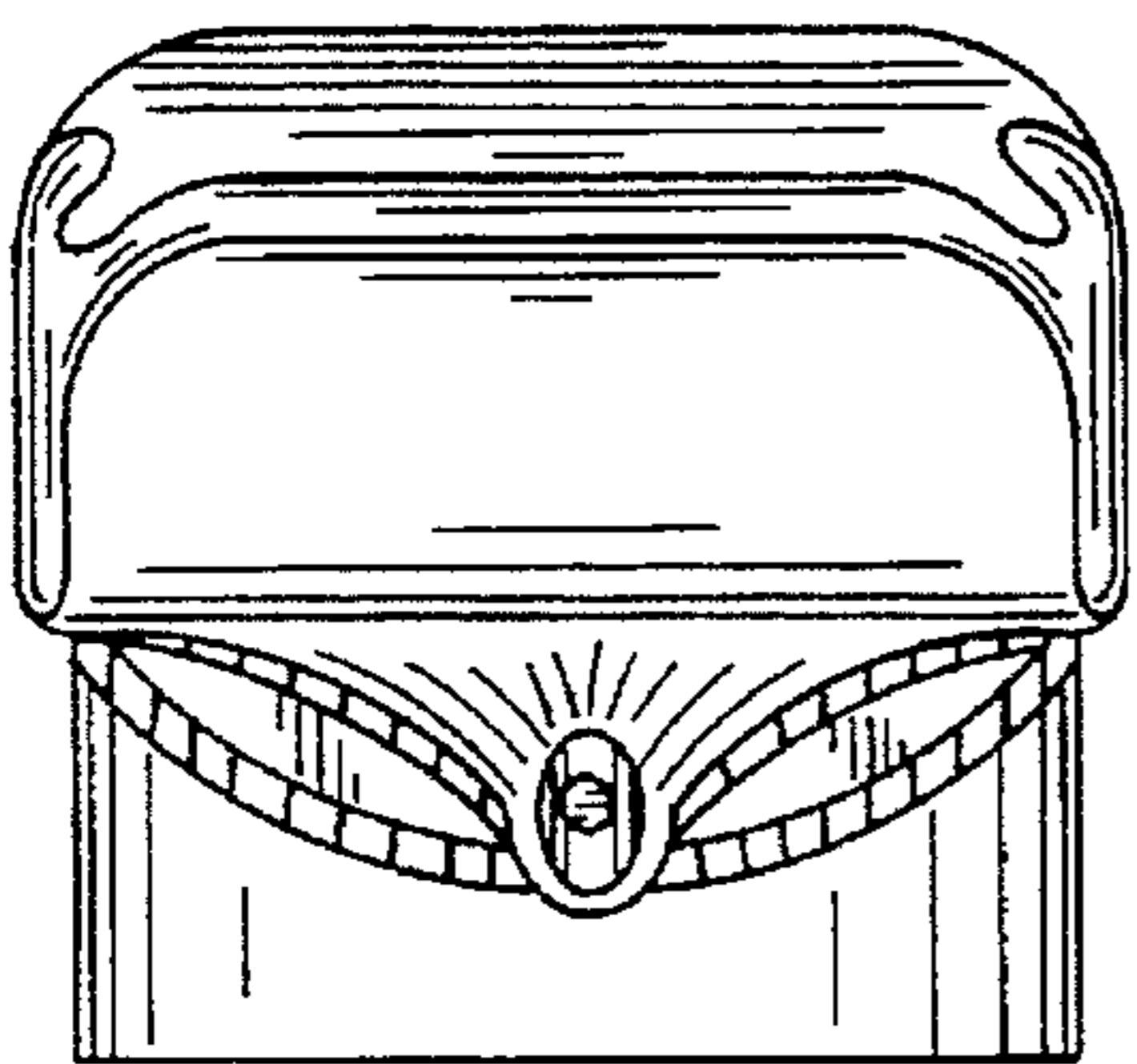

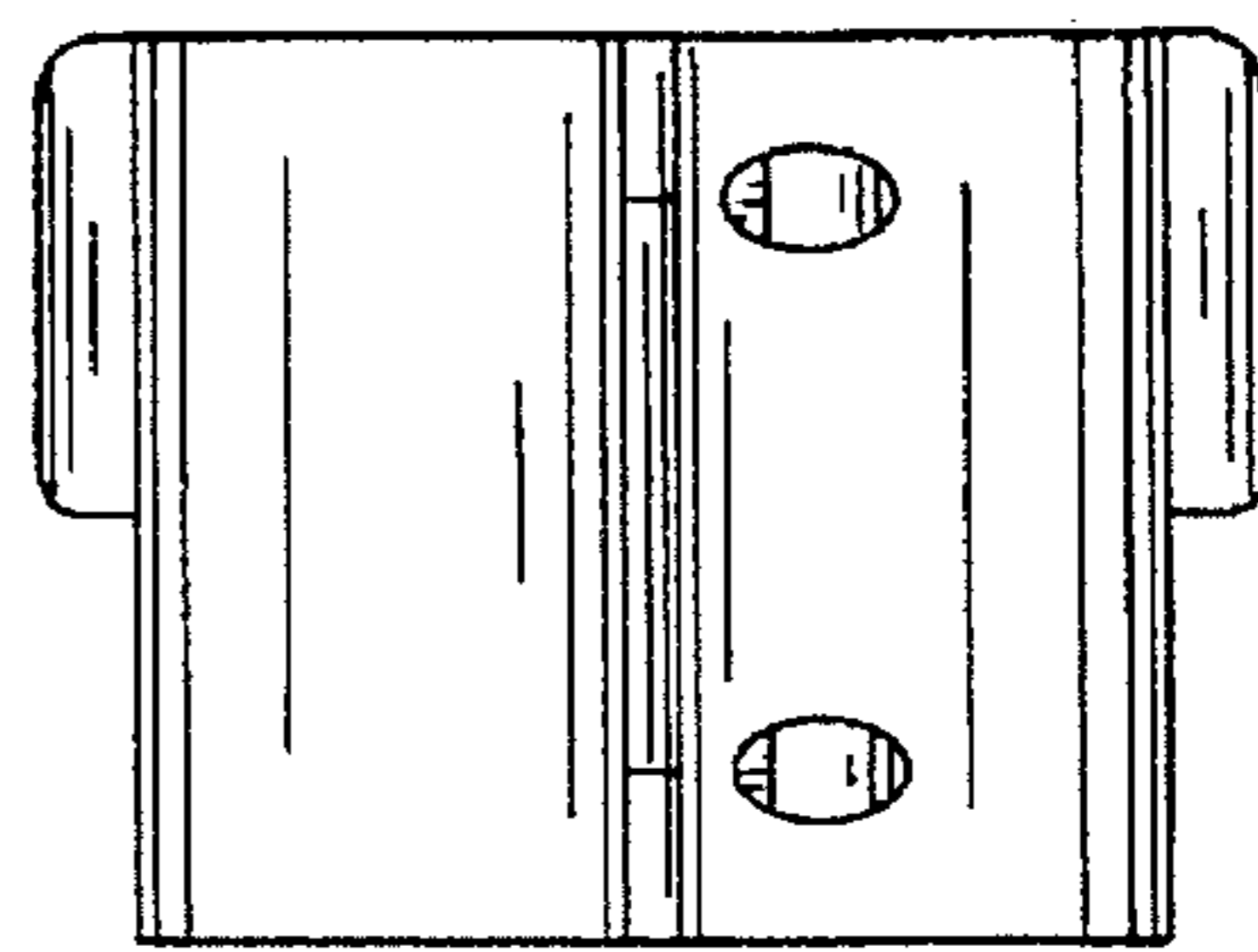

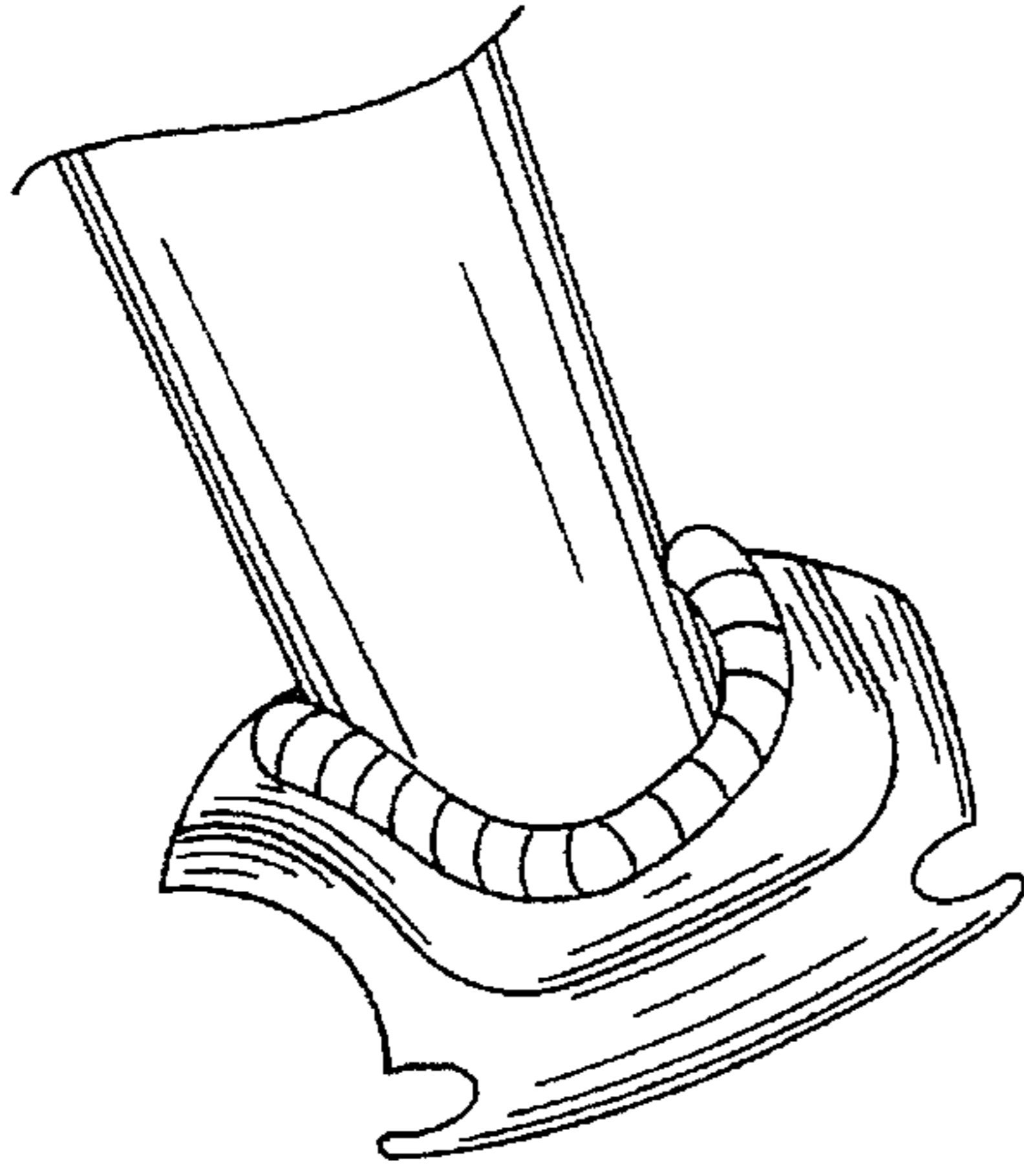

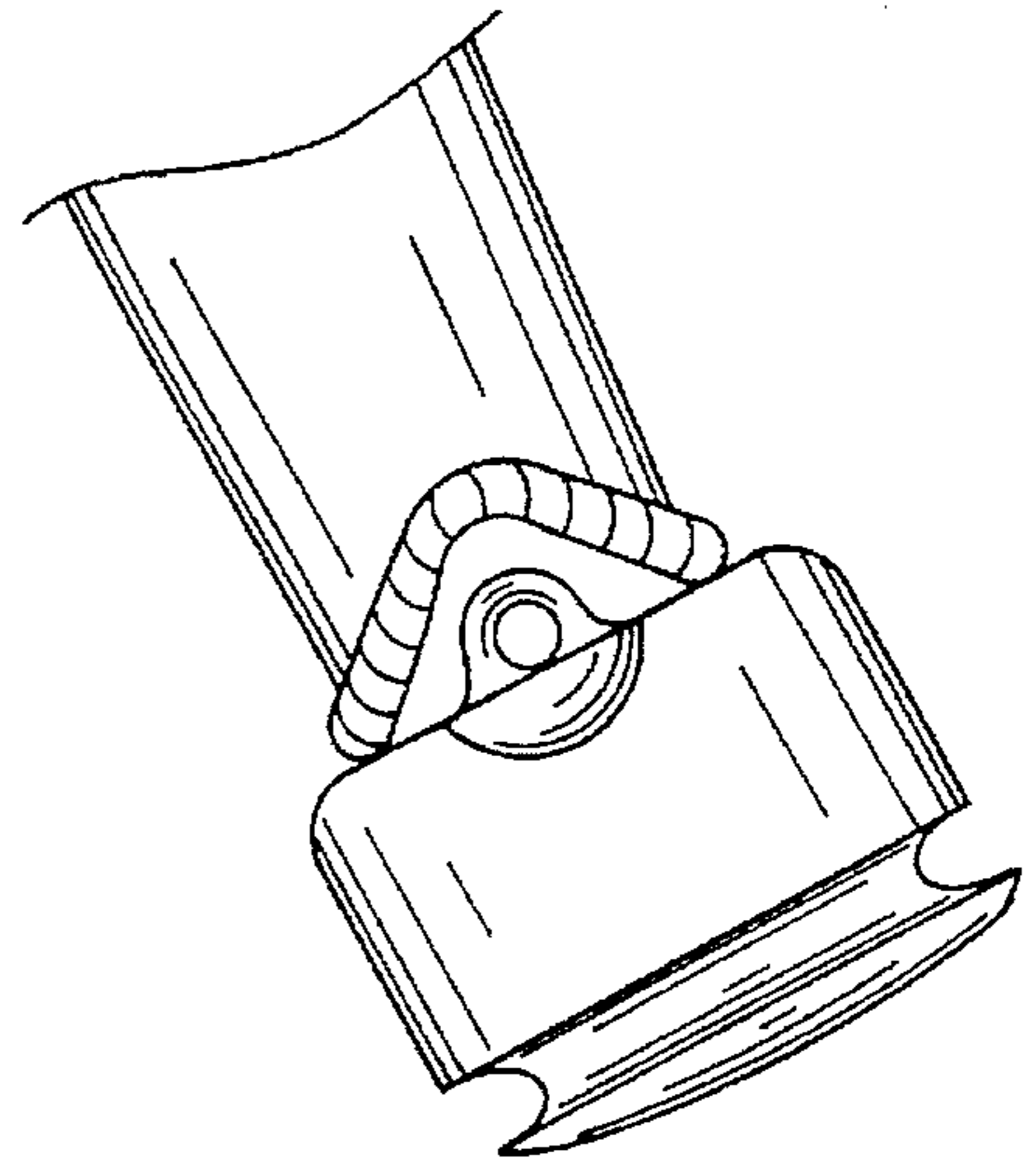

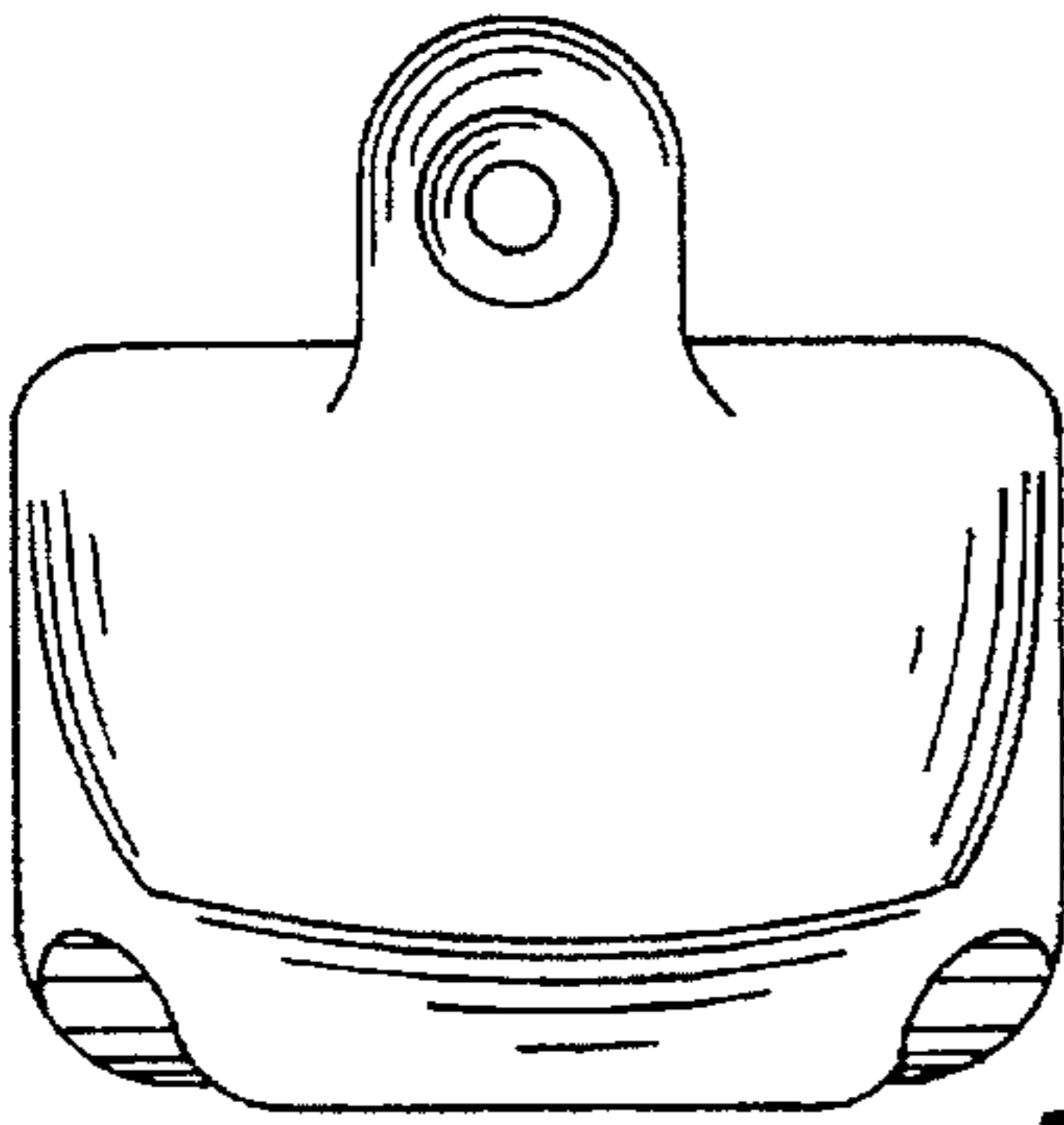

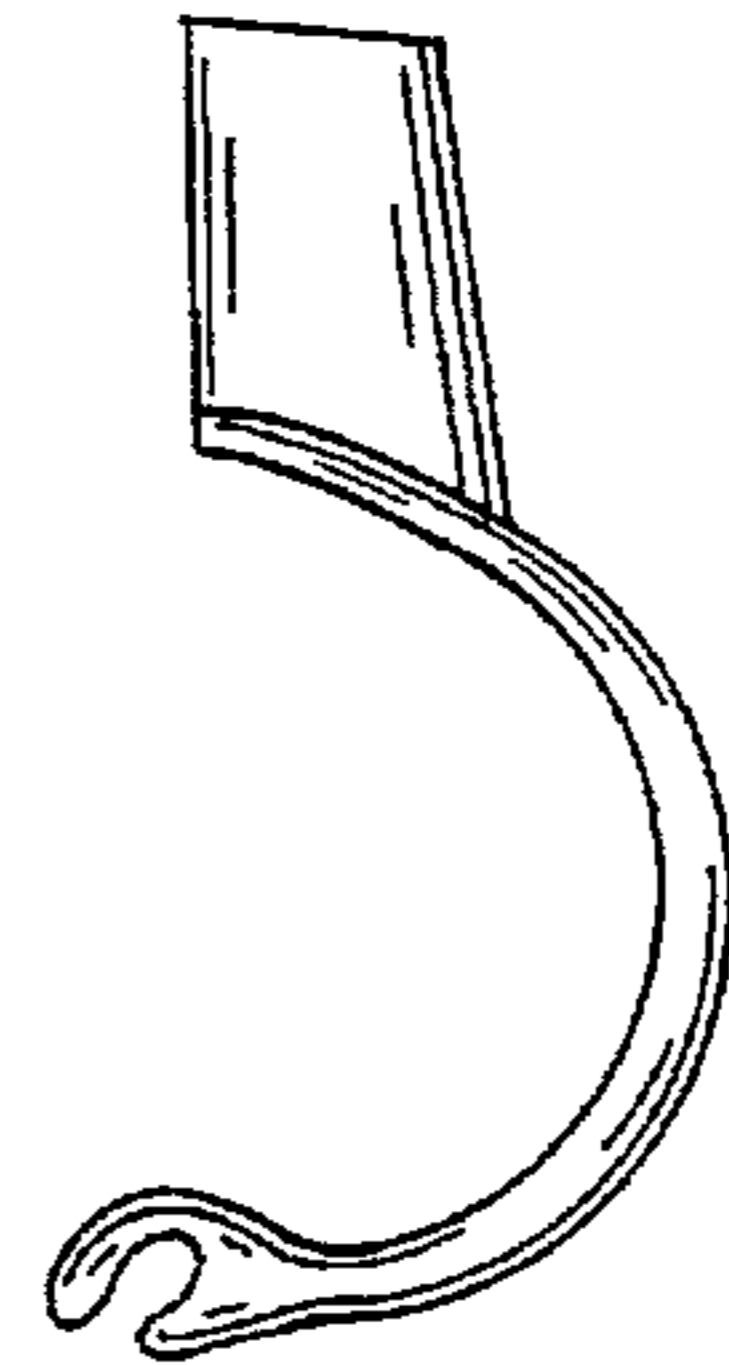

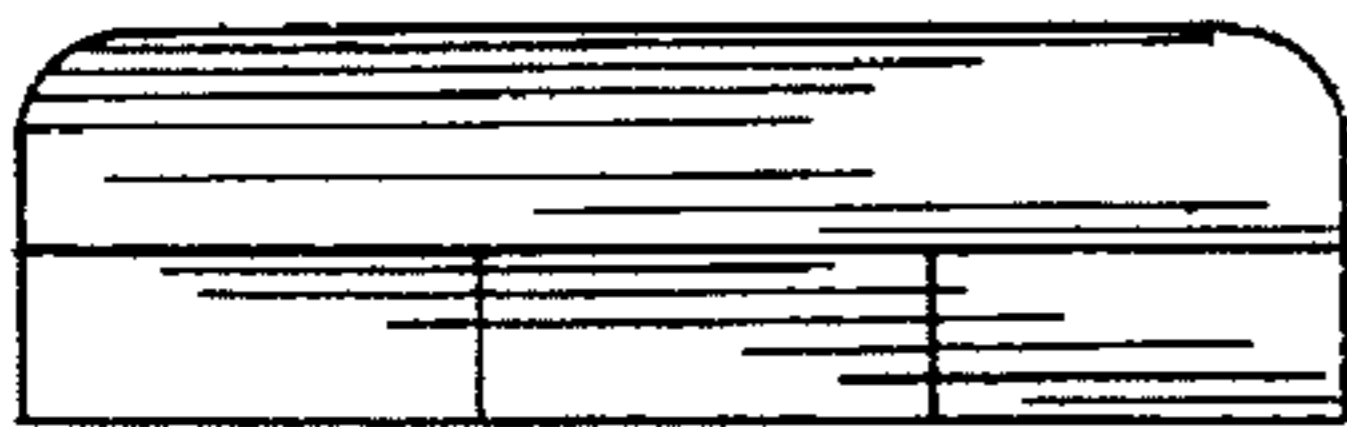
