## [57] CLAIM

The ornamental design for a vehicle top with luggage carrier siderails, as shown and described.

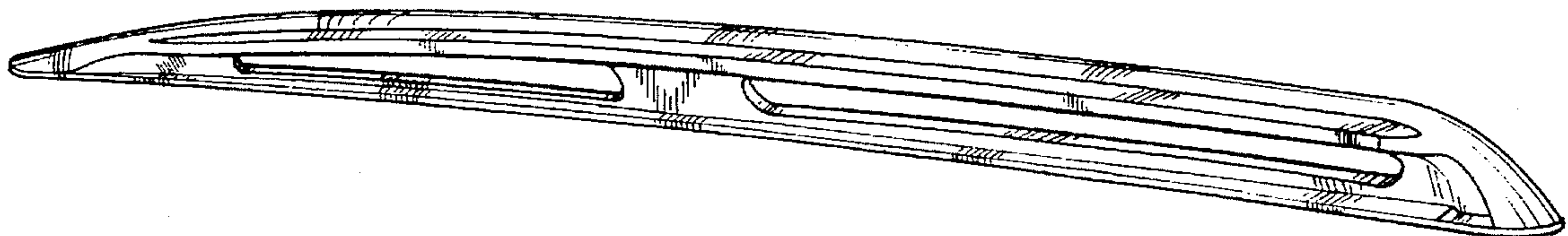
## DESCRIPTION

FIG. 1 is a perspective view of a vehicle top with luggage carrier siderails showing our new design; FIG. 2 is an end elevational view of the forward end thereof; FIG. 3 is an end elevational view of the rear end thereof; FIG. 4 is a right side elevational view thereof, the left side being a mirror image of the right side; FIG. 5 is a top plan view thereof; FIG. 6 is an enlarged cross sectional view of the siderail thereof taken along the lines 6-6 of FIG. 4; and FIG. 7 is a perspective view of the inner side of the left siderail, the right siderail being a mirror image of the left siderail.

The broken lines are for illustrative purposes only and form no part of the claimed design.

In FIGS. 6 and 7, the siderail is shown independently of the vehicle top for ease of illustration.

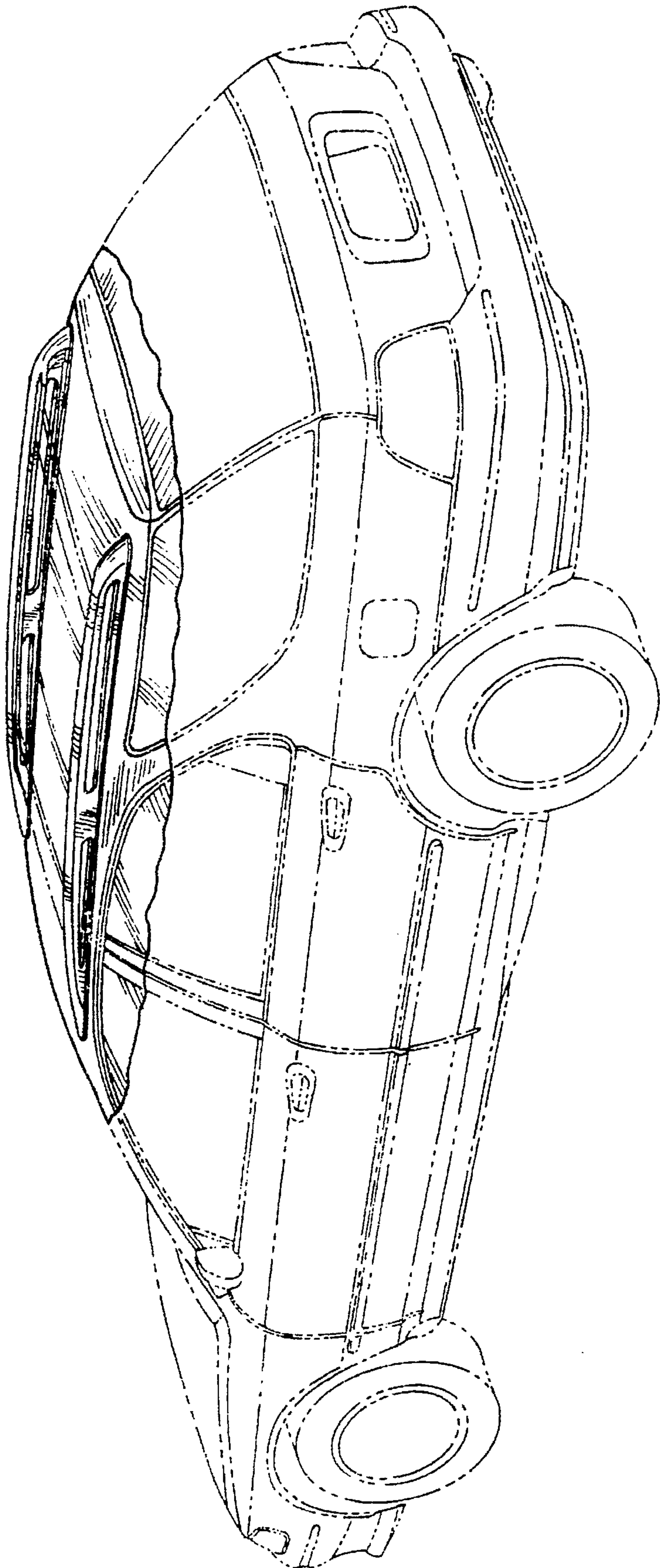

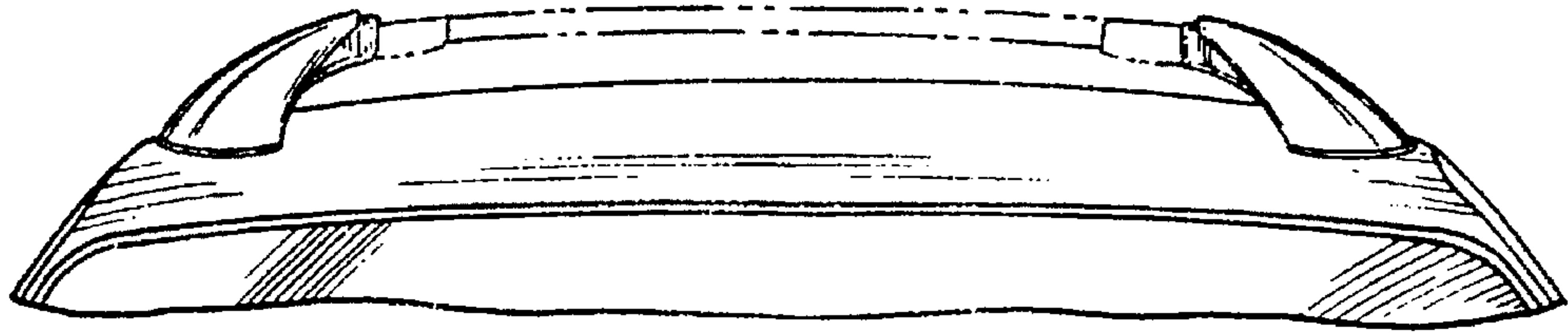

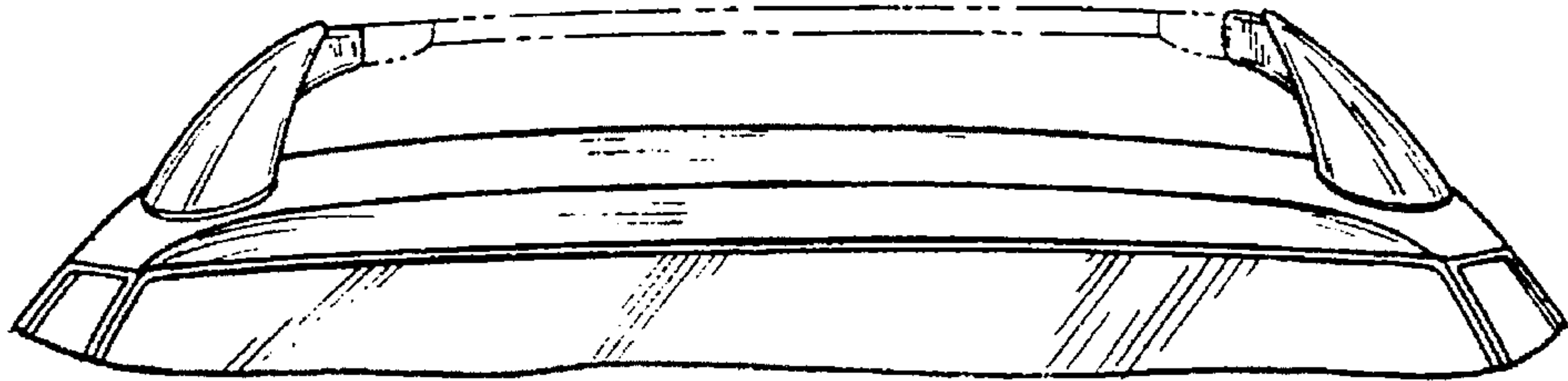
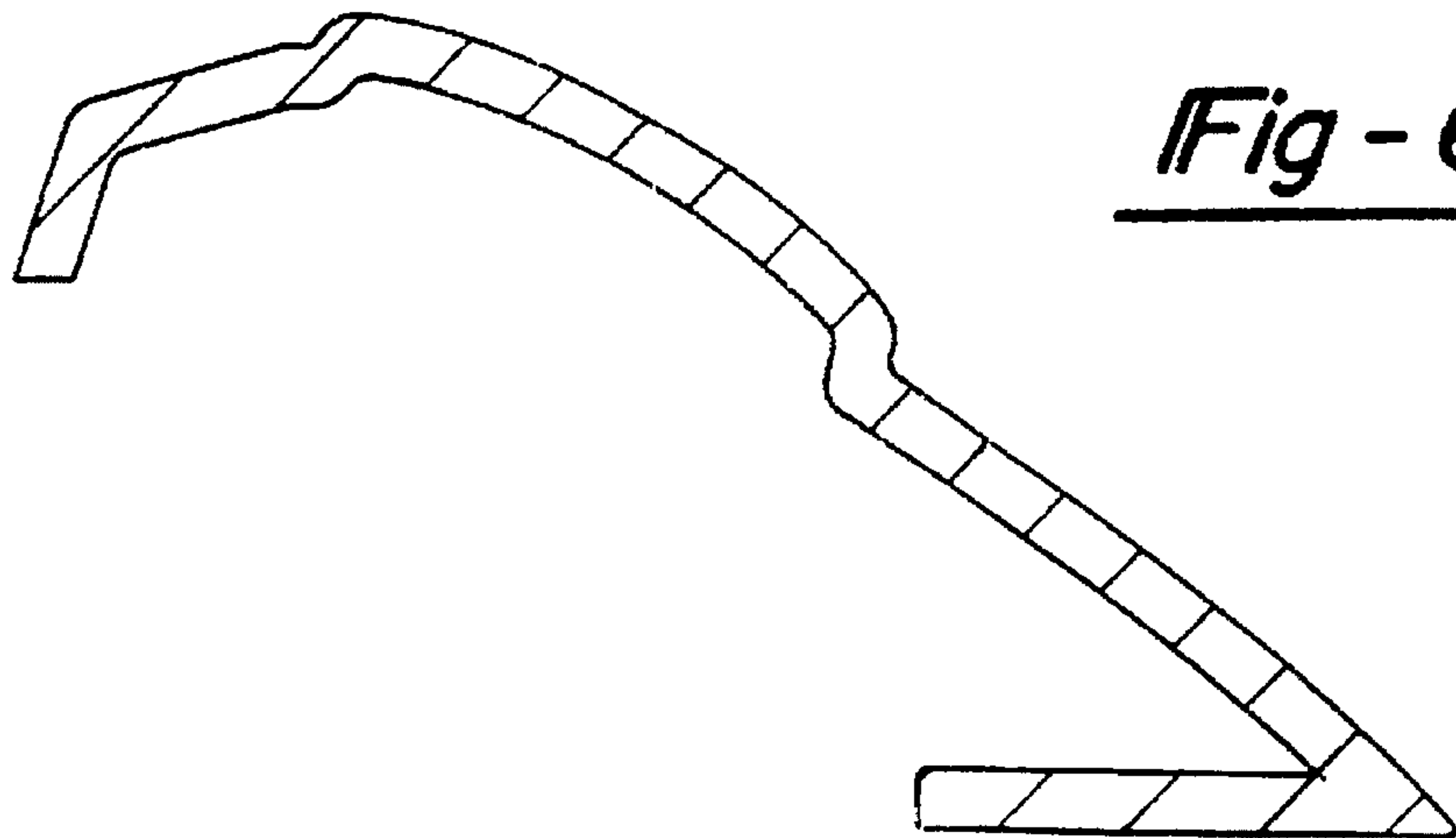

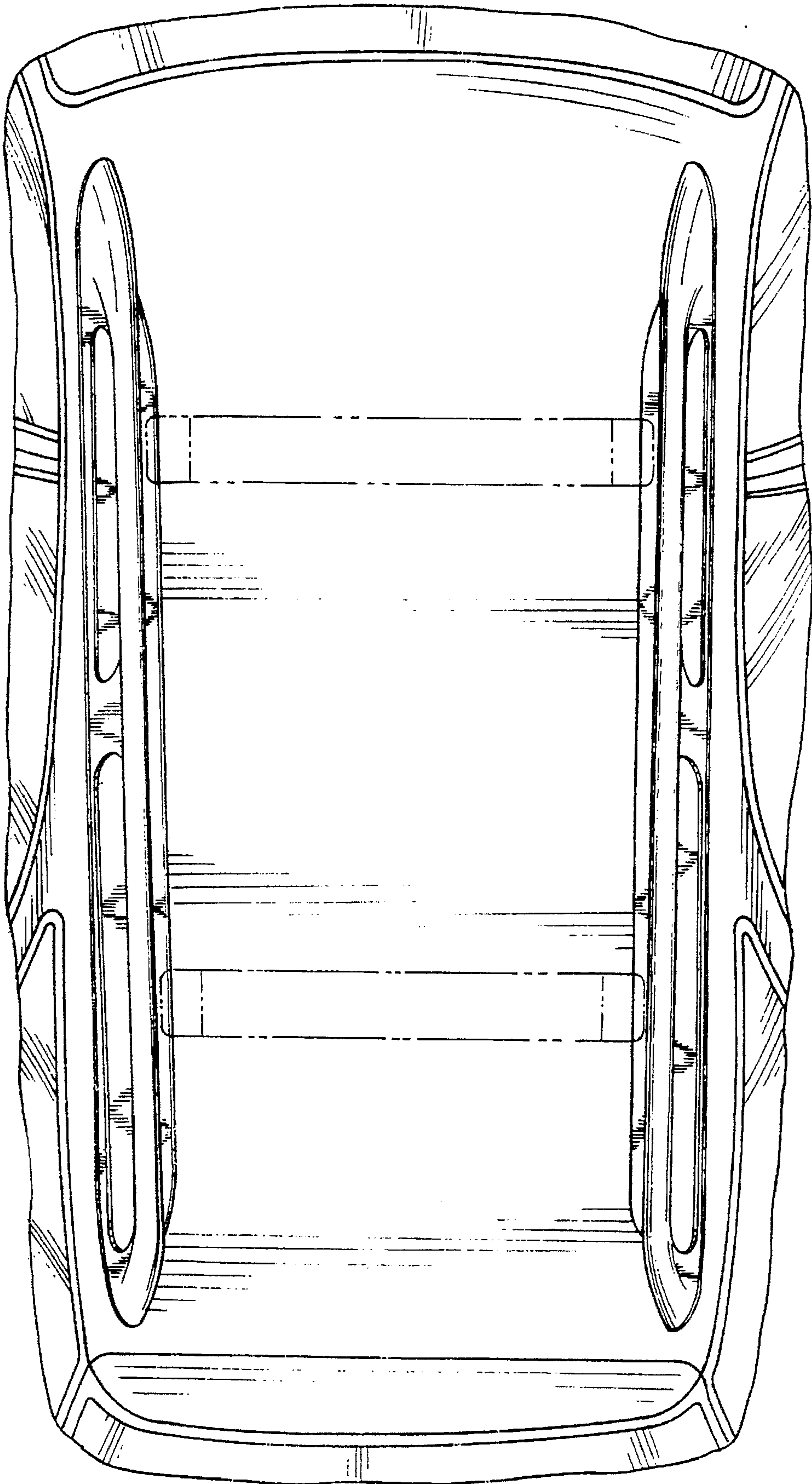

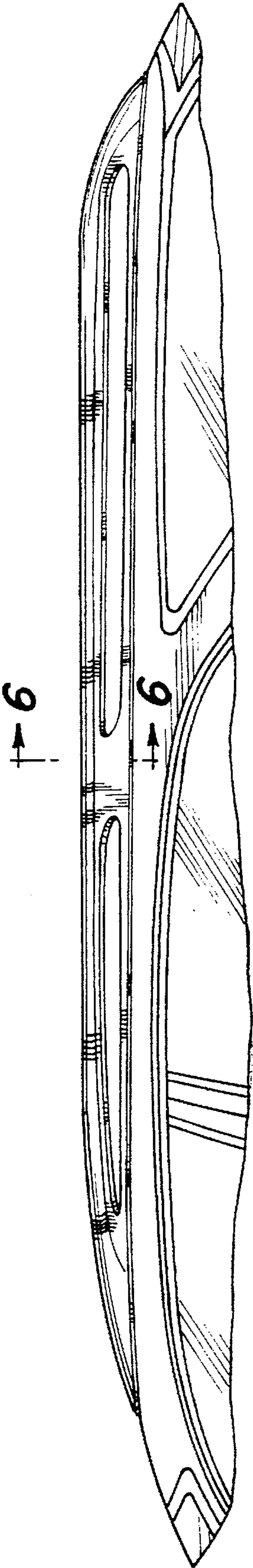

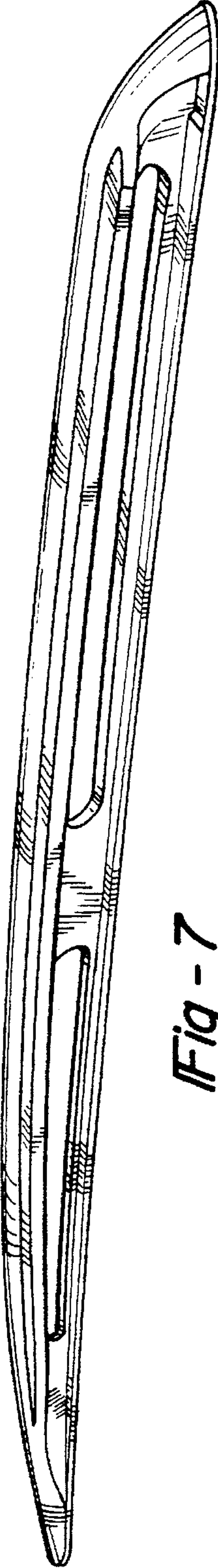
