FIG. 1 is a left side elevational view of a fishing guide pipe showing our new design, the right side being a mirror image thereof;

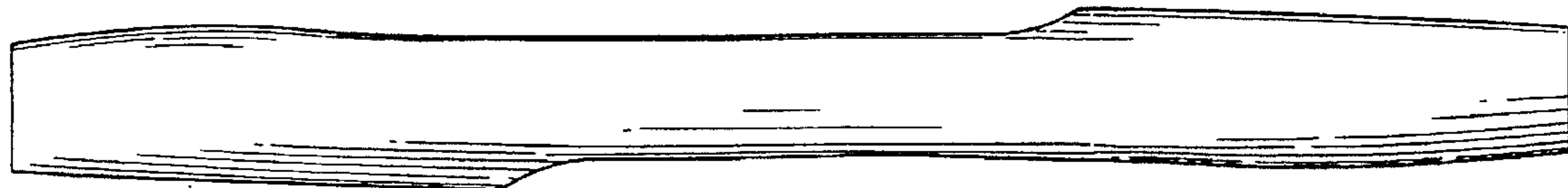

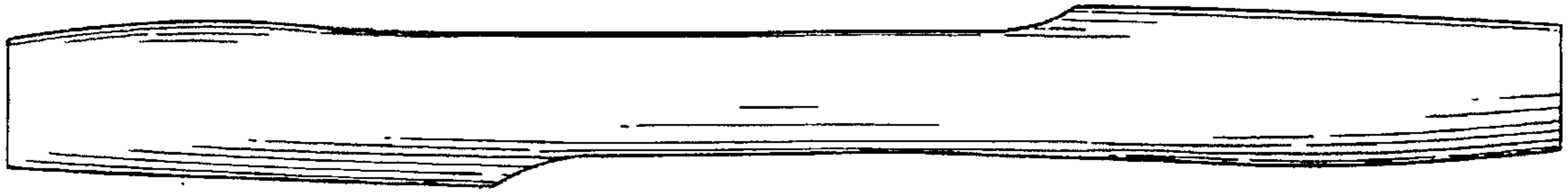

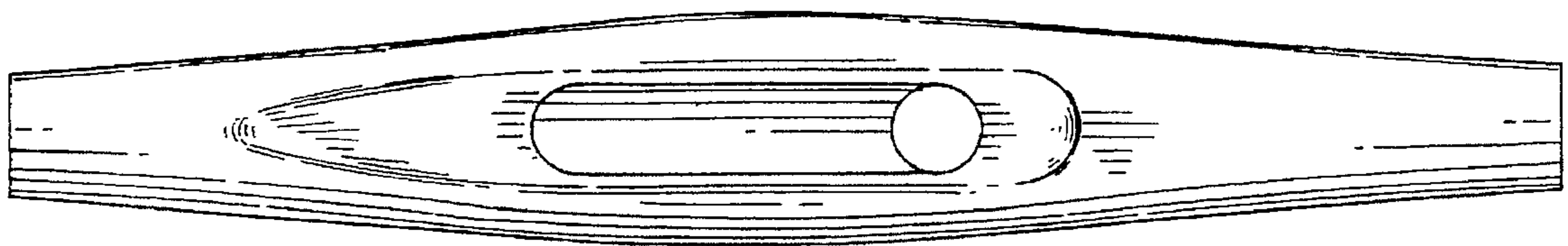

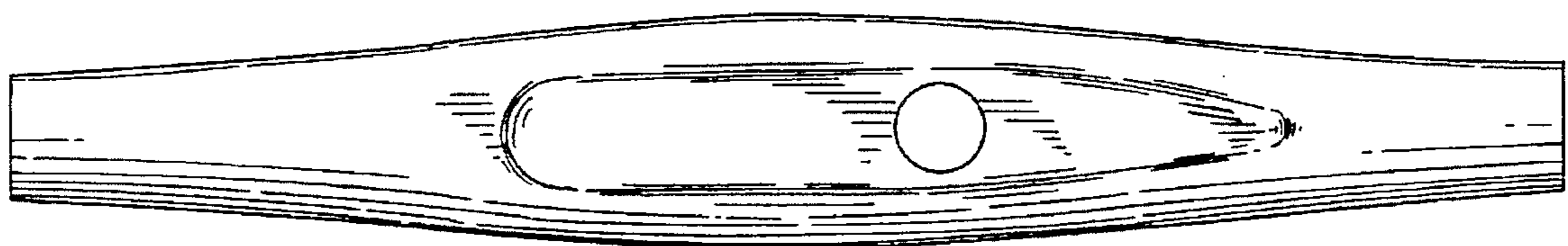

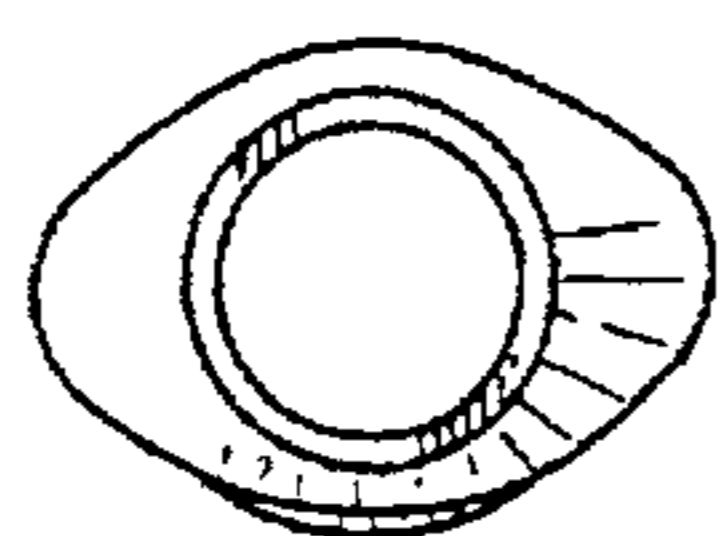

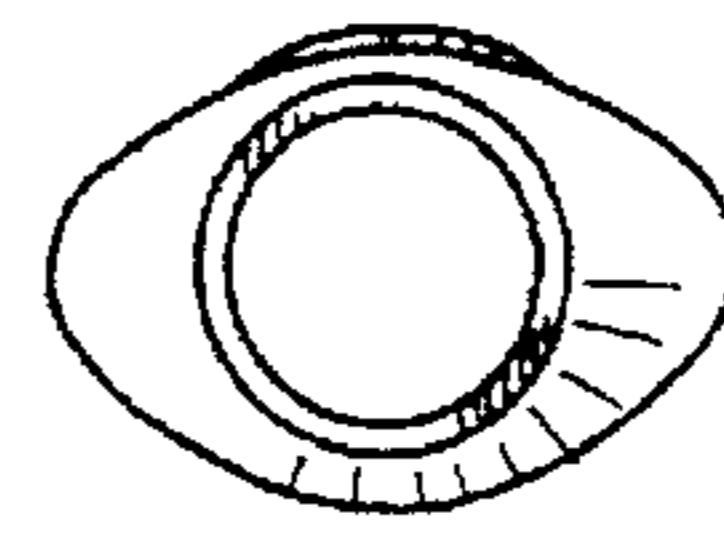

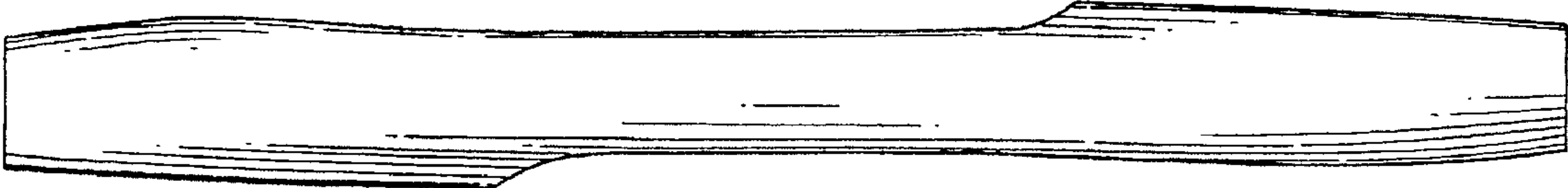

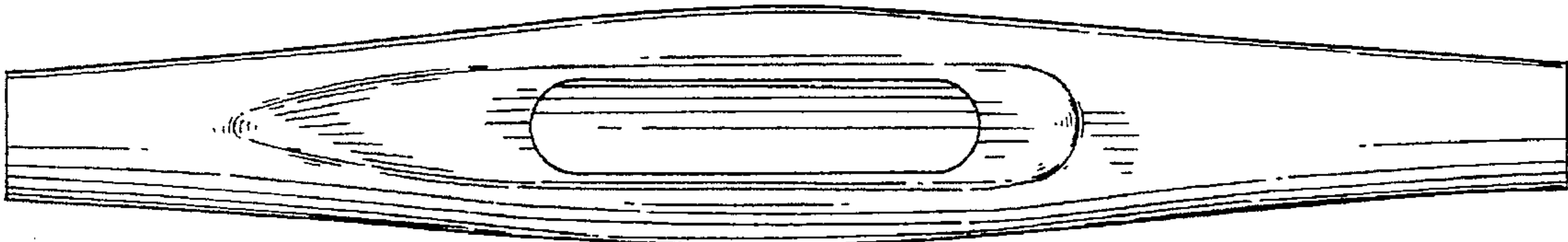

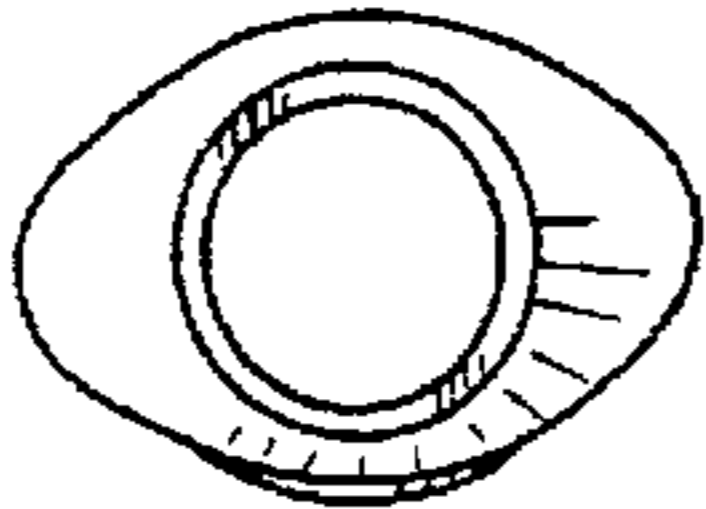
