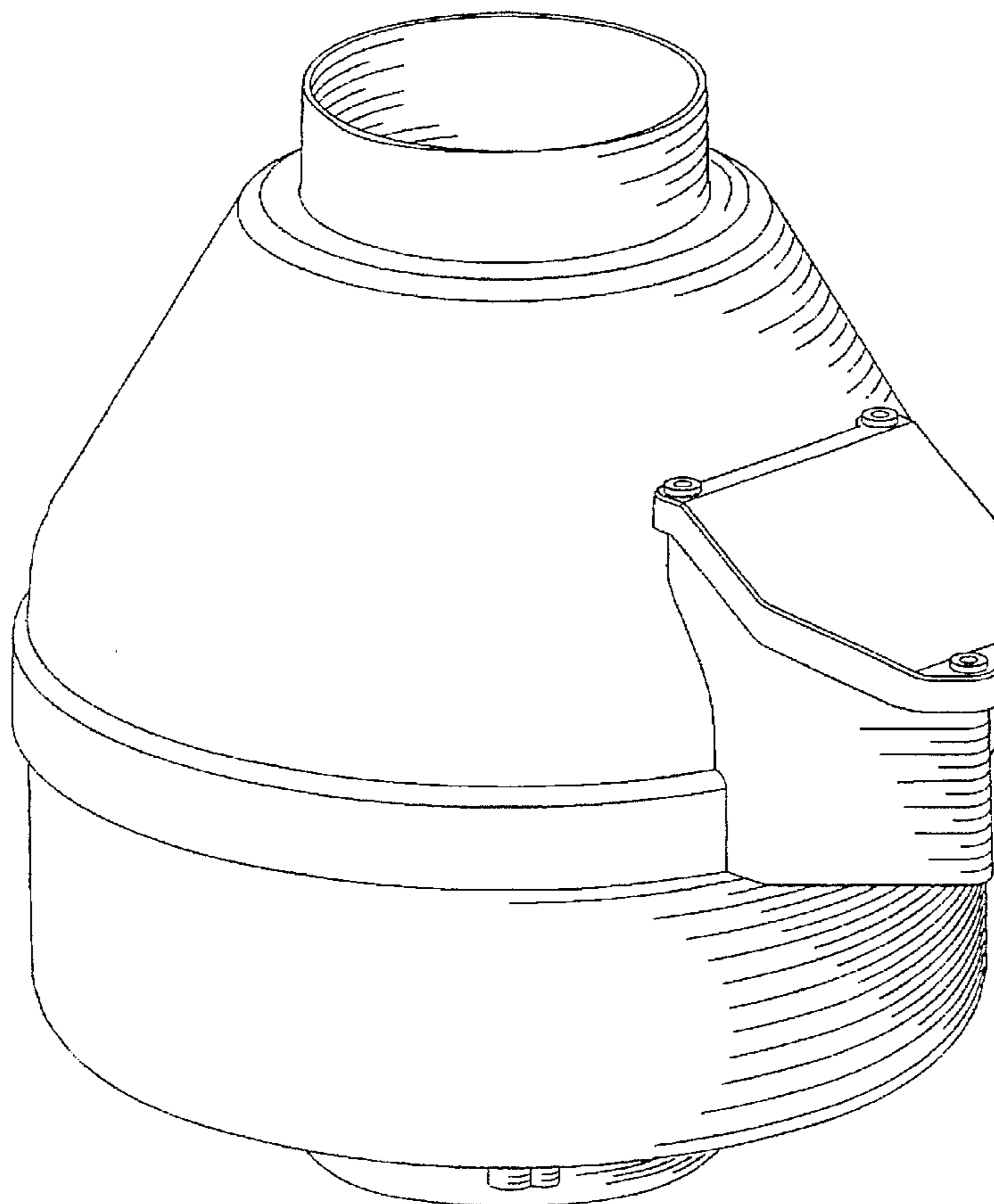
FIG. 1 is a side perspective view;

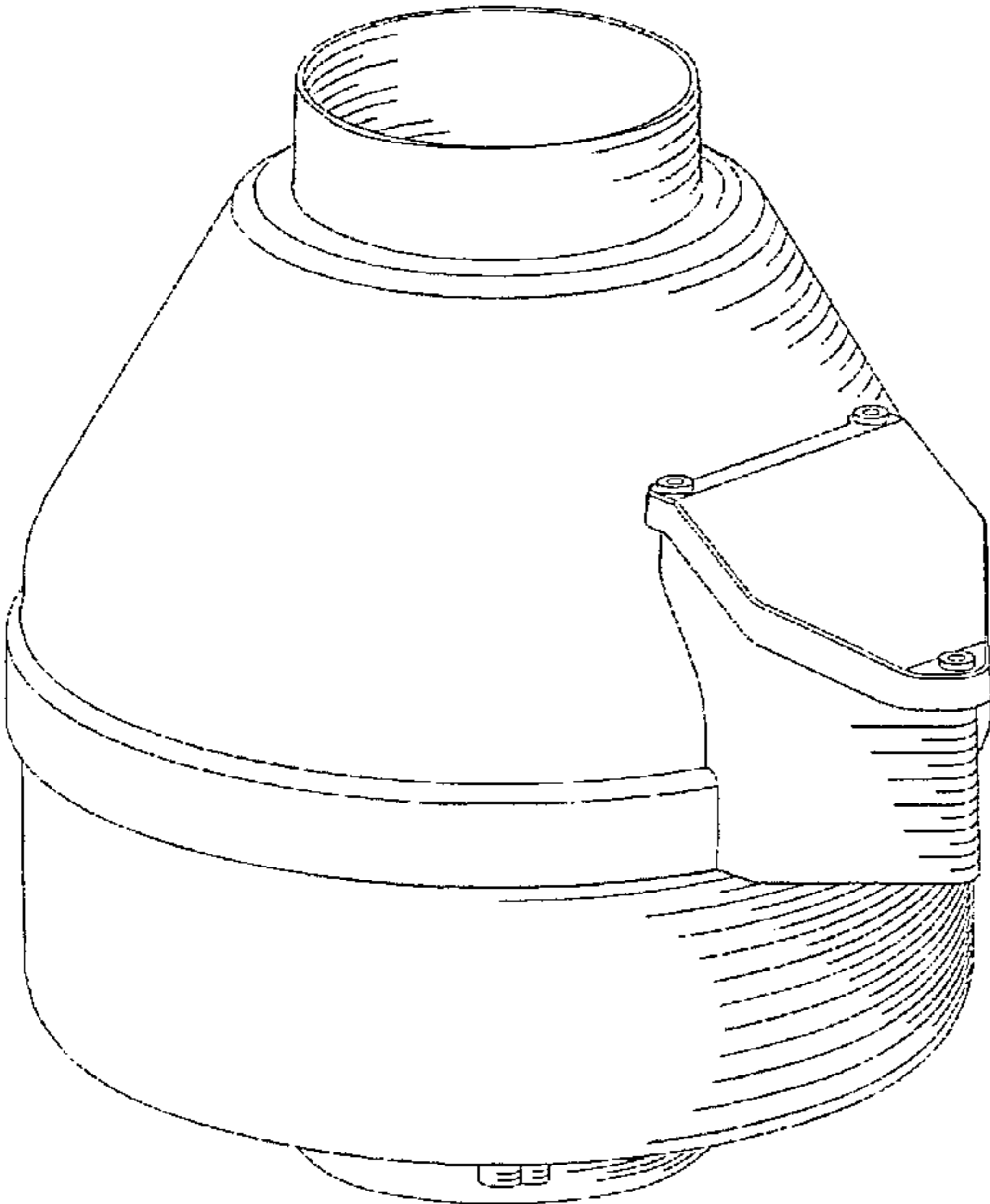

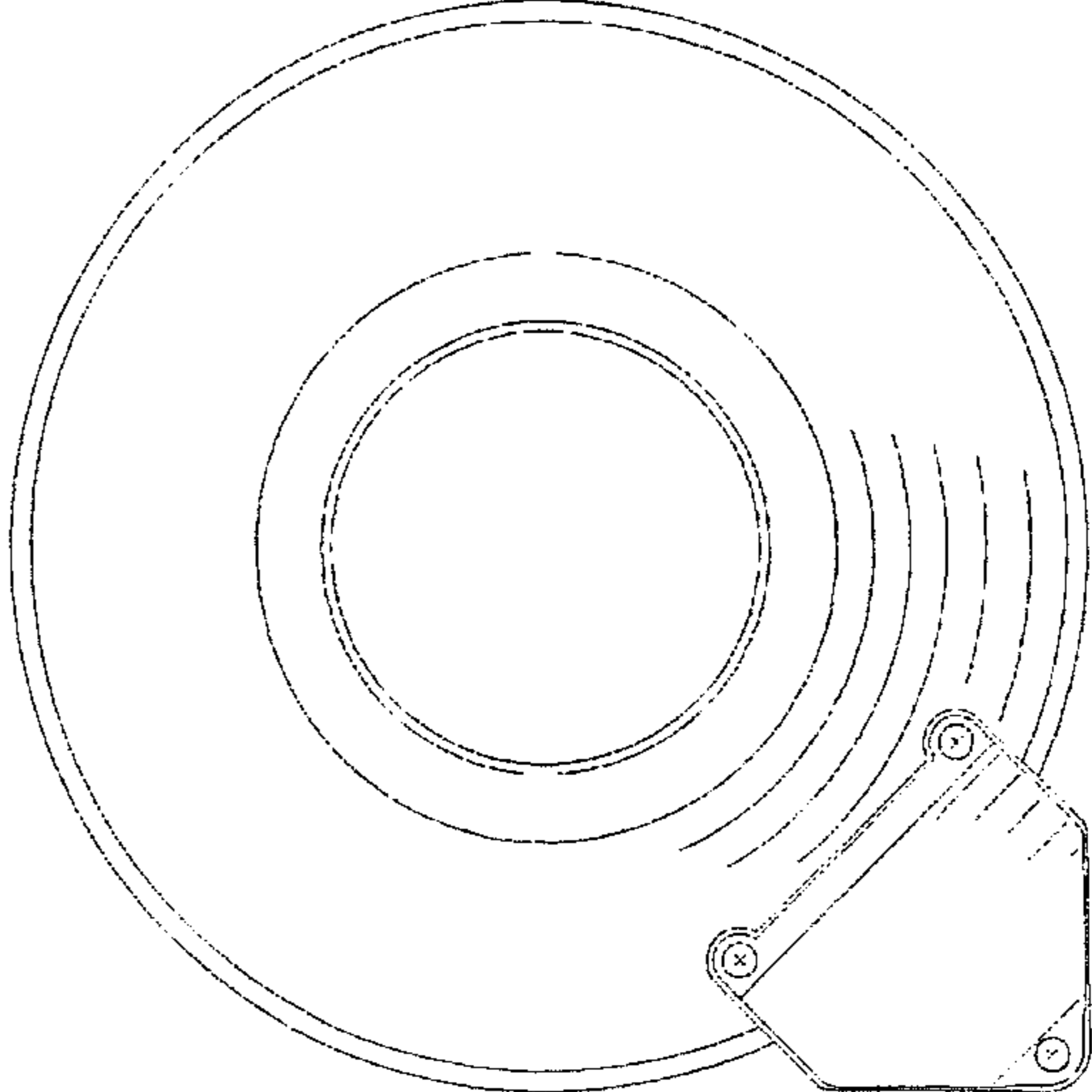

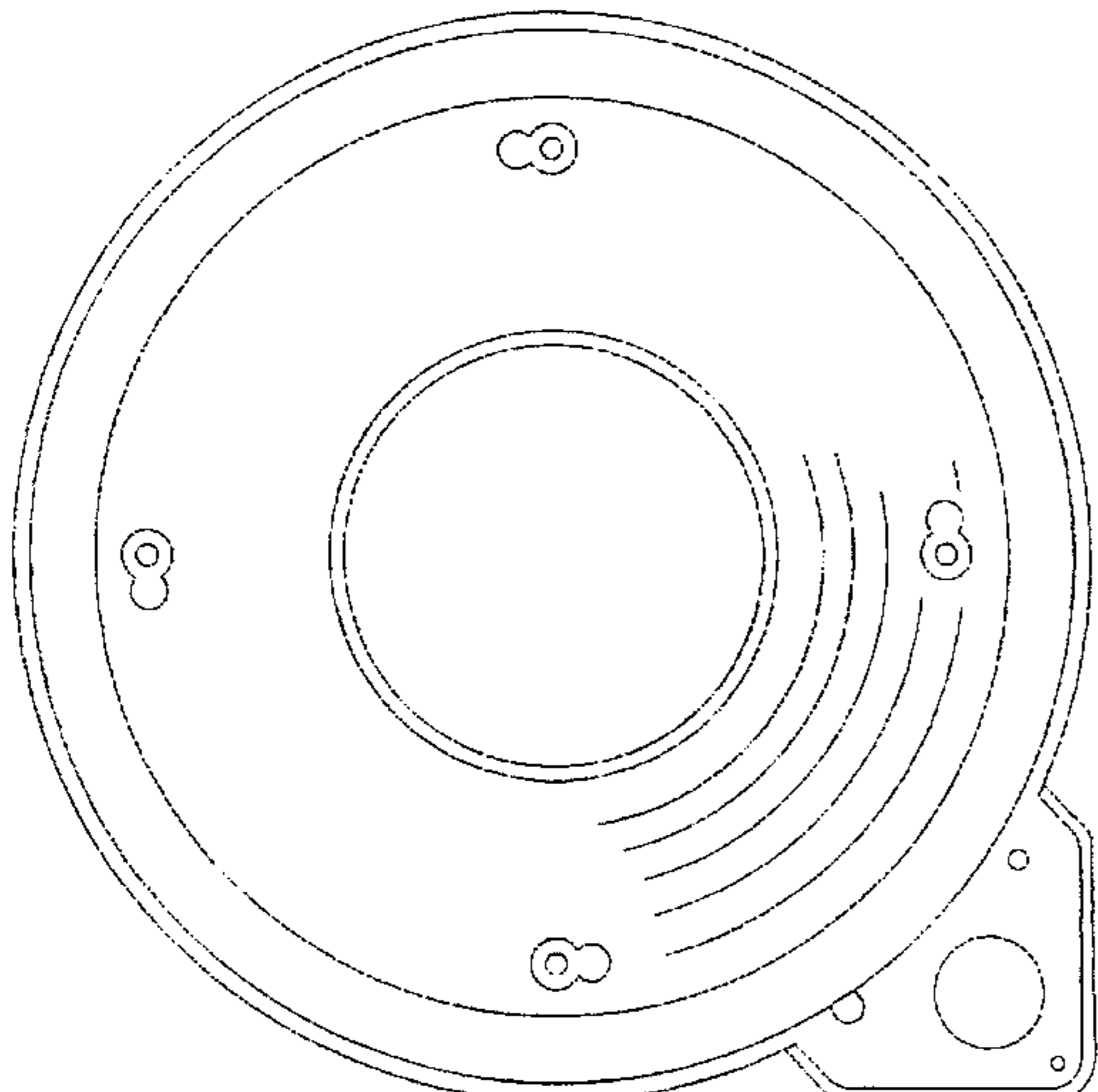

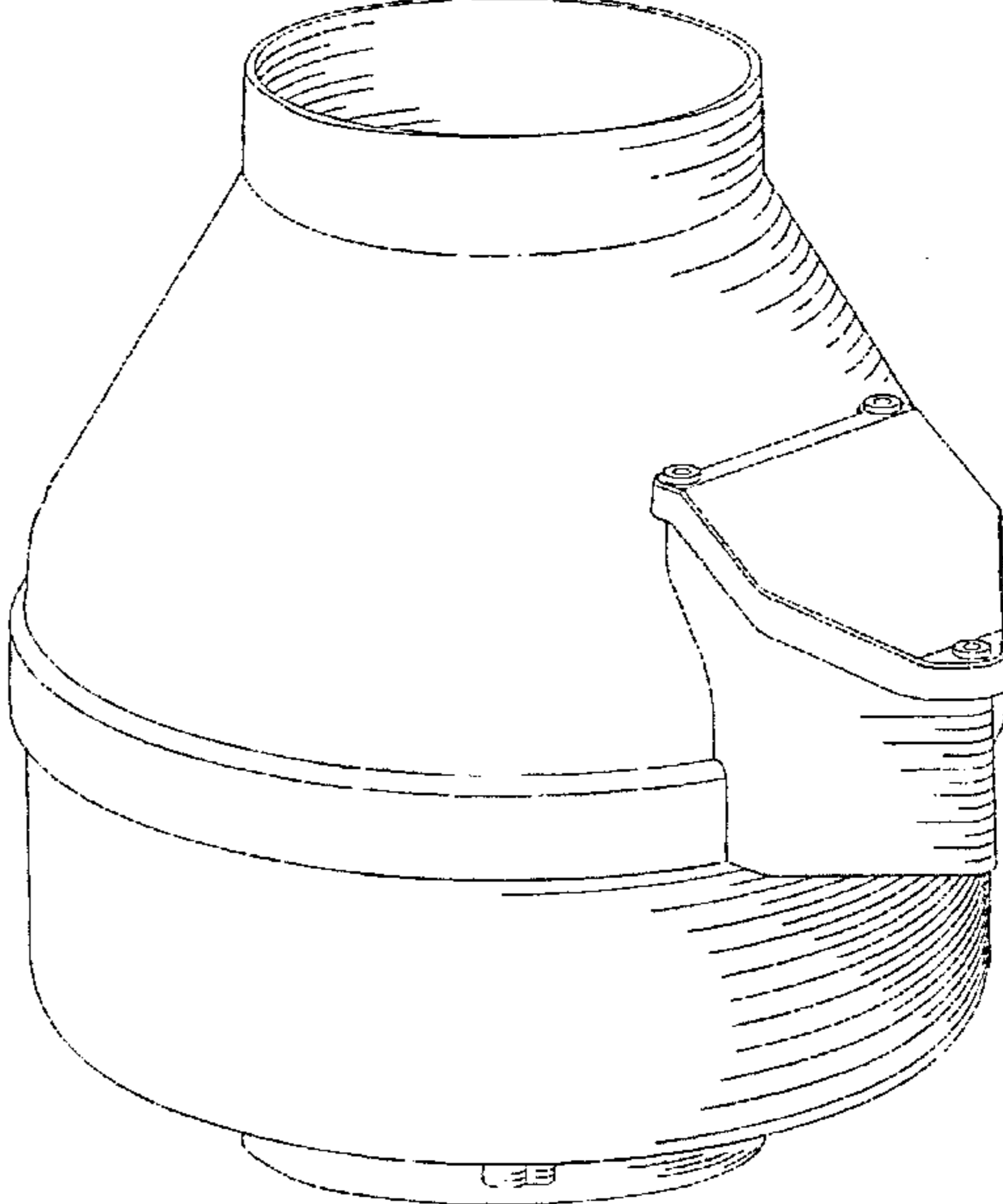

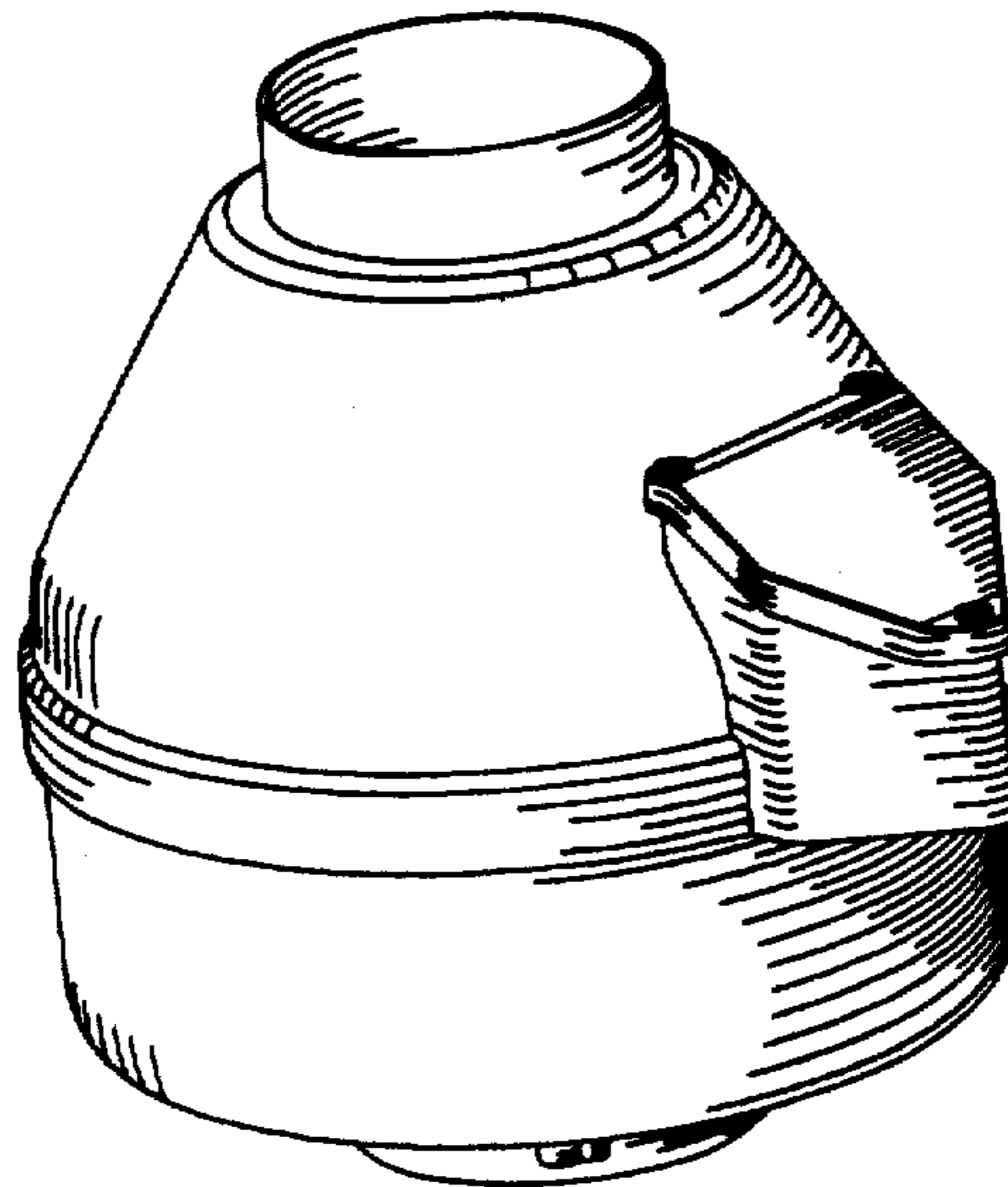

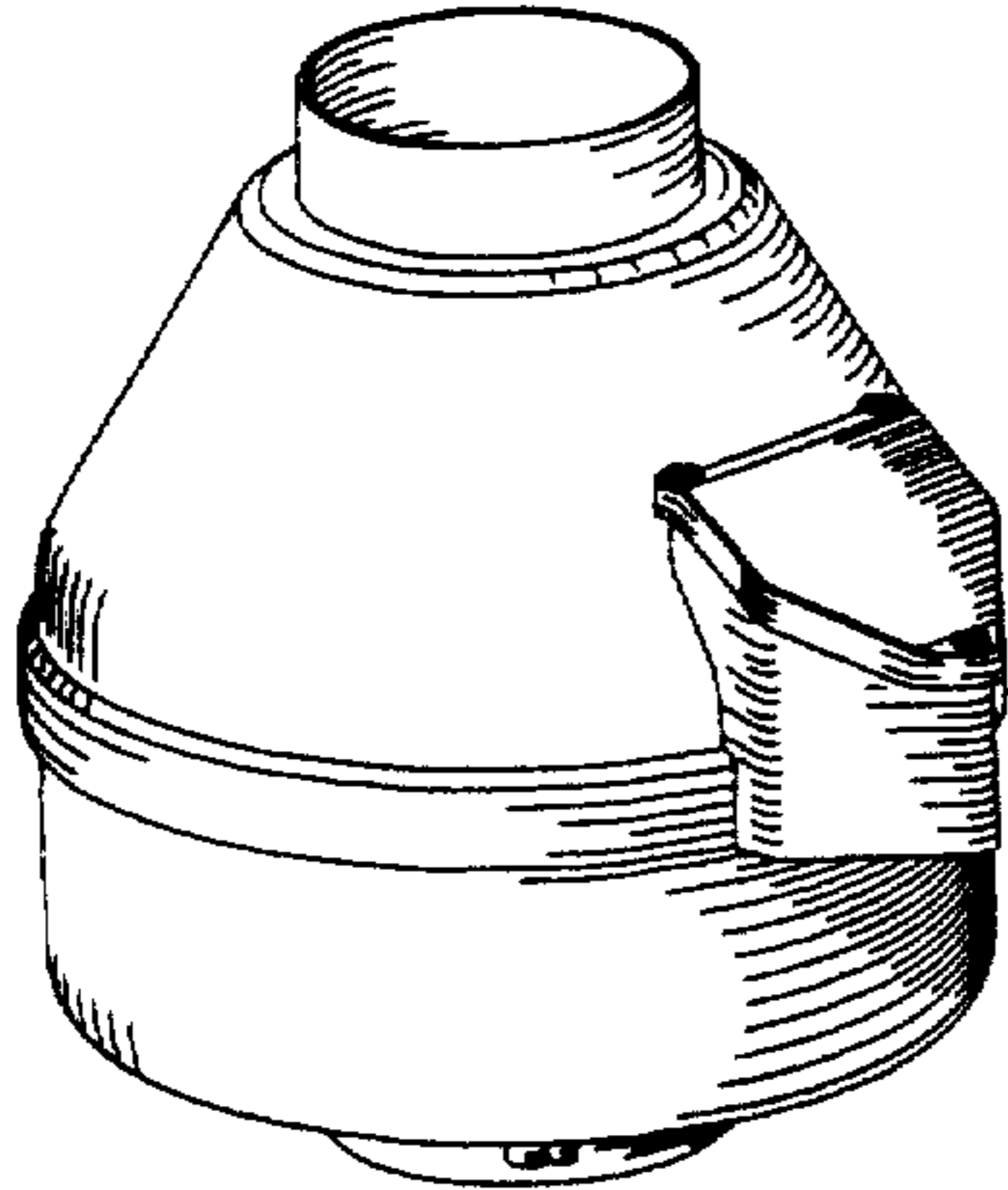

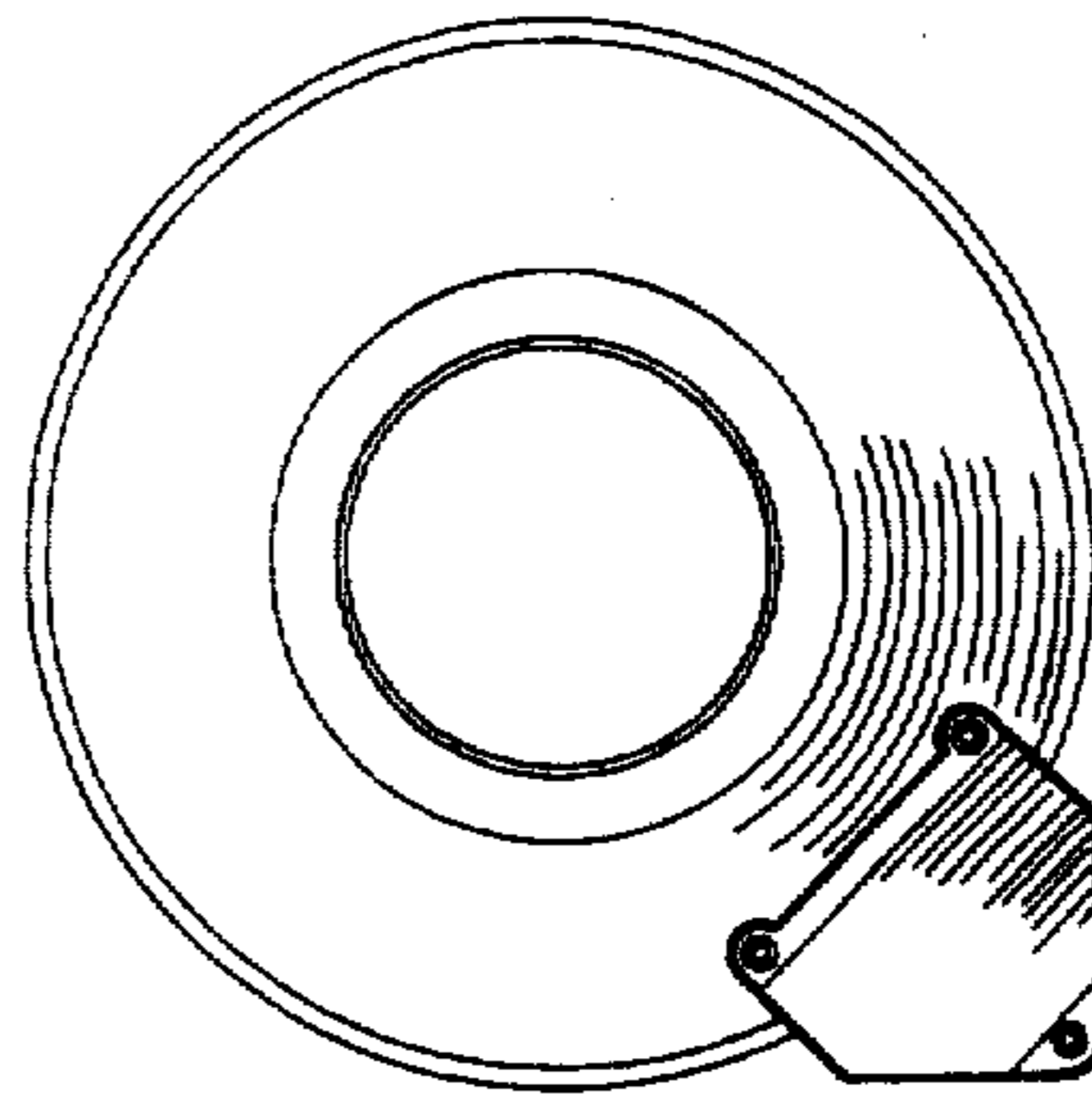

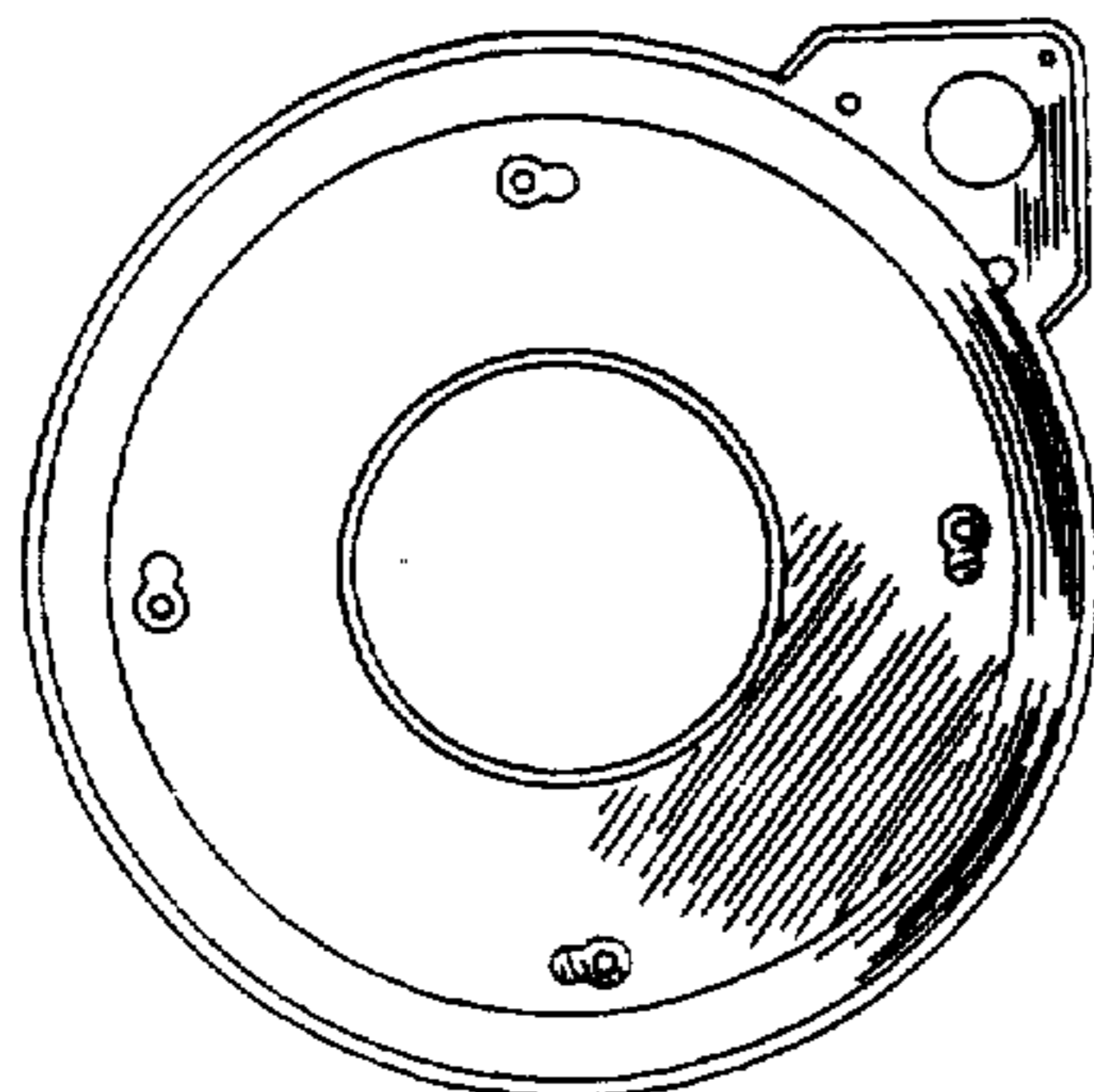

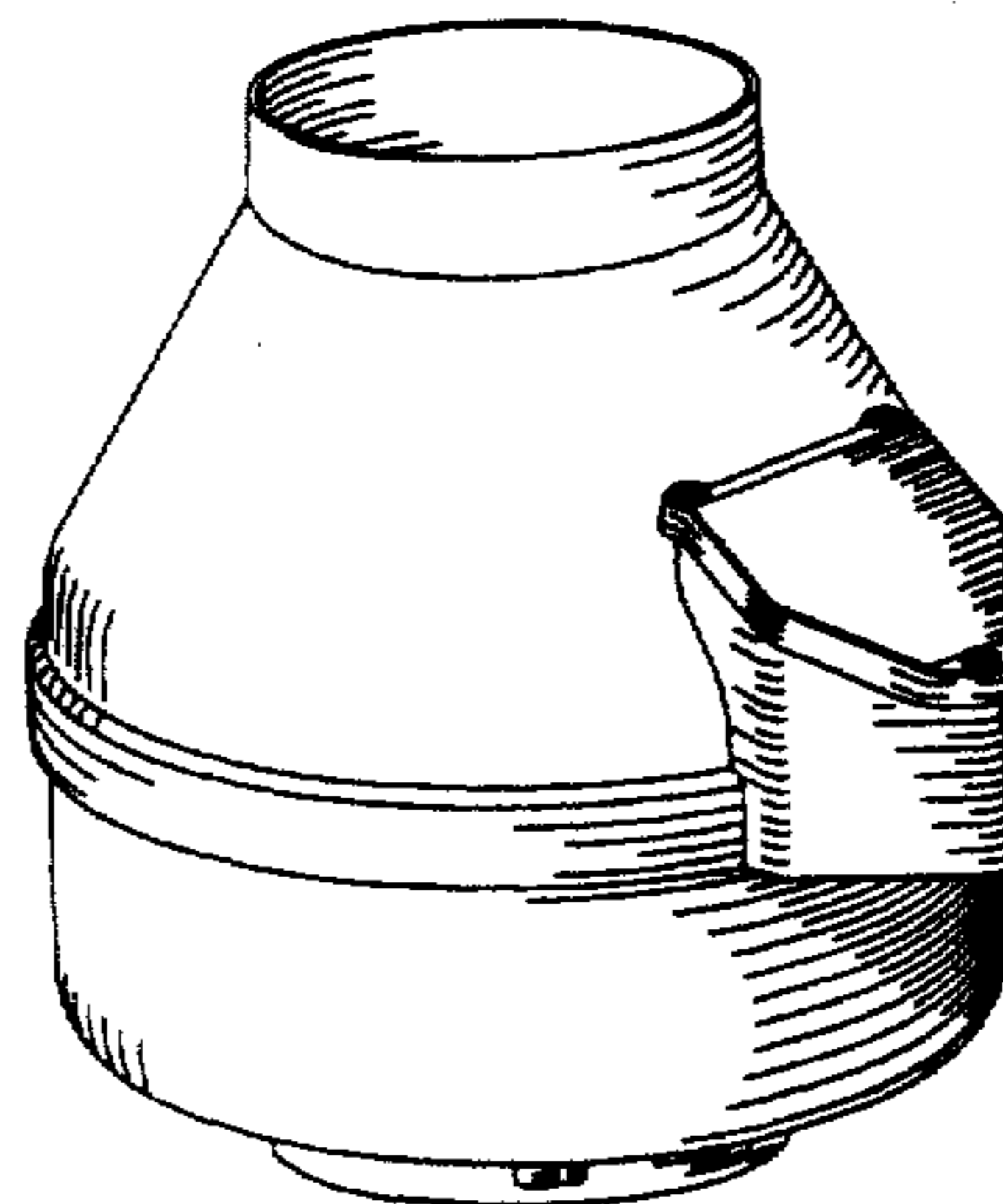
