[57] **CLAIM**

The ornamental design for “pedicure aid for wearing on a foot and separating toes”, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pedicure aid for wearing on a foot and separating toes showing my new design in accordance with a first embodiment of the present invention, wherein the pedicure aid is in a collapsed configuration;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

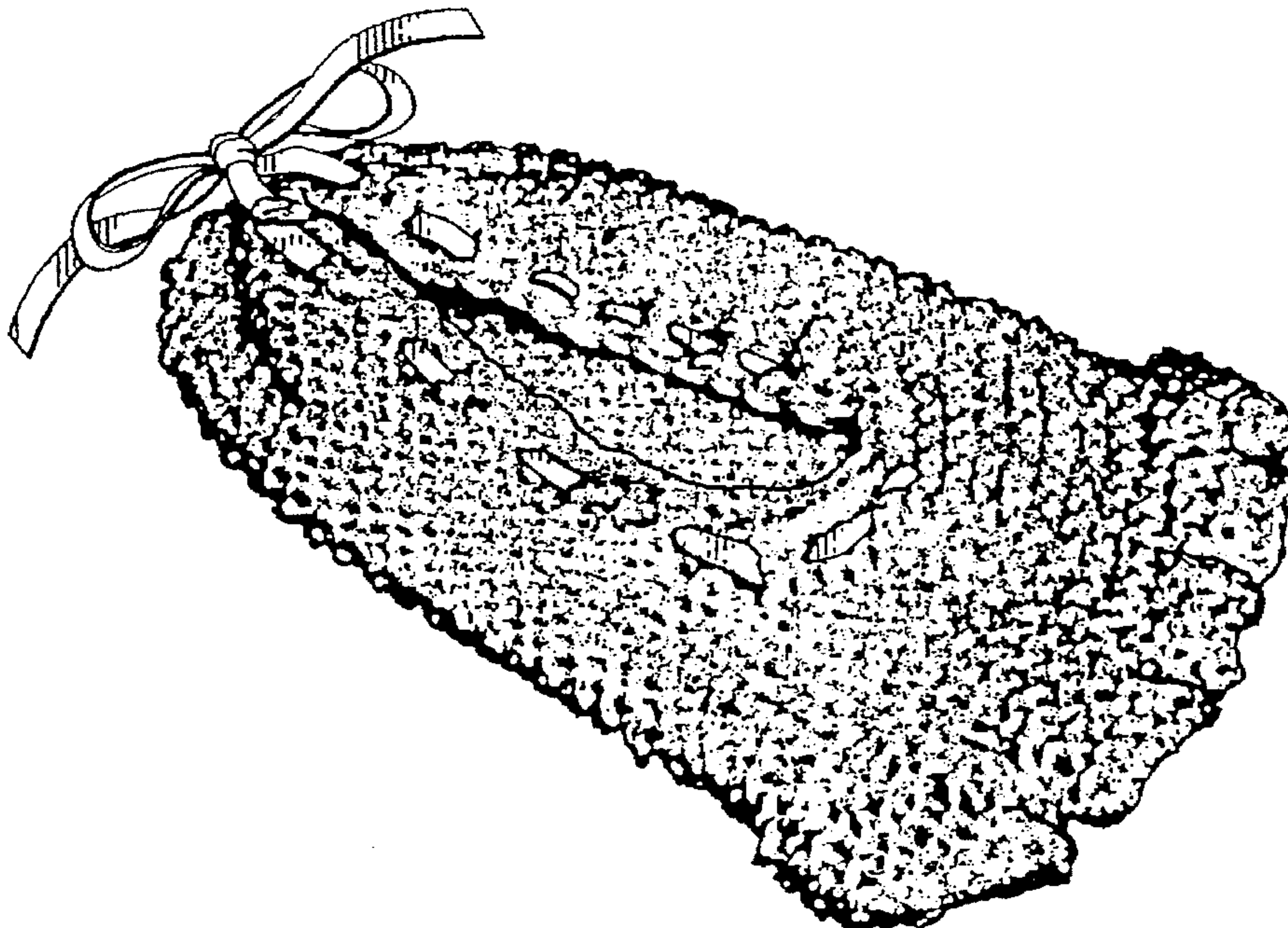
FIG. 7 is a bottom plan view thereof;

FIG. 8 is a perspective view of the pedicure aid of the first embodiment in an in-use configuration; and,

FIG. 9 is a bottom plan view of a second embodiment of my design, the undisclosed sides thereof appearing the same as the first disclosed embodiment shown in FIGS. 1–6.

The broken line showing of toes extending from holes in the front of the pedicure aid in FIG. 8 is for illustrative purposes only and forms no part of the claimed design.

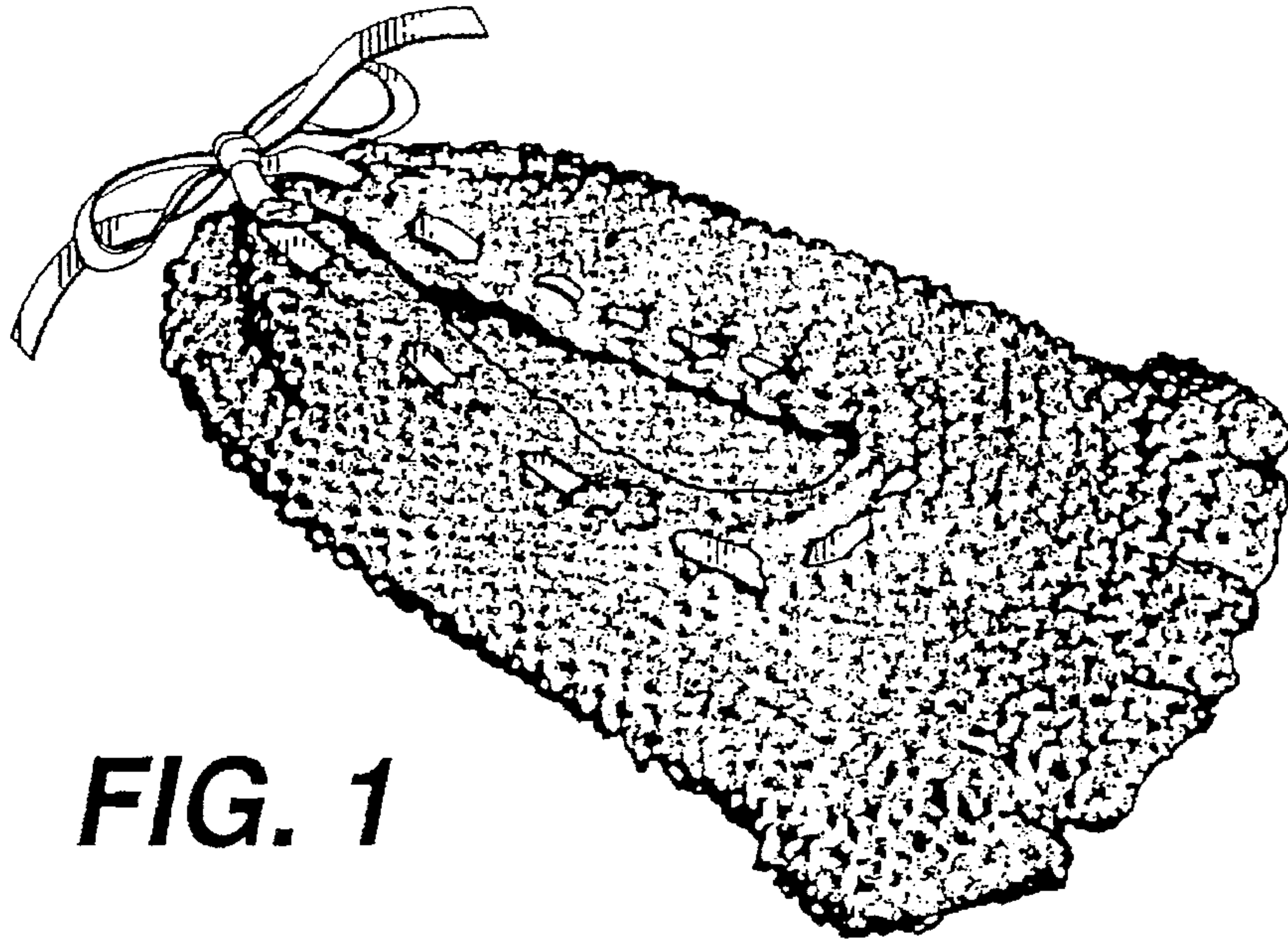

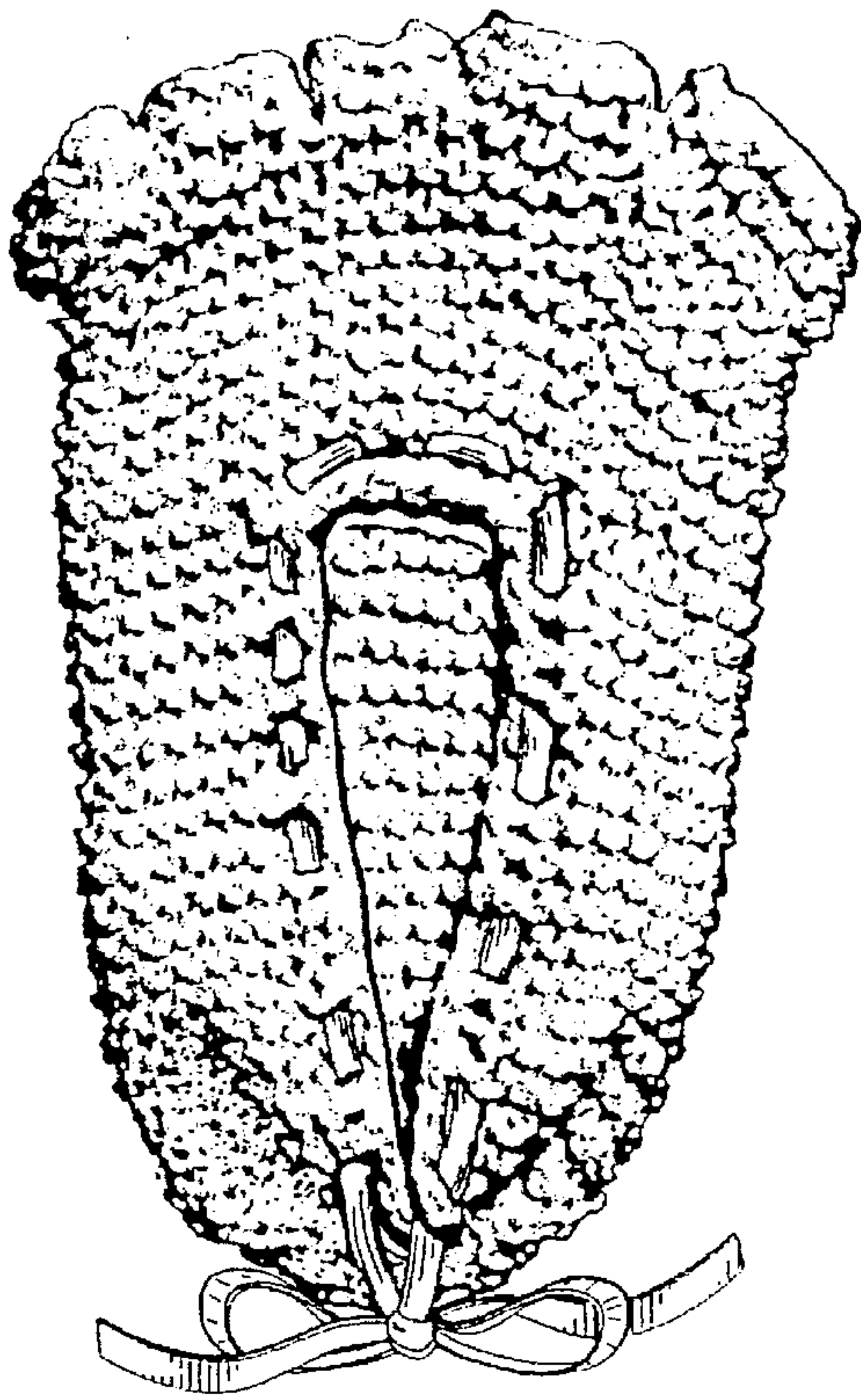

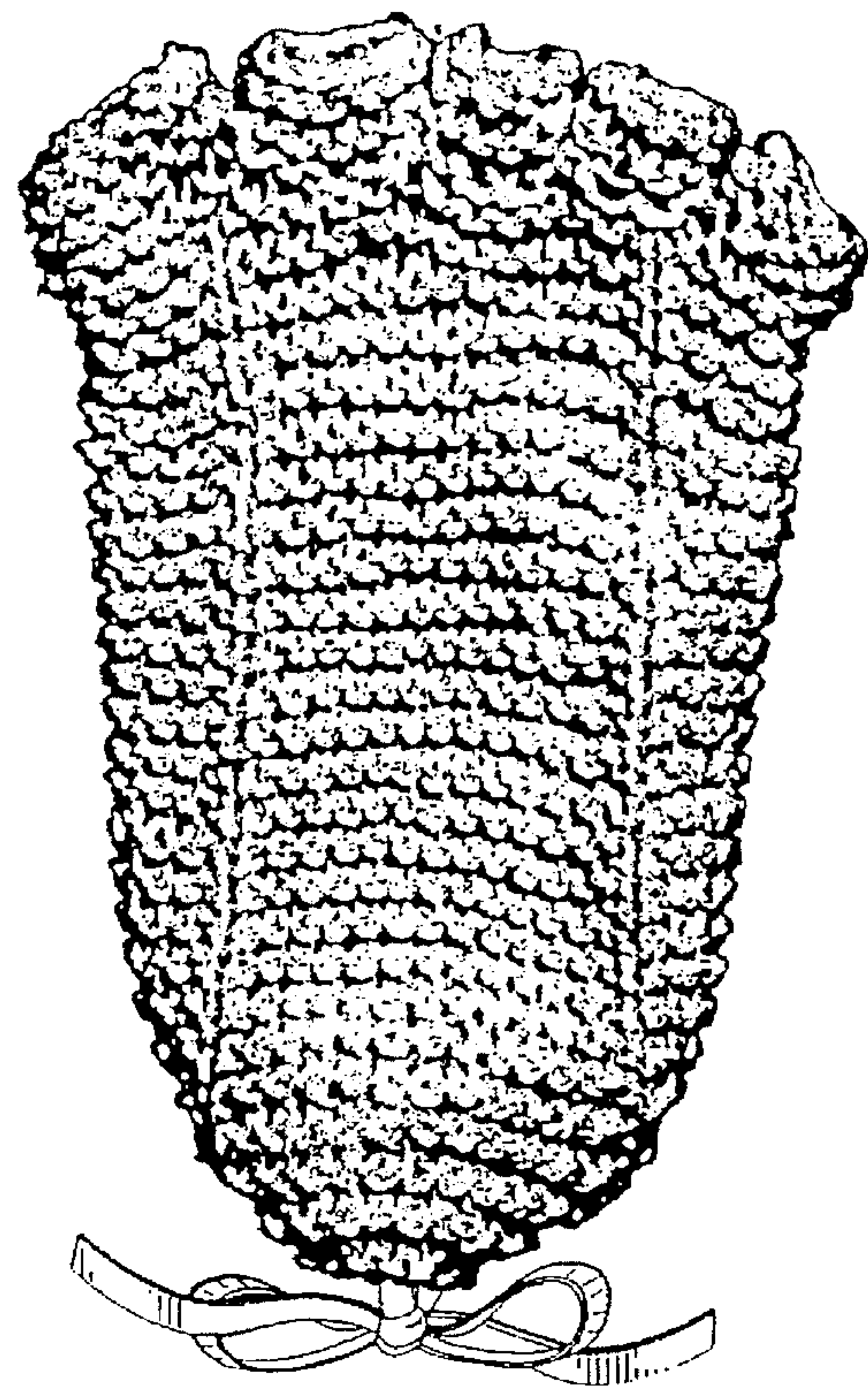

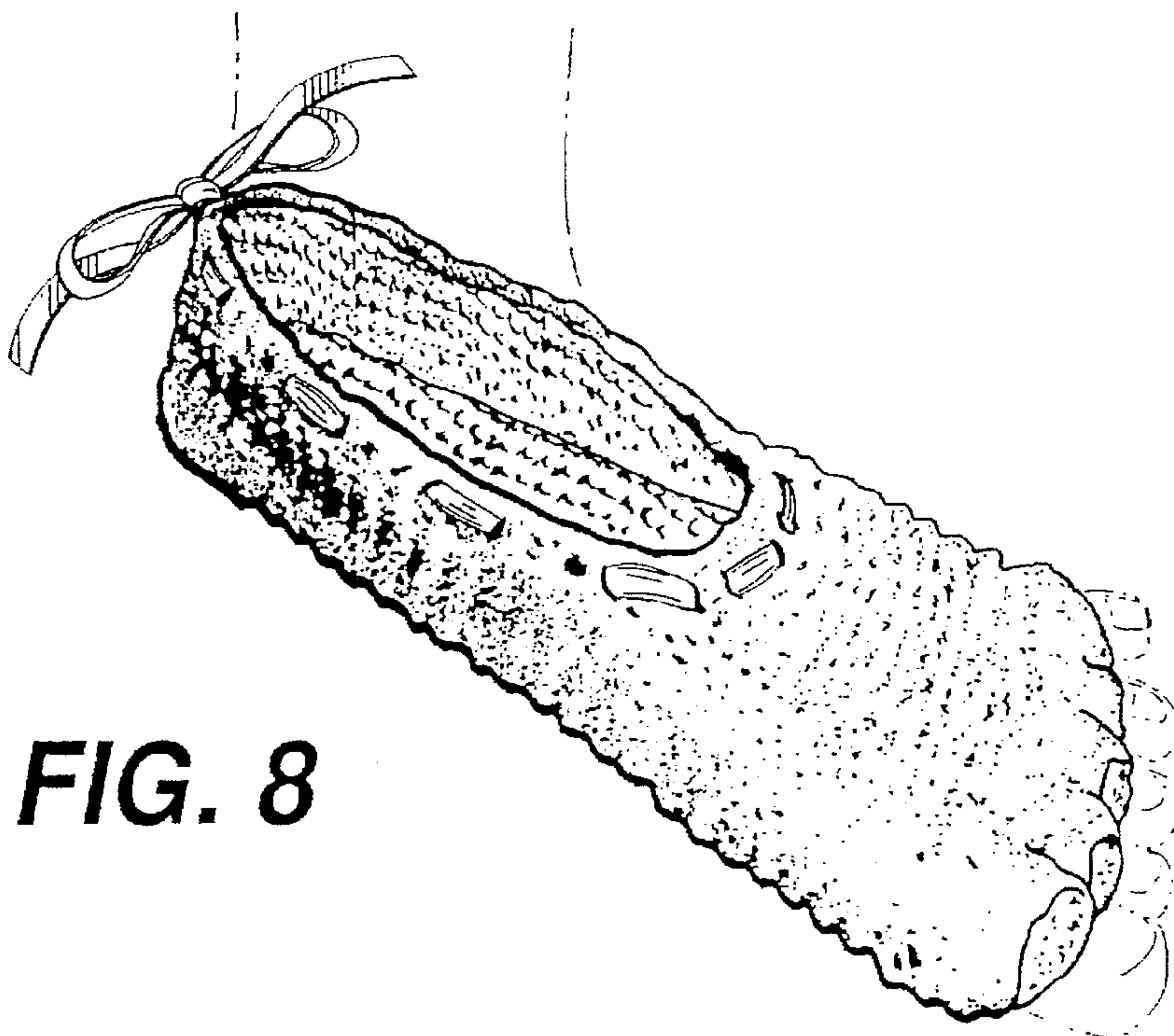

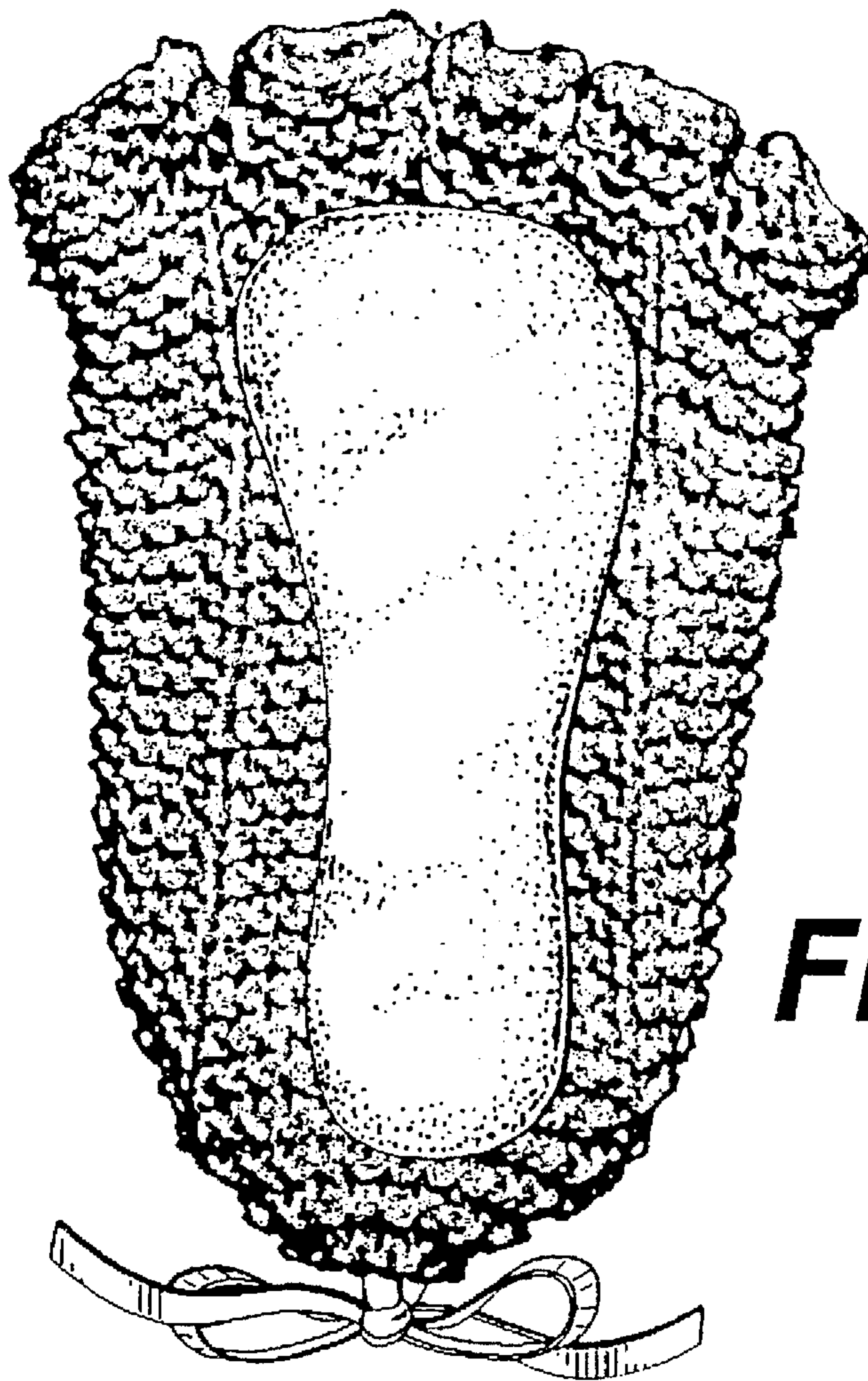
