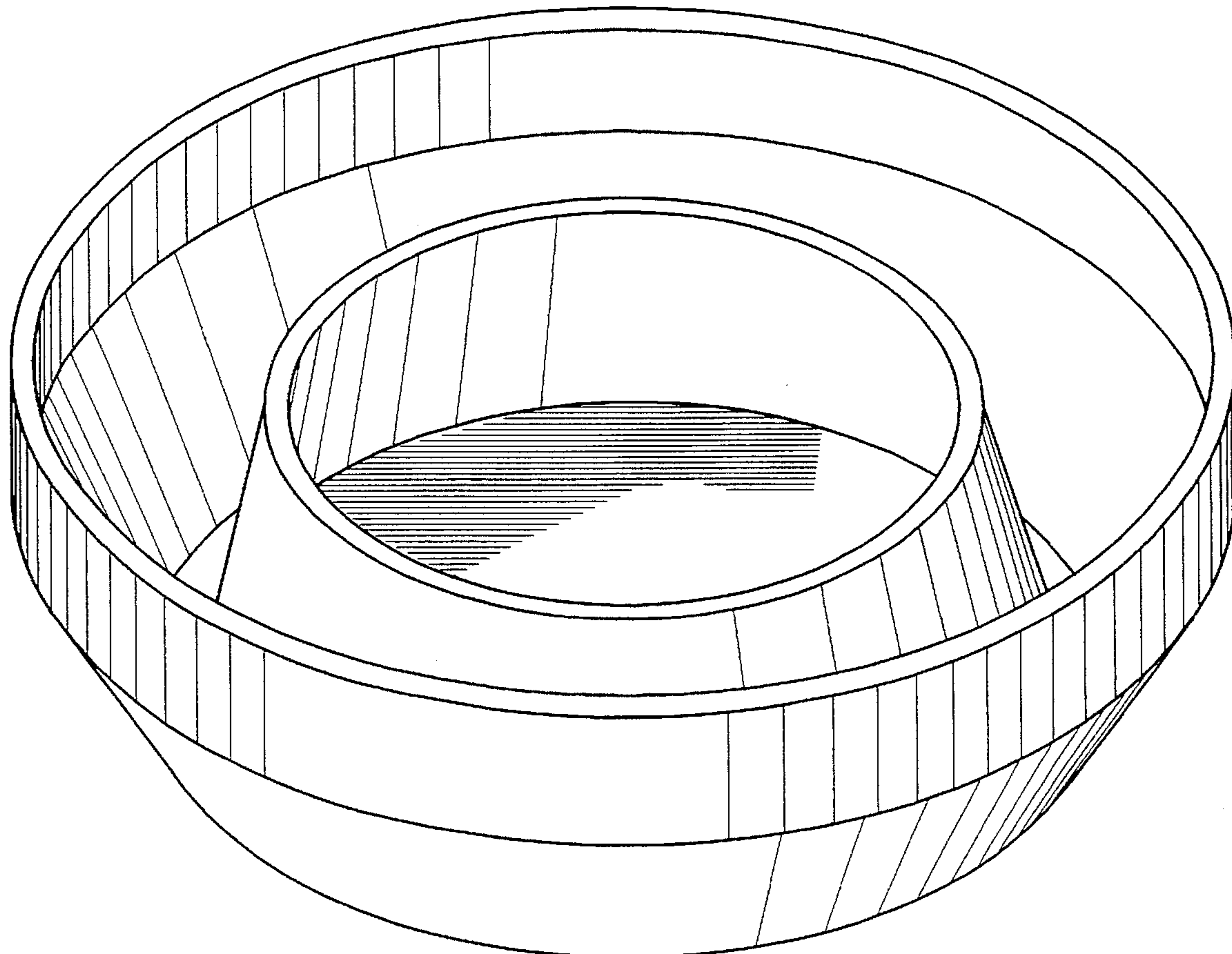
[57] **CLAIM**

The ornamental design for a spill catching pet bowl, as shown and described.

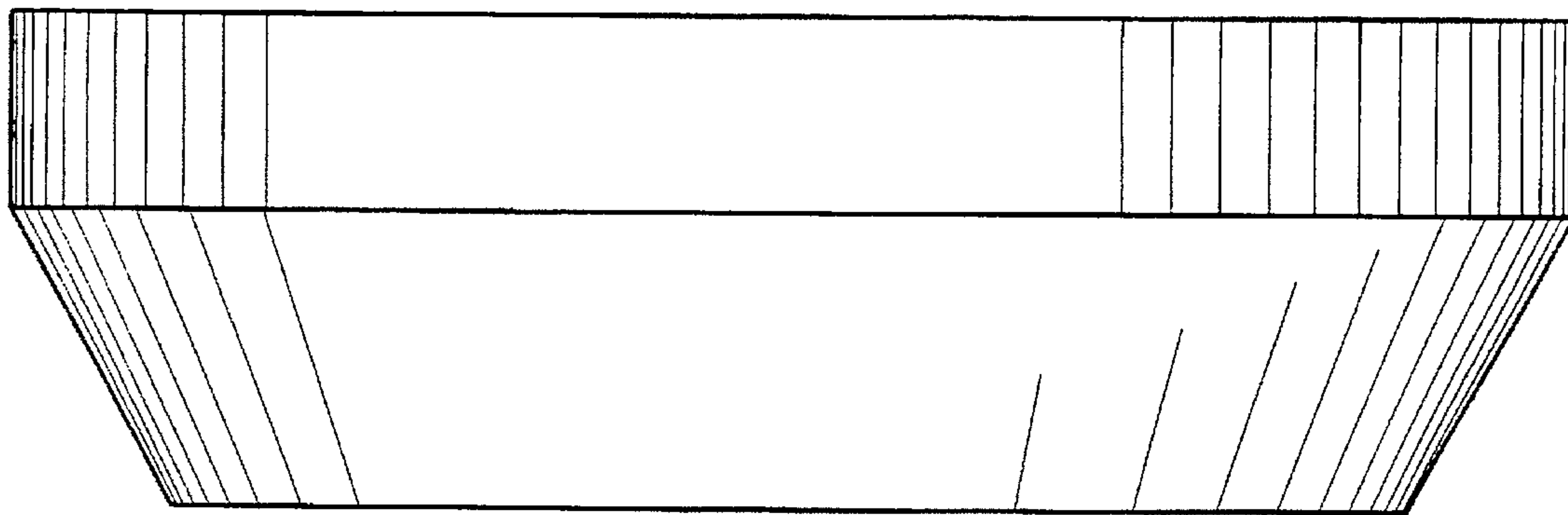
**DESCRIPTION**

FIG. 1 is a front elevational view of the spill catching pet bowl showing our new design;

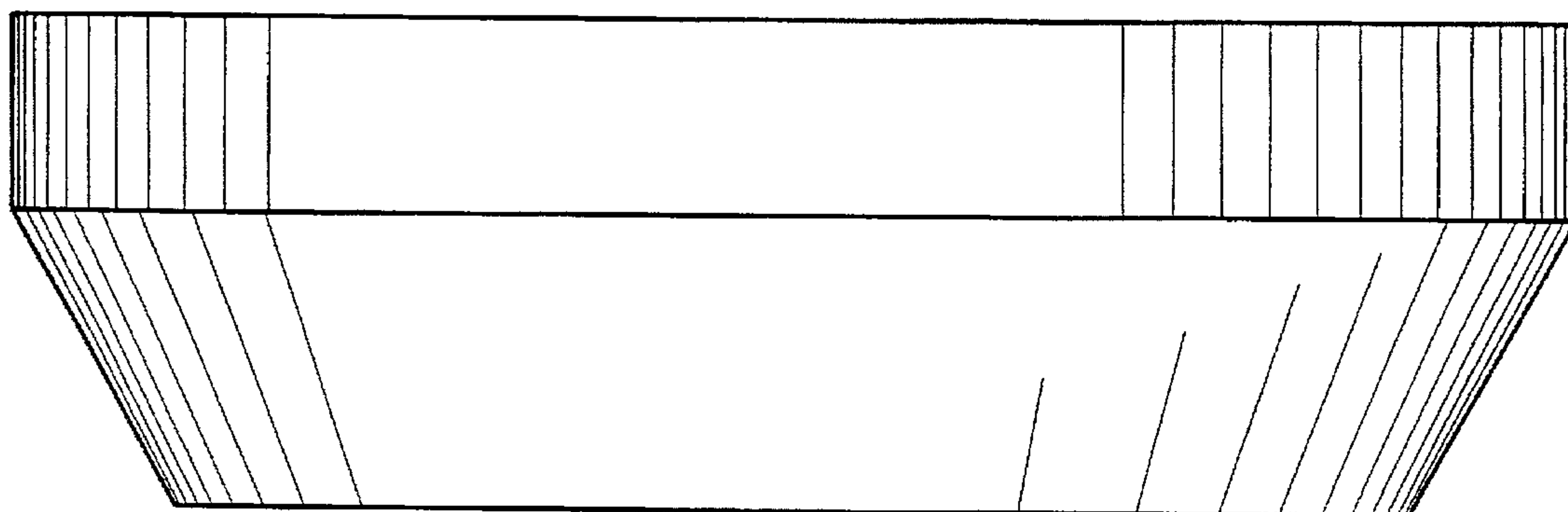

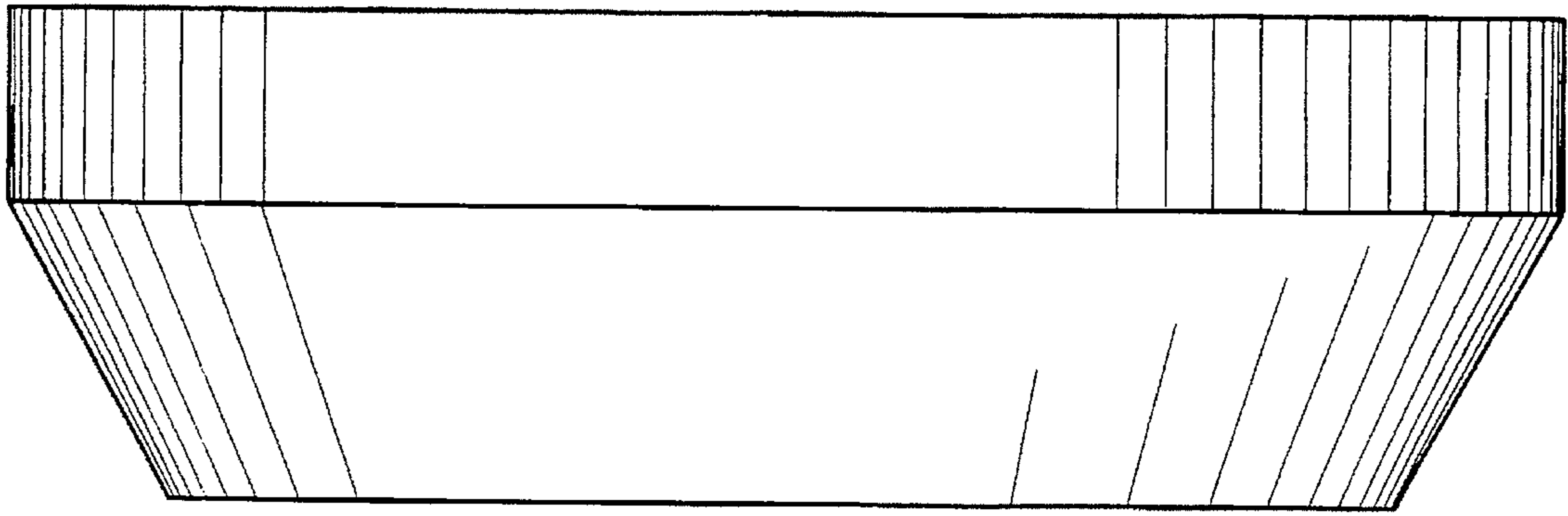
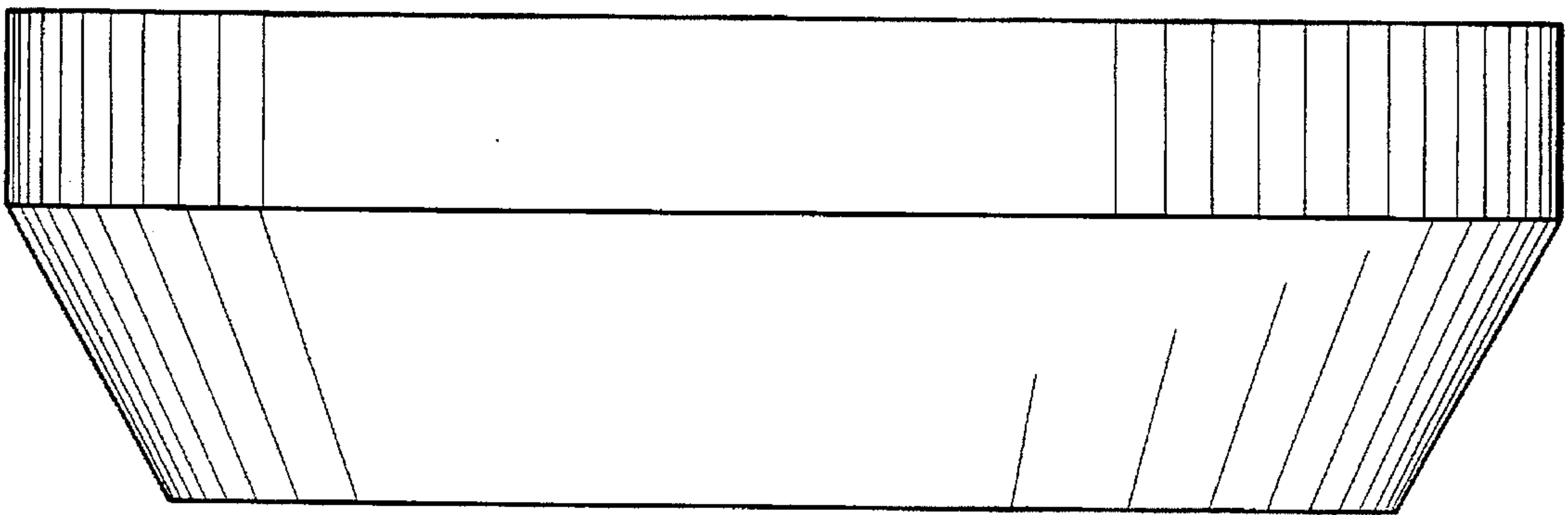

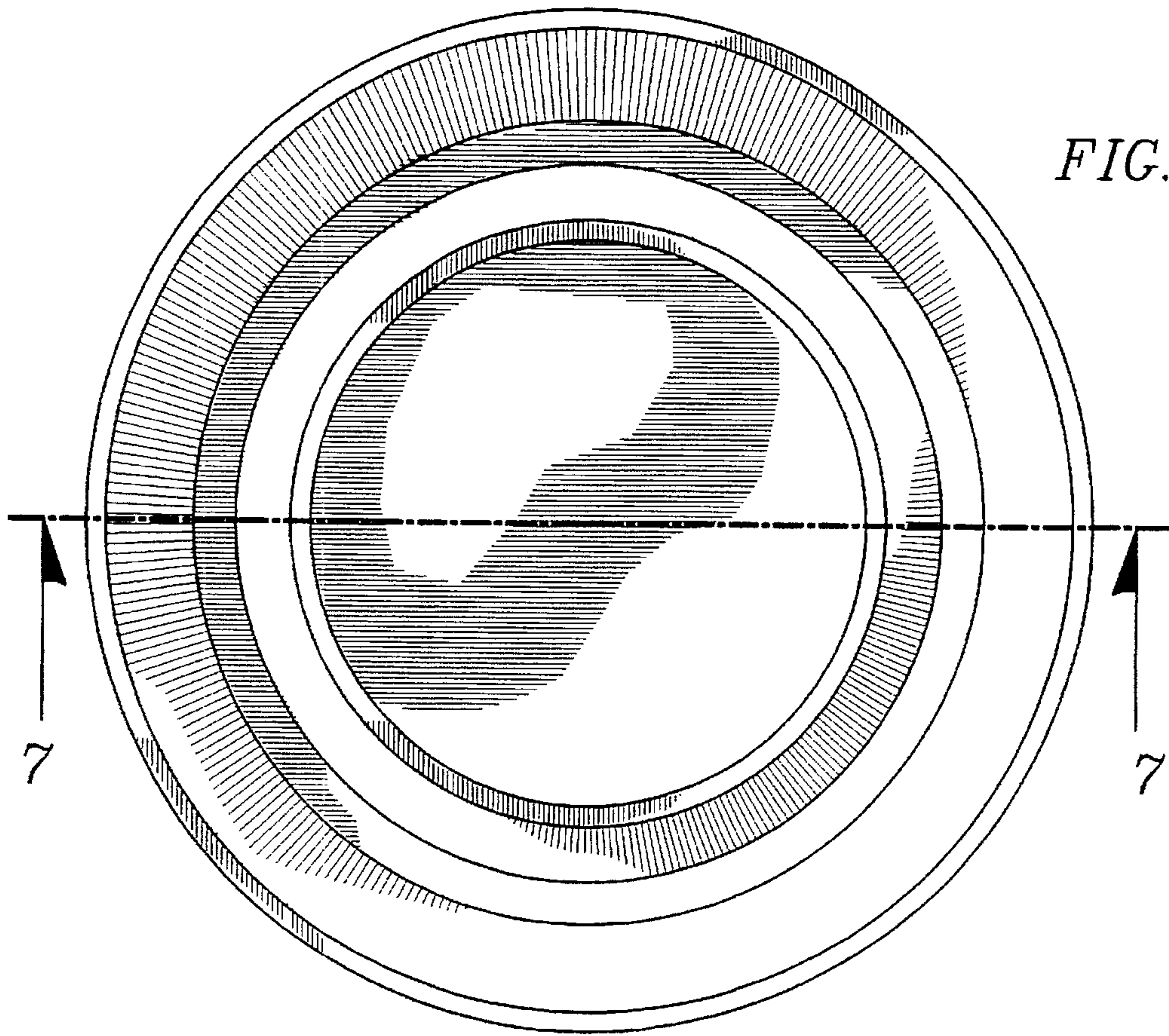
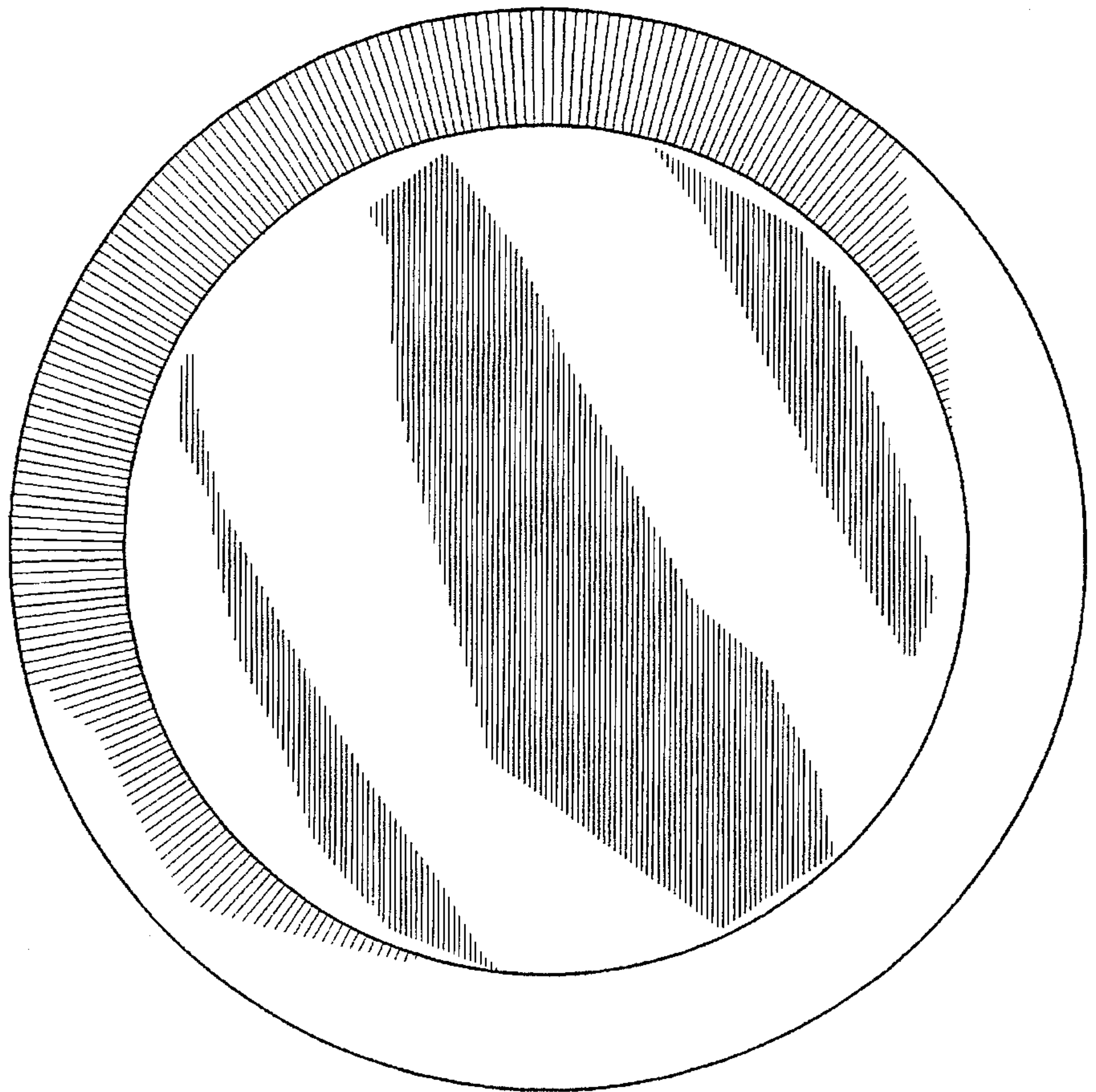

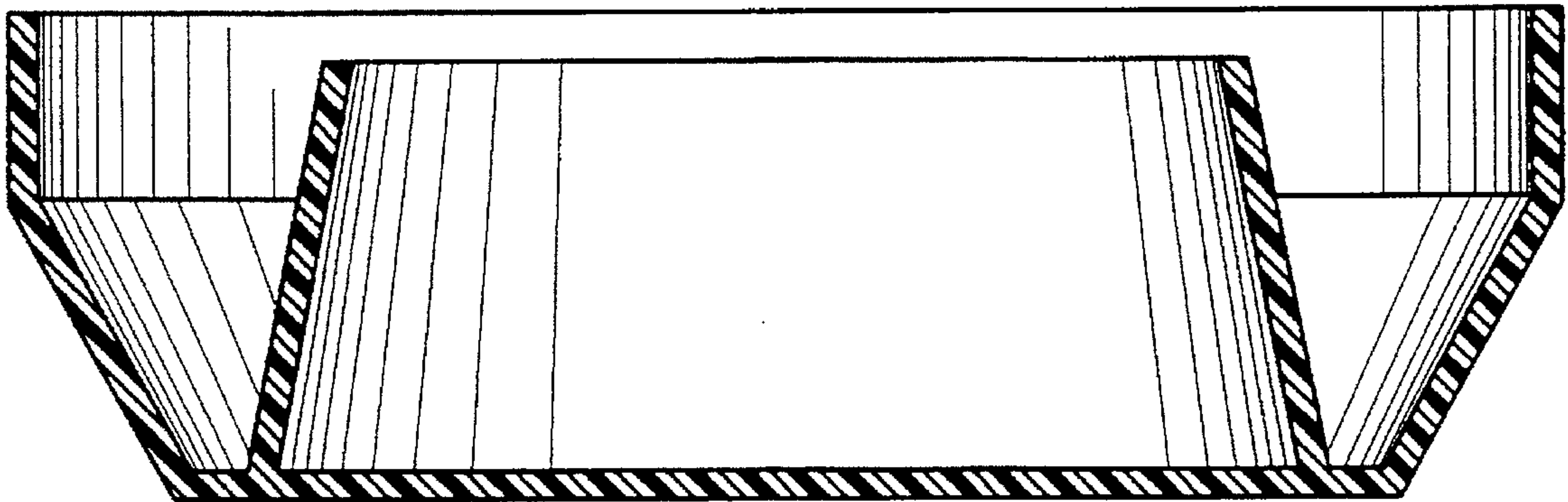
