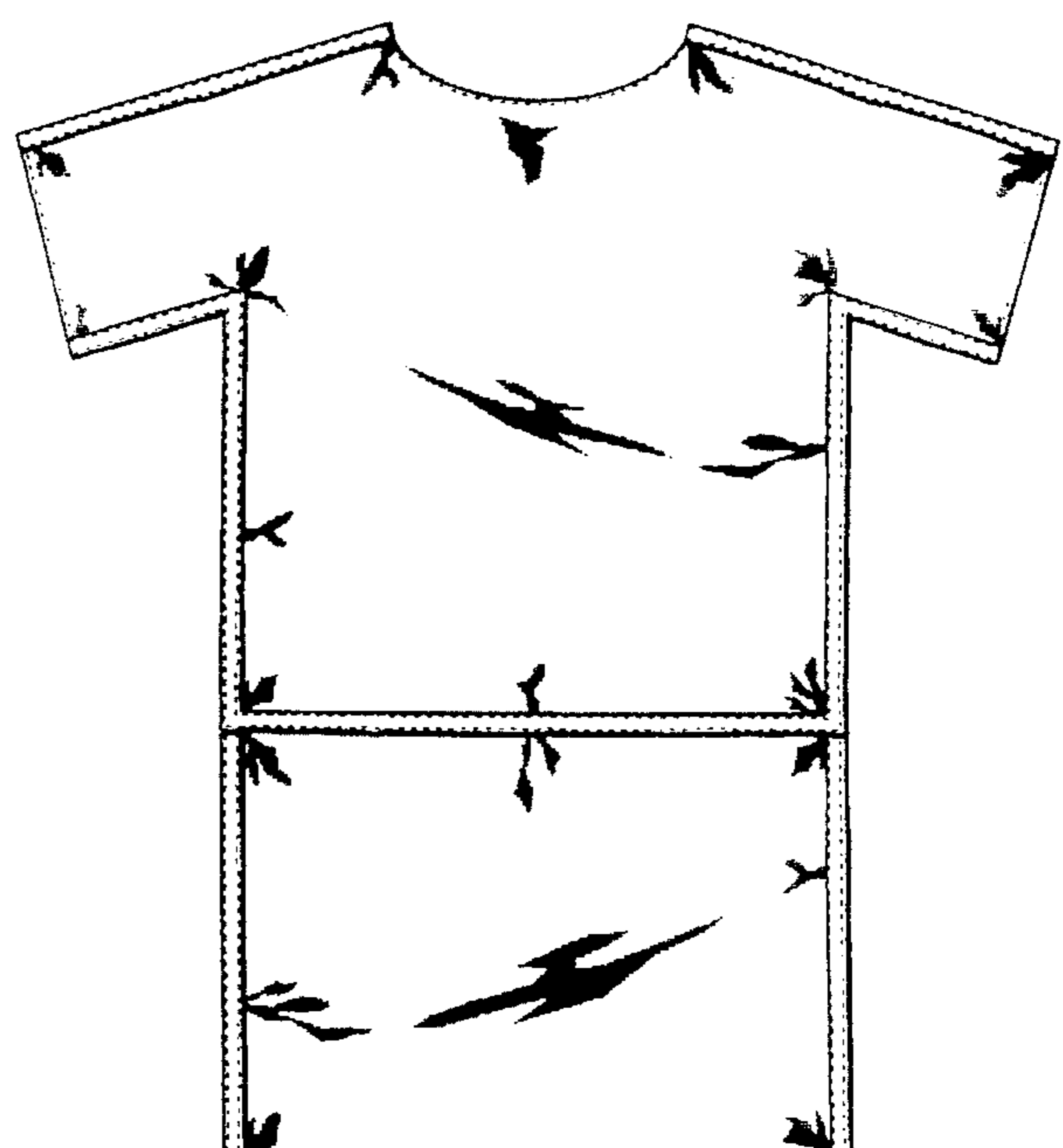
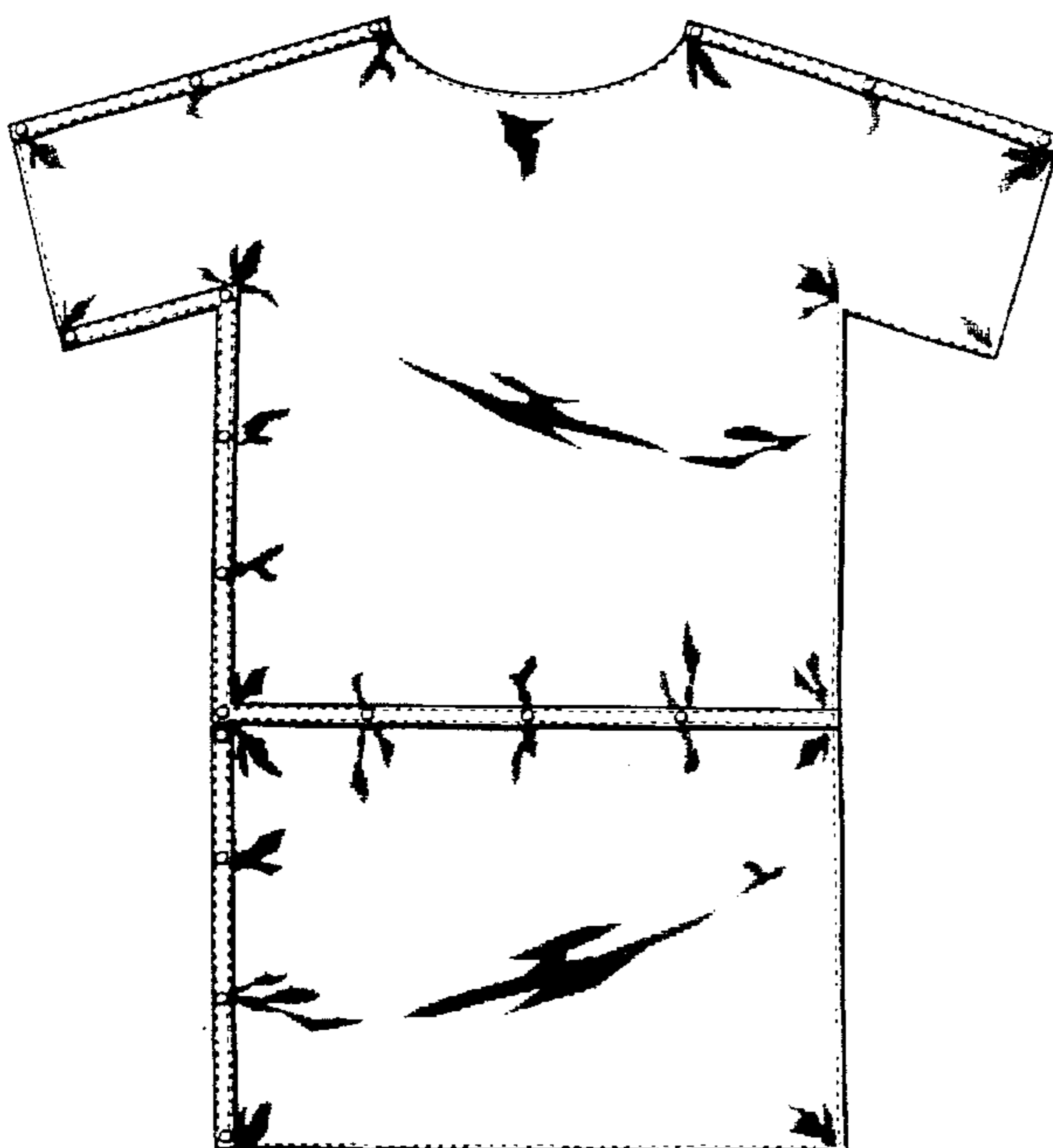
[57] **CLAIM**

An ornamental design for a hospital gown, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a hospital gown showing a first preferred embodiment of my new design;  
 FIG. 2 is a rear elevational view of the hospital gown shown in FIG. 1;  
 FIG. 3 is a front elevational view of the hospital gown shown in FIG. 1 with certain portions of front layer of the hospital gown detached from a rear layer of the hospital gown;  
 FIG. 4 is a front elevational view of a further embodiment of the hospital gown;  
 FIG. 5 is a rear elevational view of the hospital gown shown in FIG. 4;  
 FIG. 6 is a front elevational view of the hospital gown shown in FIG. 4 with certain portions of the front layer of the hospital gown detached from the rear layer of the hospital gown;  
 FIG. 7 is a front elevational view of a further embodiment of the hospital gown;  
 FIG. 8 is a rear elevational view of the hospital gown shown in FIG. 7;  
 FIG. 9 is a front elevational view of the hospital gown shown in FIG. 7 with certain portions of the front layer of the hospital gown detached from the rear layer of the hospital gown;  
 FIG. 10 is a front elevational view of a further embodiment of the hospital gown;  
 FIG. 11 is a rear elevational view of the hospital gown shown in FIG. 10; and,  
 FIG. 12 is front elevational view of the hospital gown shown in FIG. 10 with certain portions of the front layer of the hospital gown detached from the rear layer of the hospital gown.

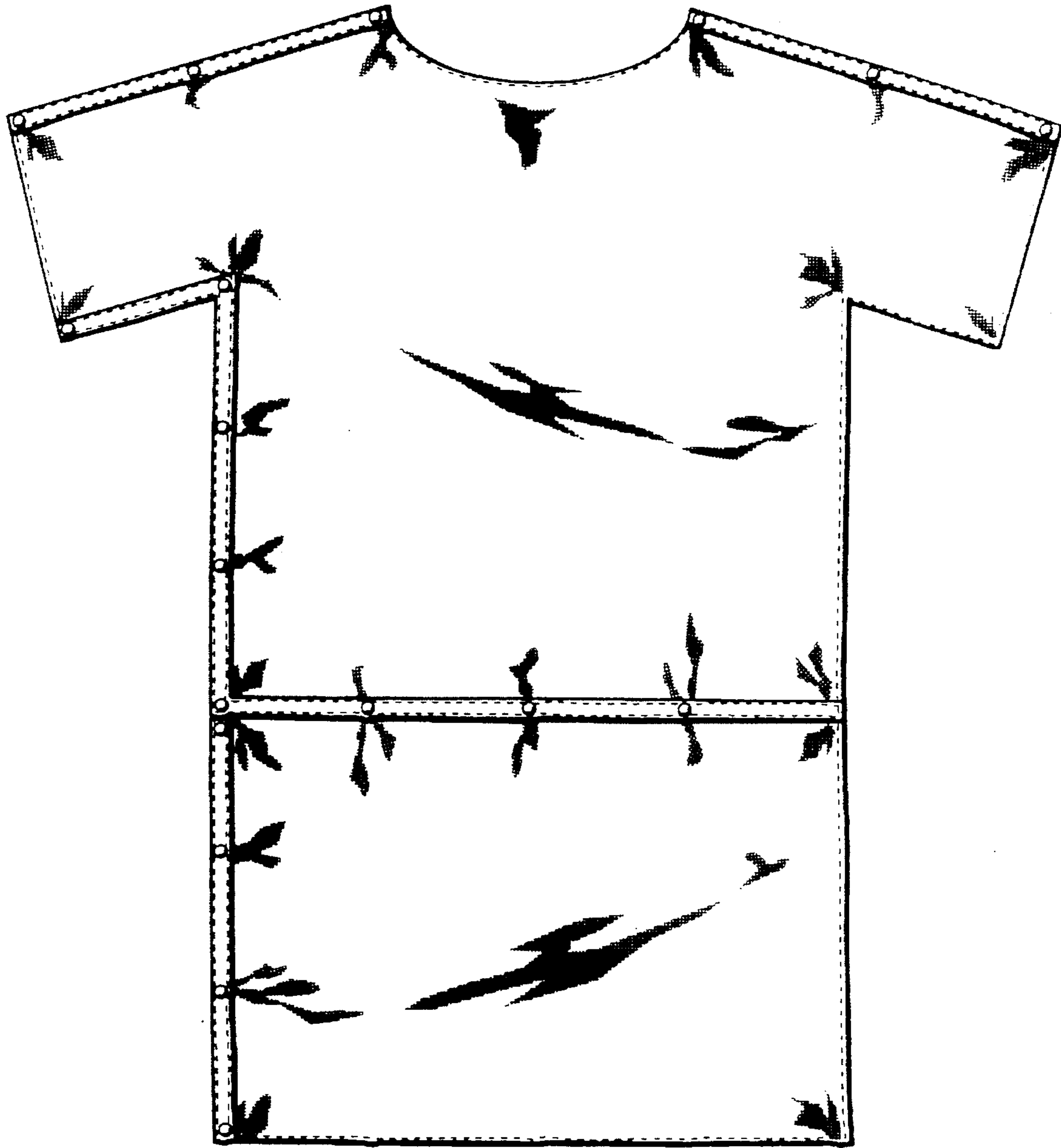

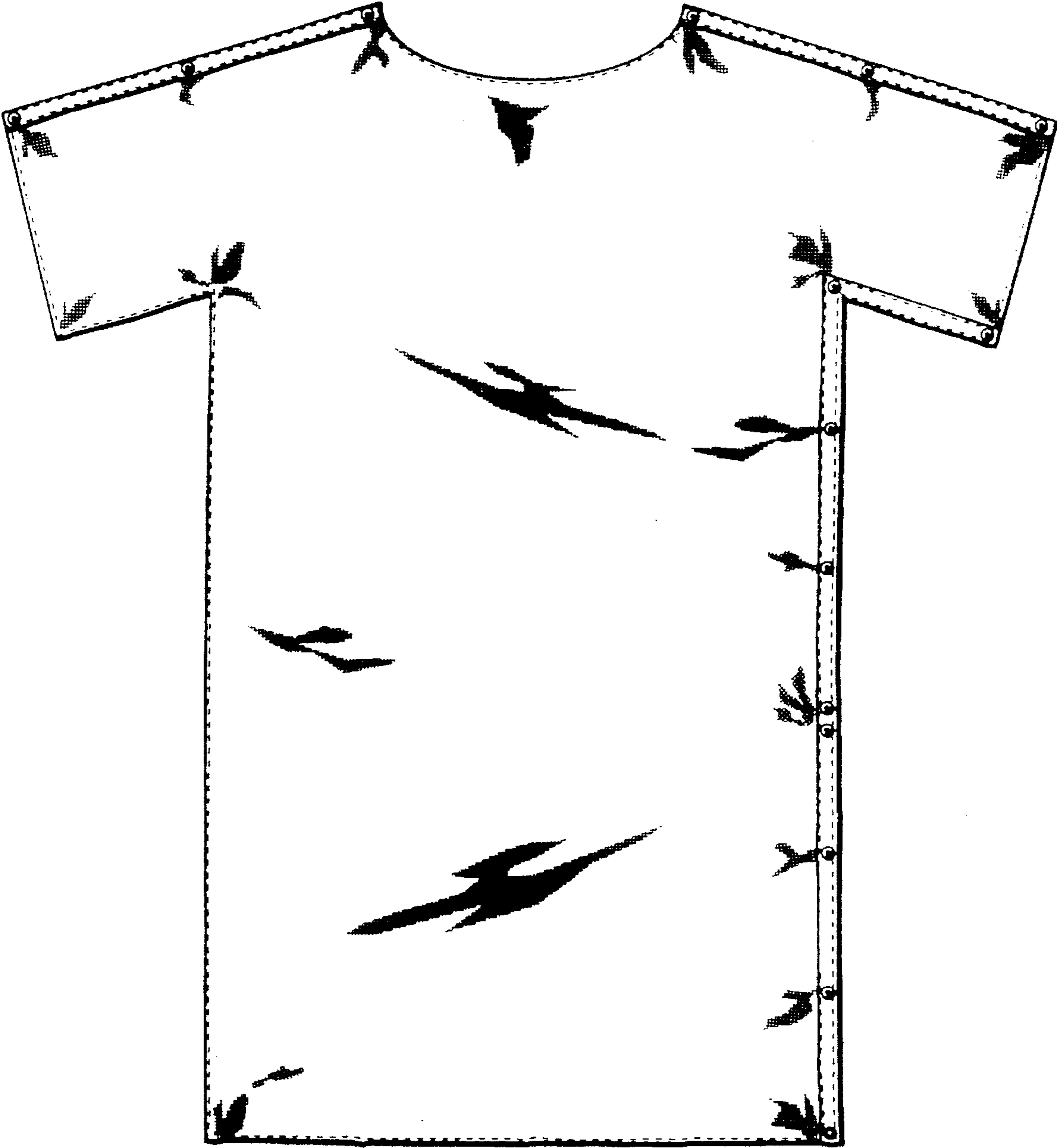

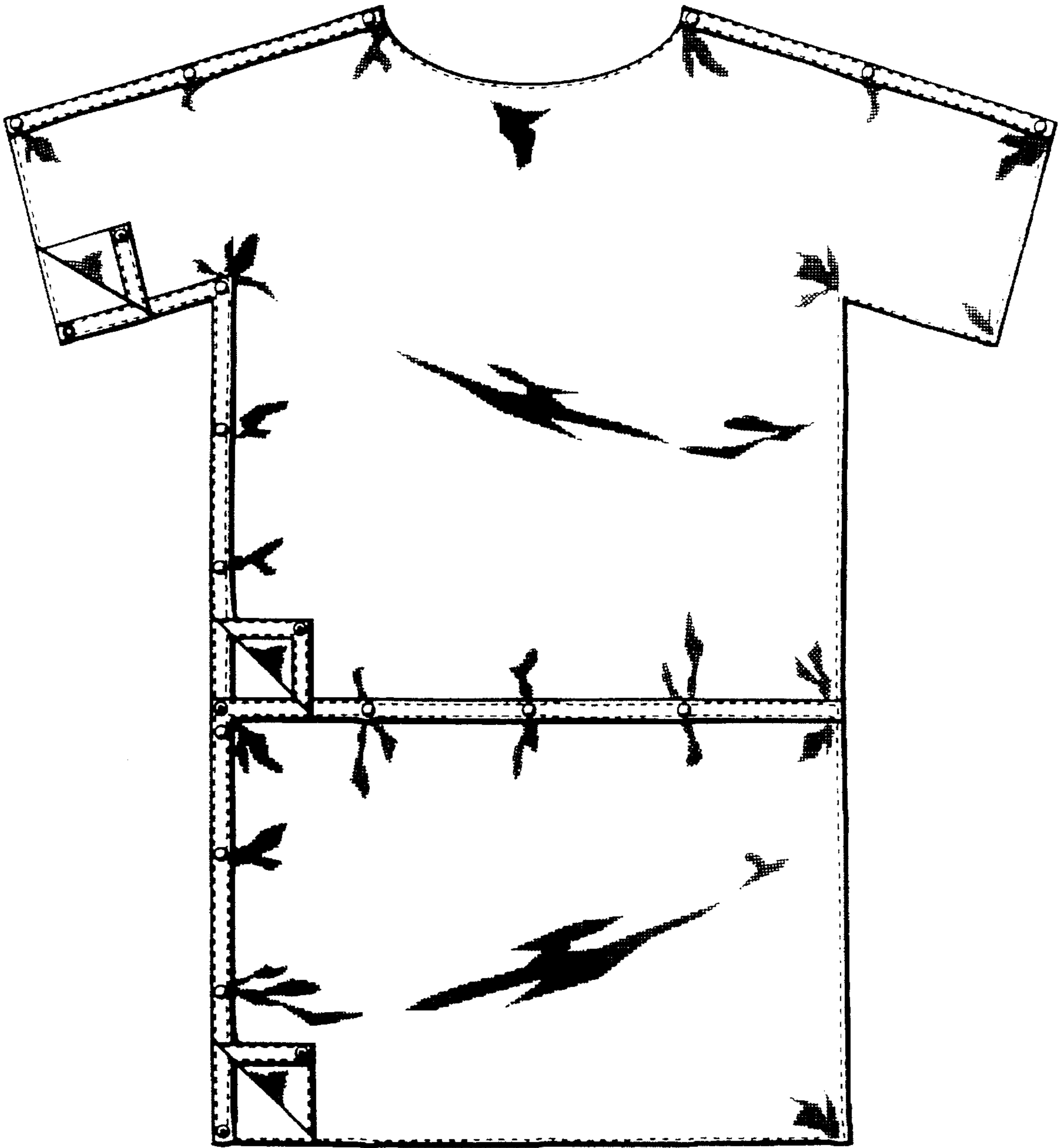

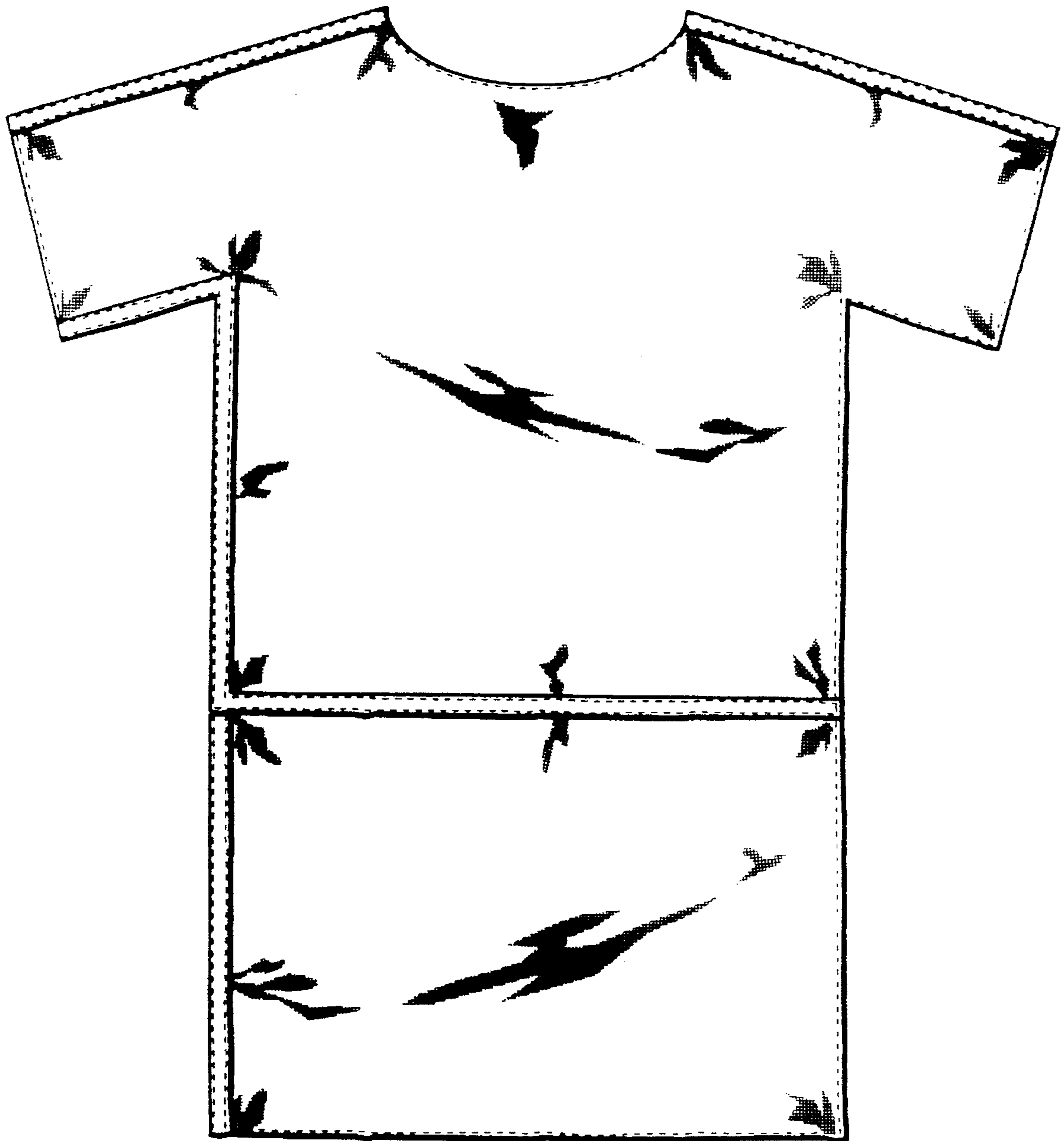

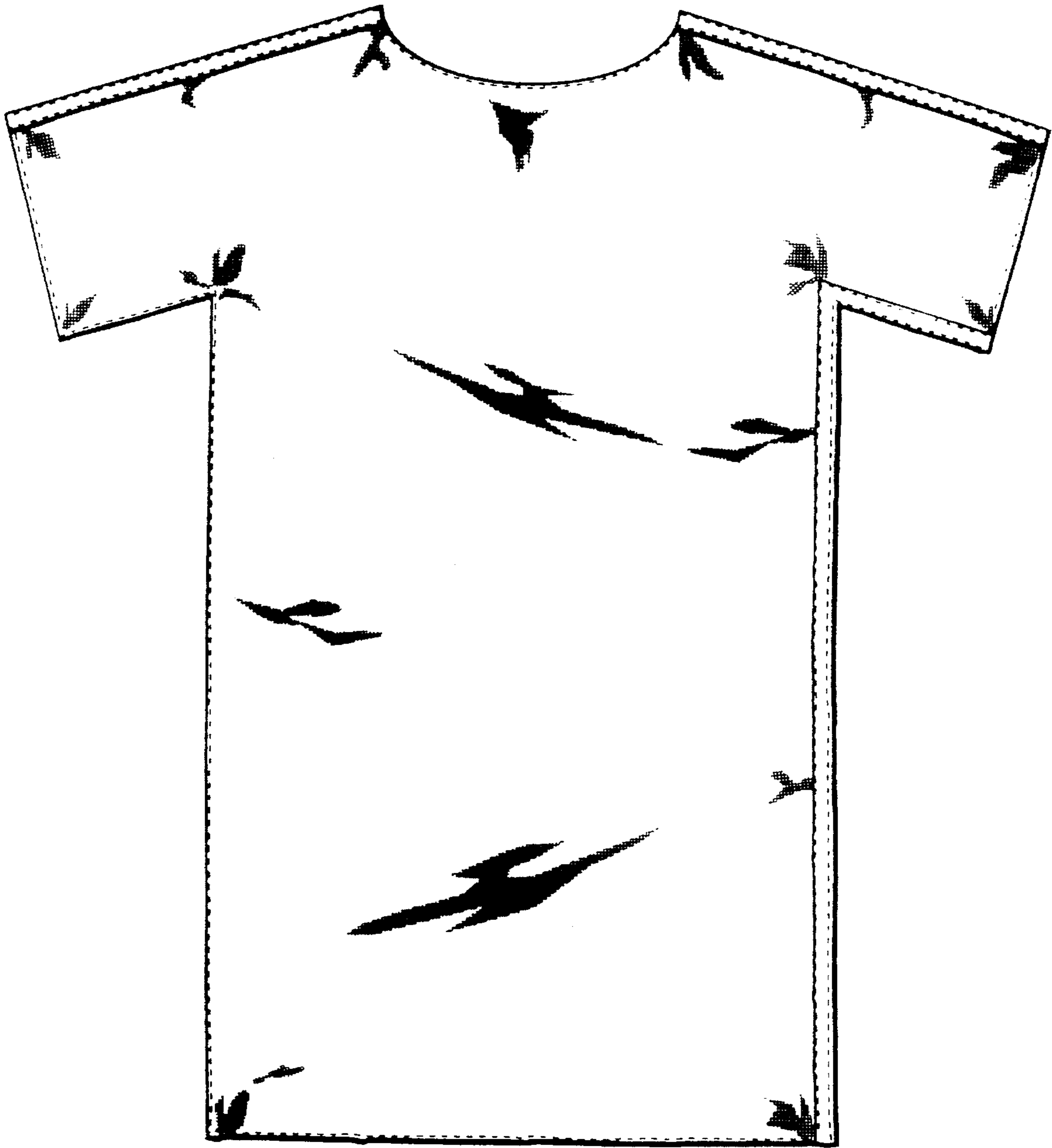

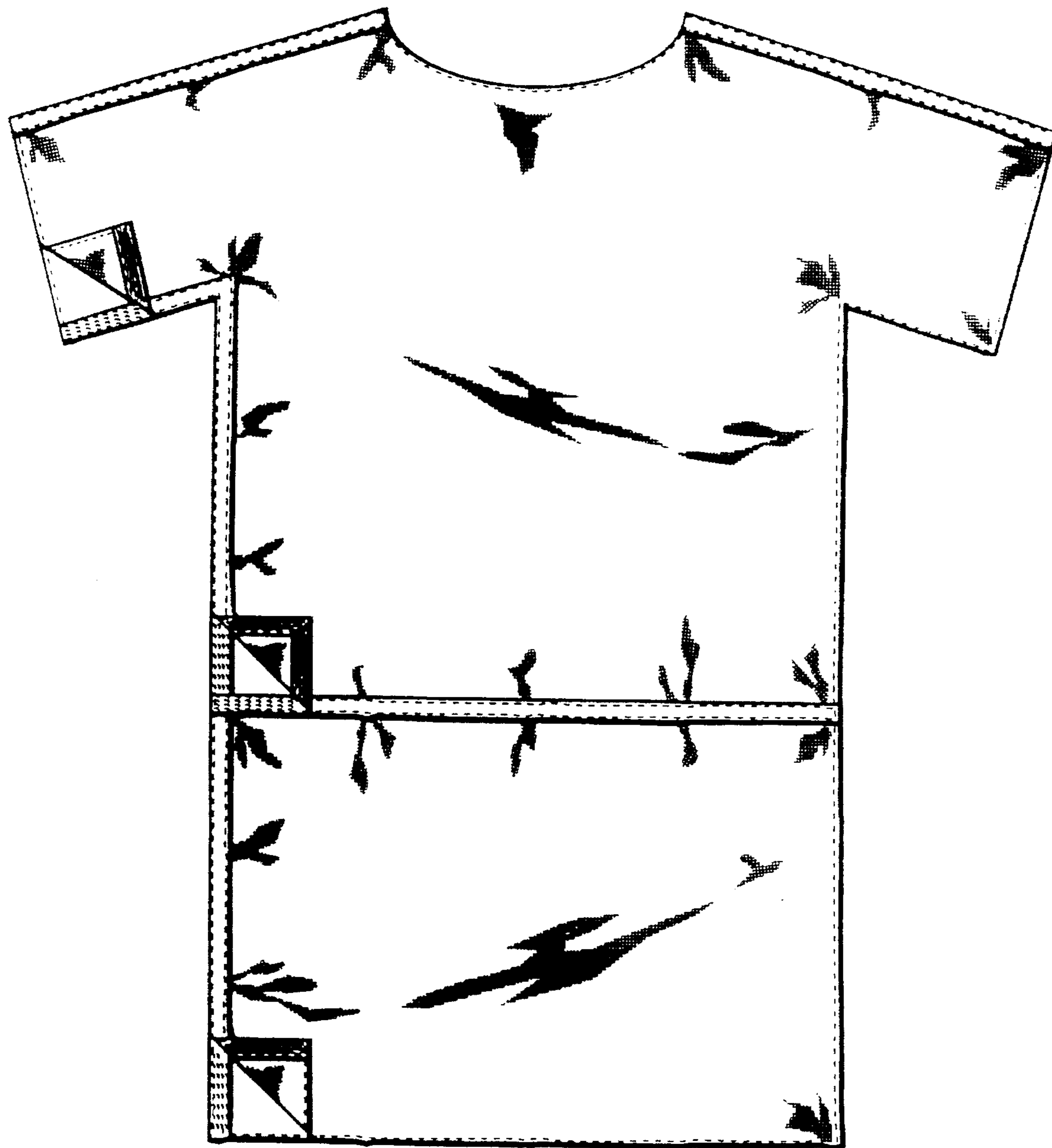

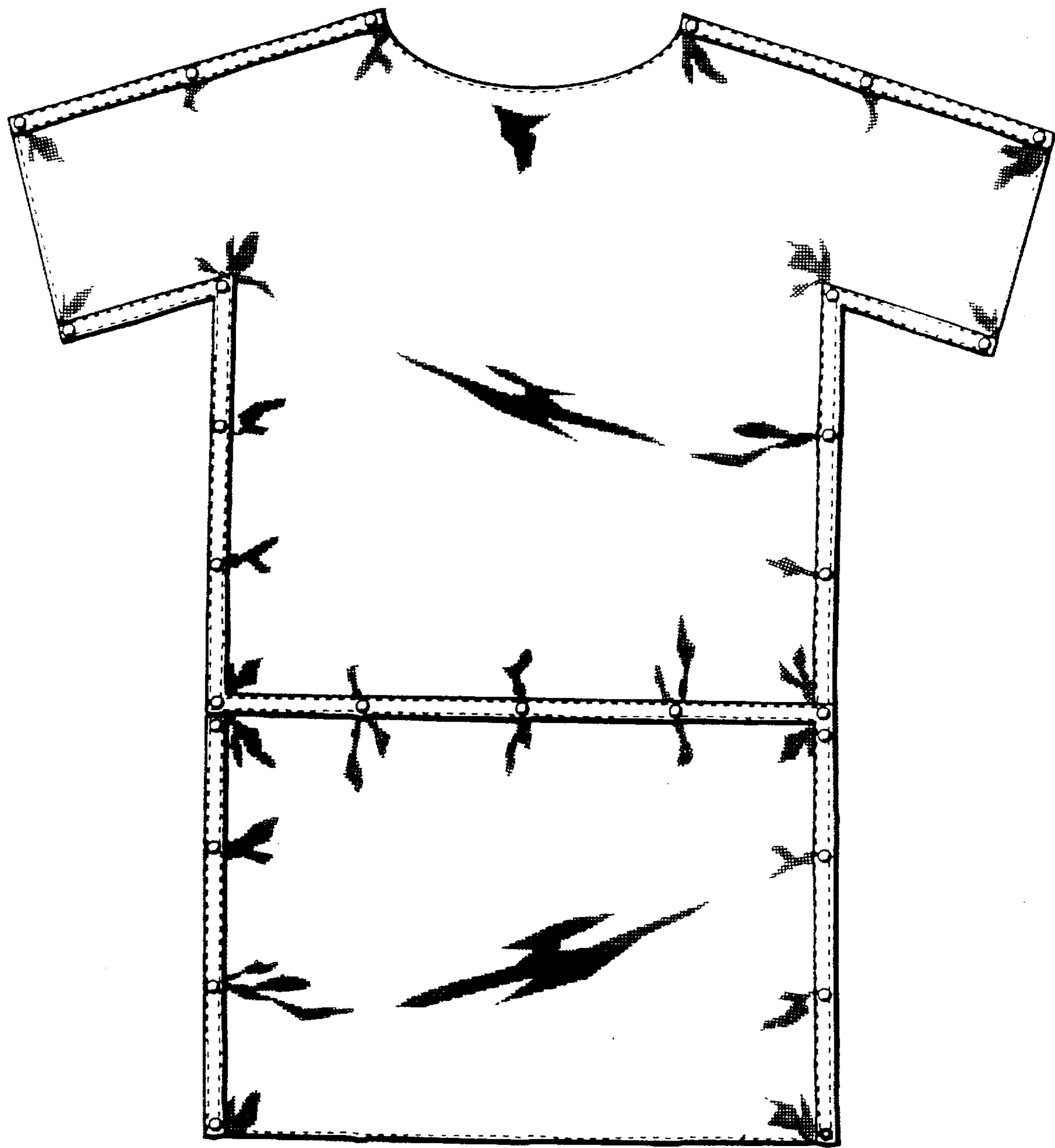

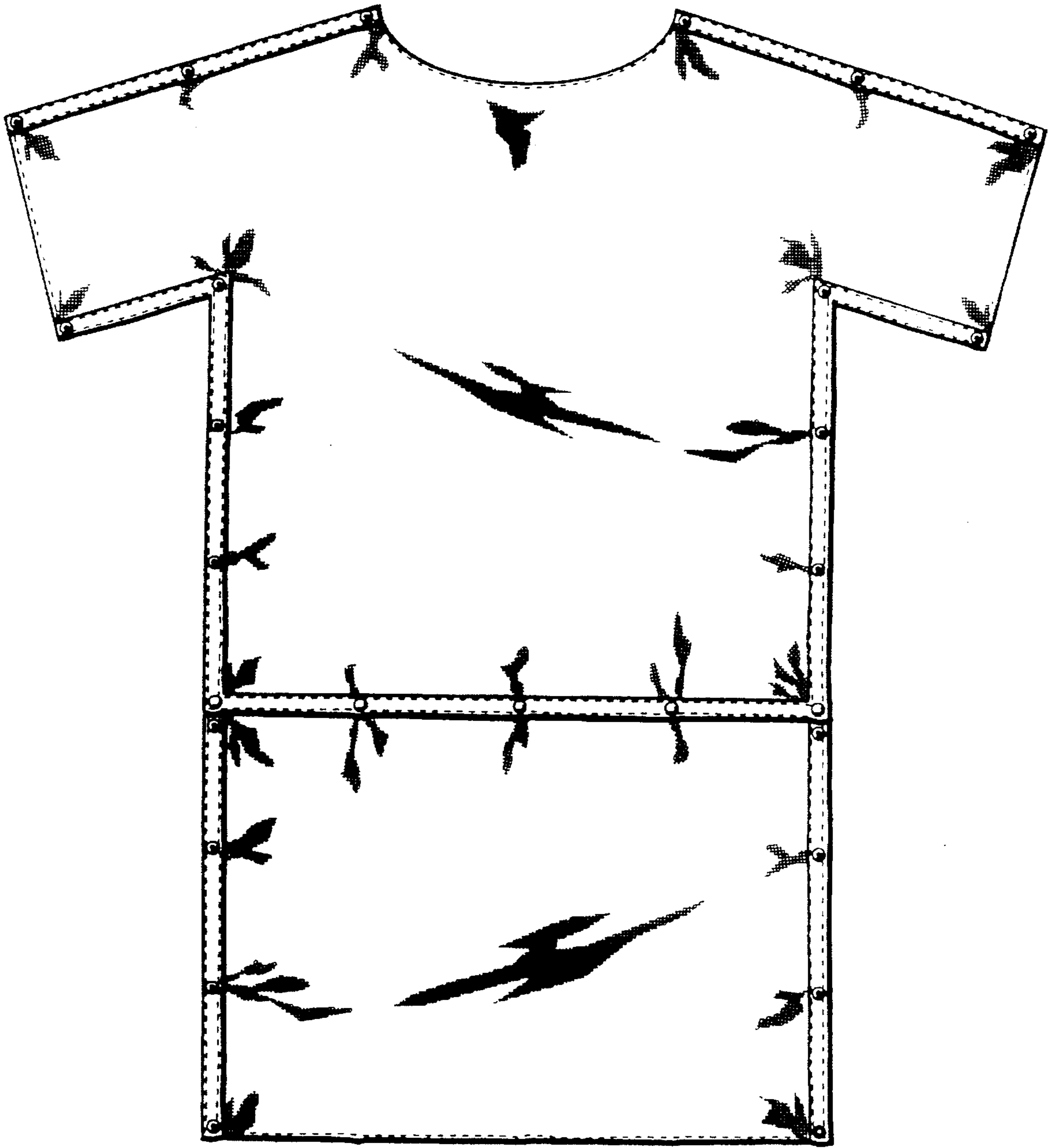

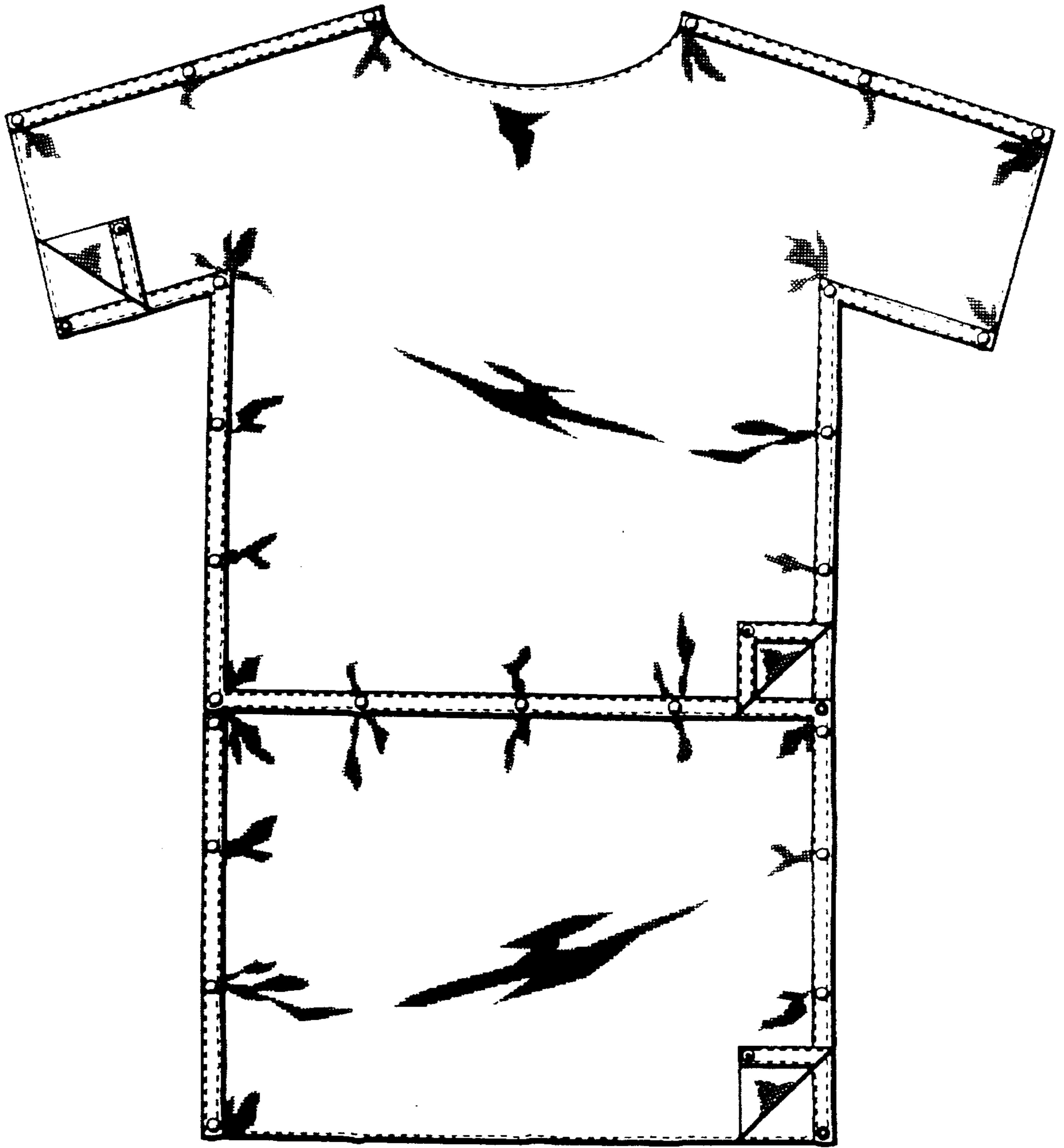

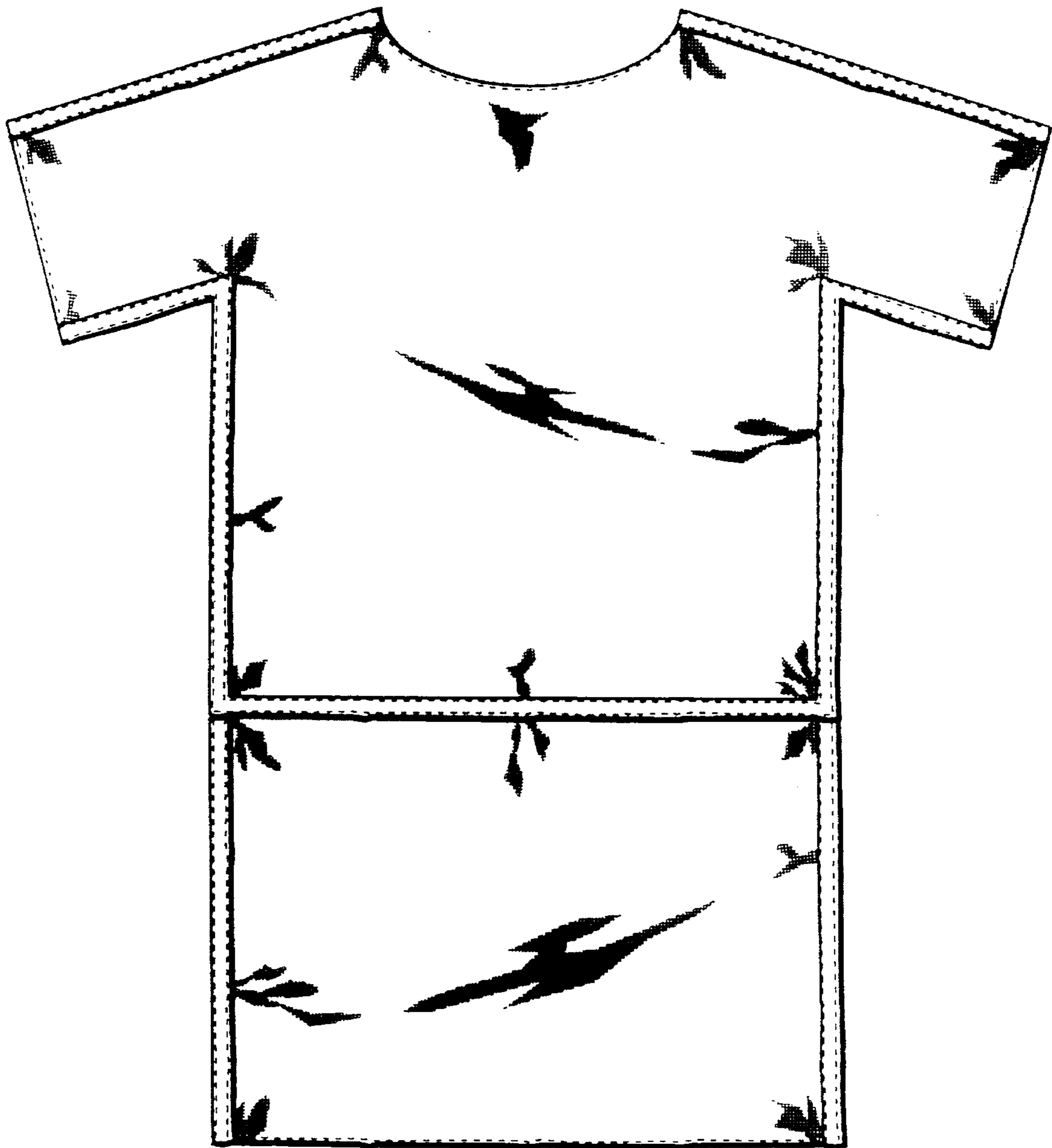

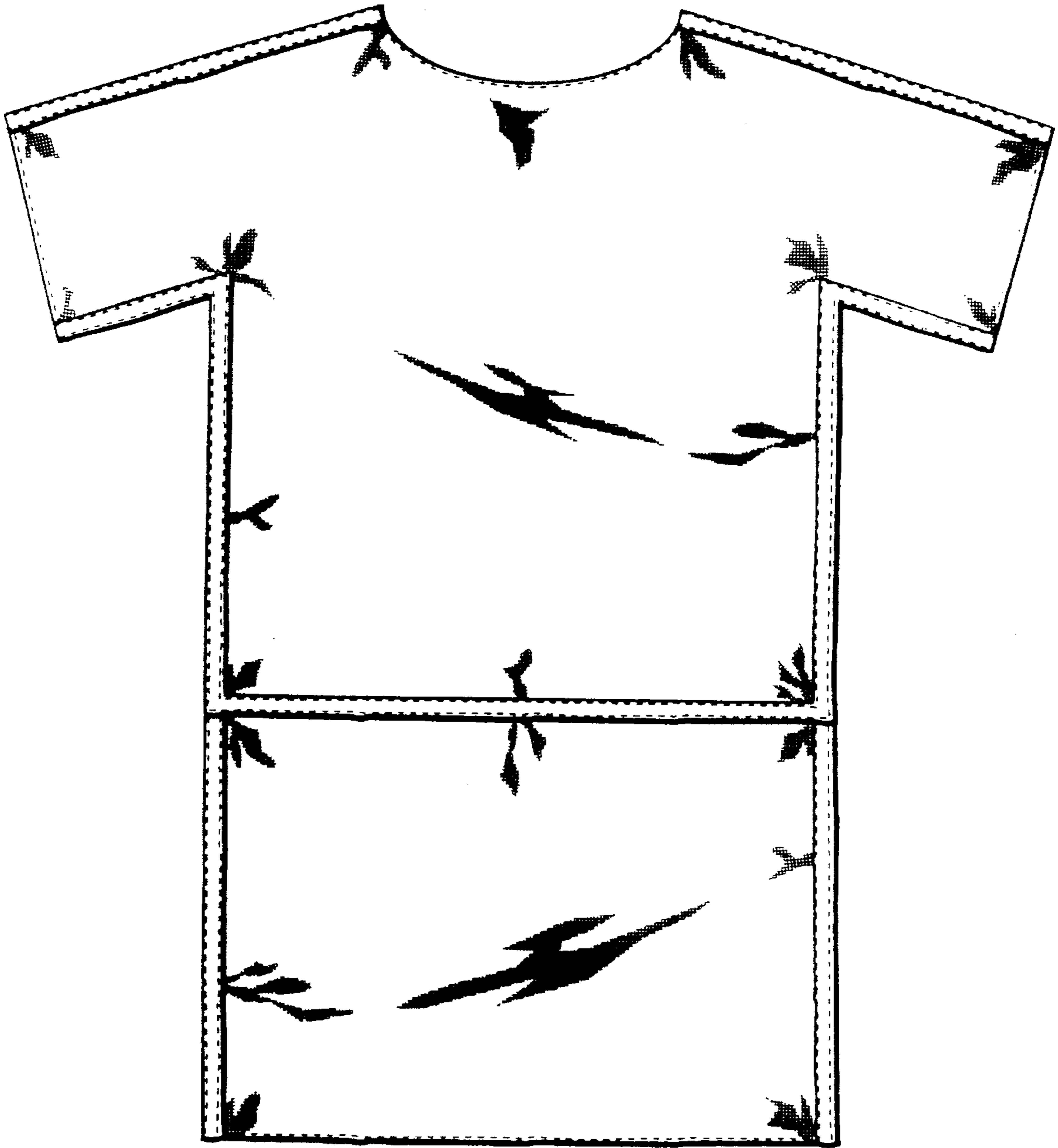

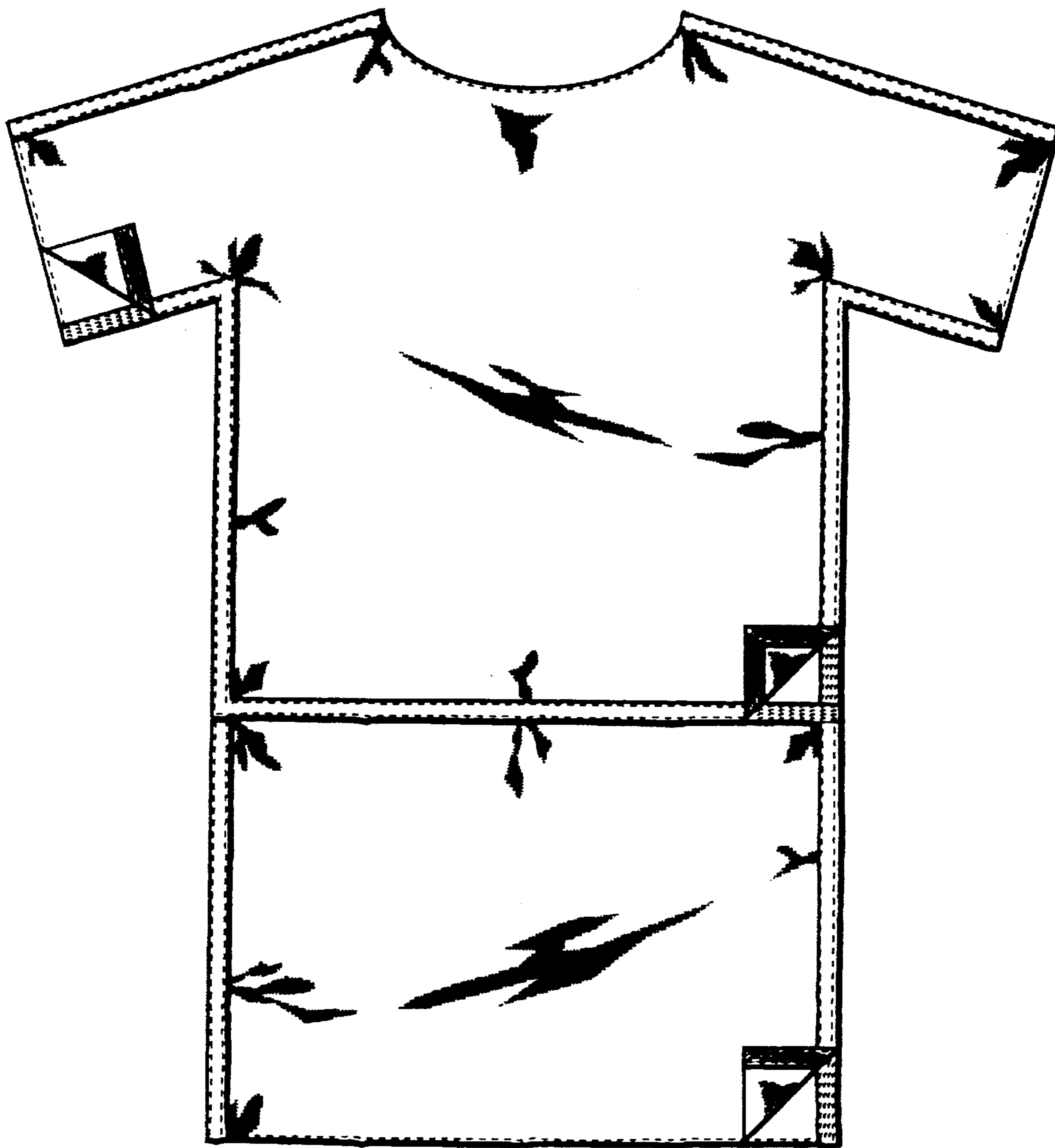
