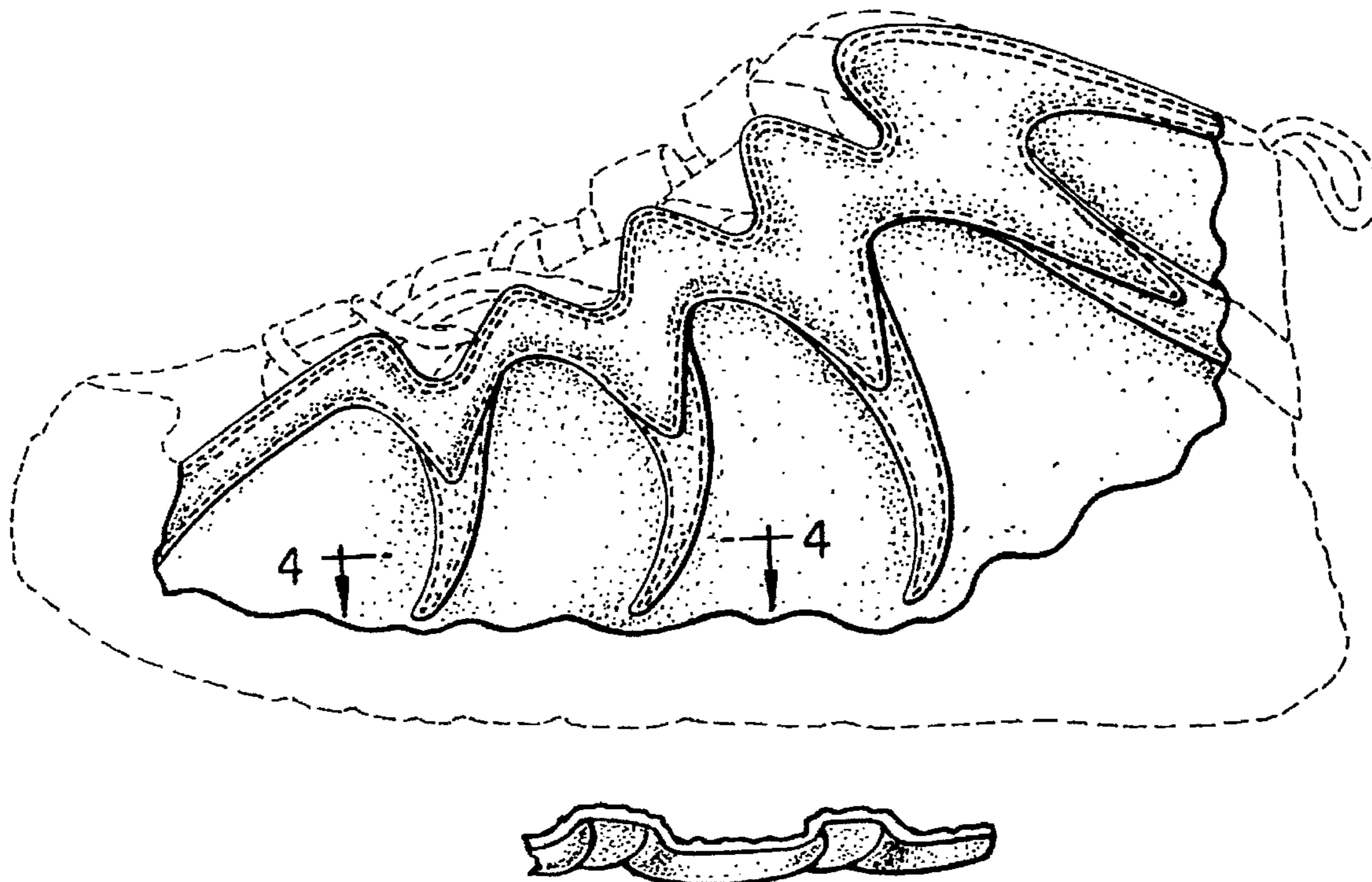
[57] **CLAIM**

The ornamental design for a side element of a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a shoe showing my new design;
FIG. 2 is a front elevational view of a shoe as shown in FIG. 1;
FIG. 3 is a top plan view thereof; and,
FIG. 4 is a cross section taken through line 4—4 of FIG. 1. The broken line showing the shoe in FIGS. 1—3 is for illustrative purposes and forms no part of the claimed design.

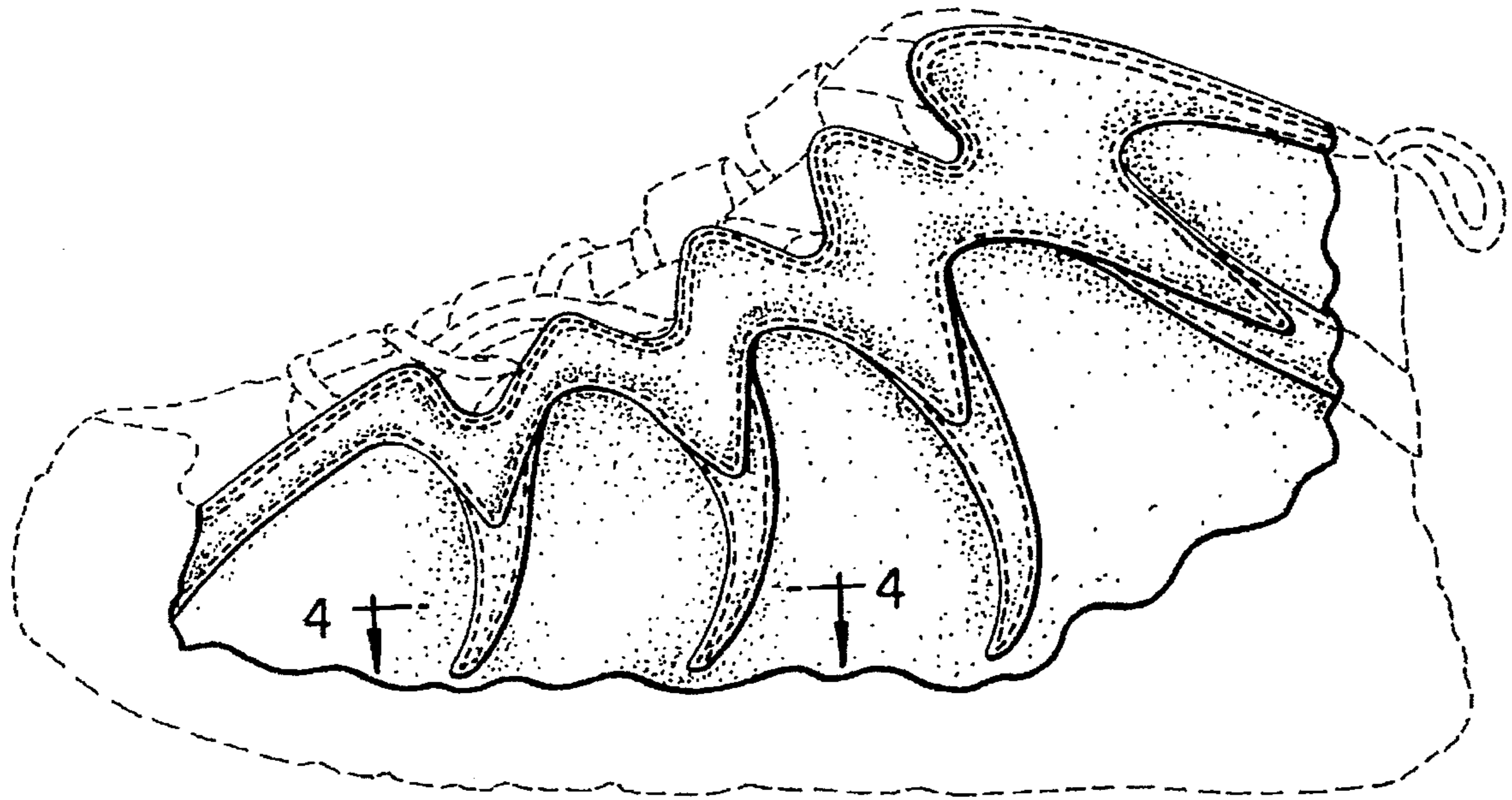

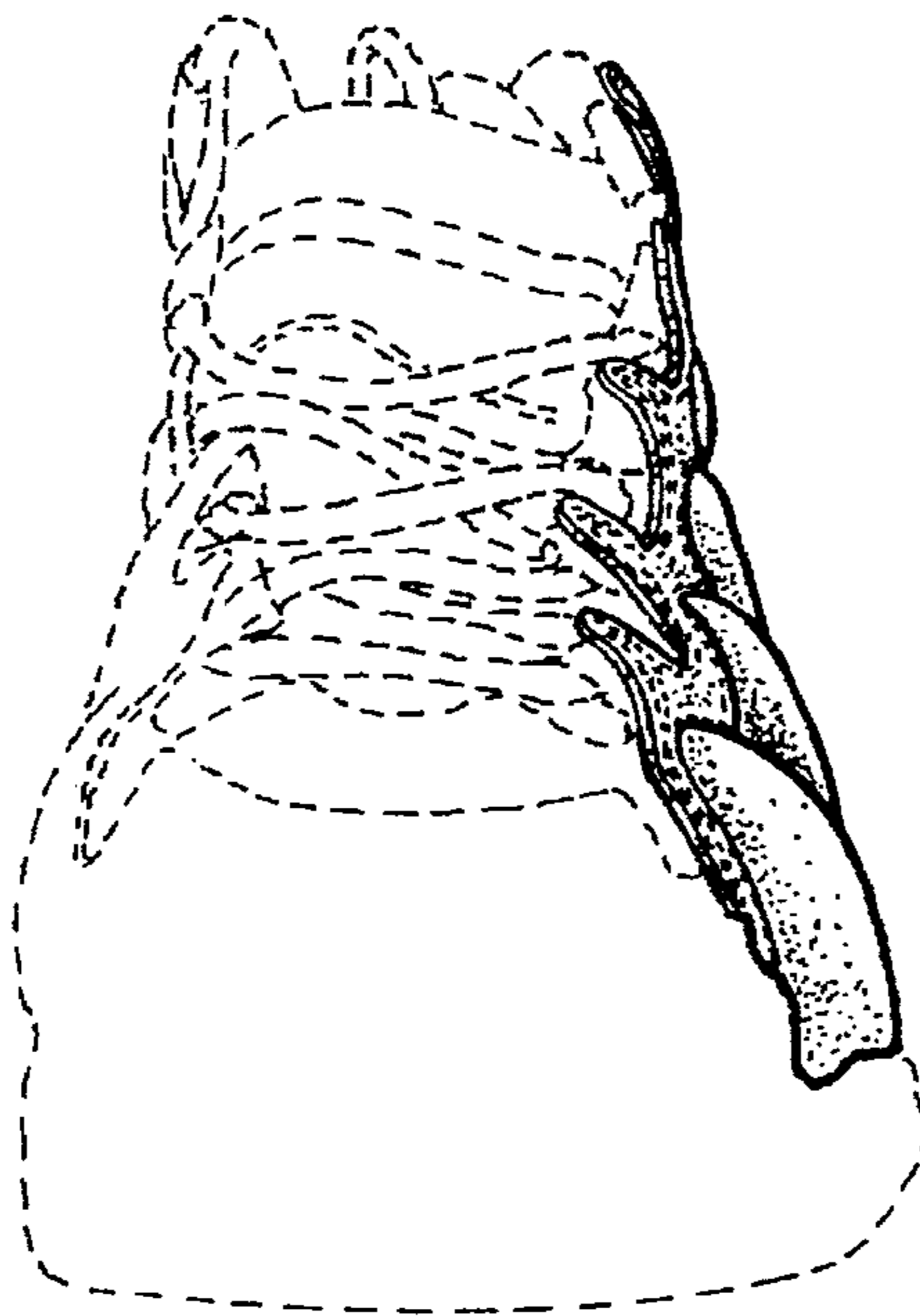

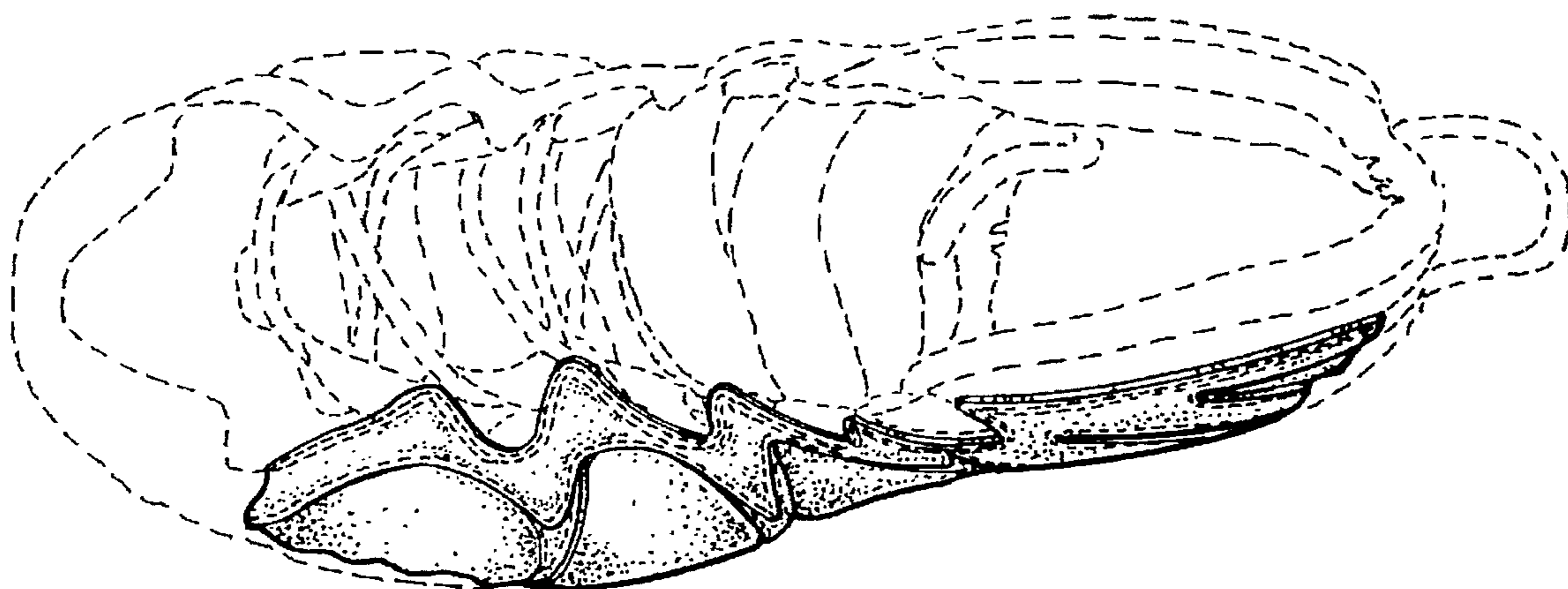
