The ornamental design for a mobile radio, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a mobile radio showing our new design;

FIG. 2 is a right elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is an isomeric view showing the front, right side, and top thereof; and

FIG. 8 is a front elevational view of an alternate embodiment of FIG. 1;

FIG. 9 is a right side elevational view of FIG. 8;

FIG. 10 is a rear elevational view of FIG. 8;

FIG. 11 is a left side elevational view of FIG. 8;

FIG. 12 is a top plan view of FIG. 8;

FIG. 13 is a bottom plan view of FIG. 8; and,

FIG. 14 is an isometric view showing the front, right side and top of FIG. 8.

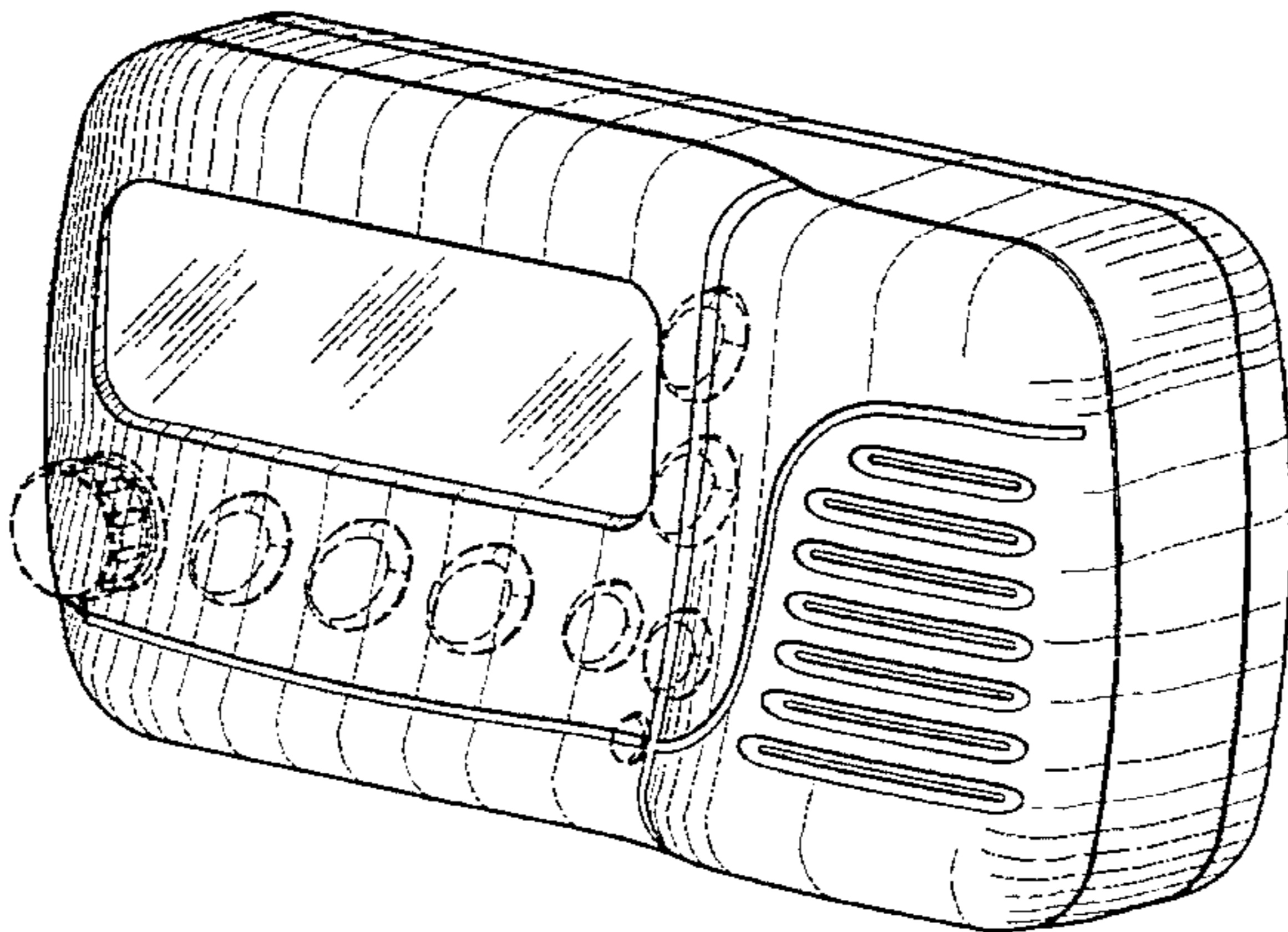
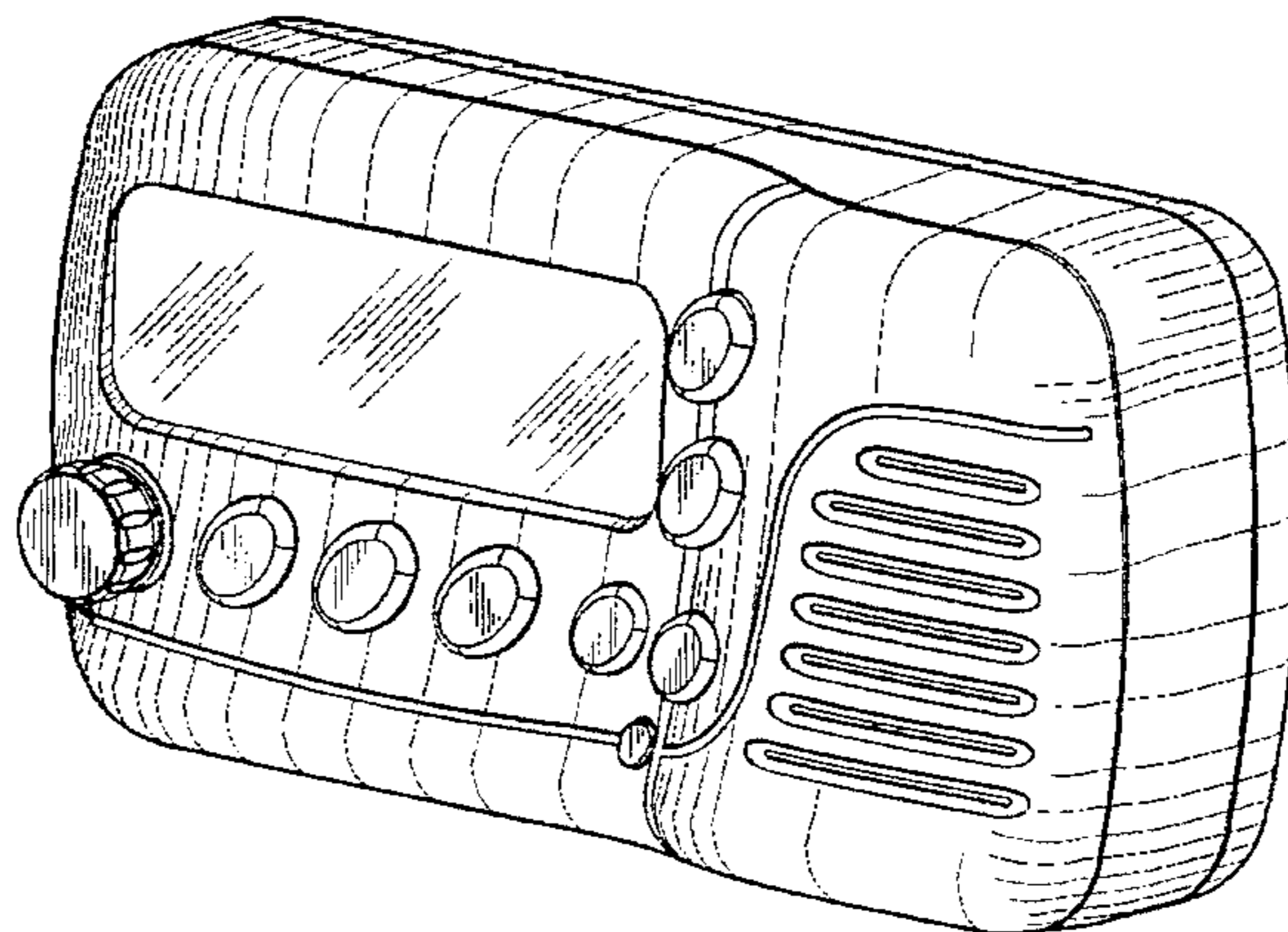

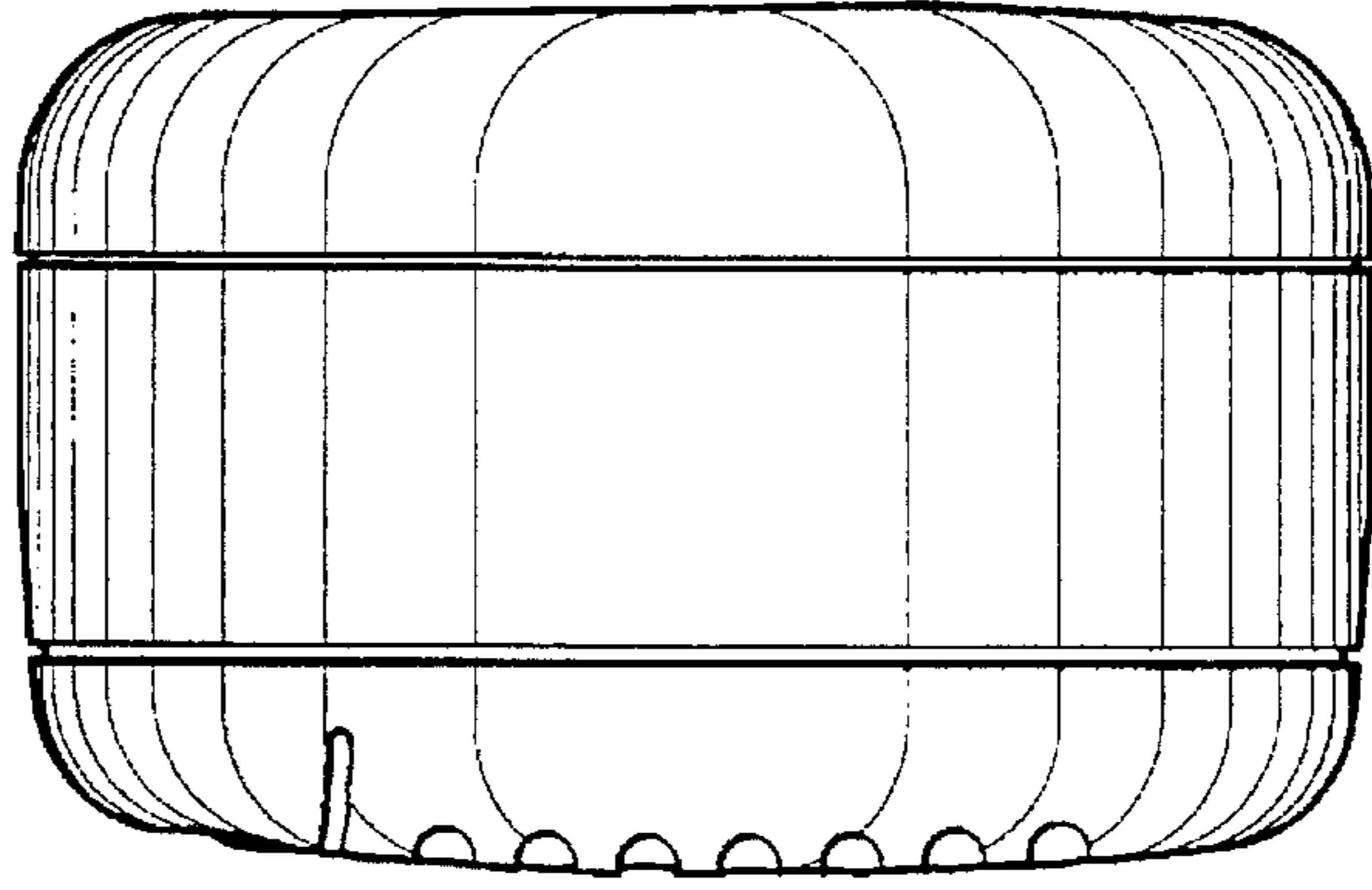

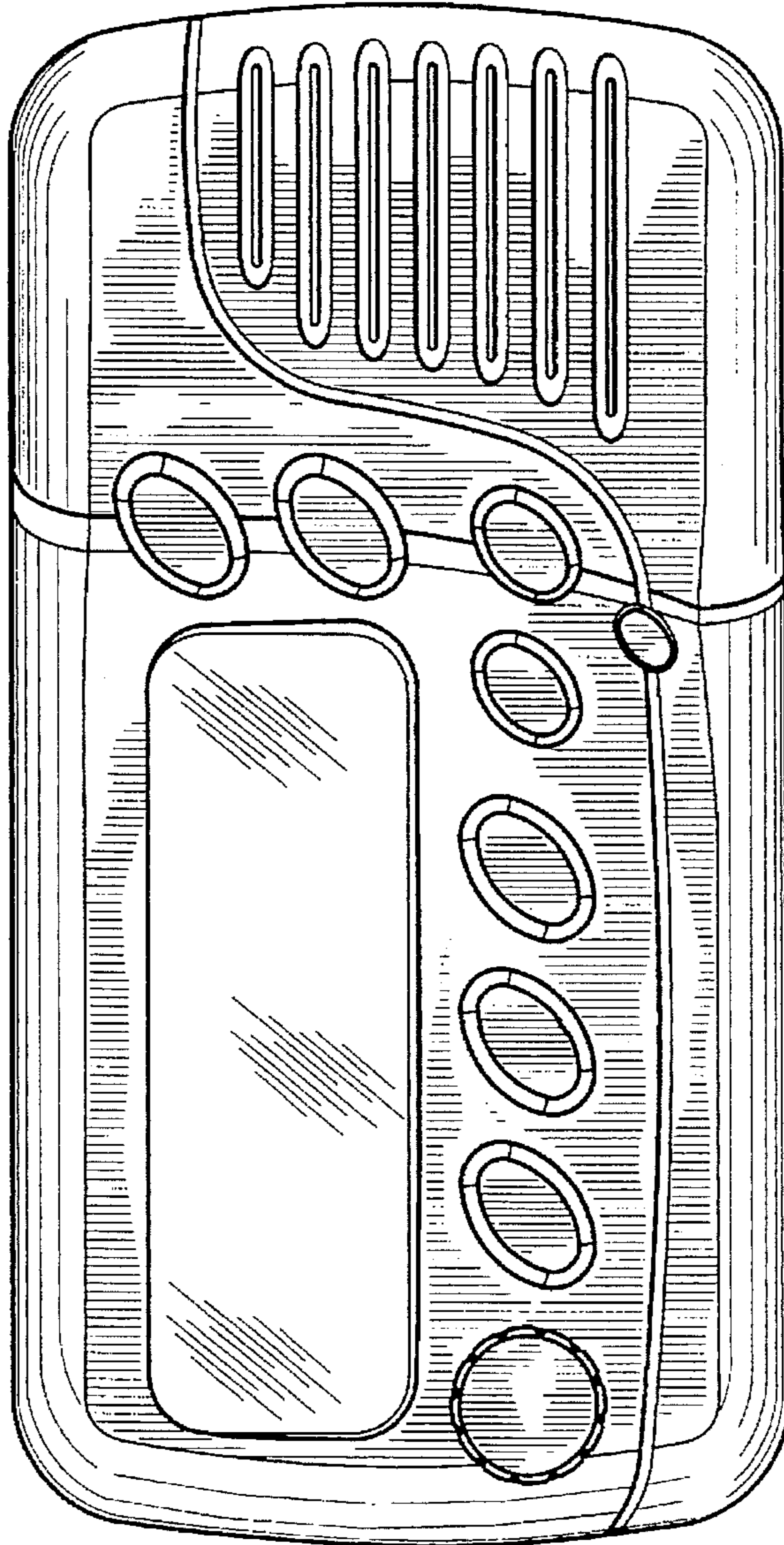

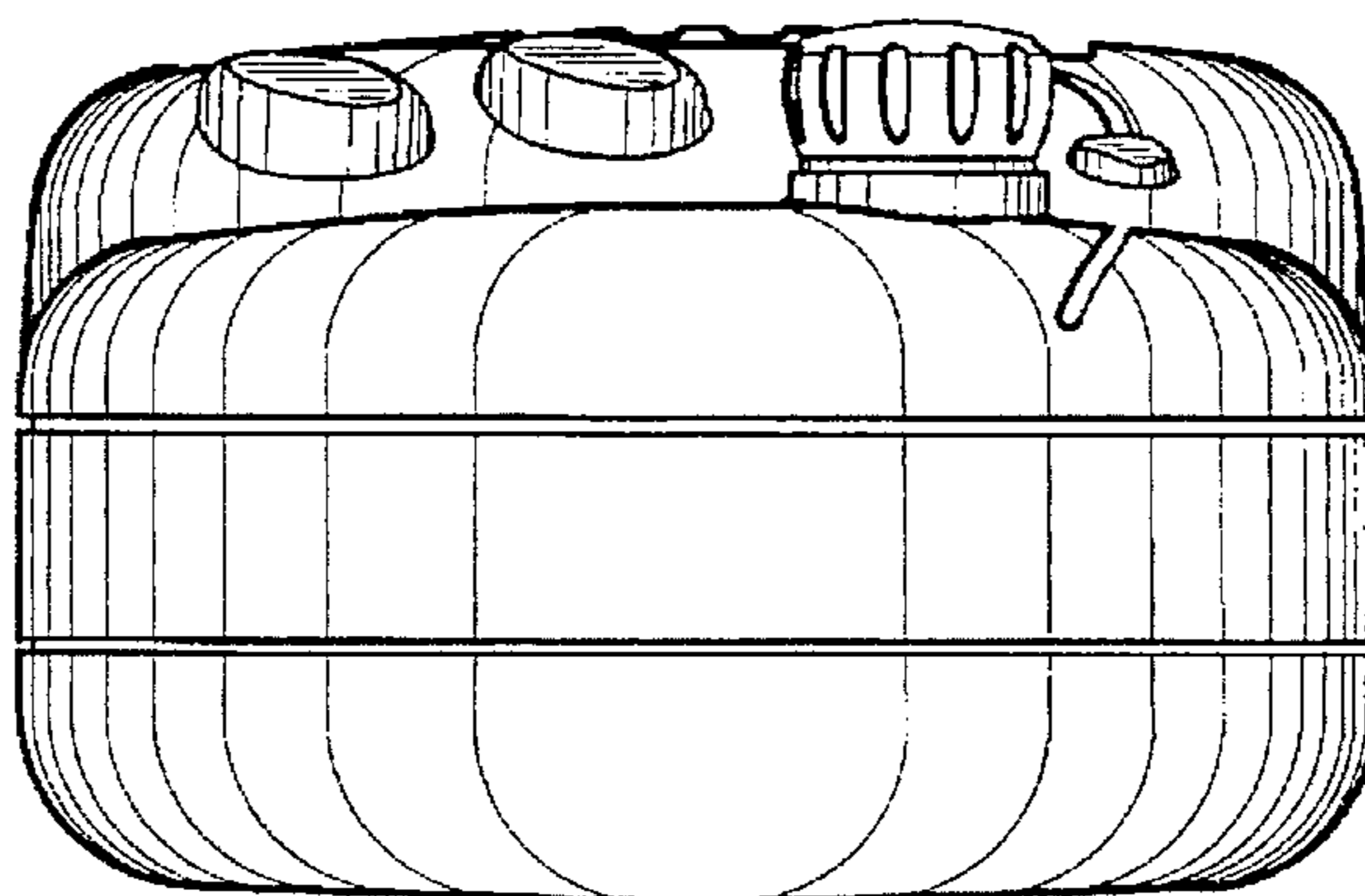

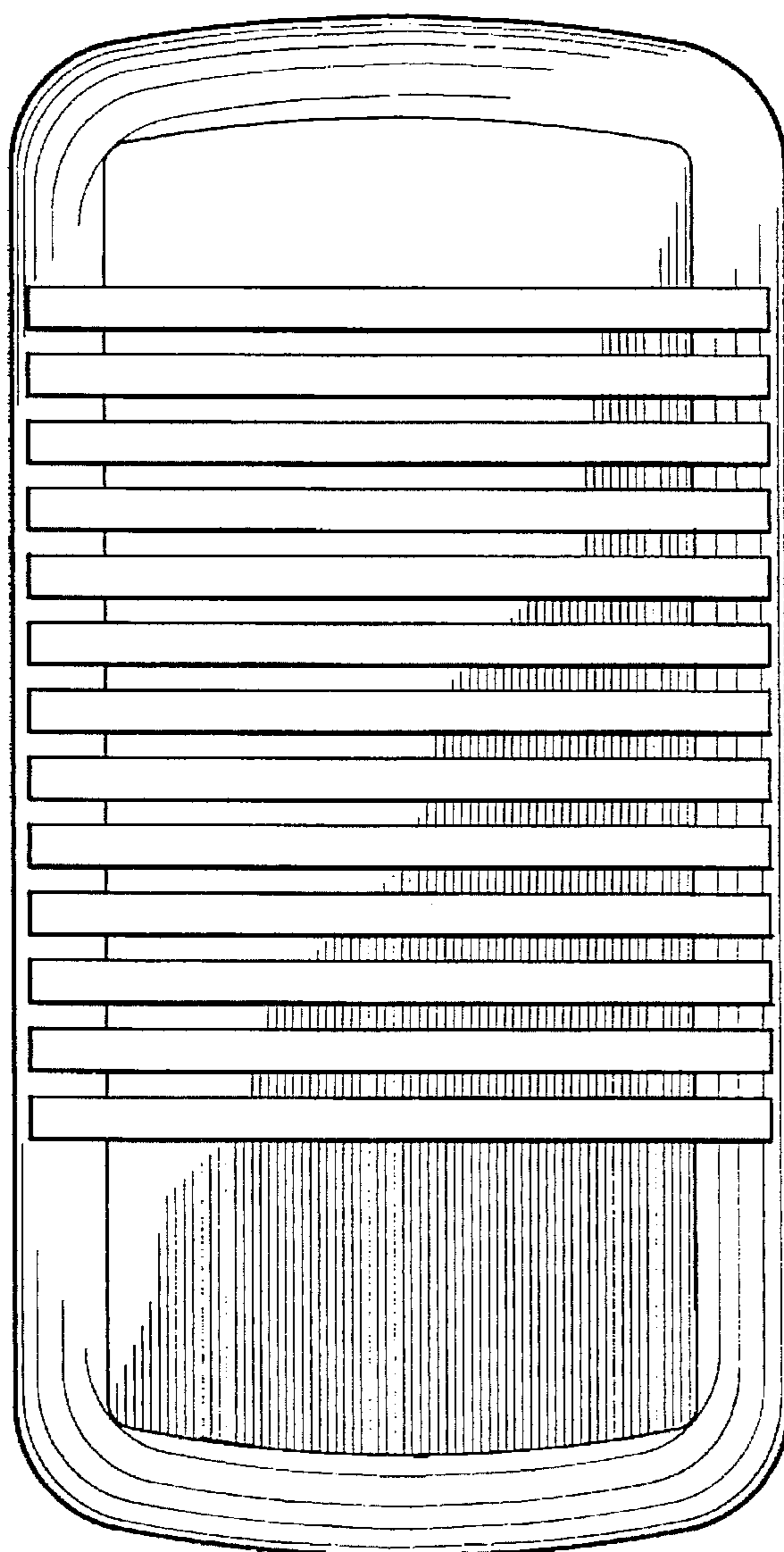

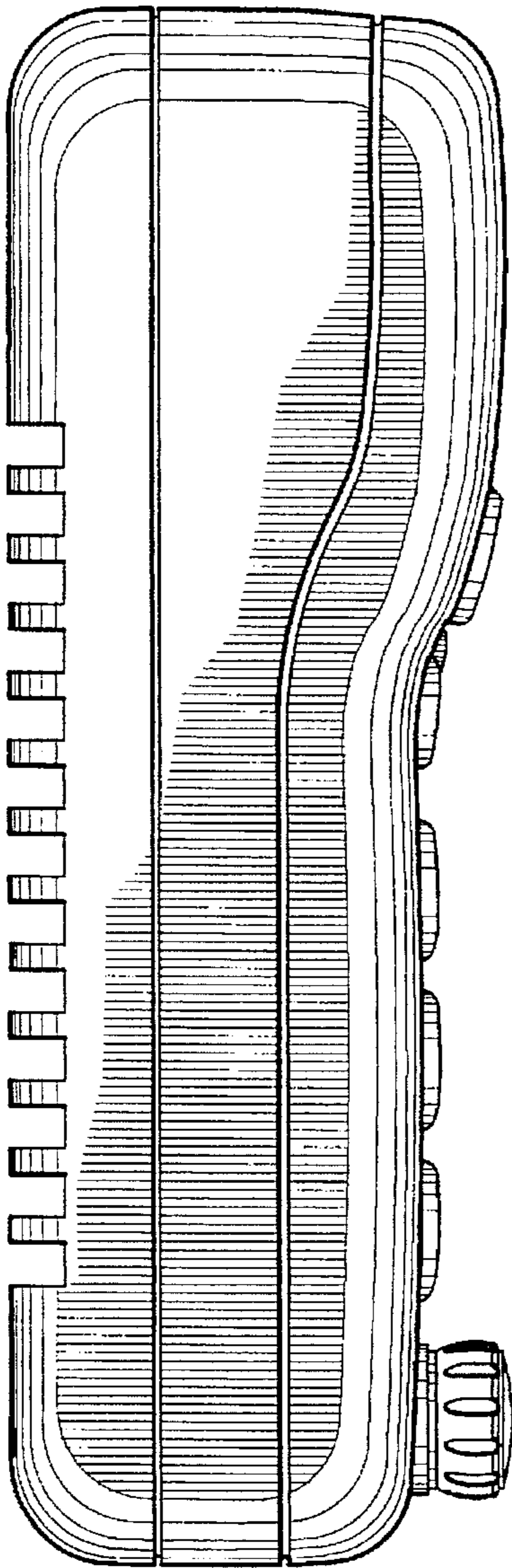

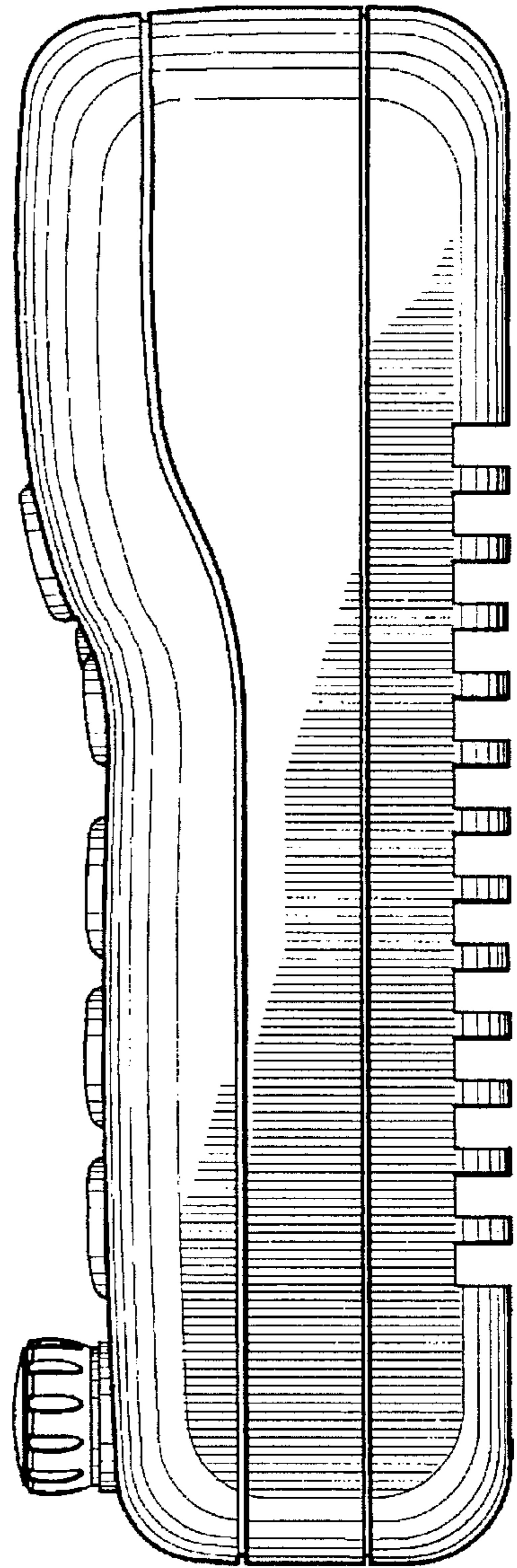

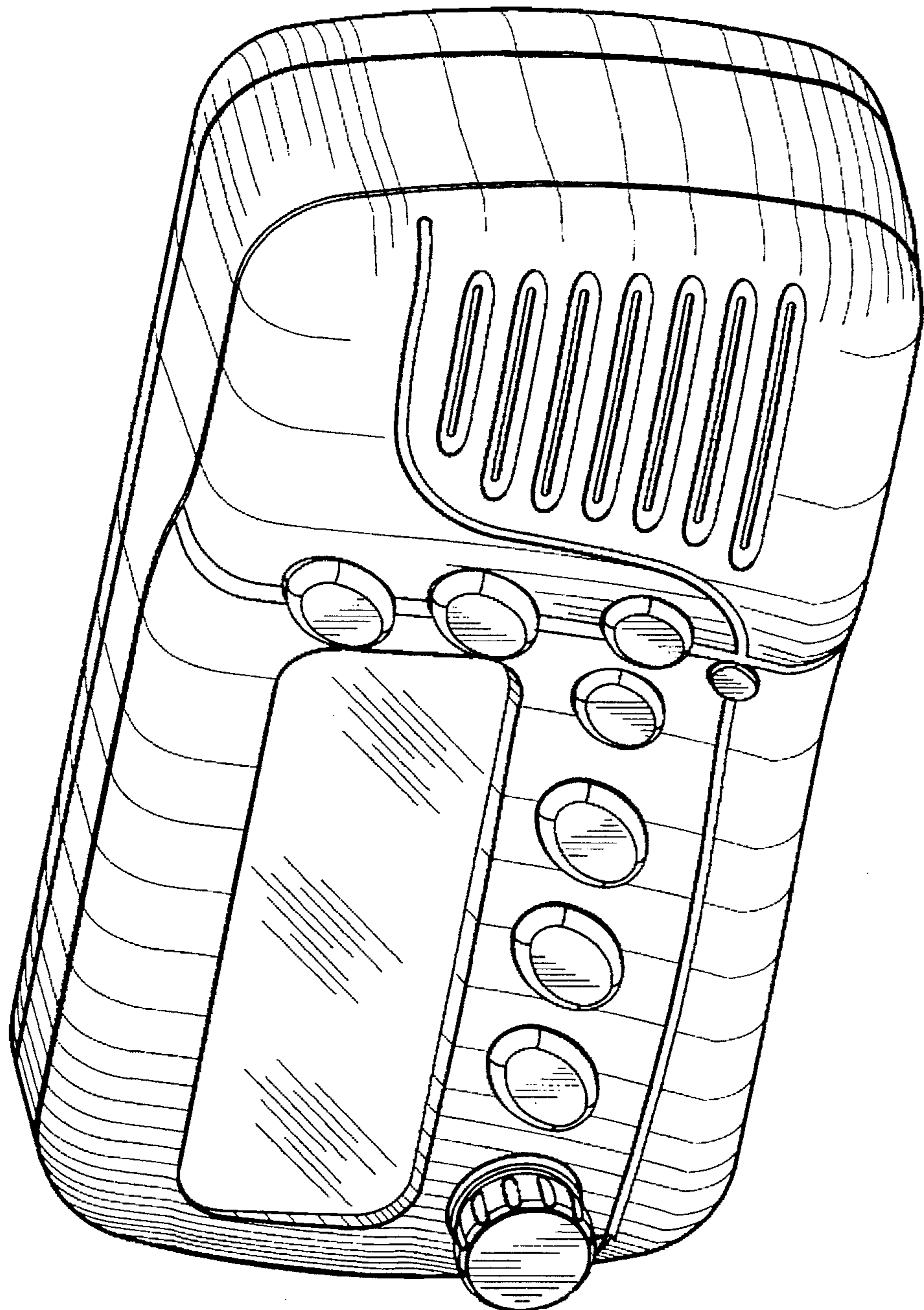

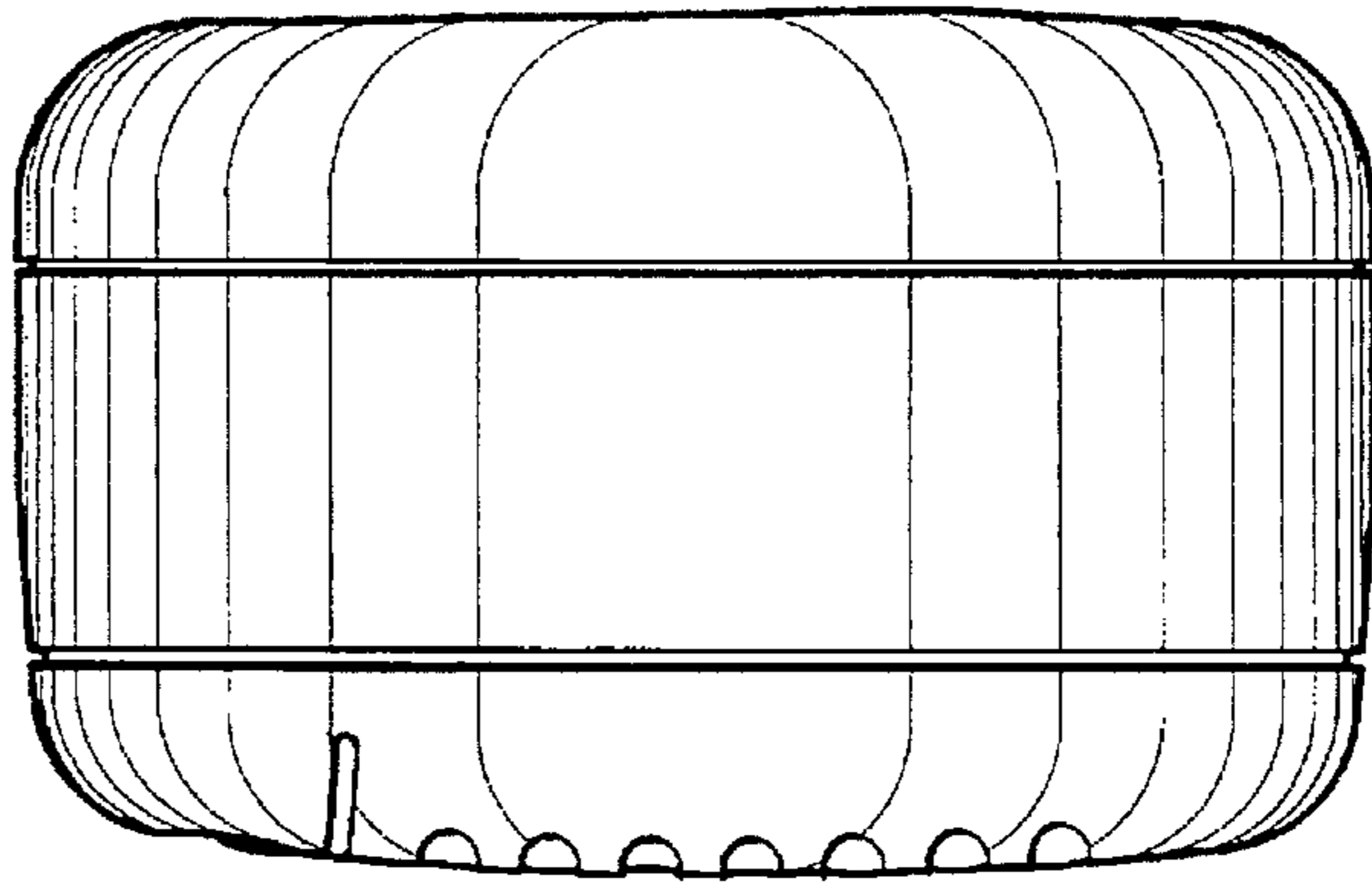

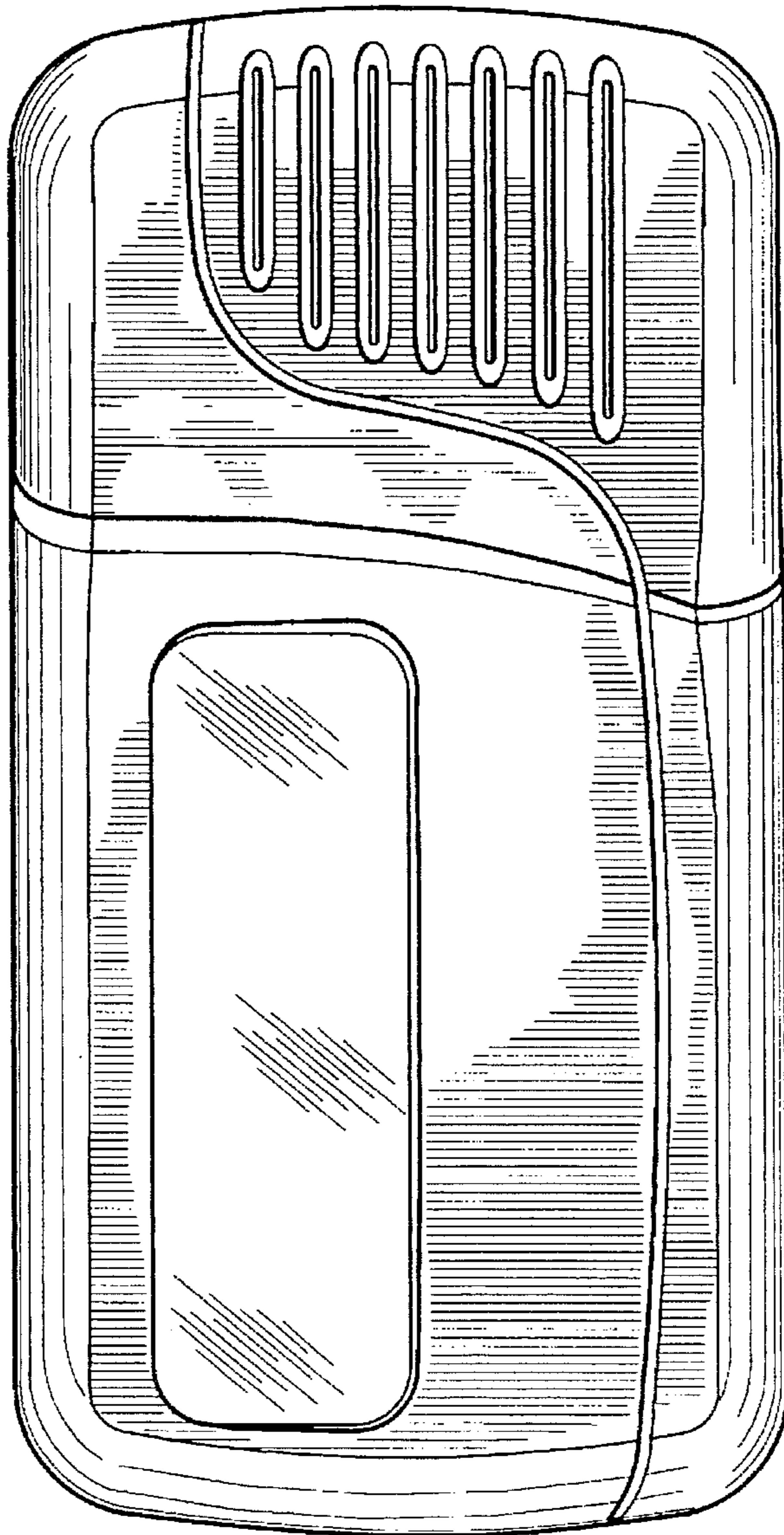

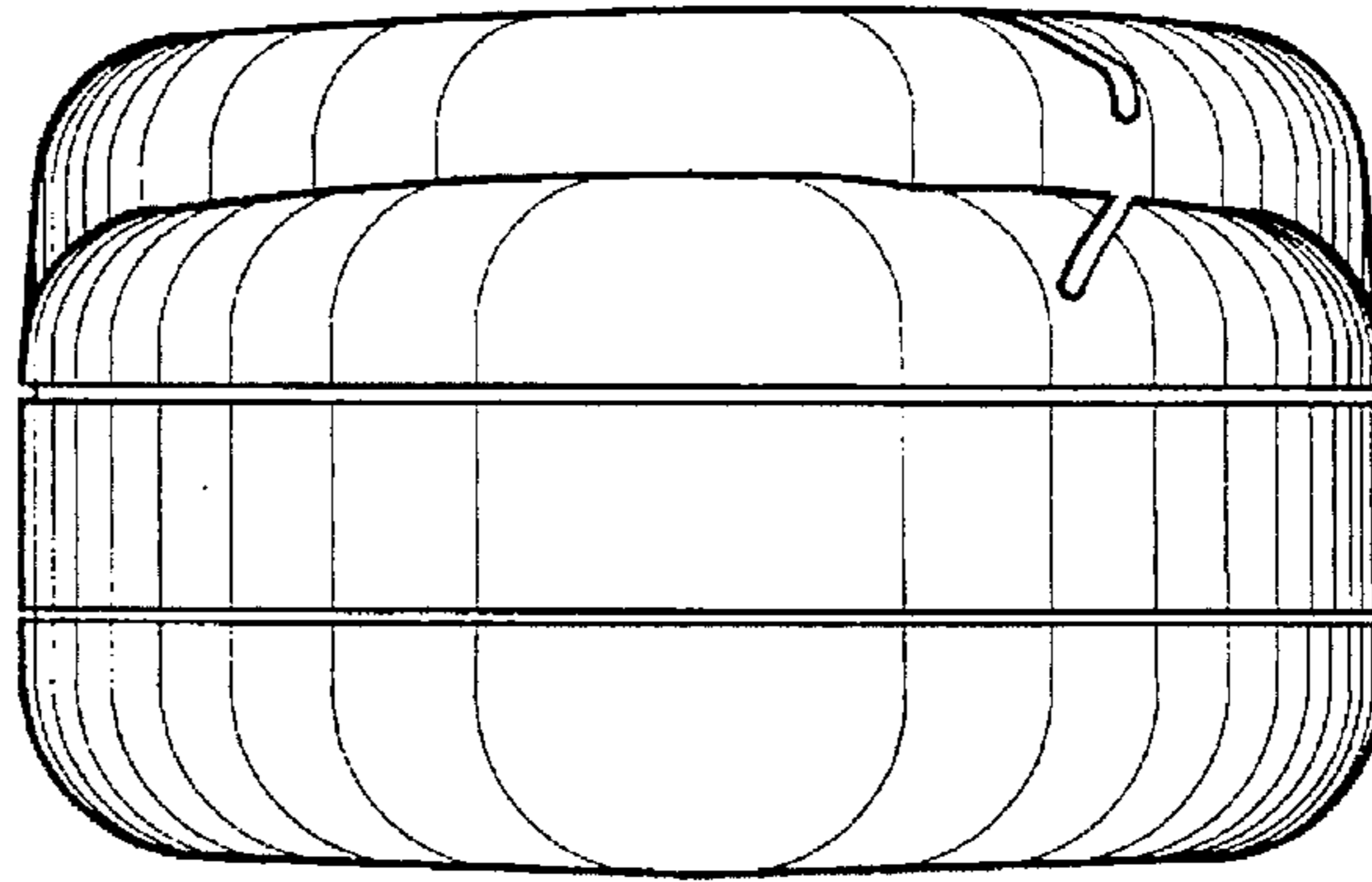

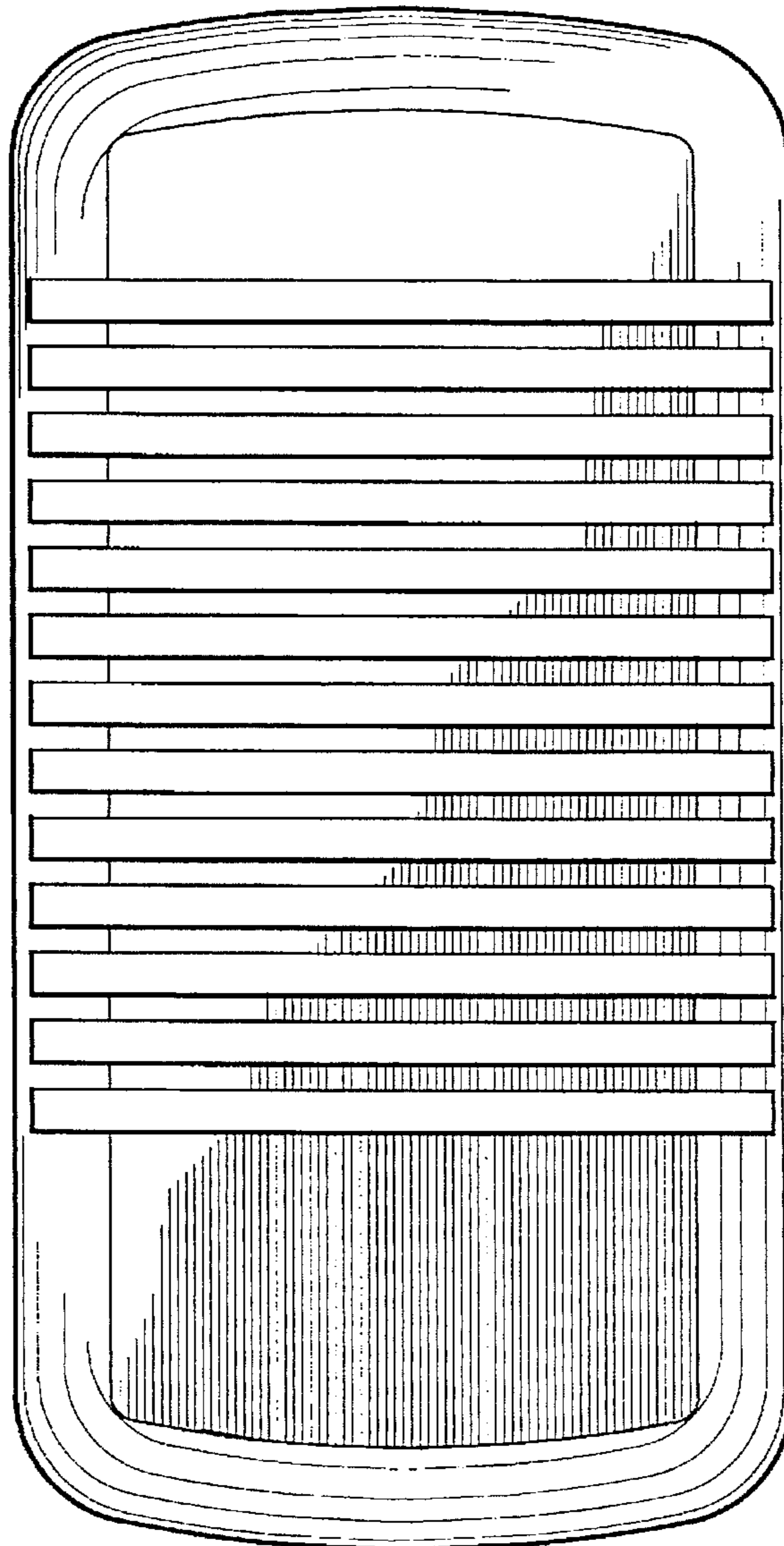

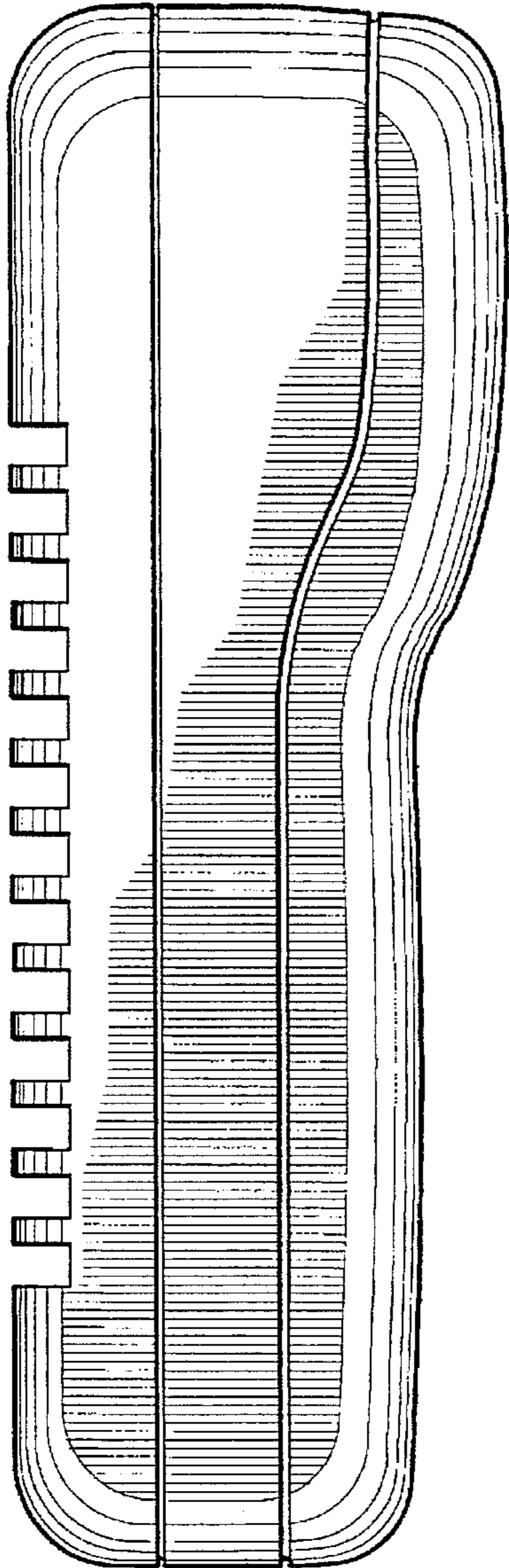

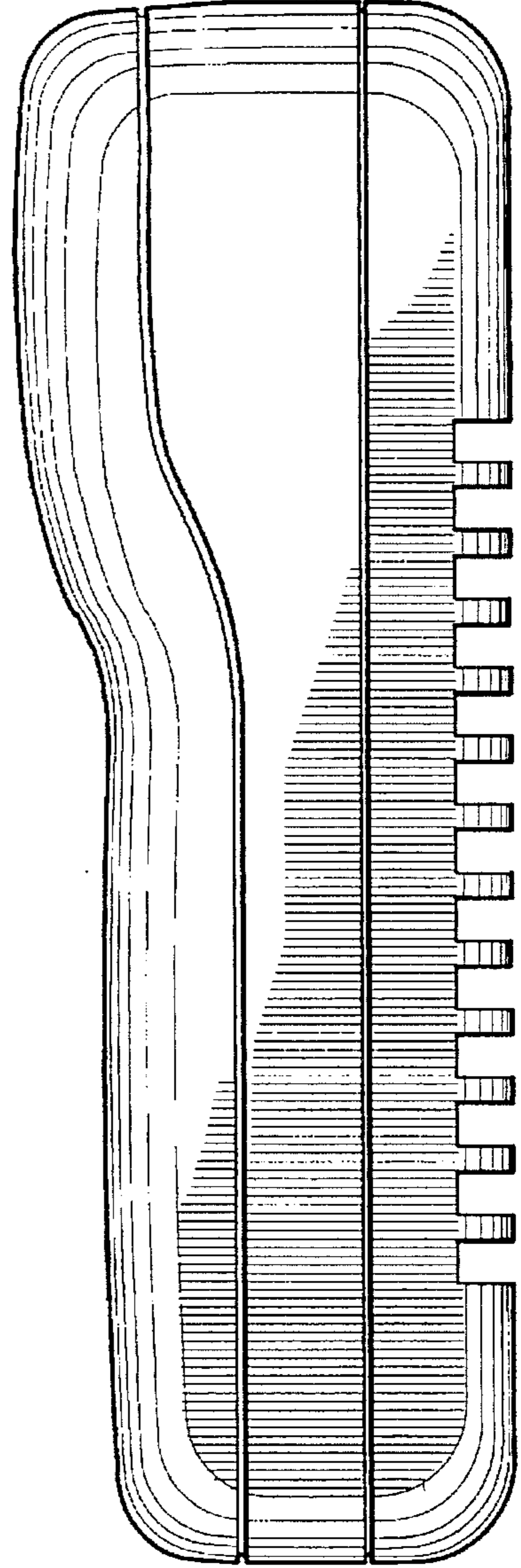
