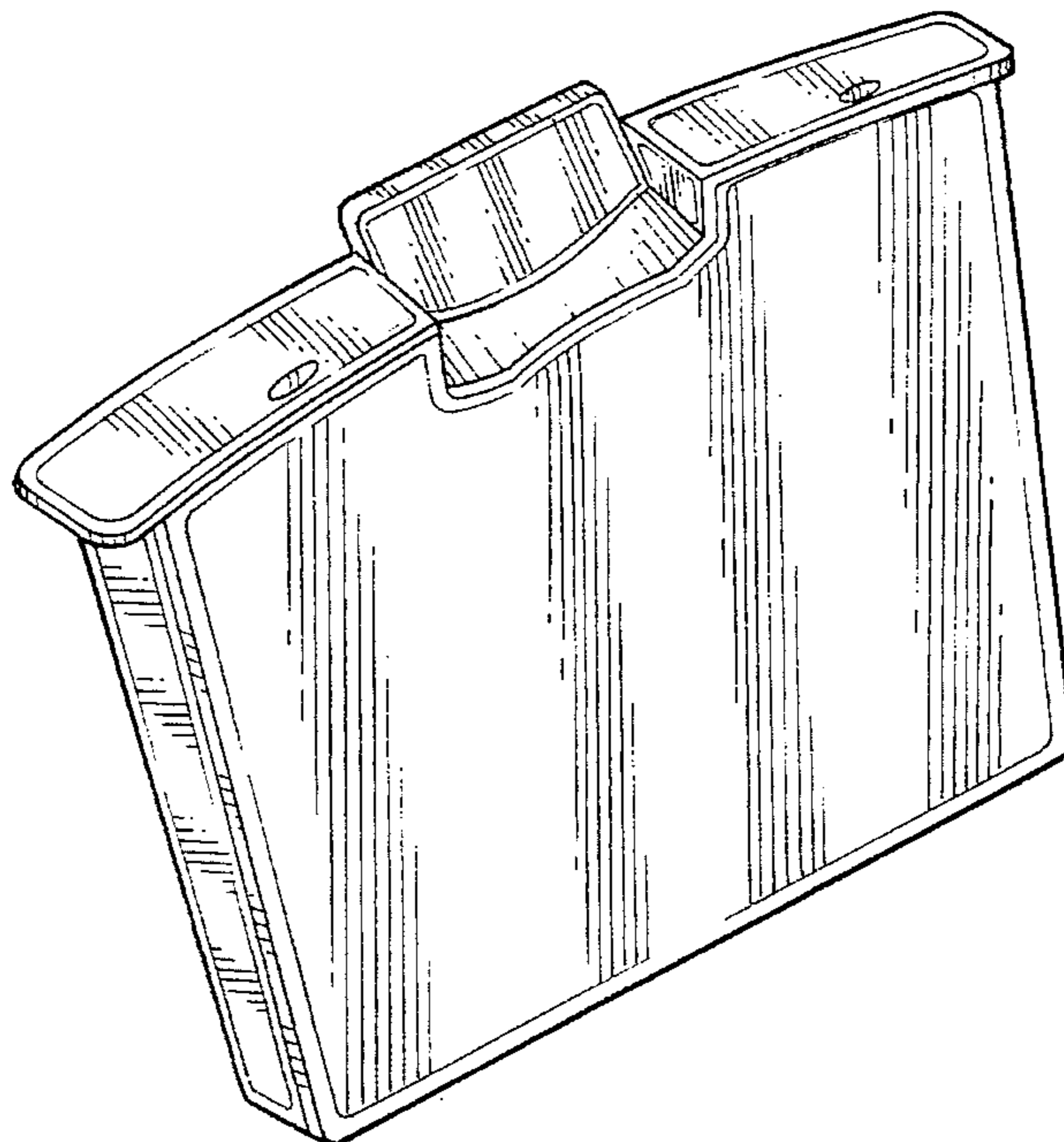
[57] **CLAIM**

The ornamental design for a hanging file, as shown and described.

**DESCRIPTION**

FIG. 1 is a left front perspective view of a hanging file showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a bottom plan view thereof; and, FIG. 6 is a left side elevational view thereof; the right side elevational view being a mirror image.

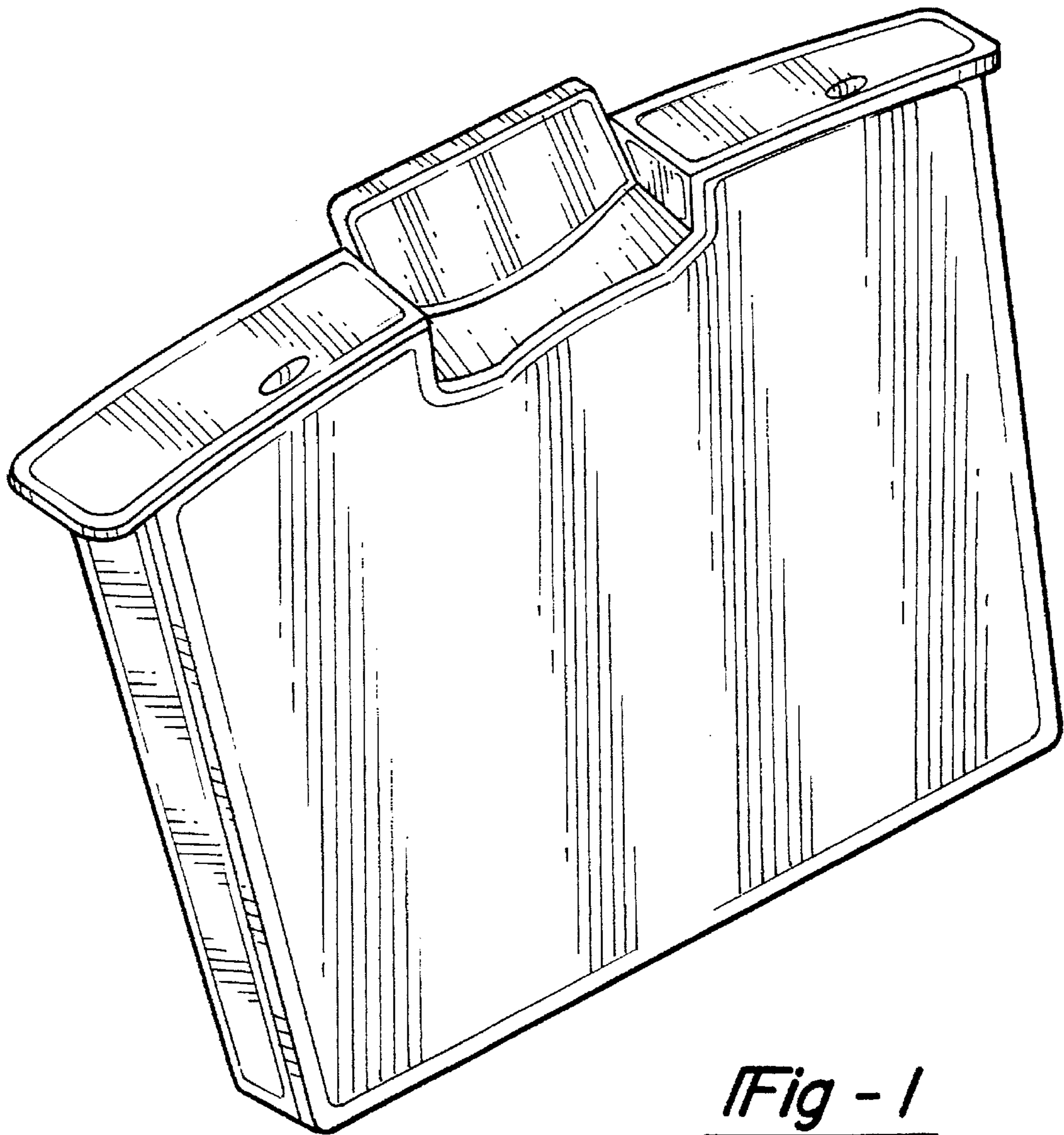

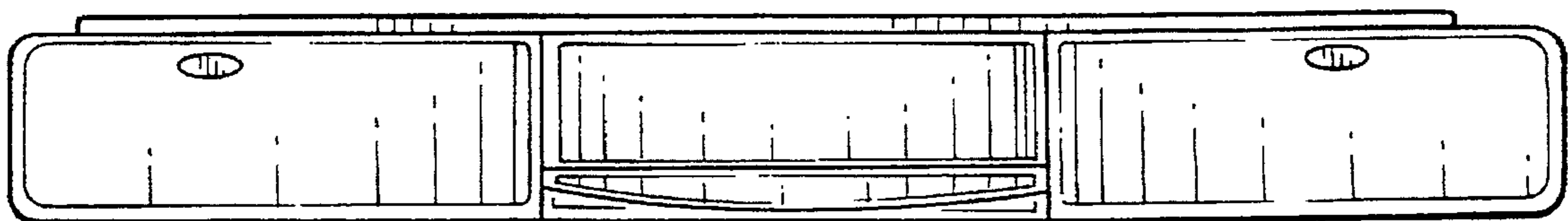
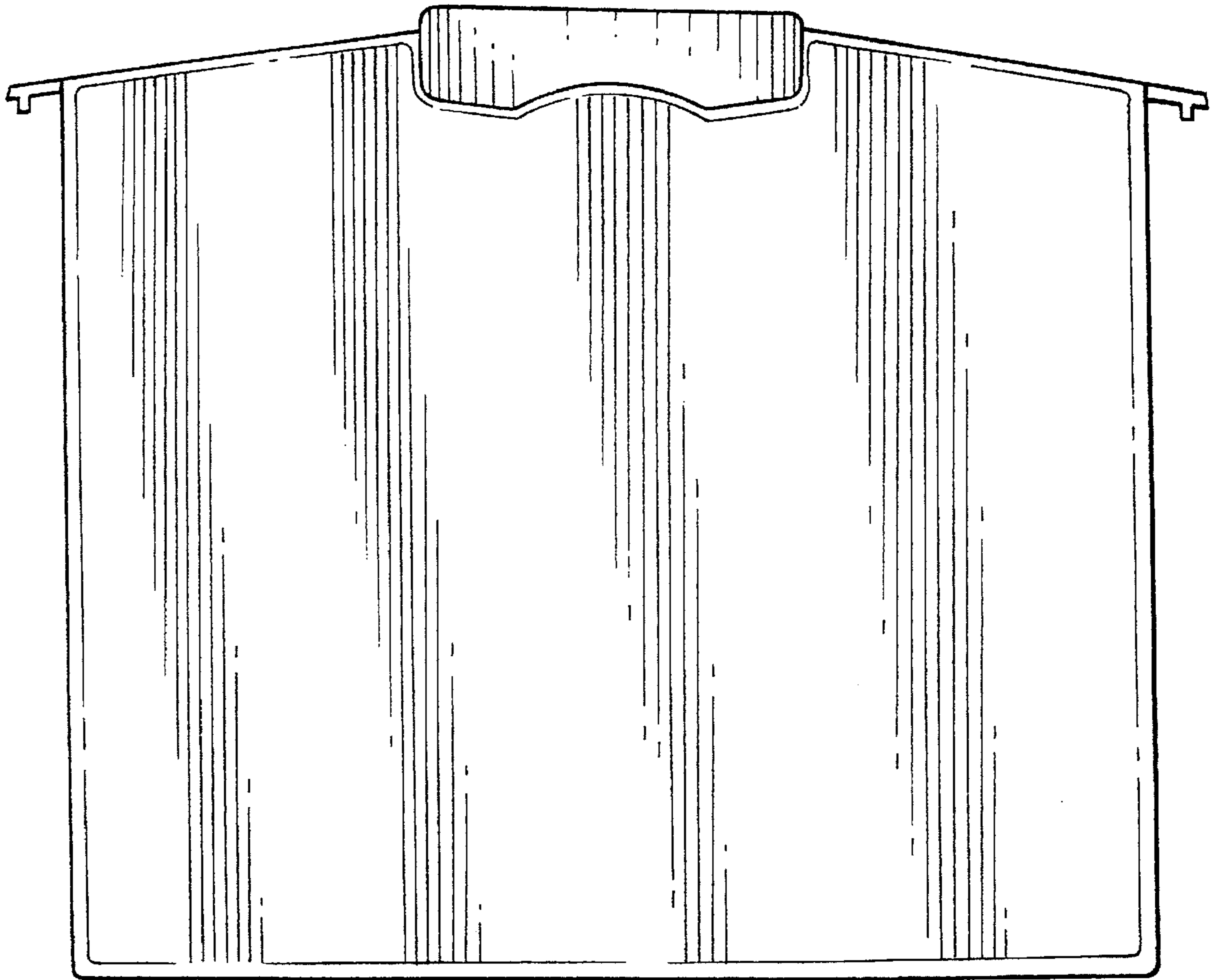

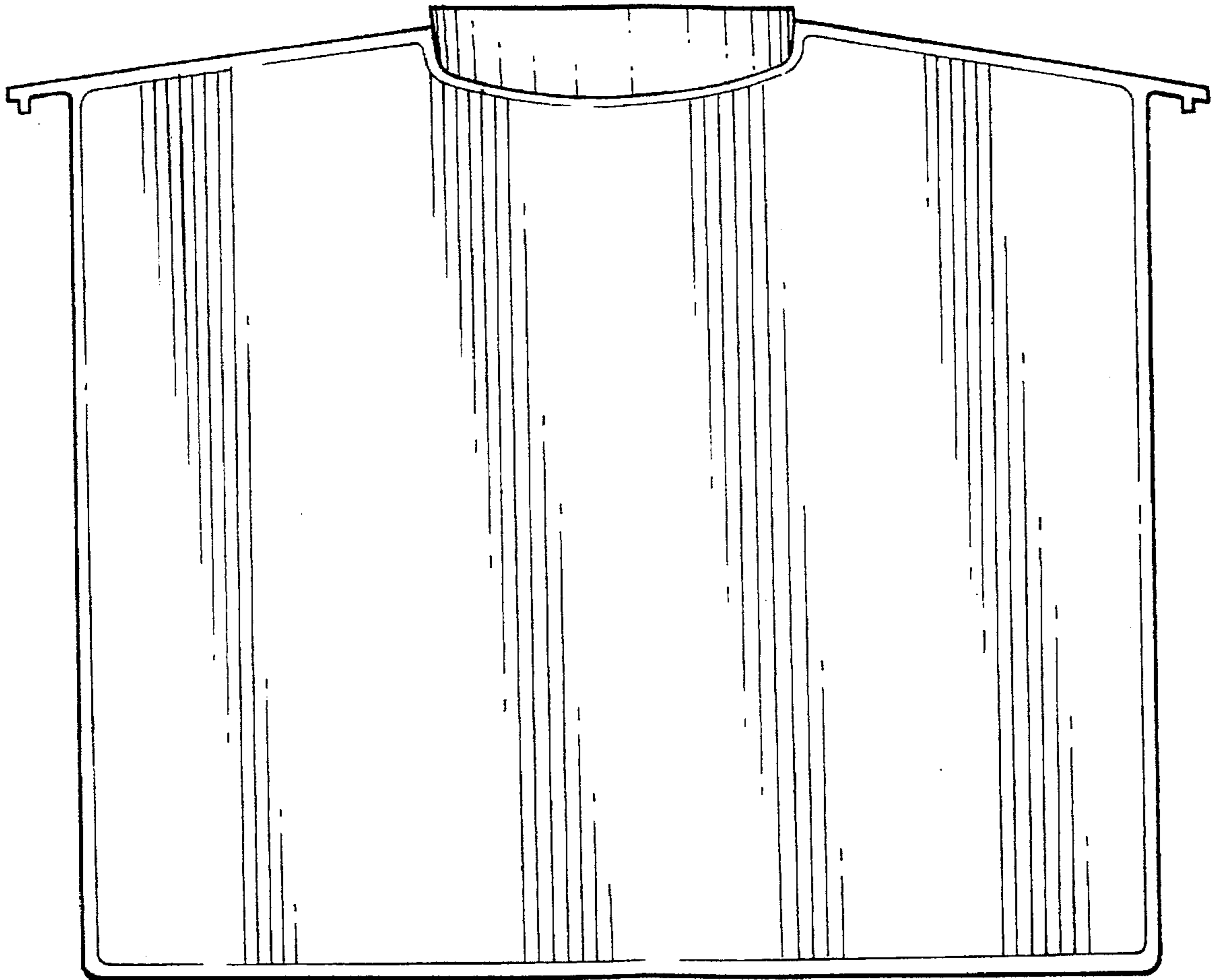

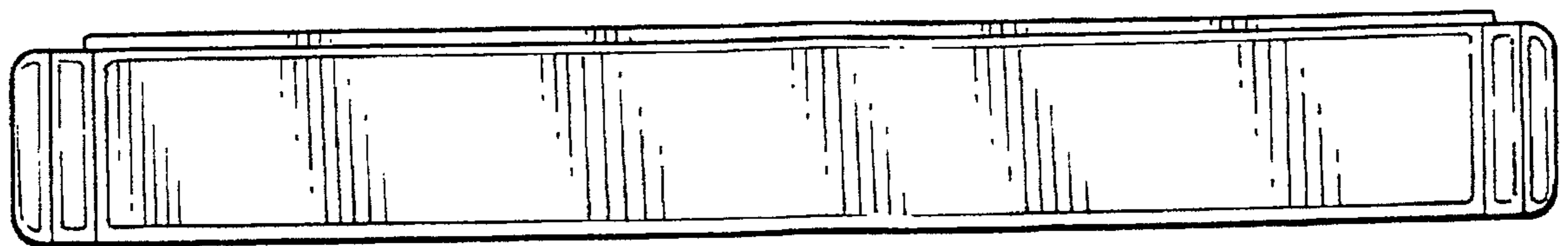

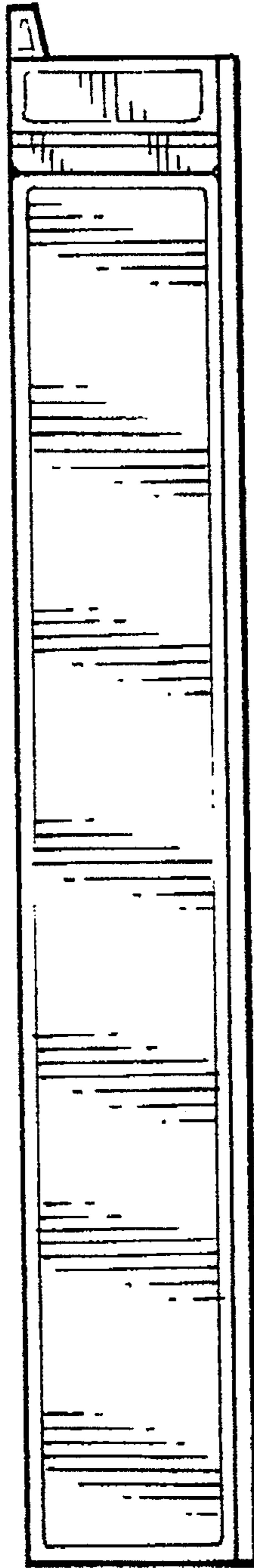
