[57] **CLAIM**

The ornamental design for a box file, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a box file showing my new design, the box file including an inner box and an outer box;

FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a left side elevational view thereof;  
FIG. 7 is a cross-sectional view of the box file taken along line 7—7 of FIG. 1;  
FIG. 8 is a front perspective view thereof;  
FIG. 9 is a front elevational view of the inner box drawn out from the outer box;  
FIG. 10 is a rear elevational view of the inner box drawn out from the outer box;  
FIG. 11 is a top plan view of the inner box drawn out from the outer box;  
FIG. 12 is a bottom plan view of the inner box drawn out from the outer box;  
FIG. 13 is a front perspective view of the inner box drawn out from the outer box;  
FIG. 14 is a front elevational view of the outer box;  
FIG. 15 is a rear elevational view of the outer box;  
FIG. 16 is a top plan view of the outer box;  
FIG. 17 is a bottom plan view of the outer box;  
FIG. 18 is a right side elevational view of the outer box;  
FIG. 19 is a left side elevational view of the outer box;  
FIG. 20 is a cross-sectional view of the outer box taken along line 20—20 of FIG. 14;  
FIG. 21 is a front perspective view of the outer box;  
FIG. 22 is a front elevational view of the inner box;  
FIG. 23 is a rear elevational view of the inner box;  
FIG. 24 is a top plan view of the inner box;  
FIG. 25 is a bottom plan view of the inner box;  
FIG. 26 is a right side elevational view of the inner box;  
FIG. 27 is a left side elevational view of the inner box;  
FIG. 28 is a cross-sectional view taken along line 22—22 of FIG. 22; and,  
FIG. 29 is a front perspective view of the inner box.

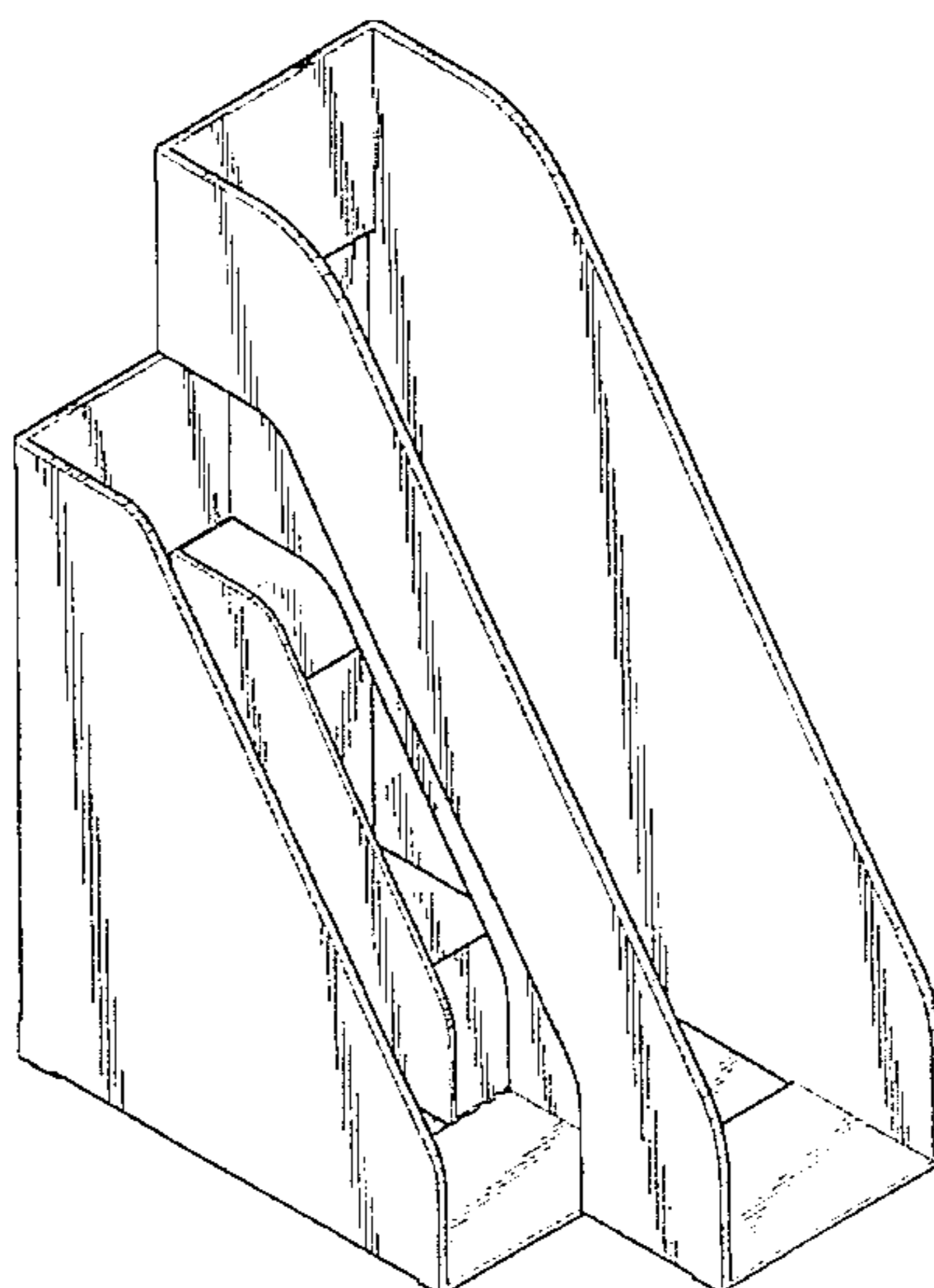

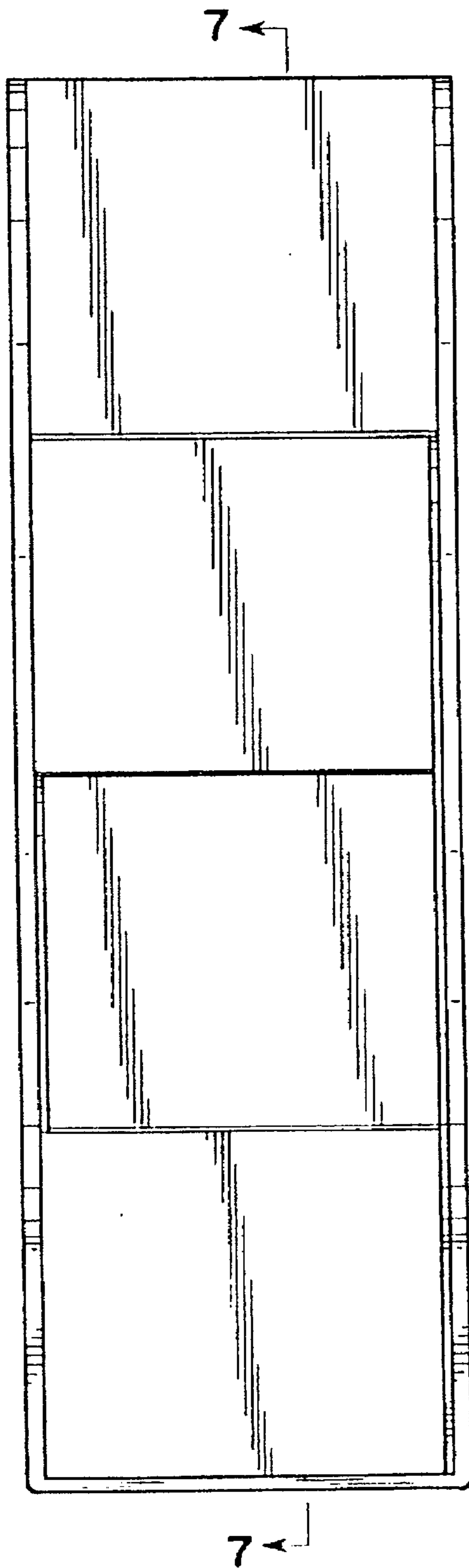

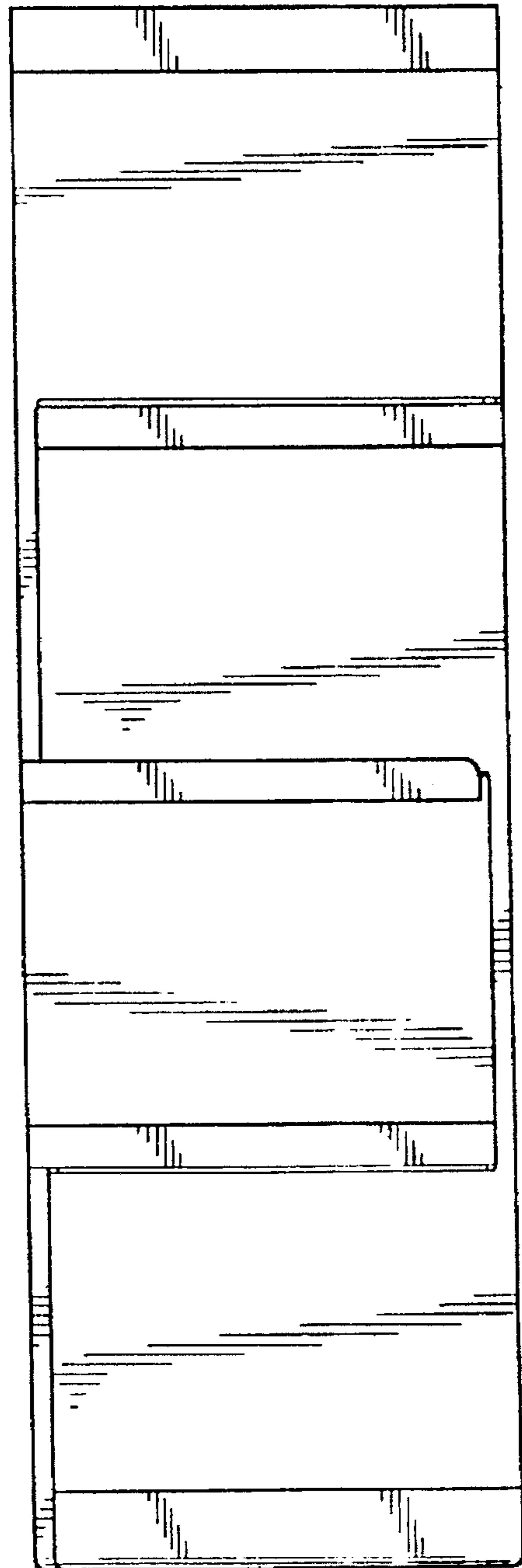

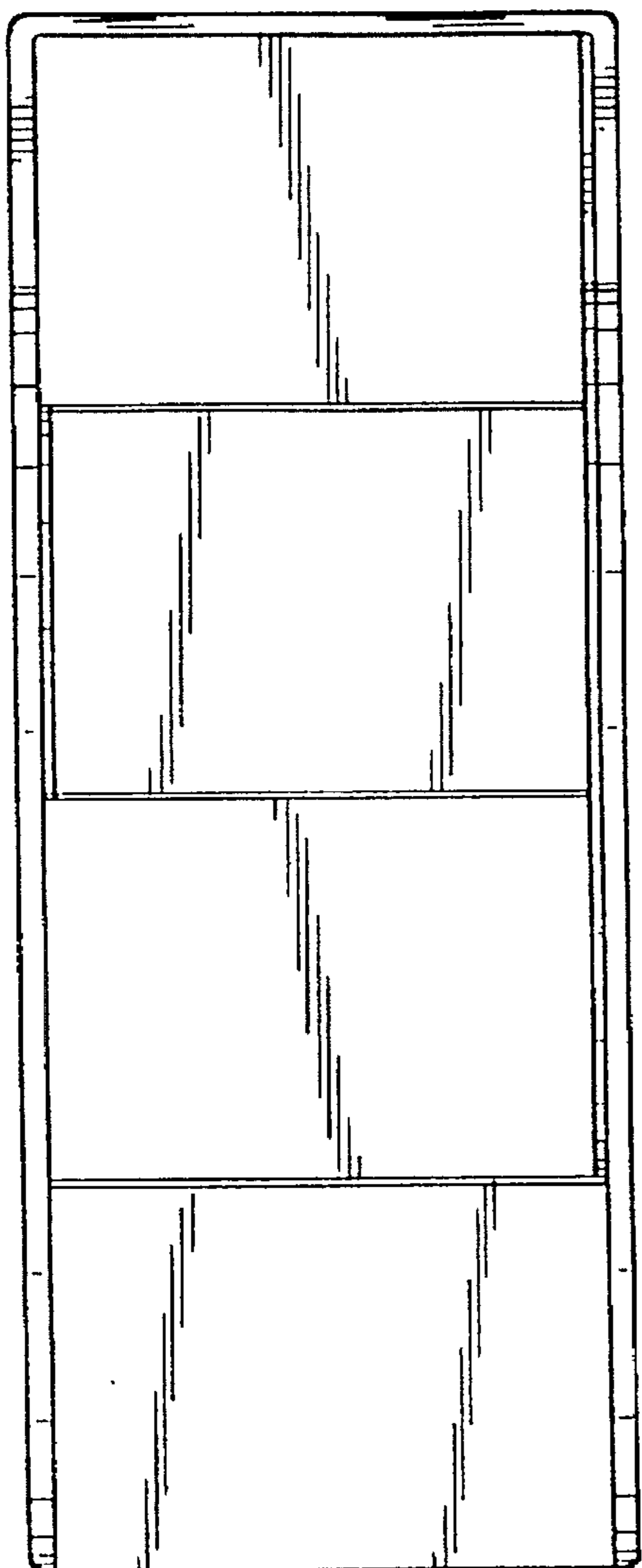

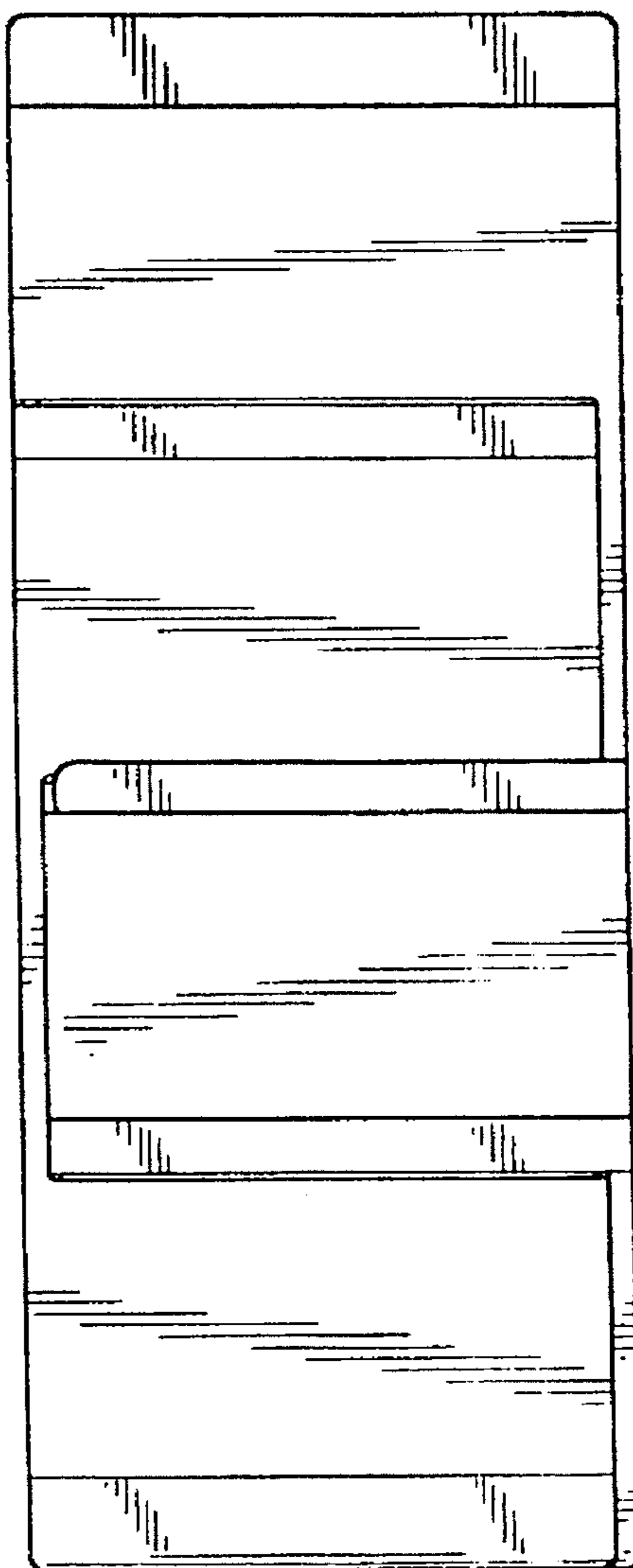

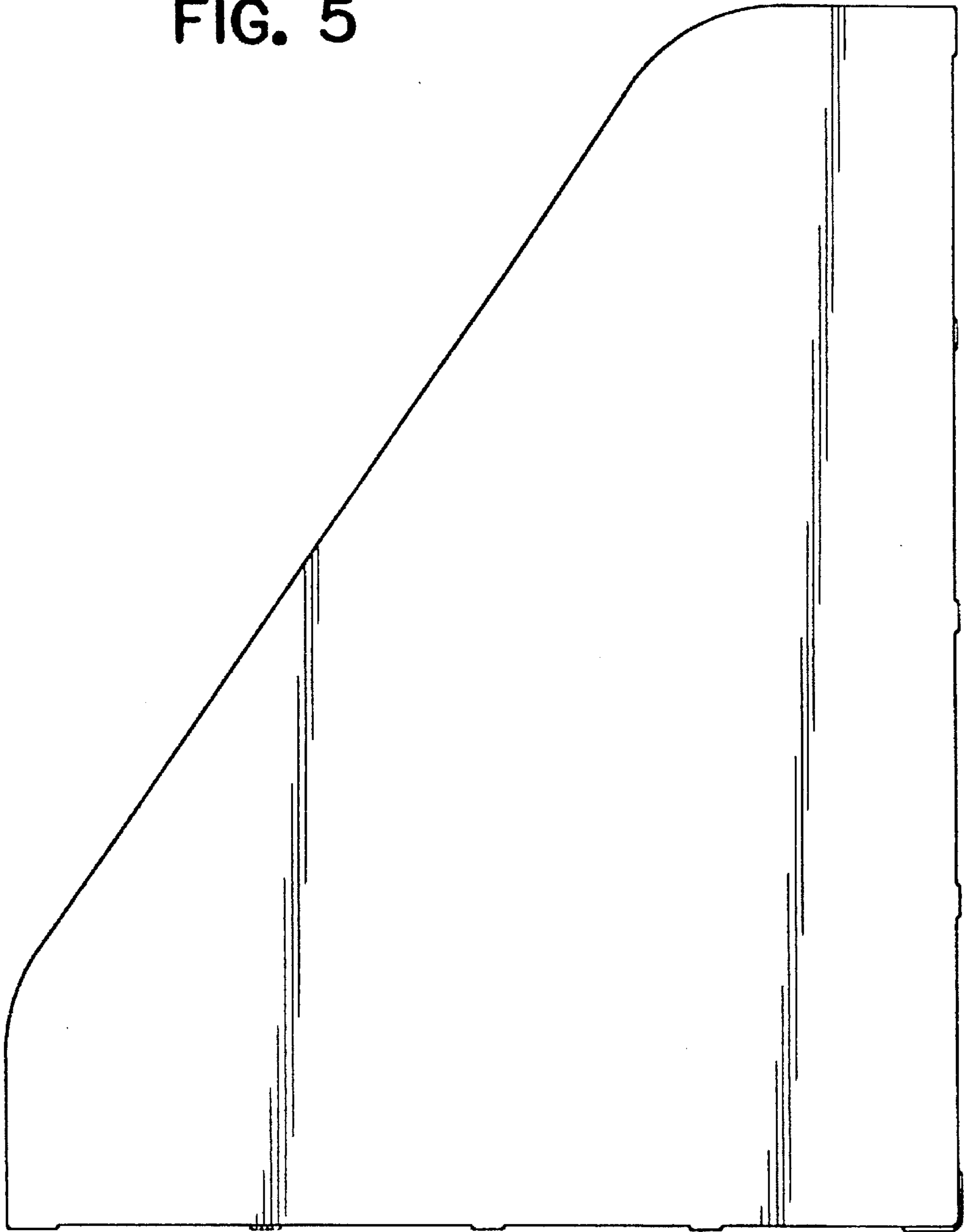

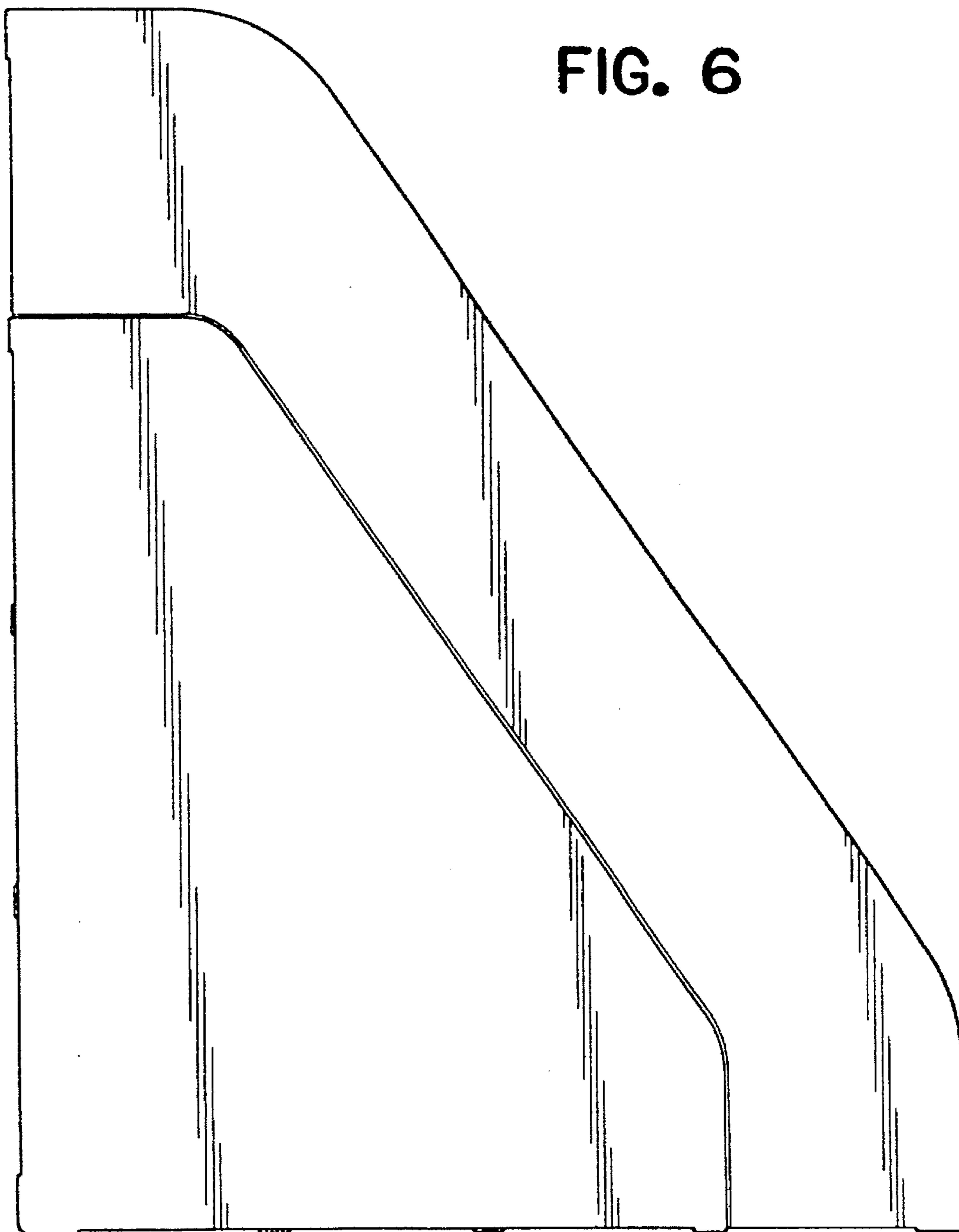

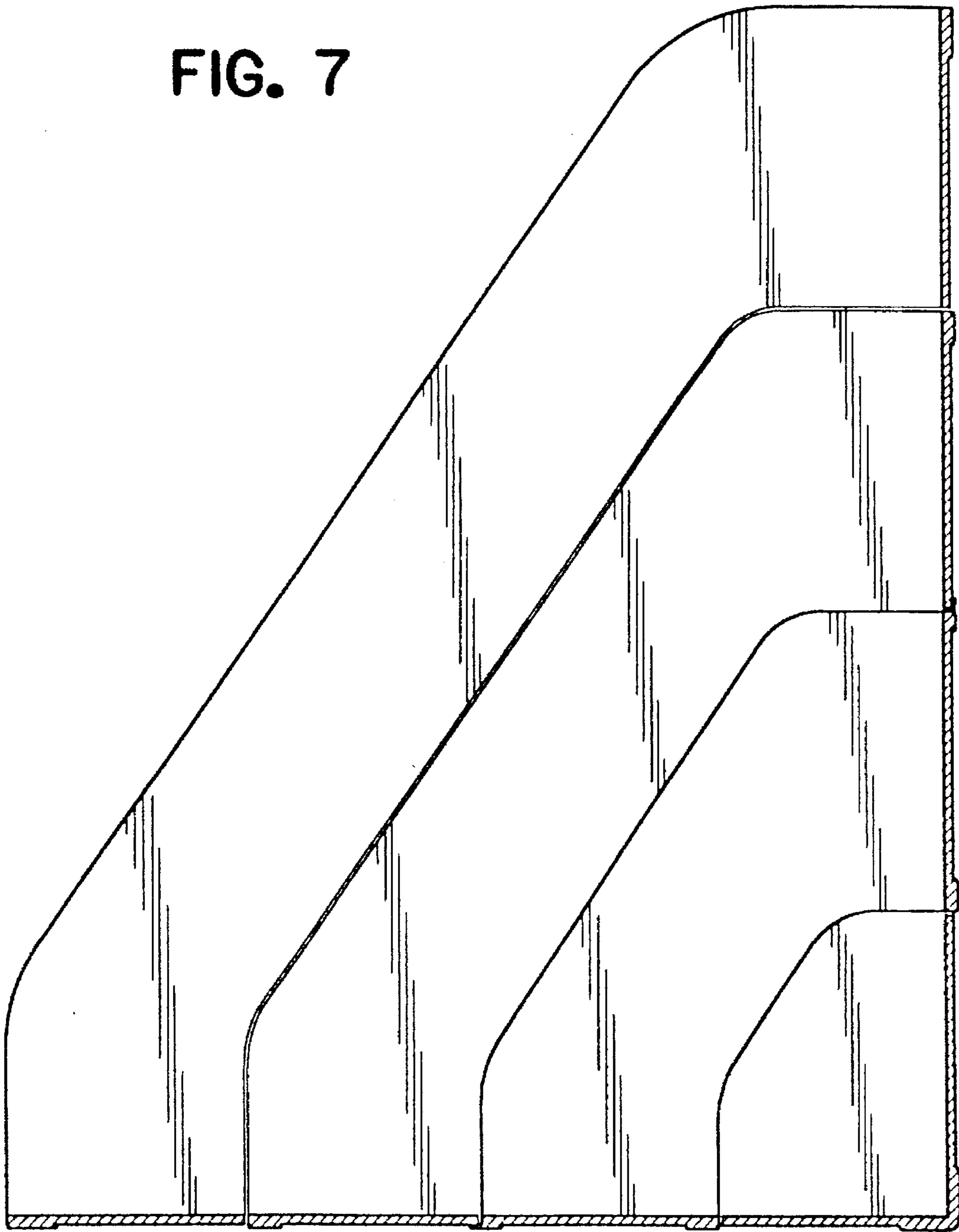

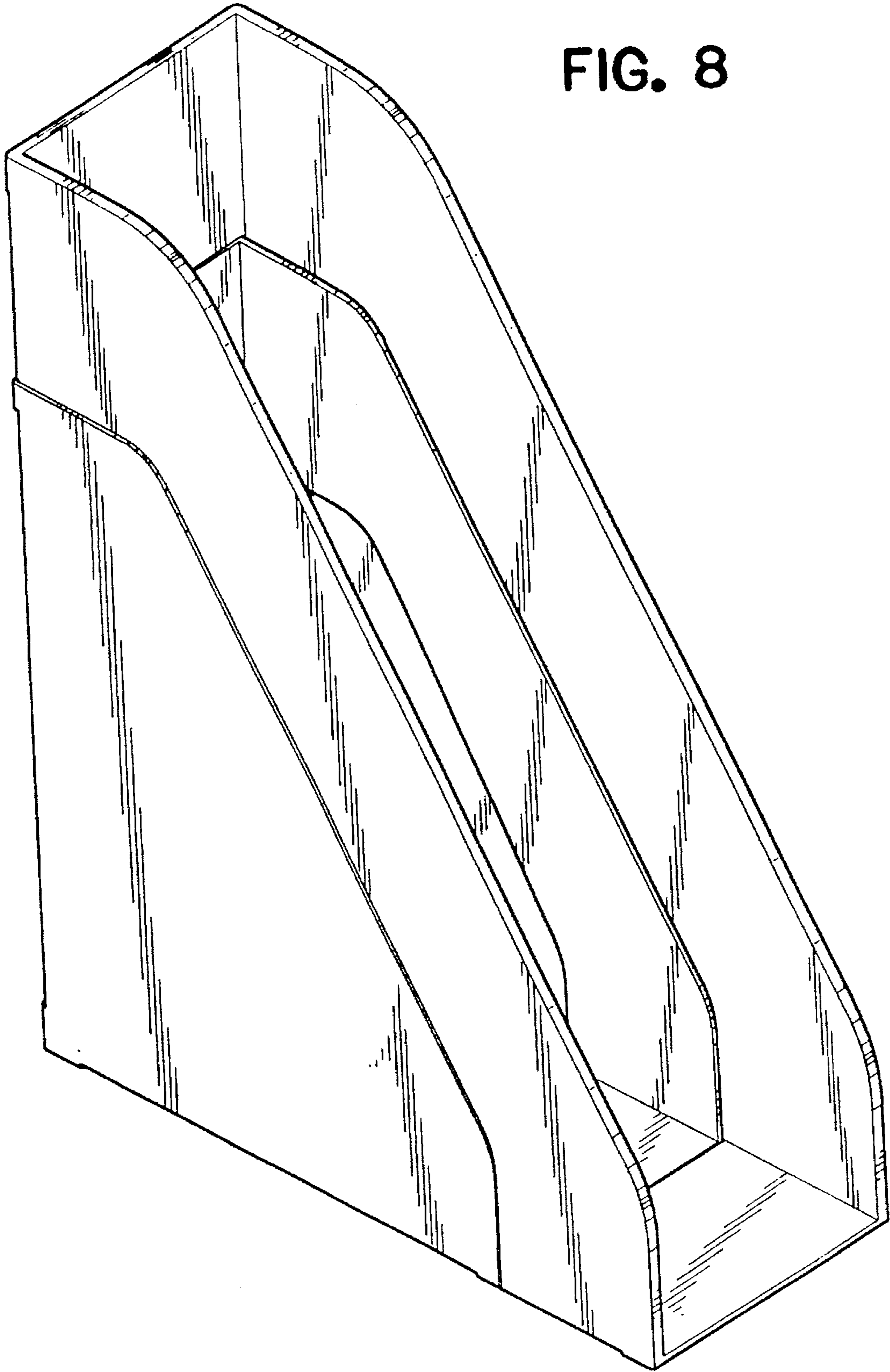

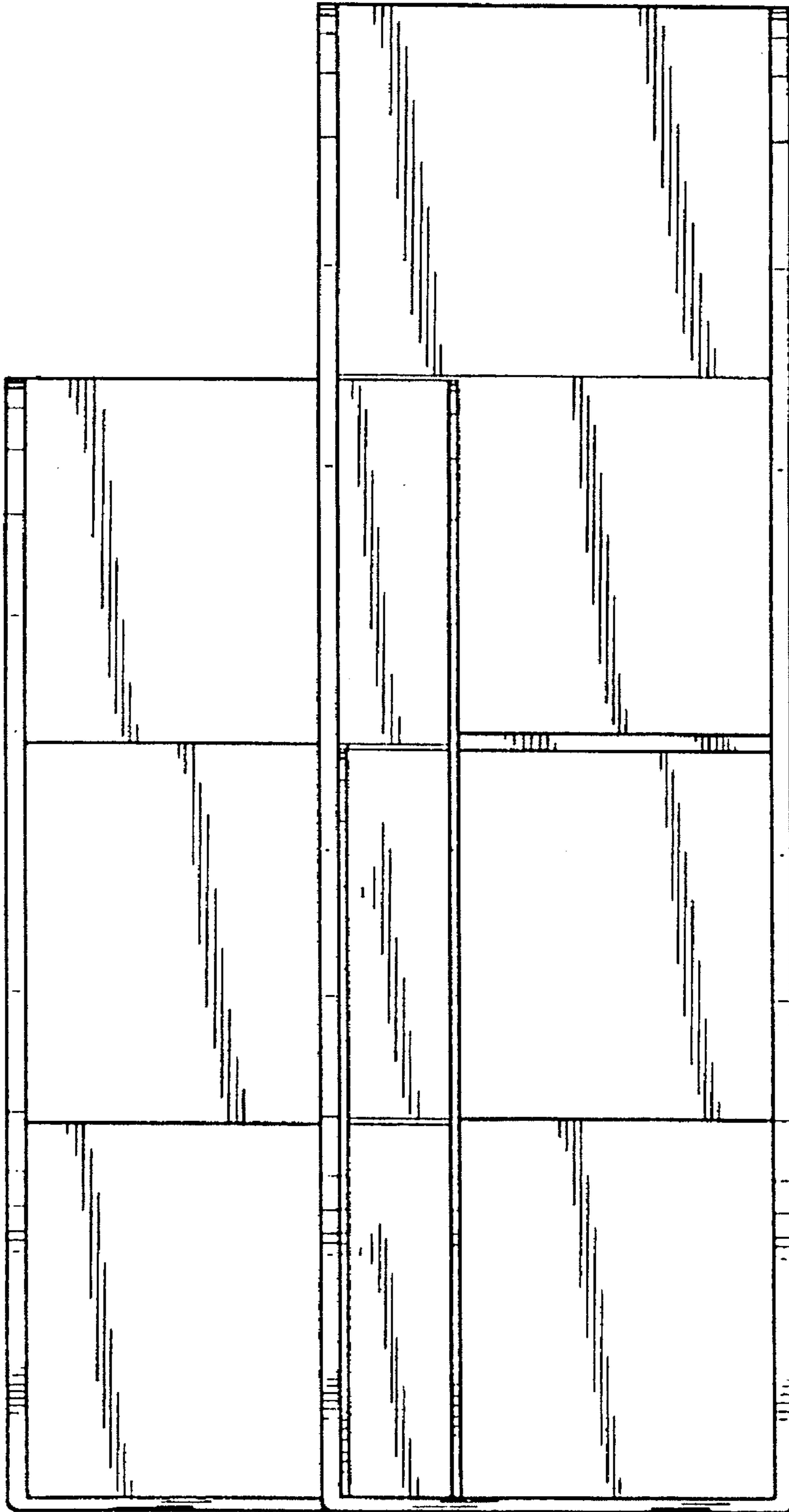

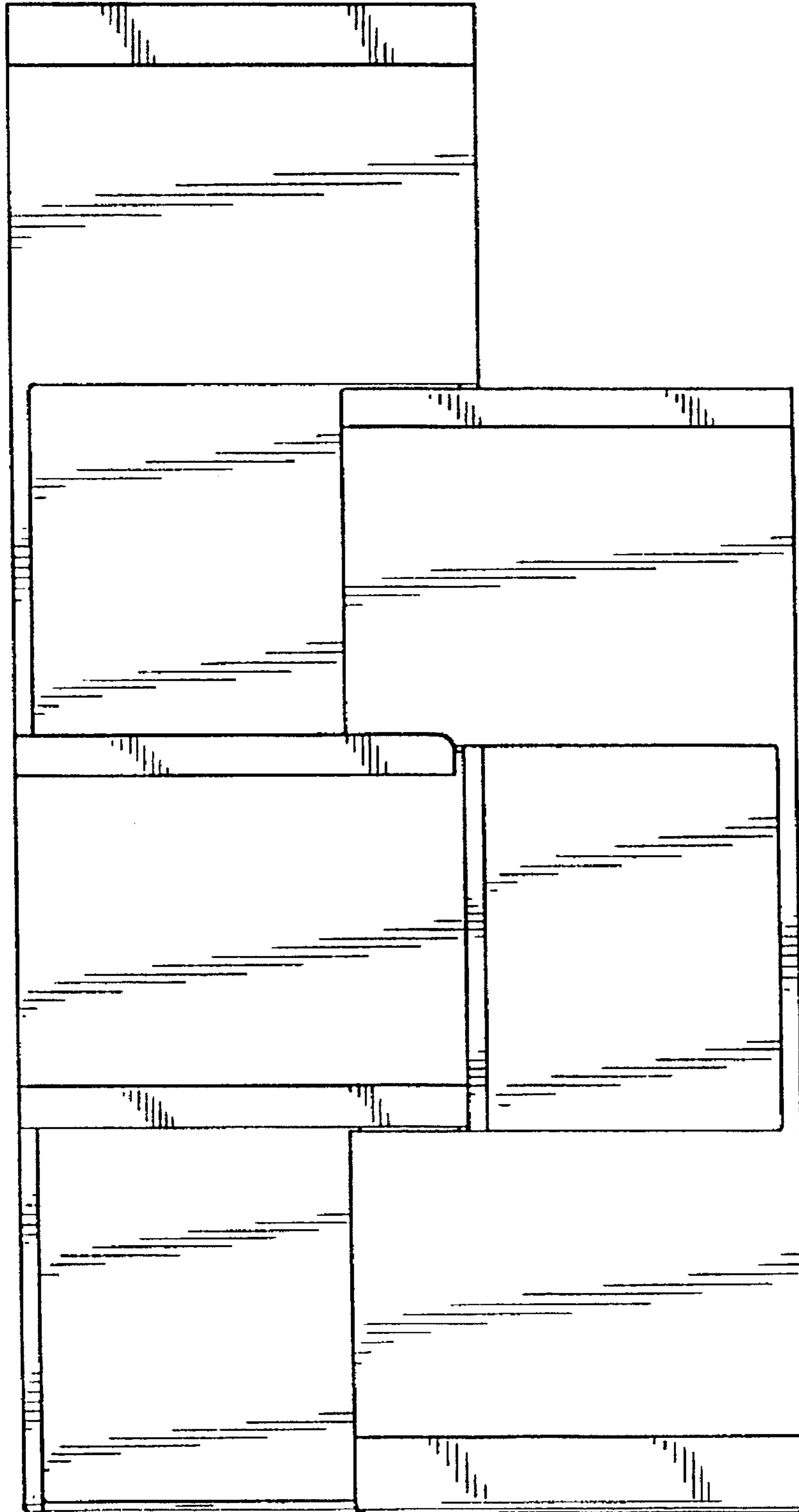

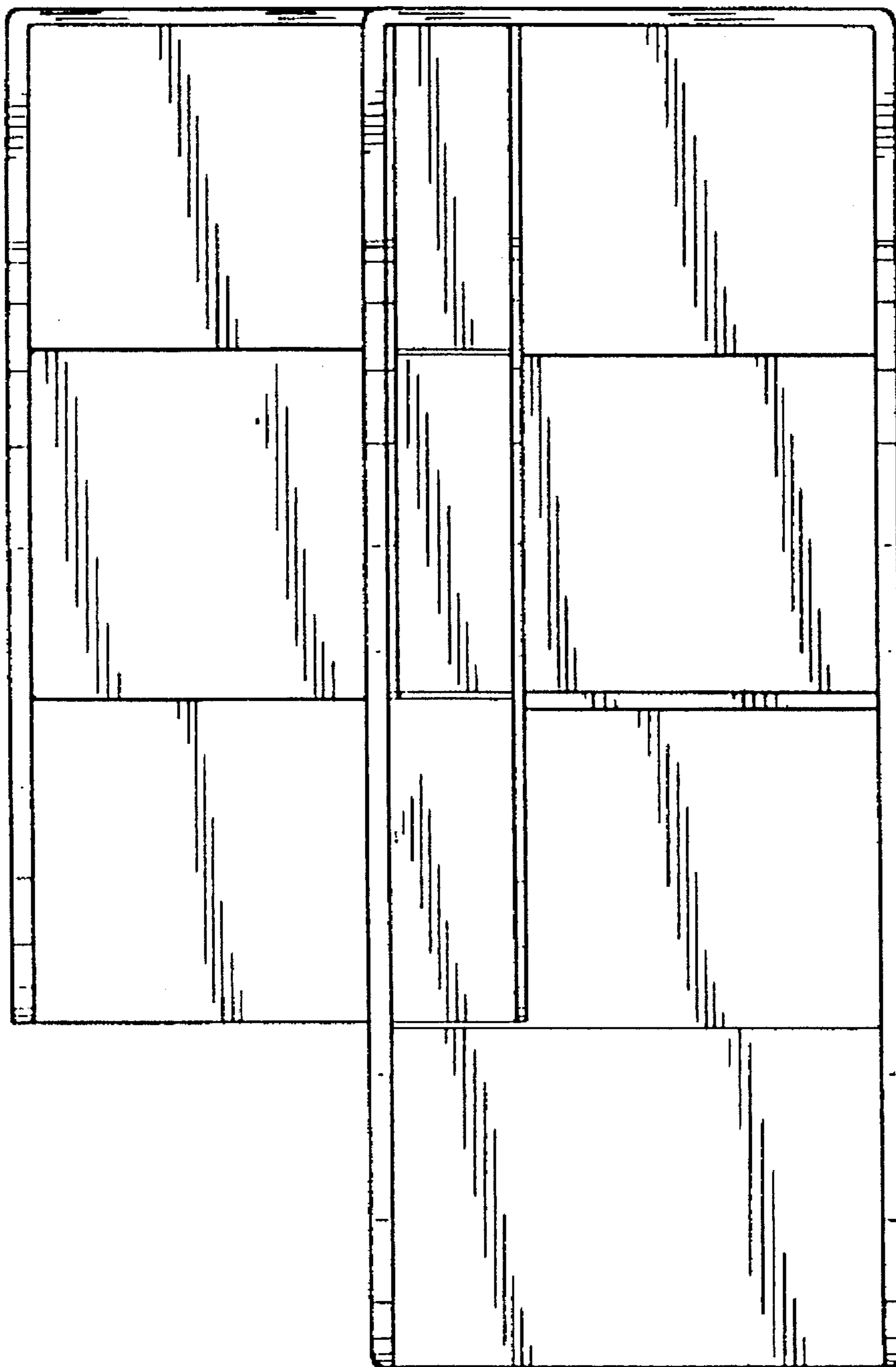

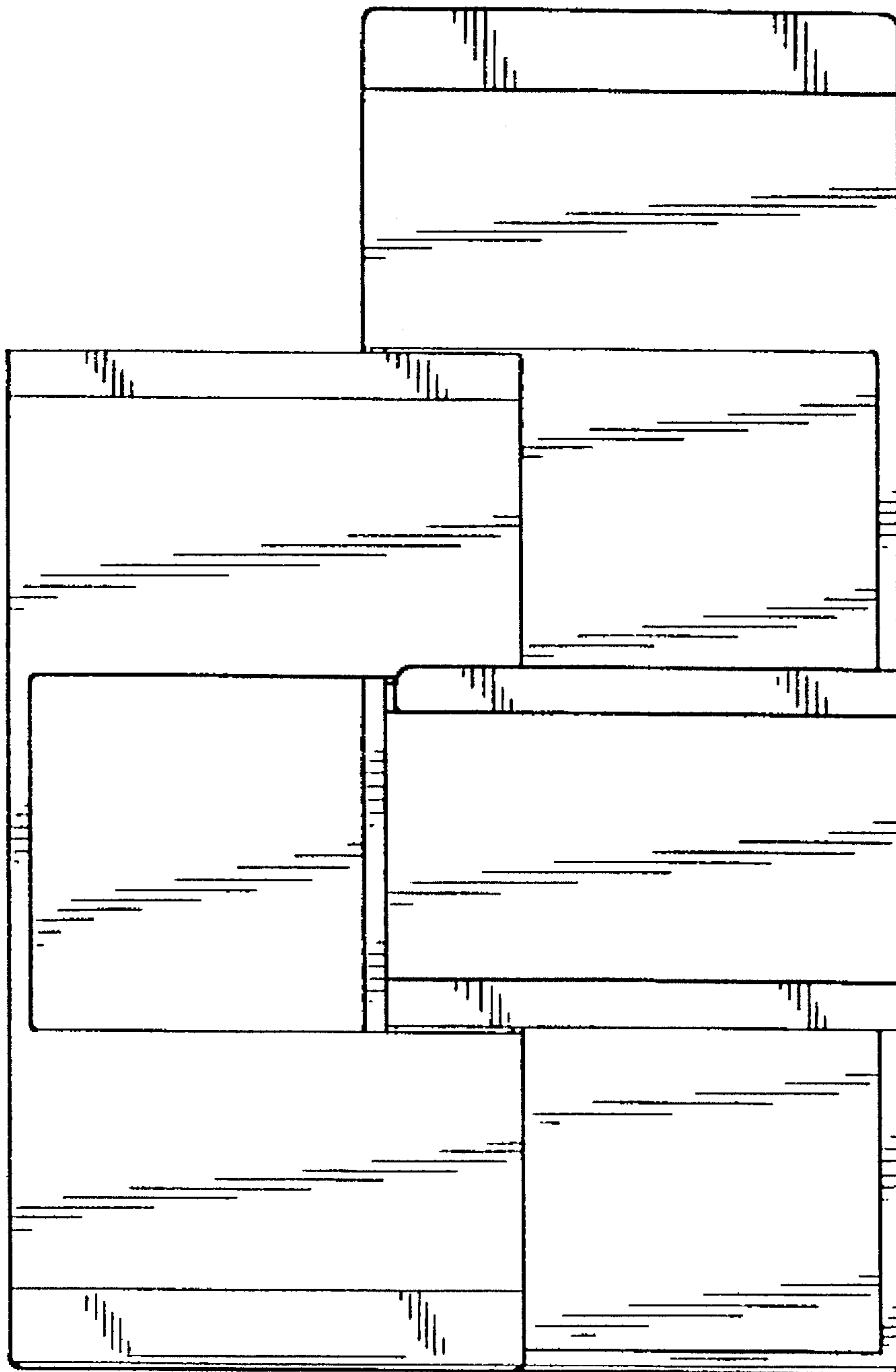

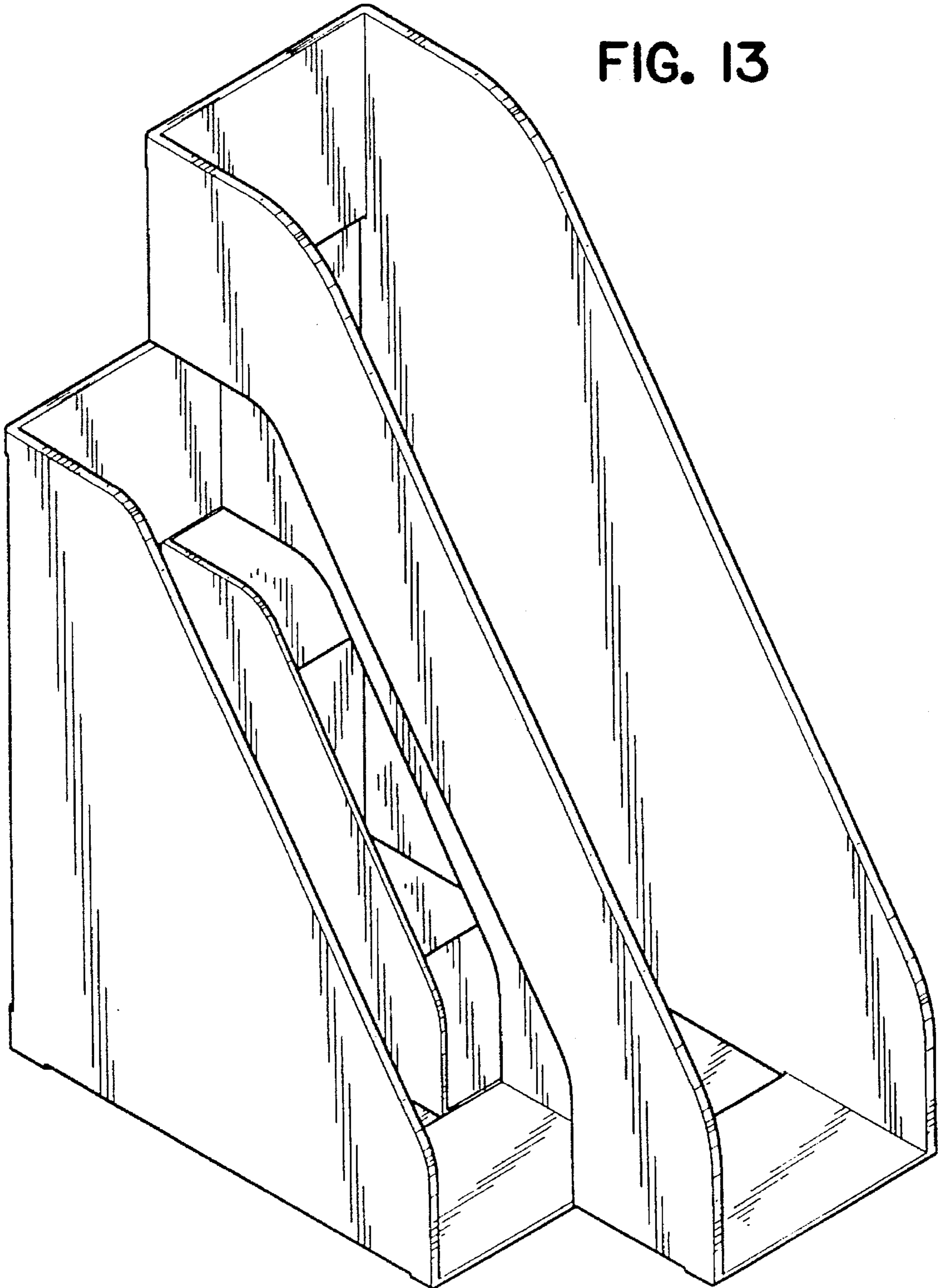

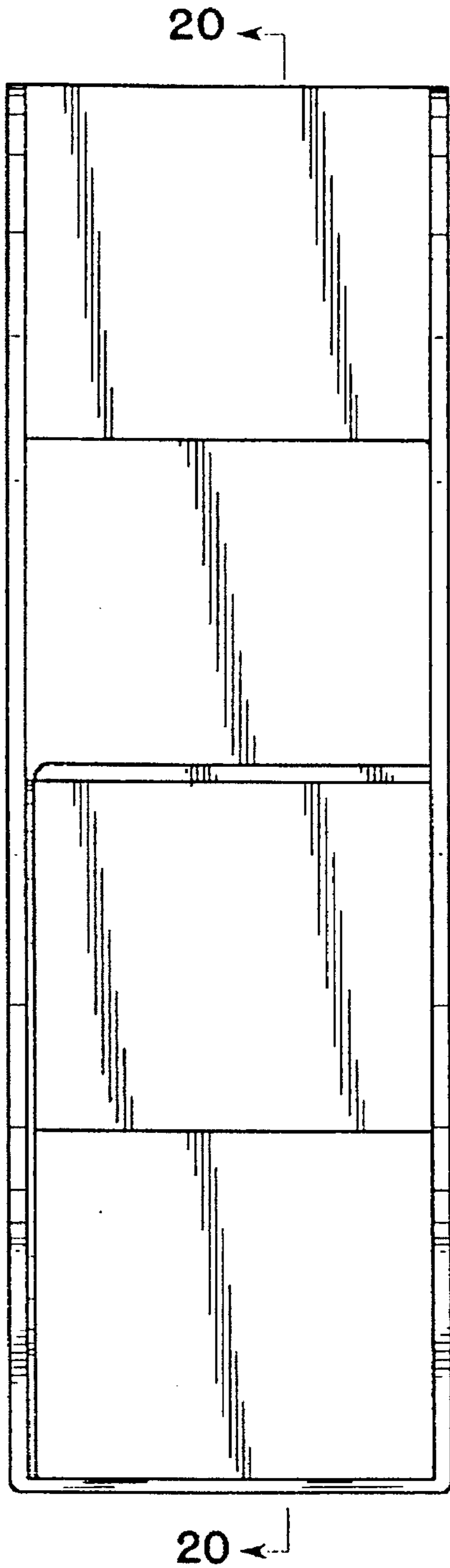

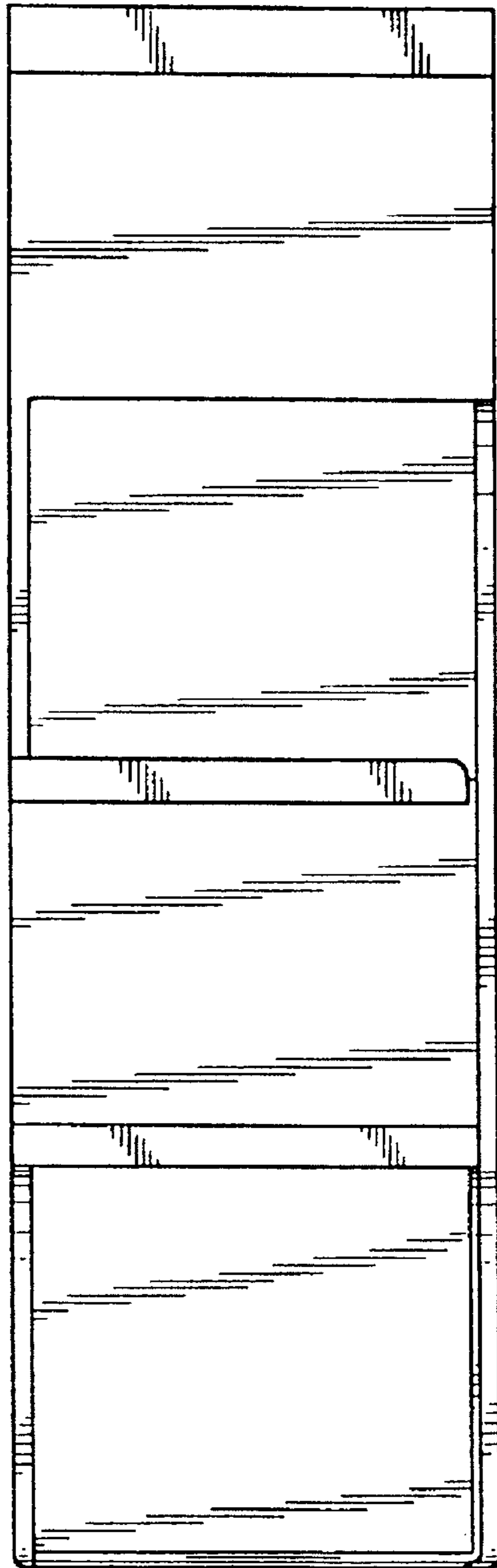

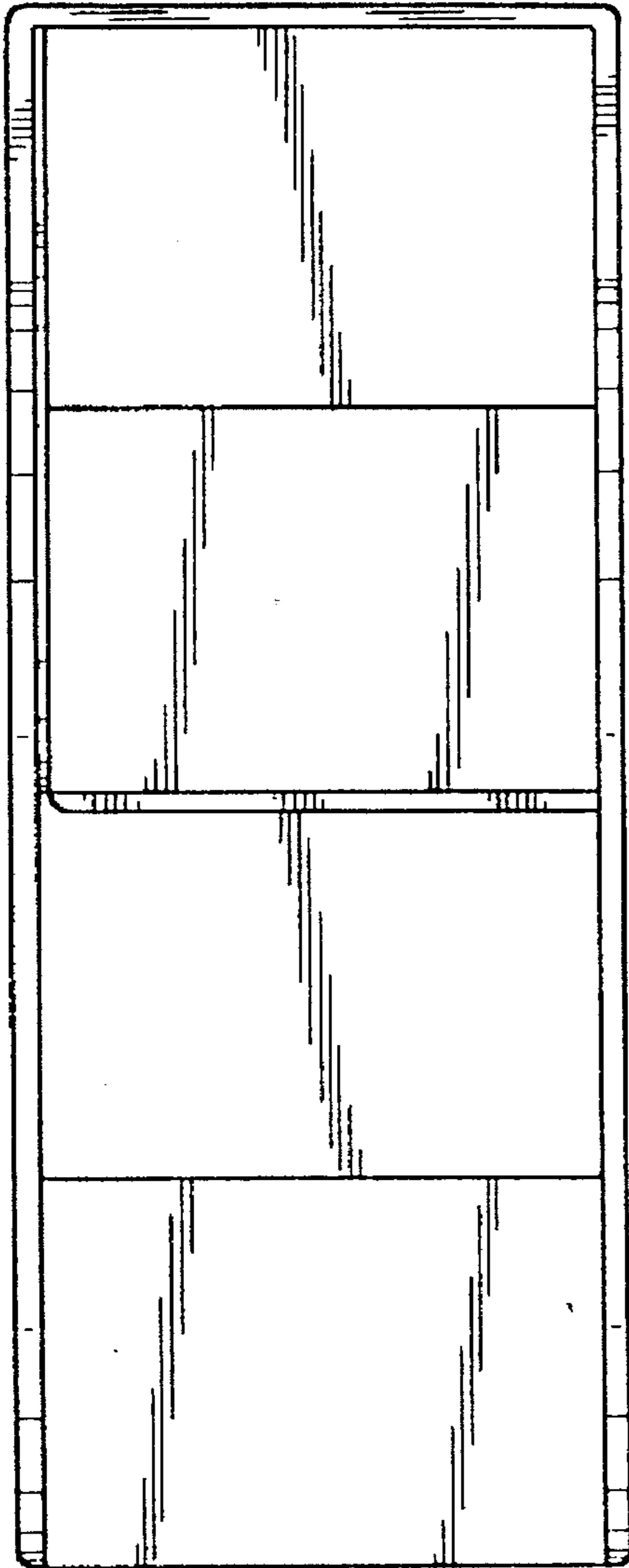

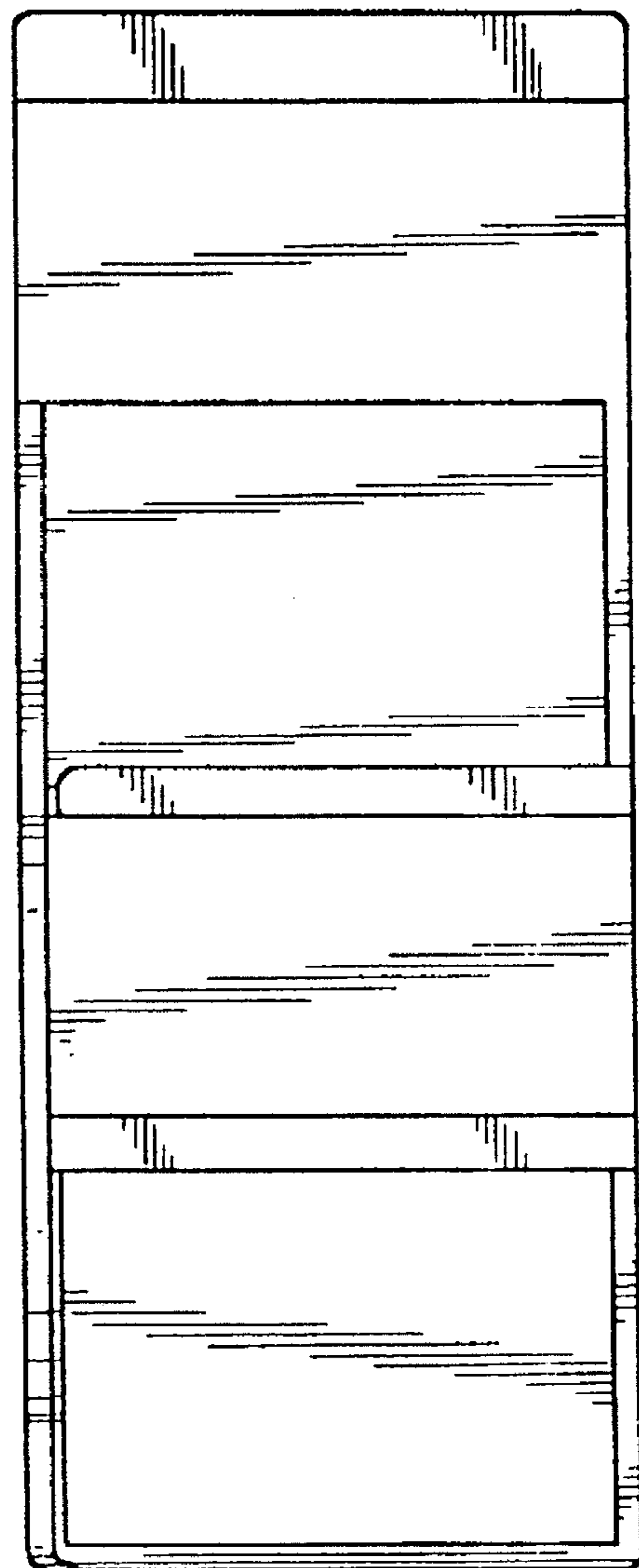

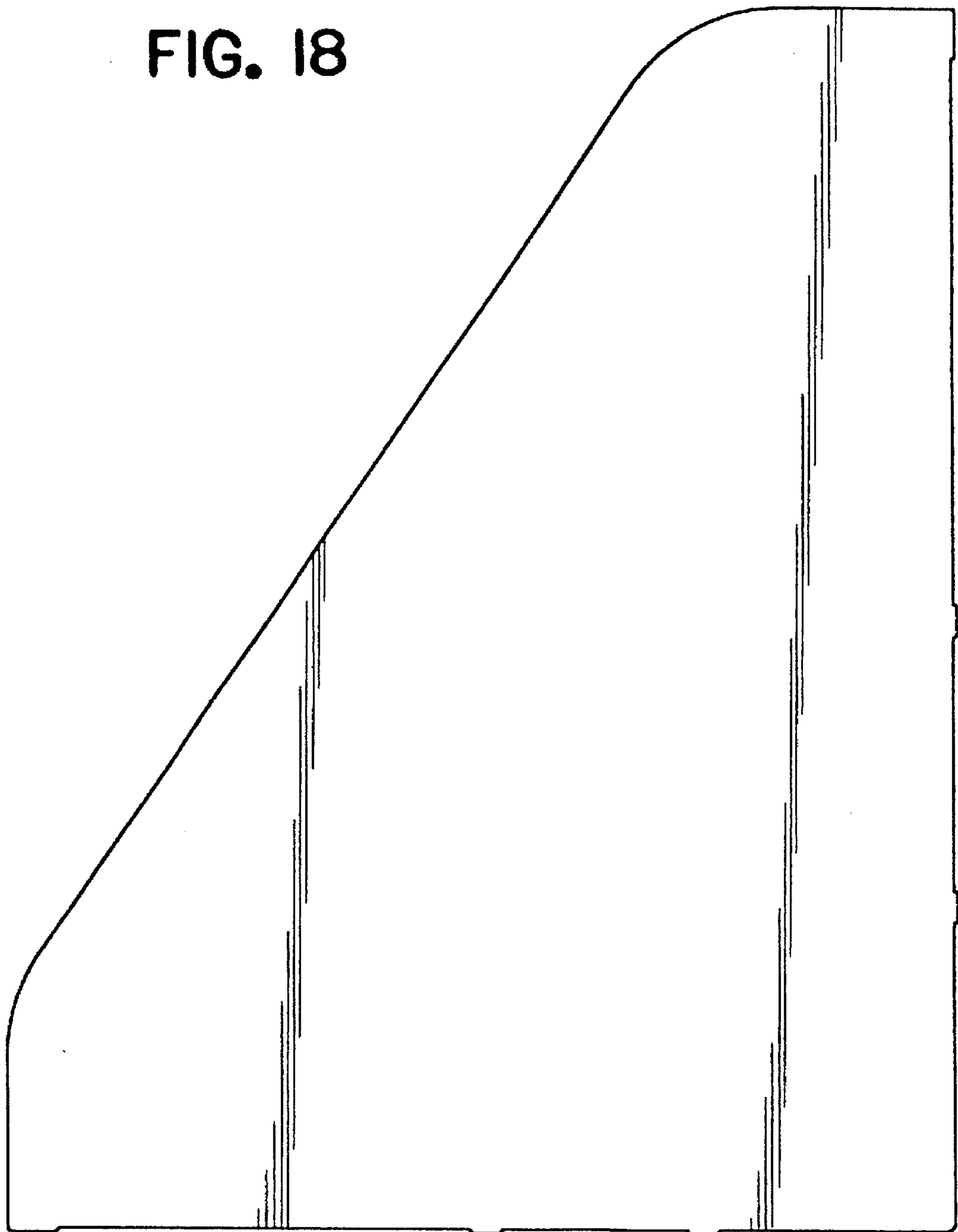

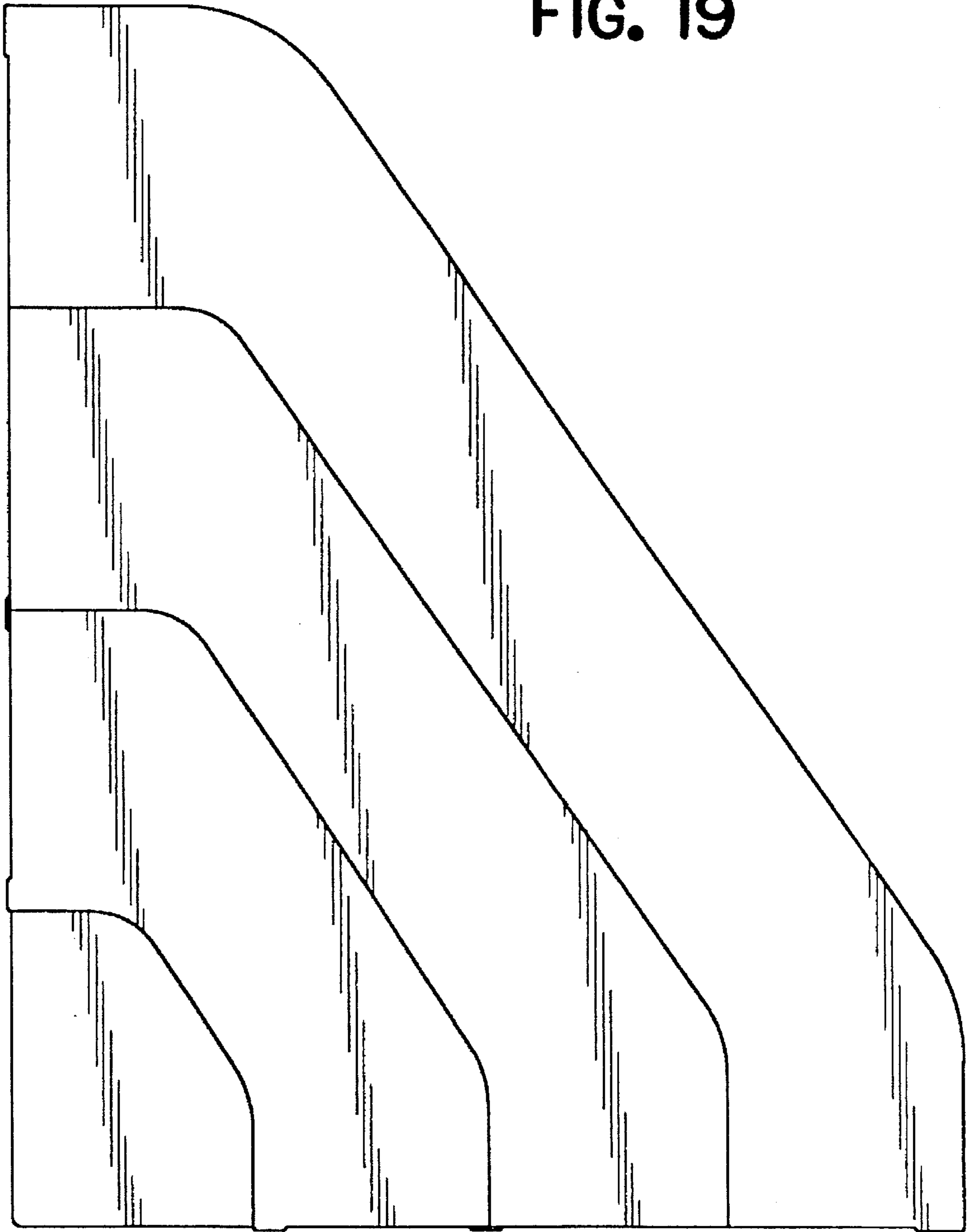

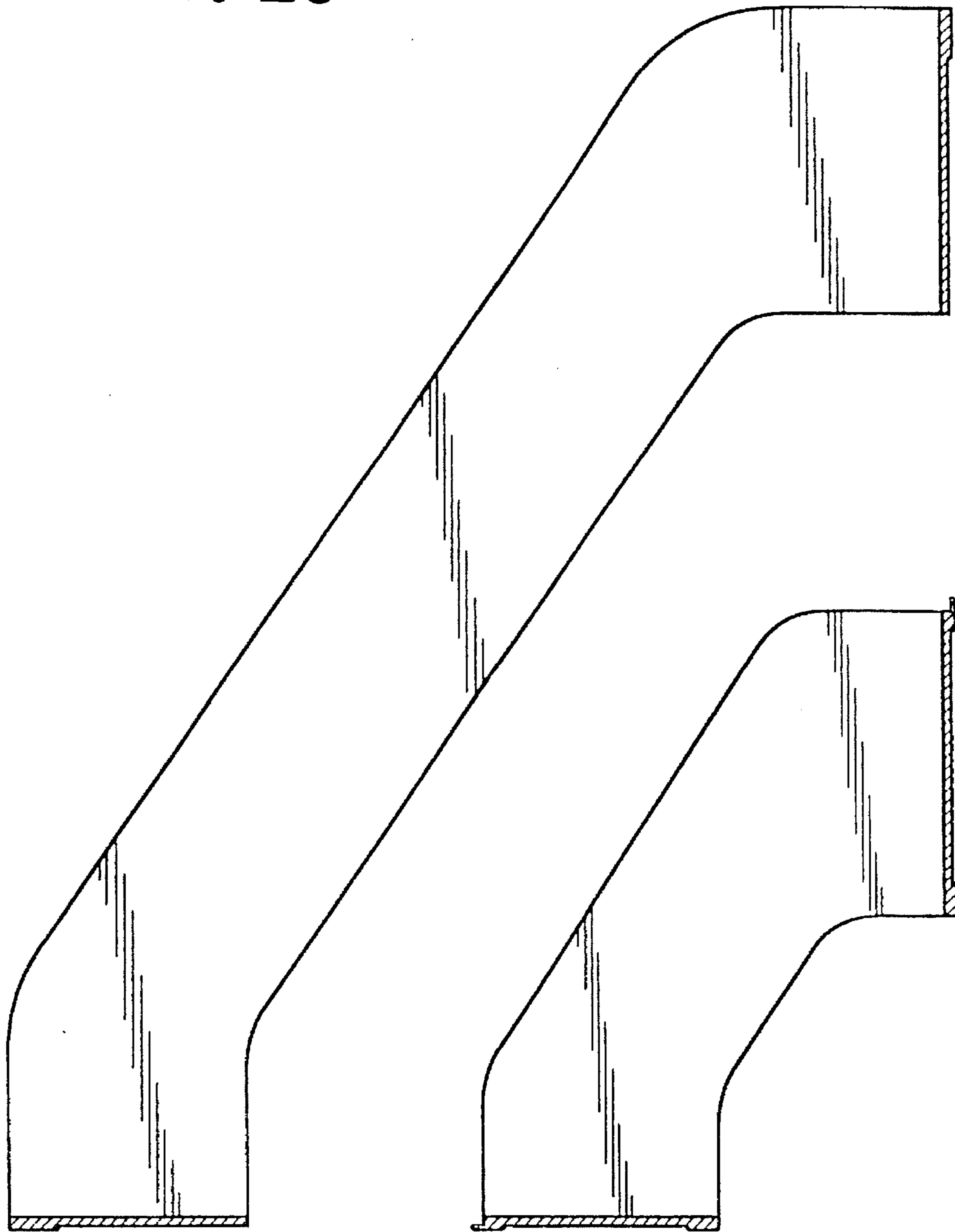

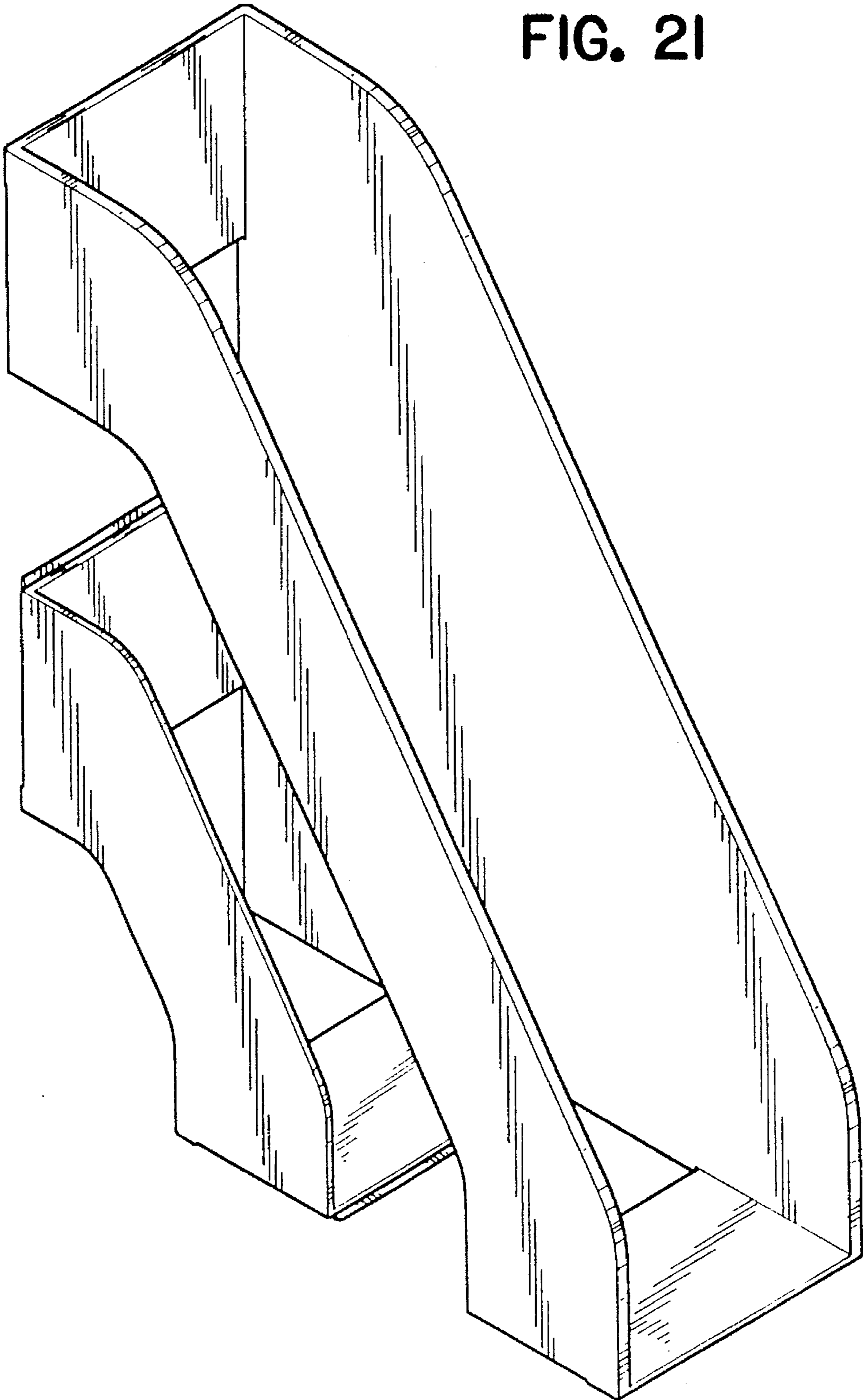

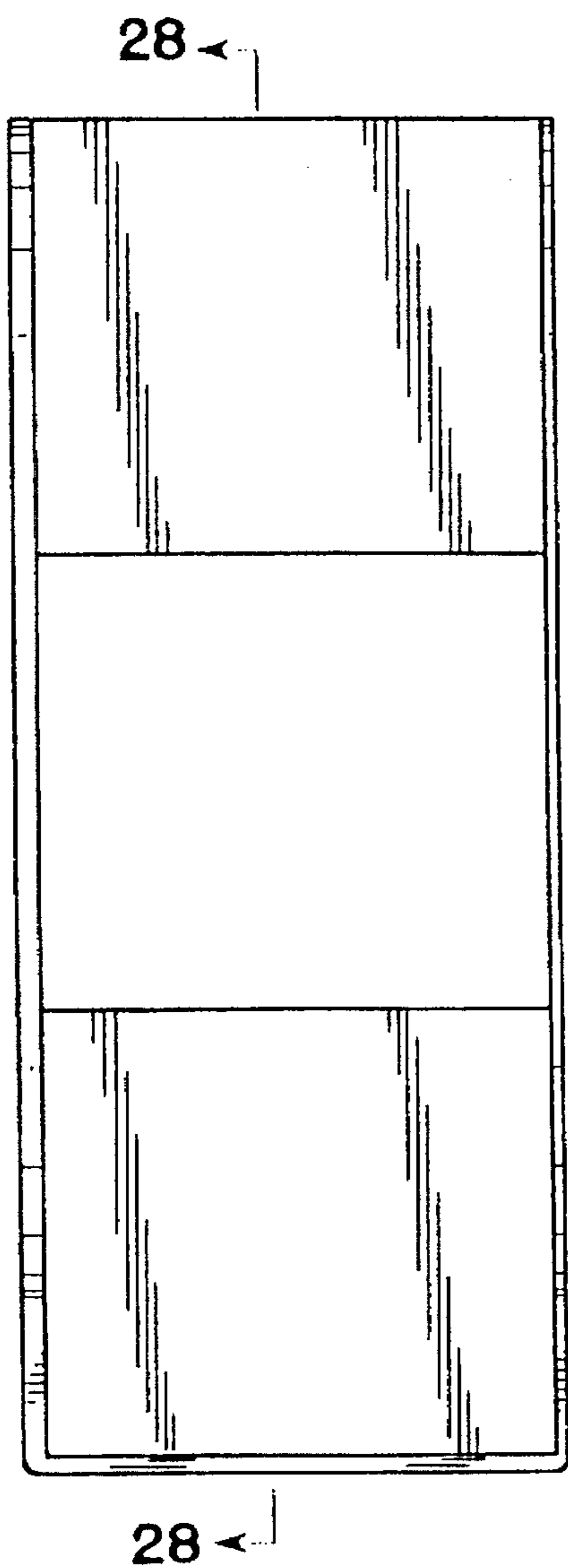

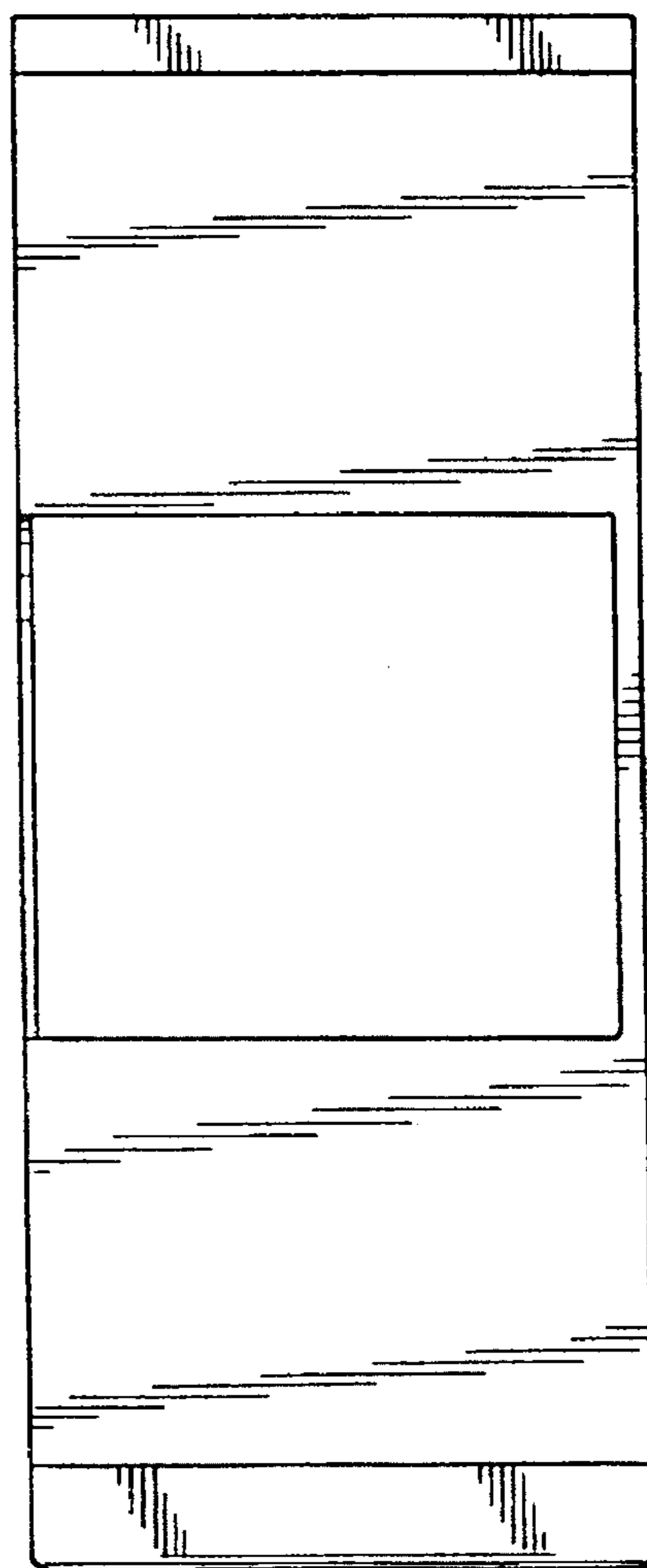

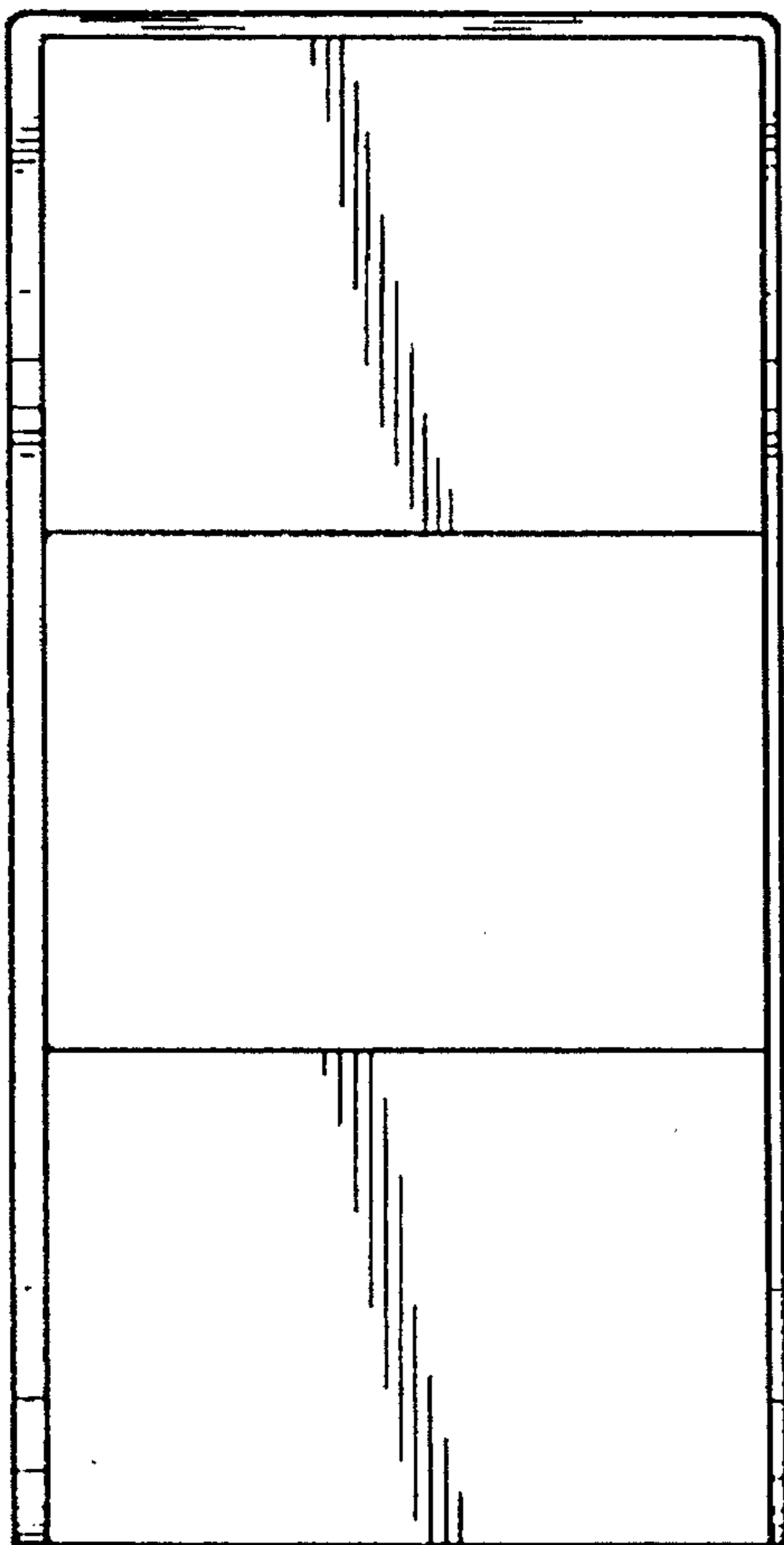

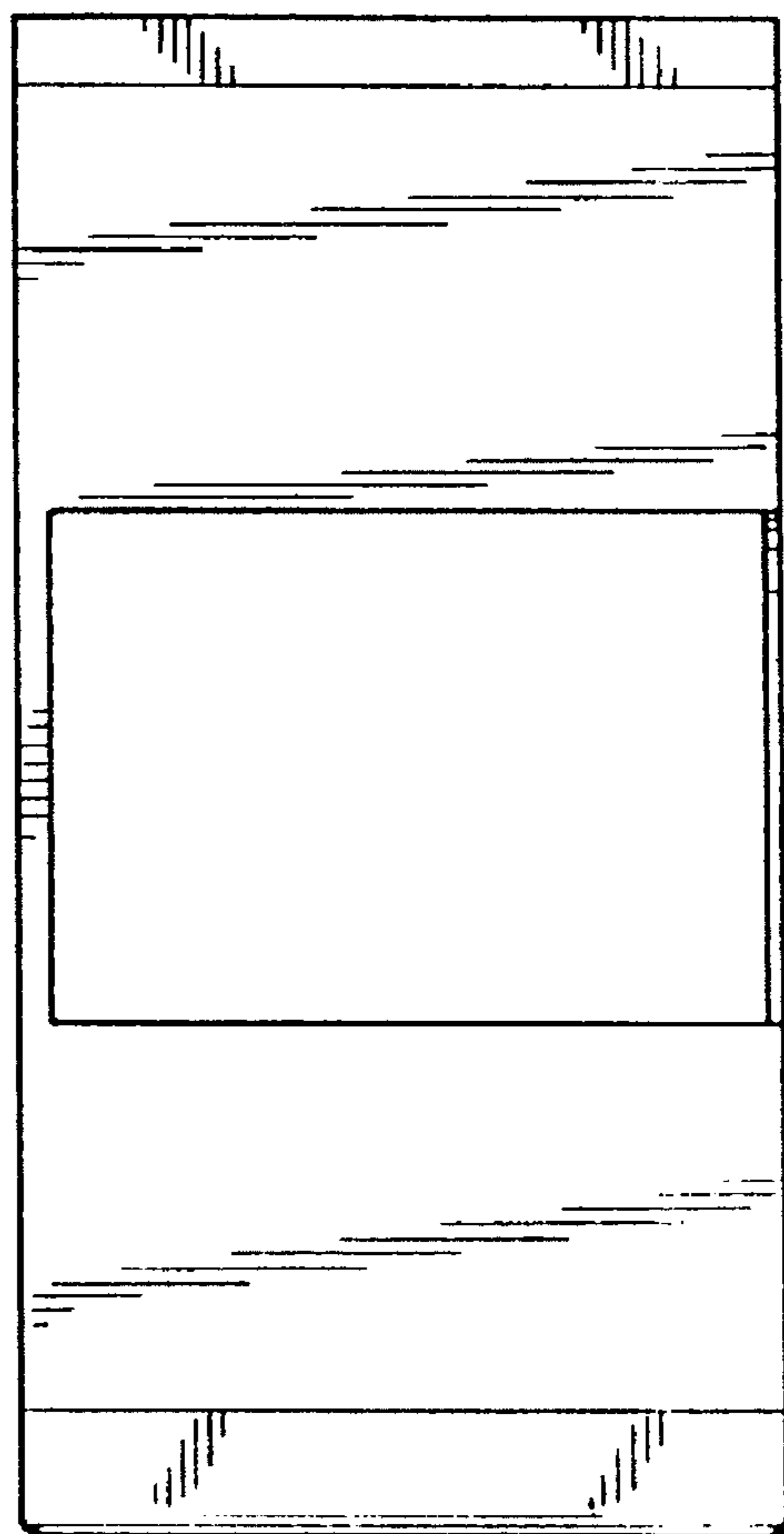

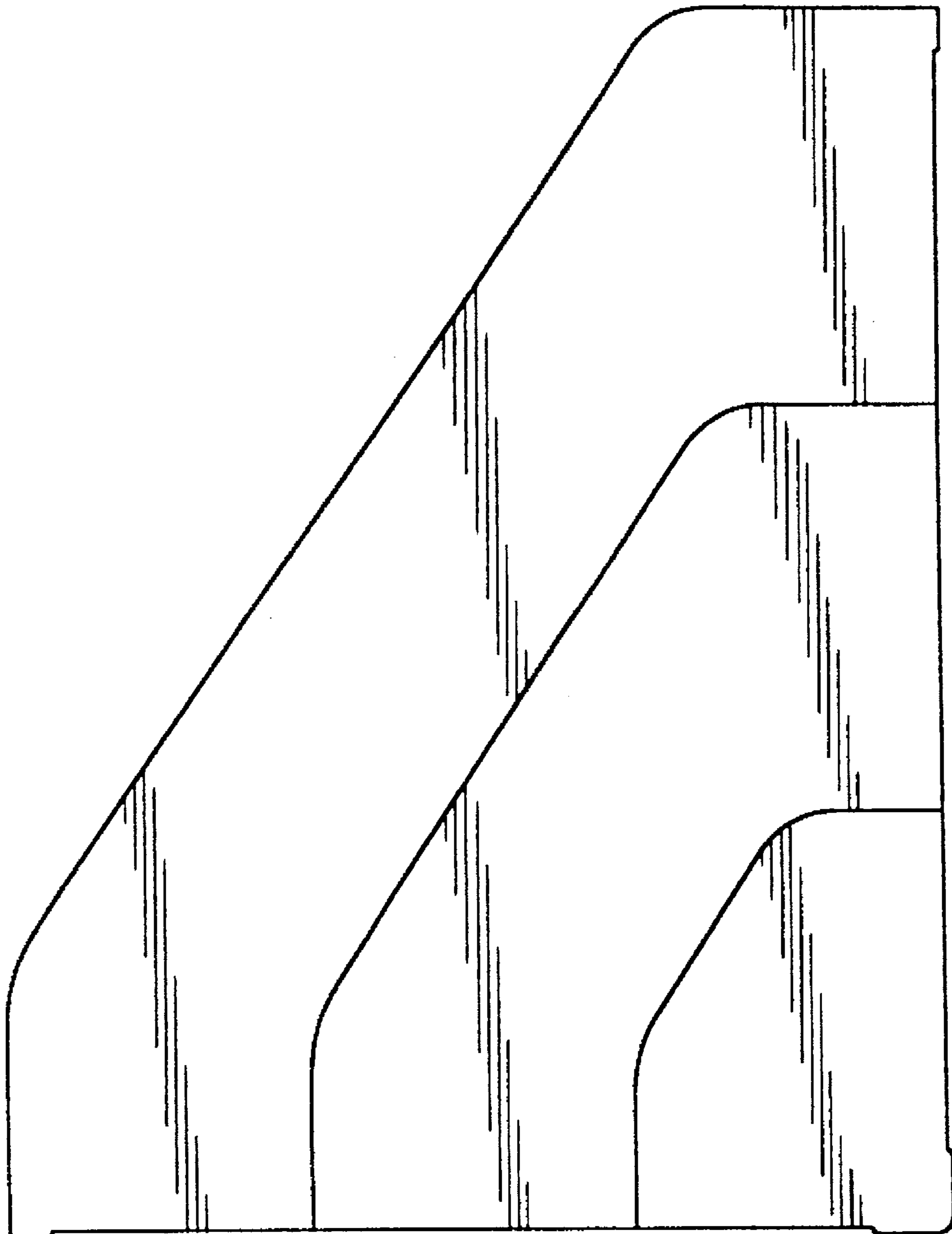

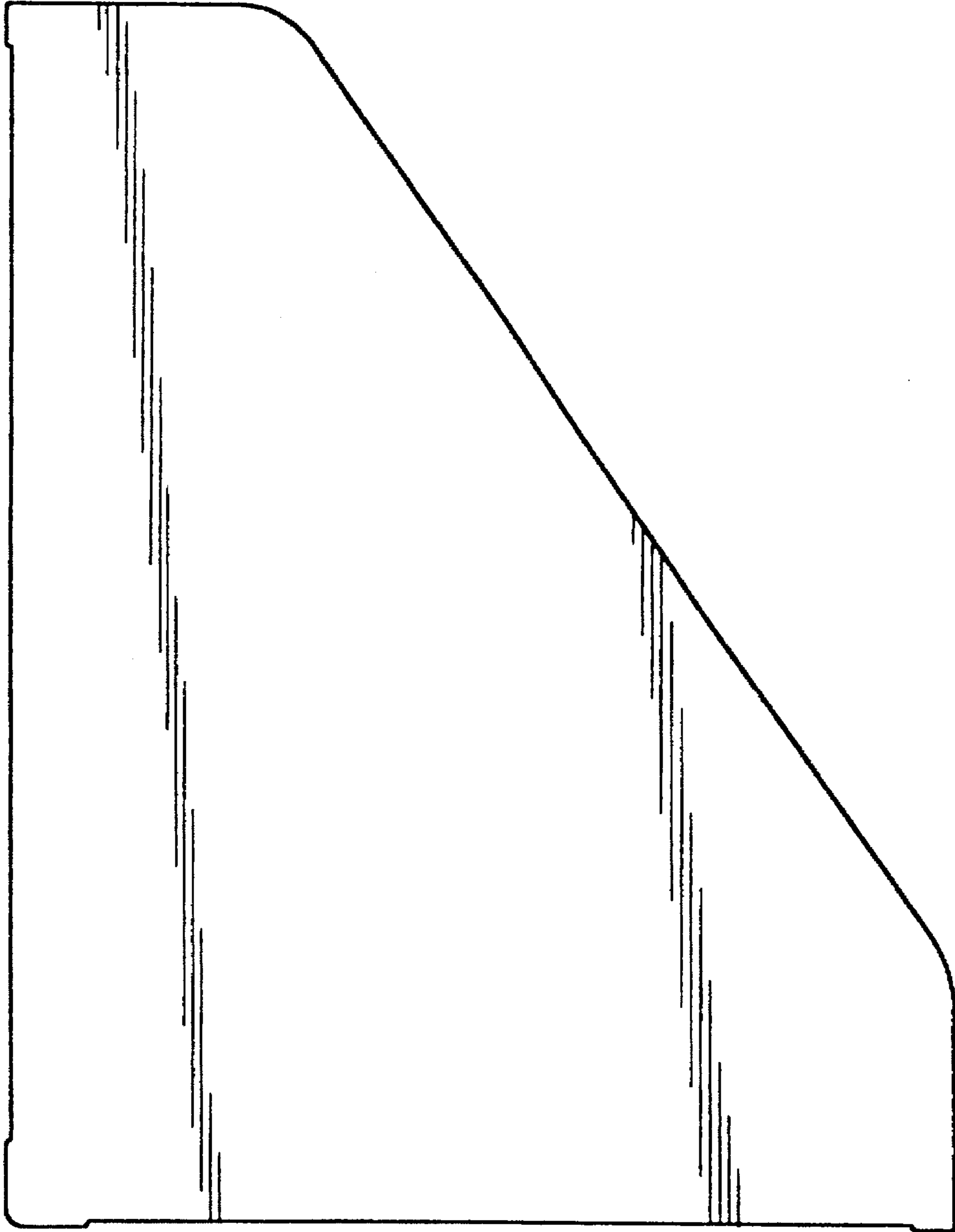

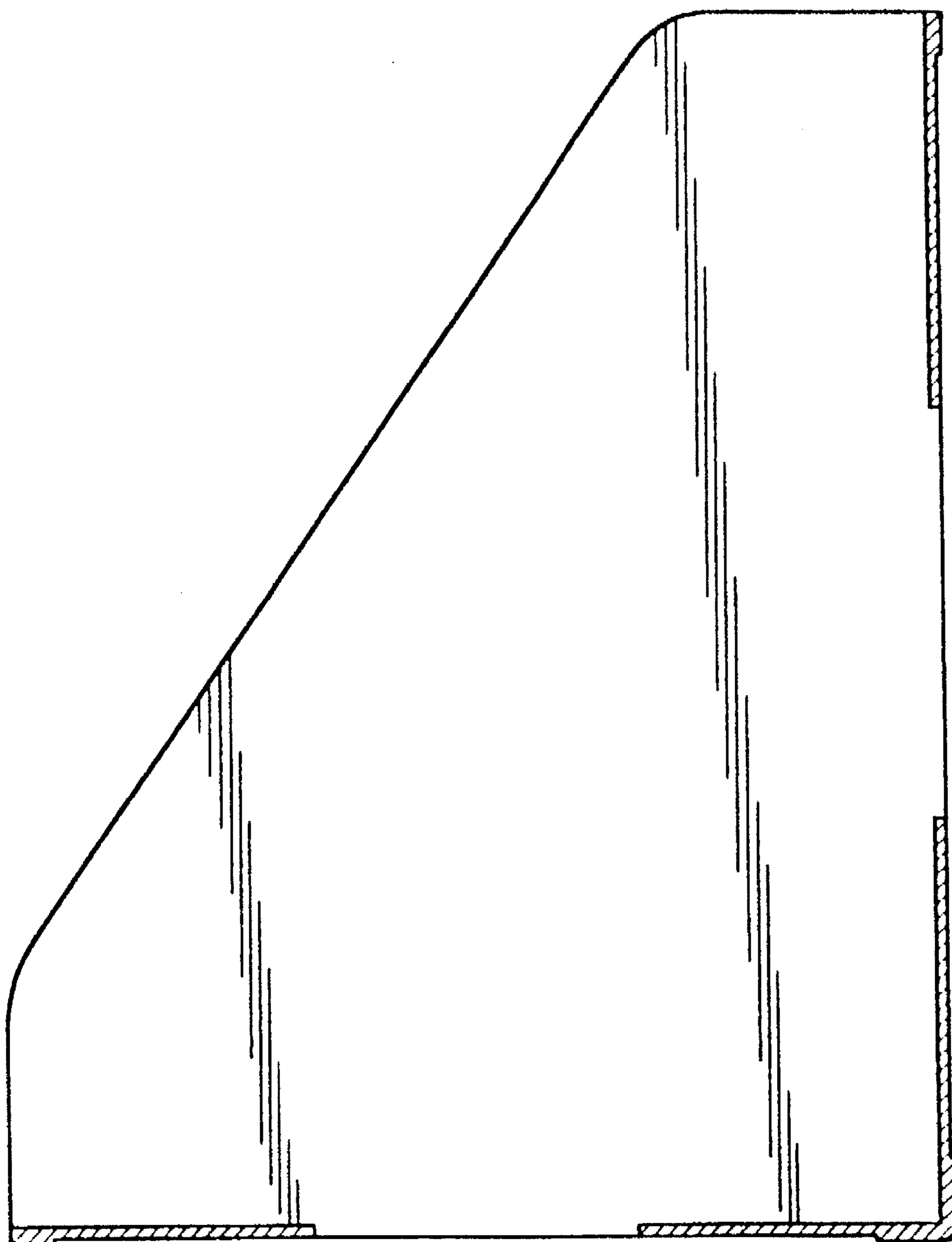
