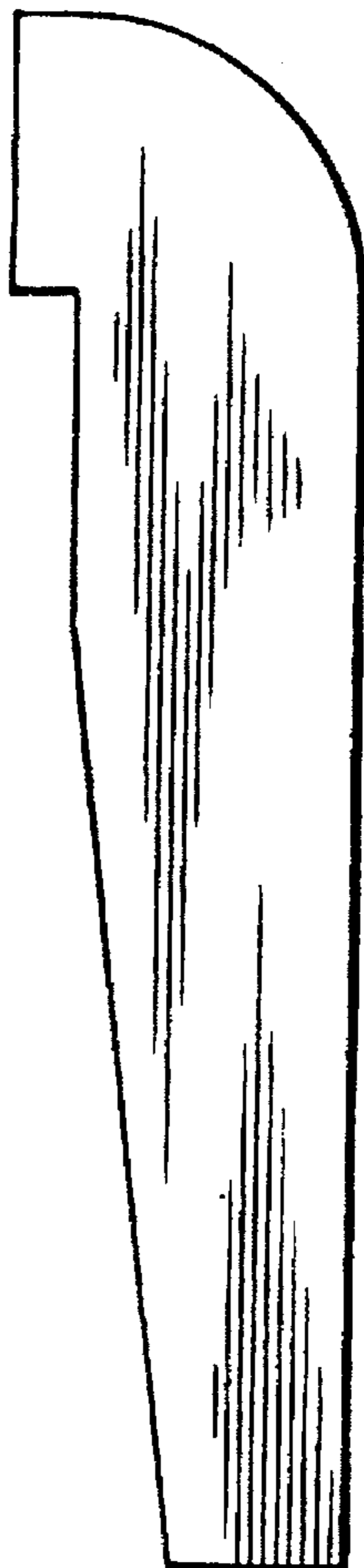
[57] **CLAIM**

The ornamental design of a splash pad, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a splash pad in accordance with my design;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a front elevational view thereof;  
 FIG. 5 is a side elevational view as viewed from the left side of FIG. 1; and,  
 FIG. 6 is a side elevational view as viewed from the right side of FIG. 1.

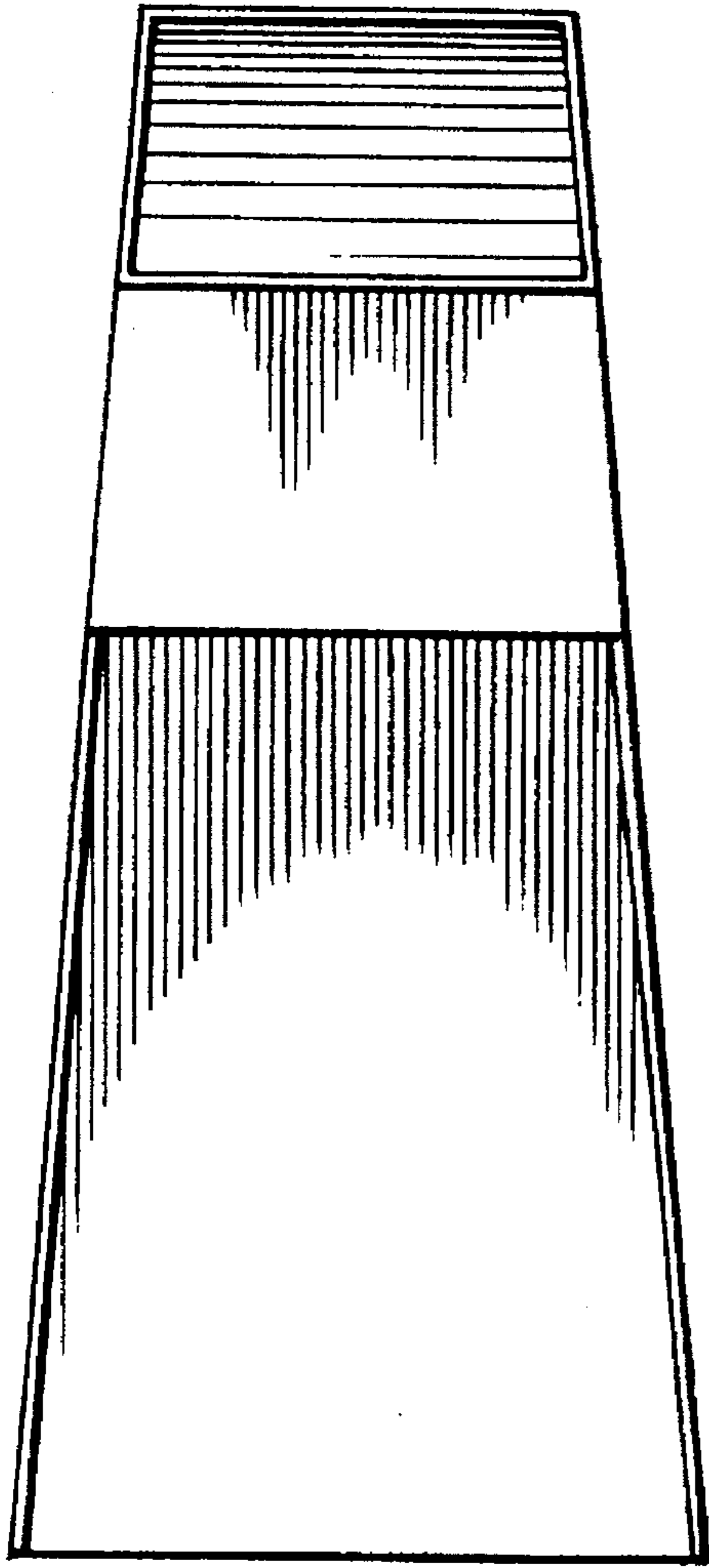

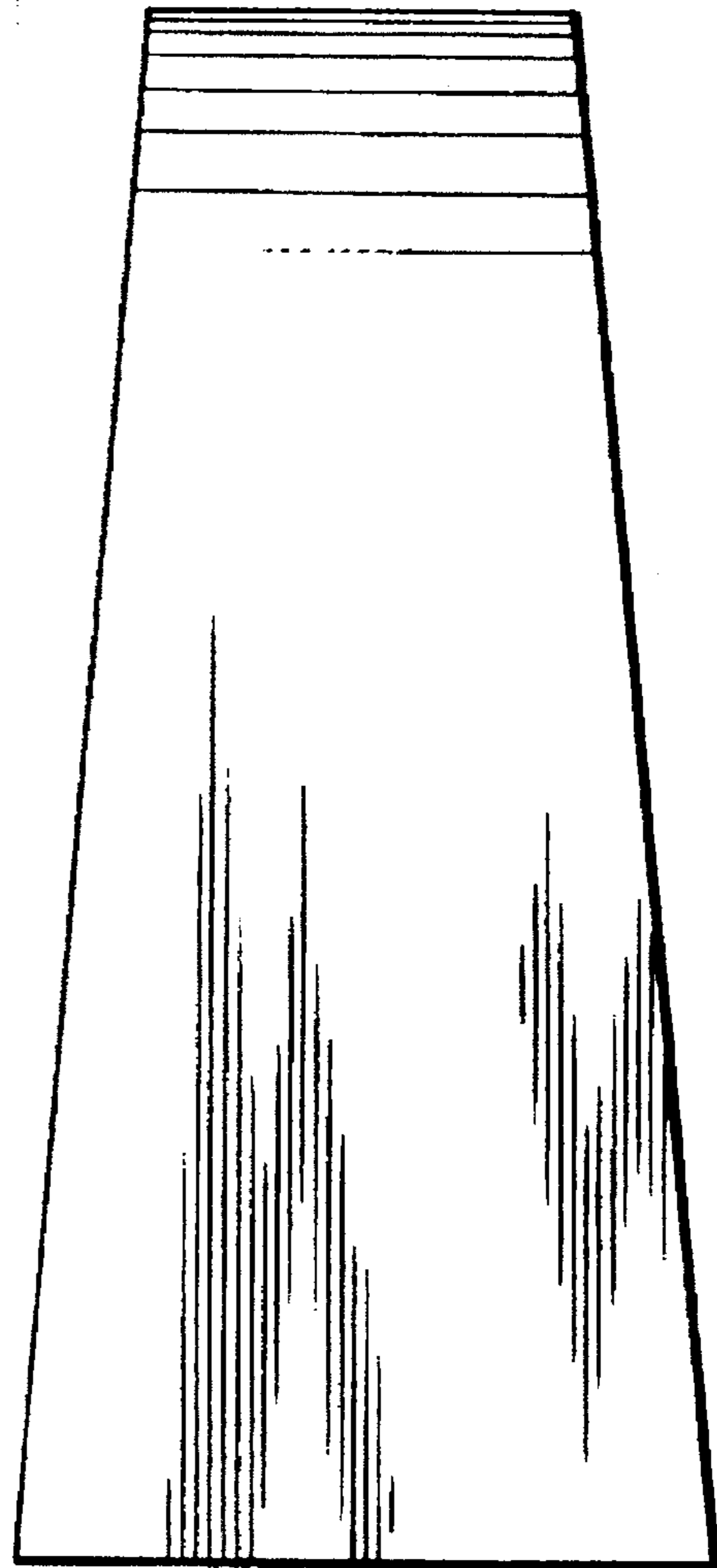

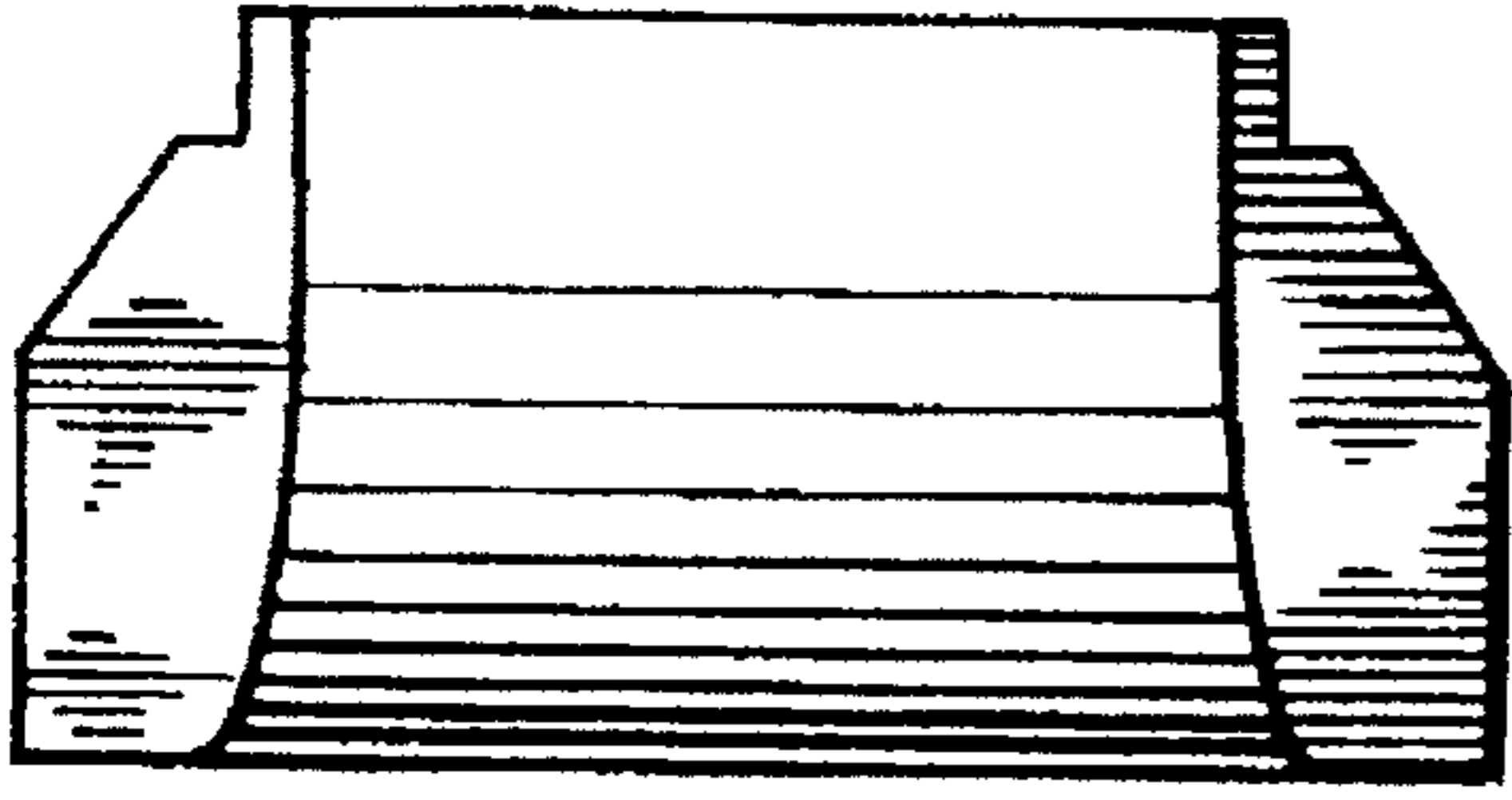

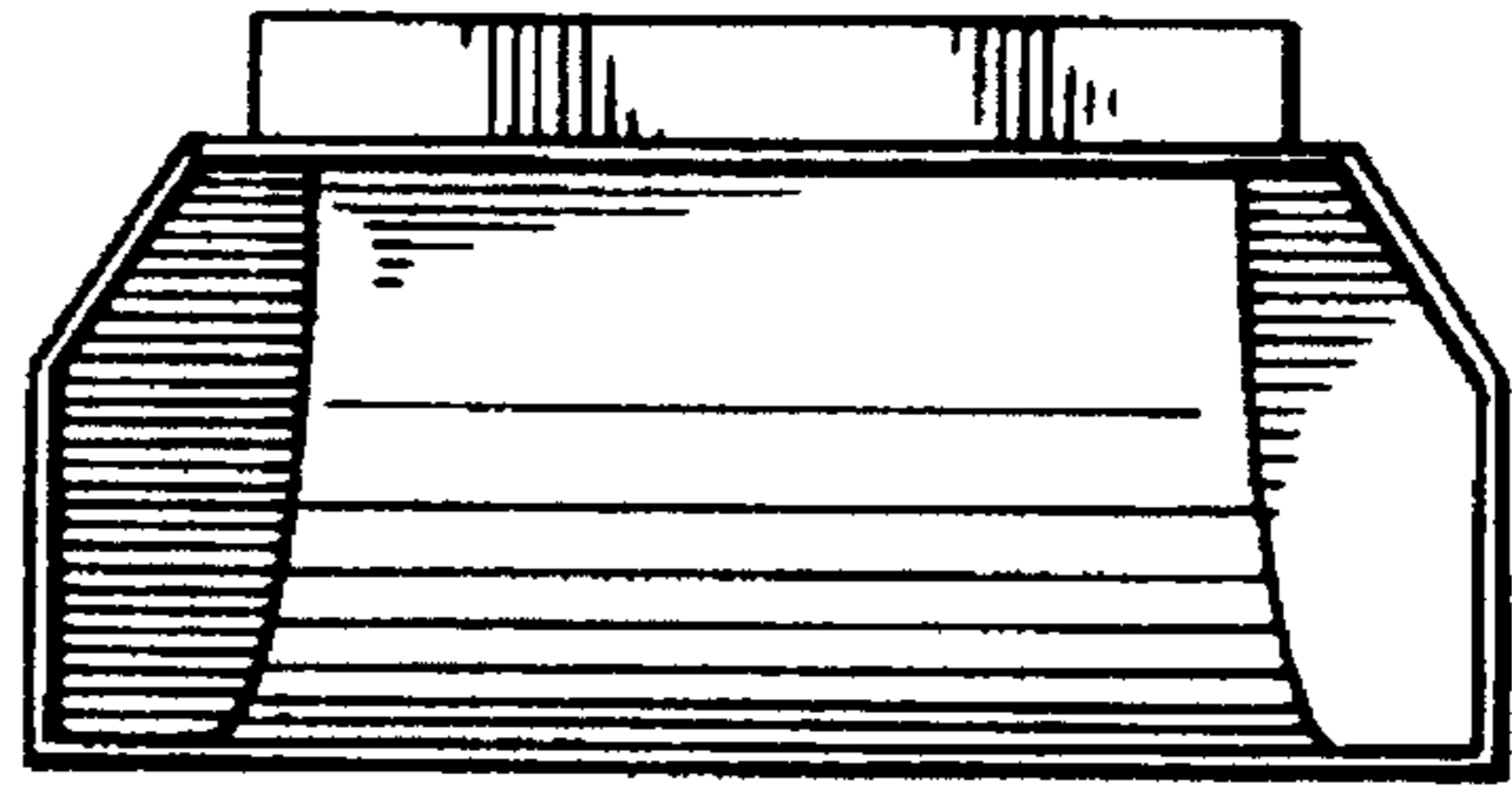

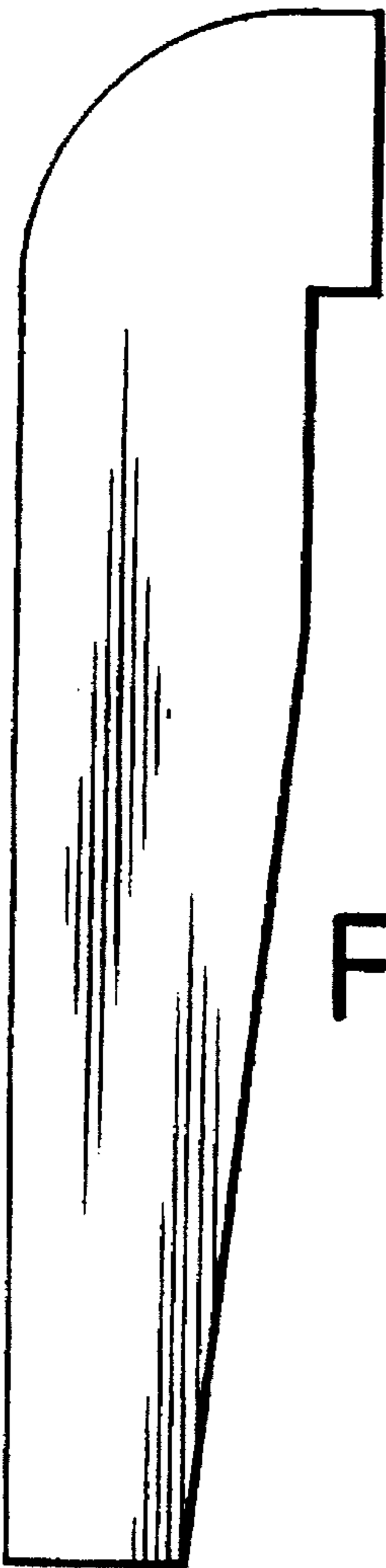

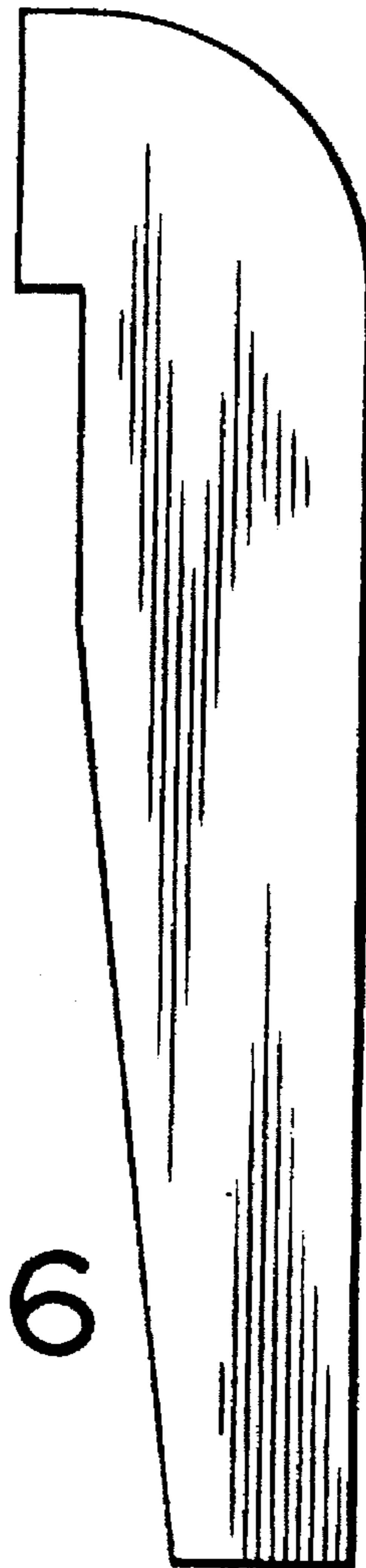
