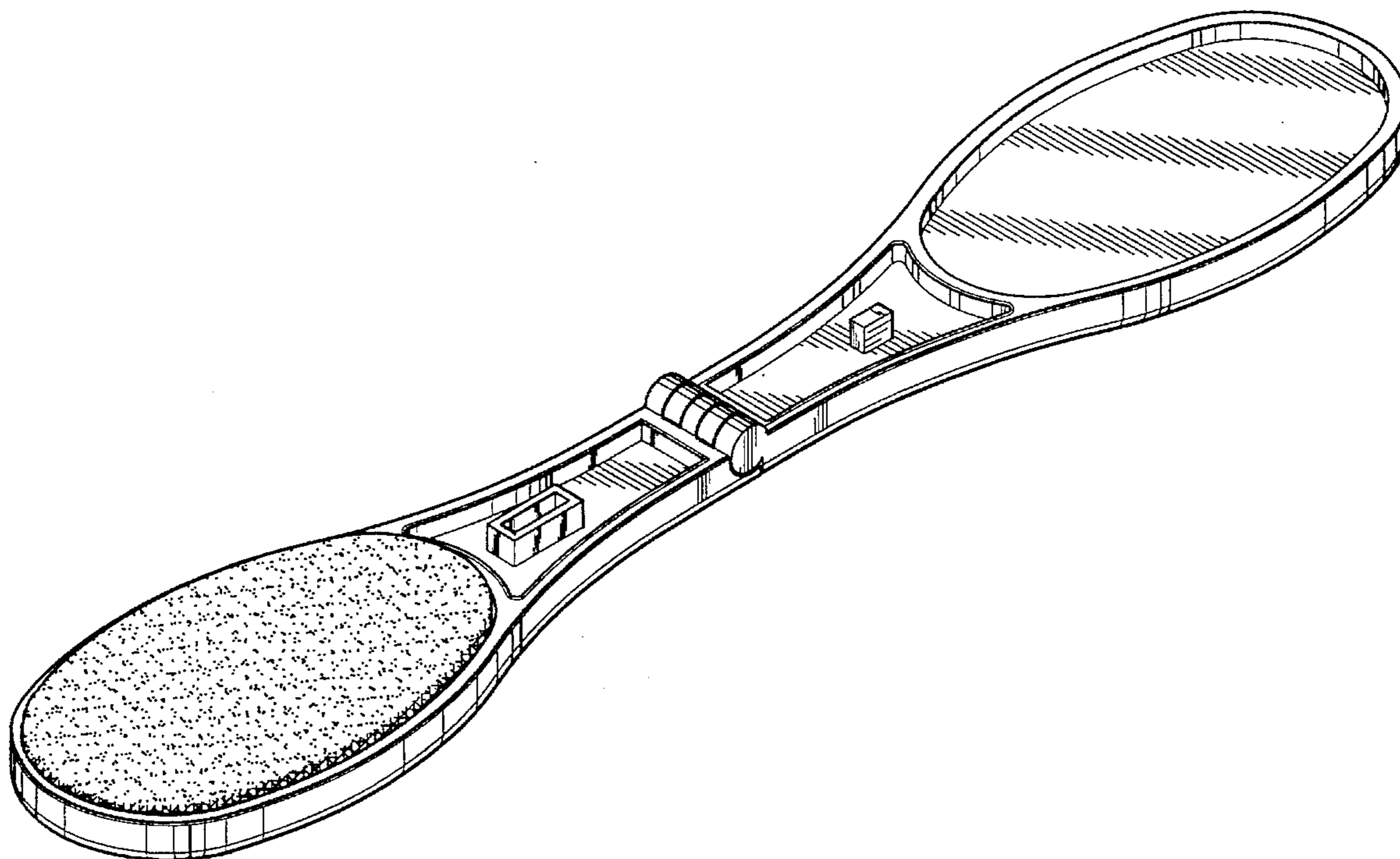

[57] **CLAIM**
The ornamental design for a lotion applicator, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a lotion applicator in an open position showing my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a left side elevational view with the right side being a mirror image thereof;
FIG. 5 is a front end elevational view thereof; and,
FIG. 6 is a rear end elevational view thereof;
FIG. 7 is a perspective view of the lotion applicator in a closed position; and,
FIG. 8 is an environmental perspective view of the lotion applicator in an open position.
The broken lines showing an oval outline, indicia and human form in FIGS. 3, 7 and 8 are for illustrative purposes only and form no part of the claimed design.

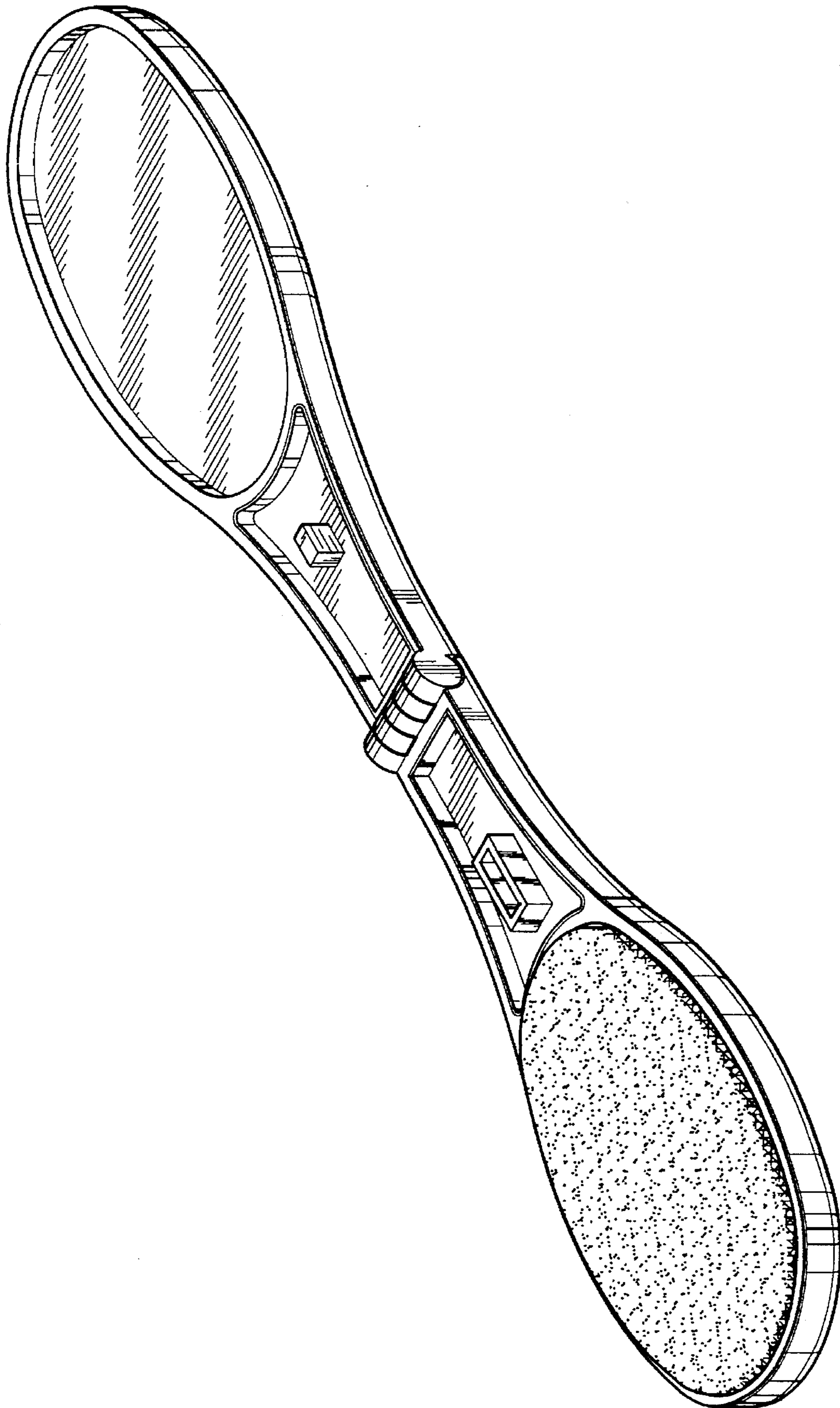

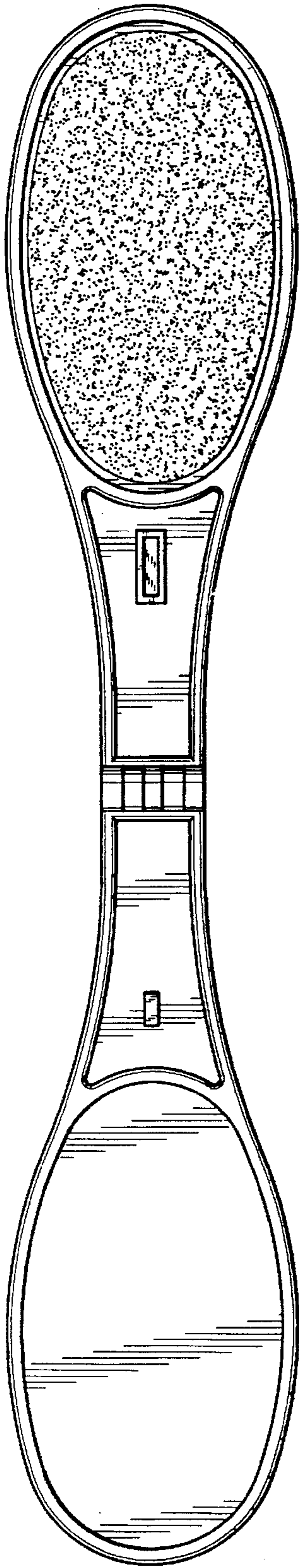

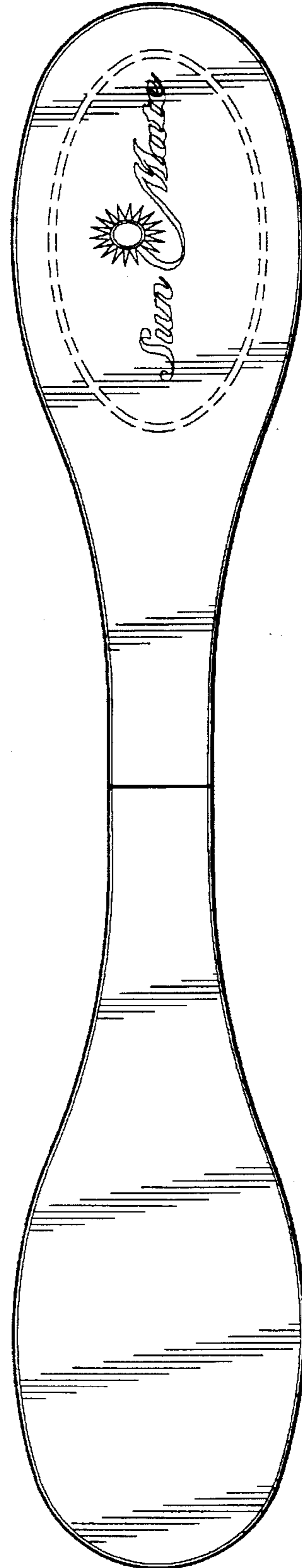

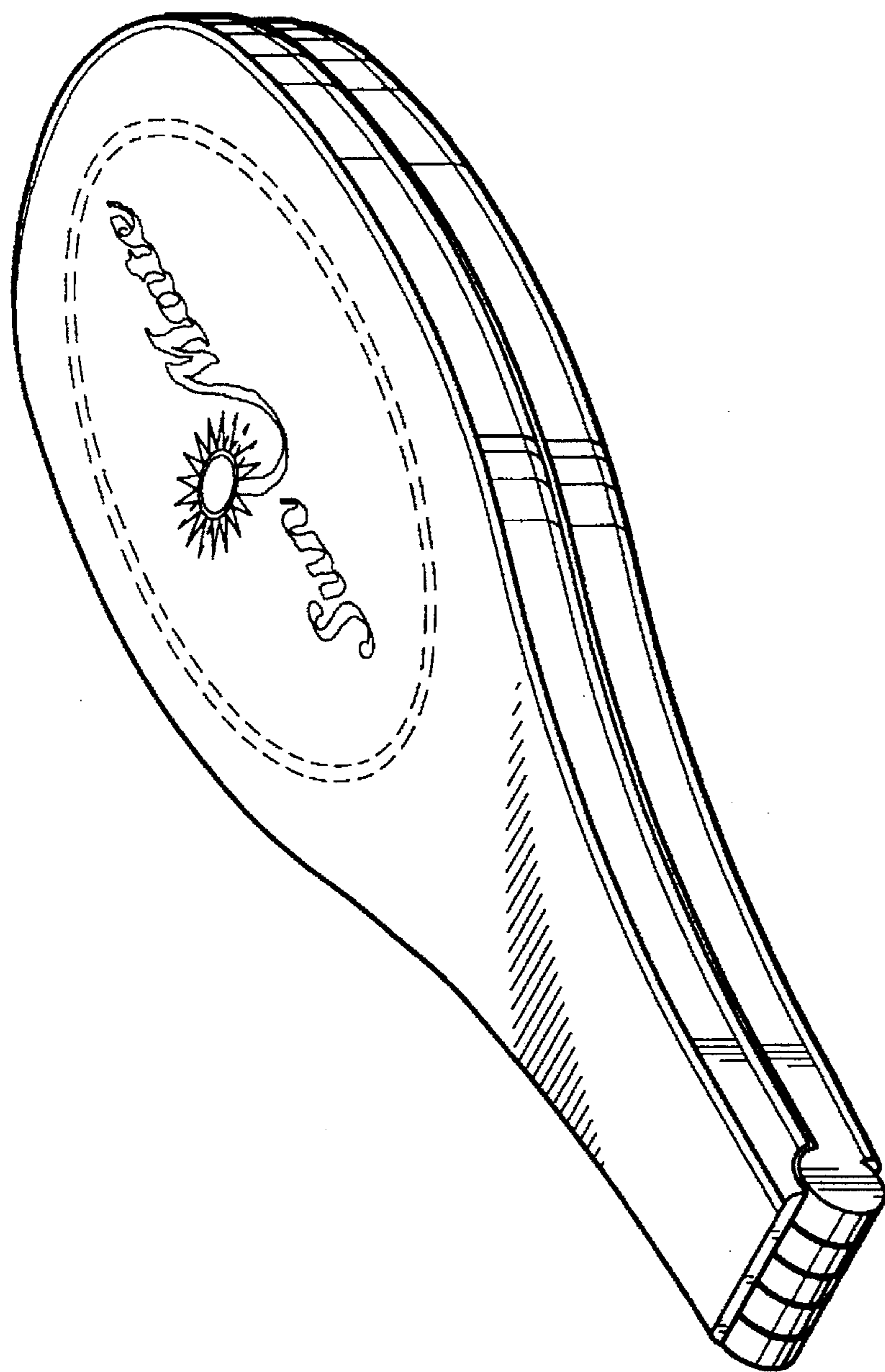
