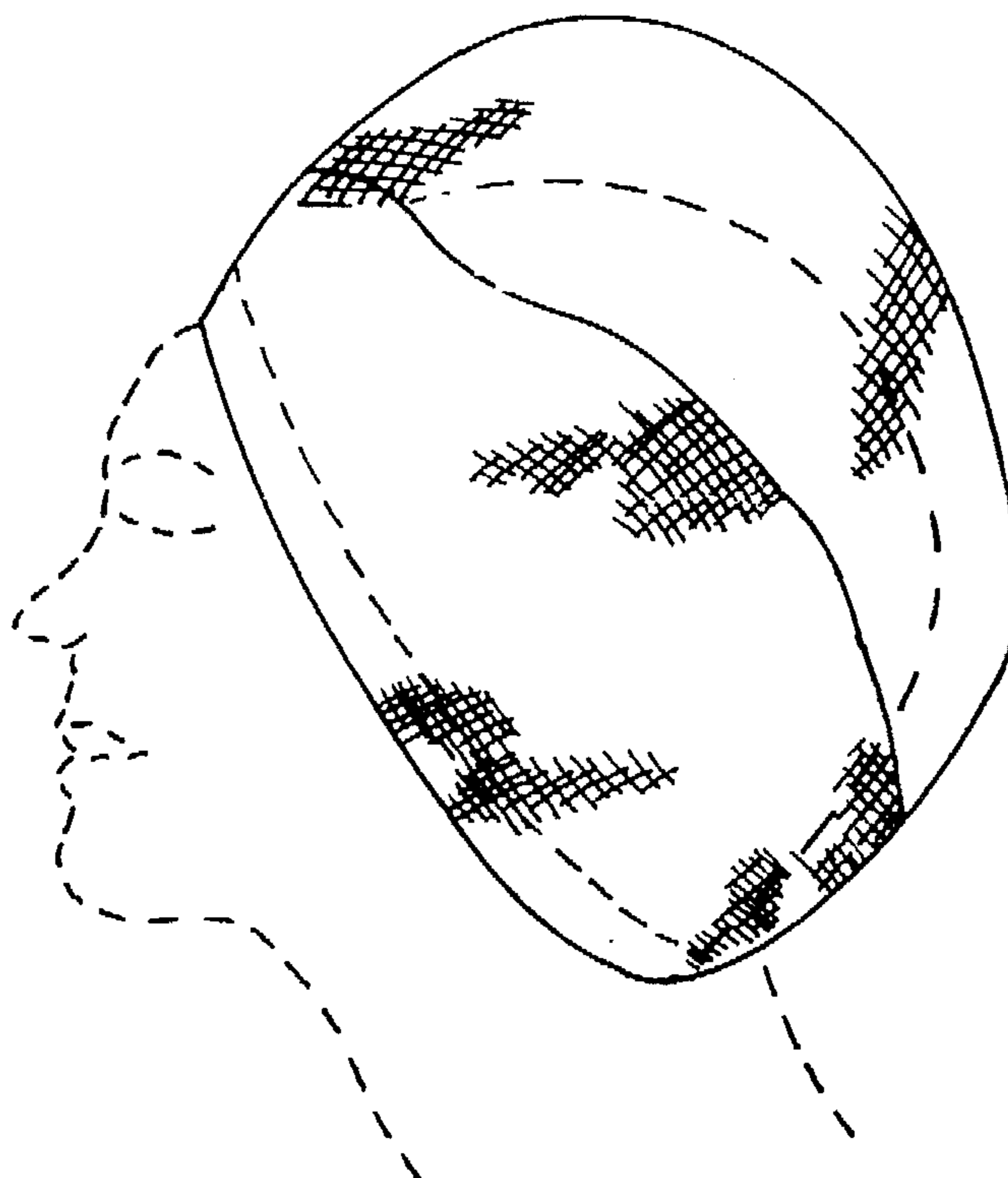
### [57] CLAIM

The ornamental design for a head wrap, as shown and described.

#### DESCRIPTION

FIG. 1 is a front perspective view of a head wrap showing my new design, the broken line showing of the human form is for illustrative purposes only and forms no part of the claimed design;  
FIG. 2 is a left side elevational view thereof, the dashed lines on the head wrap represent conventional stitching;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a top plan view thereof.

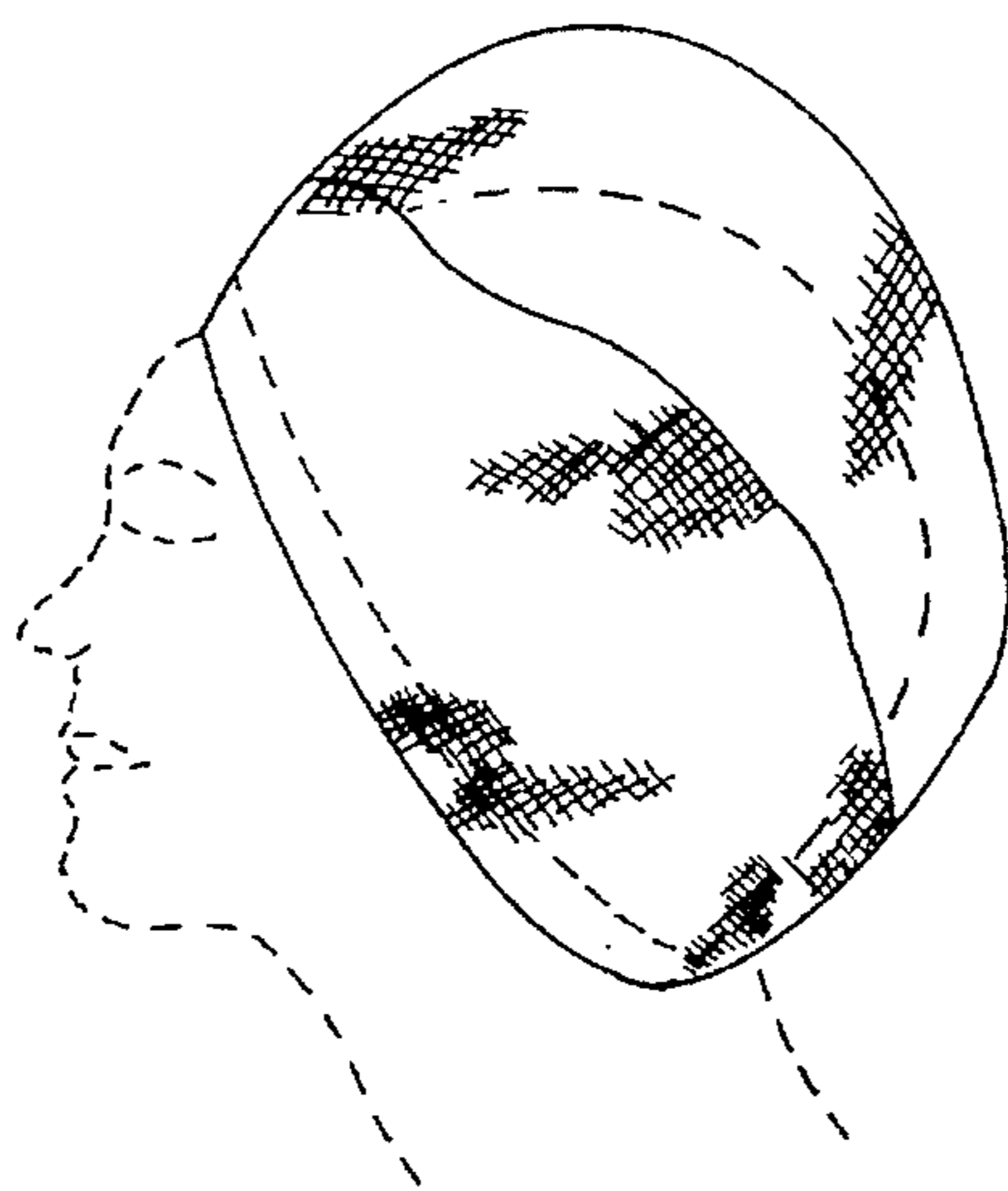

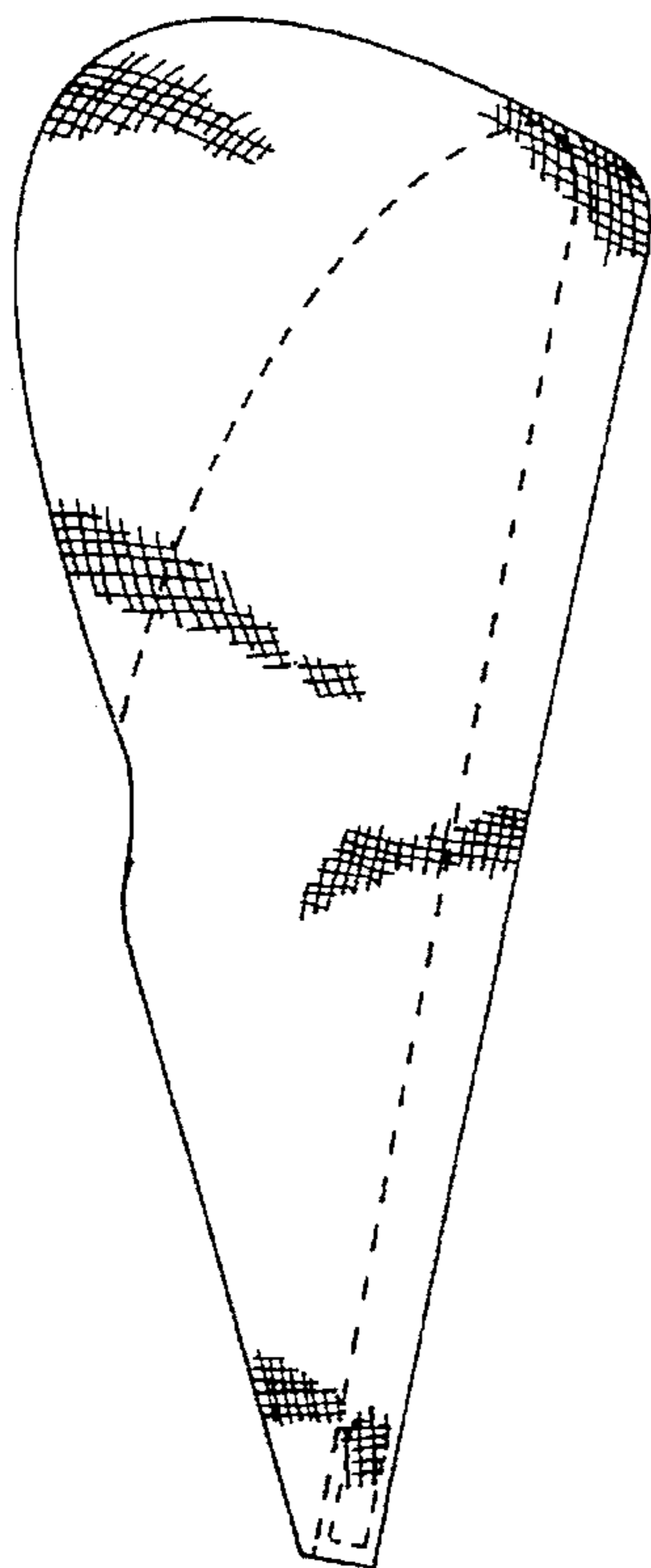

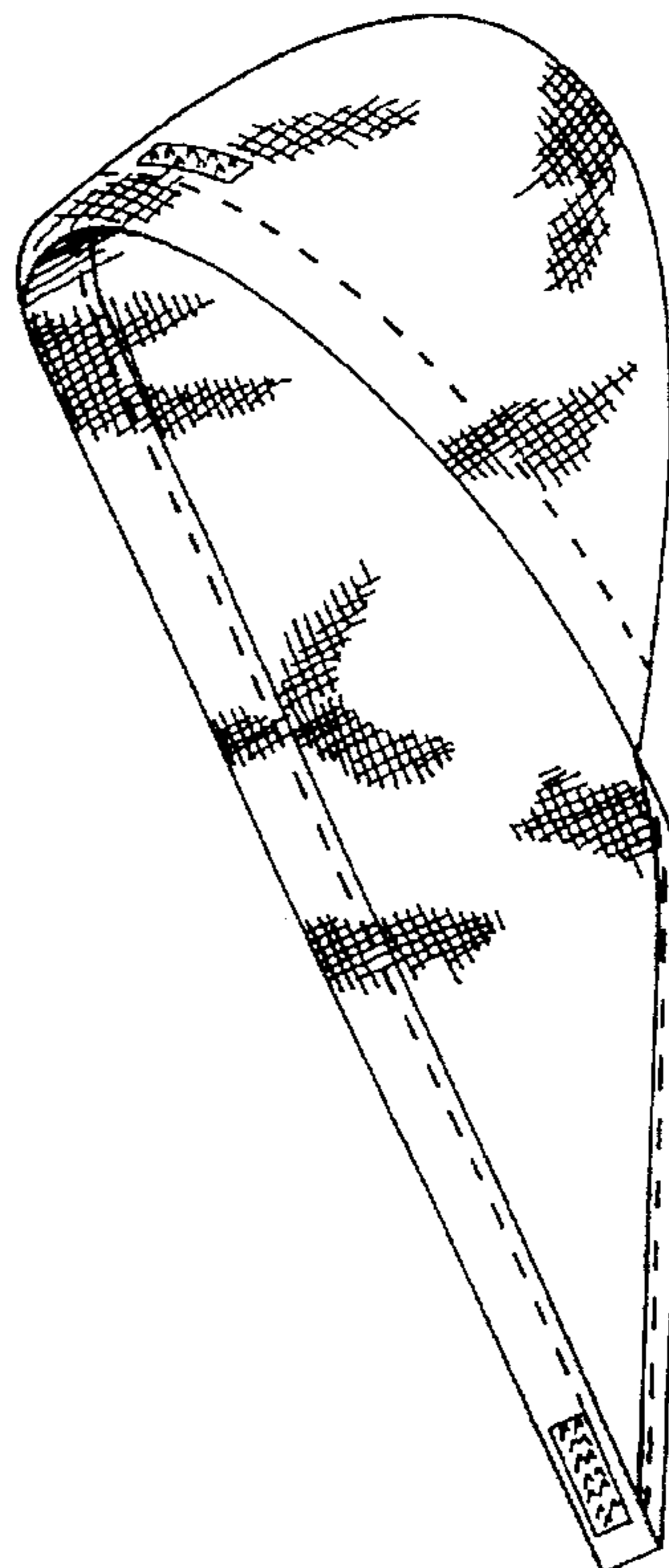

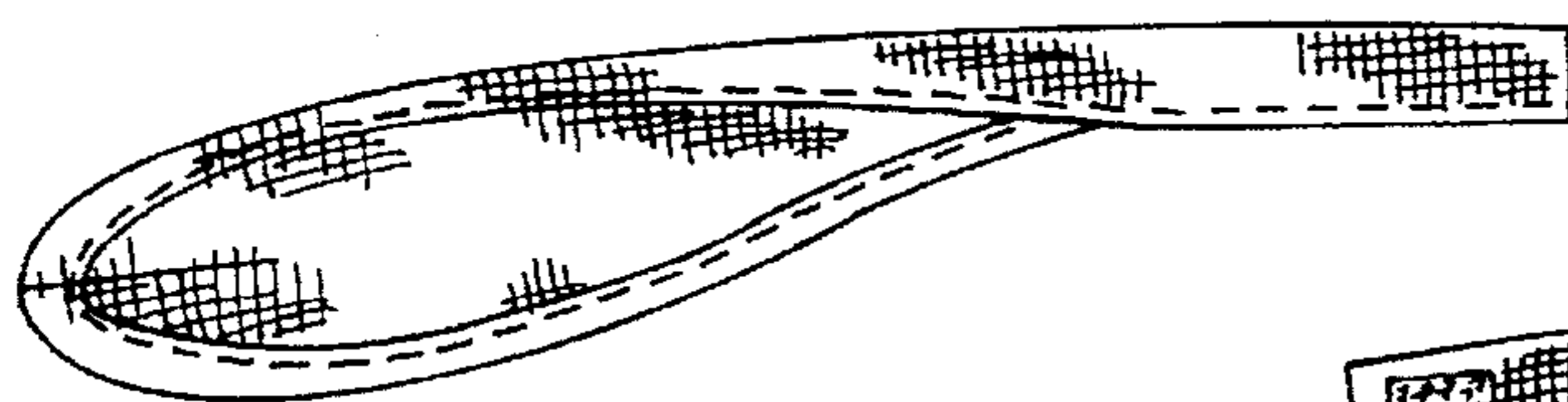

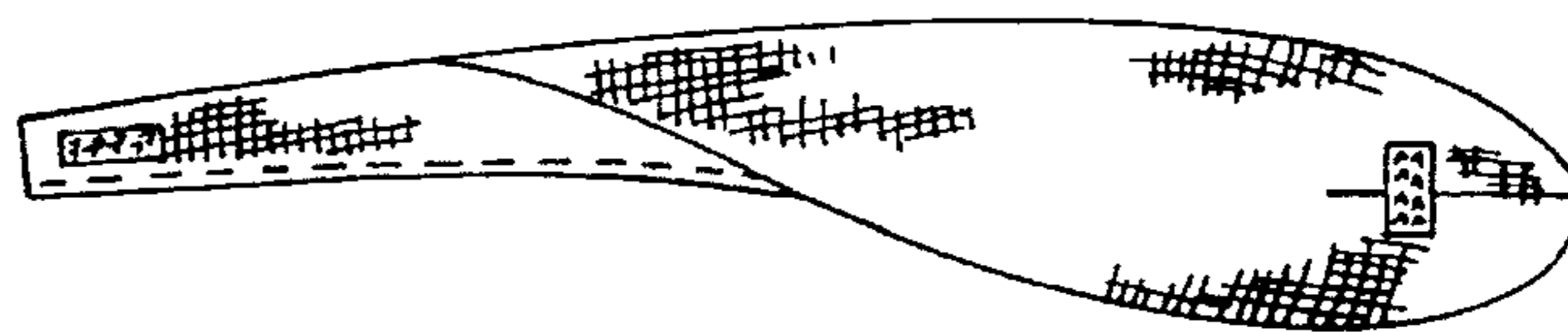
