[57] CLAIM

The ornamental design for a floor product sample frame, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a floor product sample frame showing a first embodiment of our new design;

FIG. 2 is a front elevational view of the floor product sample frame of FIG. 1, the rear view being a mirror image thereof;

FIG. 3 is a right side elevational view of the floor product sample frame of FIG. 1;

FIG. 4 is a left side elevational view of the floor product sample frame of FIG. 1; and

FIG. 5 is a top side elevational view of the floor product sample frame of FIG. 1, the bottom view being a mirror image thereof;

FIG. 6 is a top, front, and right side perspective view of a floor product sample frame showing a second embodiment of our new design;

FIG. 7 is a front elevational view of the floor product sample frame of FIG. 6, the rear view being a mirror image thereof;

FIG. 8 is a right side elevational view of the floor product sample frame of FIG. 6;

FIG. 9 is a left side elevational view of the floor product sample frame of FIG. 6; and,

FIG. 10 is a top side elevational view of the floor product sample frame of FIG. 6, the bottom view being a mirror image thereof.

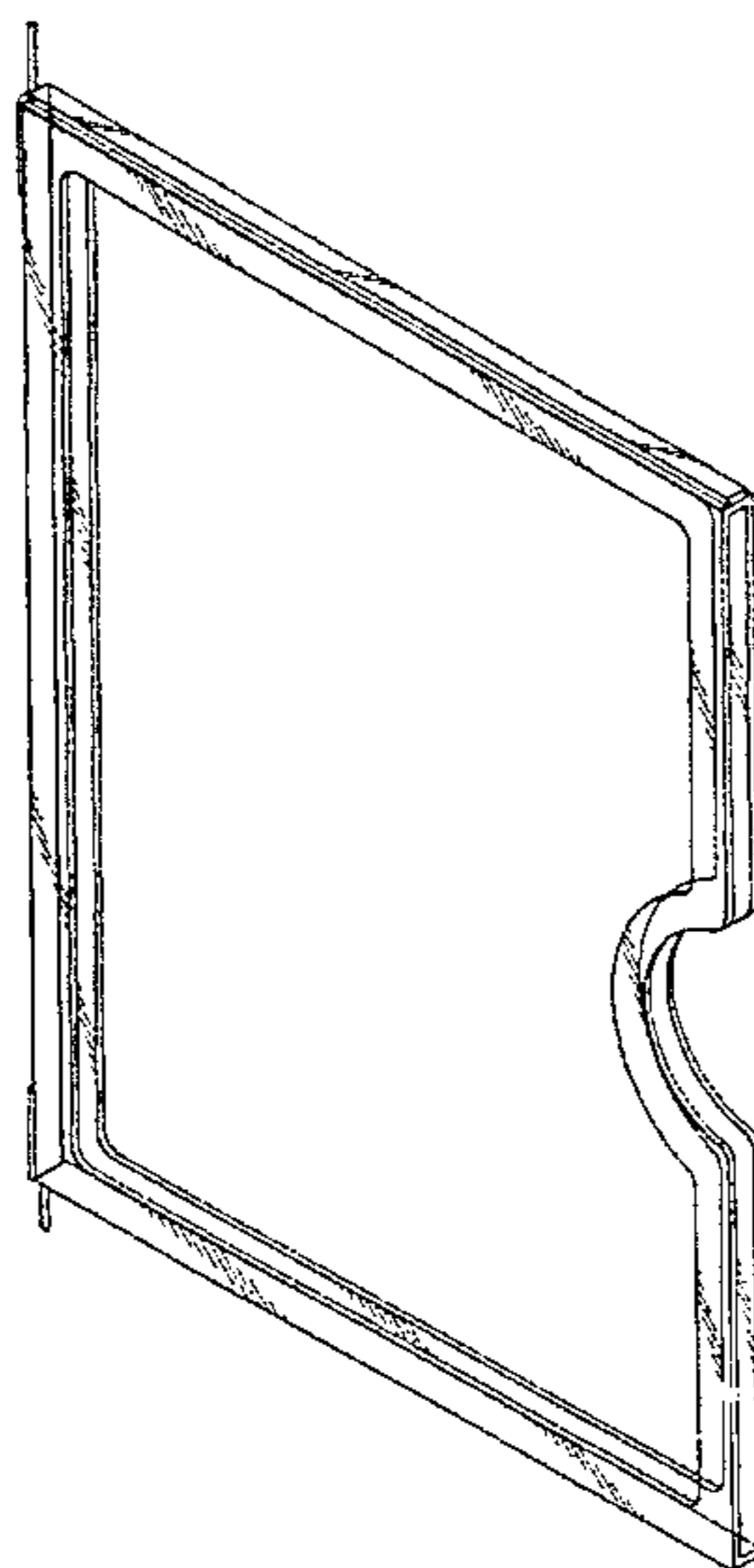

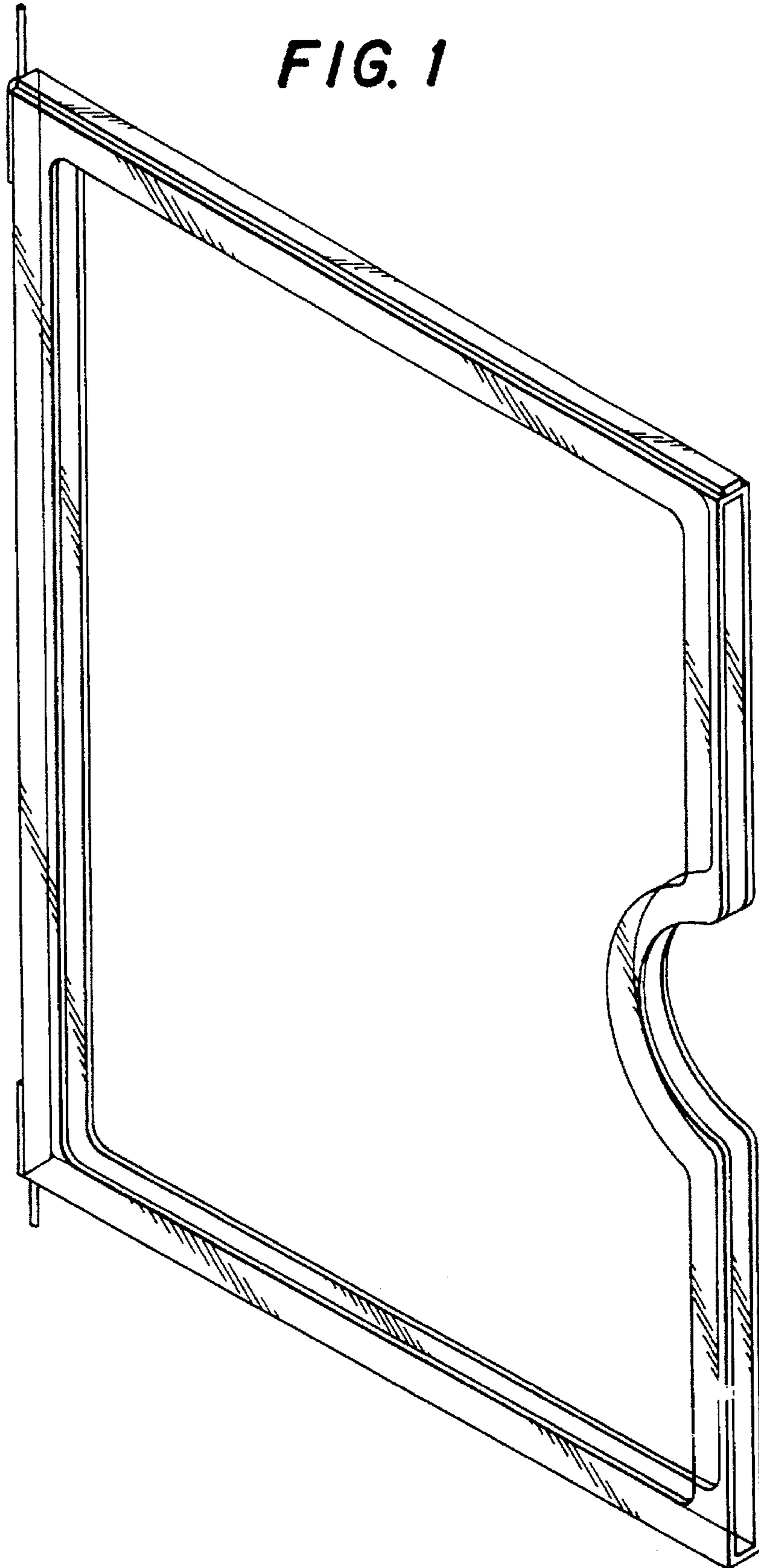

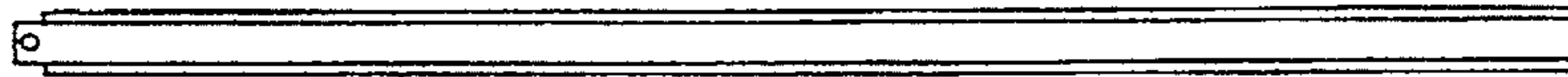

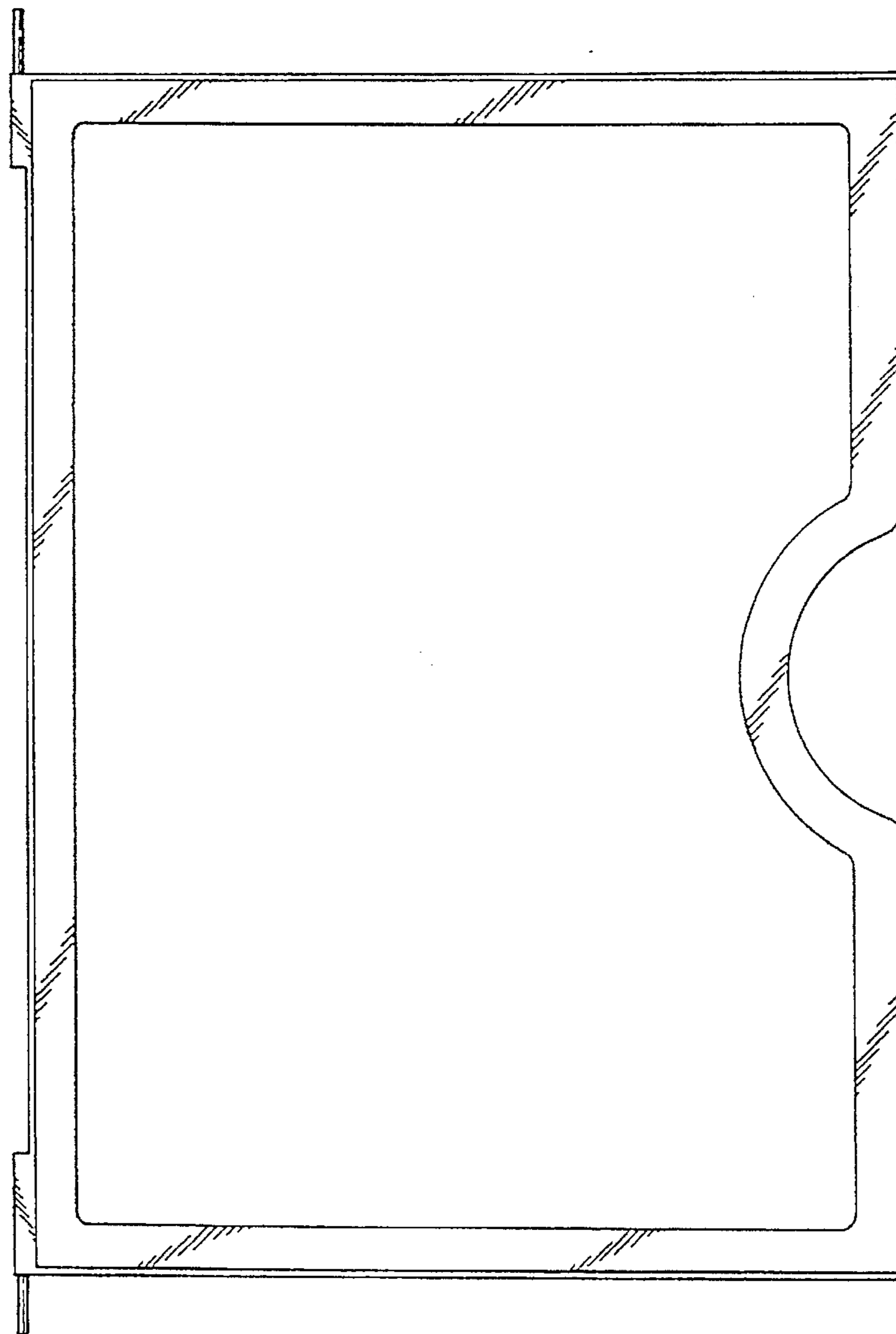

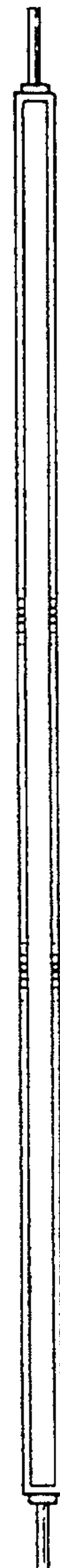

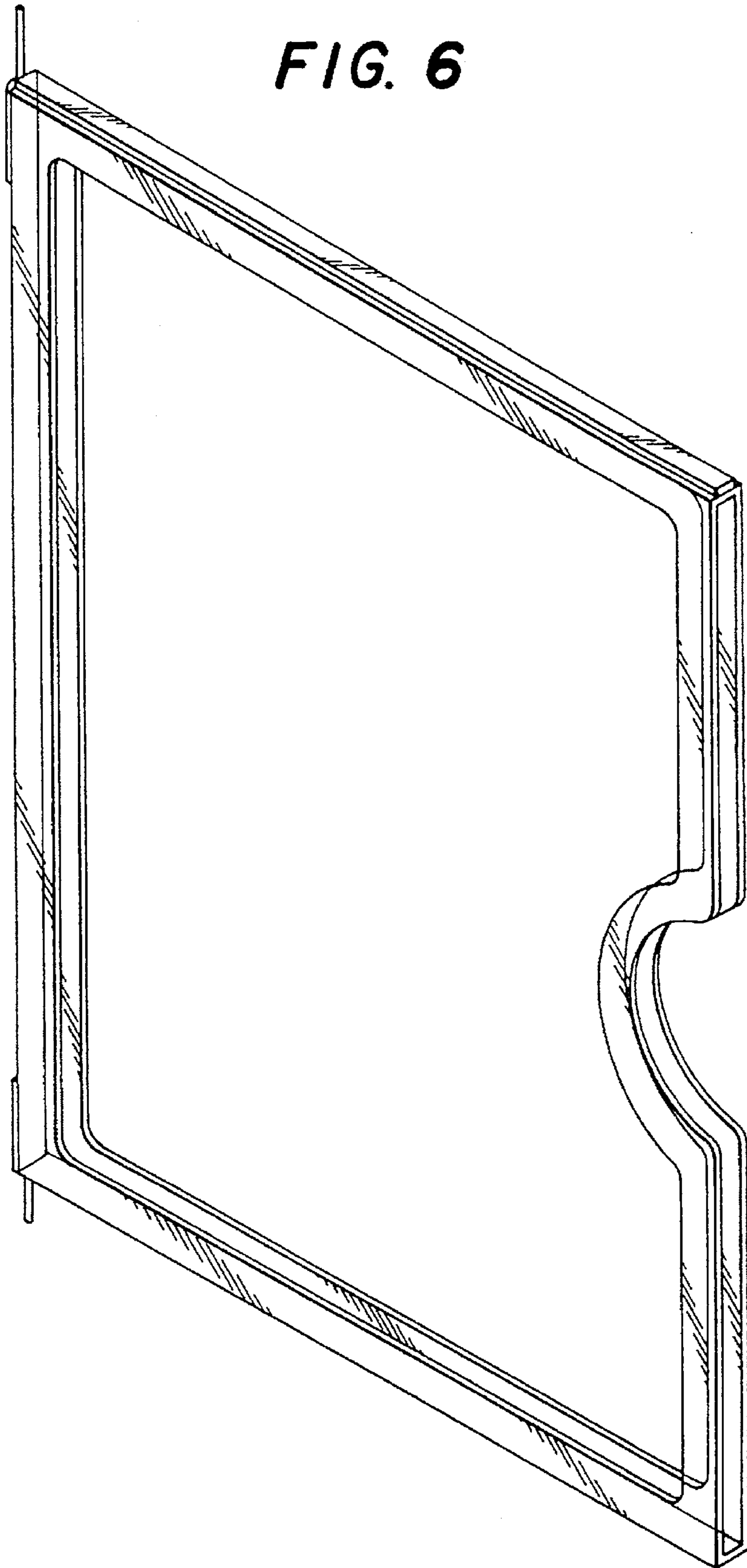

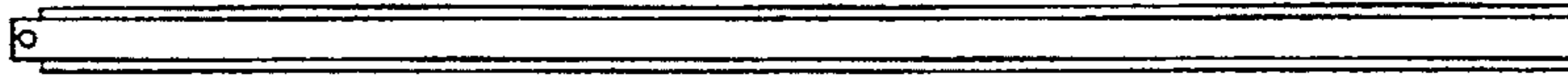

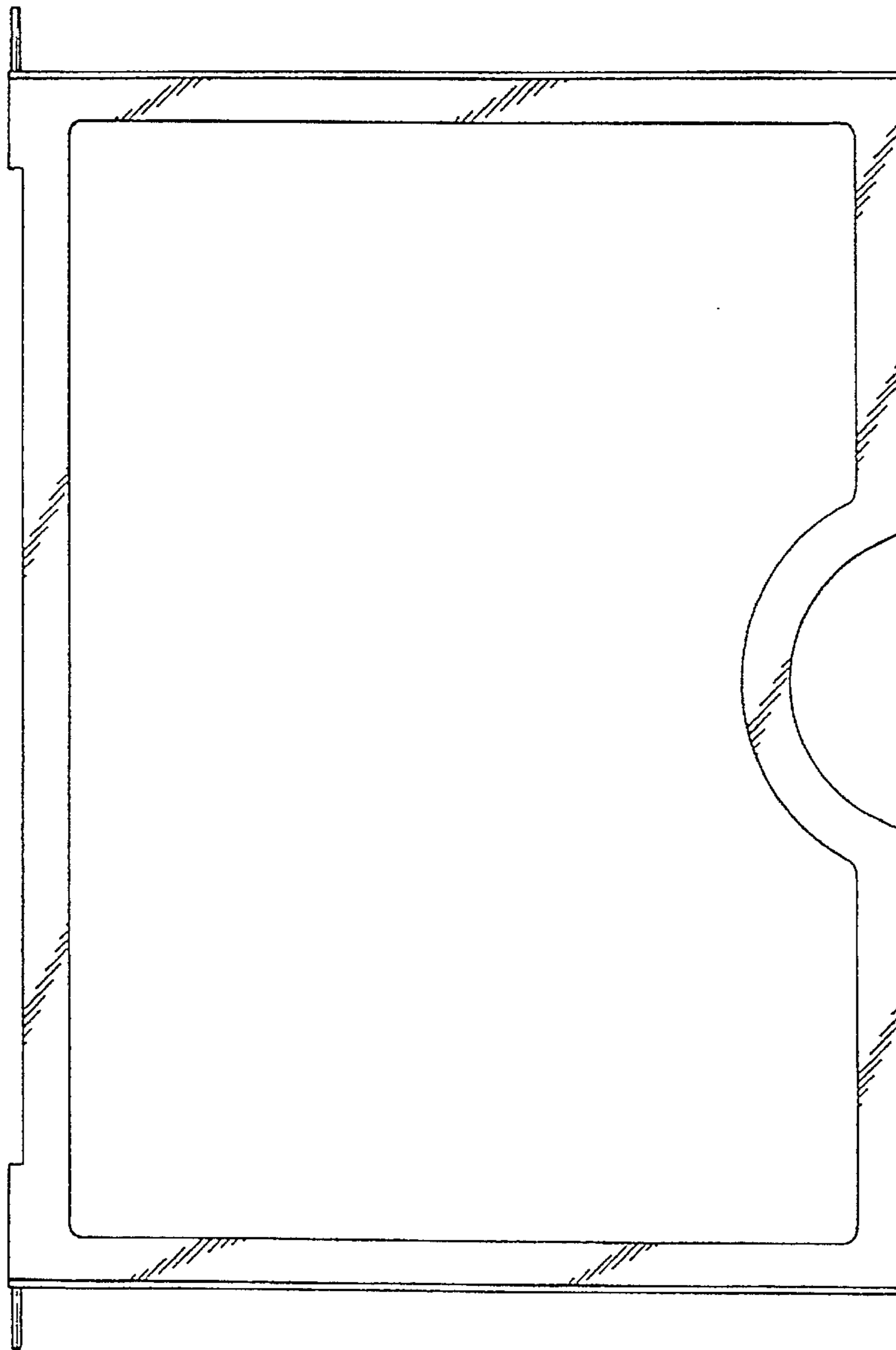
