### DESCRIPTION

FIG. 4 is a bottom plan view thereof; and,

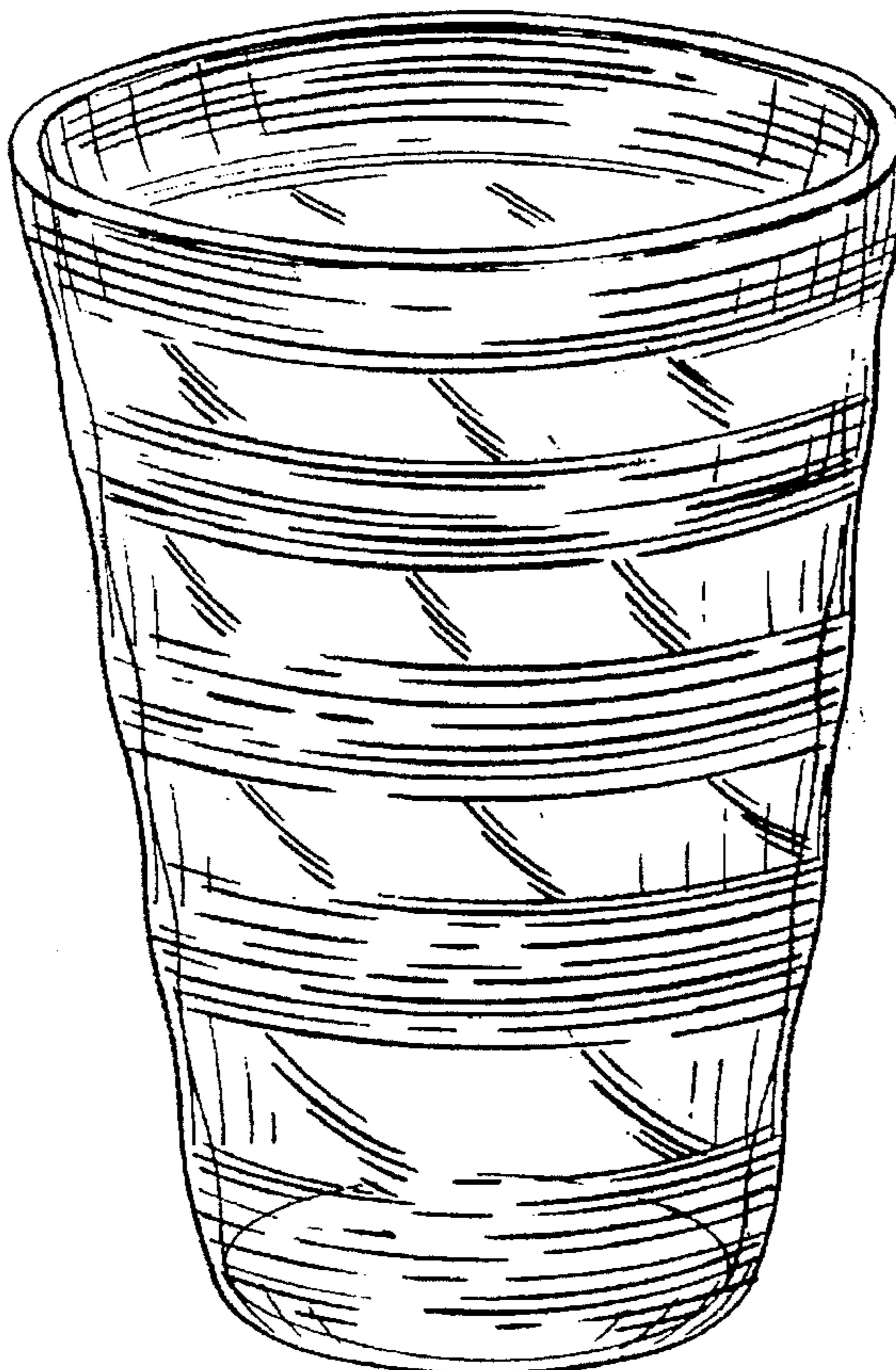
FIG. 5 is a cross-section thereof taken on line 5—5 in FIG. 3.

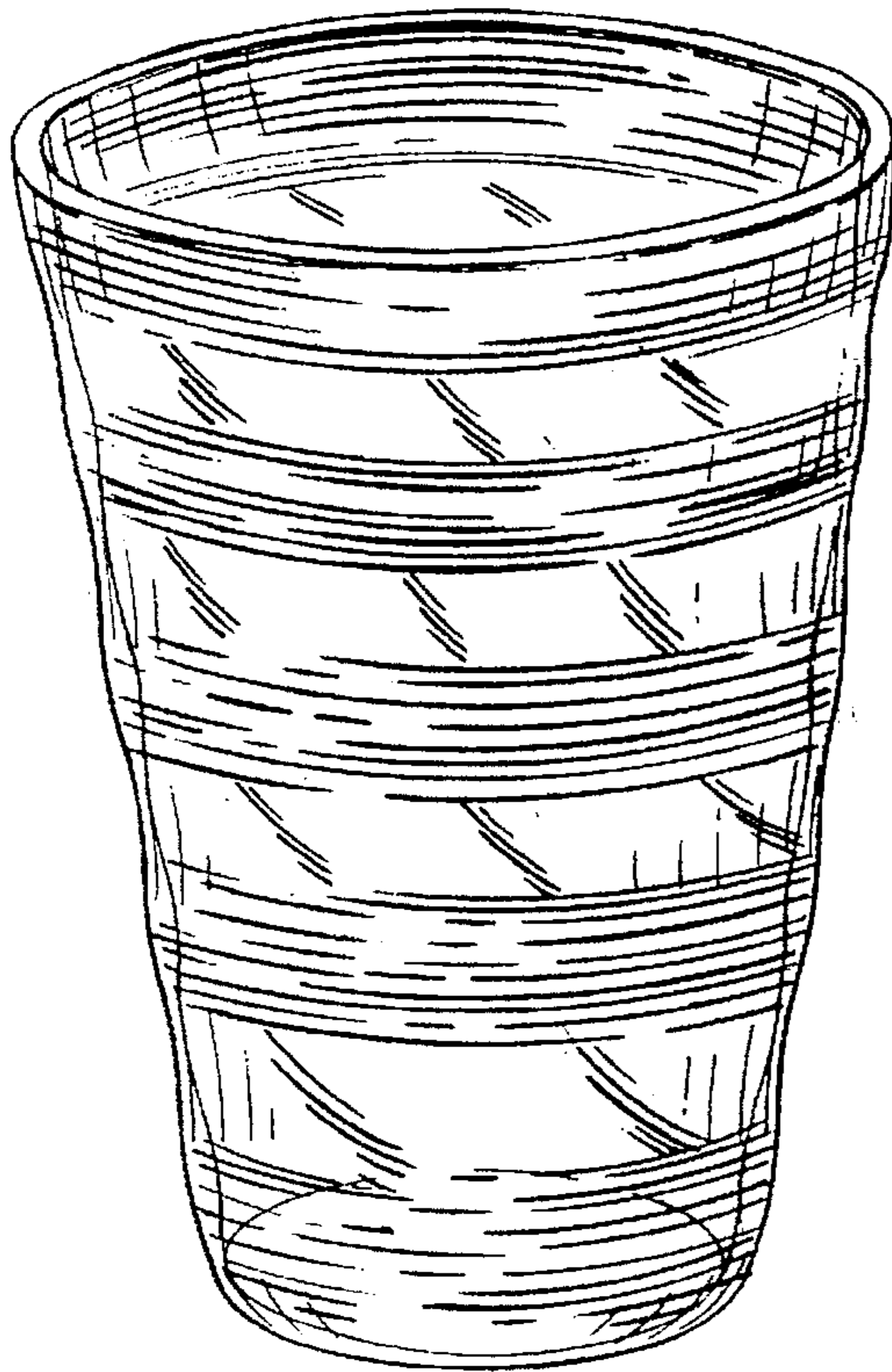

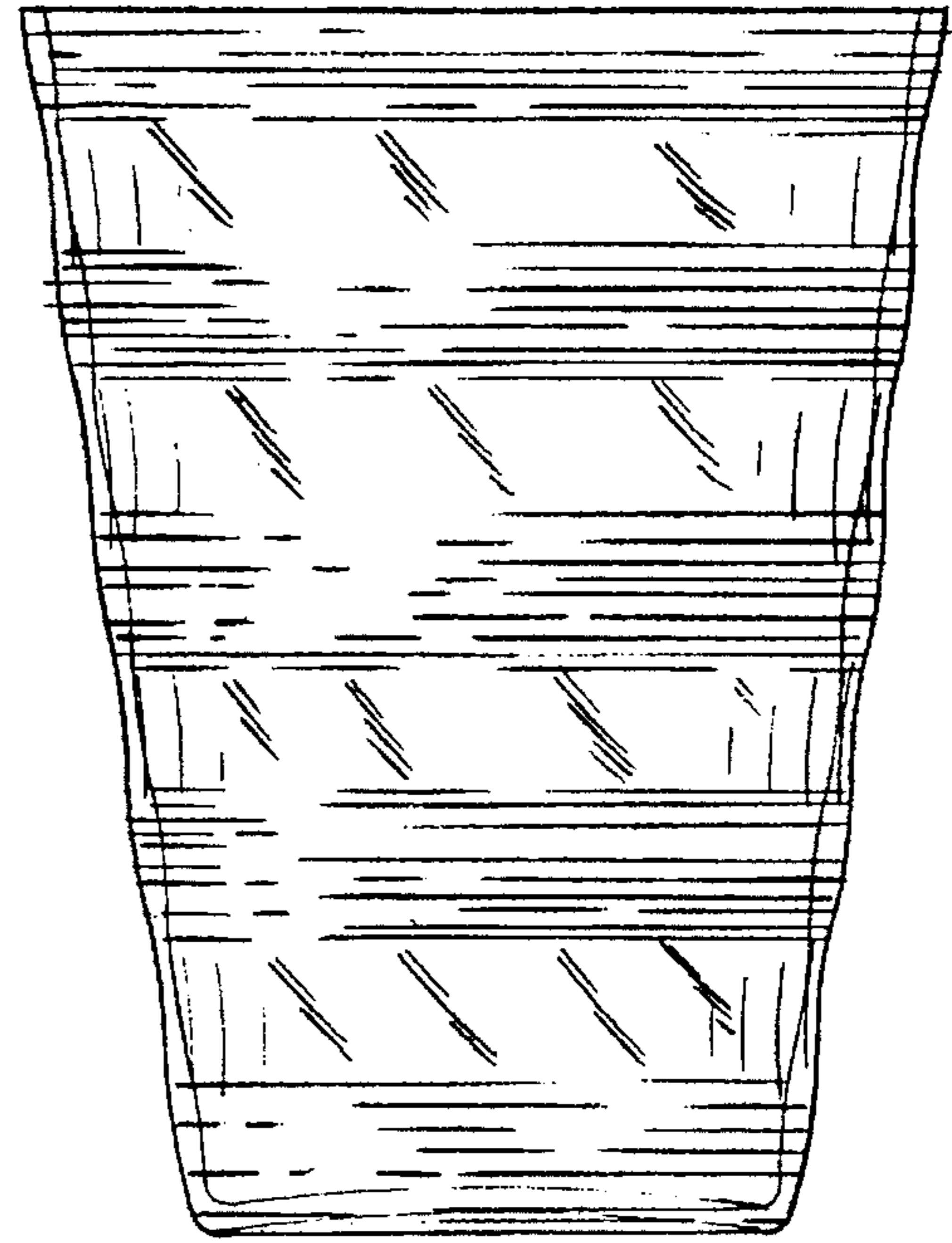

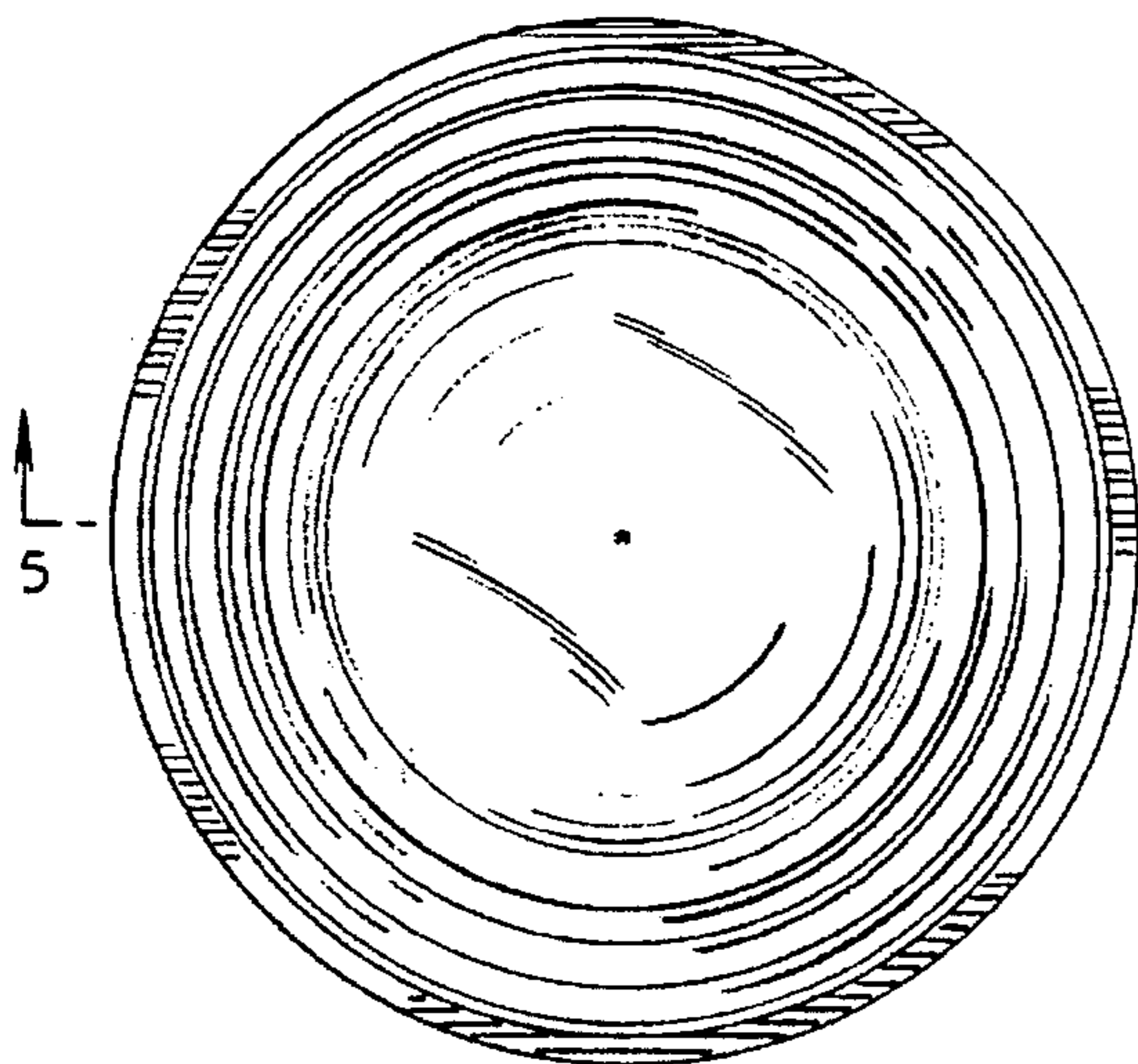

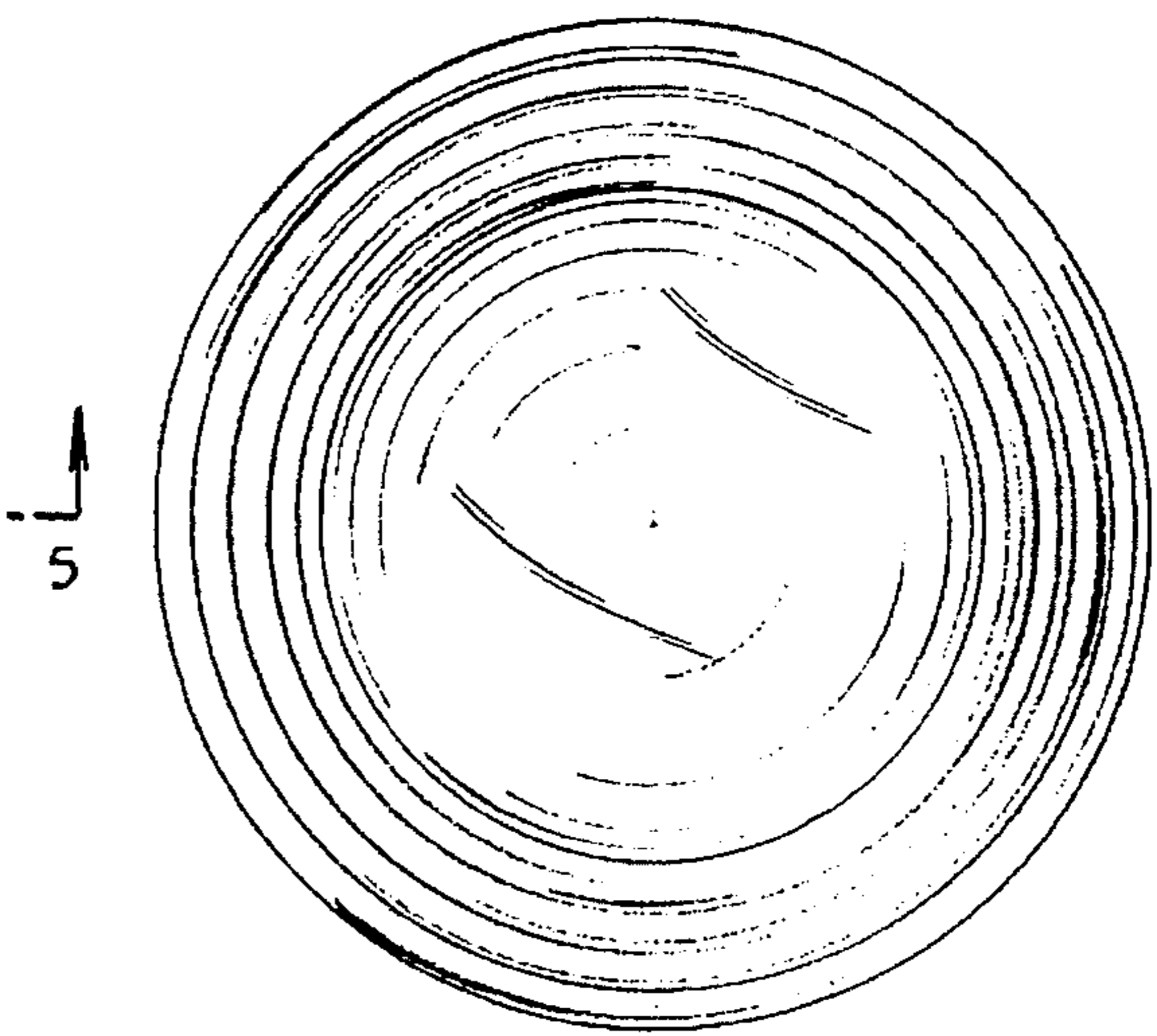

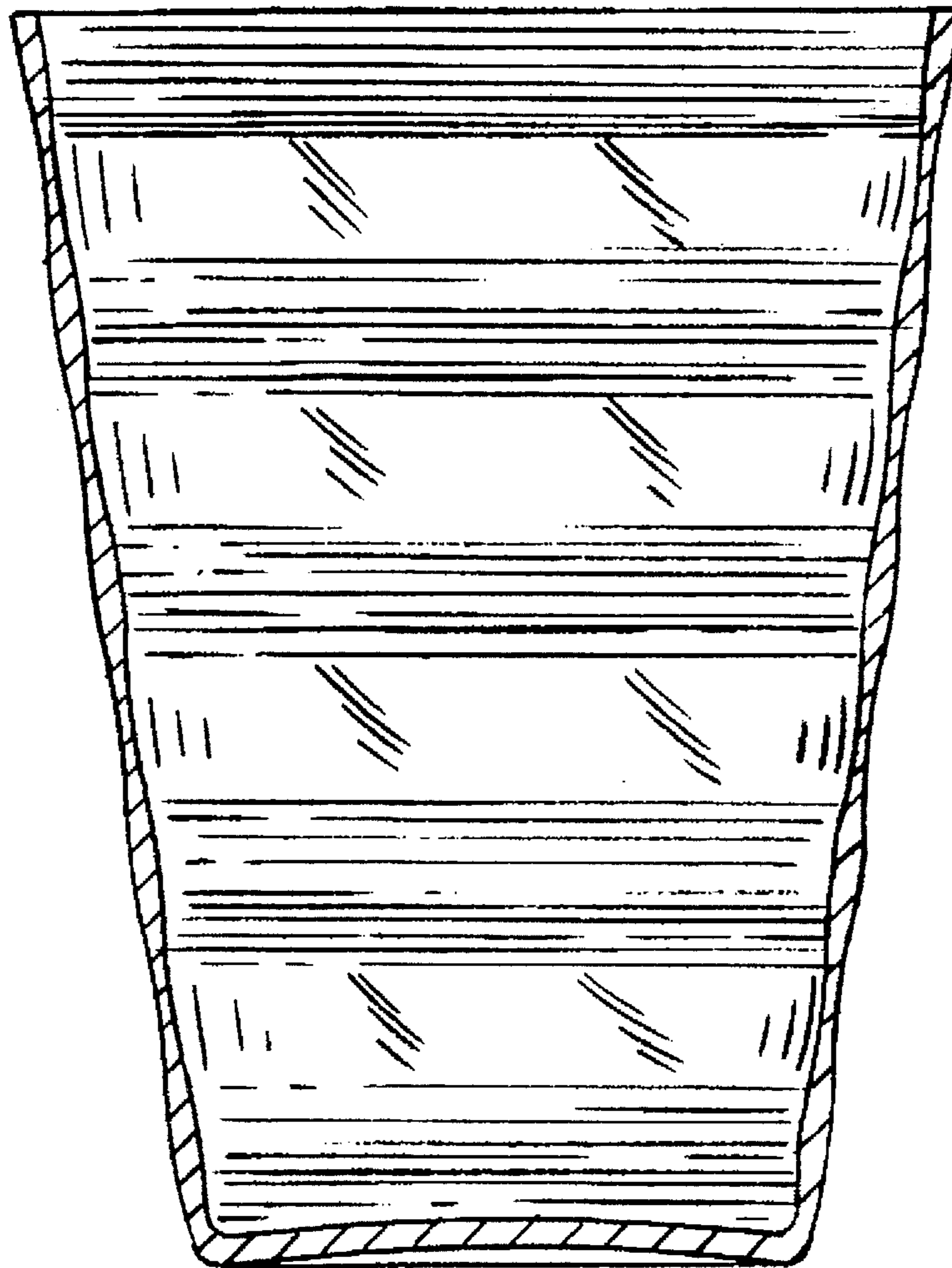
