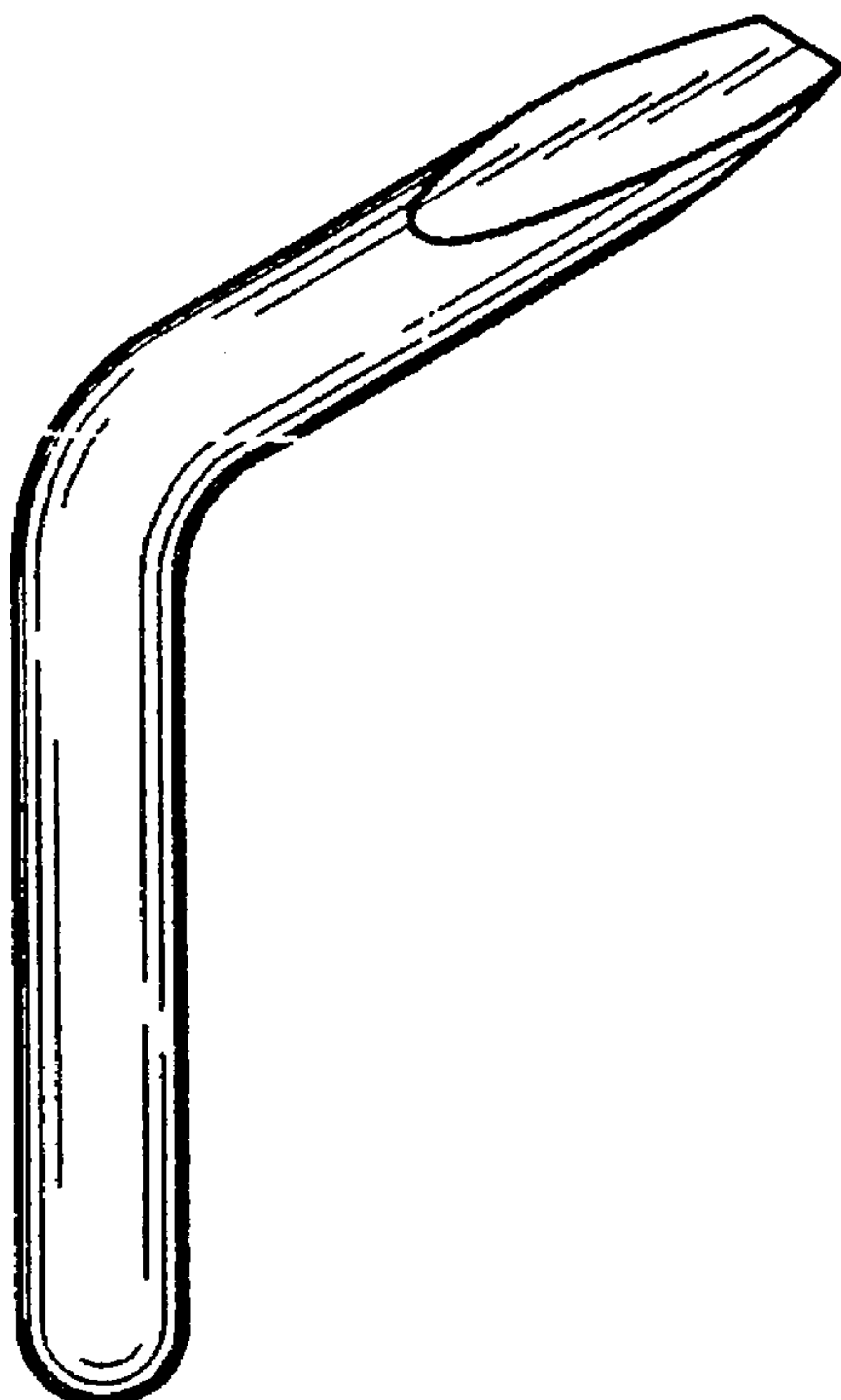
[57] **CLAIM**

The ornamental design for an electrical outlet cover remover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of an electrical outlet cover remover, showing my new design;  
 FIG. 2 is a rear elevational view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a top (plan) view thereof;  
 FIG. 6 is a bottom view thereof;  
 FIG. 7 is a top, rear perspective view thereof;  
 FIG. 8 is a top, front perspective view thereof;  
 FIG. 9 is a front elevational view of the electrical outlet cover remover as in FIG. 1;  
 FIG. 10 is a rear elevational view of FIG. 2;  
 FIG. 11 is a left side elevational view of FIG. 2;  
 FIG. 12 is a right side elevational view of FIG. 2;  
 FIG. 13 is a top (plan) view of FIG. 2;  
 FIG. 14 is a bottom view of FIG. 2;  
 FIG. 15 is a top, rear perspective view of FIG. 2;  
 FIG. 16 is a top, front perspective view of FIG. 2; and,  
 FIG. 17 is a perspective view of FIG. 2, the broken line showing an outlet and outlet cover is for illustrative purposes only and forms no part of the claimed invention.

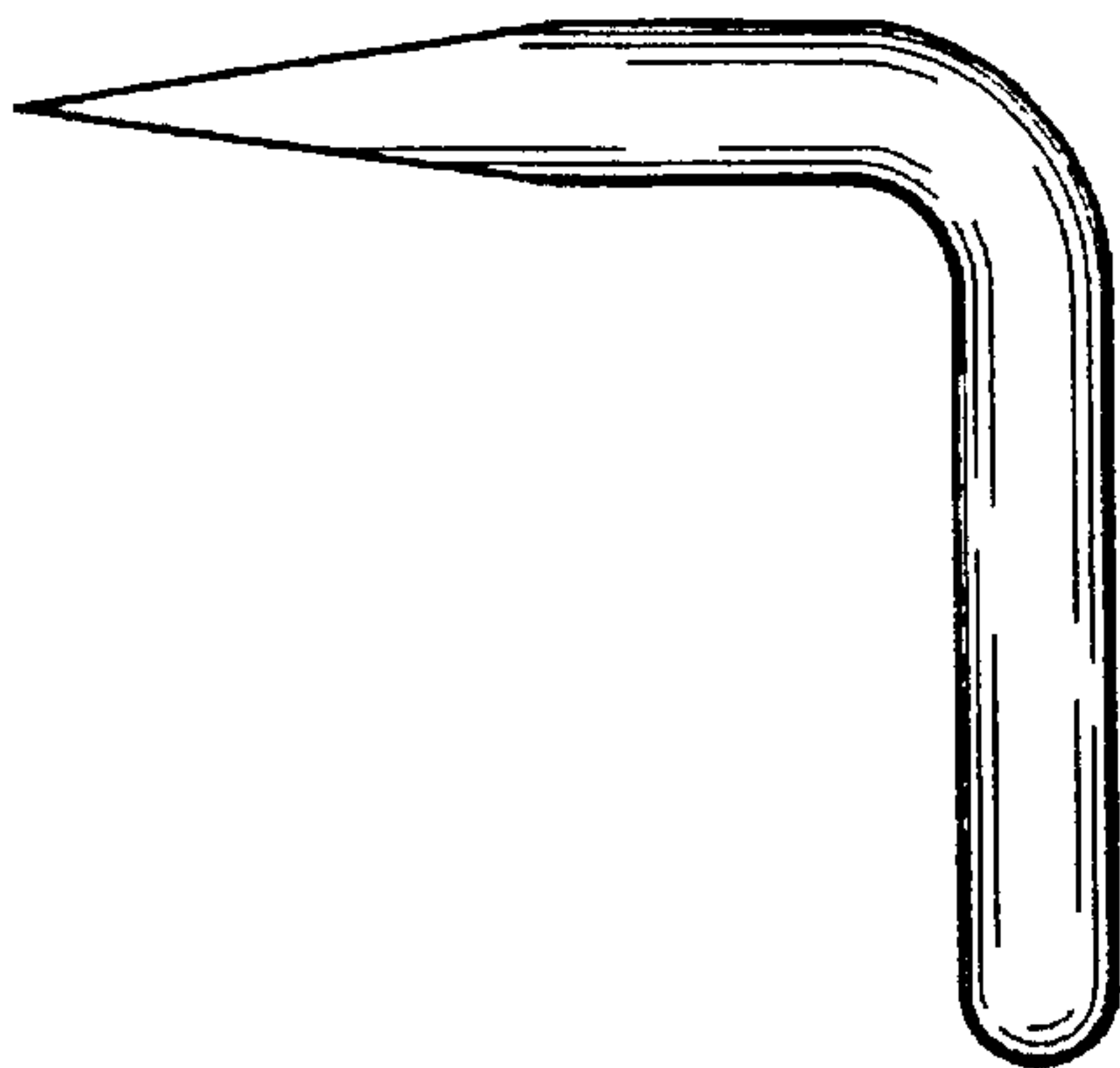

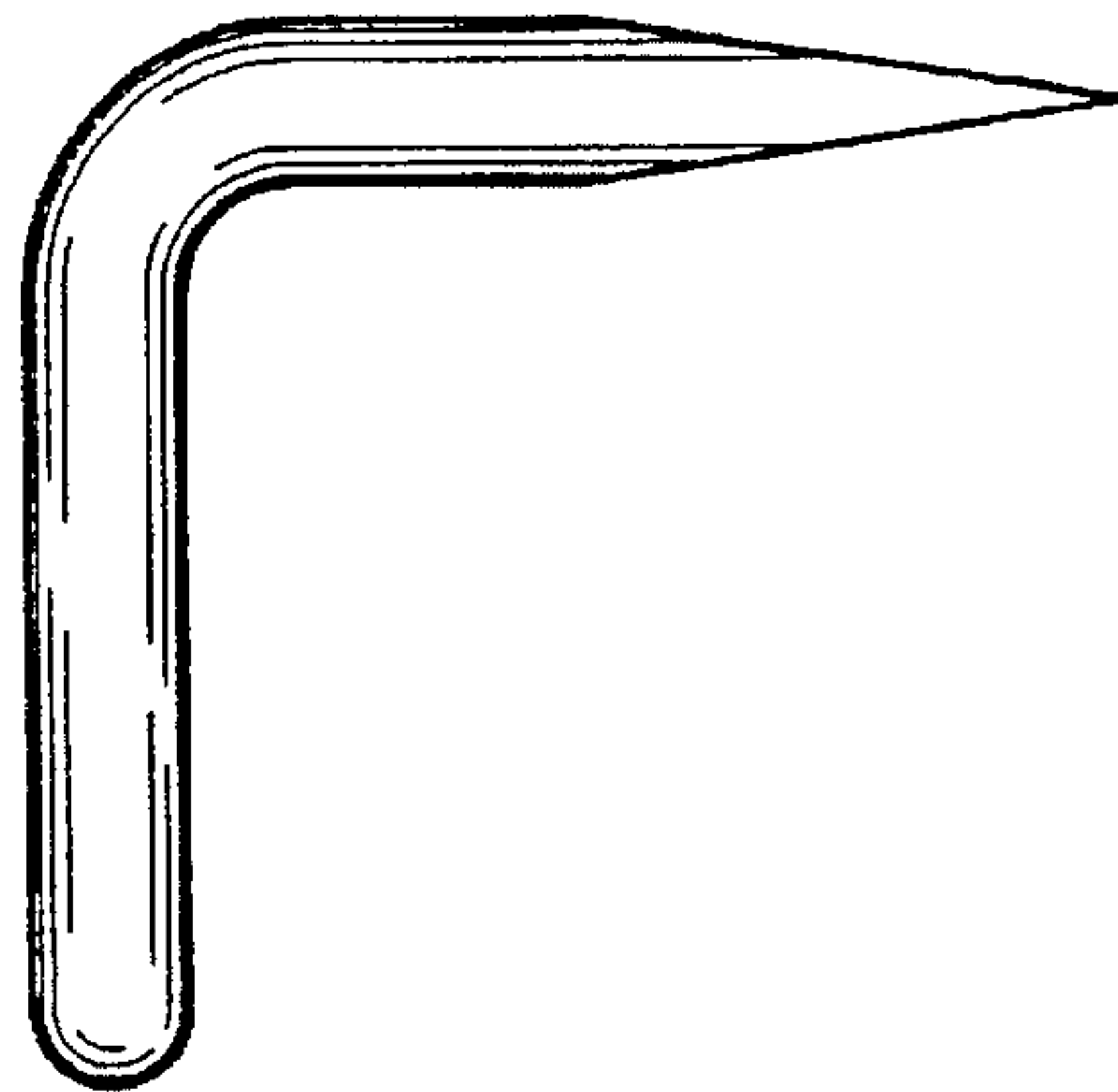

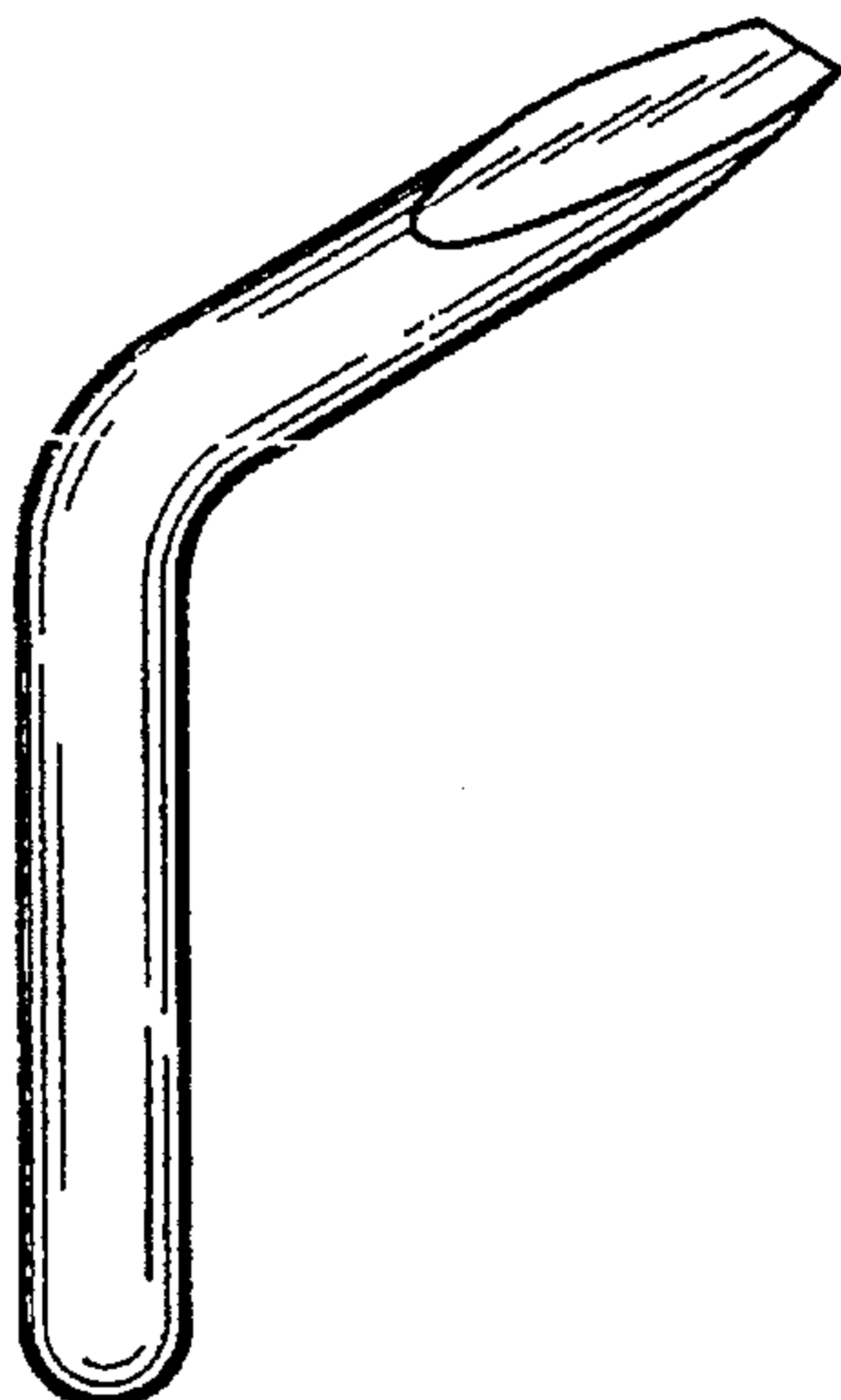

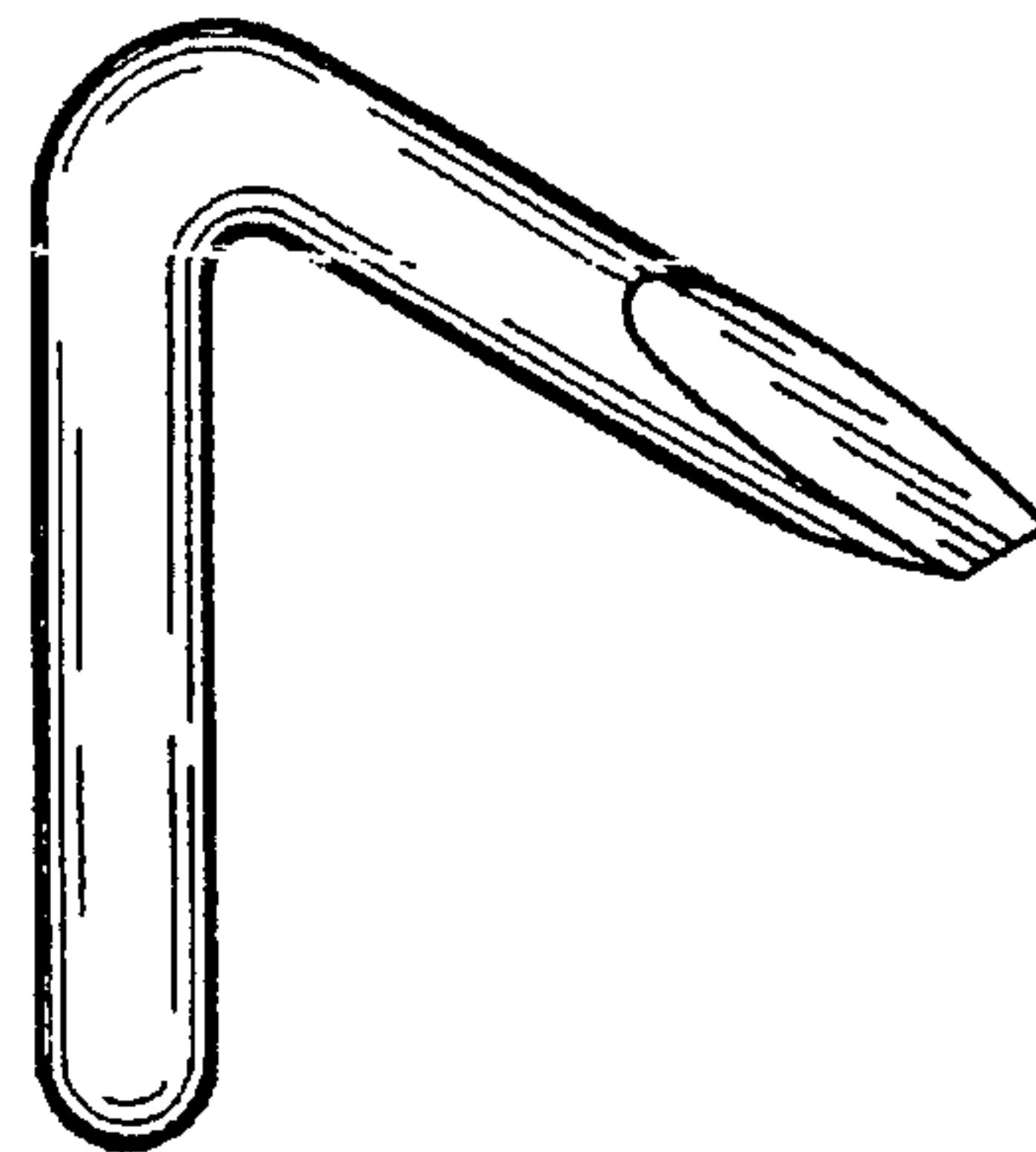

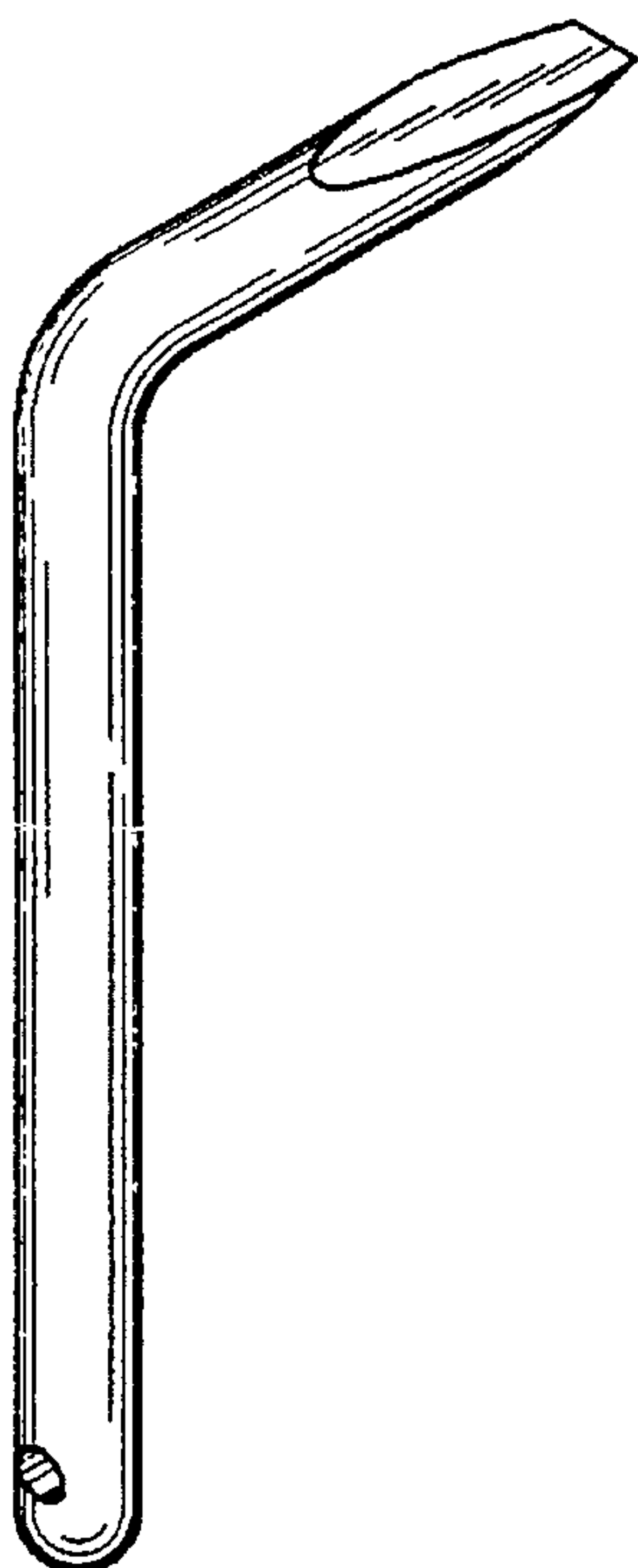

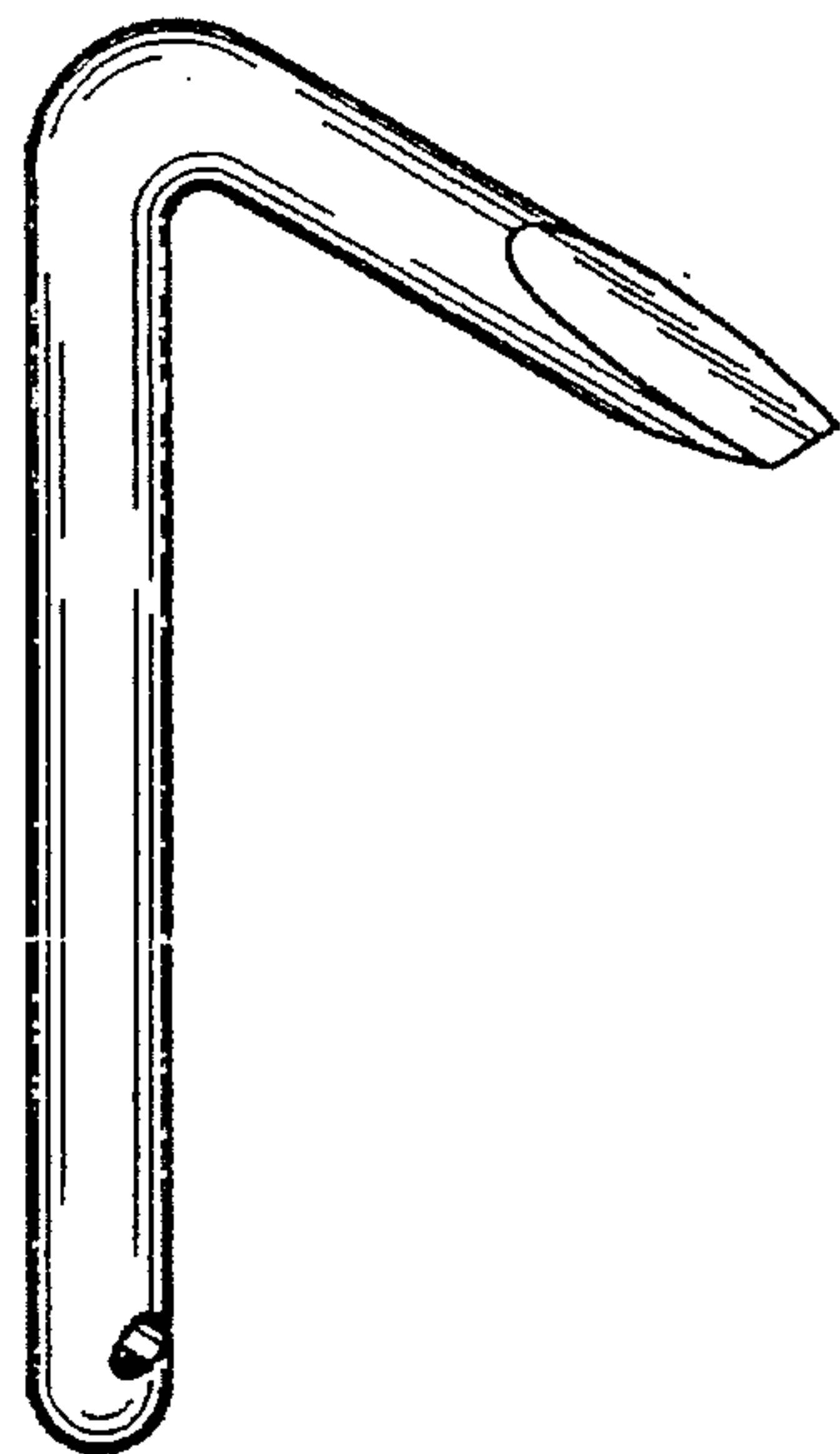
