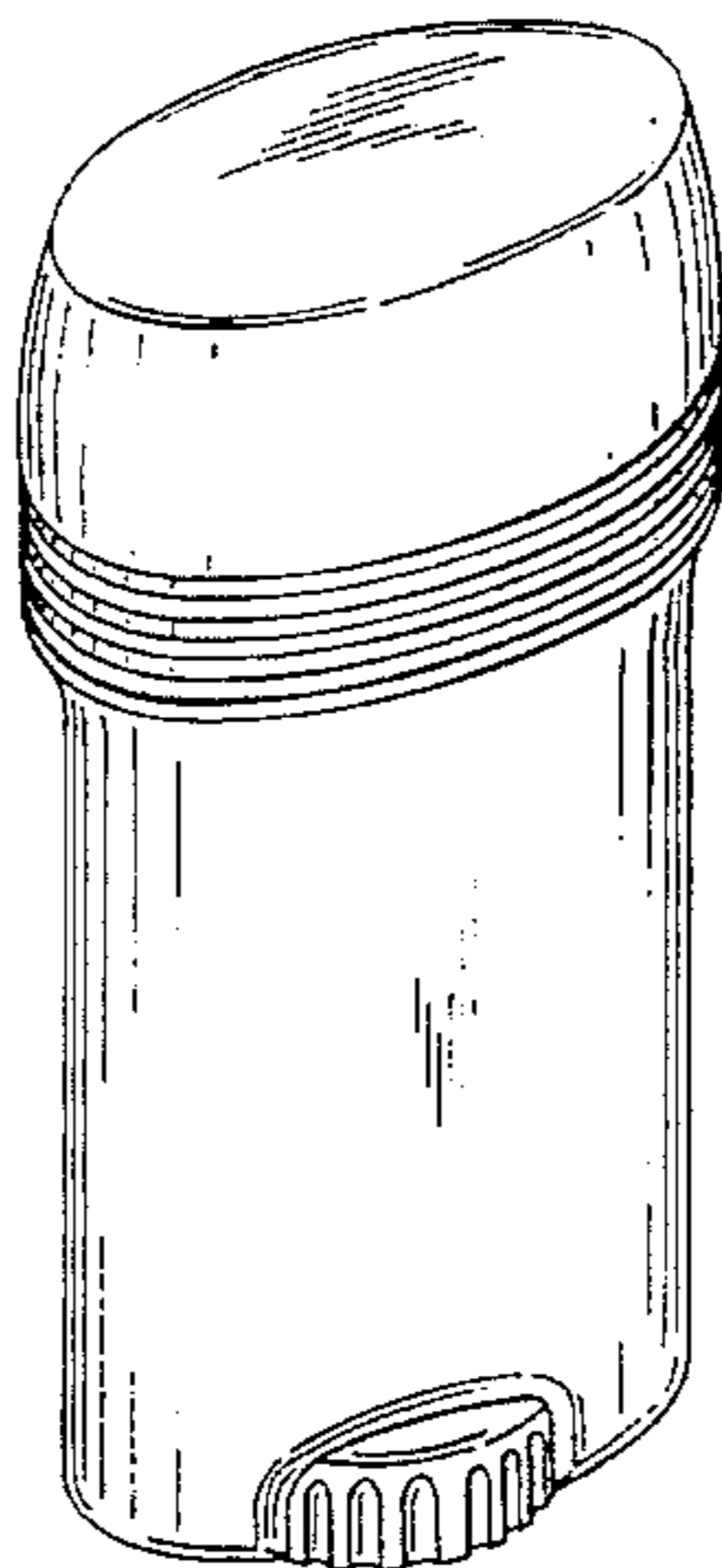
#### [57] CLAIM

The ornamental design for a combined cosmetic container and cap, as shown and described.

#### DESCRIPTION

FIG. 1 is a perspective view of a combined cosmetic container and cap showing my new design;  
 FIG. 2 is a front elevation view thereof, the opposite side being identical;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a side elevation view thereof, the opposite side being identical;  
 FIG. 6 is an exploded perspective view;  
 FIG. 7 is a front elevation view thereof, the opposite side being identical;  
 FIG. 8 is a top plan view thereof; and,  
 FIG. 9 is a side elevation view thereof, the opposite side being identical.  
 FIGS. 7-9 are shown without the cap for clarity of illustration.

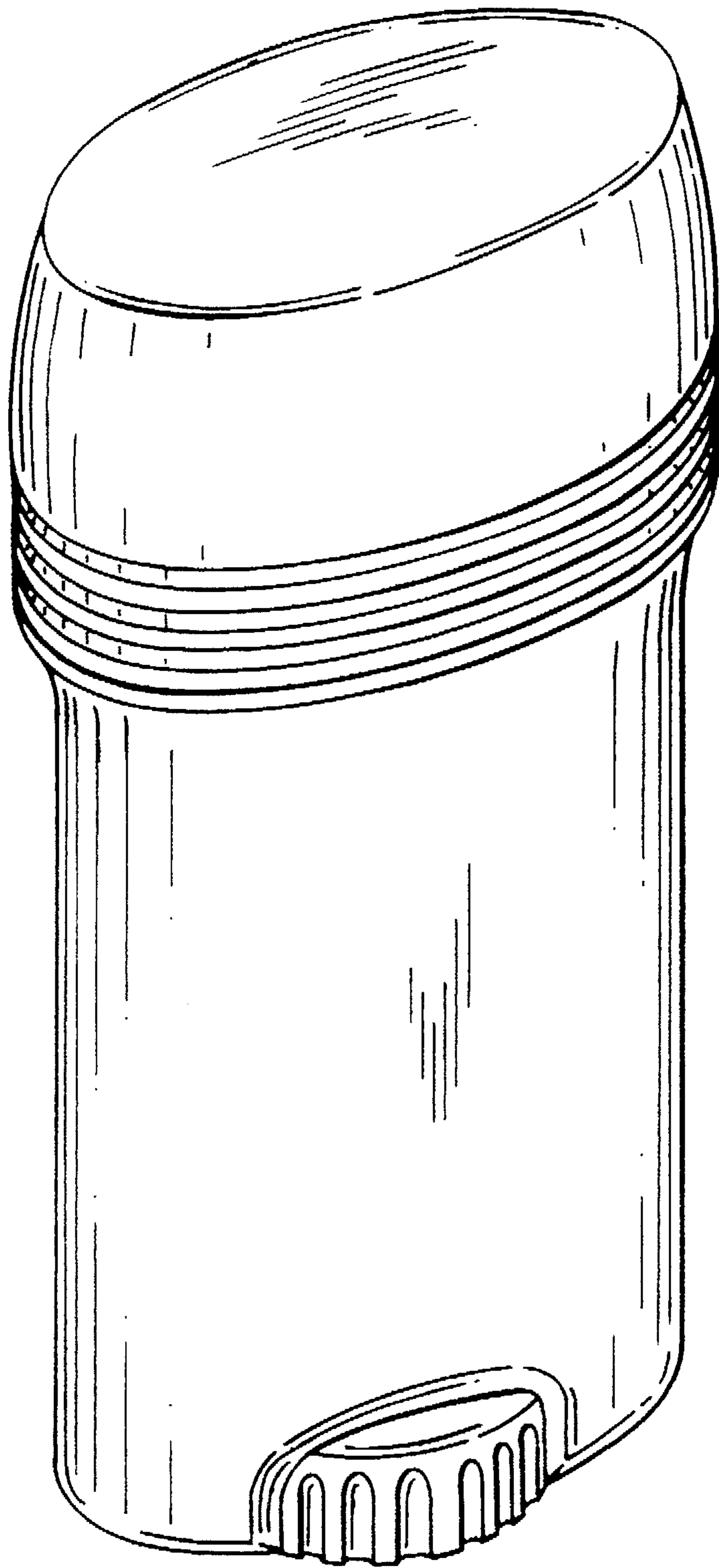

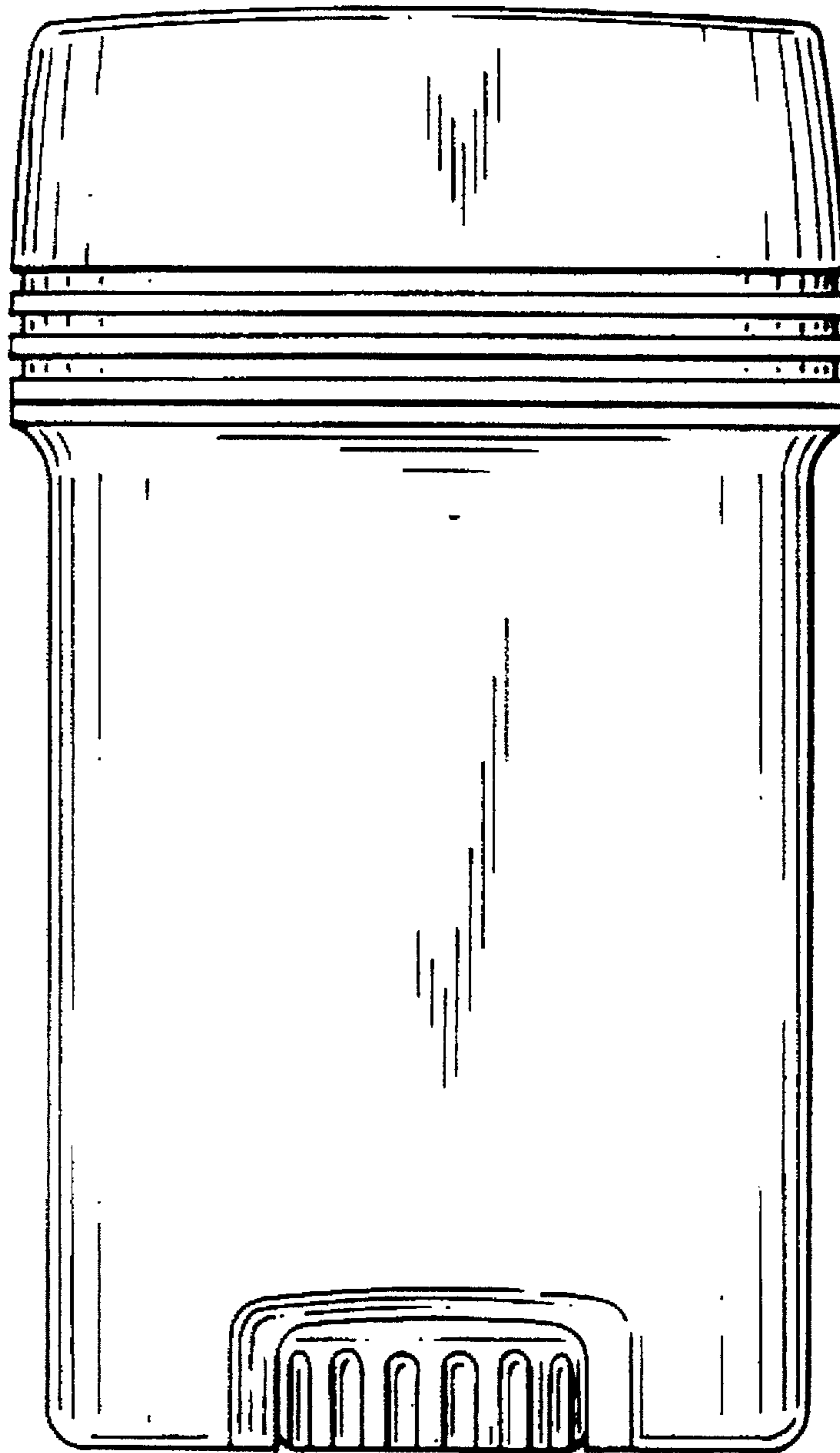

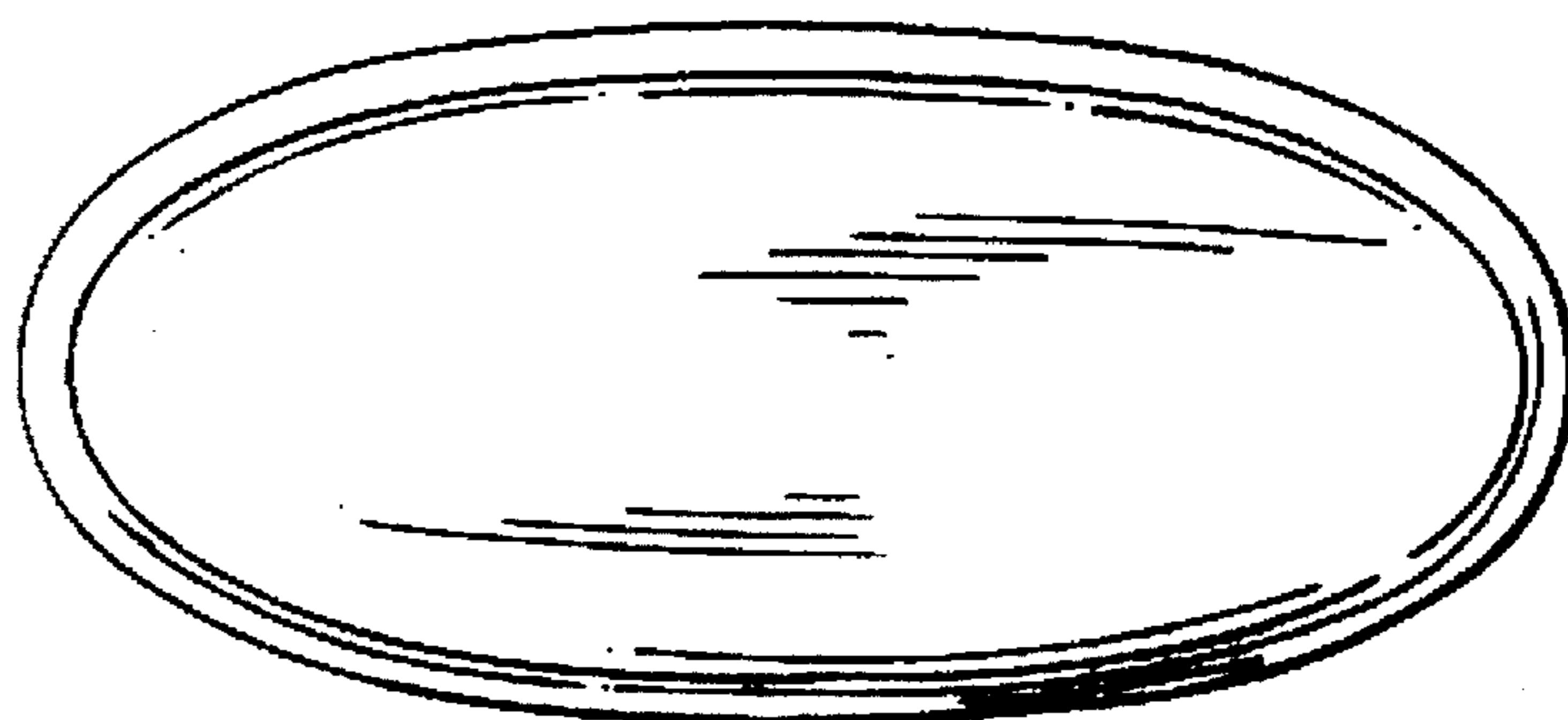

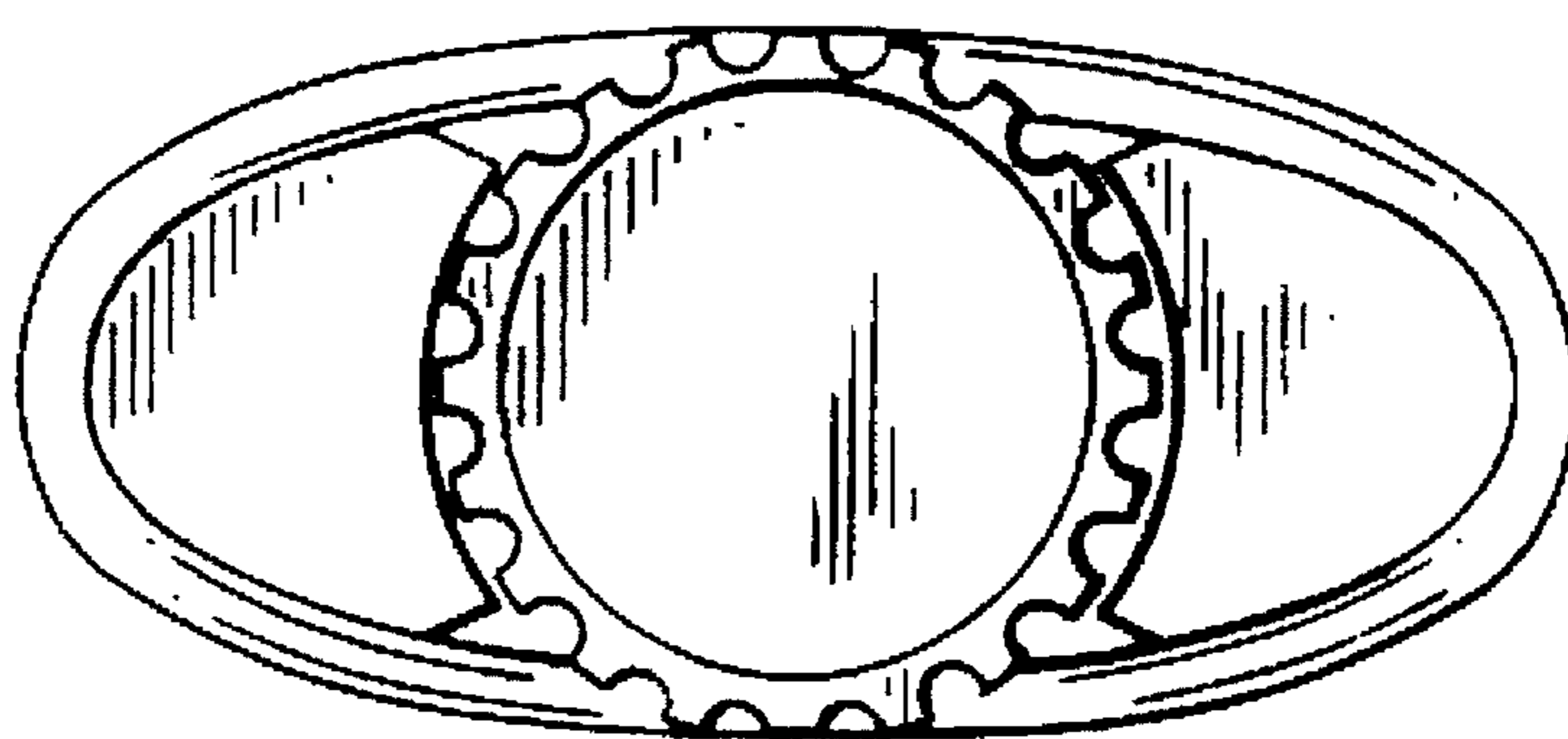

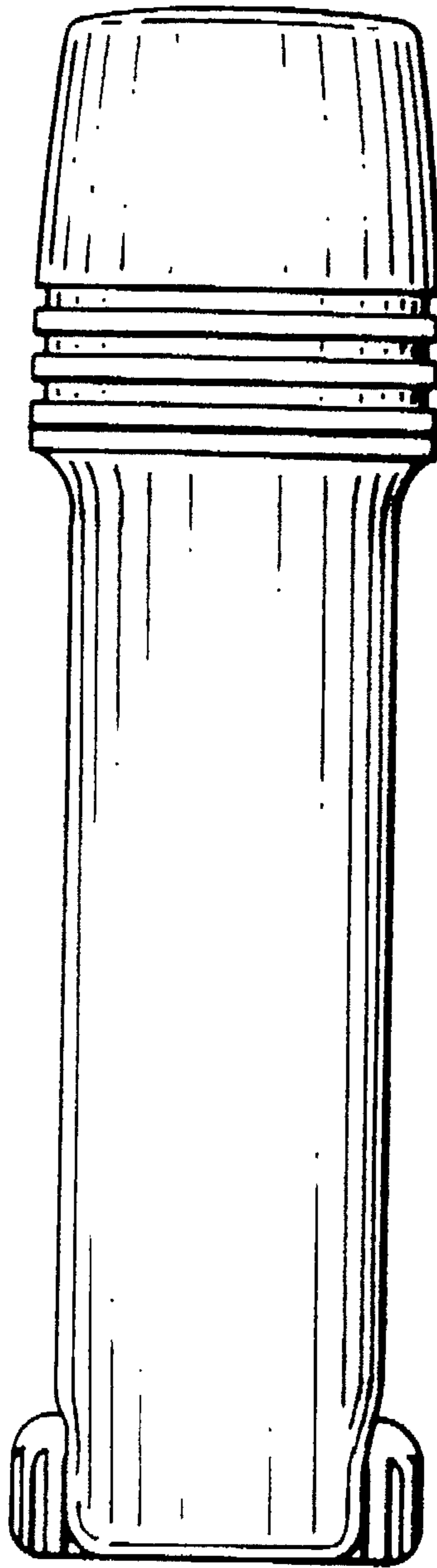

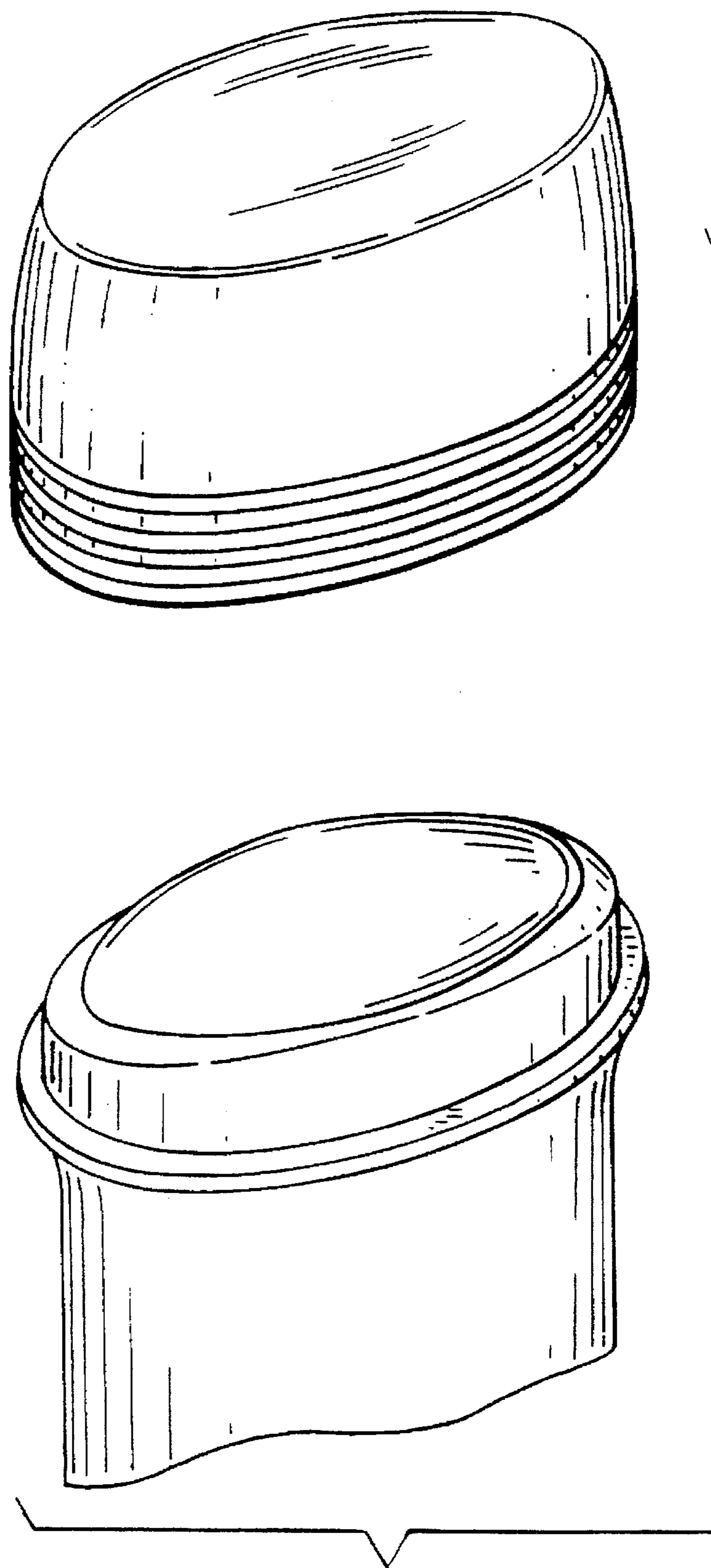

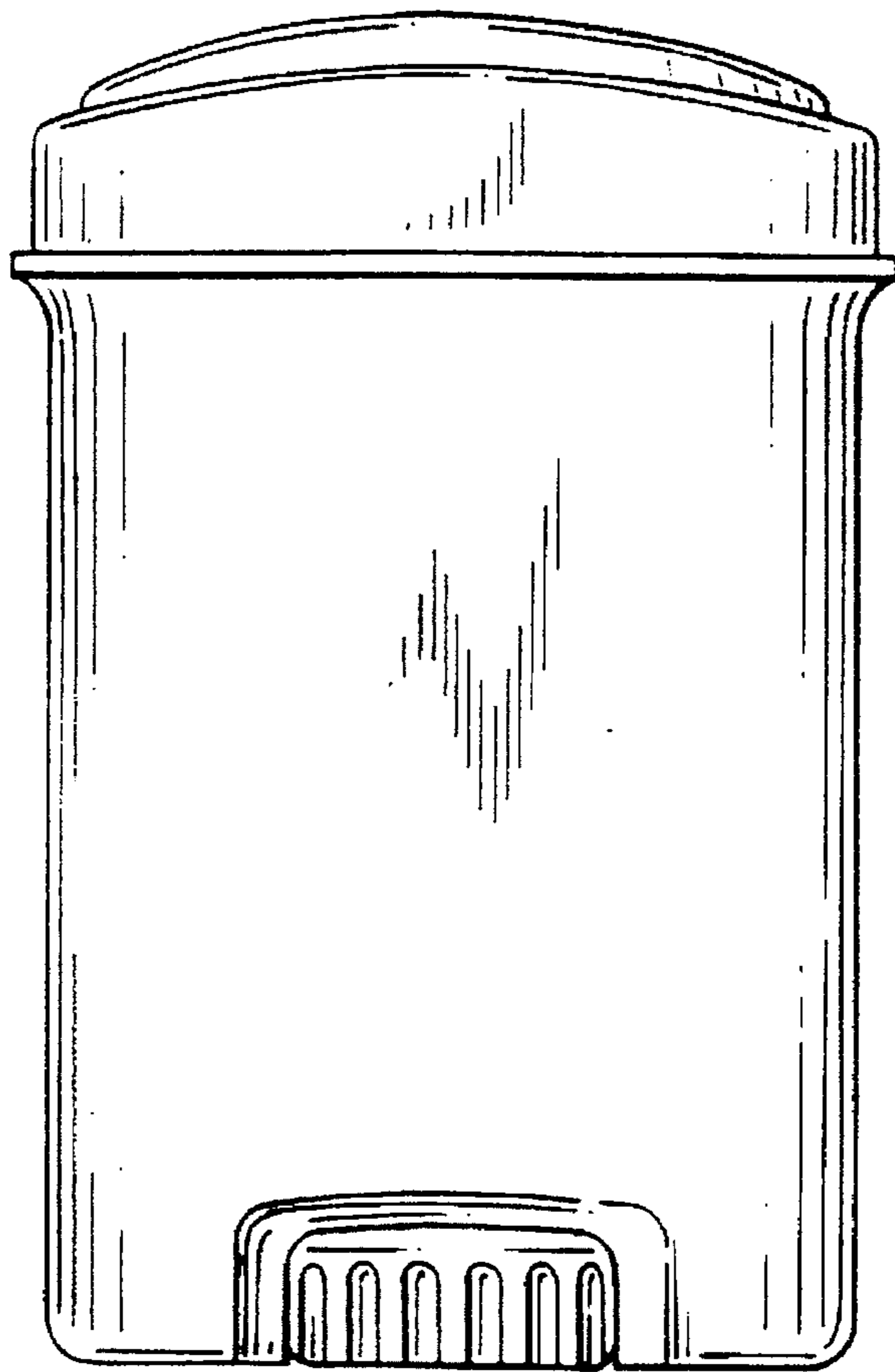

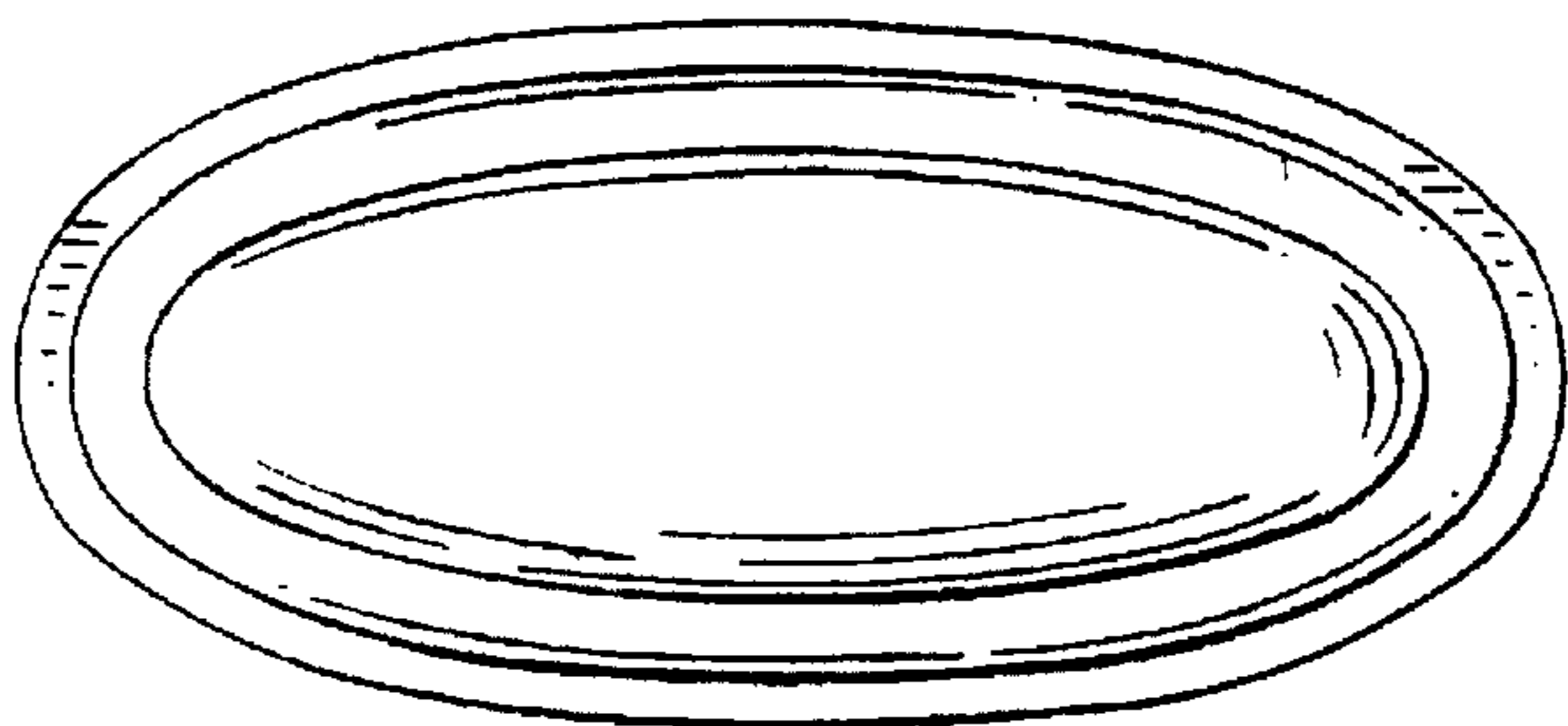

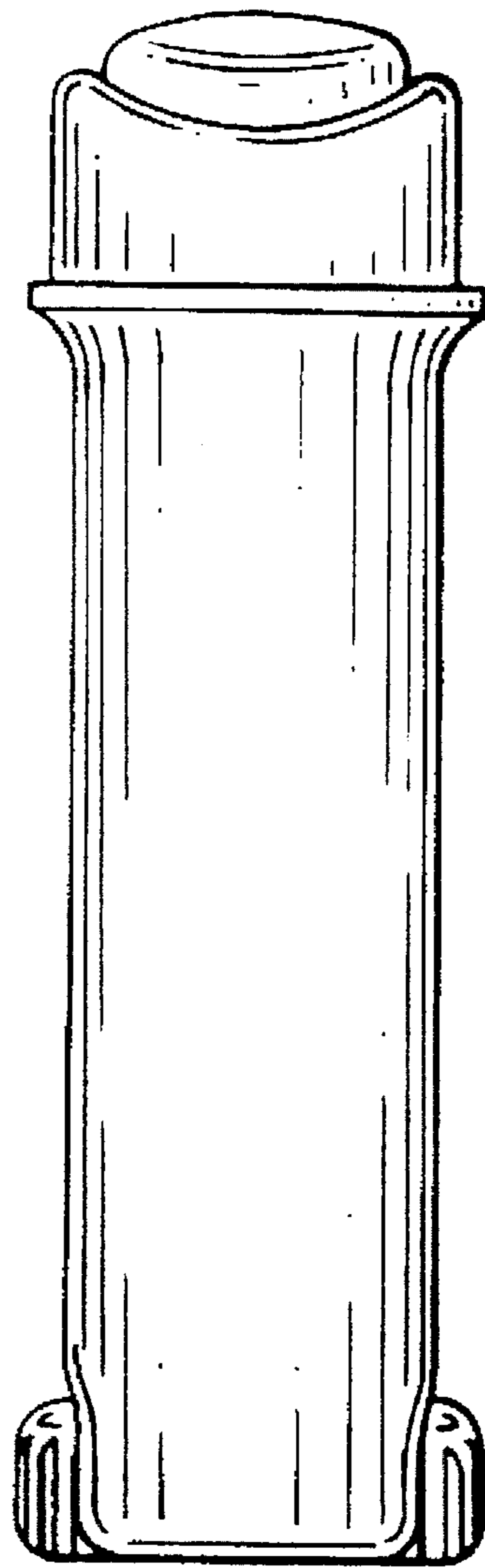
