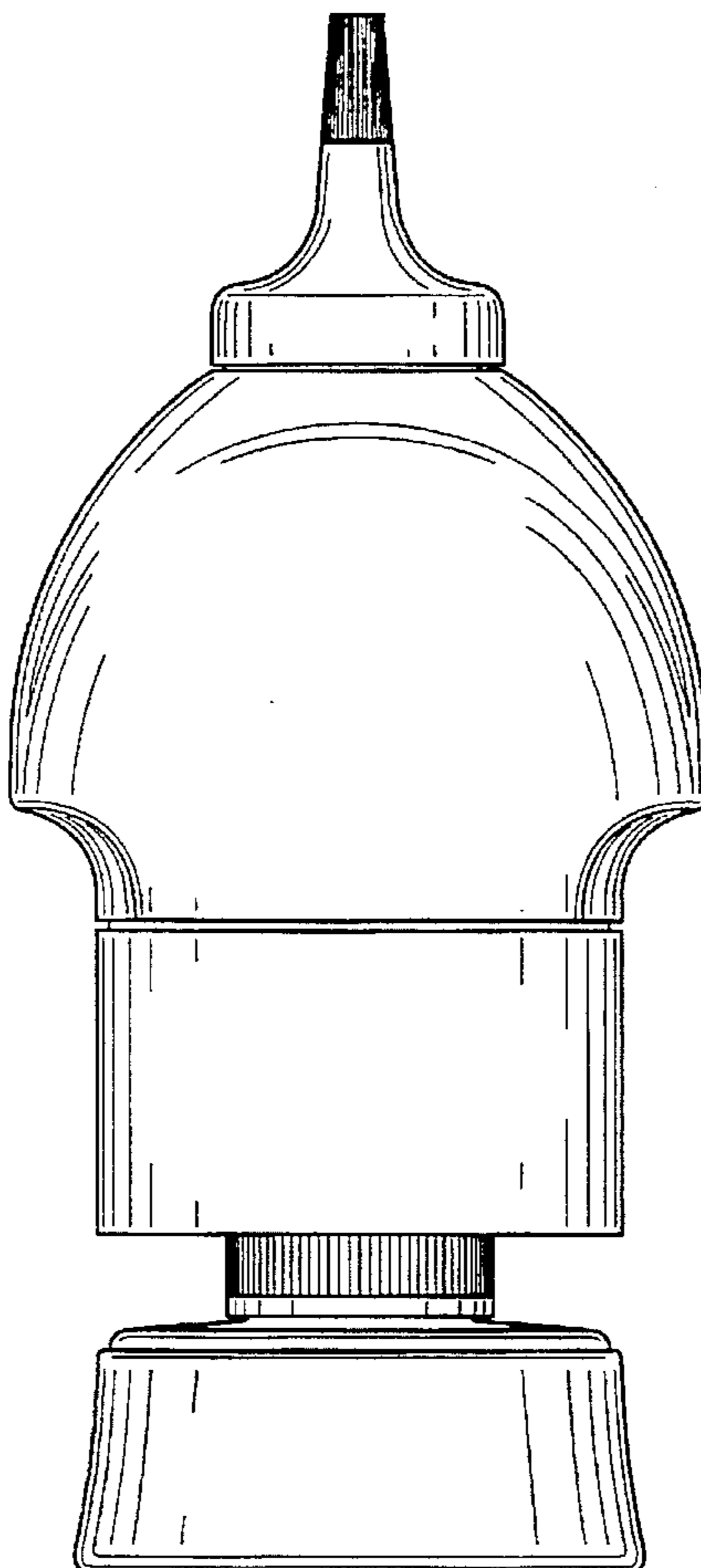
[57] **CLAIM**

The ornamental design for a dual container package, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a dual container package showing our new design;  
FIG. 2 is a front elevational view thereof, the back elevational view being identical;  
FIG. 3 is a side elevational view thereof, the opposite side being identical;  
FIG. 4 is a top plan view of FIG. 1; and,  
FIG. 5 is a bottom plan view thereof.

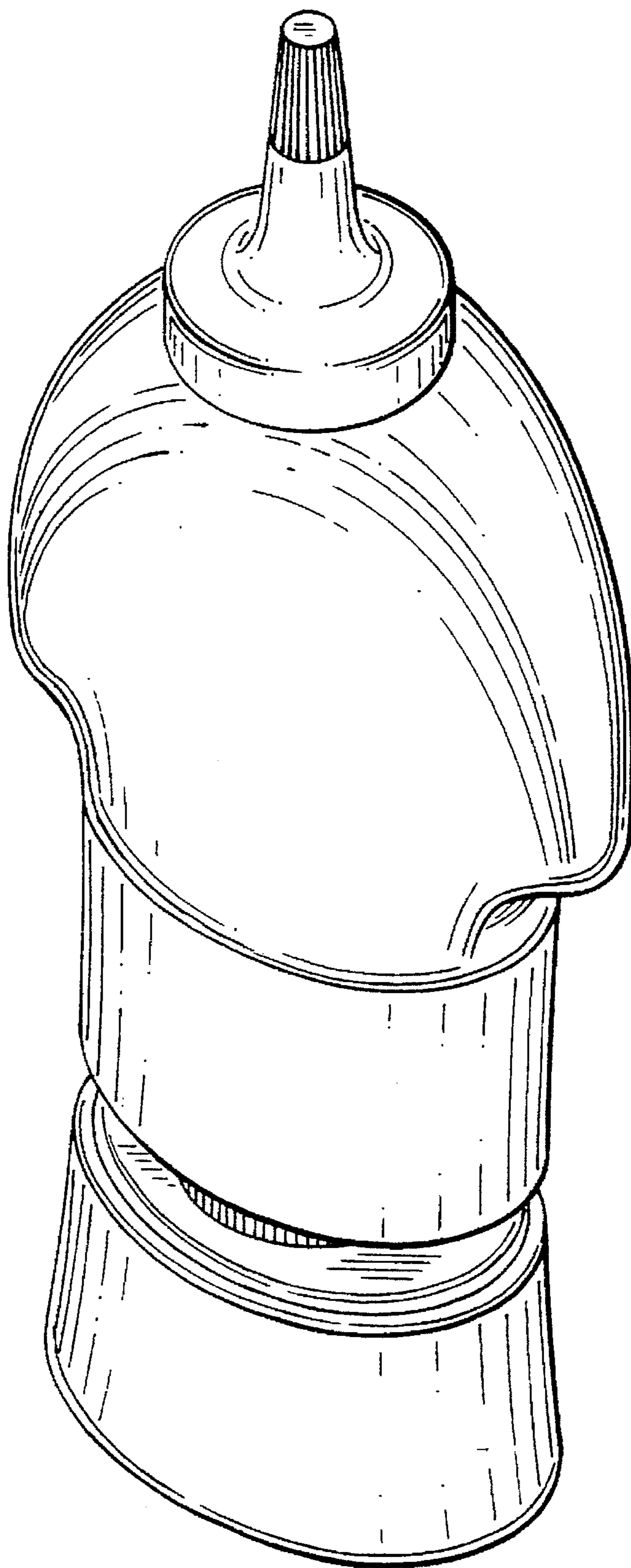

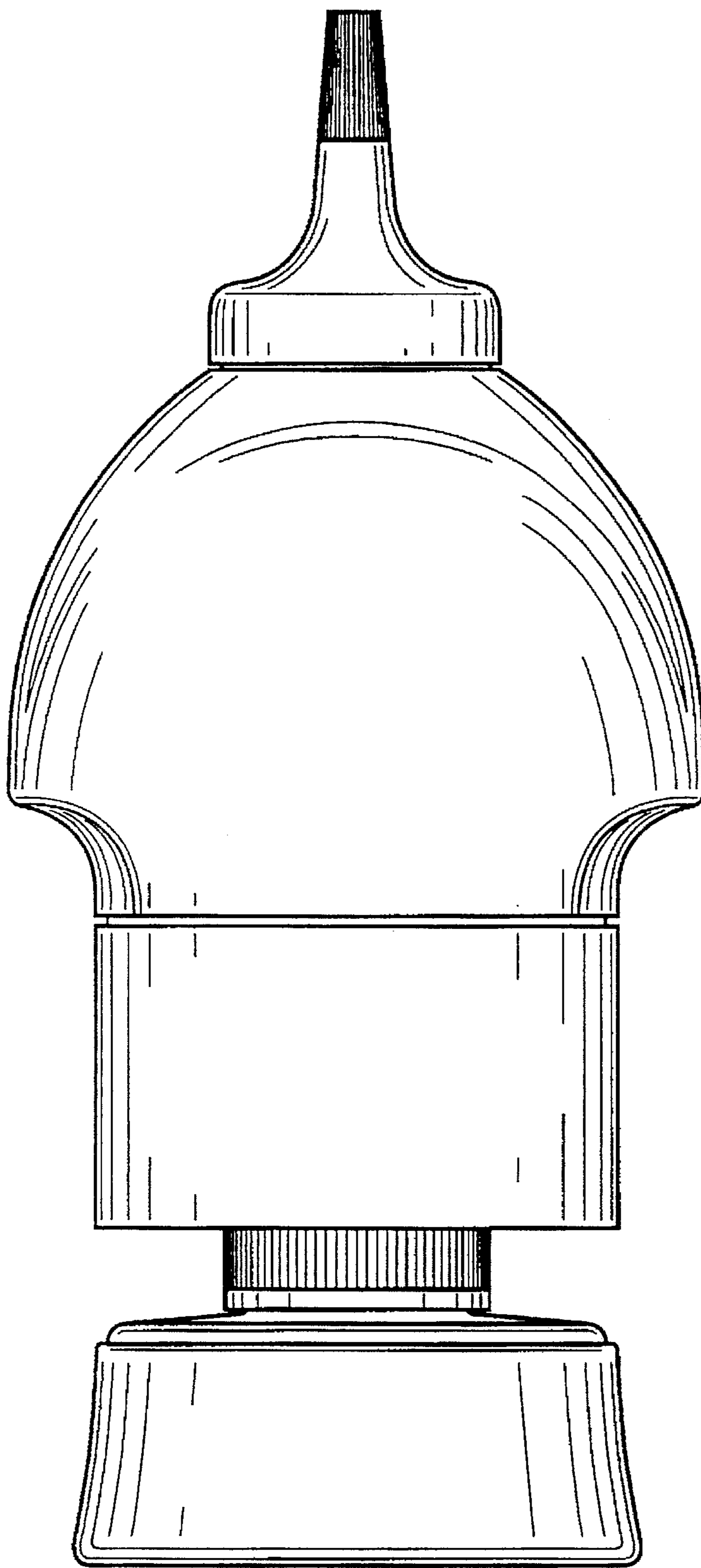

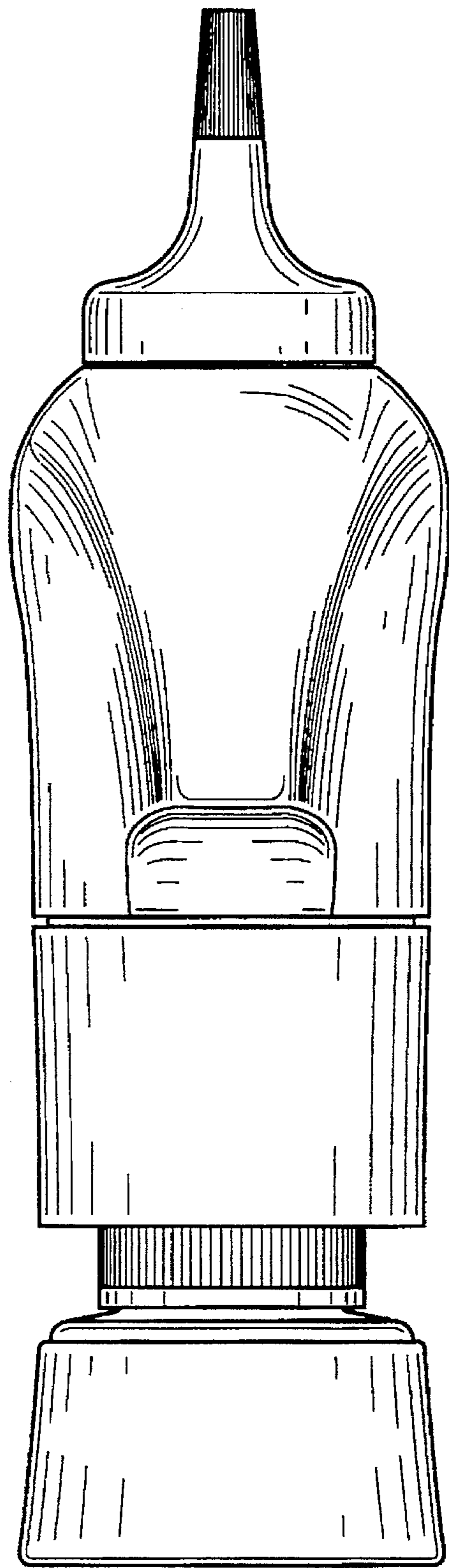

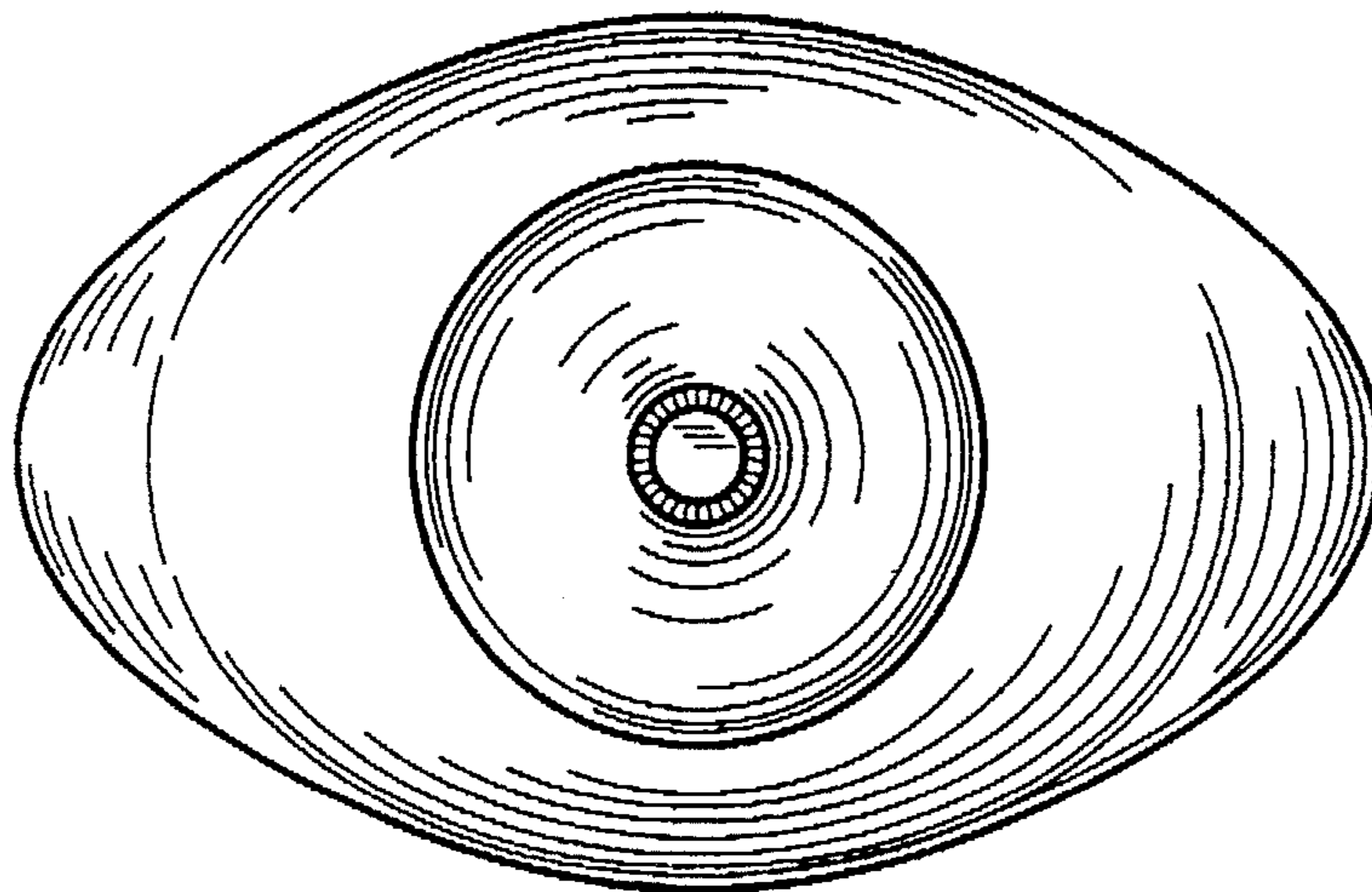

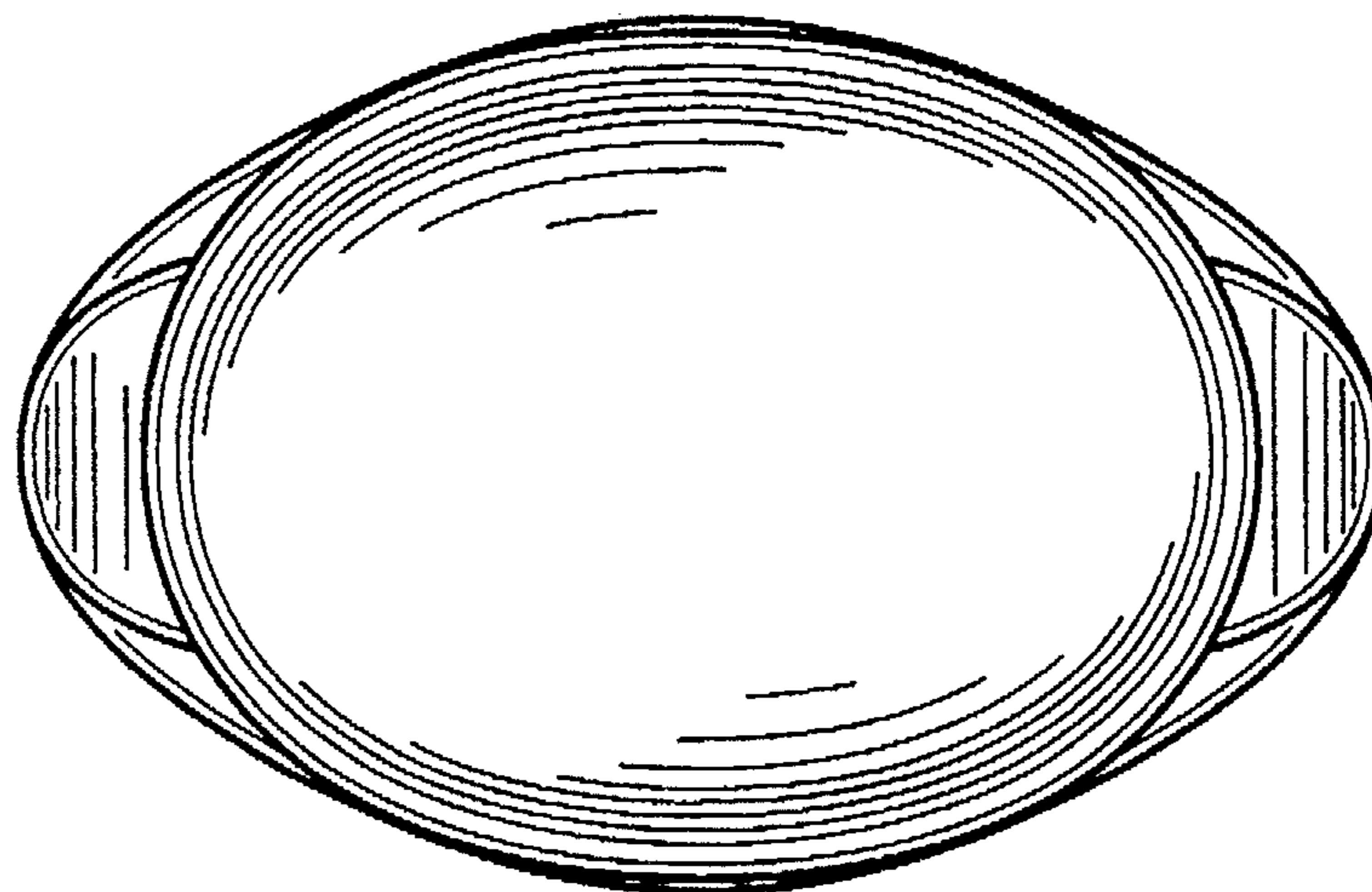
