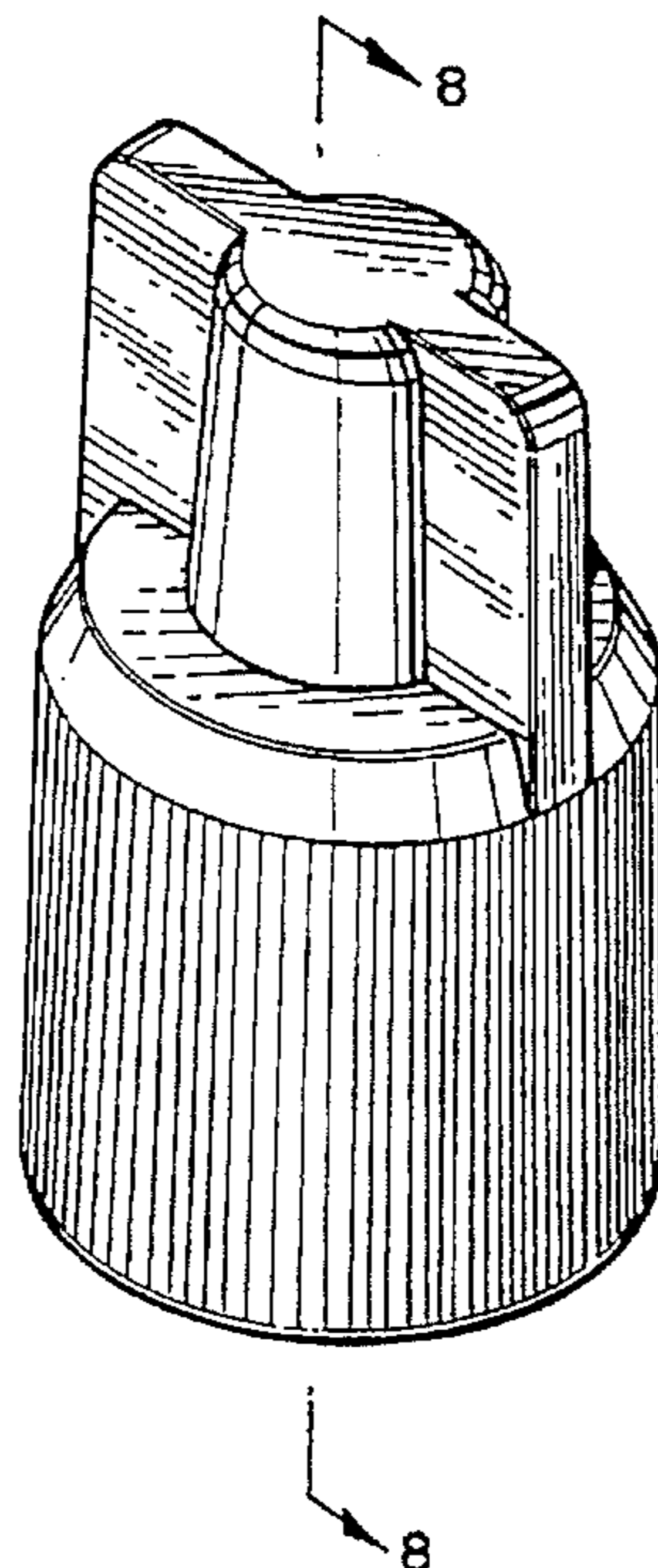
[57] CLAIM

DESCRIPTION

FIG. 1 is a perspective view showing my new design for a container closure;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a cross-sectional view of the design of FIG. 1 taken along the line 8—8 of FIG. 1.

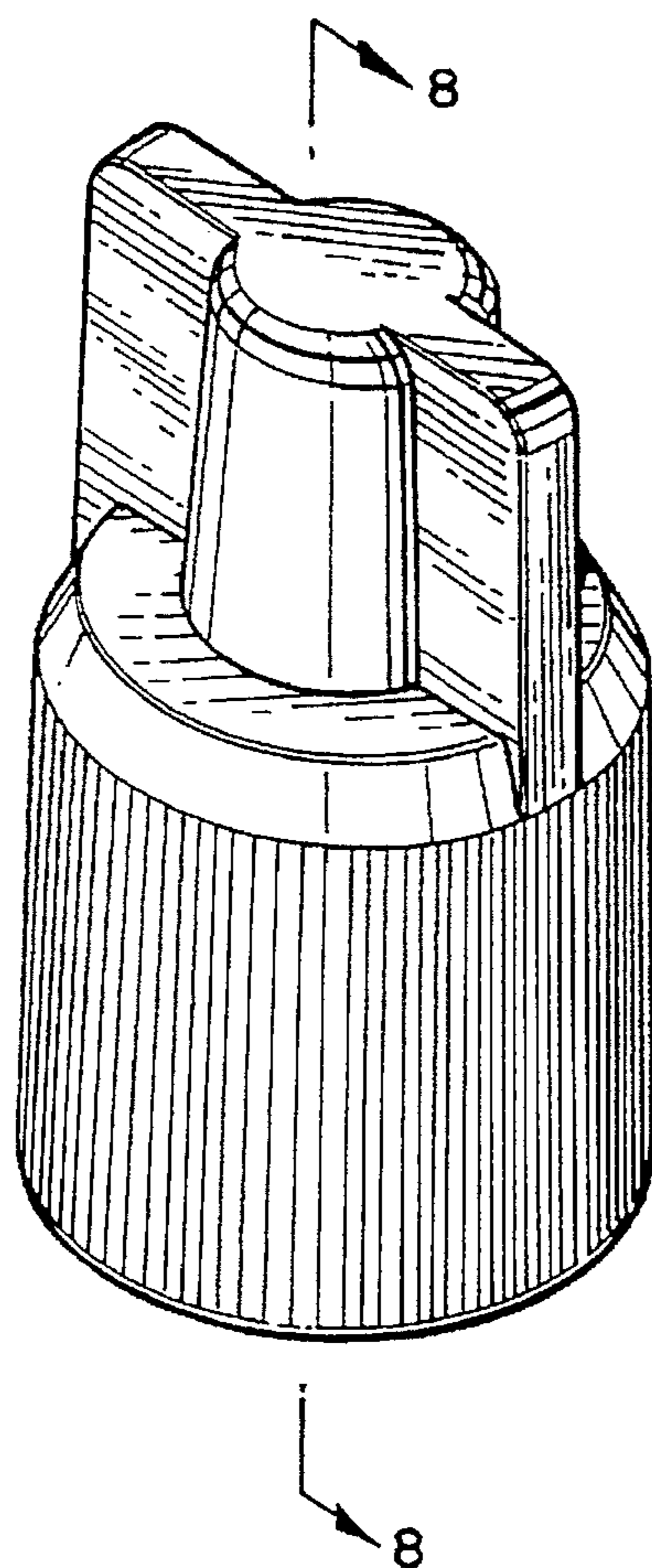

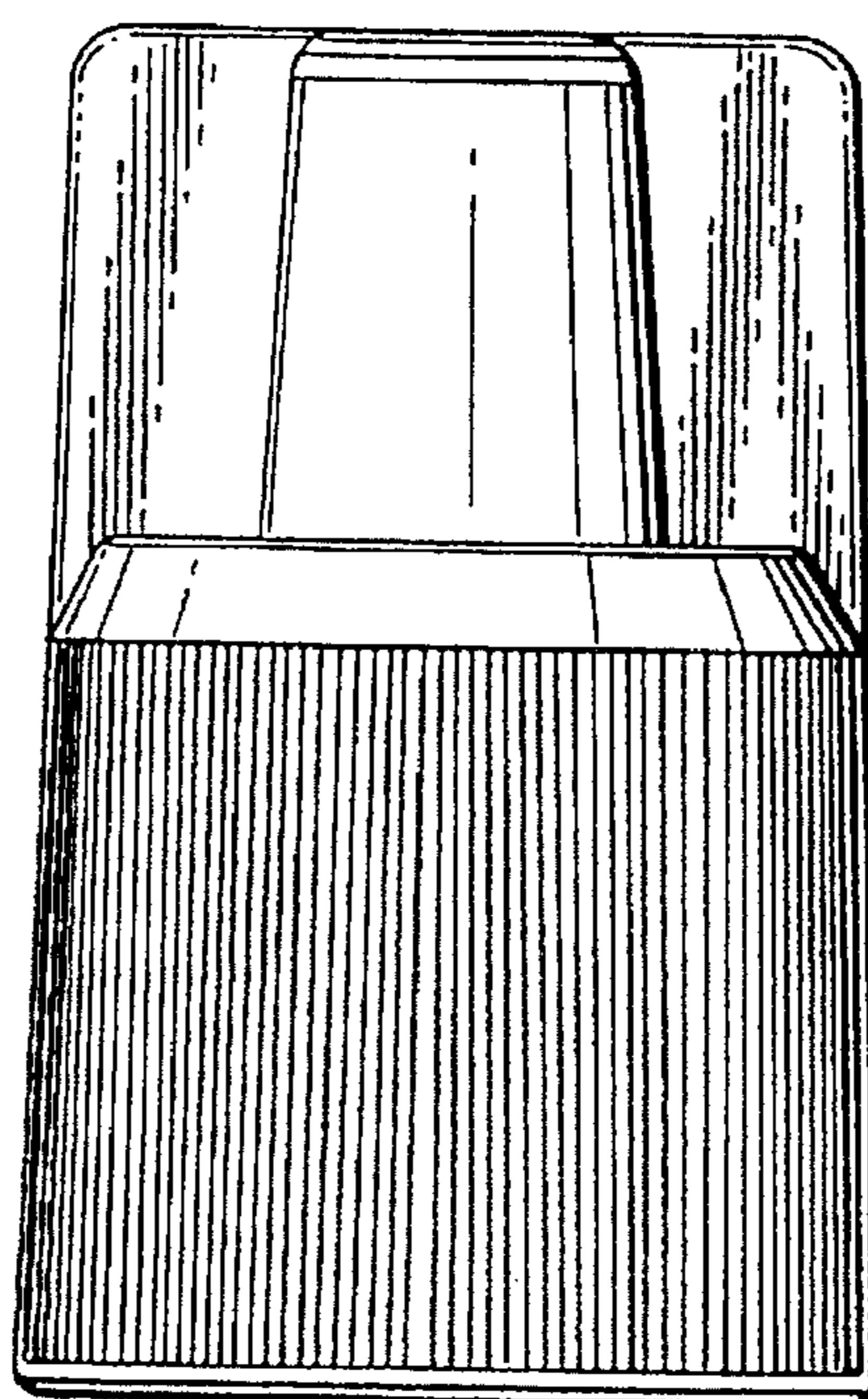

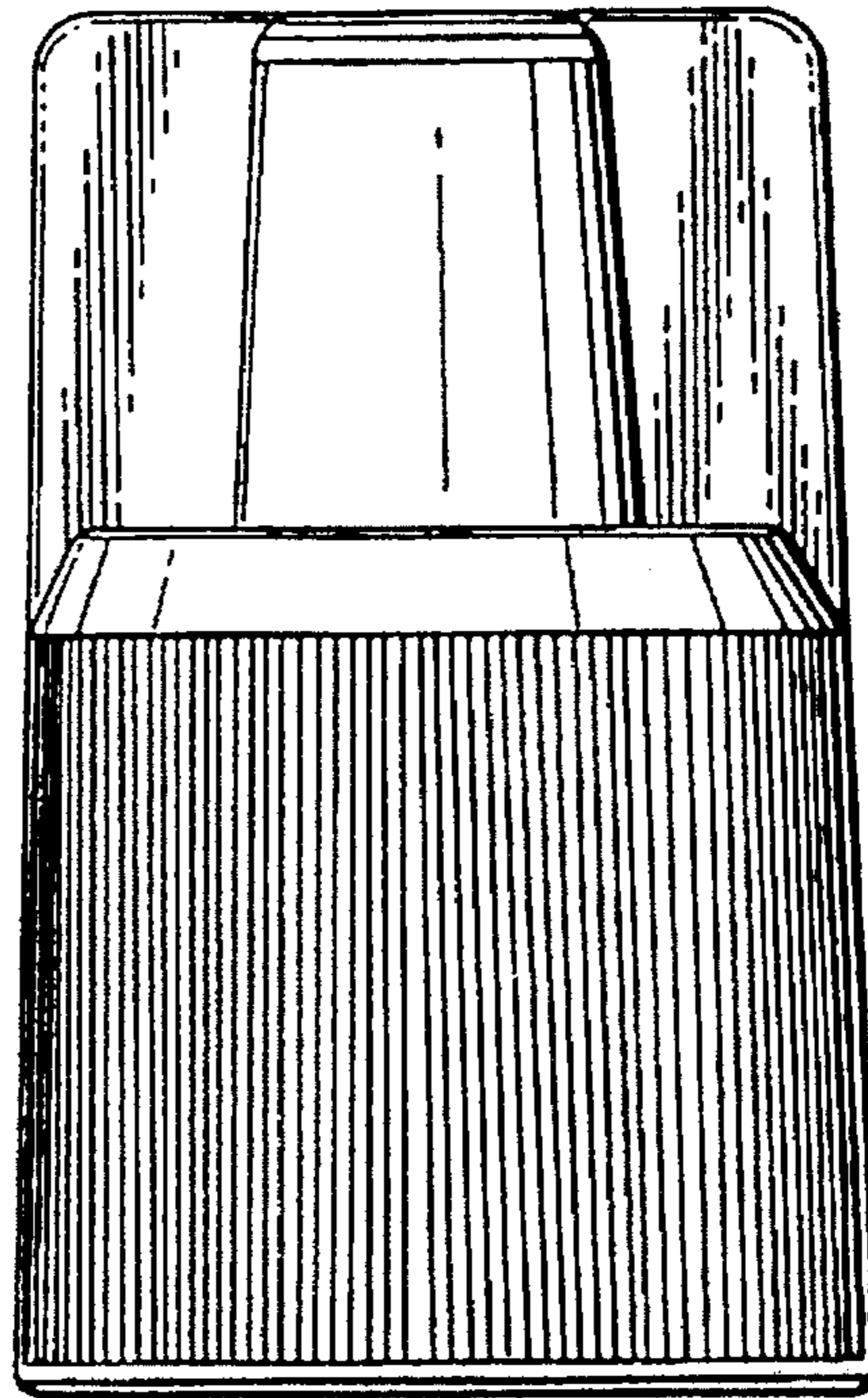

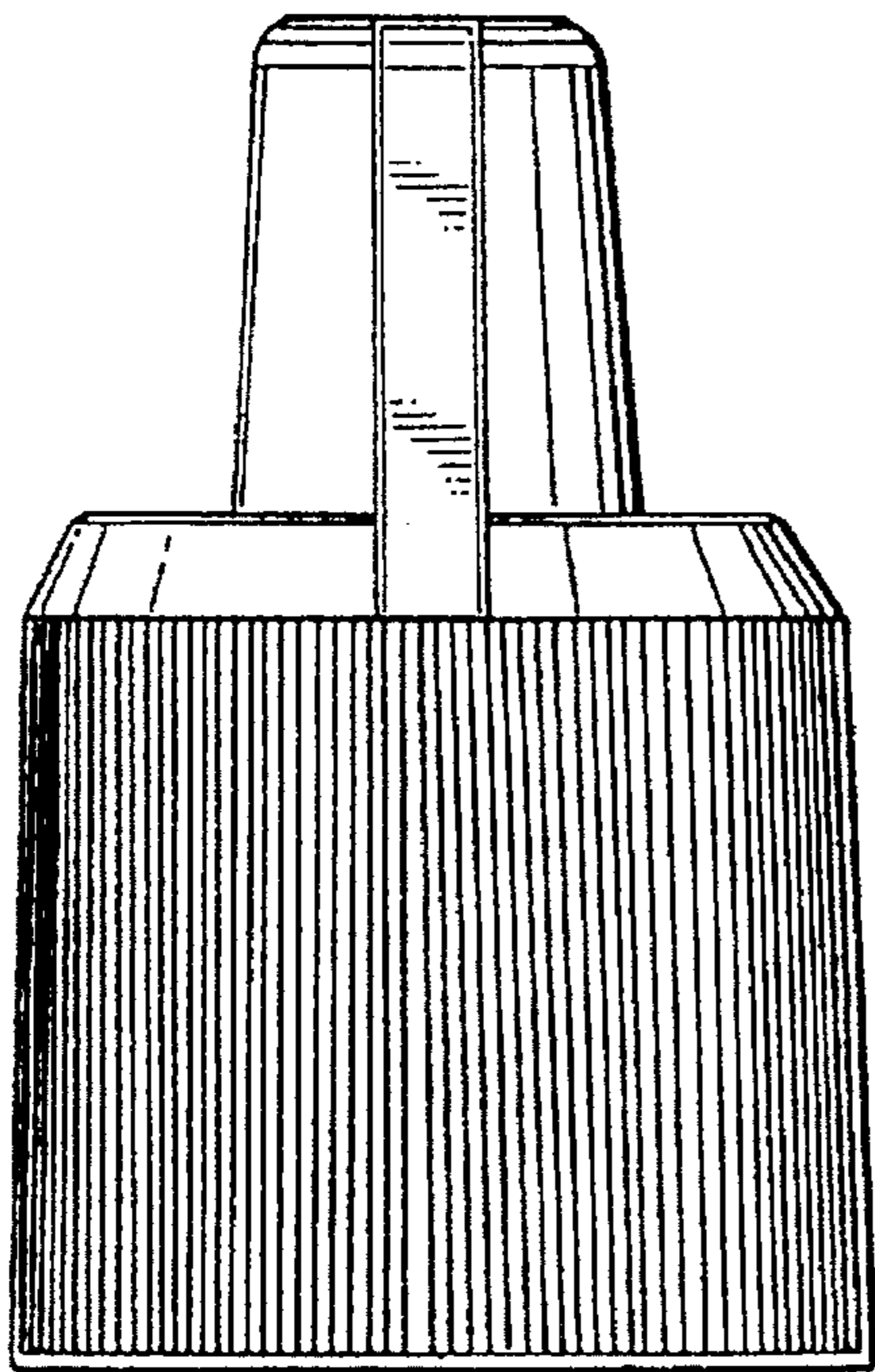

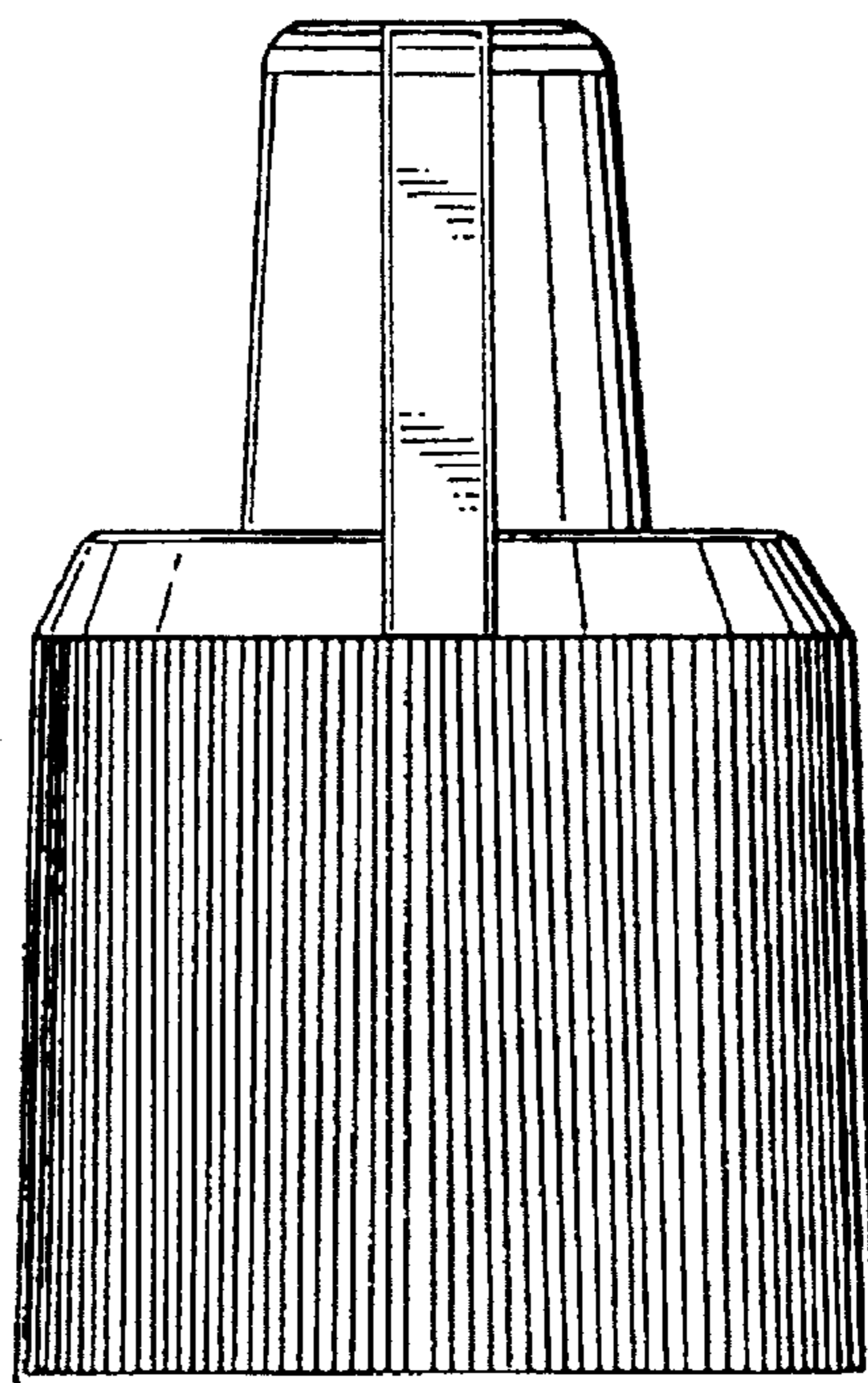

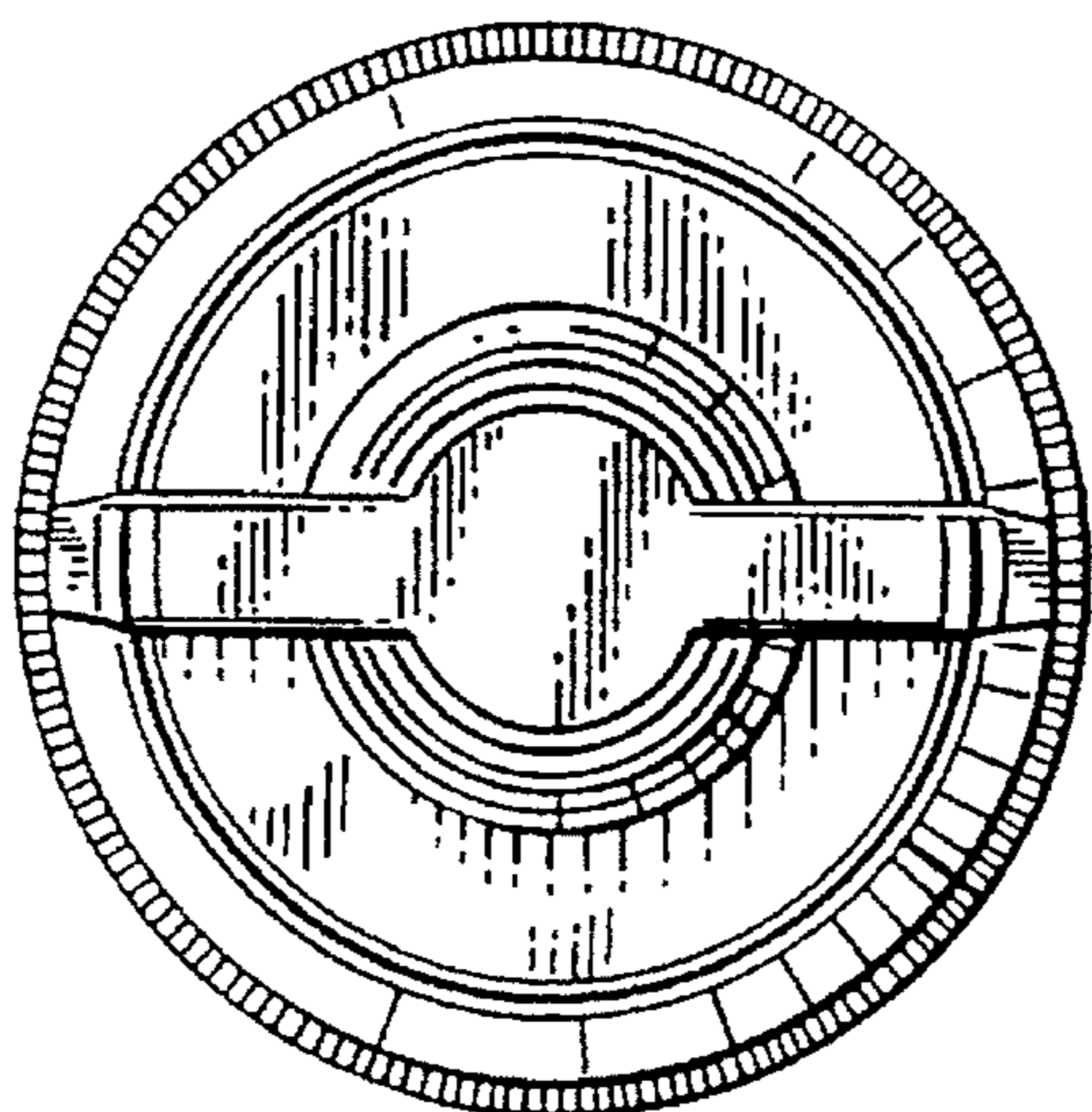

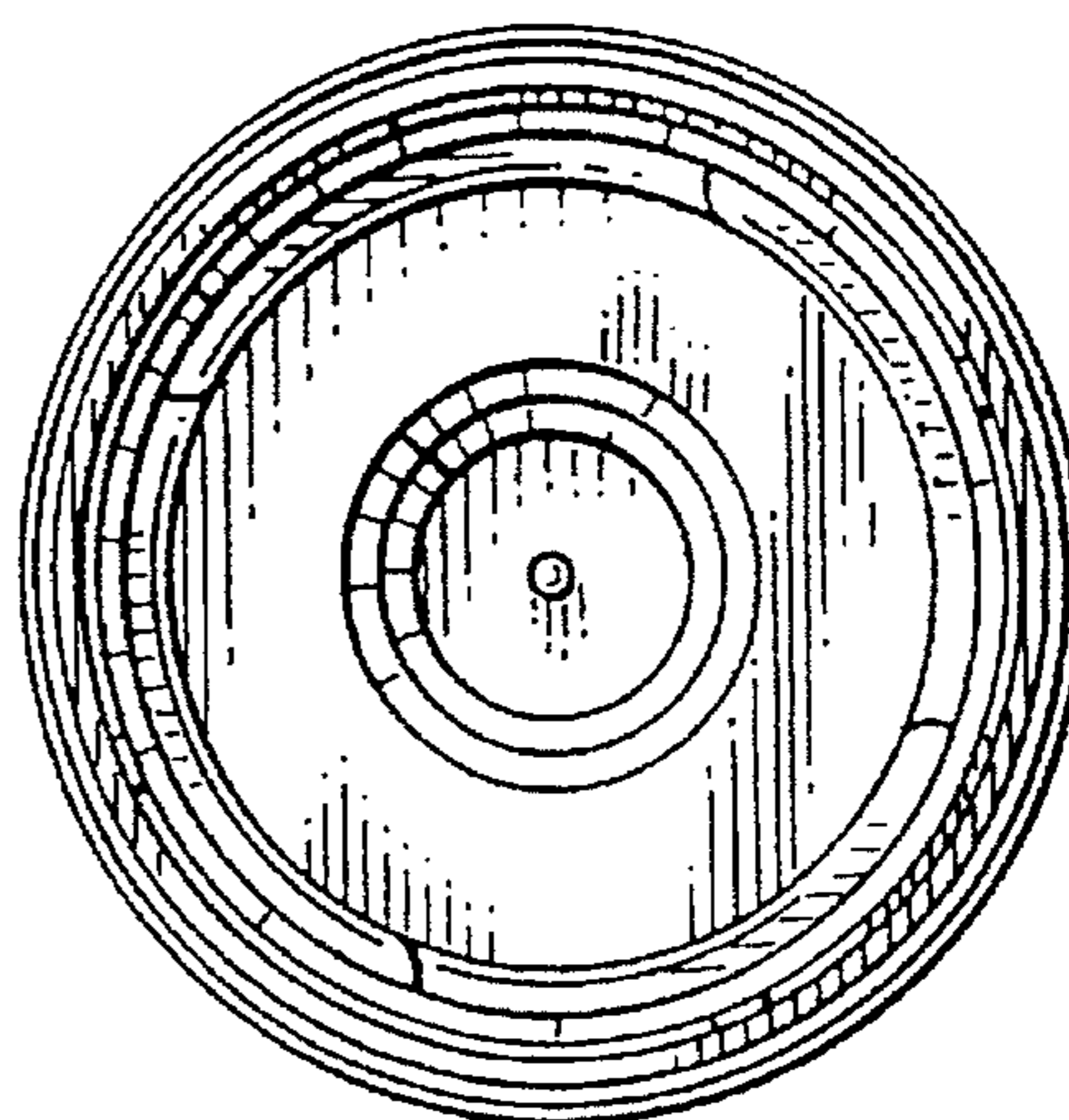
