FIG. 1 is a front elevational view of a spray bottle body showing our new design, the rear and side views are identical;

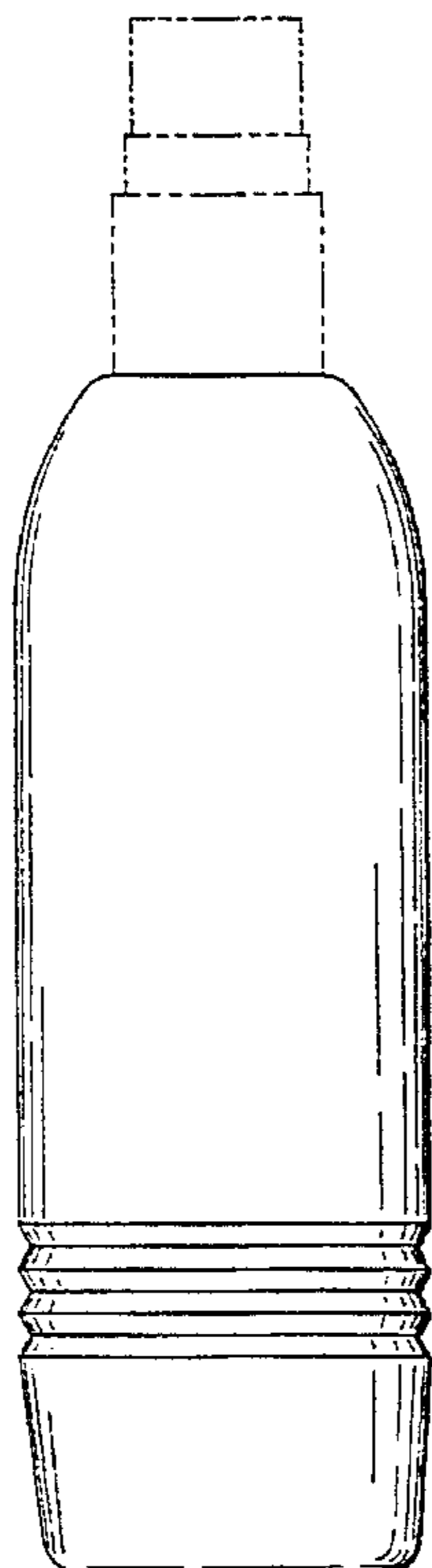
FIG. 2 is a top plan view thereof;

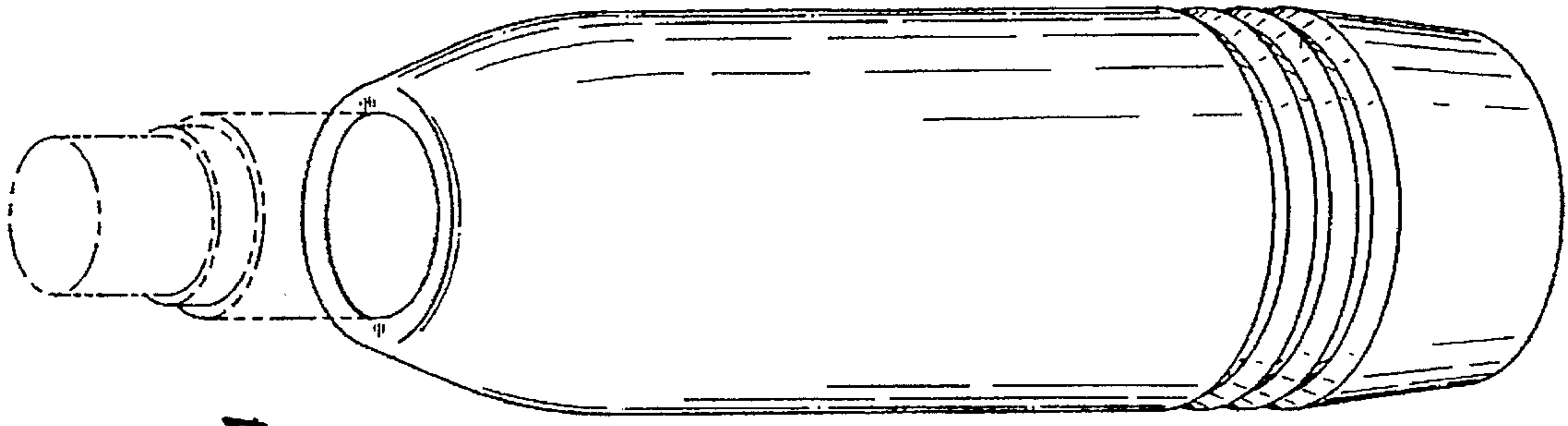

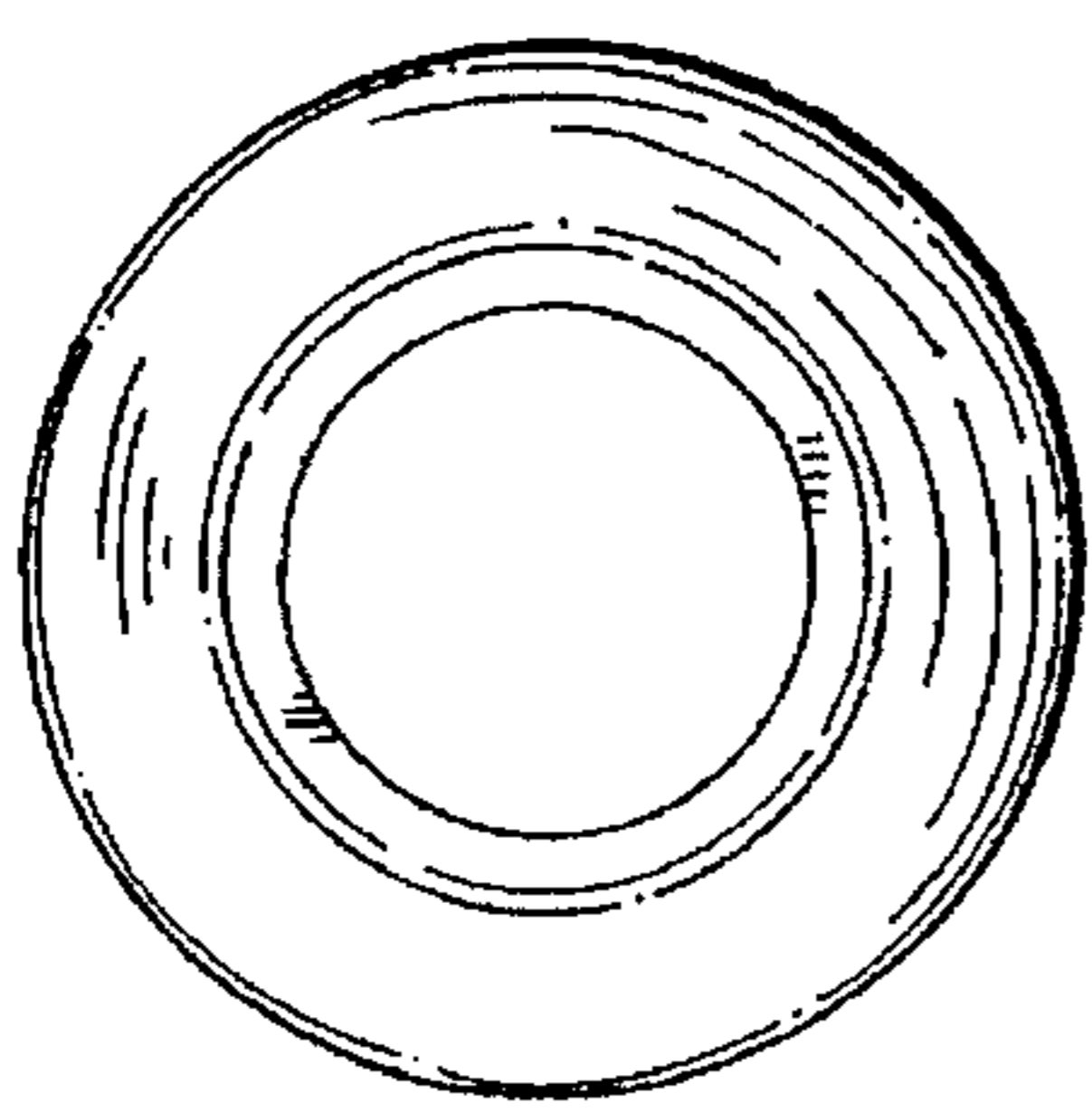

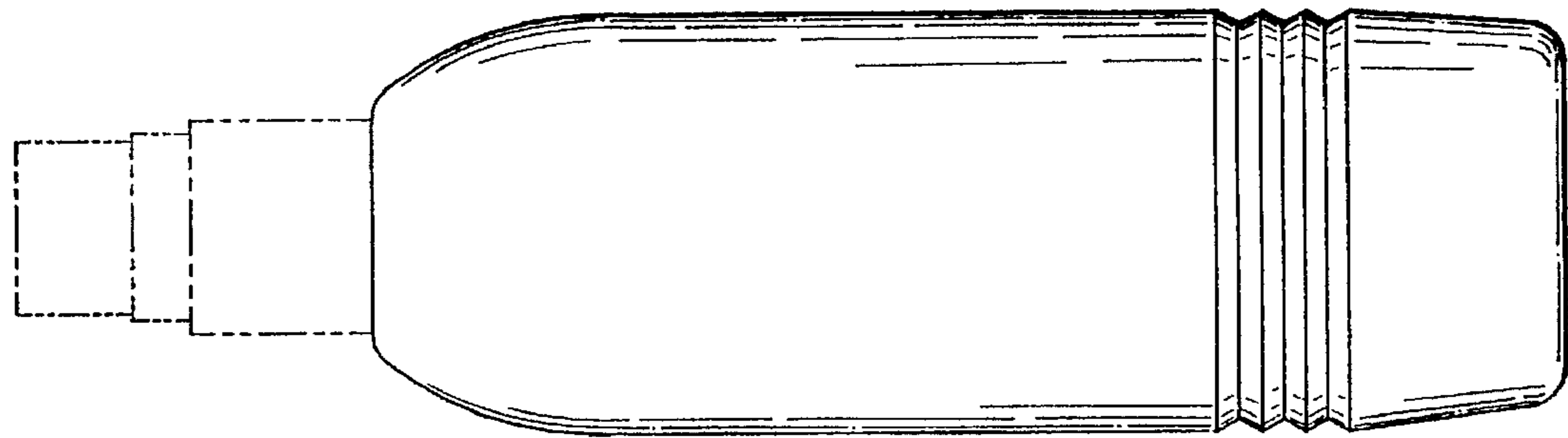
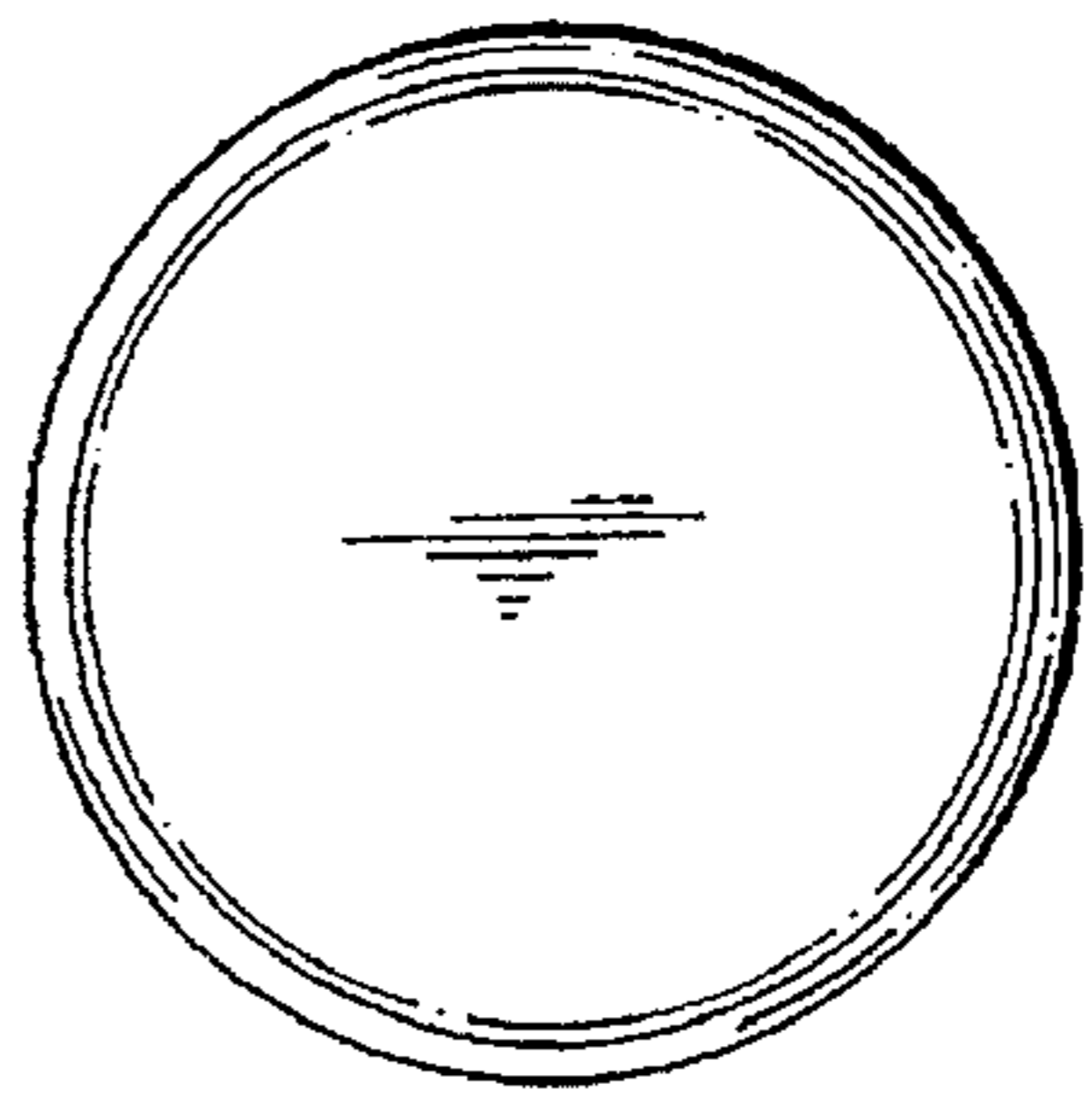
