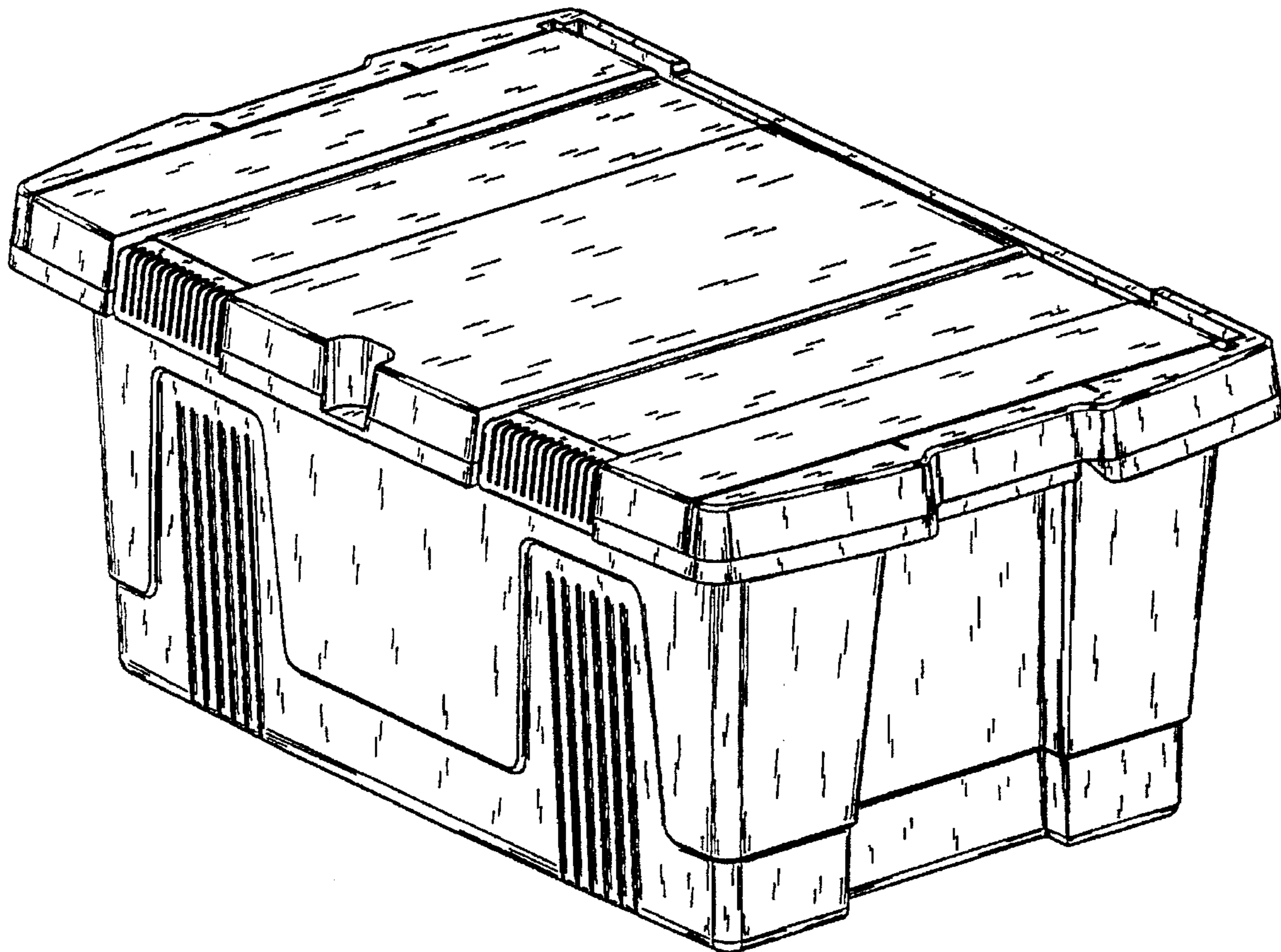
[57] **CLAIM**

The ornamental design for a storage container with recessed removable lid, as shown and described.

DESCRIPTION

FIG. 1 is an isometric projection of a storage container with recessed removable lid showing the new design; FIG. 2 is a front side elevational view thereof; FIG. 3 is a rear side elevational view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; and, FIG. 6 is an end elevational view thereof.

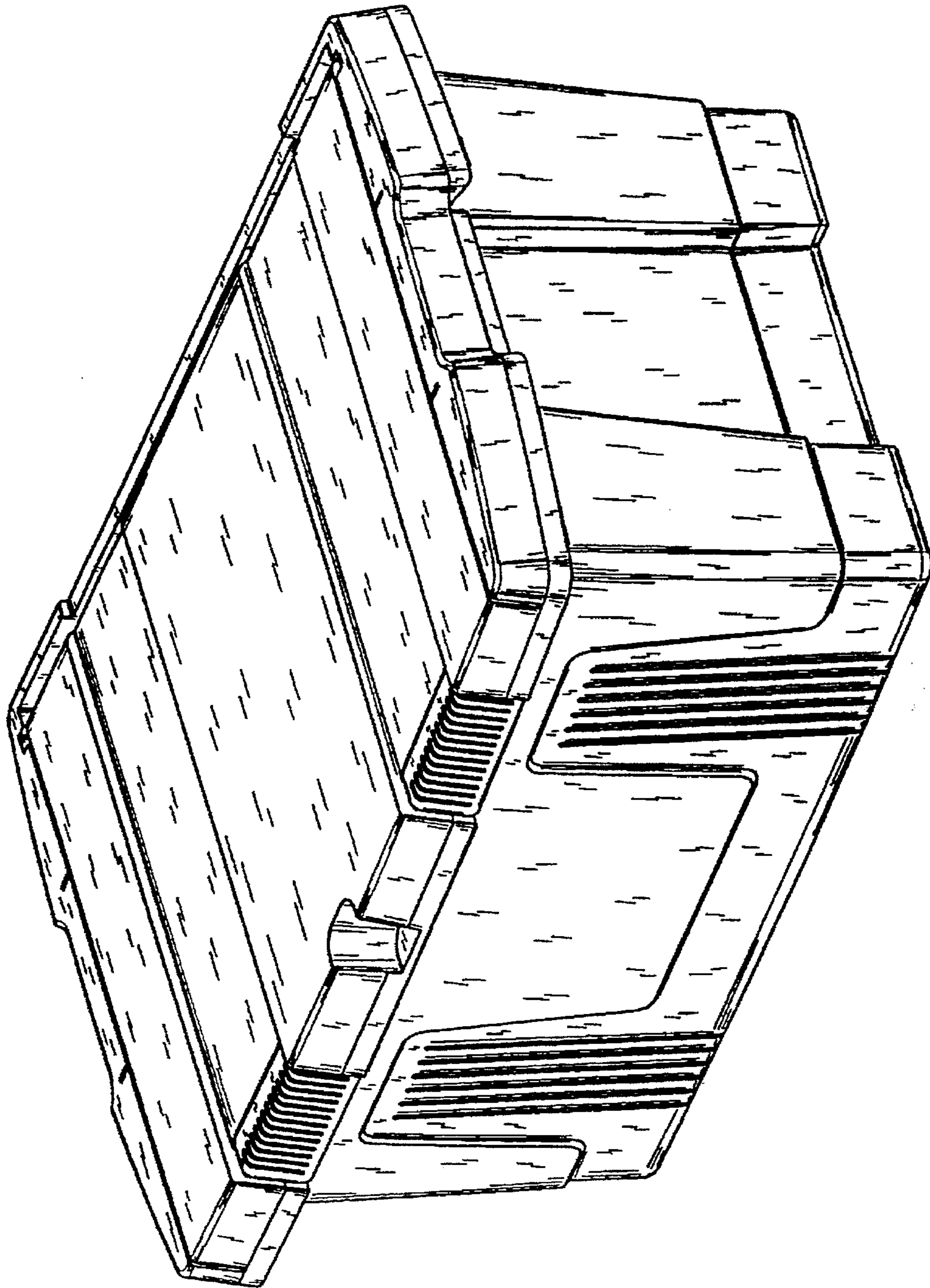

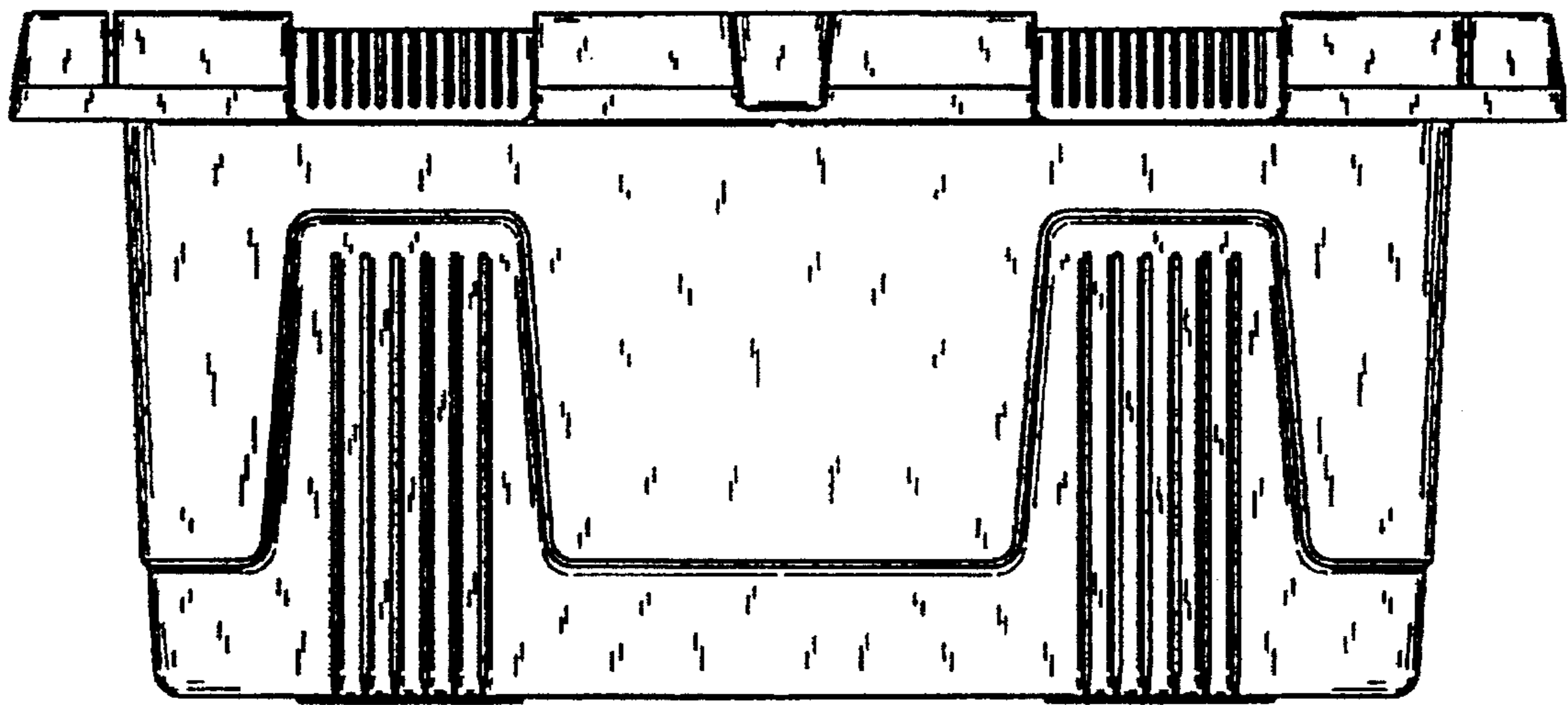

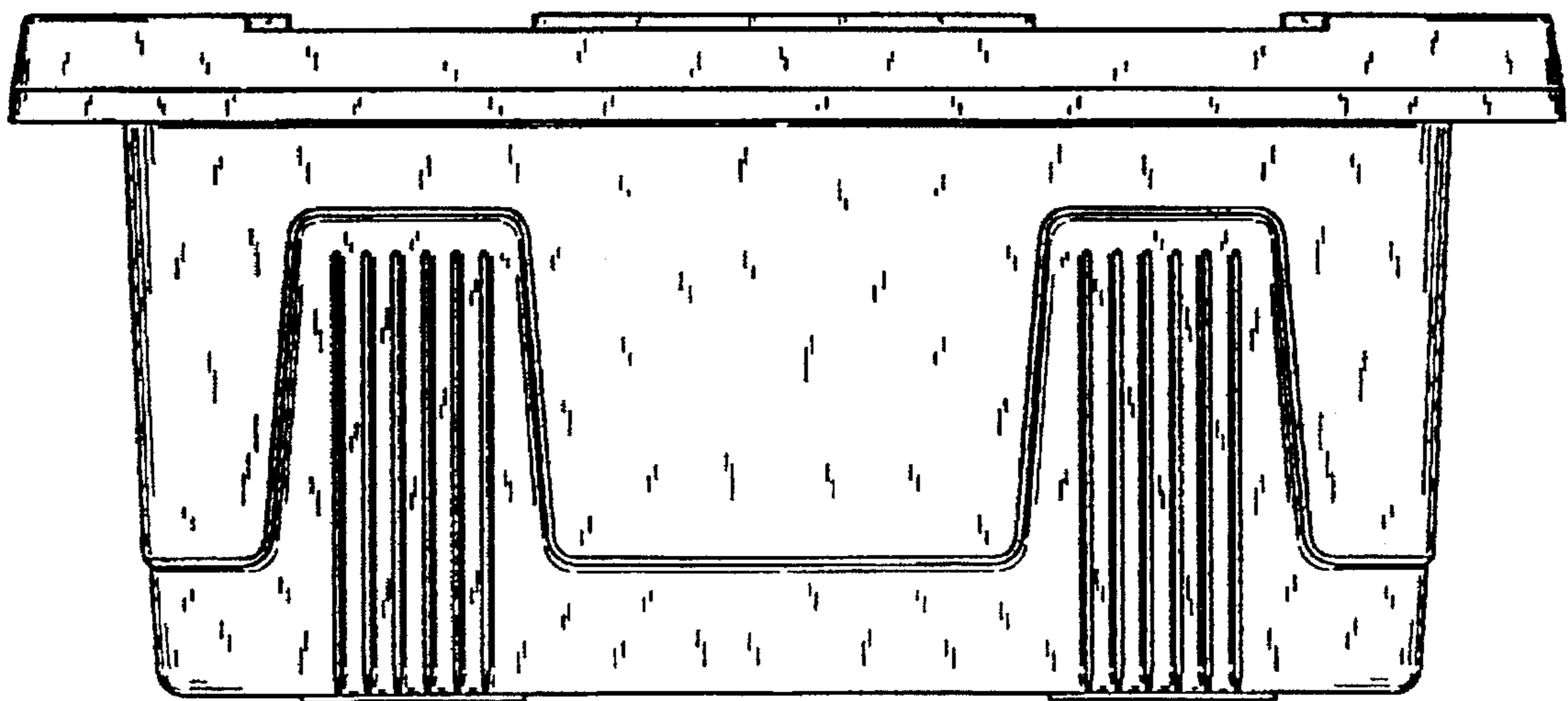

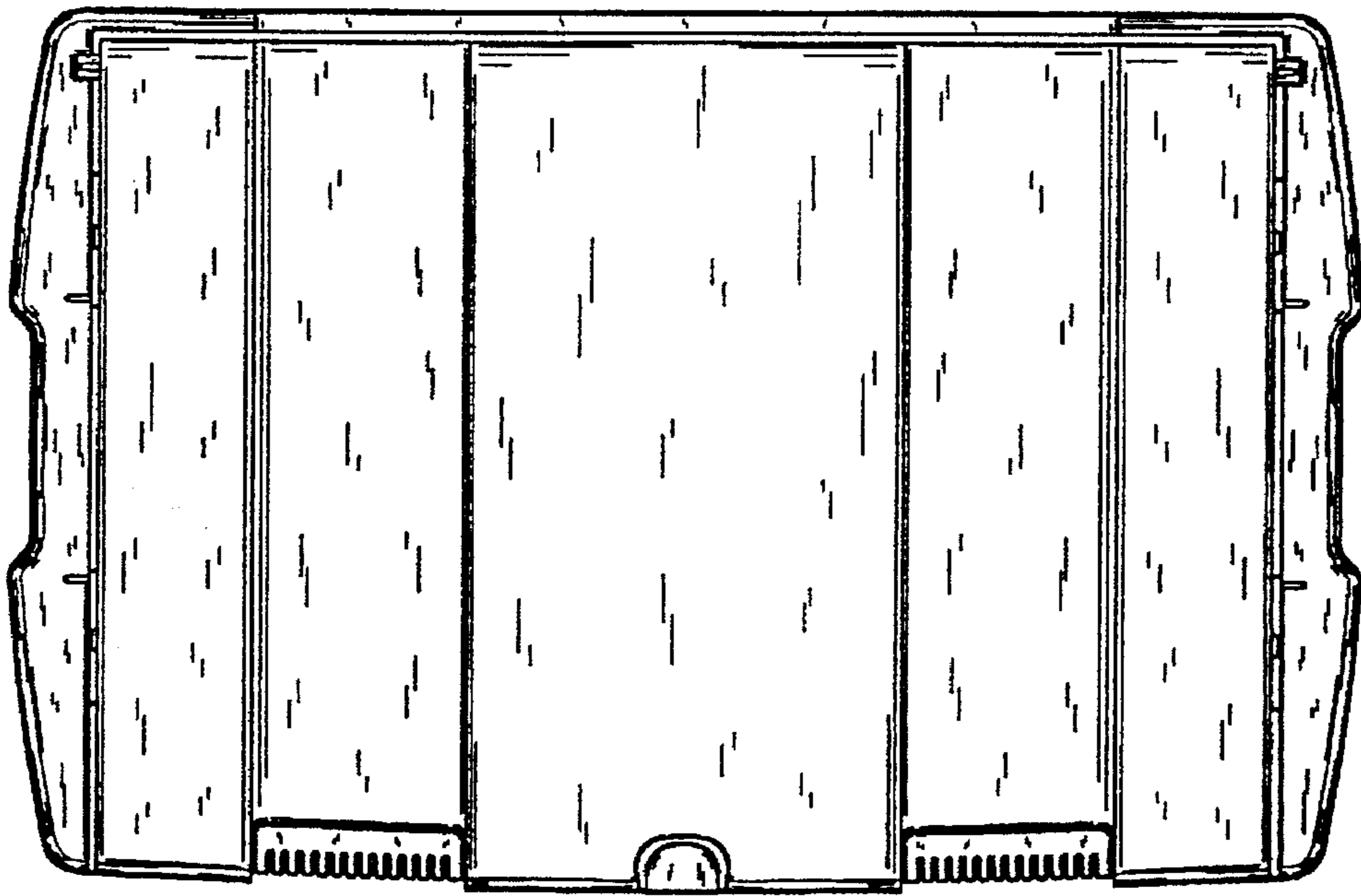

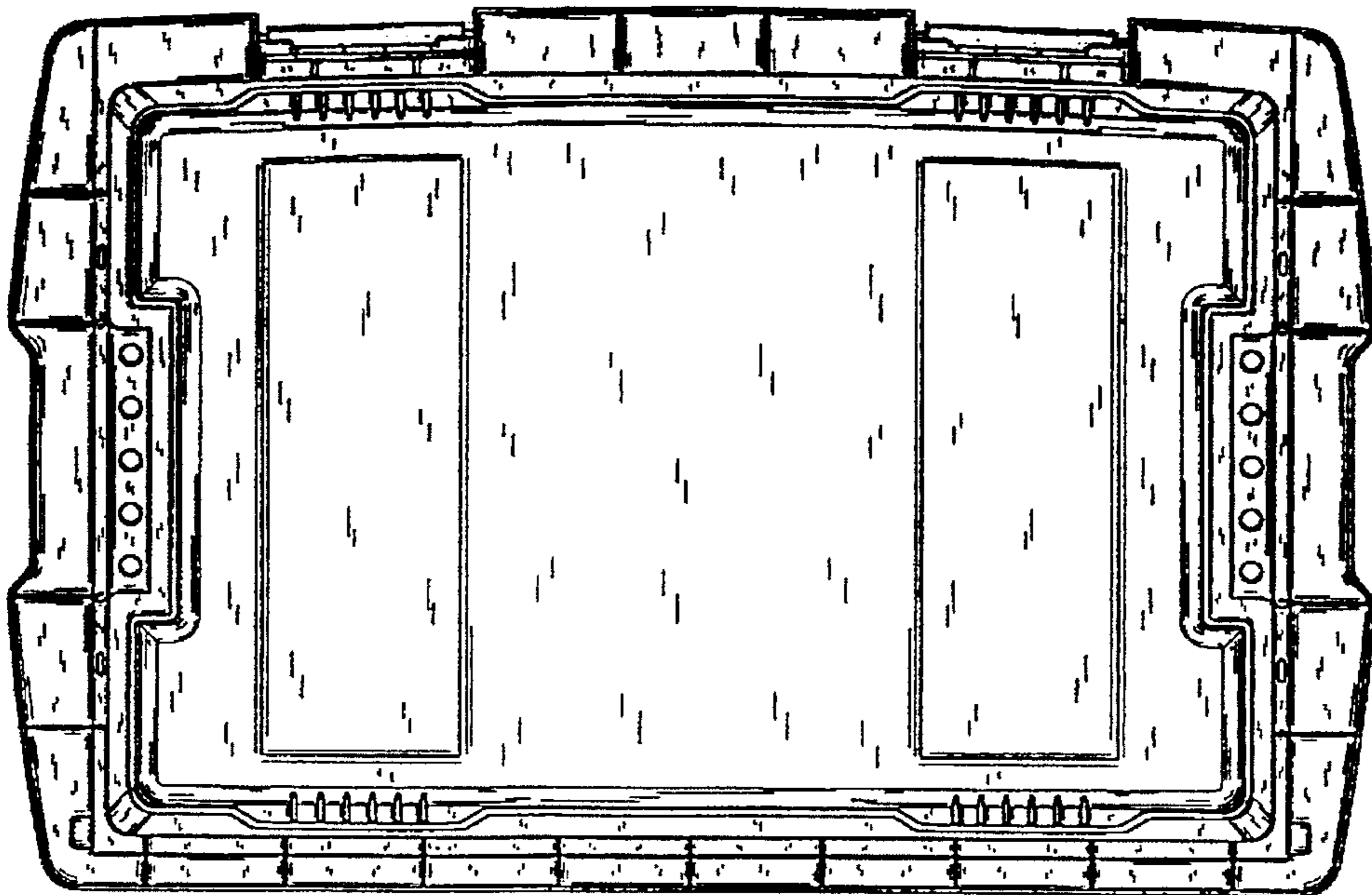

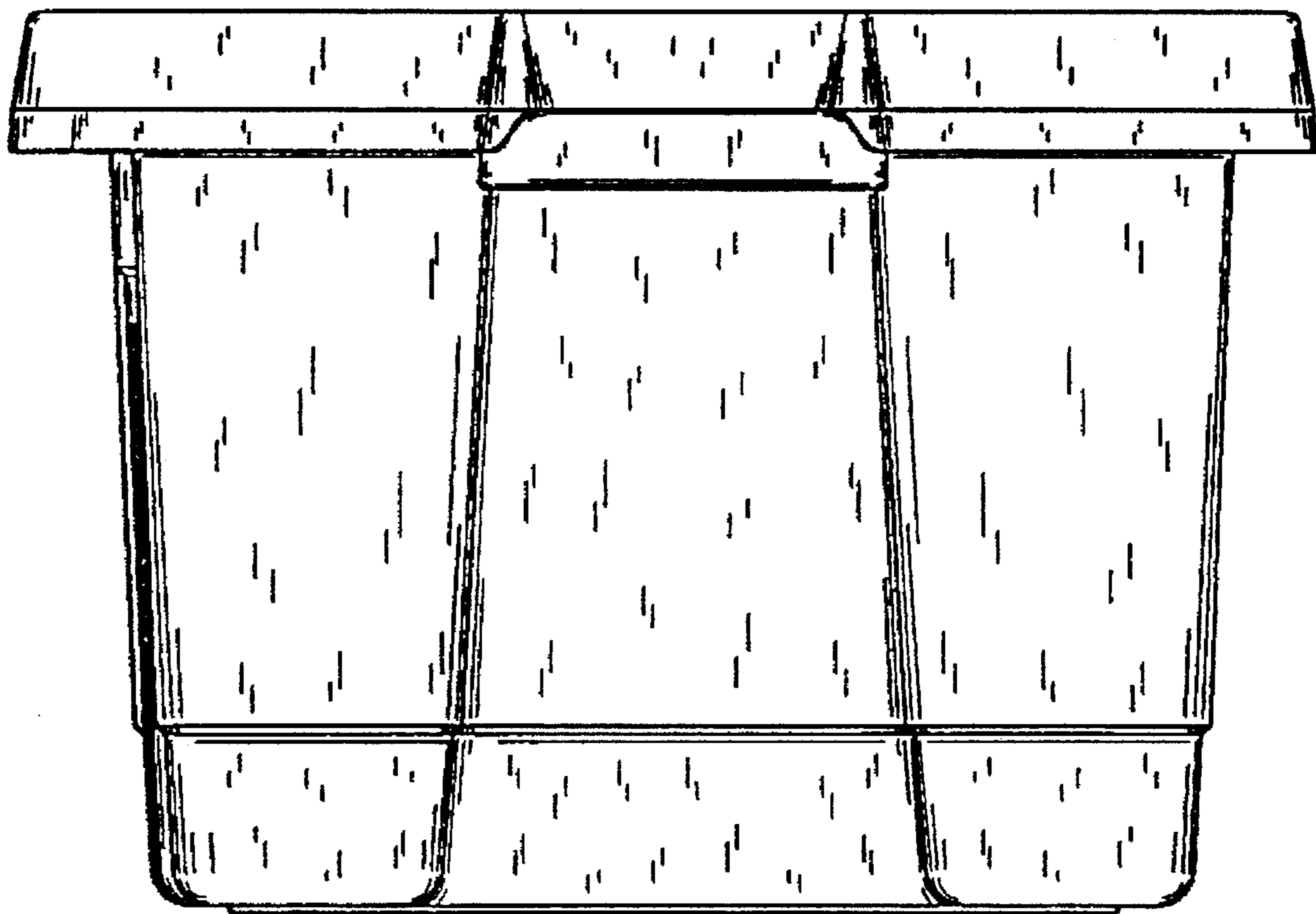
