[57] **CLAIM**

The ornamental design for a housing for rolled paper products, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a housing for rolled paper products, showing a first embodiment of the new design;

FIG. 2 is a right side view of the housing for rolled paper products of FIG. 1, the left side being a mirror image thereof;

FIG. 3 is a top view of the housing for rolled paper products of FIG. 1;

FIG. 4 is a bottom view of the housing for rolled paper products of FIG. 1;

FIG. 5 is a front view of a housing for rolled paper products, showing a second embodiment of the new design;

FIG. 6 is a right side view of the housing for rolled paper products of FIG. 5, the left side being a mirror image thereof;

FIG. 7 is a top view of the housing for rolled paper products of FIG. 5;

FIG. 8 is a bottom view of the housing for rolled paper products of FIG. 5;

FIG. 9 is a front view of a housing for rolled paper products, showing a third embodiment of the new design;

FIG. 10 is a right side view of the housing for rolled paper products of FIG. 9, the left side being a mirror image thereof;

FIG. 11 is a top view of the housing for rolled paper products of FIG. 9; and,

FIG. 12 is a bottom view of the housing for rolled paper products of FIG. 9.

The rear elevation of each embodiment of the housing for rolled paper products of the present invention is mounted against a wall or the like and is not ornamental.

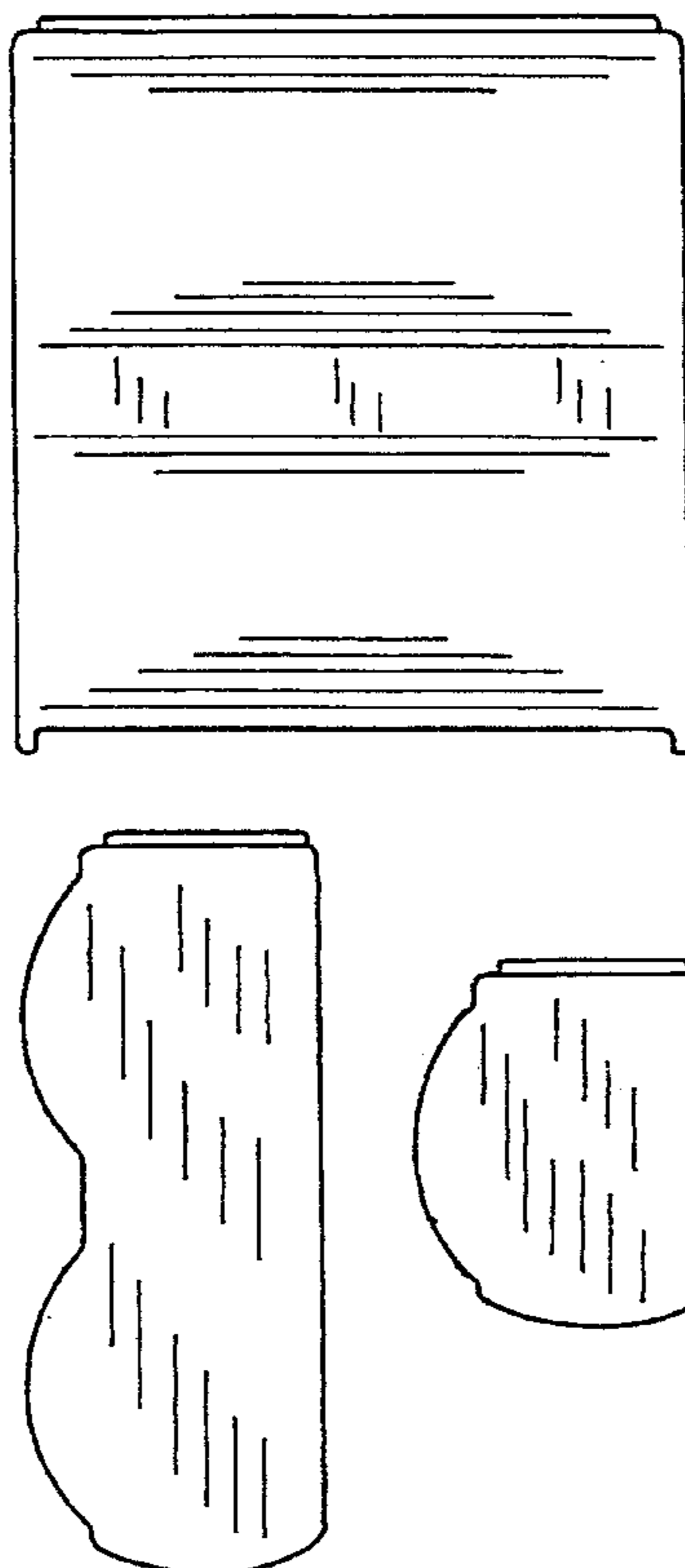

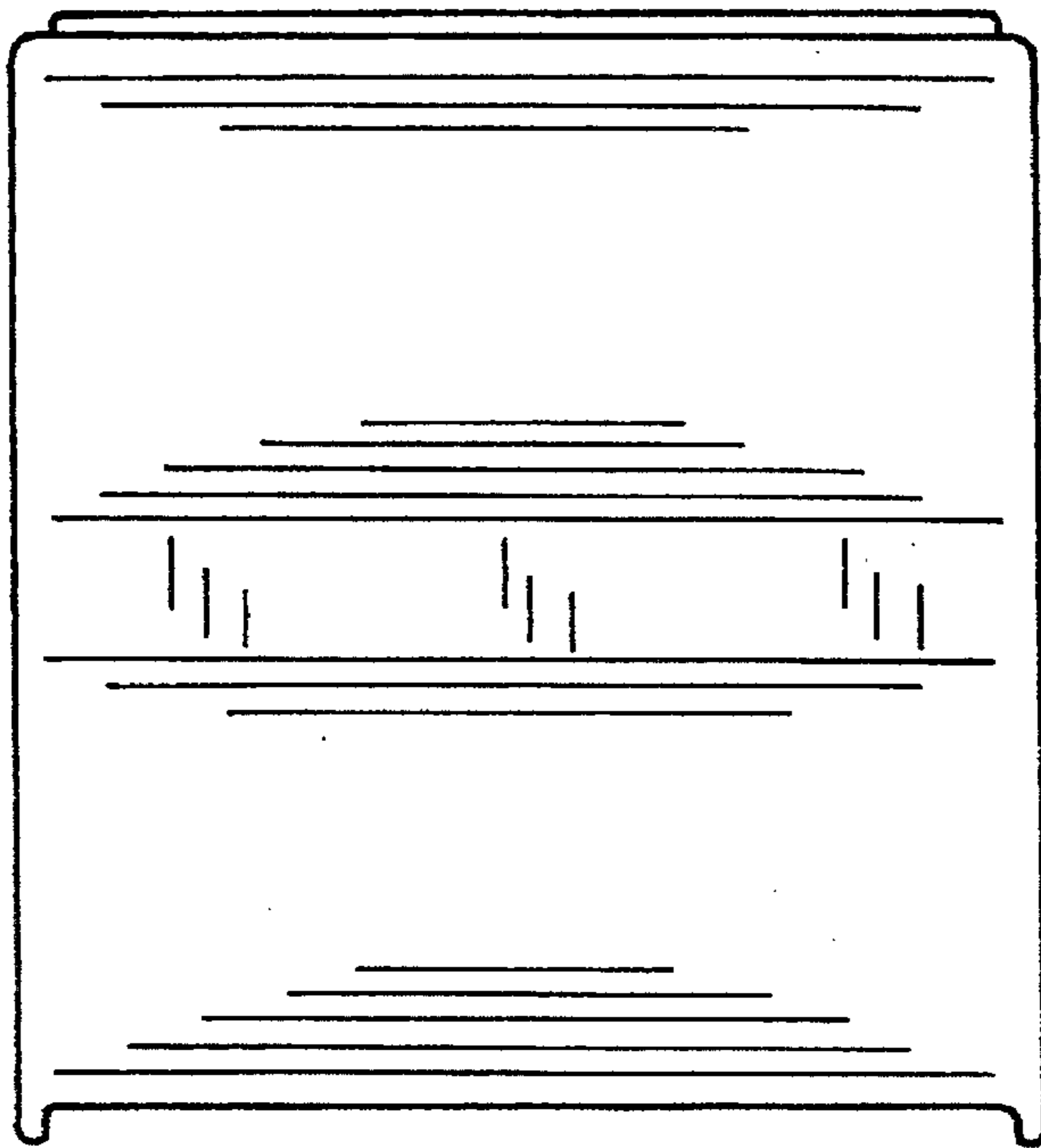

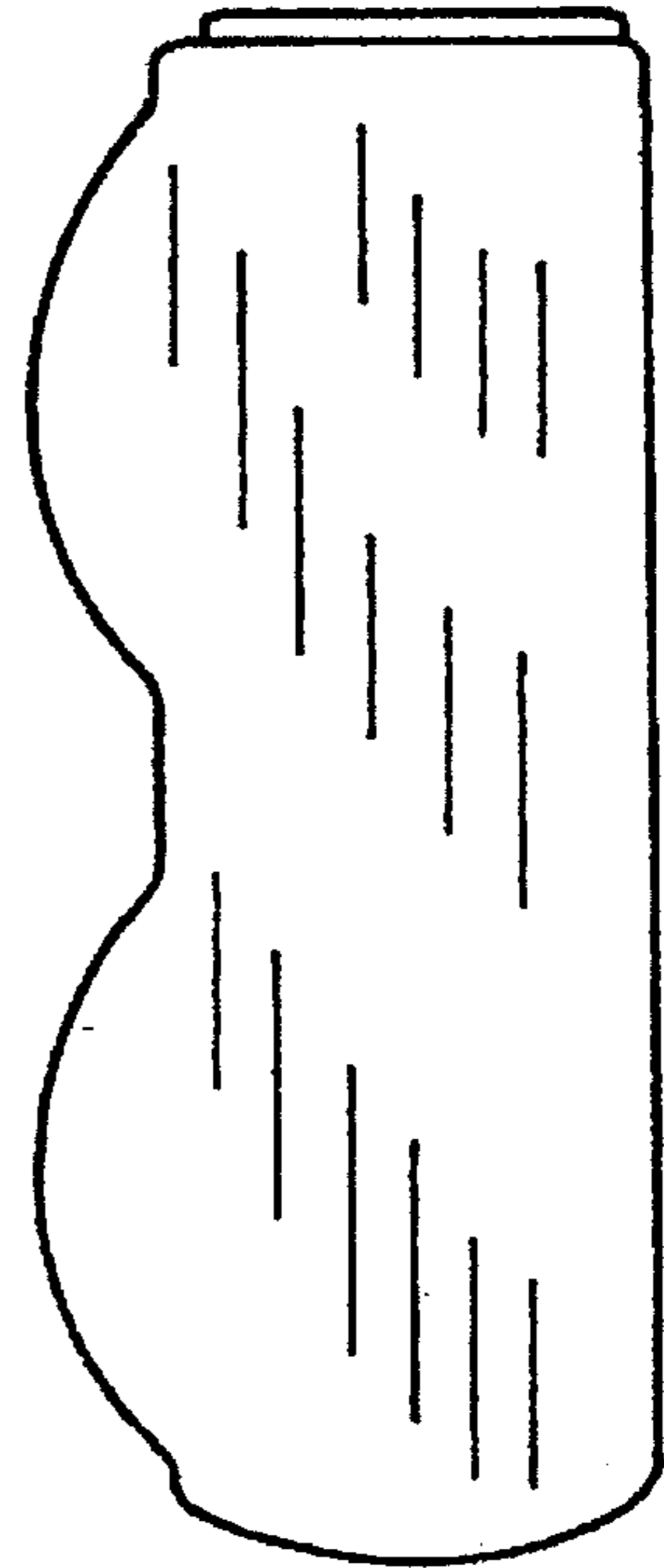

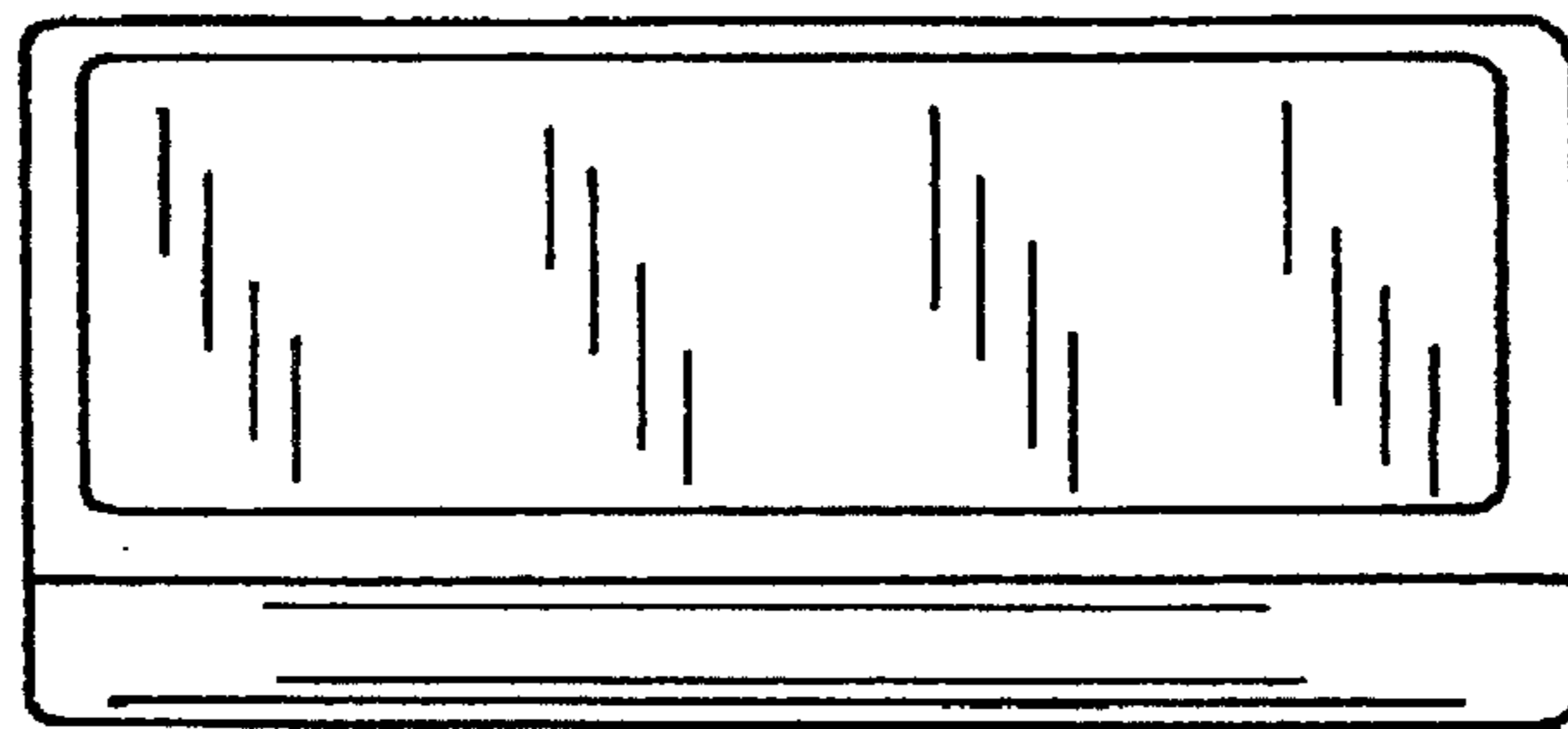

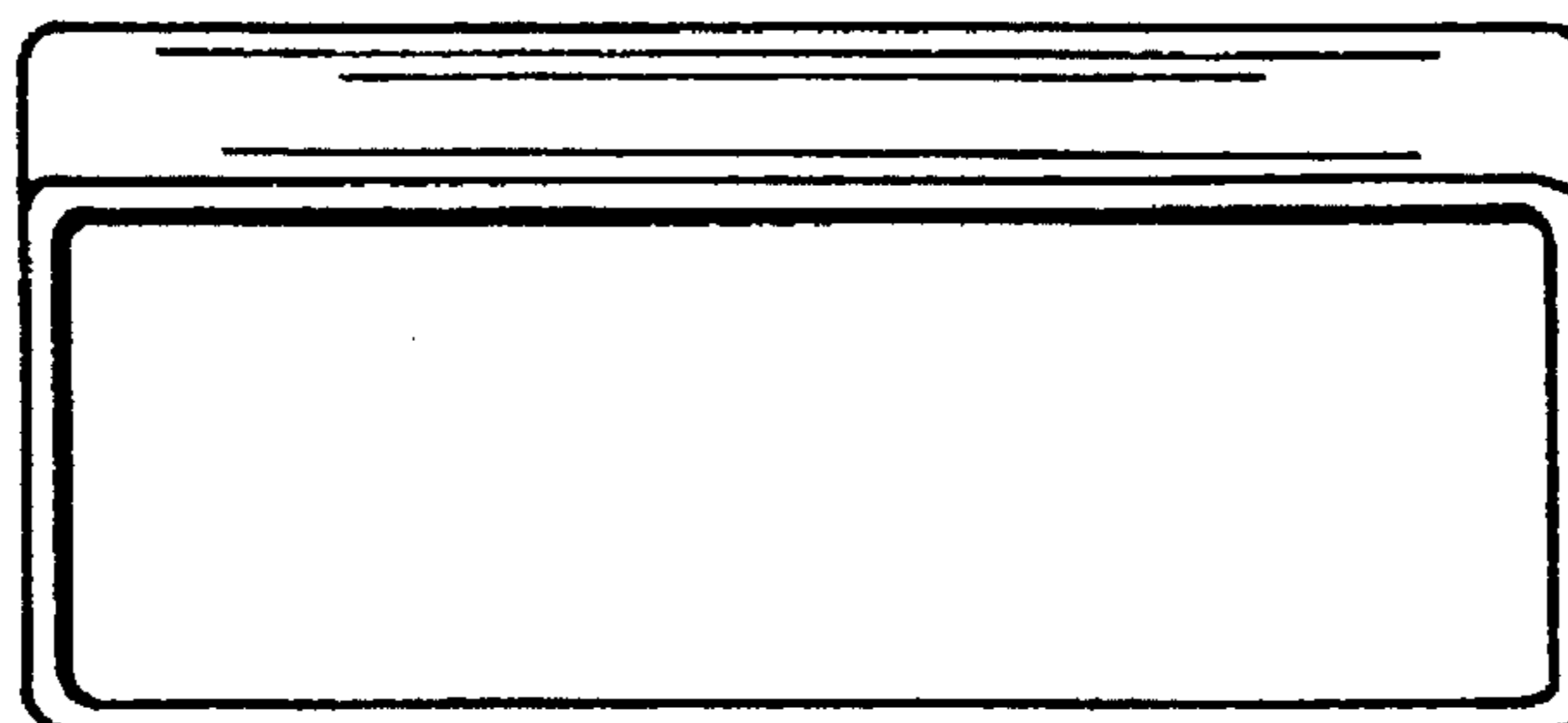

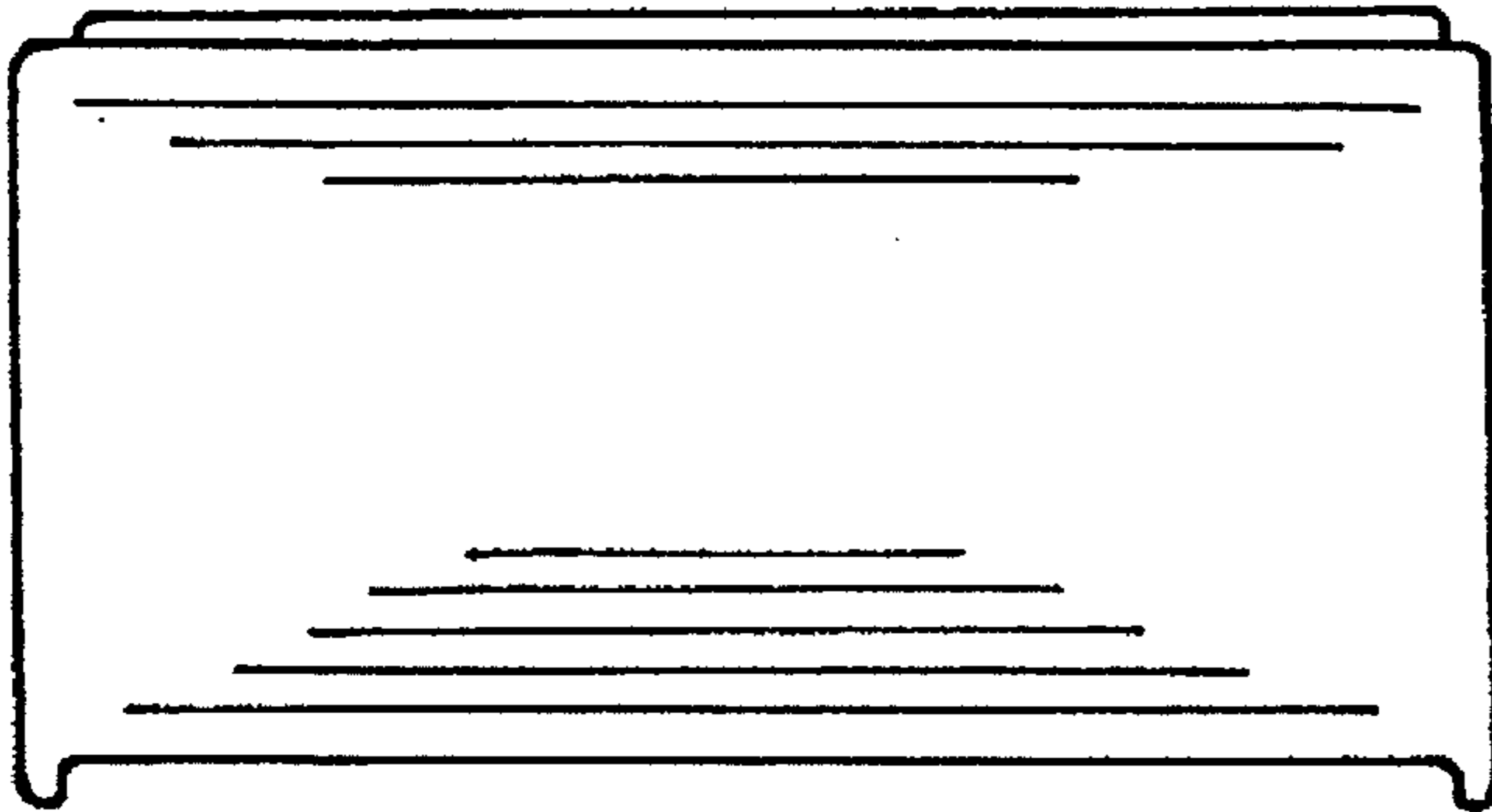

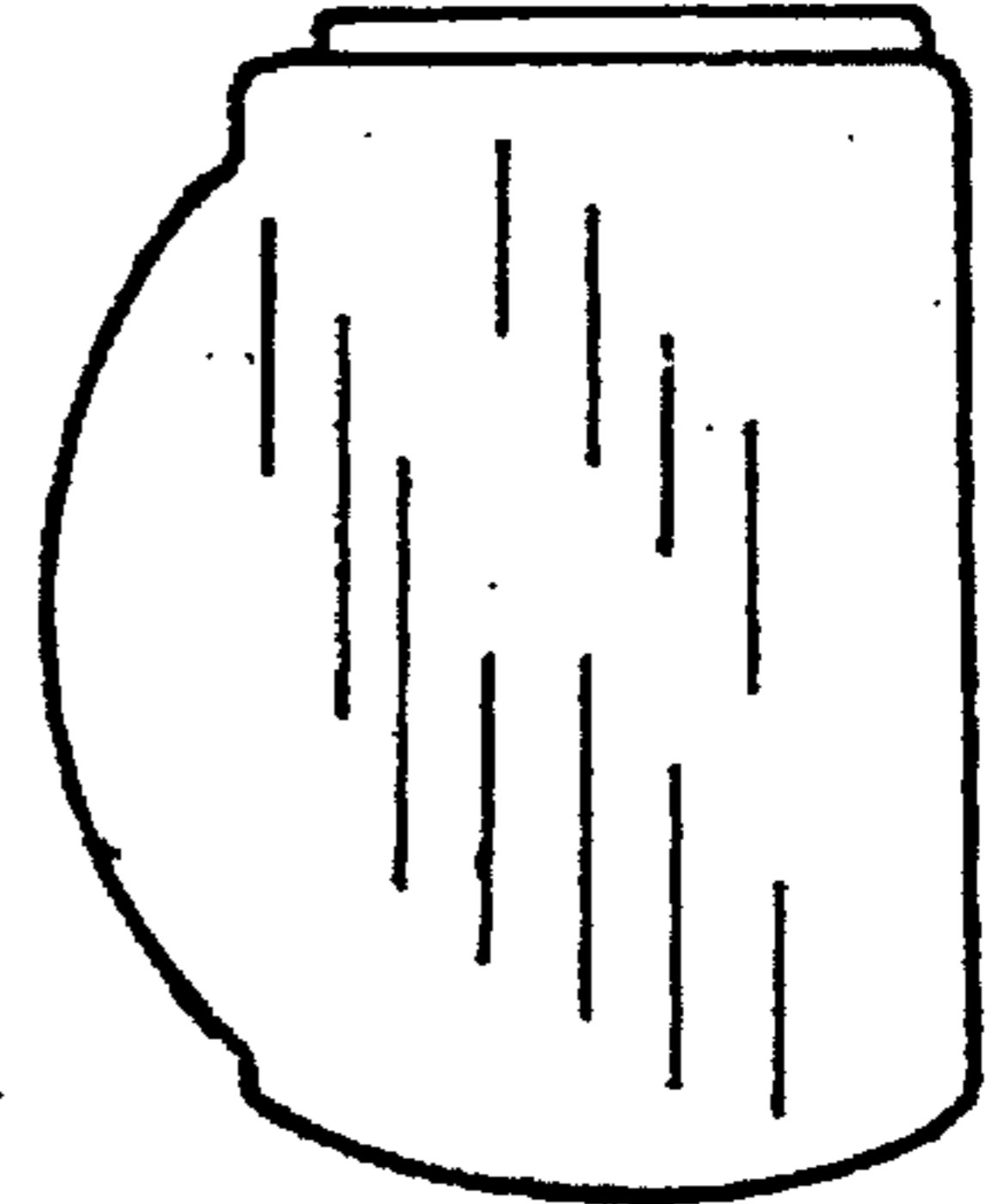

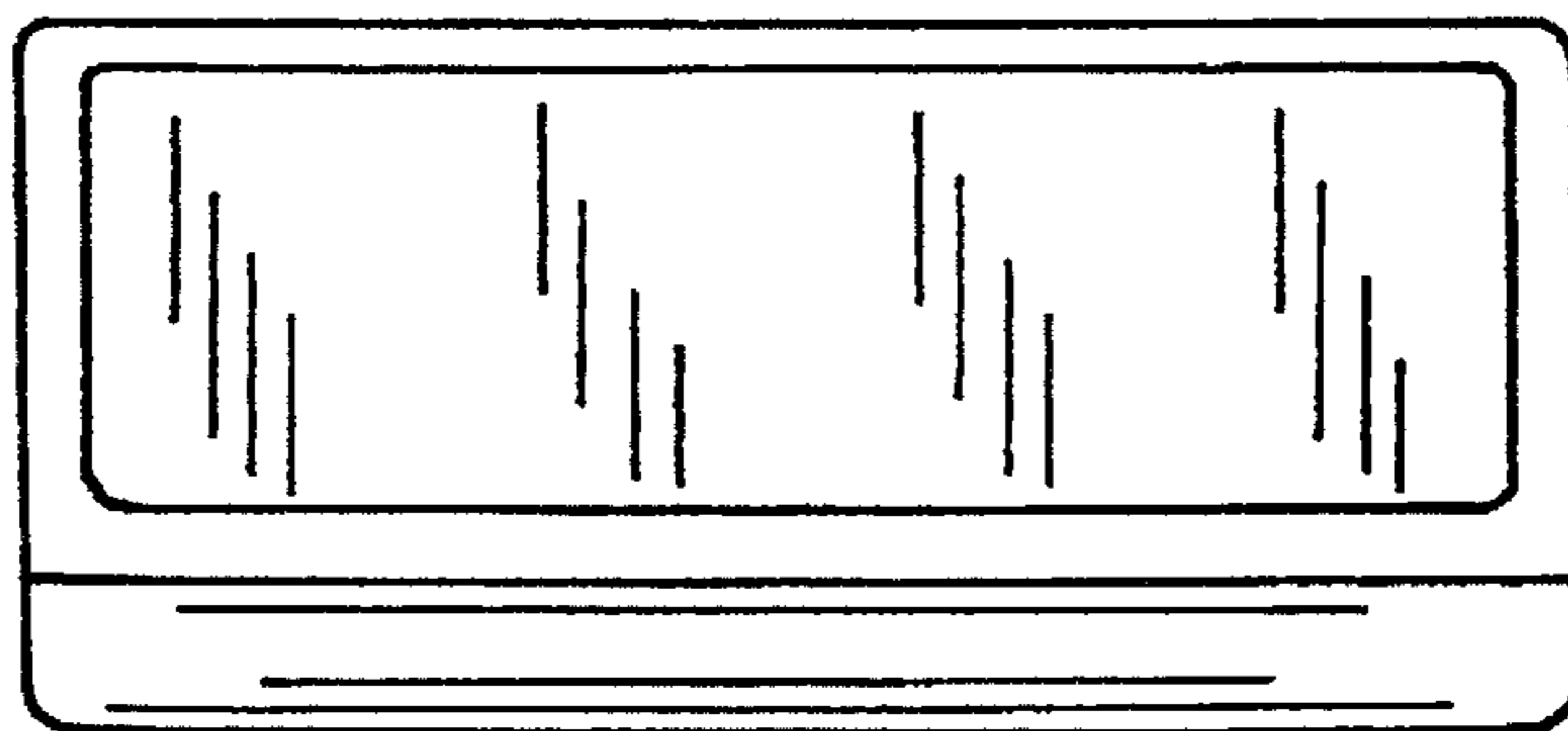

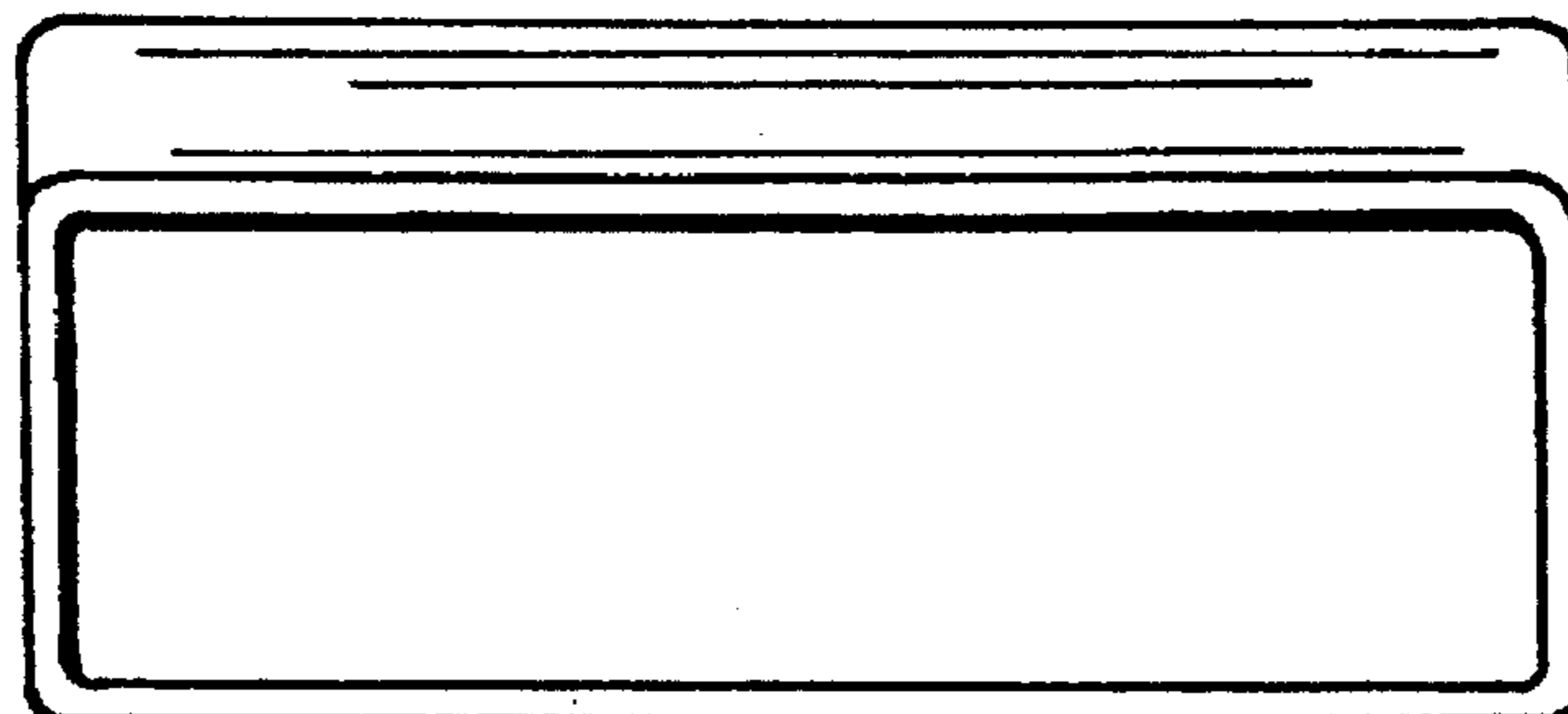

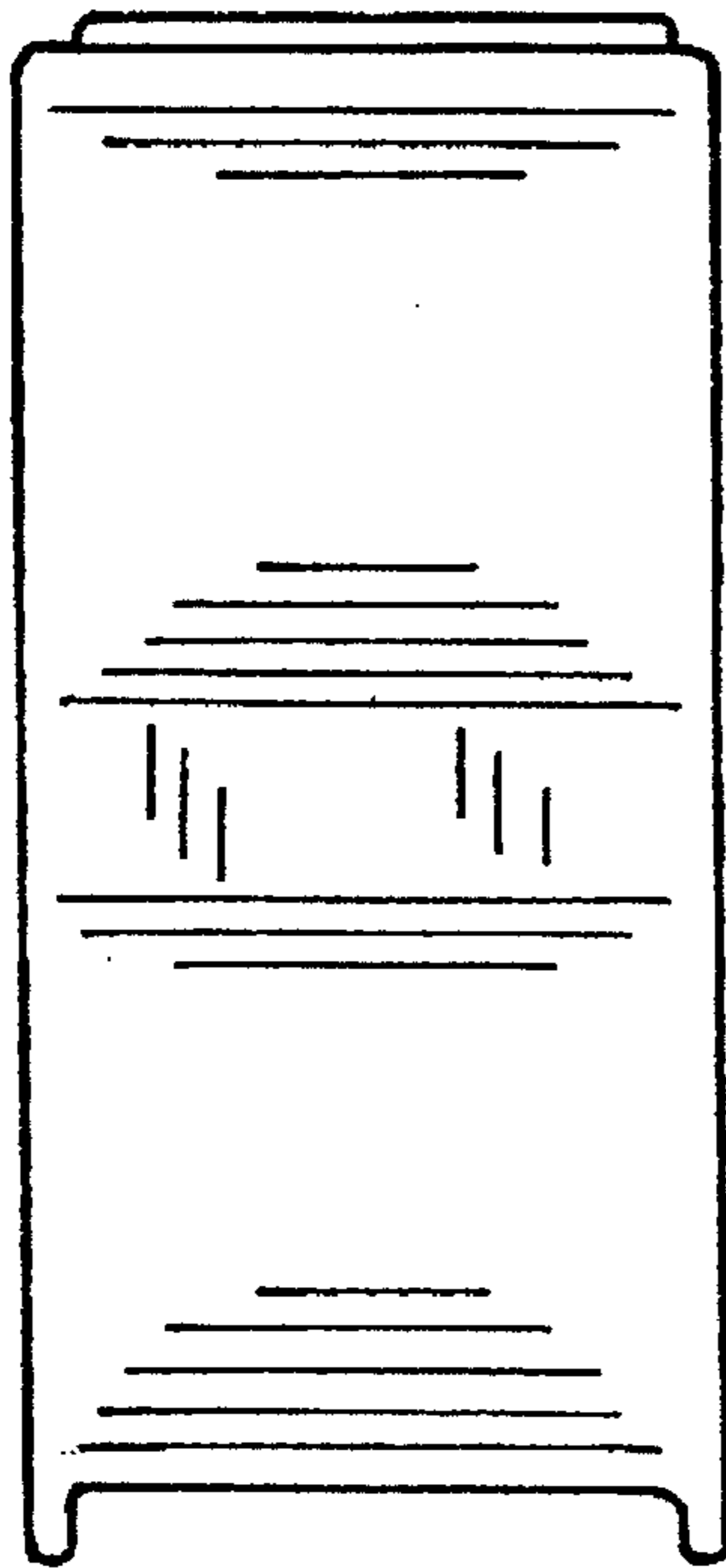

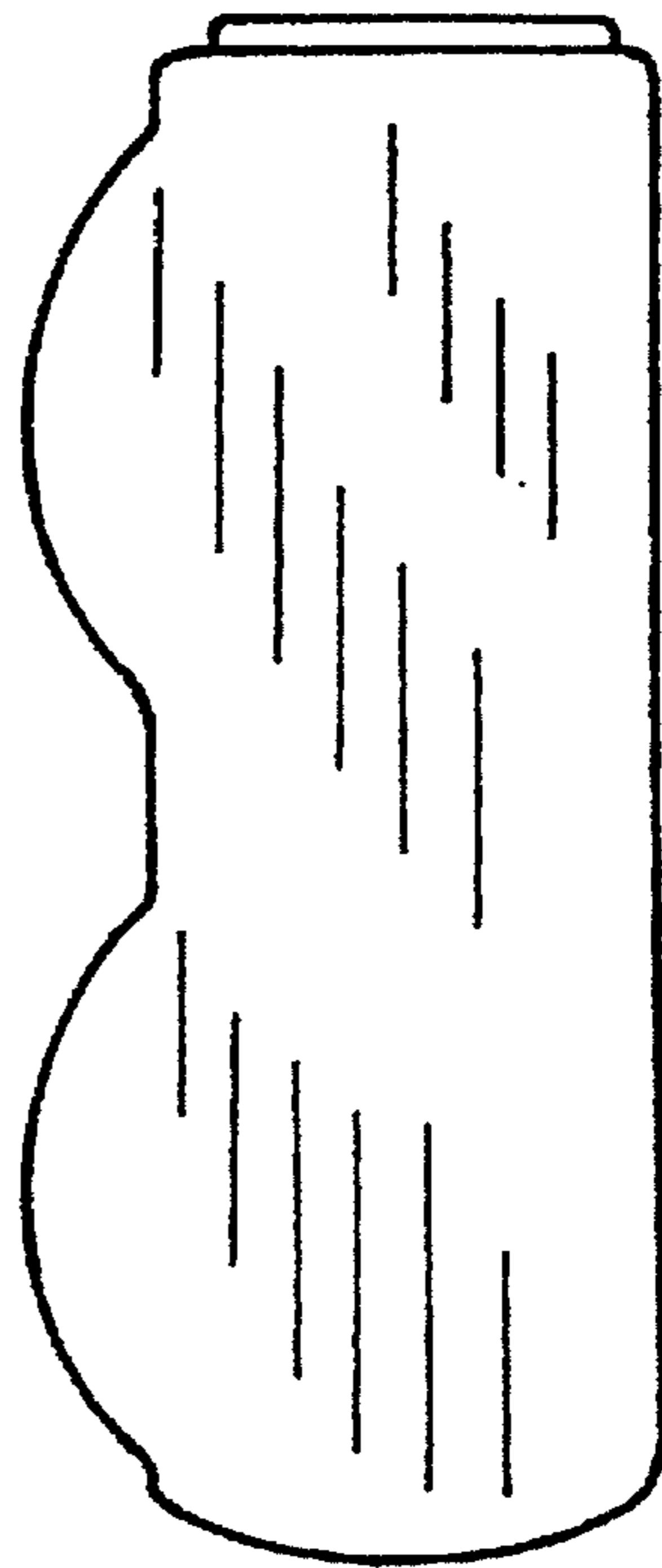

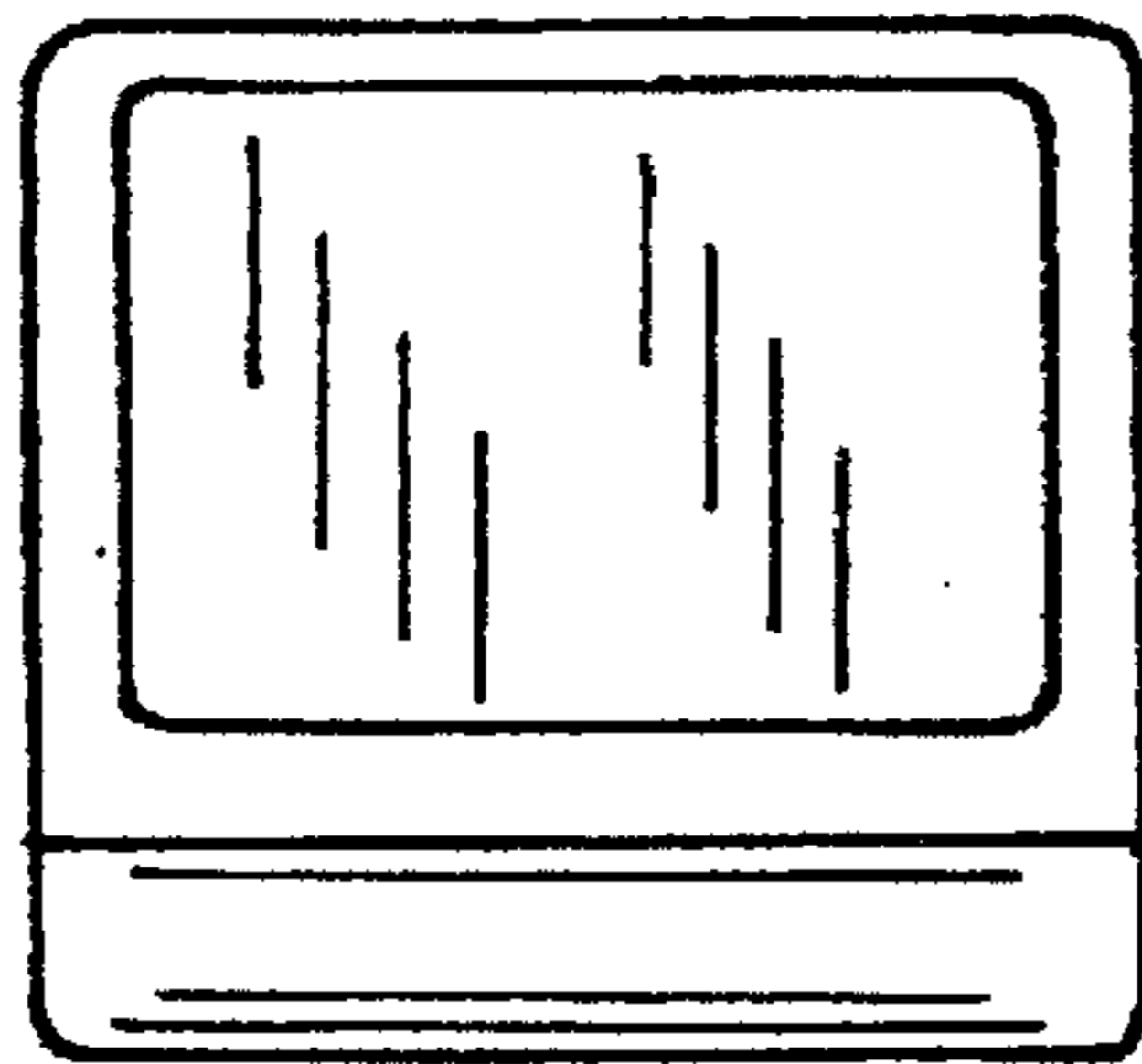
