### [57] CLAIM

The ornamental design for a compact disc equipment case, as shown and described.

### DESCRIPTION

FIG. 1 is a view showing the front design of the compact disc equipment case;  
FIG. 2 is a rear view of the FIG. 1 equipment case;  
FIG. 3 is a top plan view of the FIG. 1 equipment case, the bottom plan view being the same;  
FIG. 4 is a section taken on lines 4-4 of FIG. 1;  
FIG. 5 is a right side view of the FIG. 1 equipment case, the left side view being the same;  
FIG. 6 is a section taken on lines 6-6 of FIG. 1; and,  
FIG. 7 is a perspective view showing the equipment case in folded condition.  
The broken line showing of the pen, notepad and compact disks in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

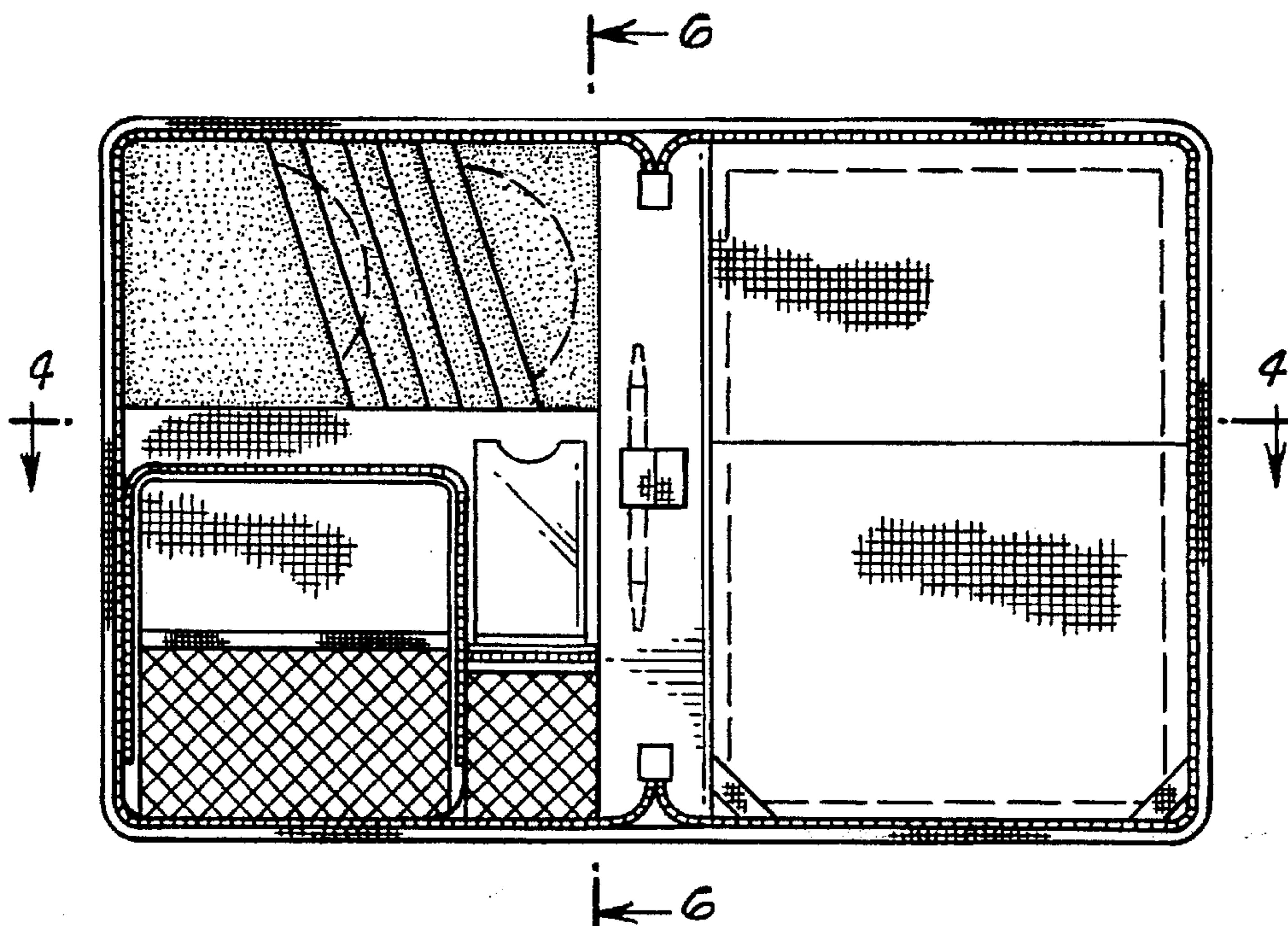

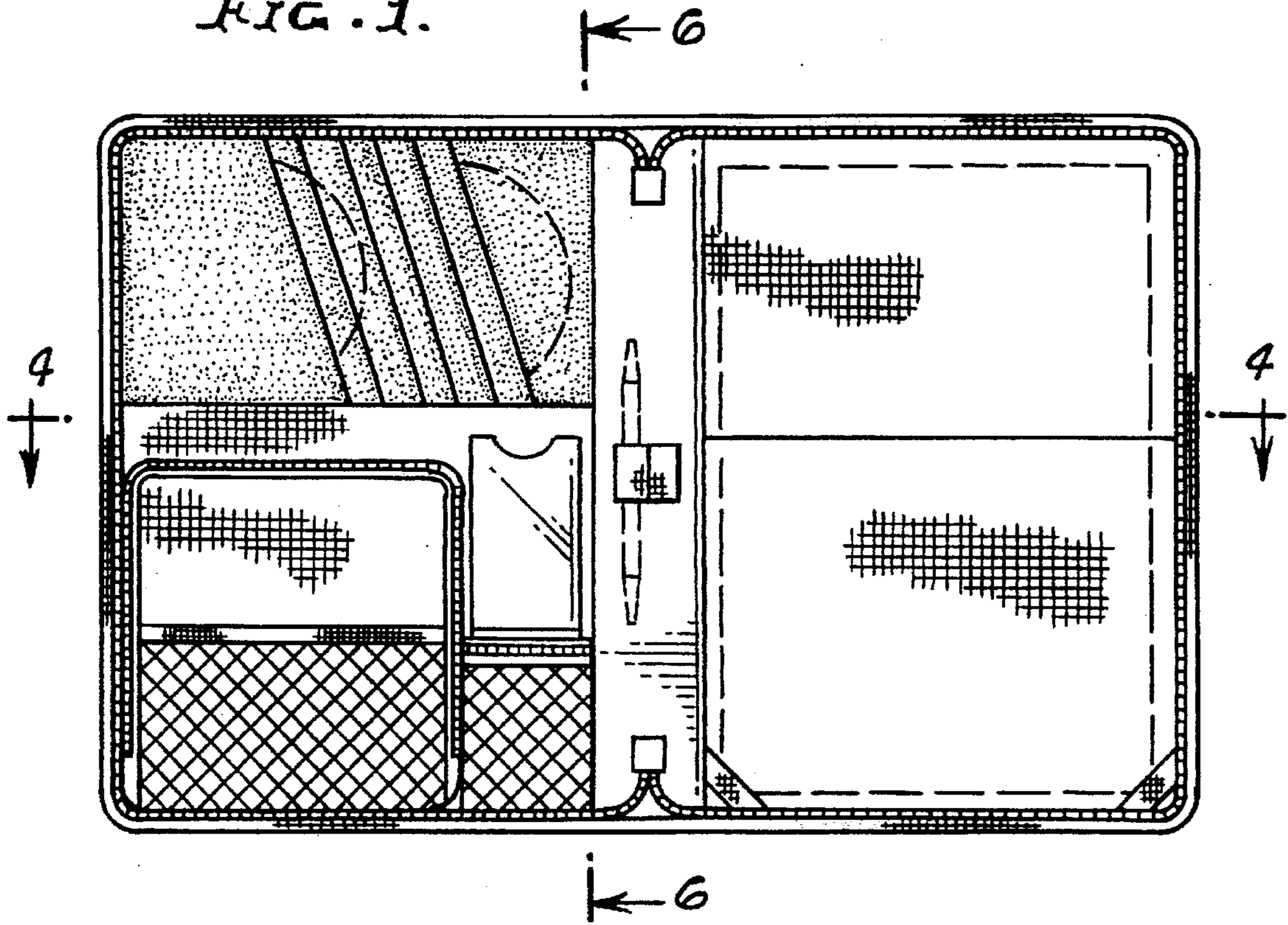

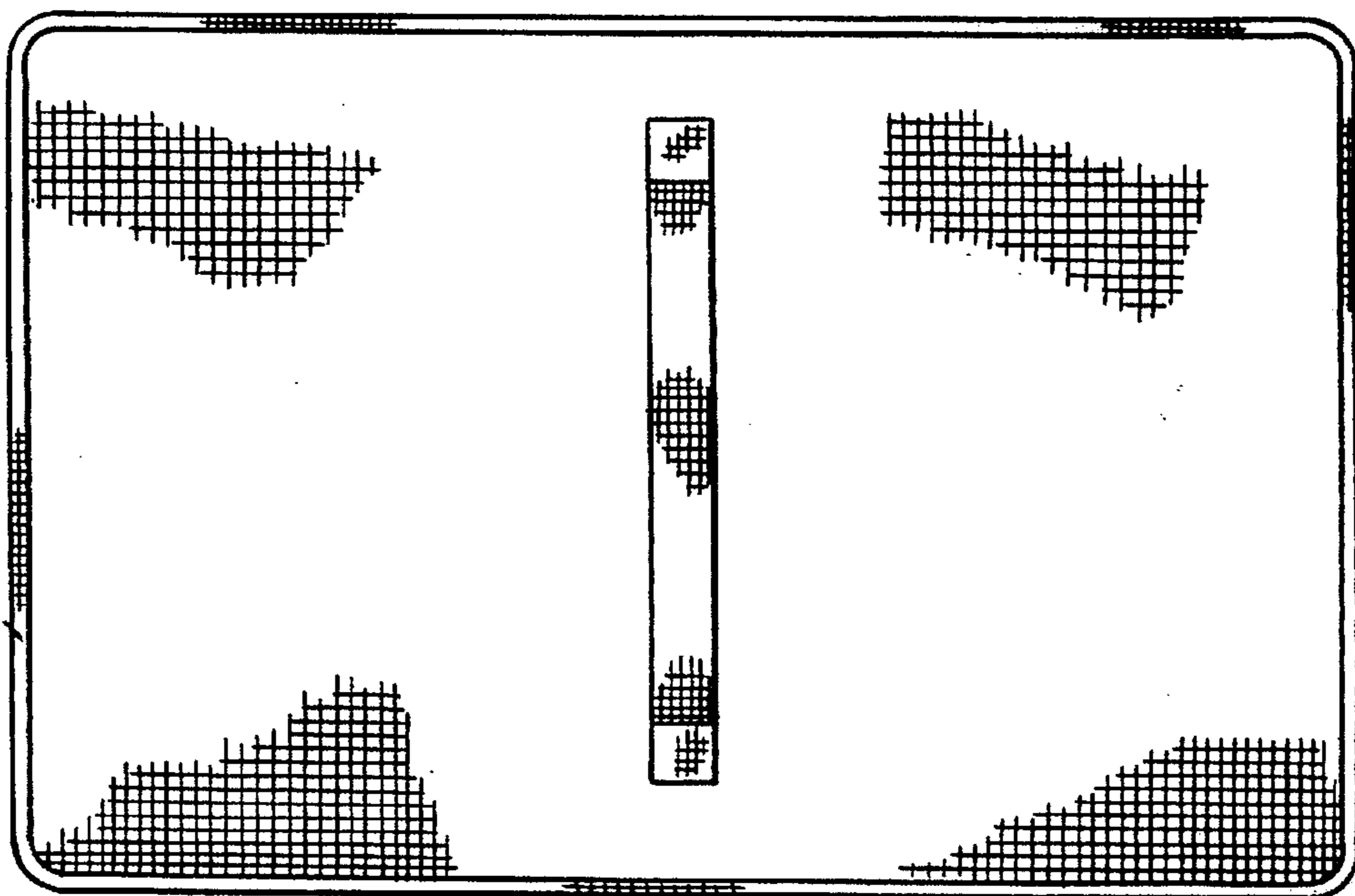

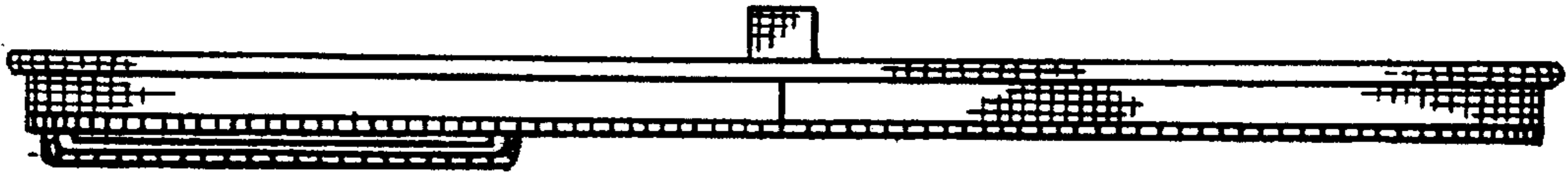

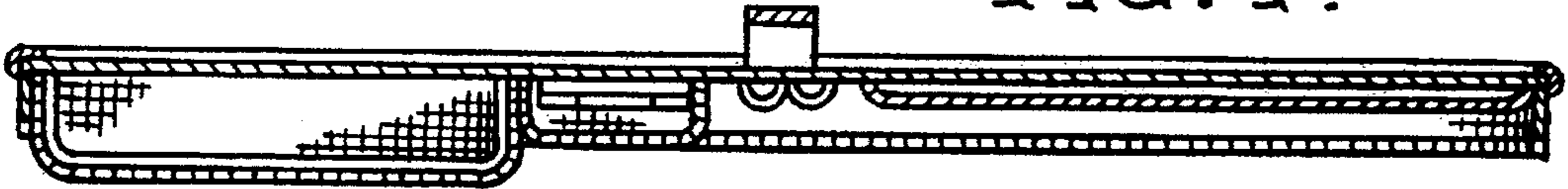

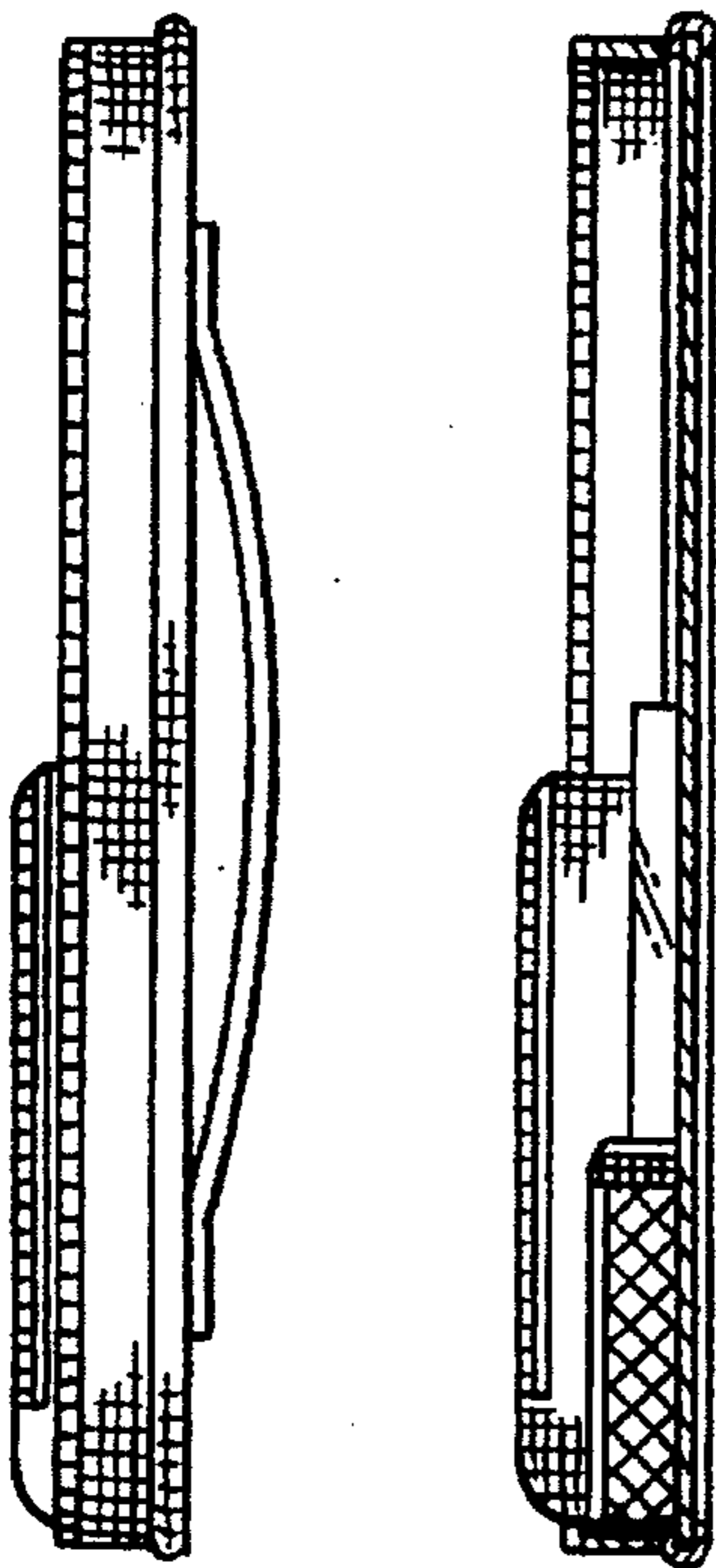

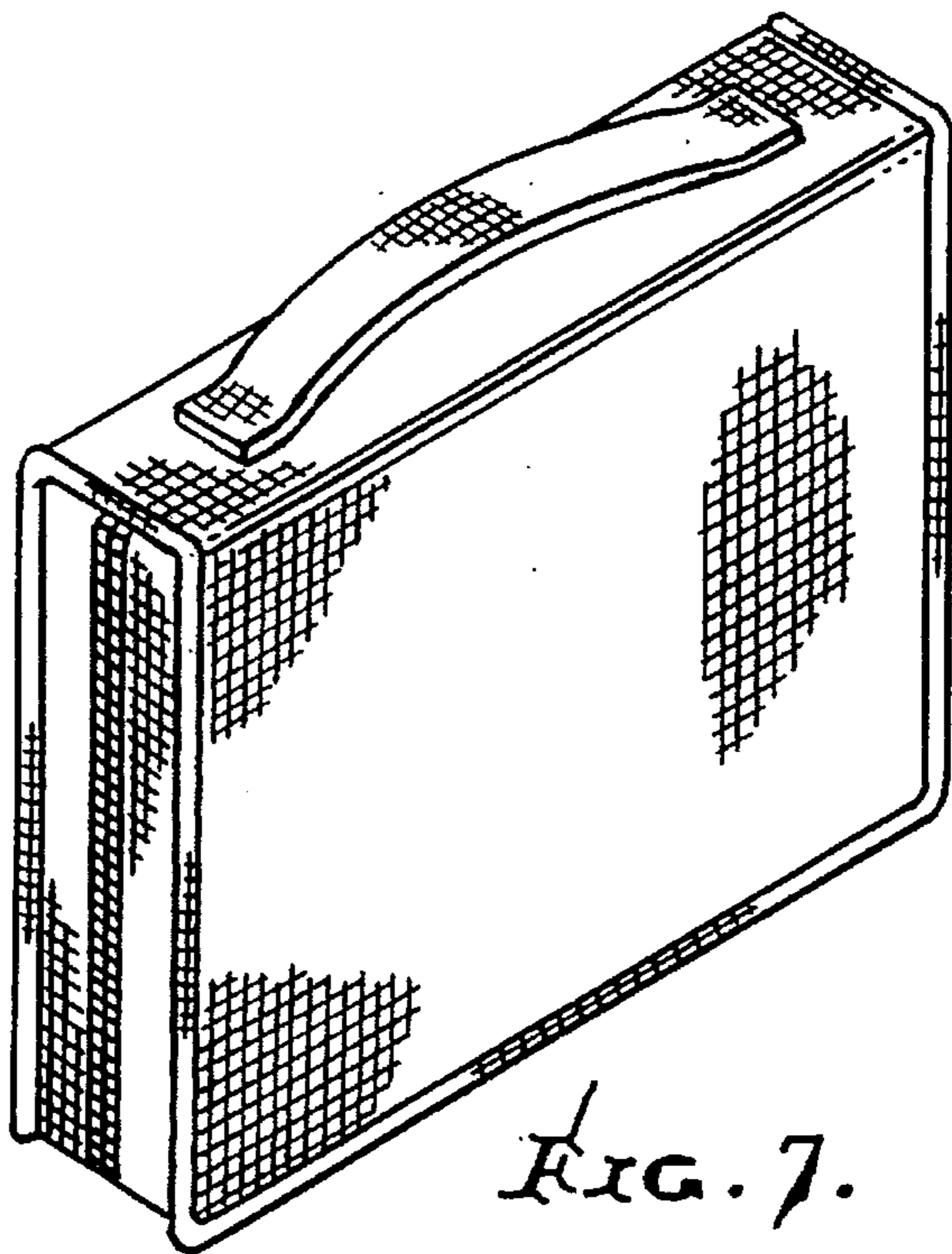
