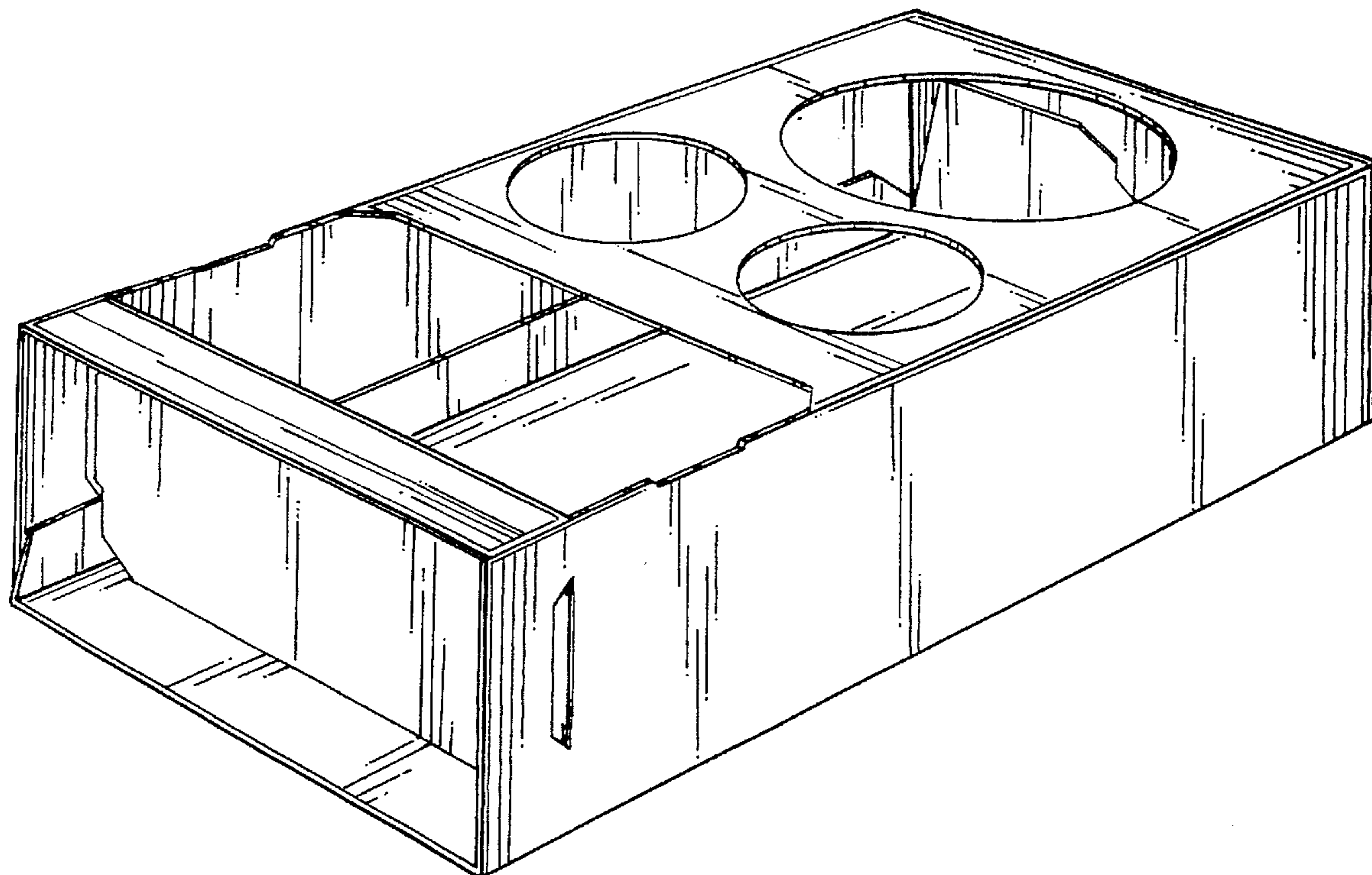
[57] CLAIM

The ornamental design for a food and beverage service tray, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a food and beverage service tray showing our new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a front elevational view thereof. The broken lines disclosed on FIG. 5 represent fold lines.

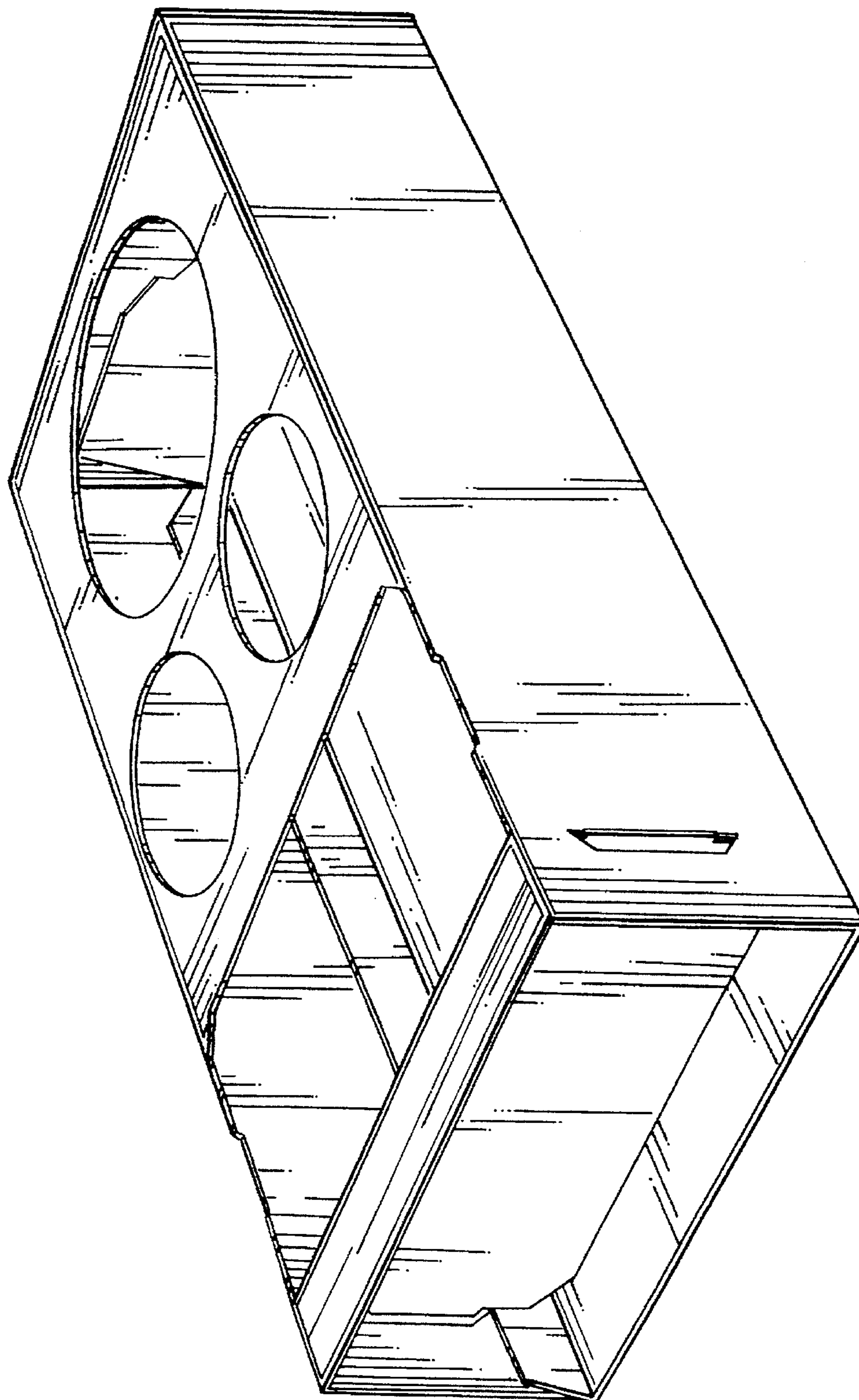

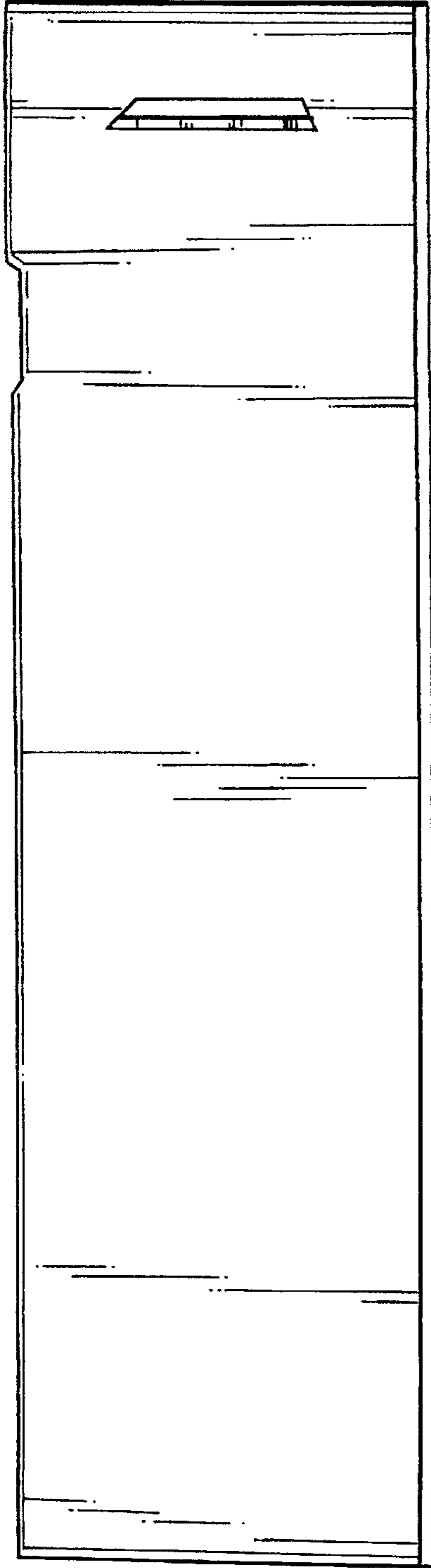

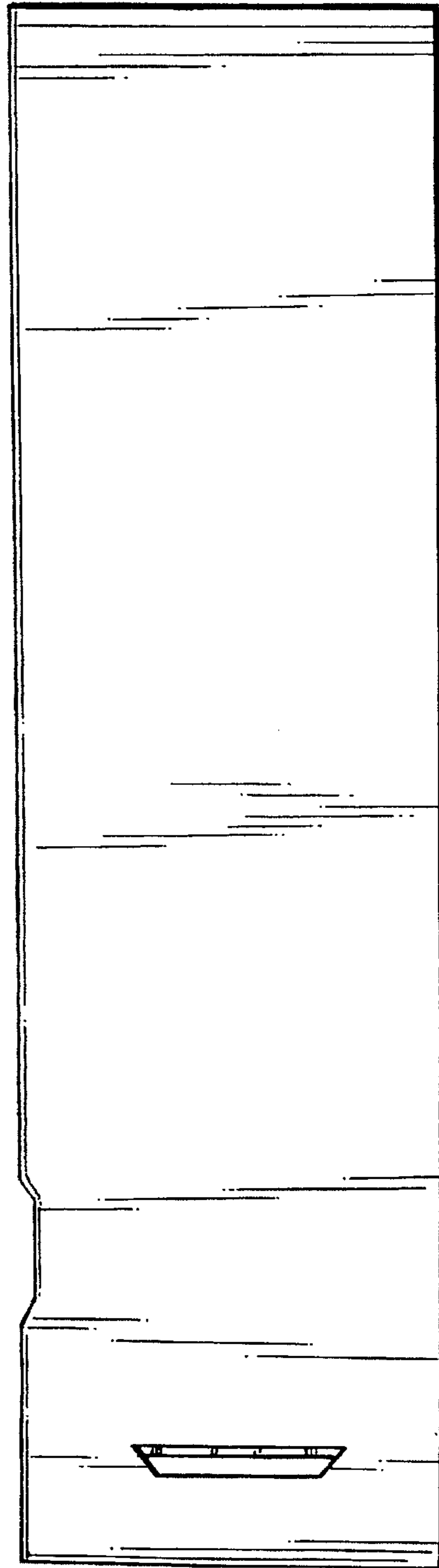

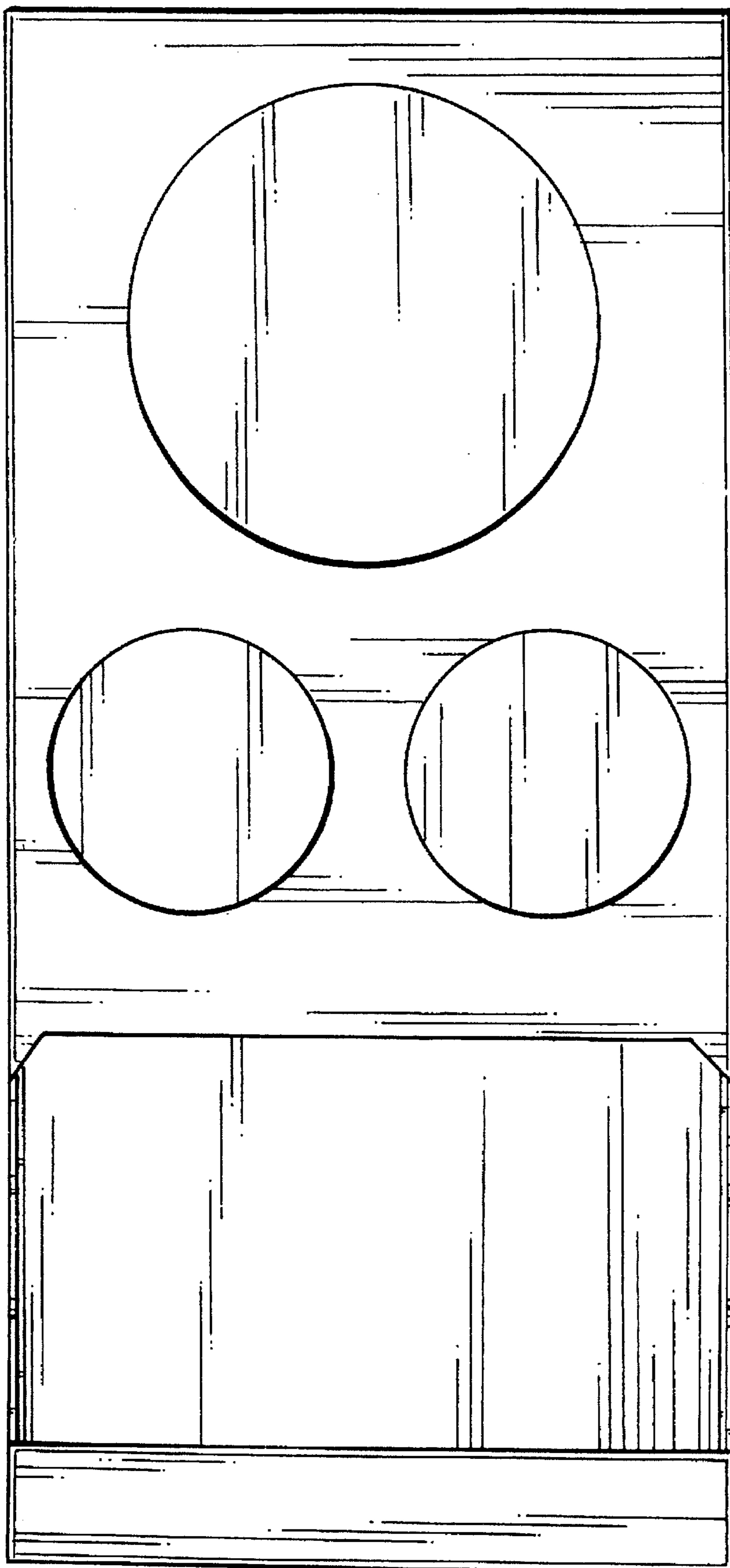

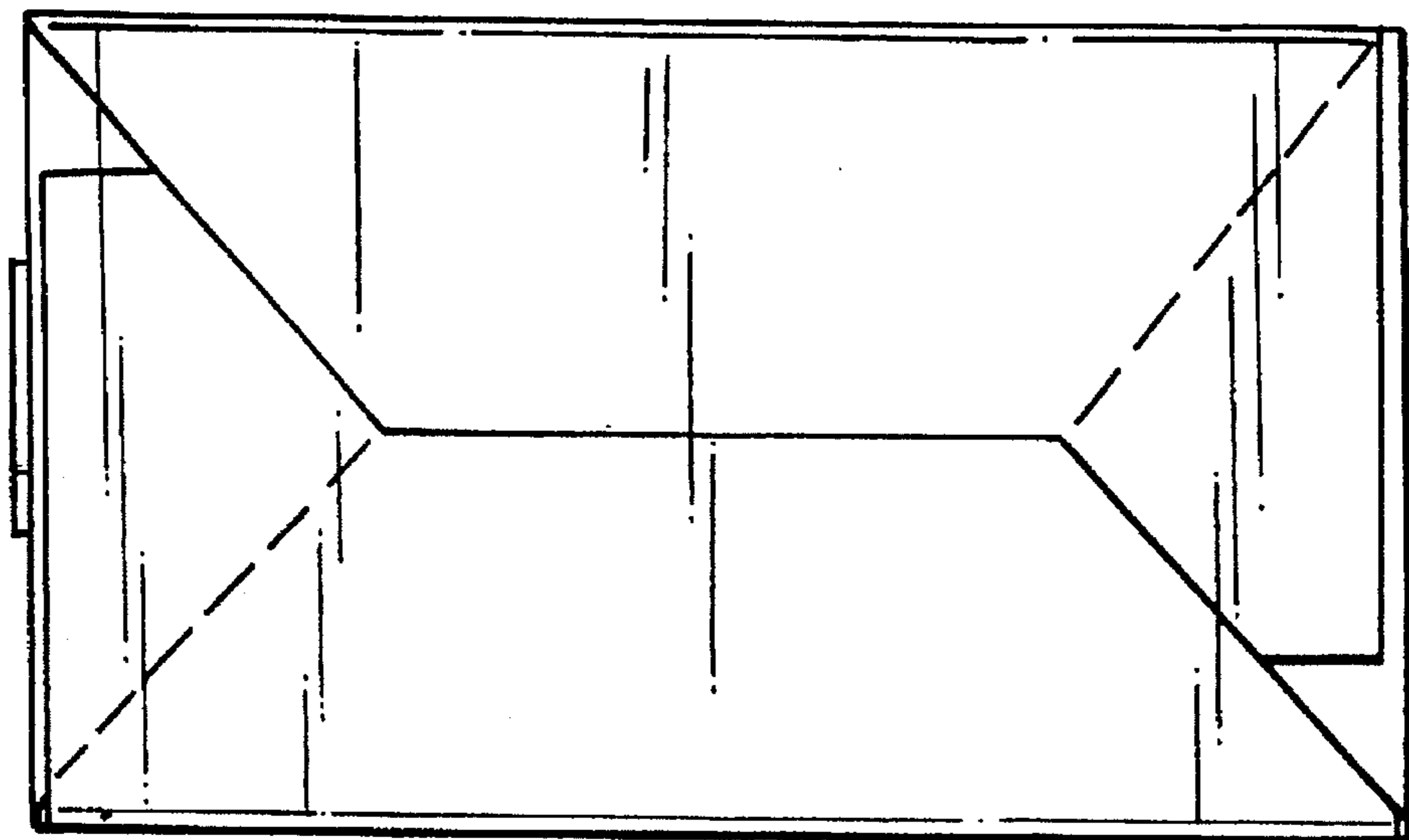

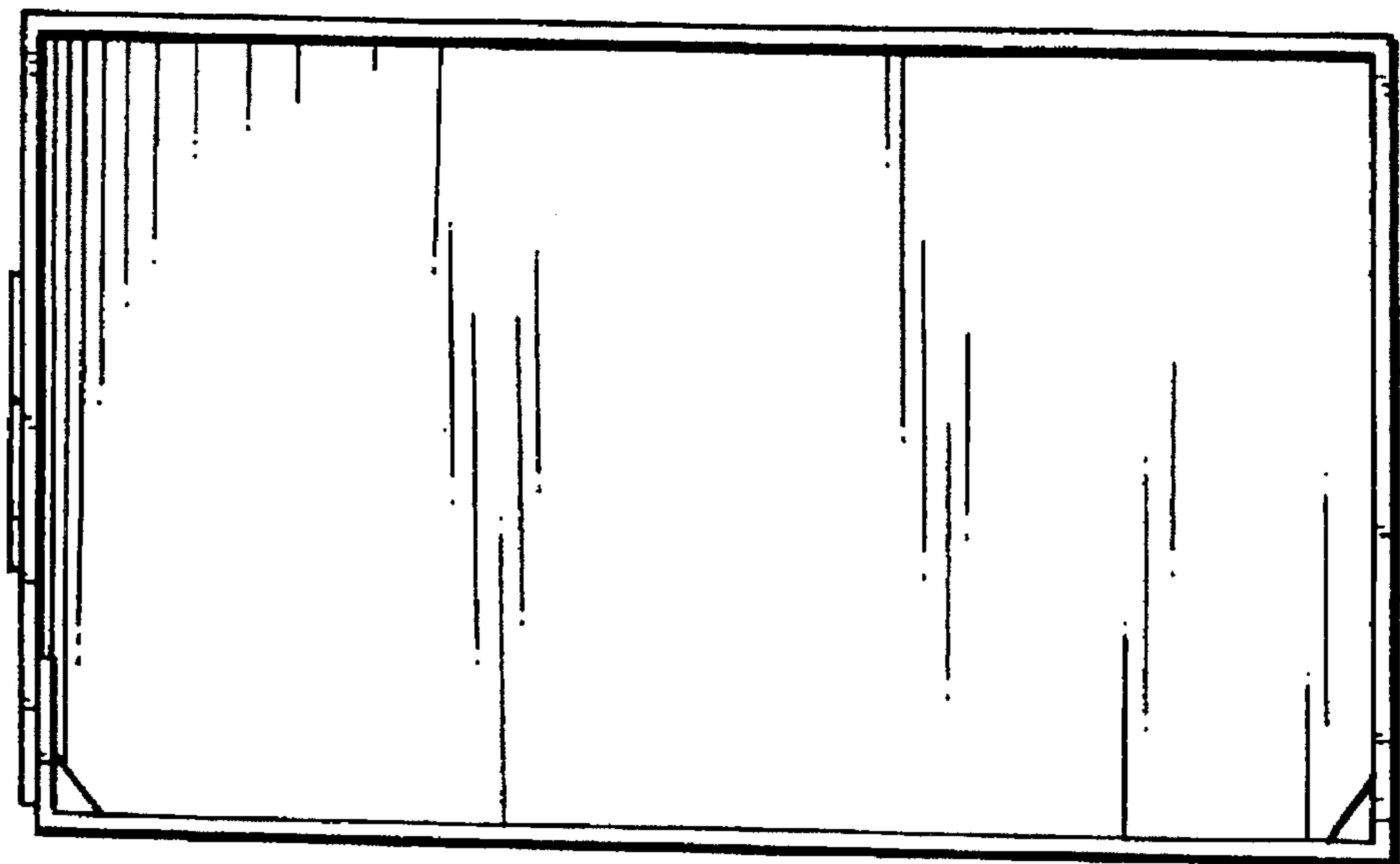
