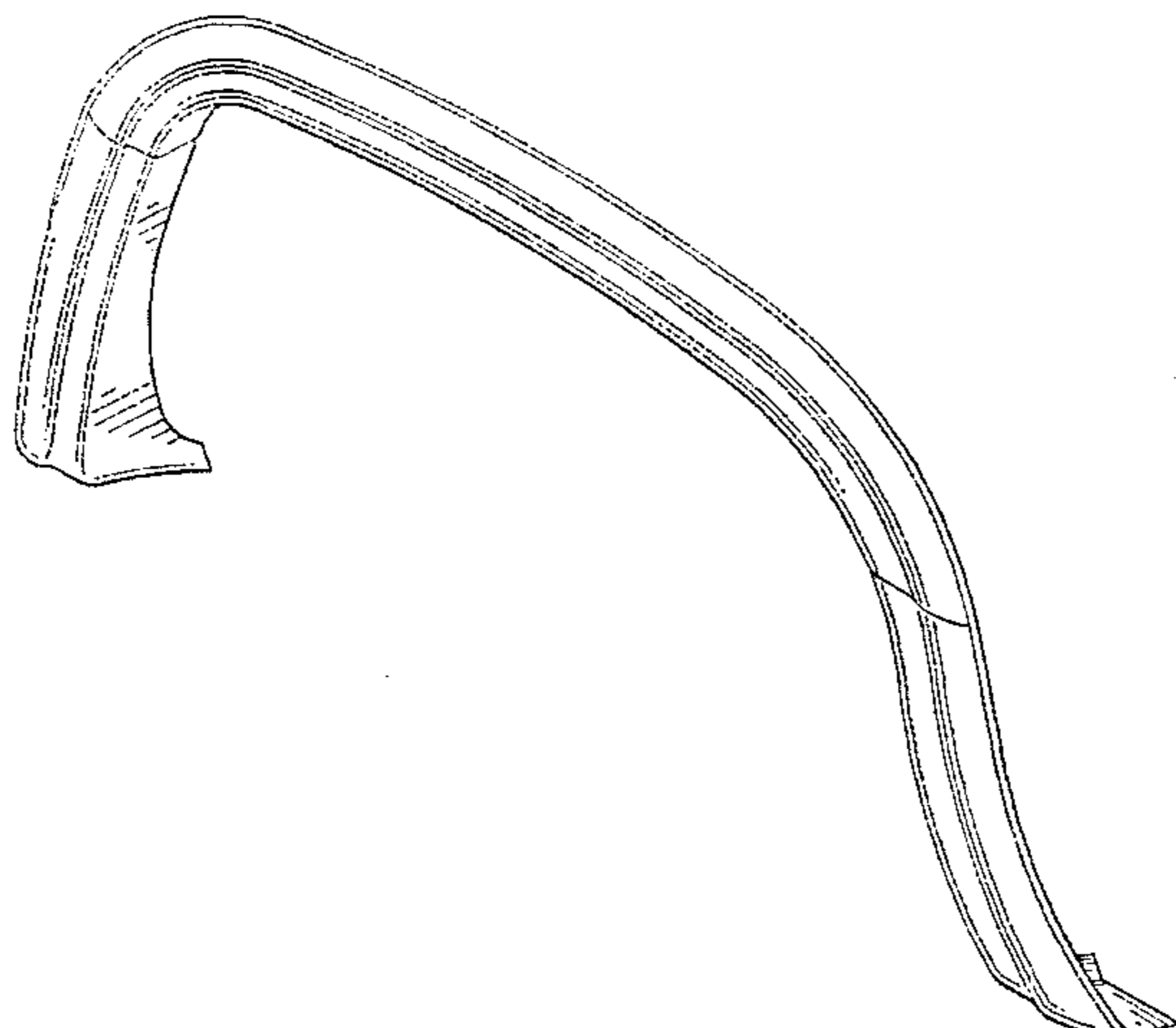
FIG. 13 is a rear elevational view of the right front fender flare of FIG. 8; and,

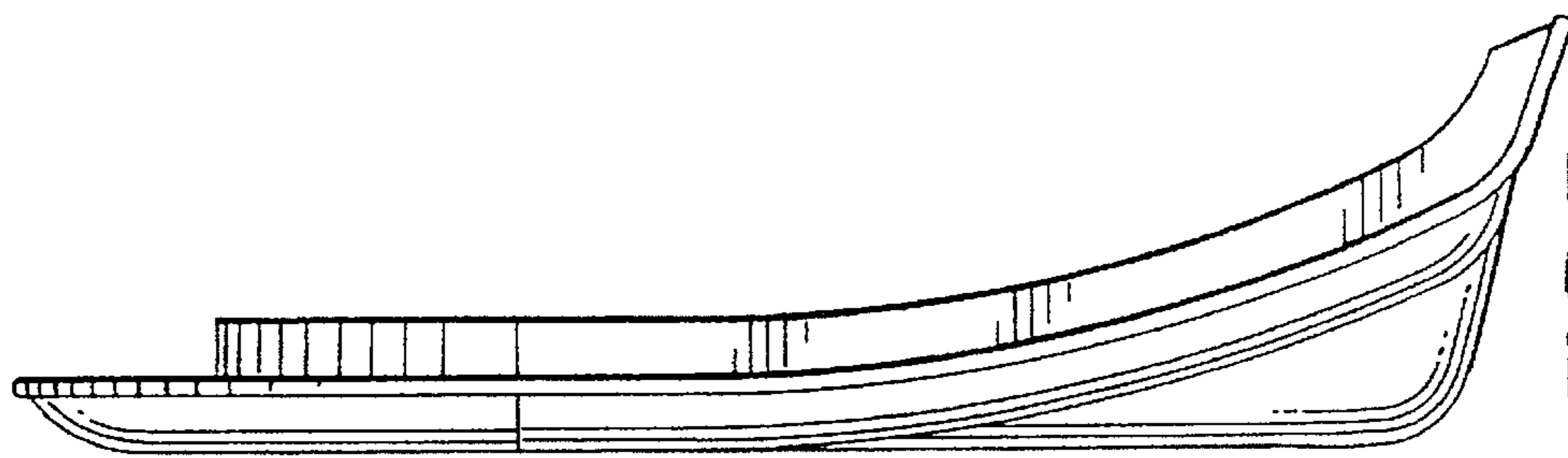

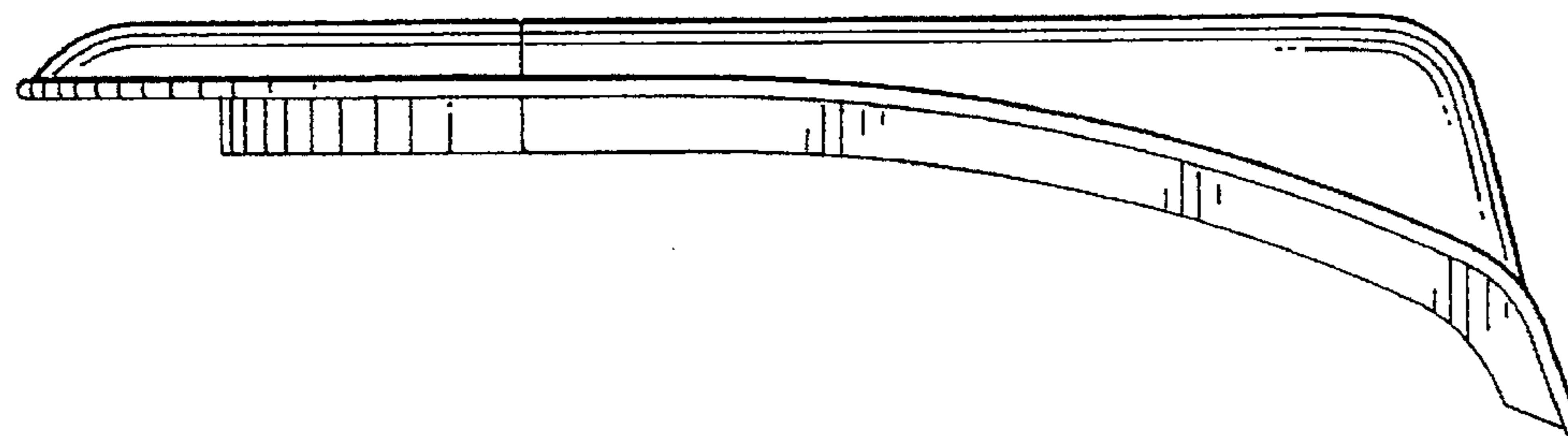

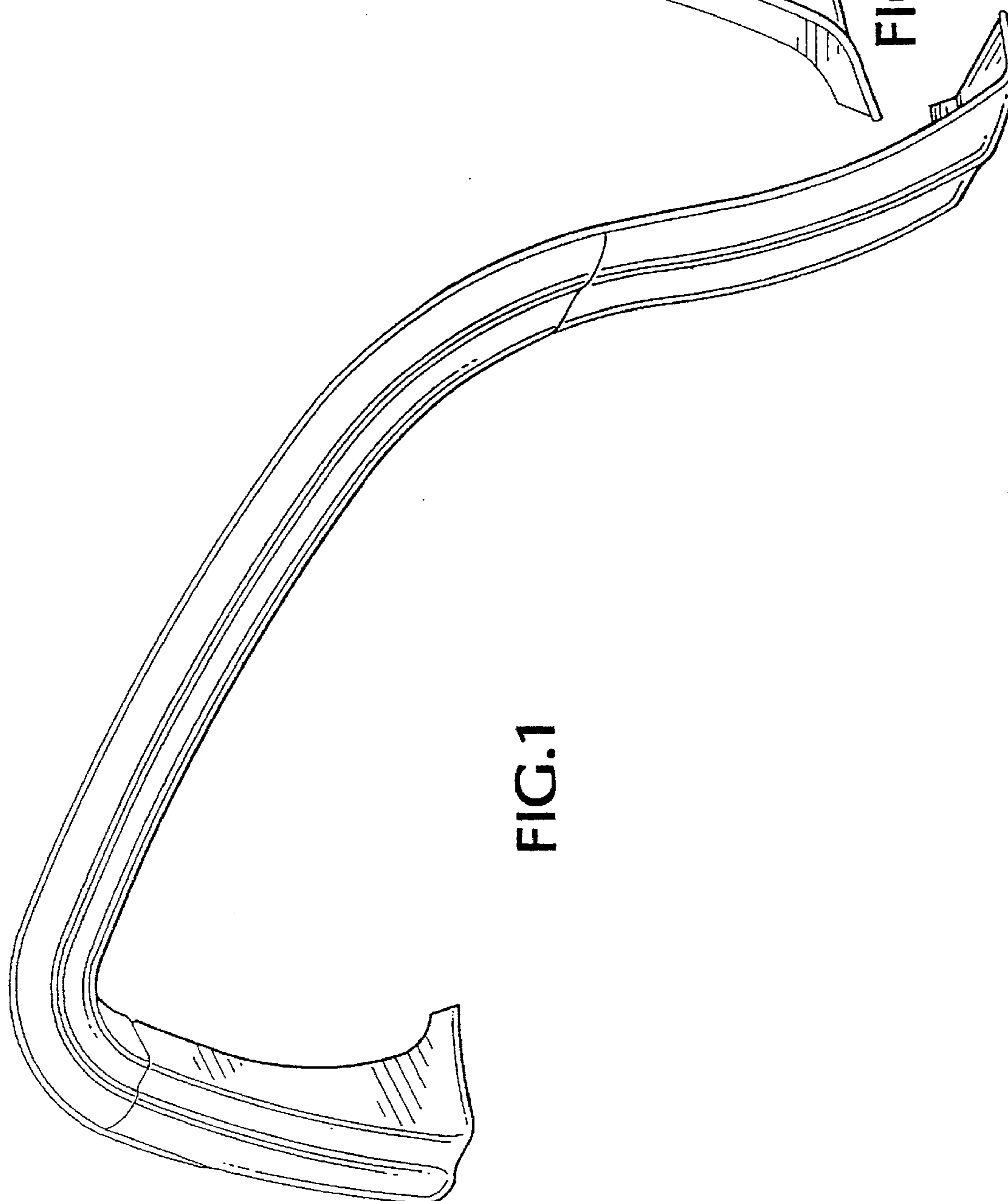

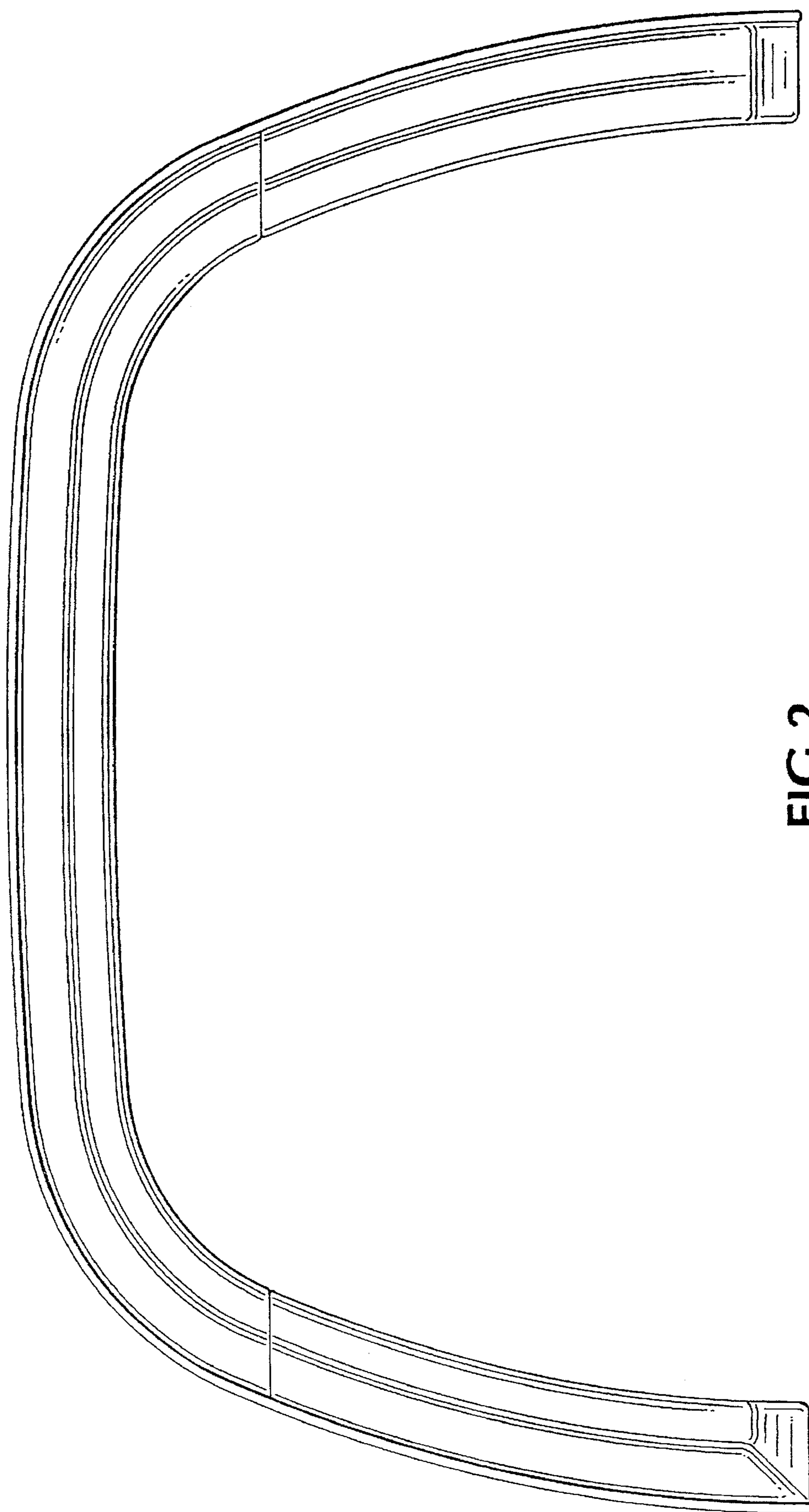

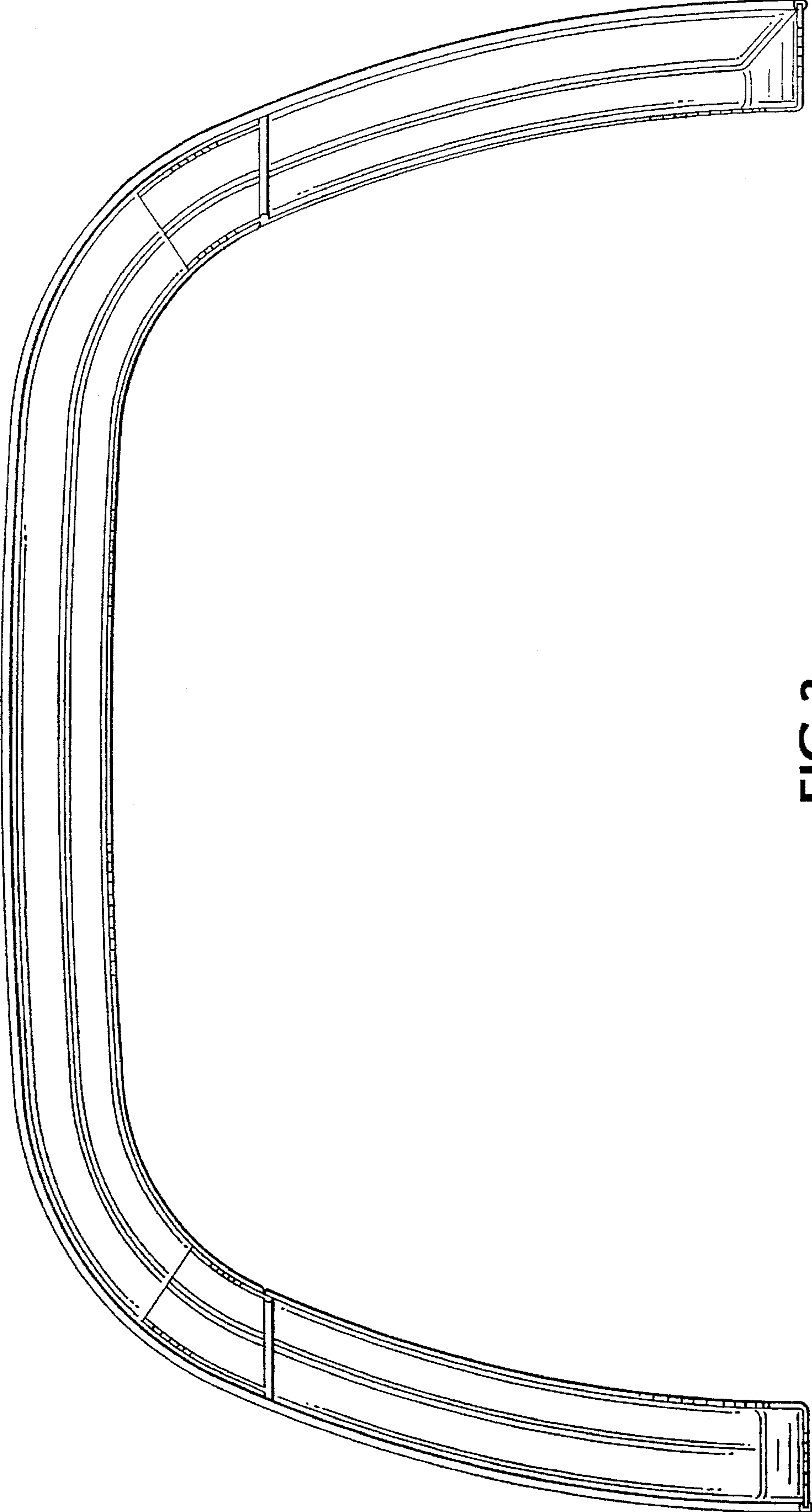

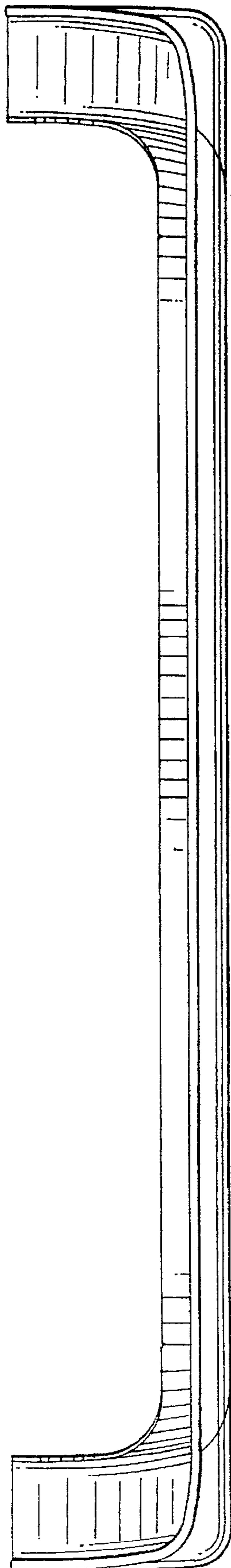

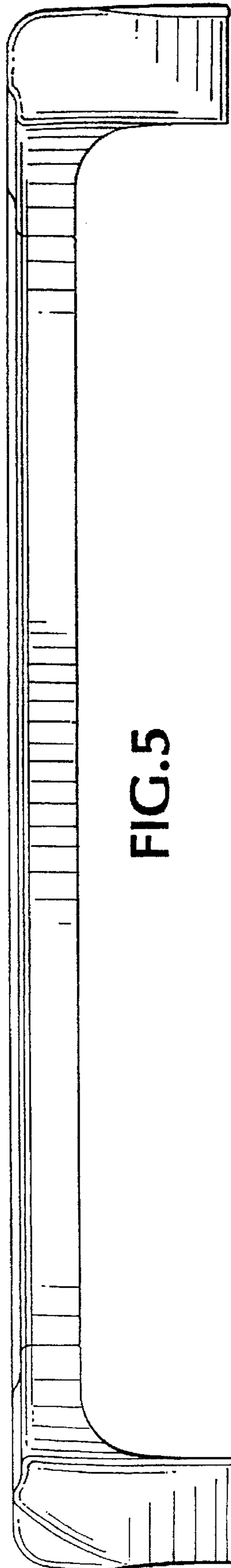

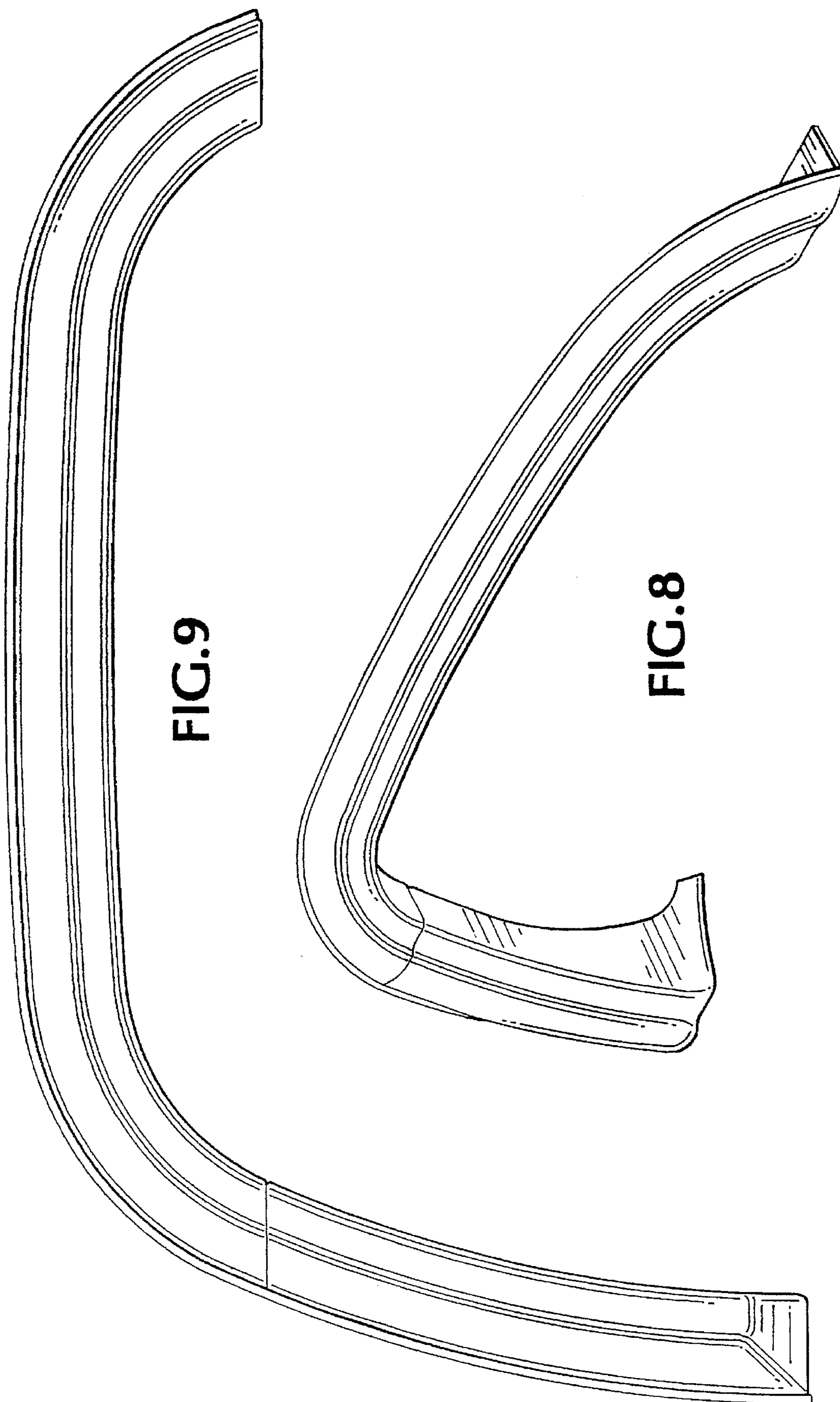

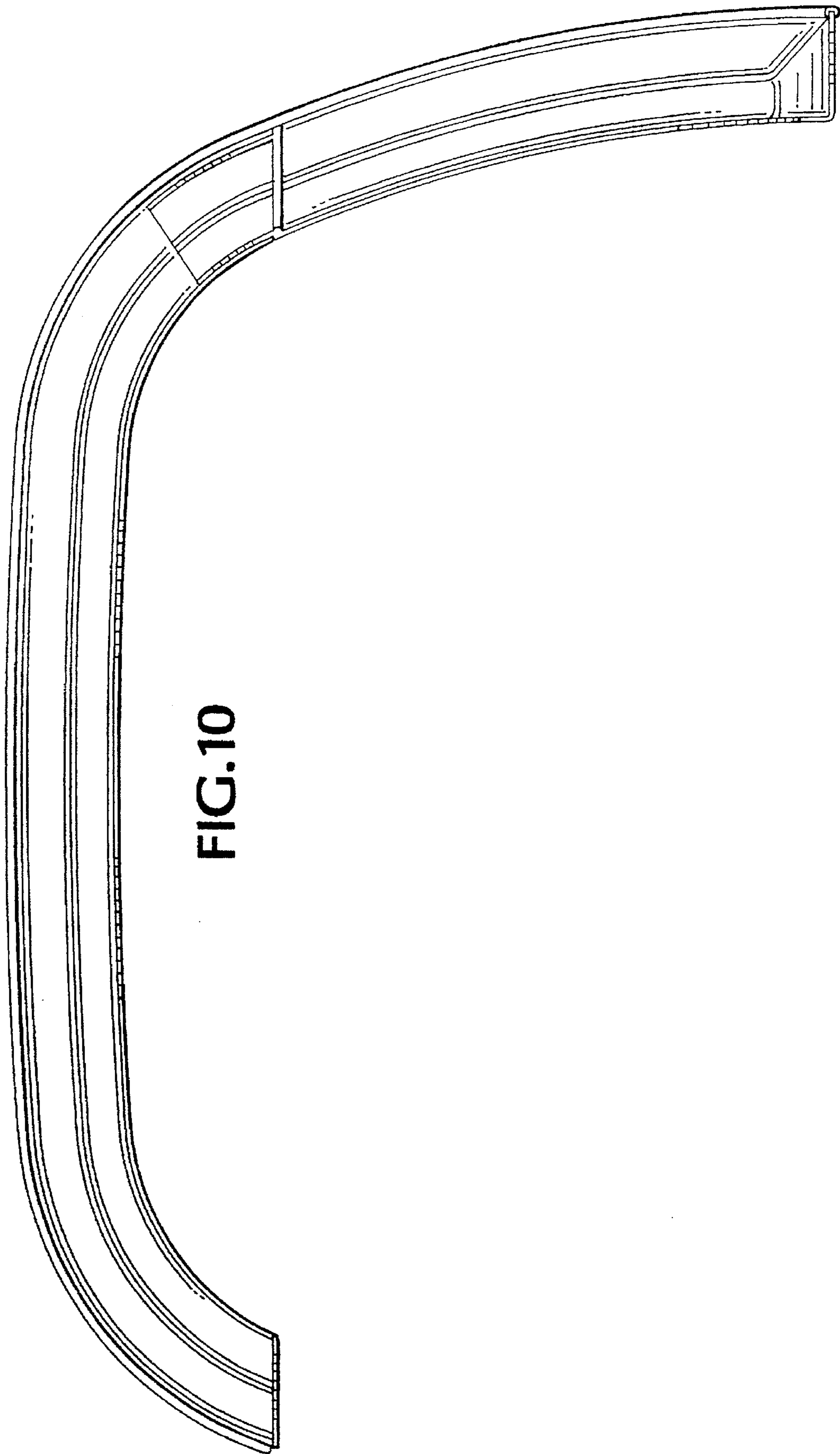

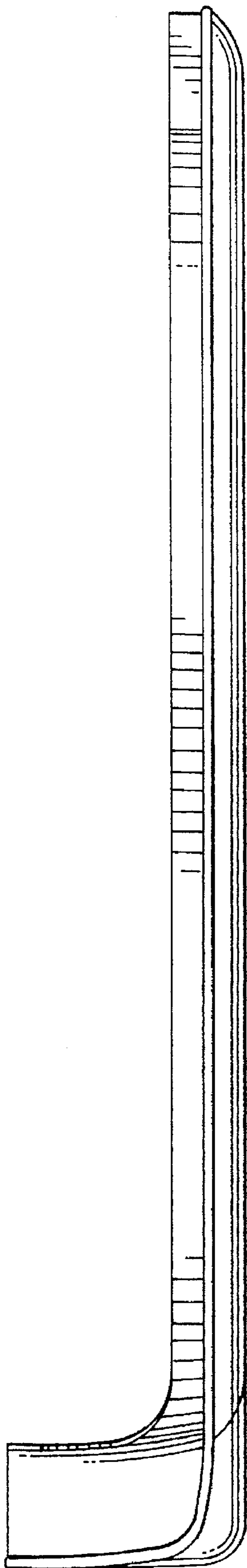

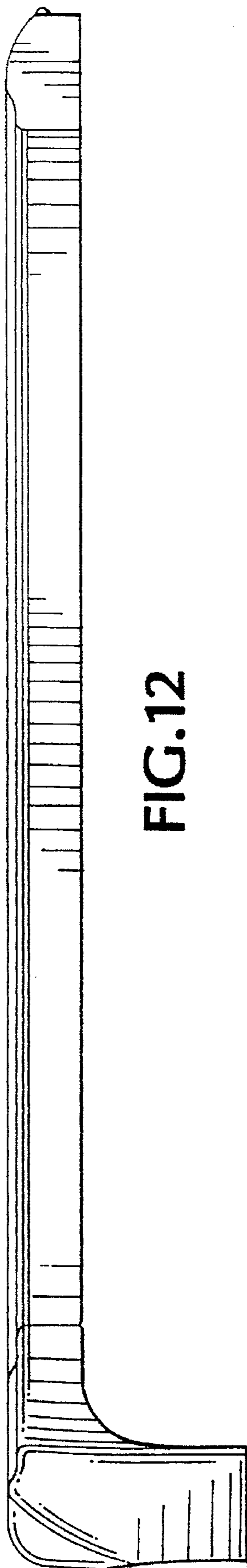

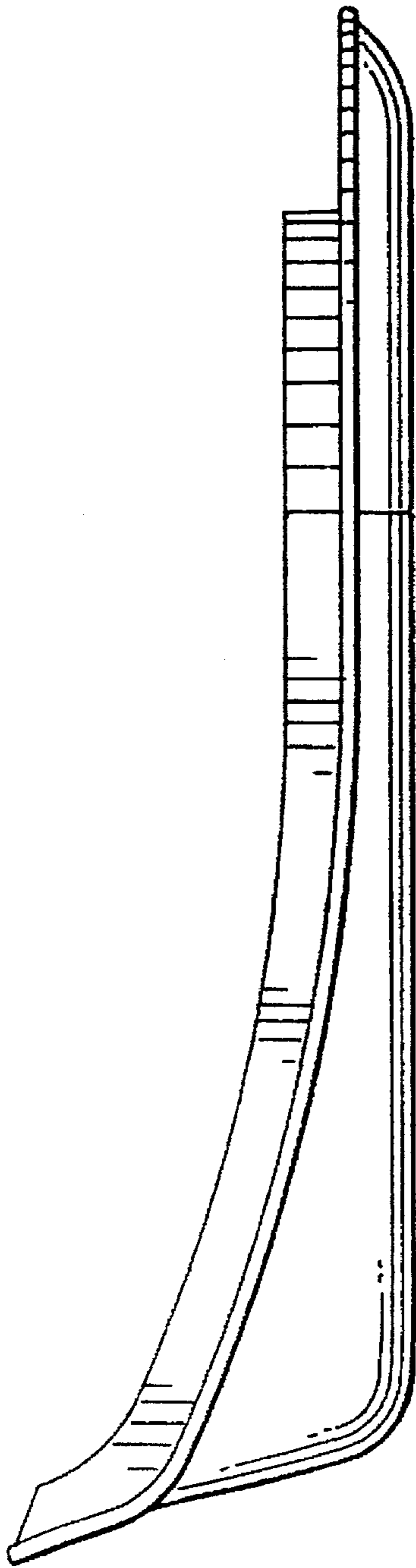

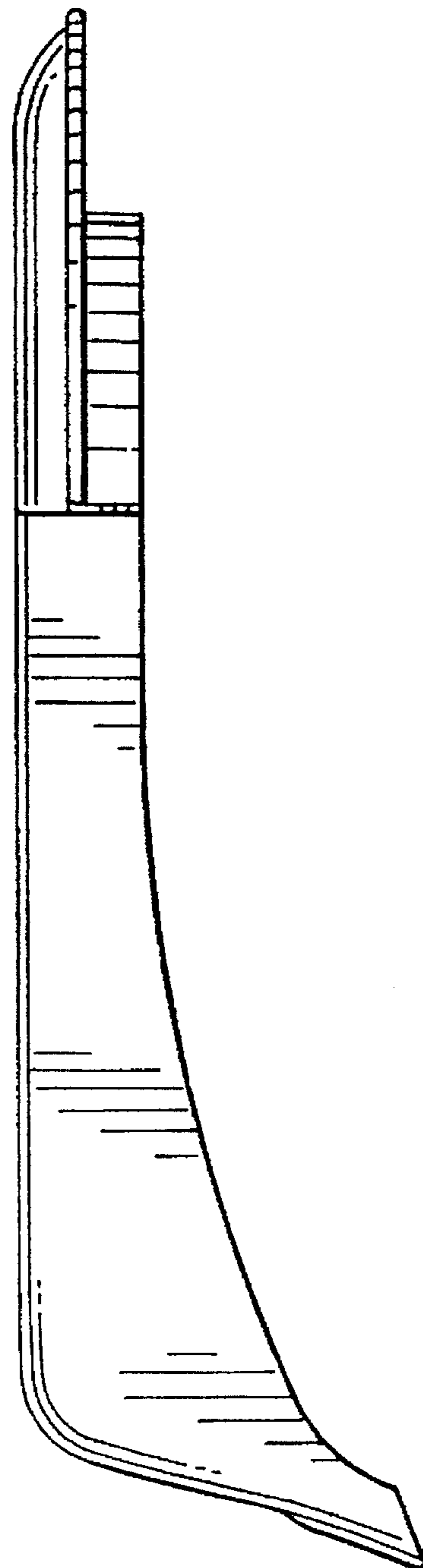
