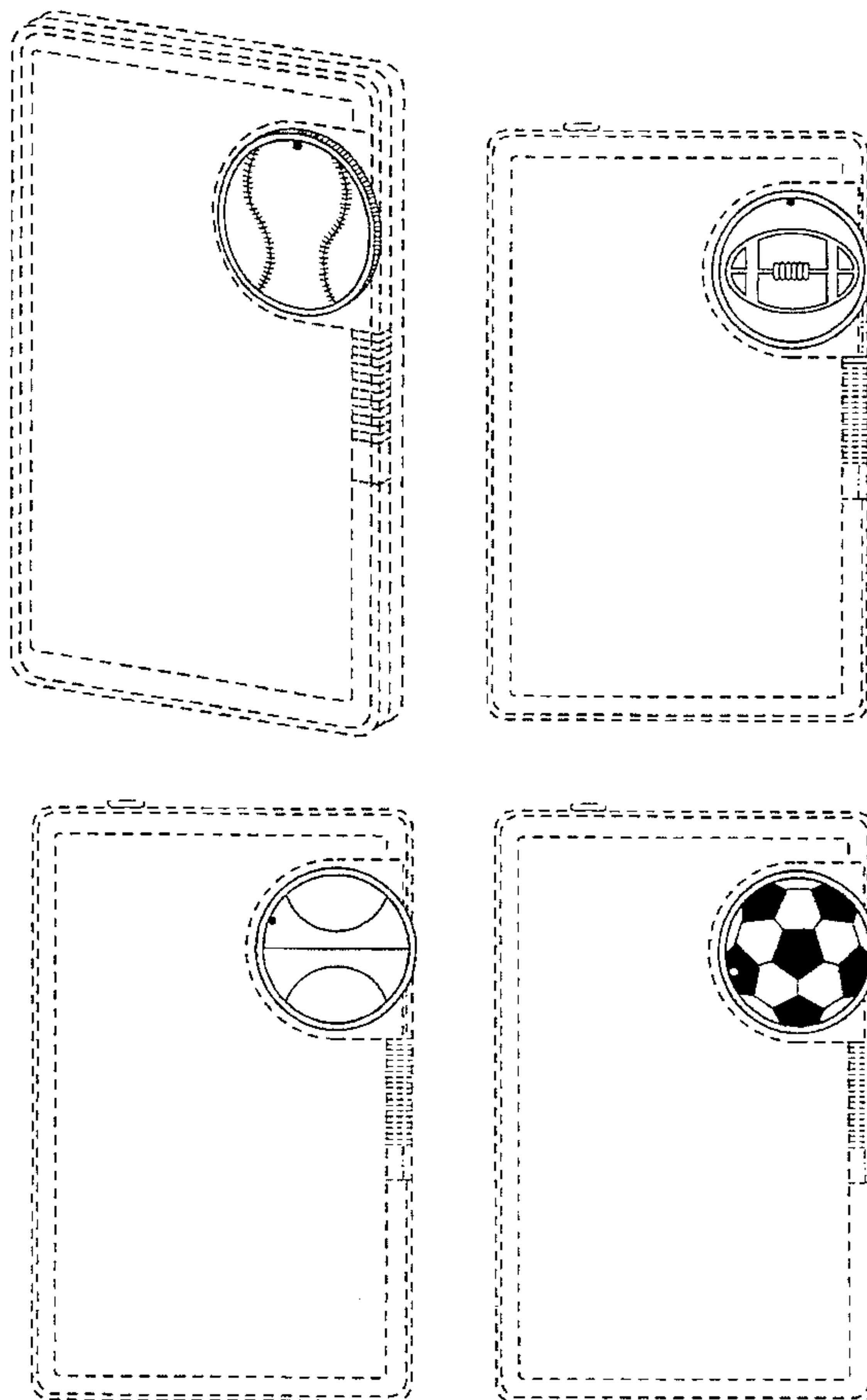
[57] **CLAIM**

The ornamental design for a radio dial, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a baseball-oriented embodiment of the radio dial showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a front elevational view of a second embodiment of FIG. 1, showing a football-oriented radio dial design; FIG. 8 is a front elevational view of a third embodiment of FIG. 1, showing a basketball-oriented radio dial design; and, FIG. 9 is a front elevational view of a fourth embodiment of FIG. 1, showing a soccerball-oriented radio dial design. The undisclosed rear, side, top and bottom views of the second, third, and fourth embodiments are identical to the views of the first embodiment. The broken lines shown in FIGS. 1-9 are for illustrative purposes only, and form no part of the claimed design.

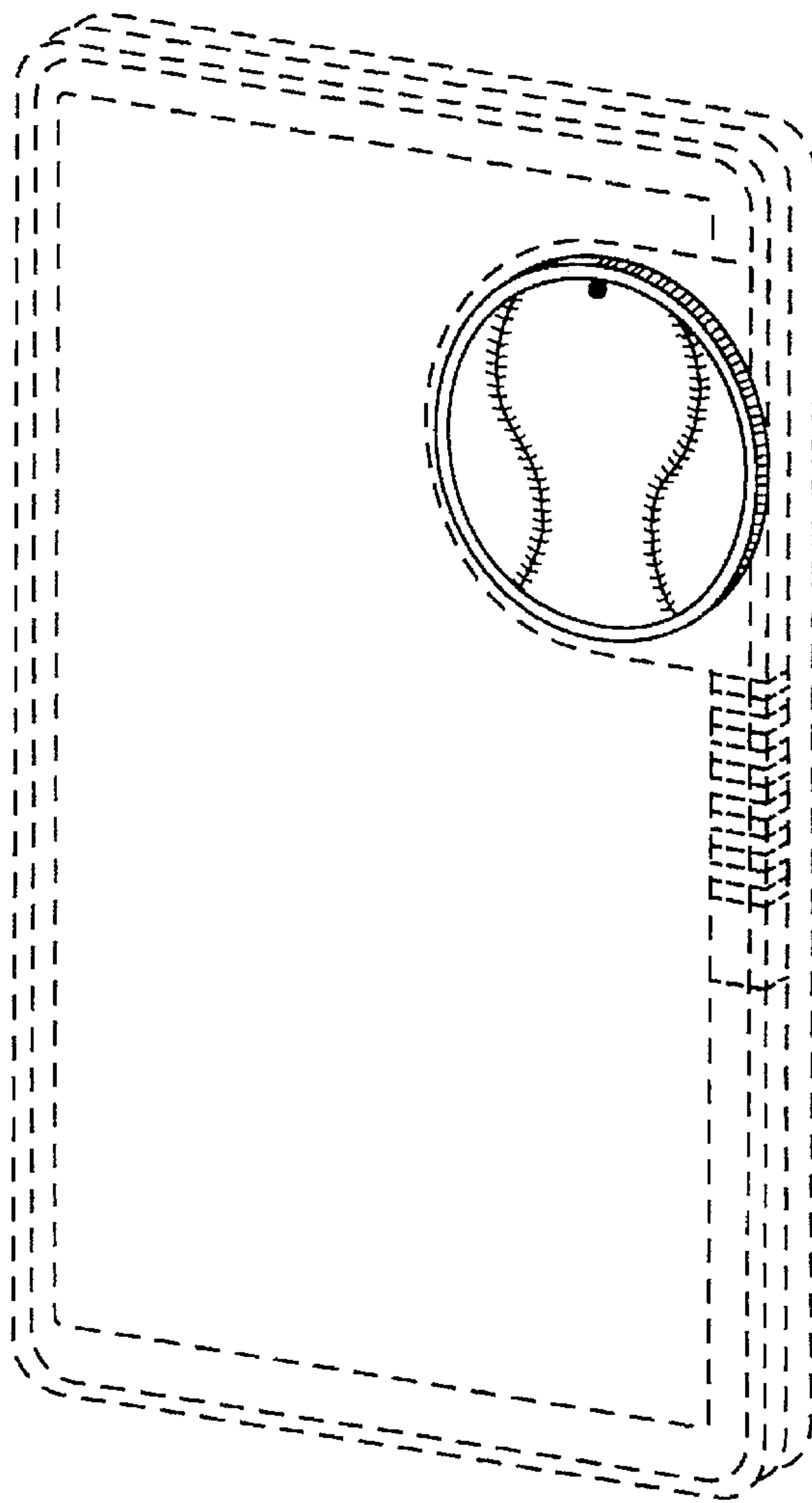

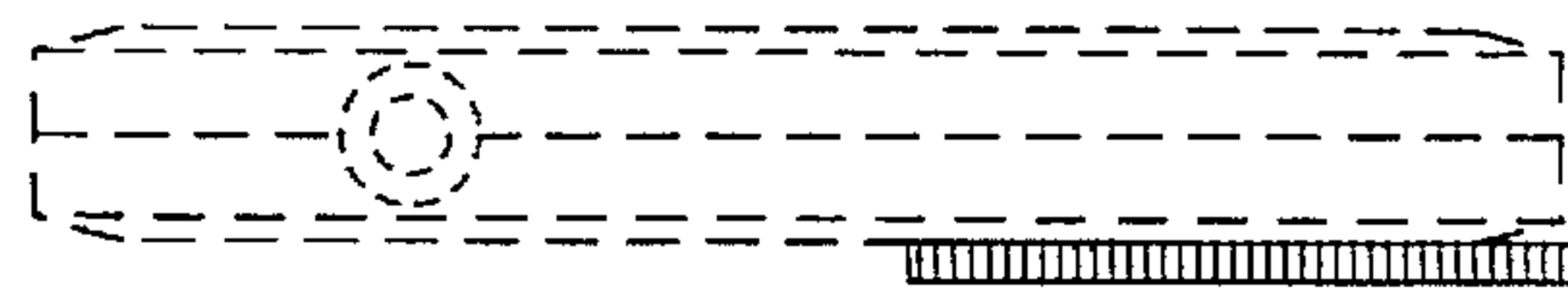

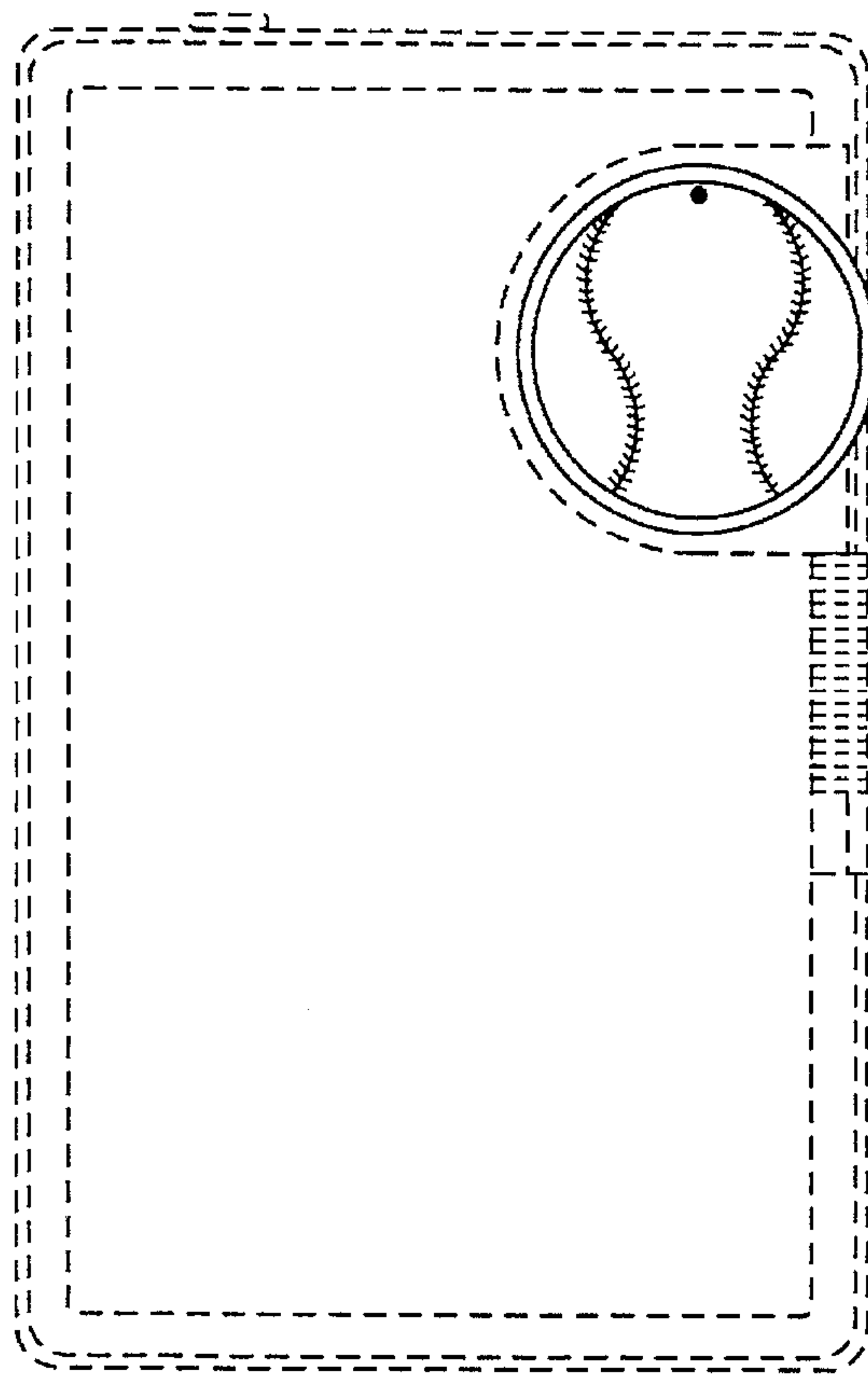

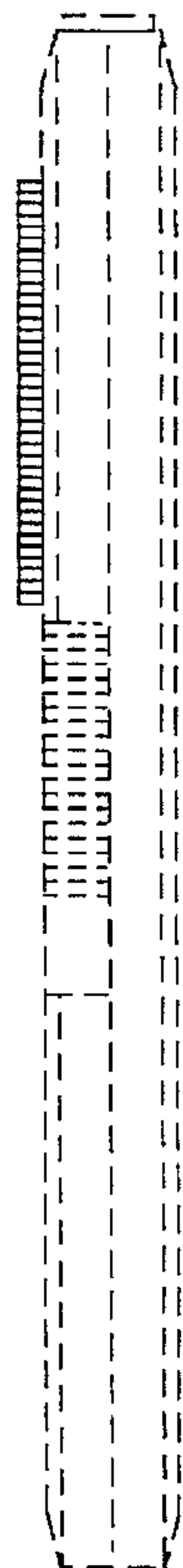

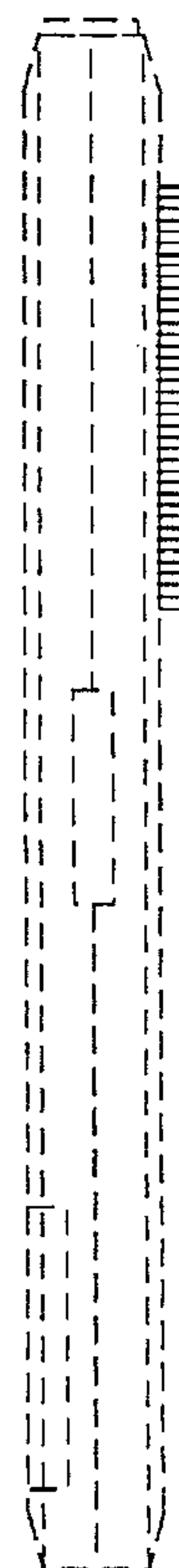

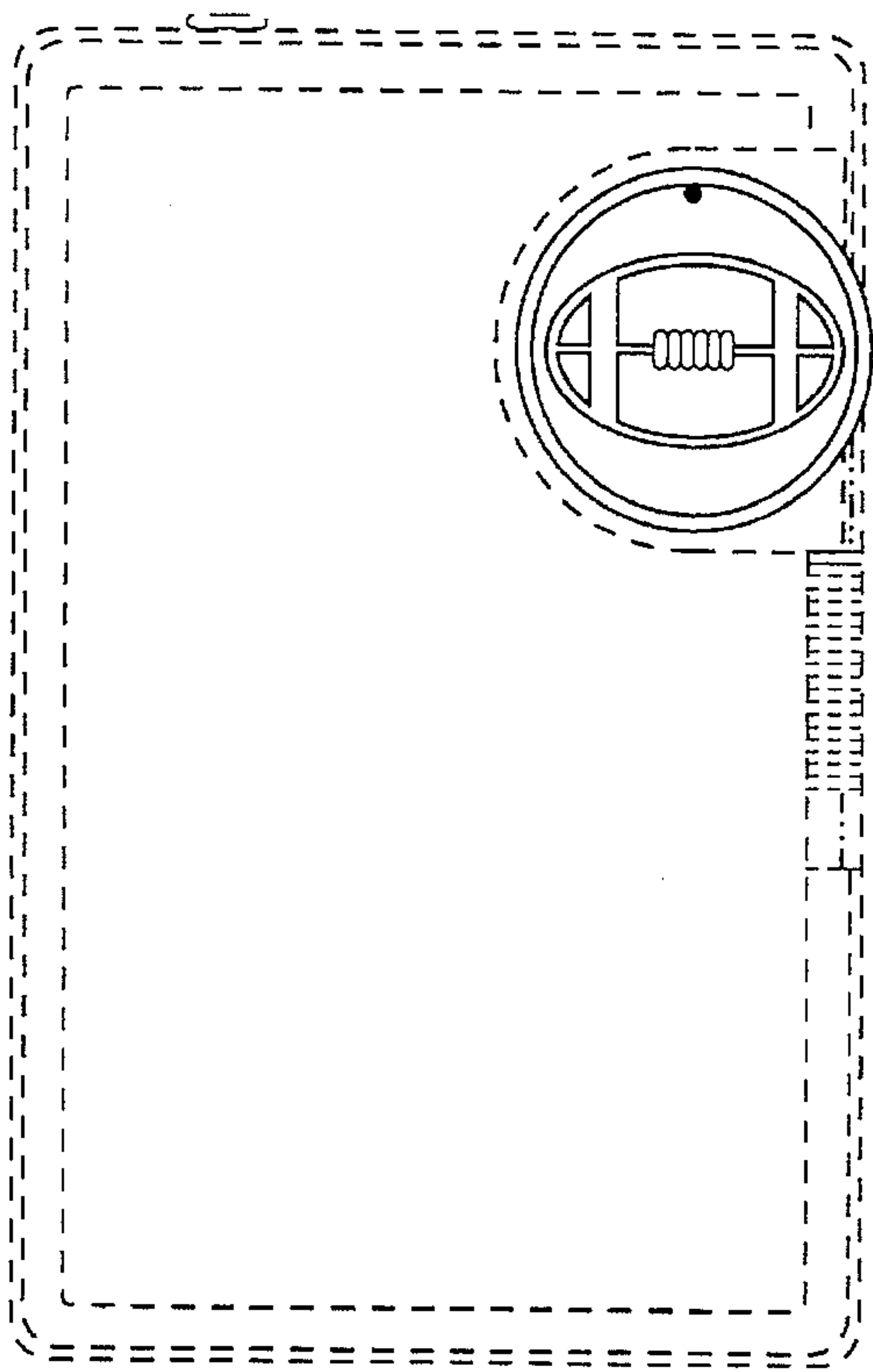

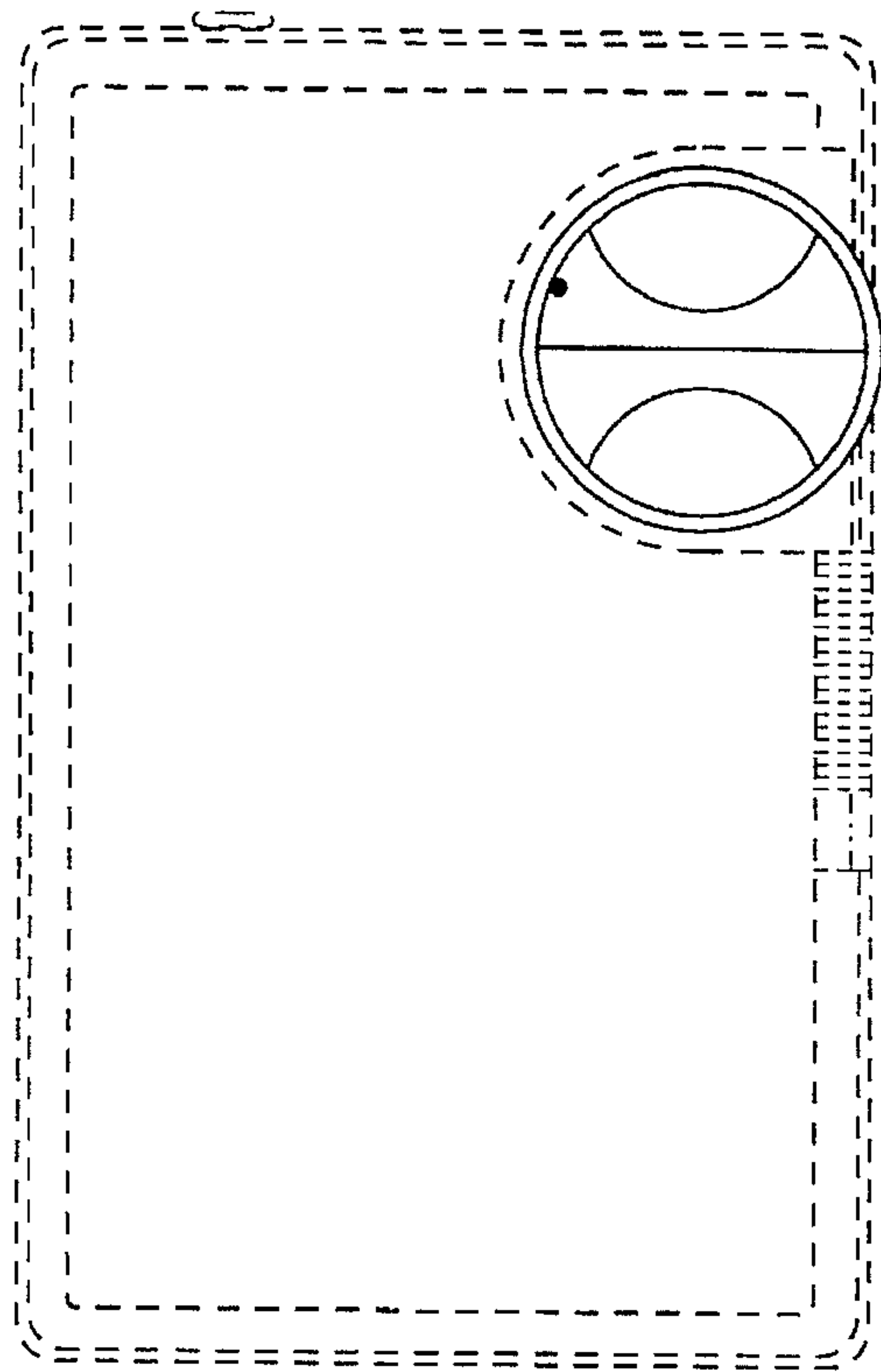

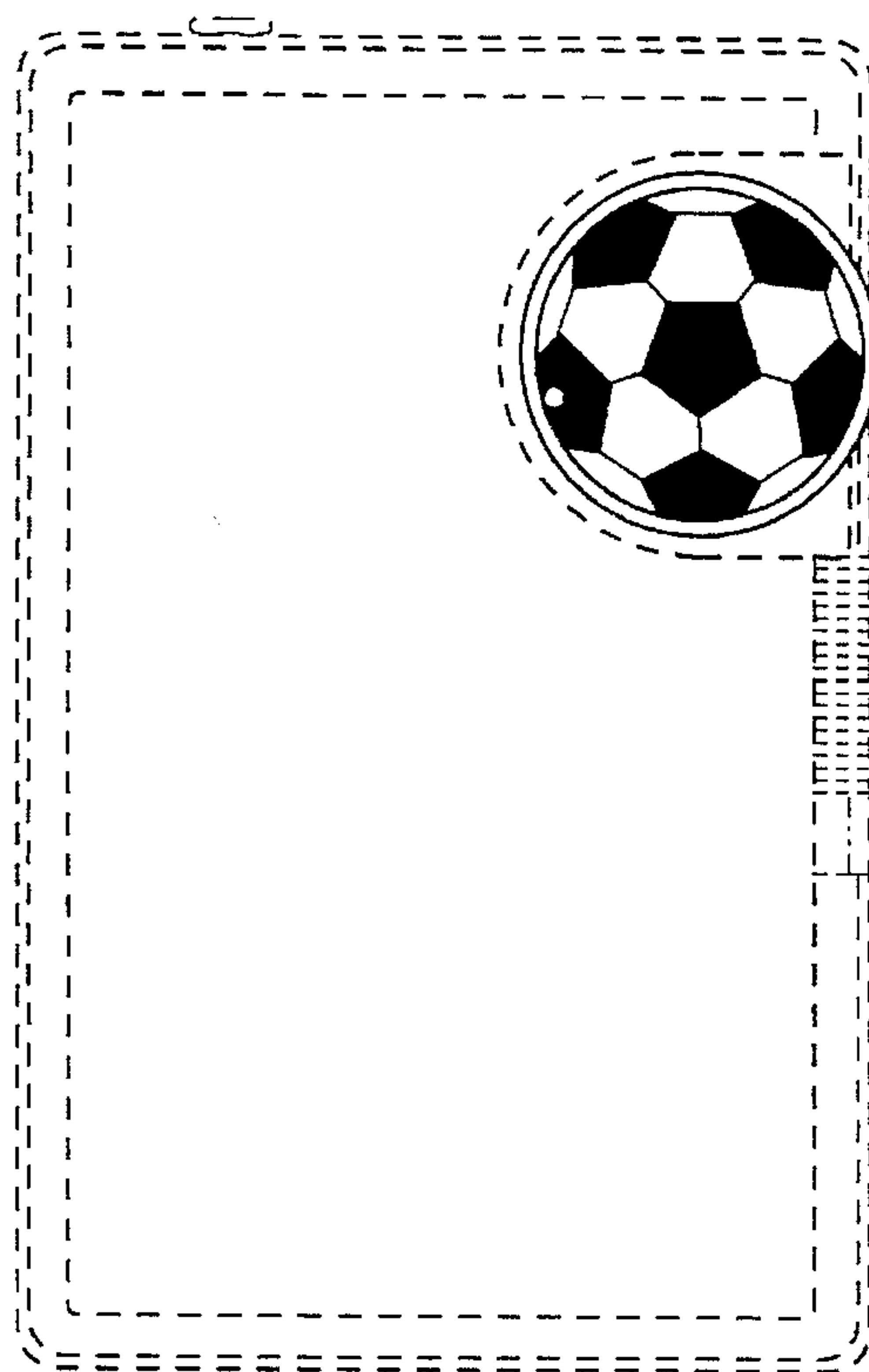
