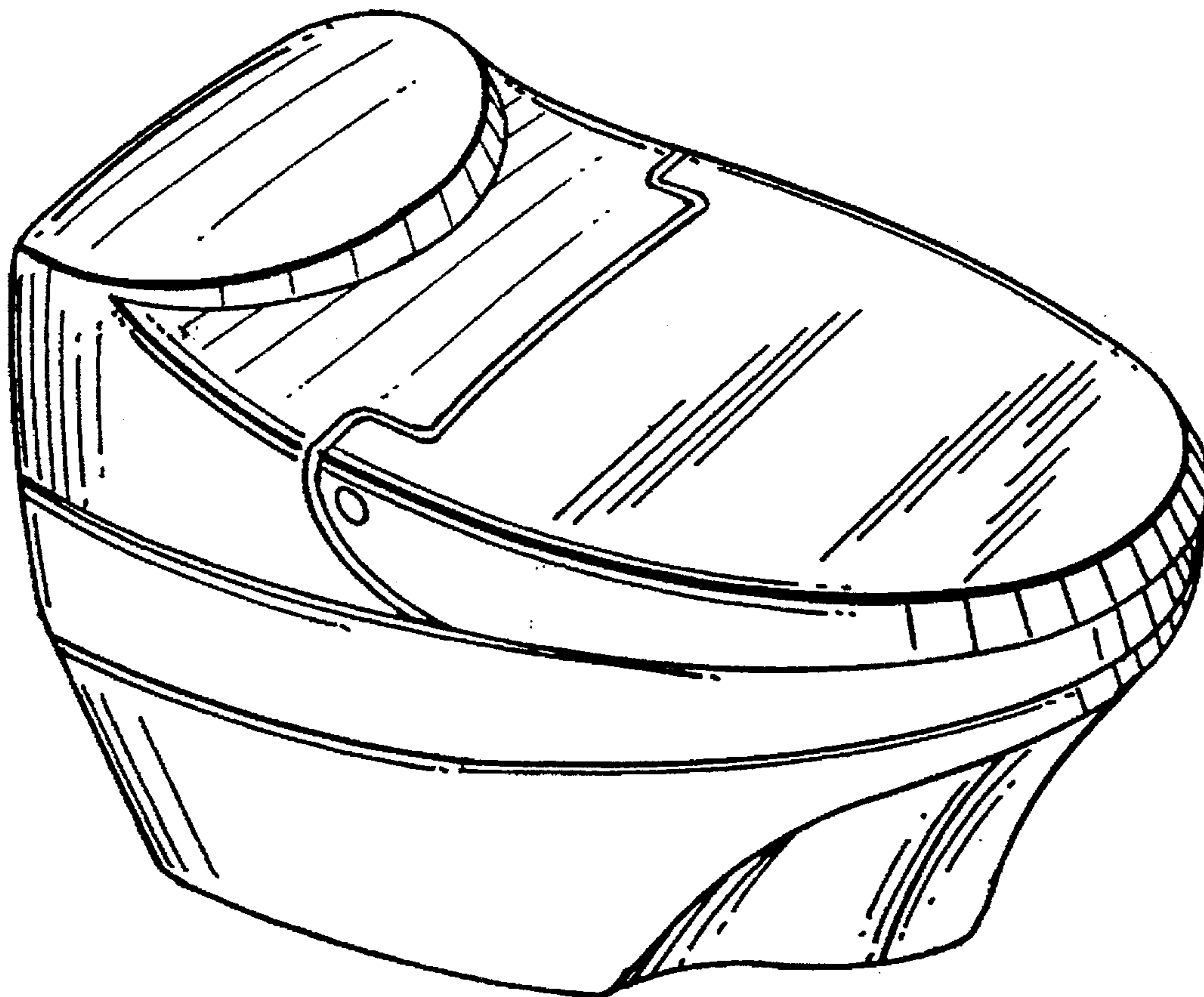
[57] CLAIM

The ornamental design for a combined toilet basin, toilet seat and seat cover, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a combined toilet basin, toilet seat, and seat cover showing my new design, the opposite side being a mirror image;
 FIG. 2 is a rear elevational view;
 FIG. 3 is a front elevational view;
 FIG. 4 is a top plan view;
 FIG. 5 is a bottom plan view; and,
 FIG. 6 is a perspective view of the front and right side thereof.

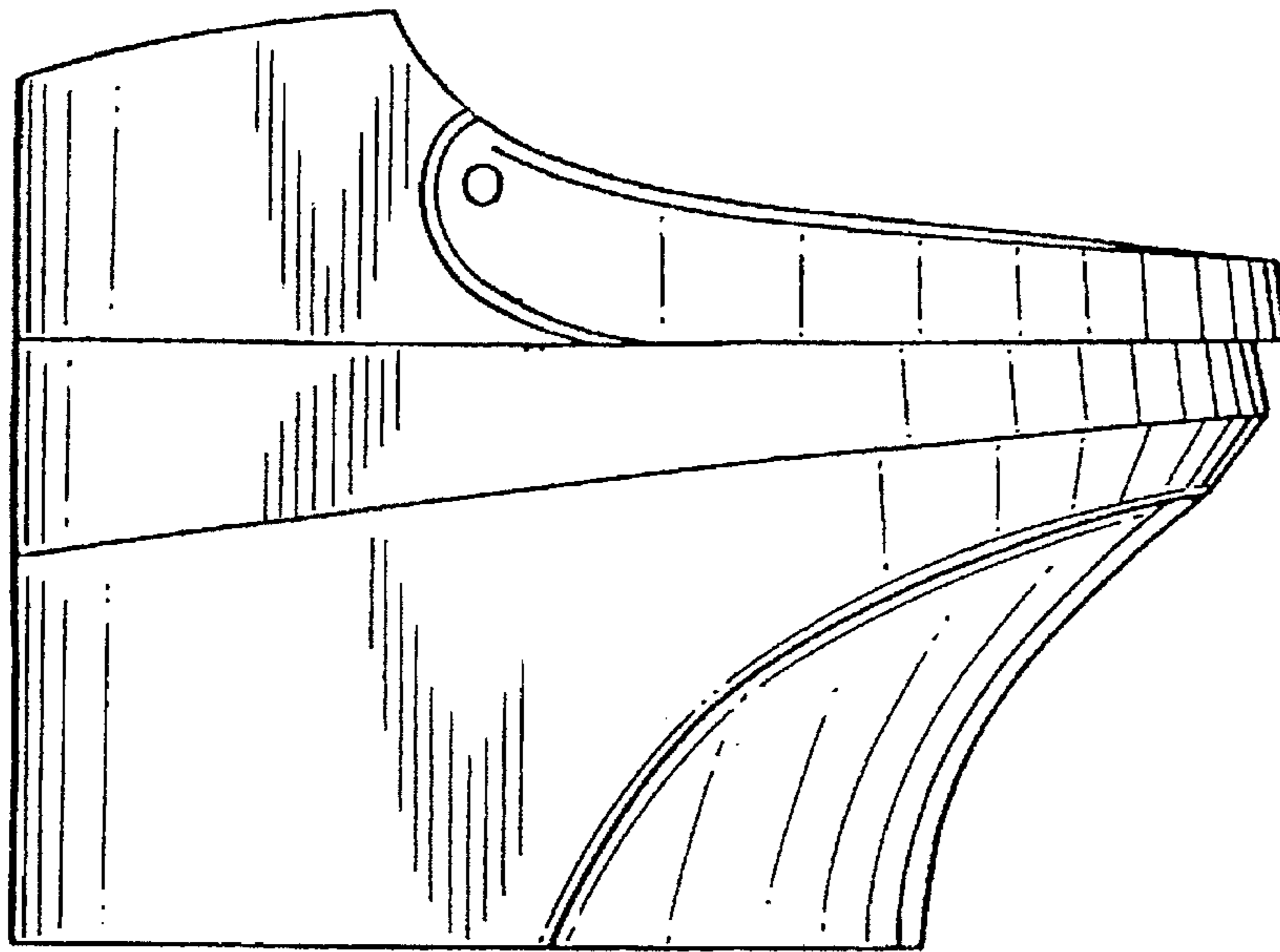

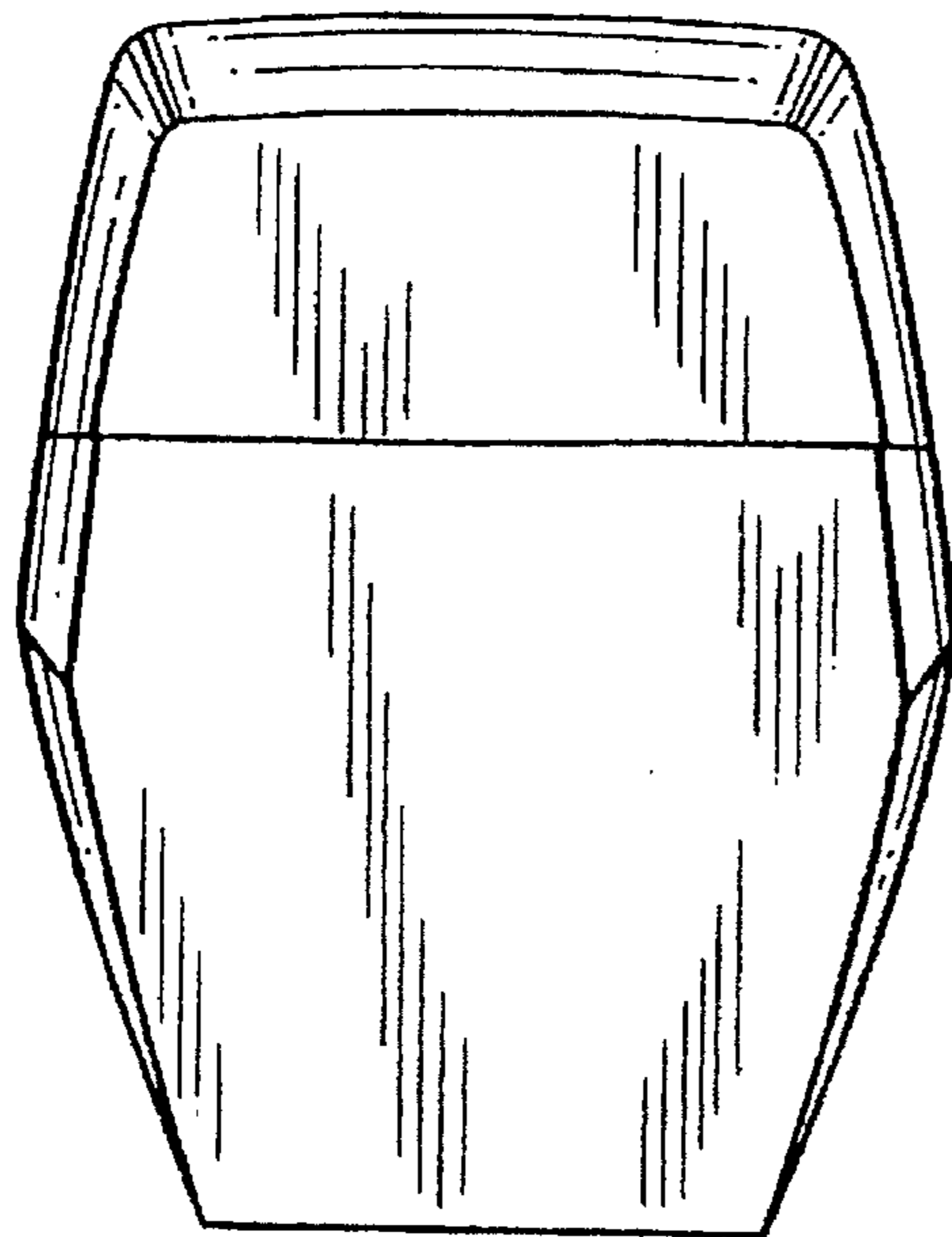

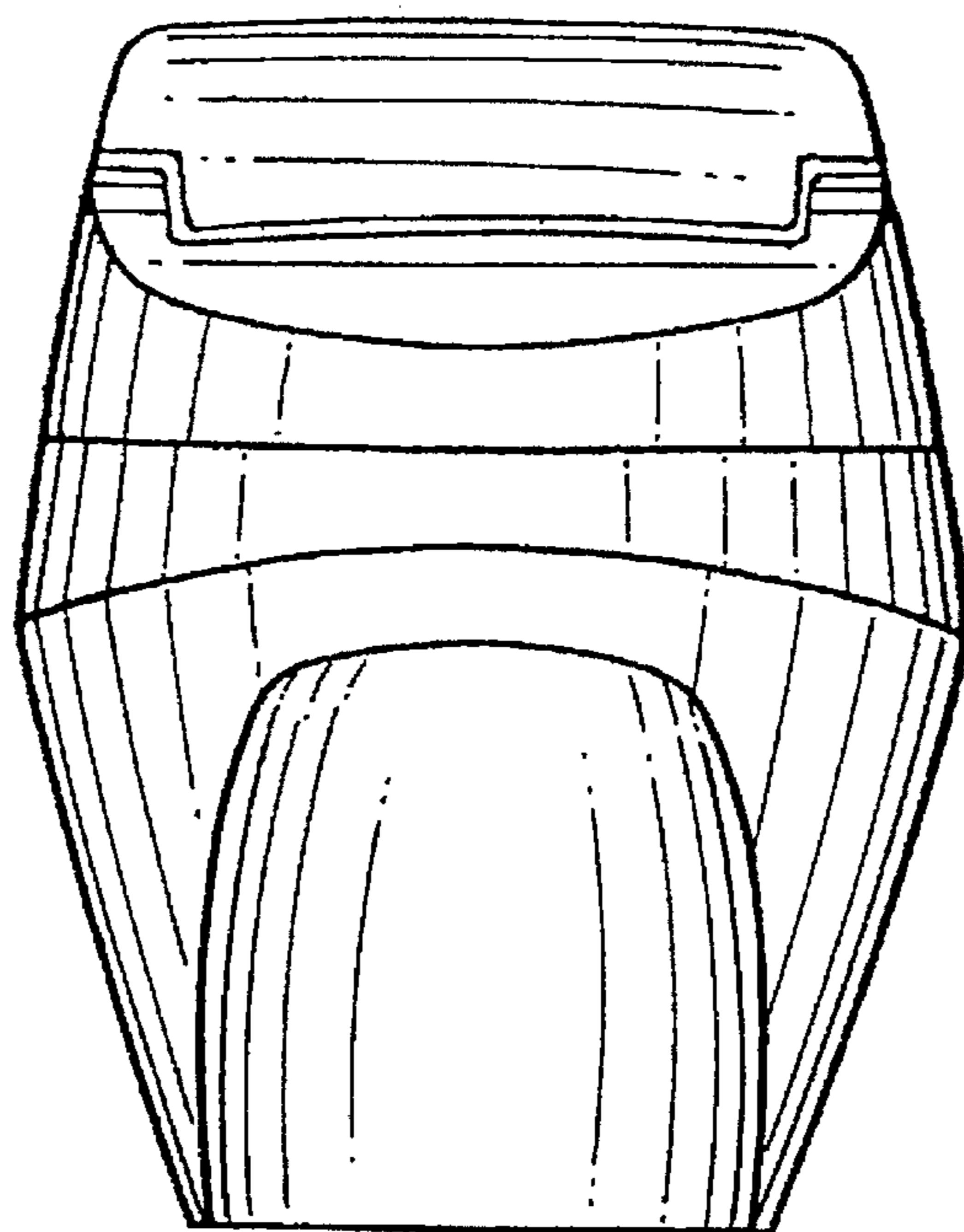

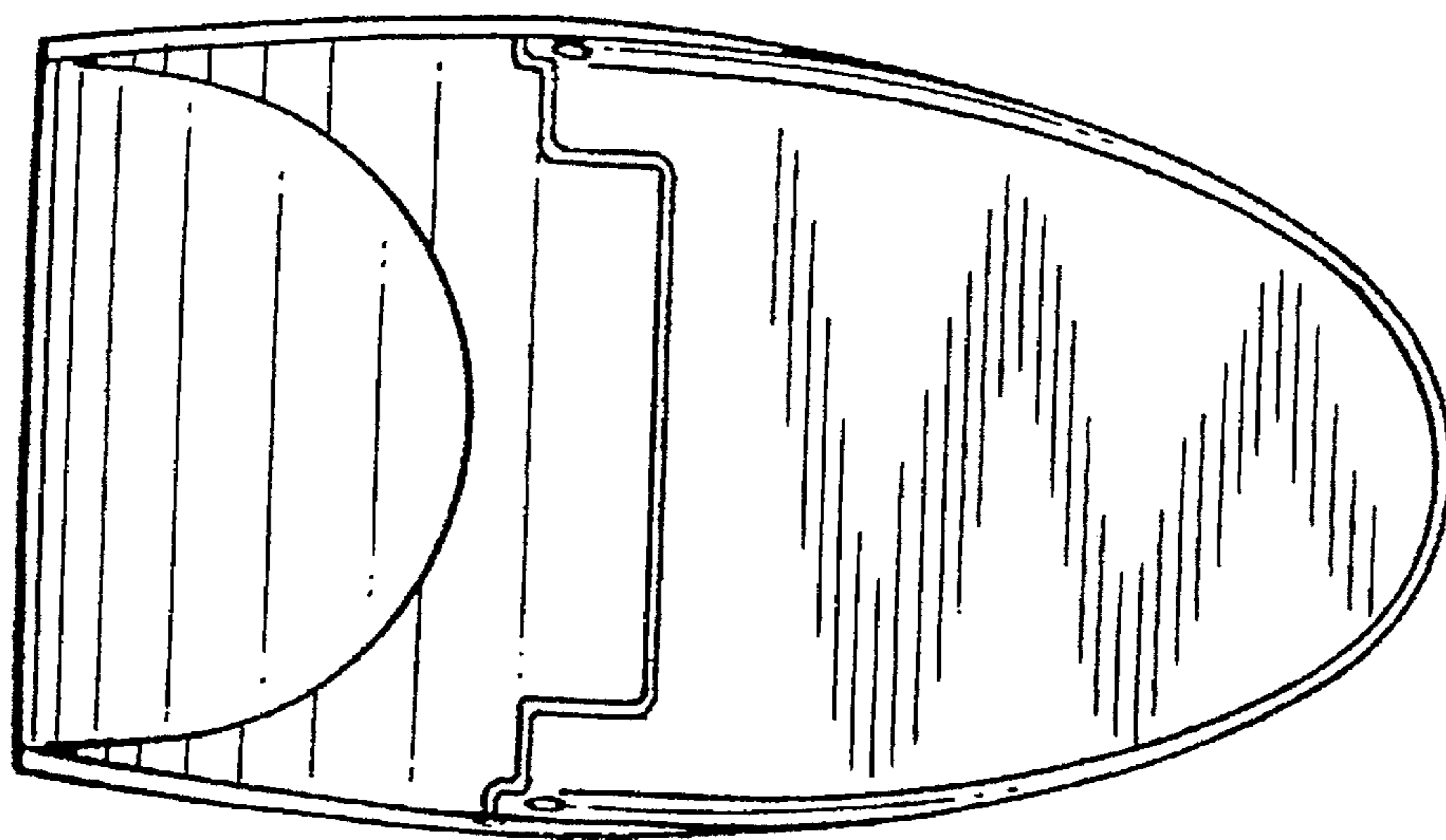

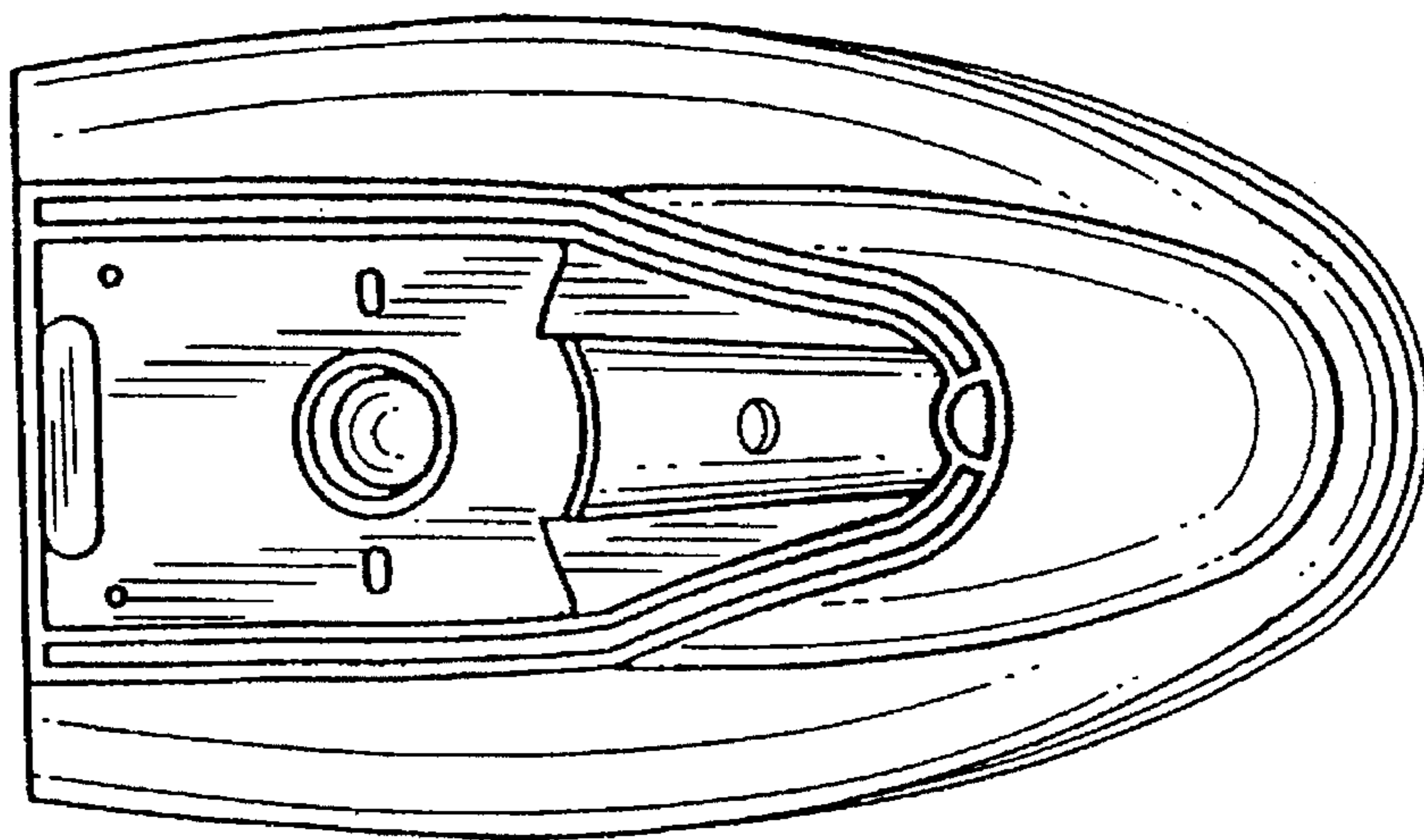

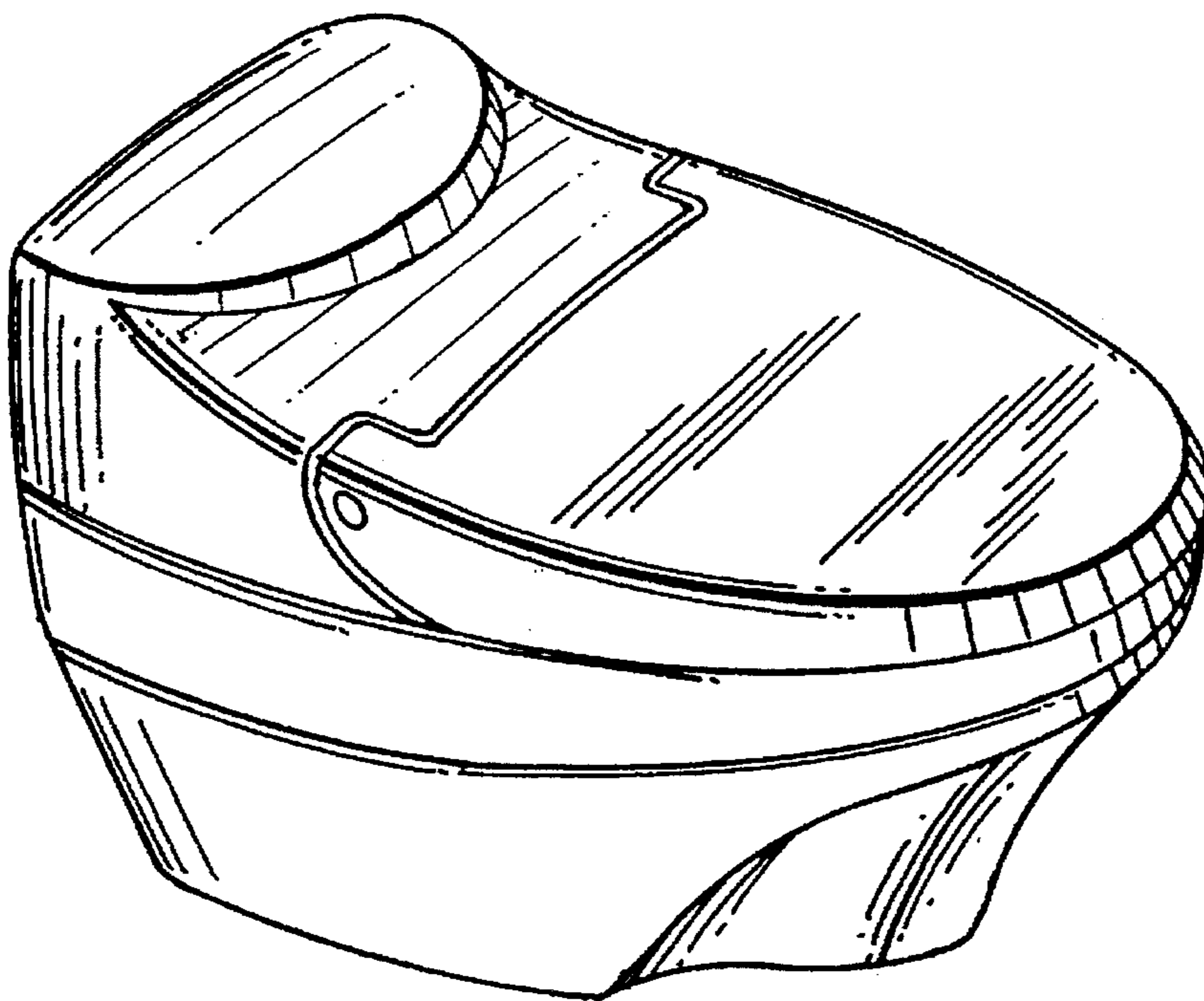
