## [57] CLAIM

The ornamental design for a siding interlock panel, as shown and described.

## DESCRIPTION

FIG. 1 is a foreshortened front elevational view of a first embodiment of a siding interlock panel showing our new design;

FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image;

FIG. 3 is a foreshortened top plan view thereof;

FIG. 4 is a foreshortened rear elevational view thereof;

FIG. 5 is a foreshortened bottom plan view thereof;

FIG. 6 is a foreshortened front elevational view of a second embodiment of a siding interlock panel showing our new design;

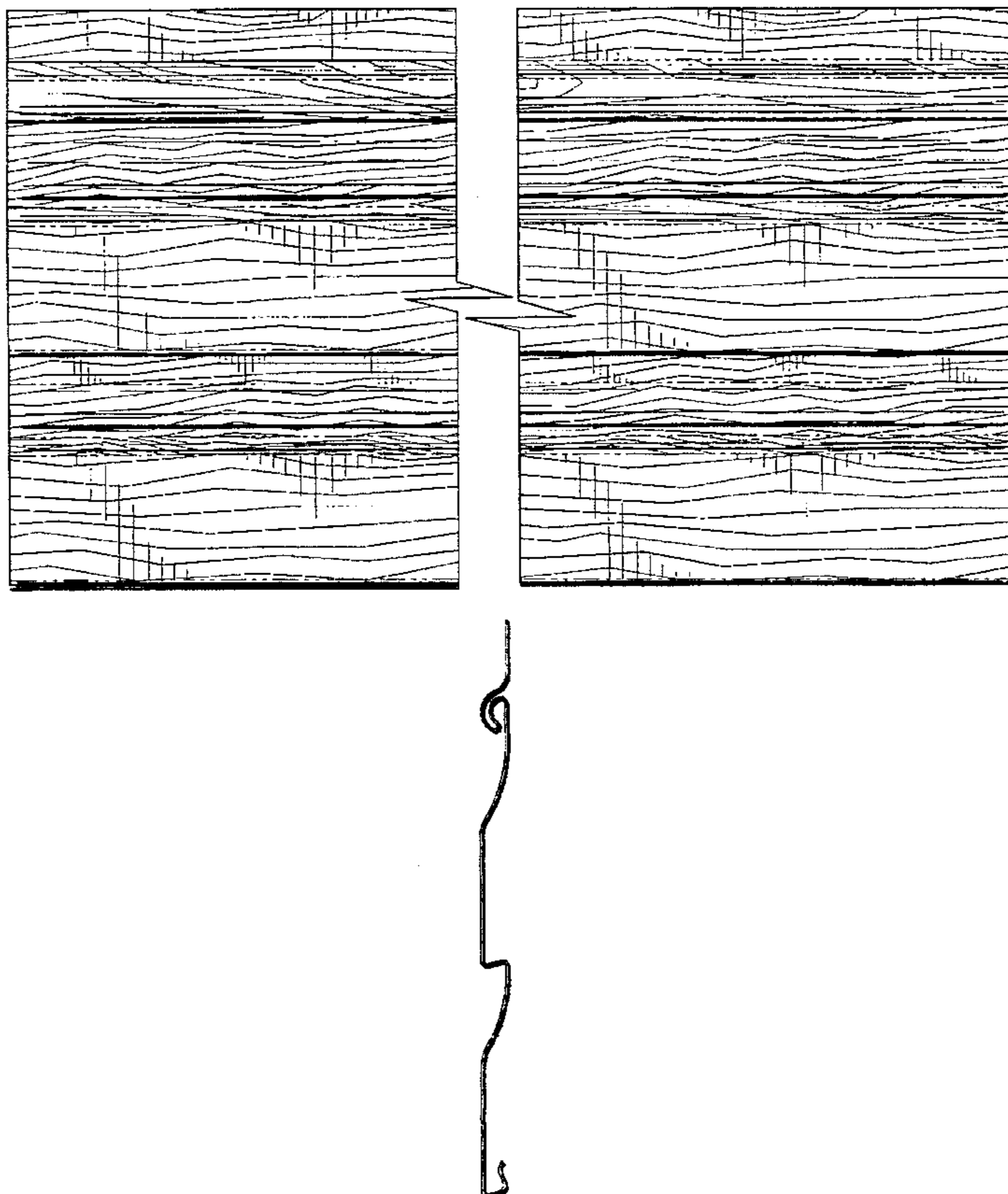
FIG. 7 is a right side elevational view thereof, the left side elevational view being a mirror image;

FIG. 8 is a foreshortened top plan view thereof;

FIG. 9 is a foreshortened rear elevational view thereof; and,

FIG. 10 is a foreshortened bottom plan view thereof.

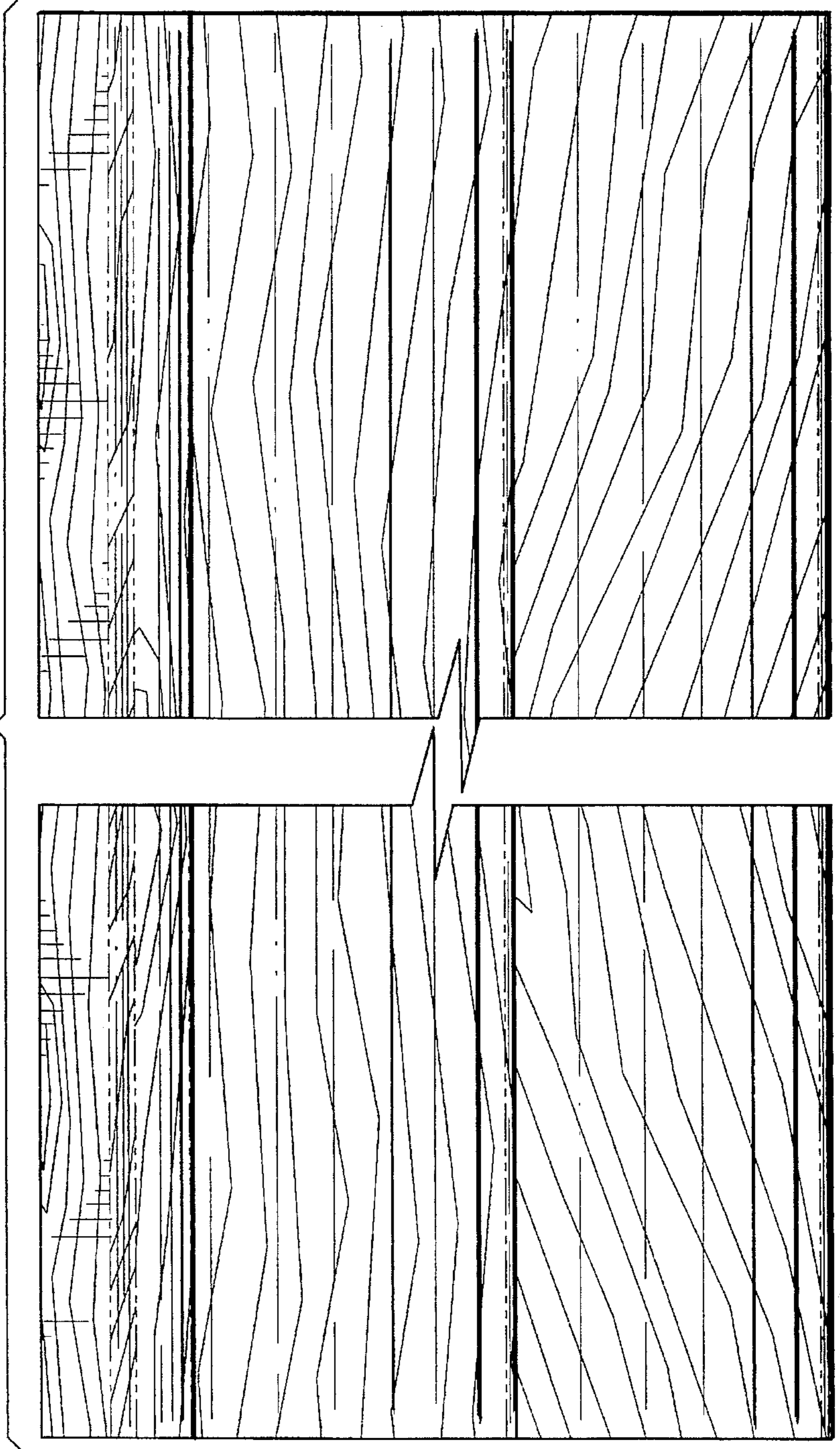

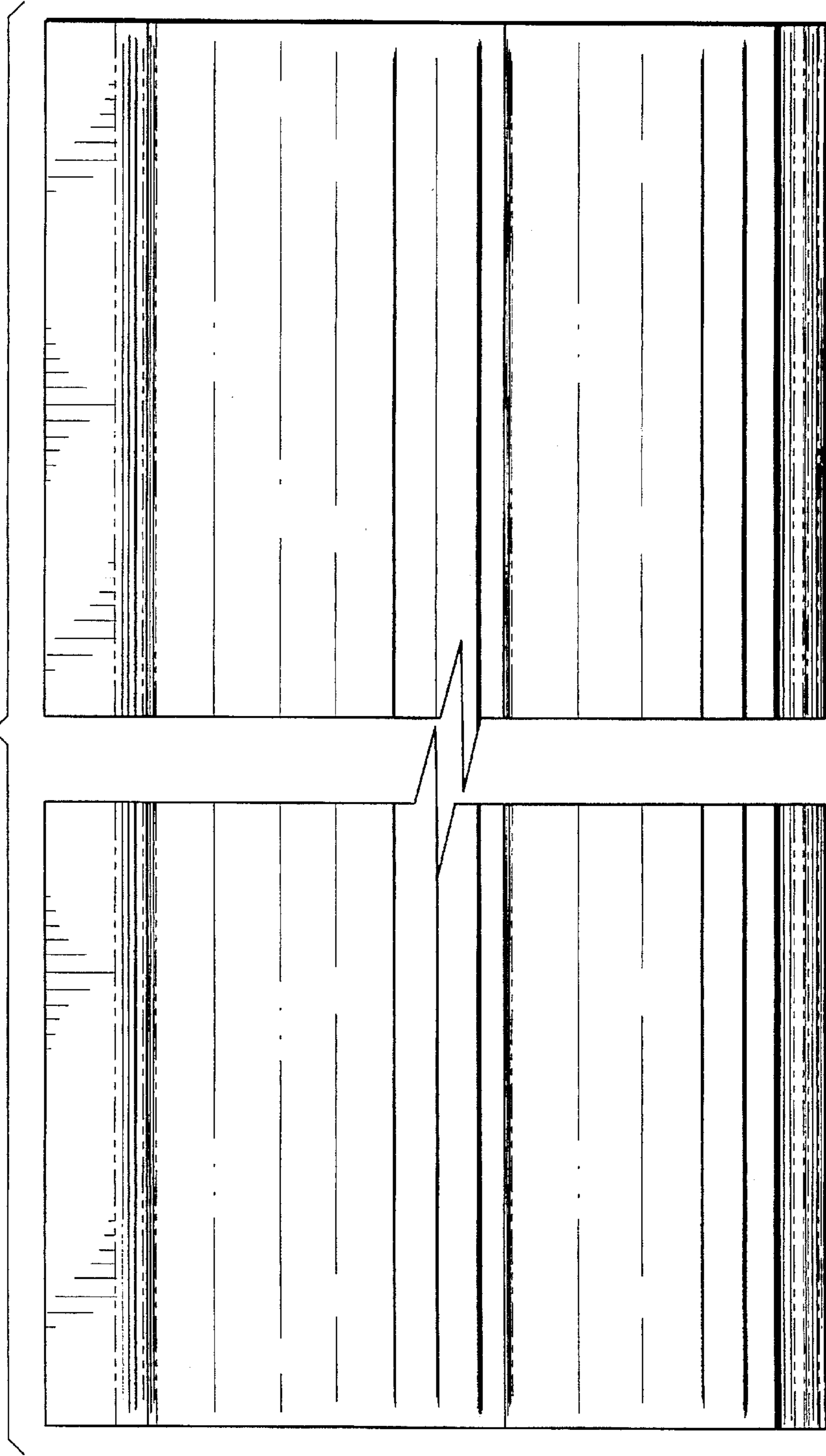

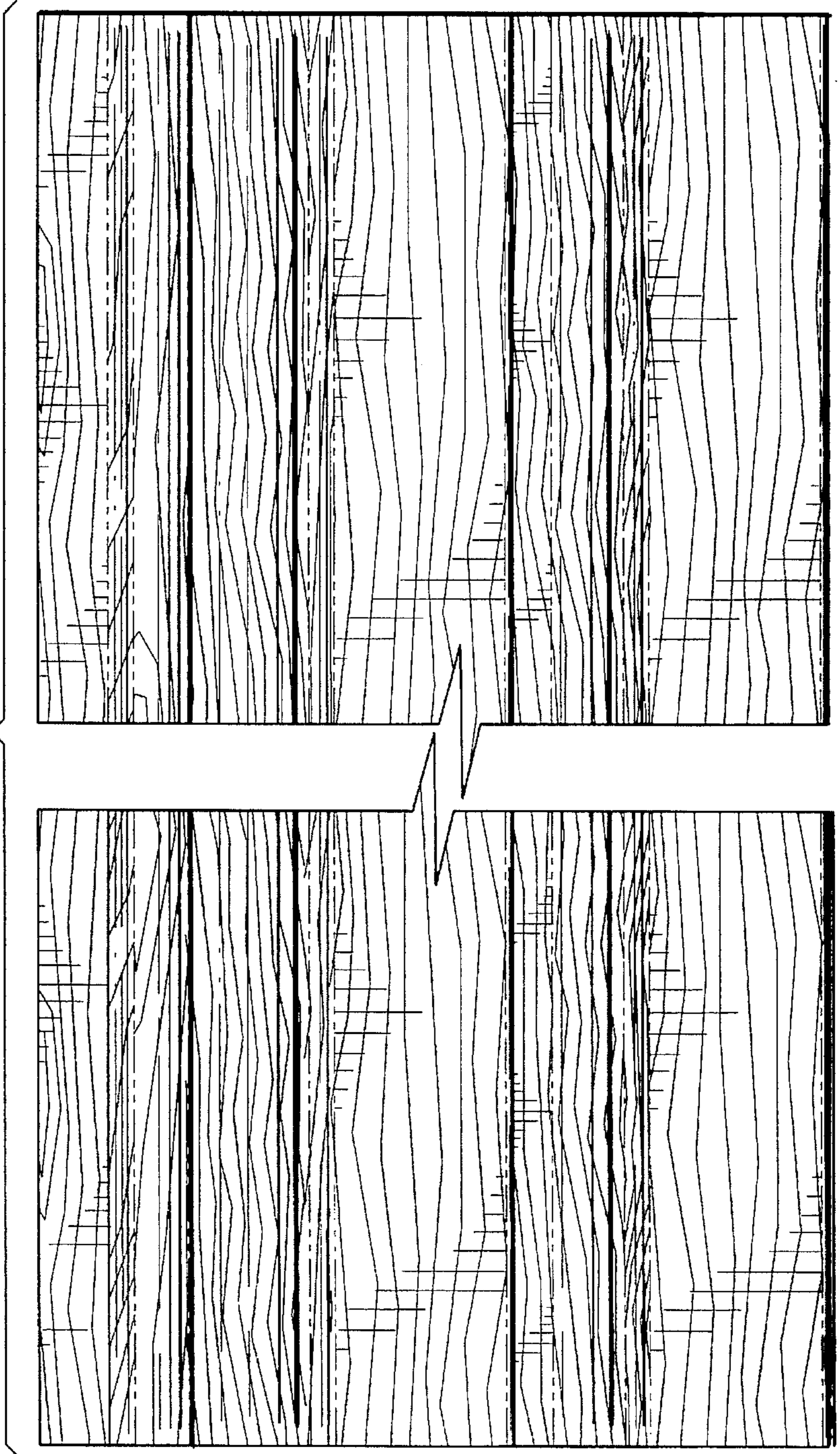

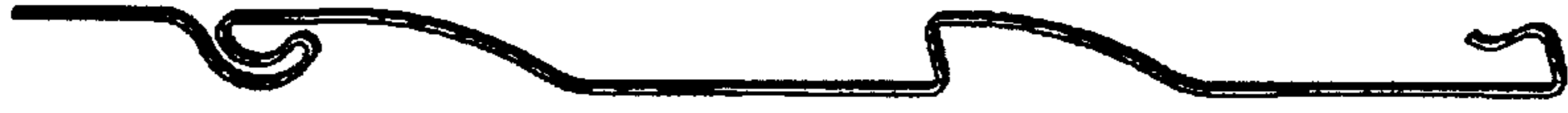

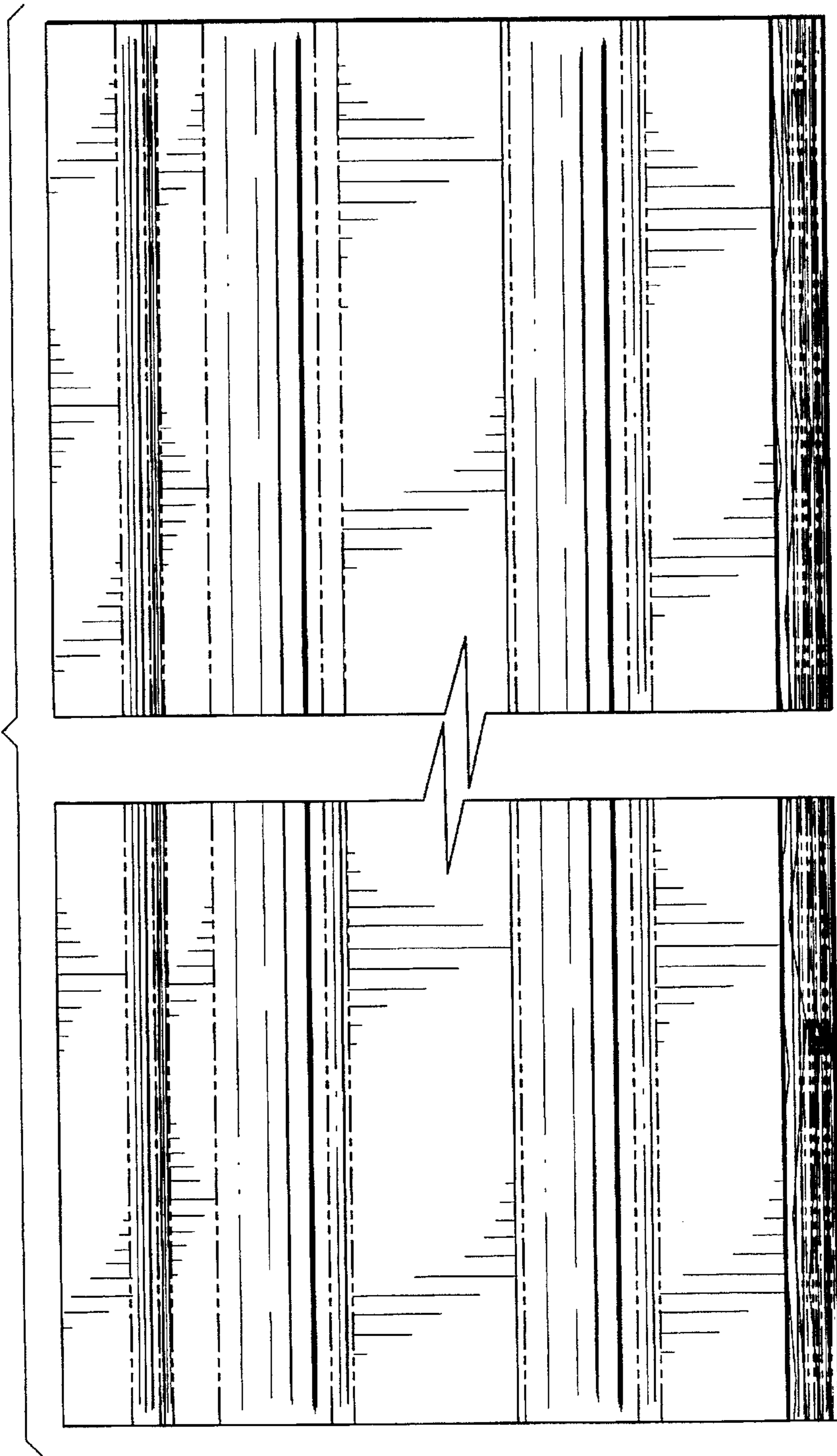
