The ornamental design for a speed lace, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a speed lace showing our new

design; the laces partially broken away for ease of illustration;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side elevational view thereof, the left side being a mirror image;

FIG. 6 is a perspective view of a second embodiment of FIG. 1;

FIG. 7 is a front elevational view of FIG. 6;

FIG. 8 is a top plan view of FIG. 6;

FIG. 9 is a bottom plan view of FIG. 6;

FIG. 10 is a right side elevational view of FIG. 6, the left side being a mirror image;

FIG. 11 is a perspective view of a third embodiment of FIG. 1;

FIG. 12 is a front elevational view of FIG. 11;

FIG. 13 is a top plan view of FIG. 11;

FIG. 14 is a bottom plan view of FIG. 11;

FIG. 15 is a right side elevational view of FIG. 11, the left side being a mirror image;

FIG. 16 is a perspective view of a fourth embodiment of FIG. 1;

FIG. 21 is a perspective view of a fifth embodiment of FIG. 1;

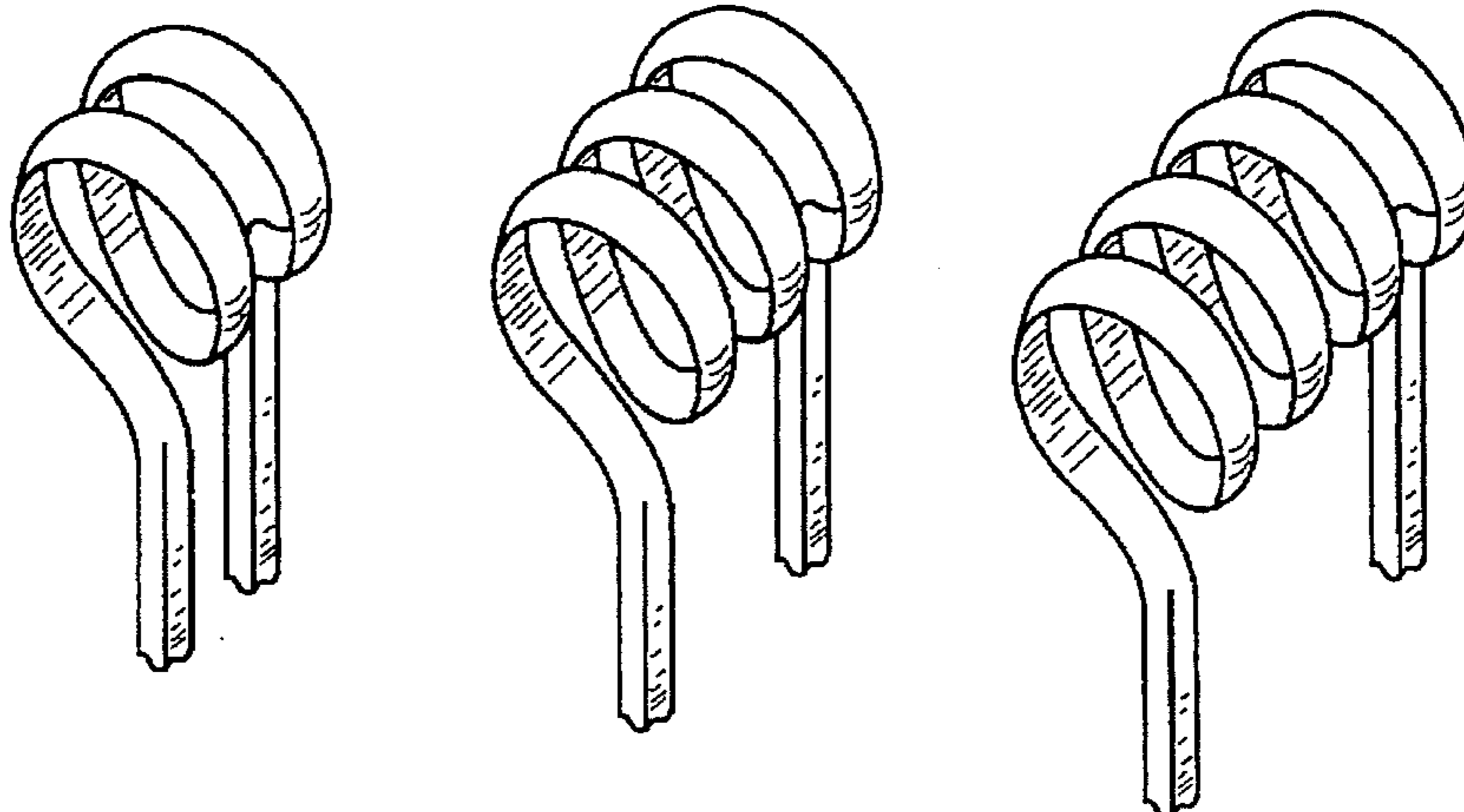
FIG. 22 is a front elevational view of FIG. 21;

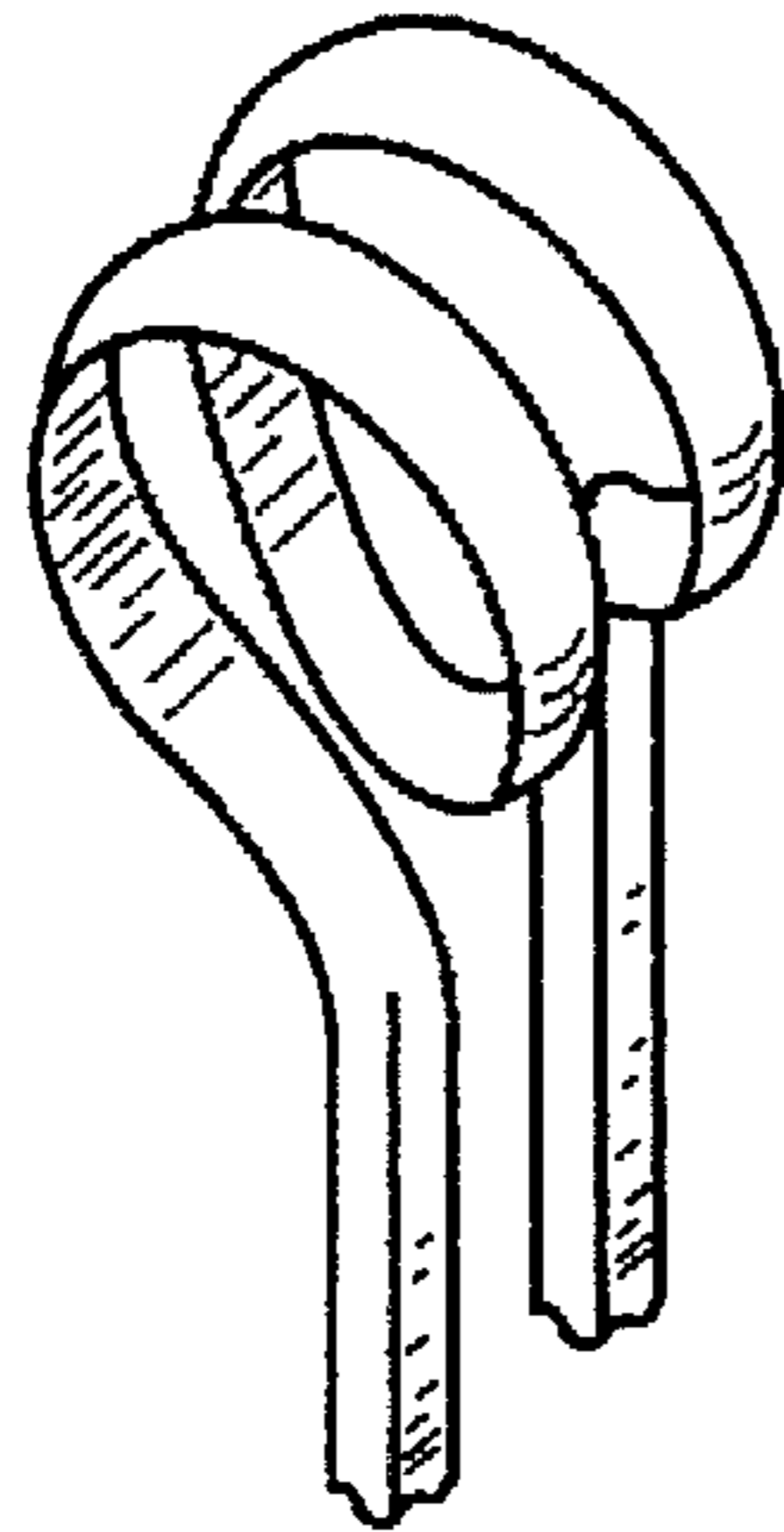
FIG. 23 is a top plan view of FIG. 21;

FIG. 24 is a bottom plan view of FIG. 21;

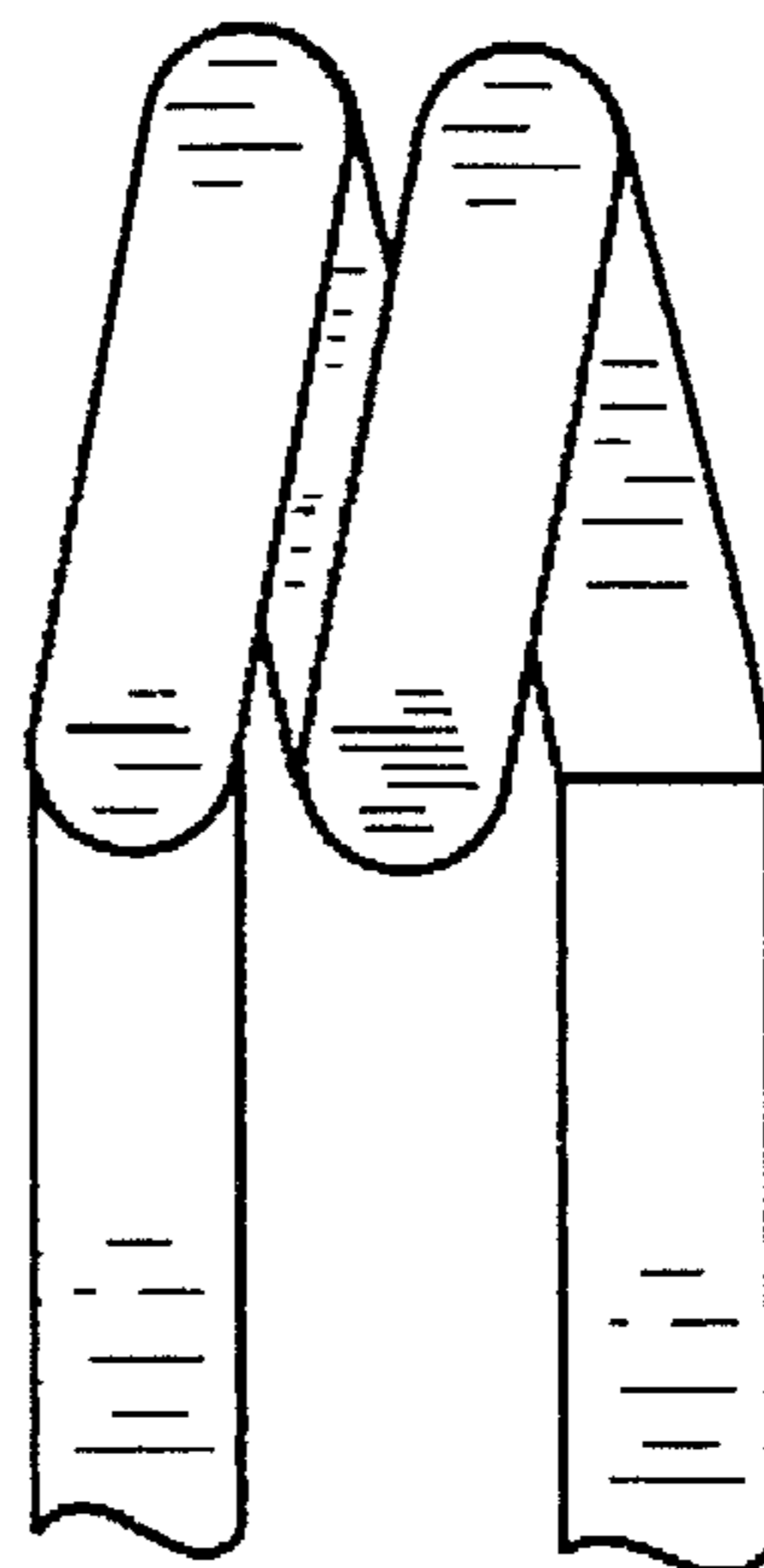
FIG. 25 is a right side elevational view of FIG. 21, the left side being a mirror image.

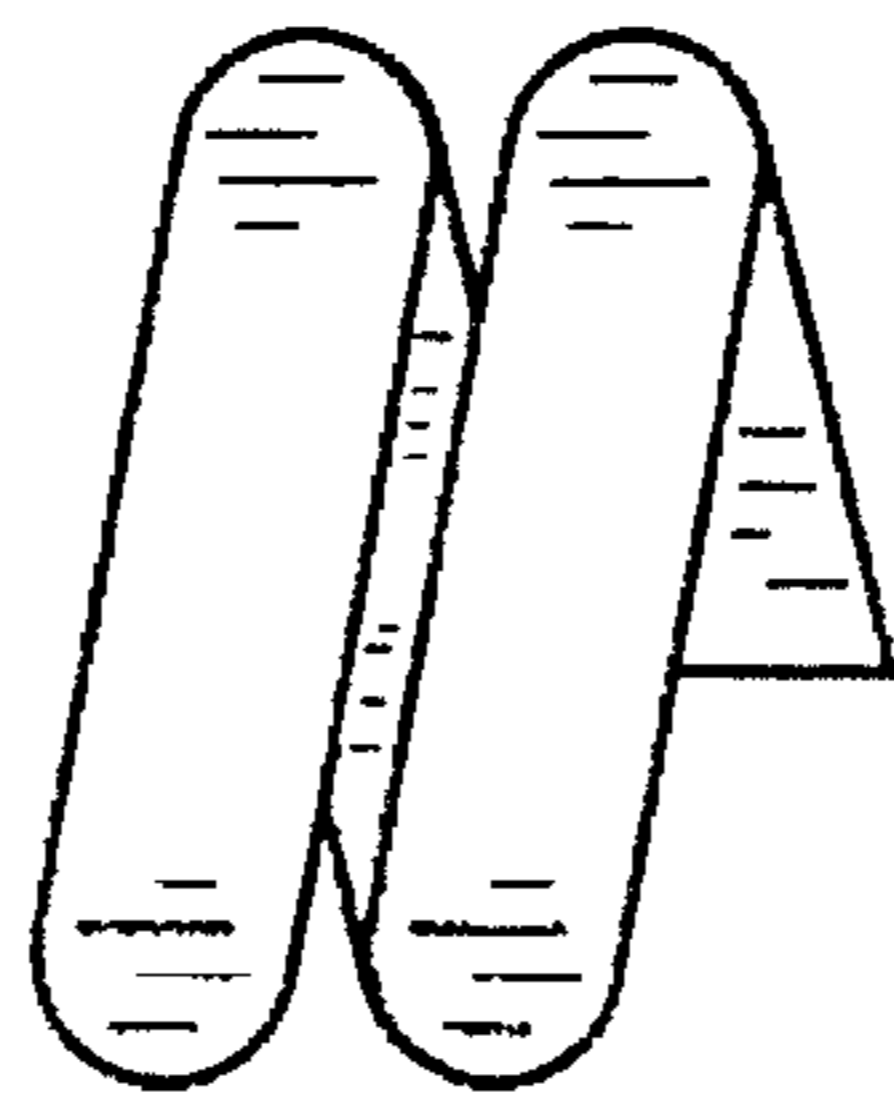

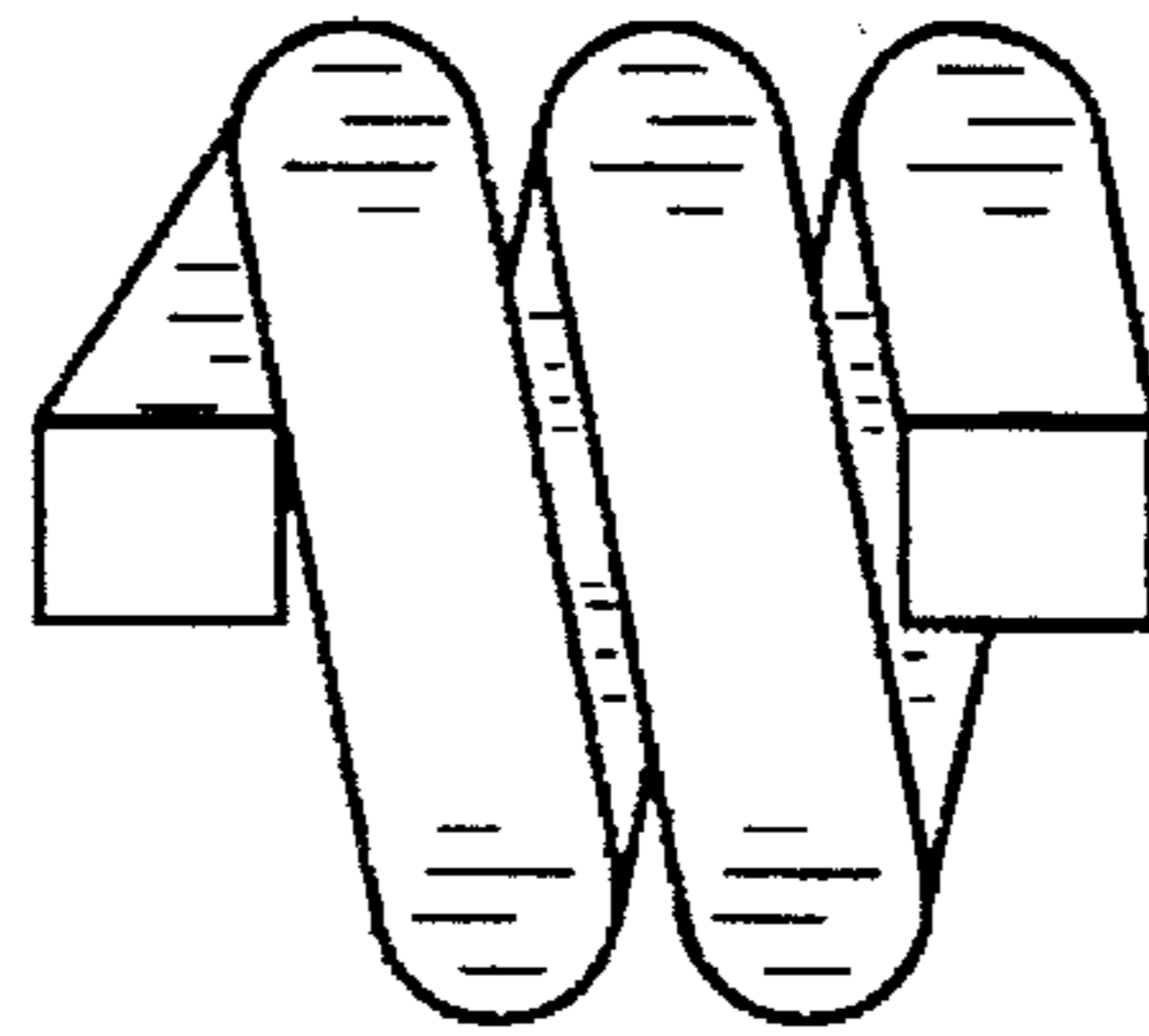

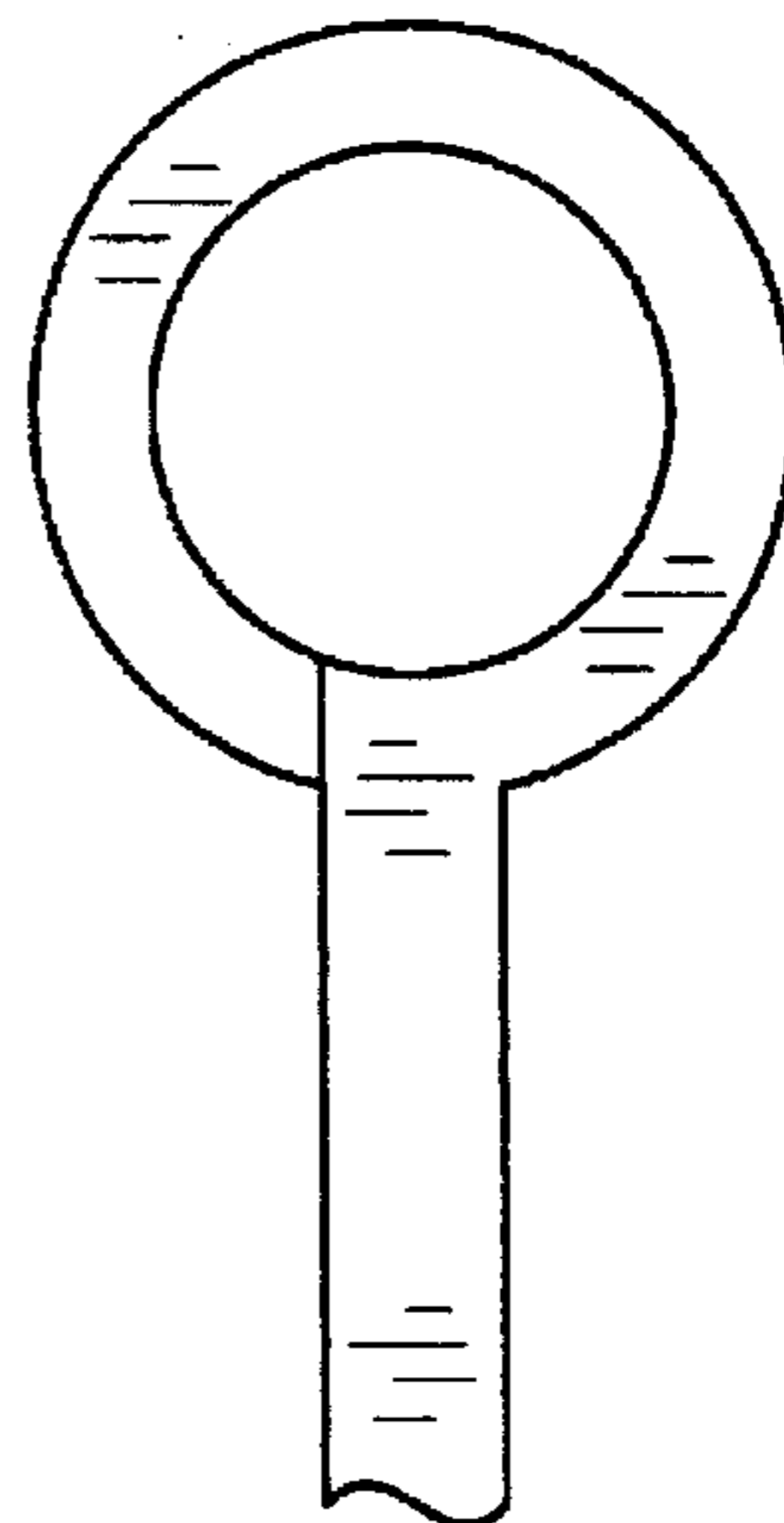


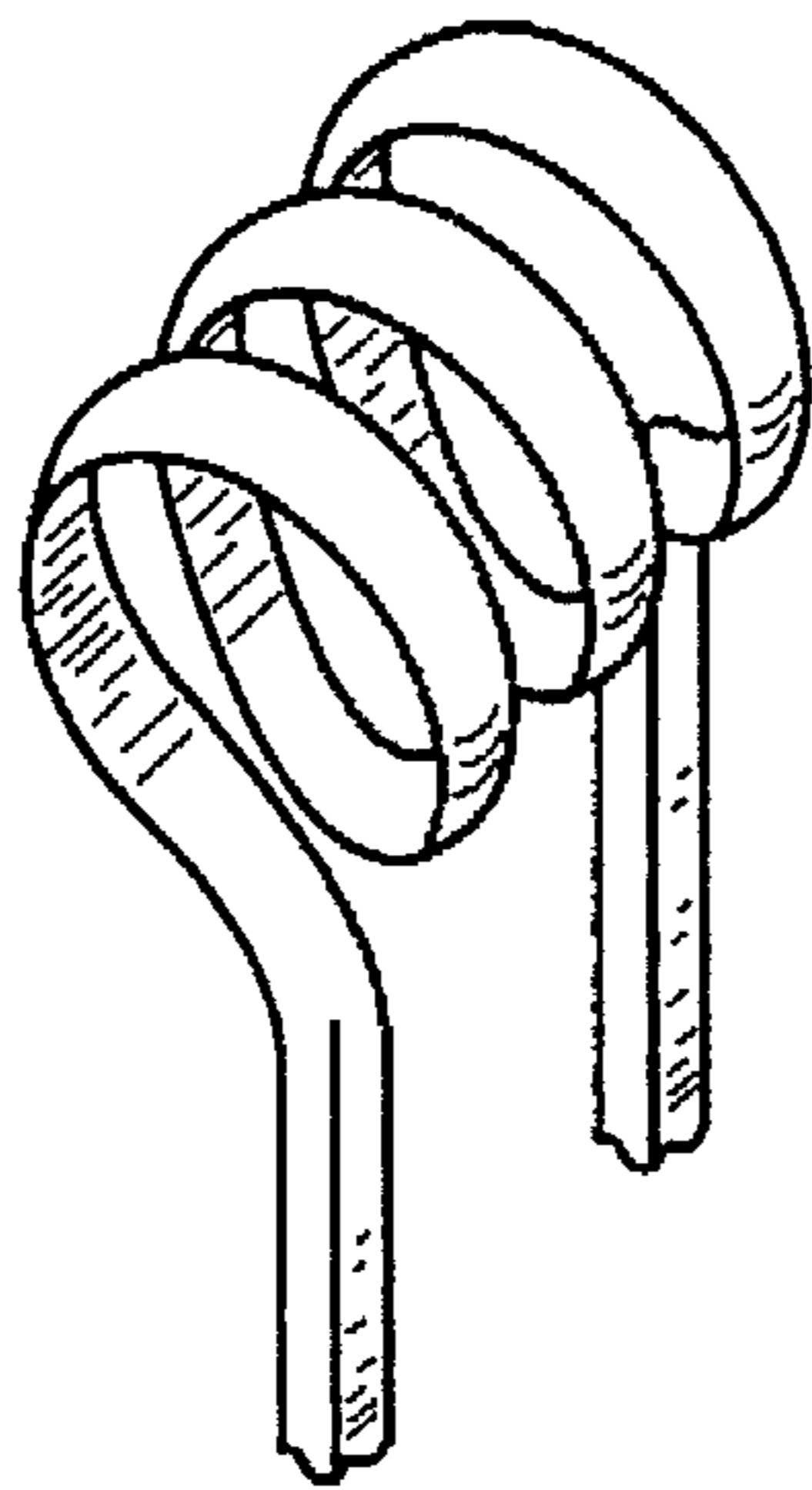

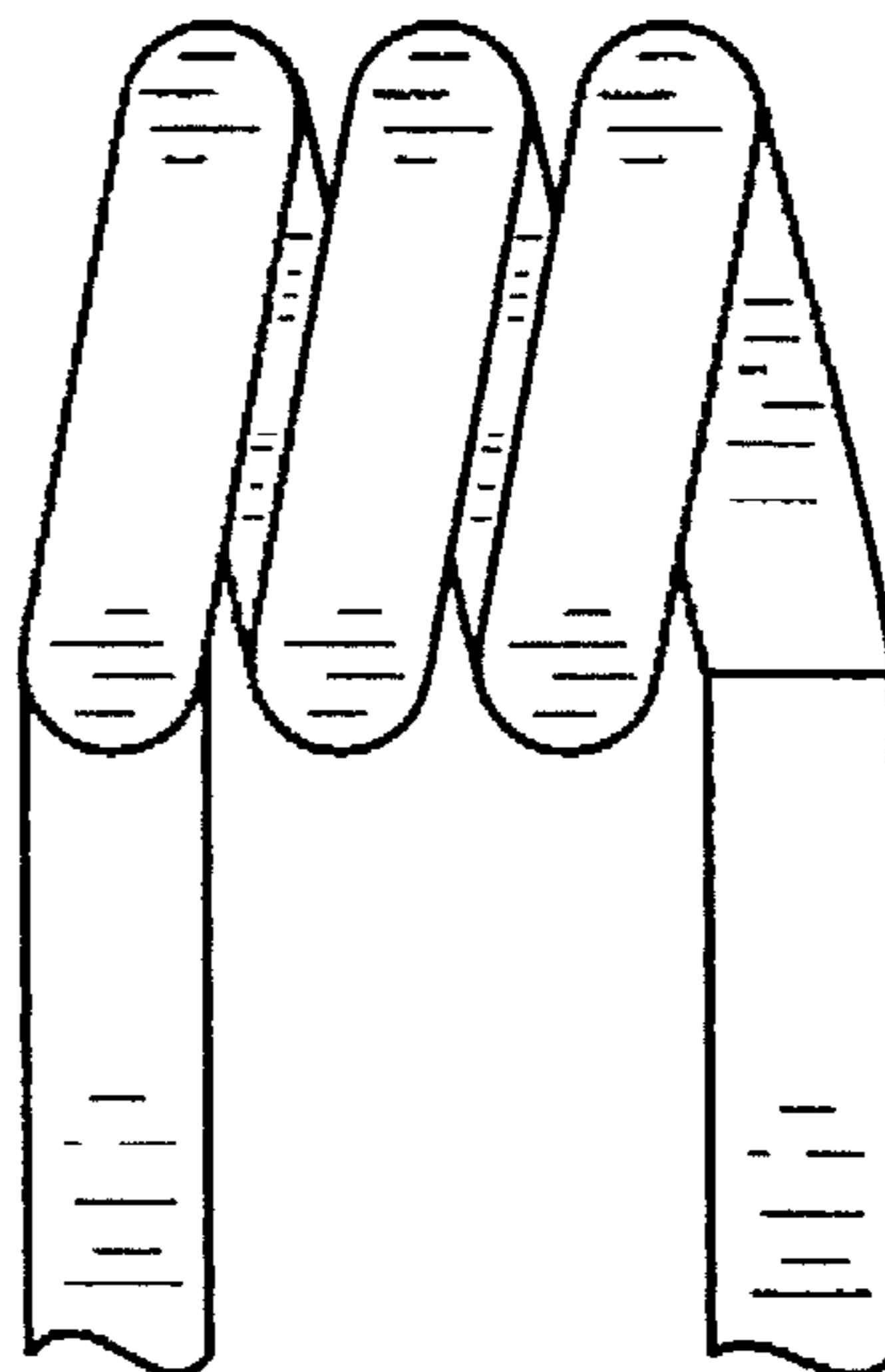

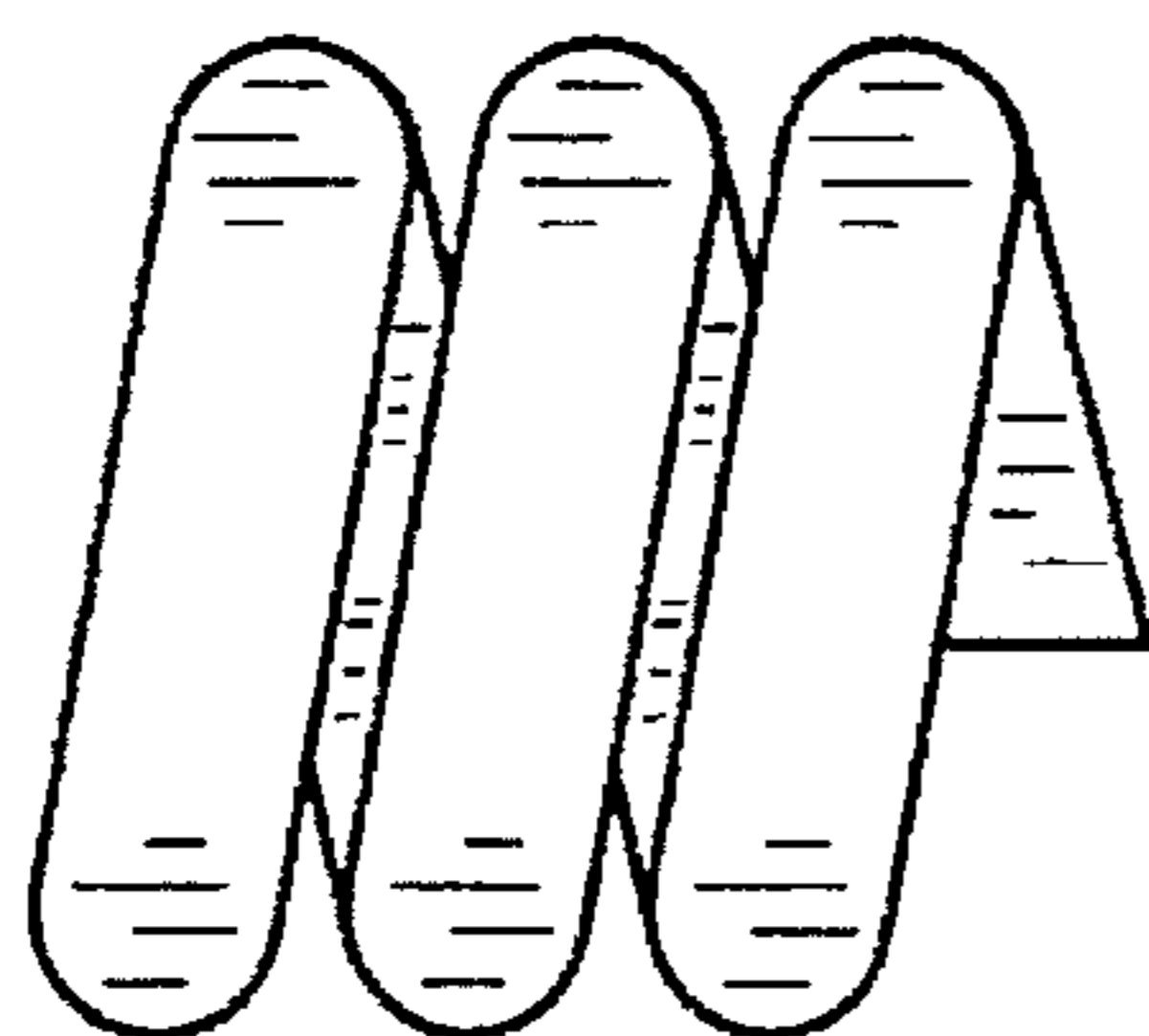

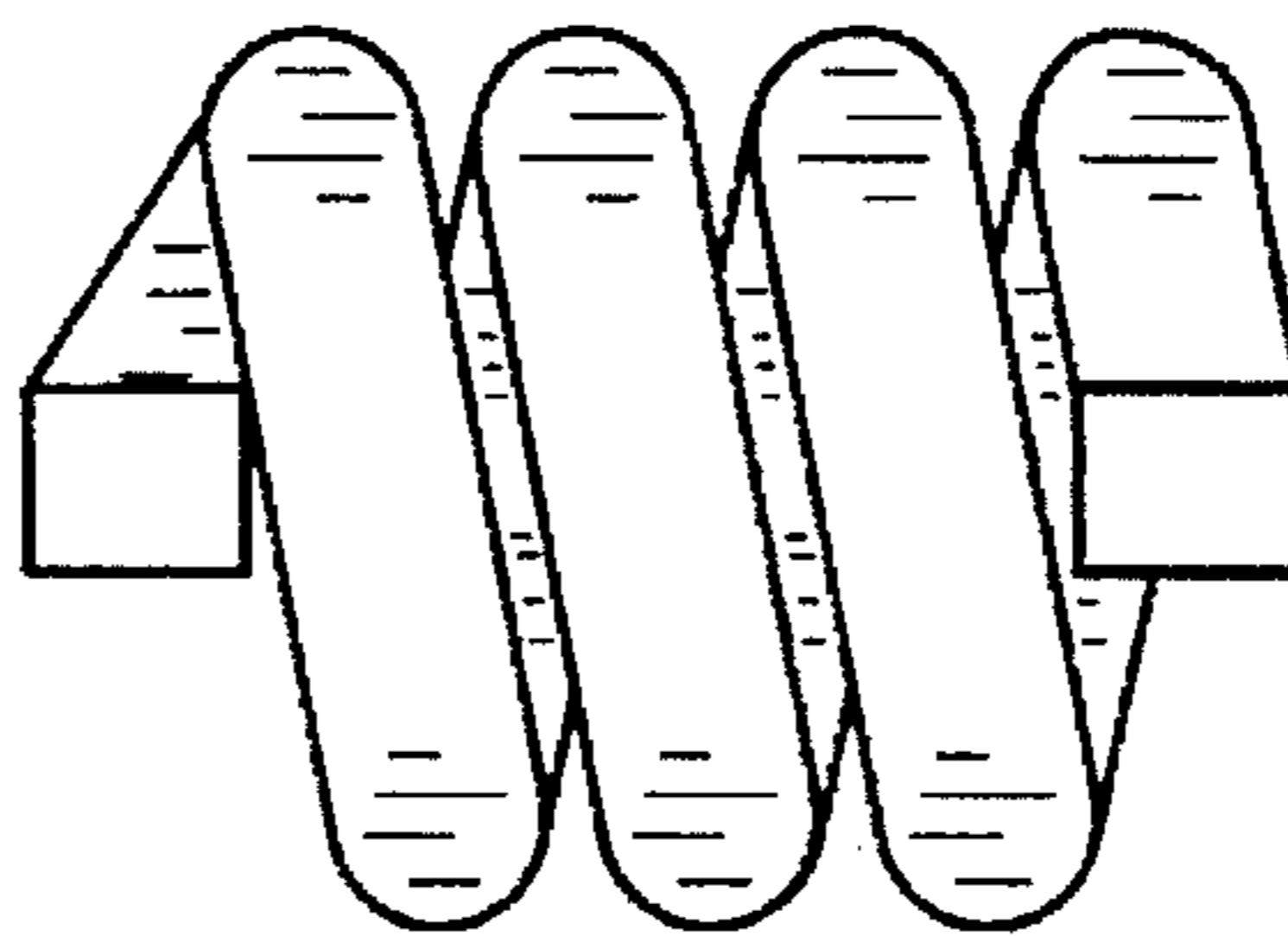

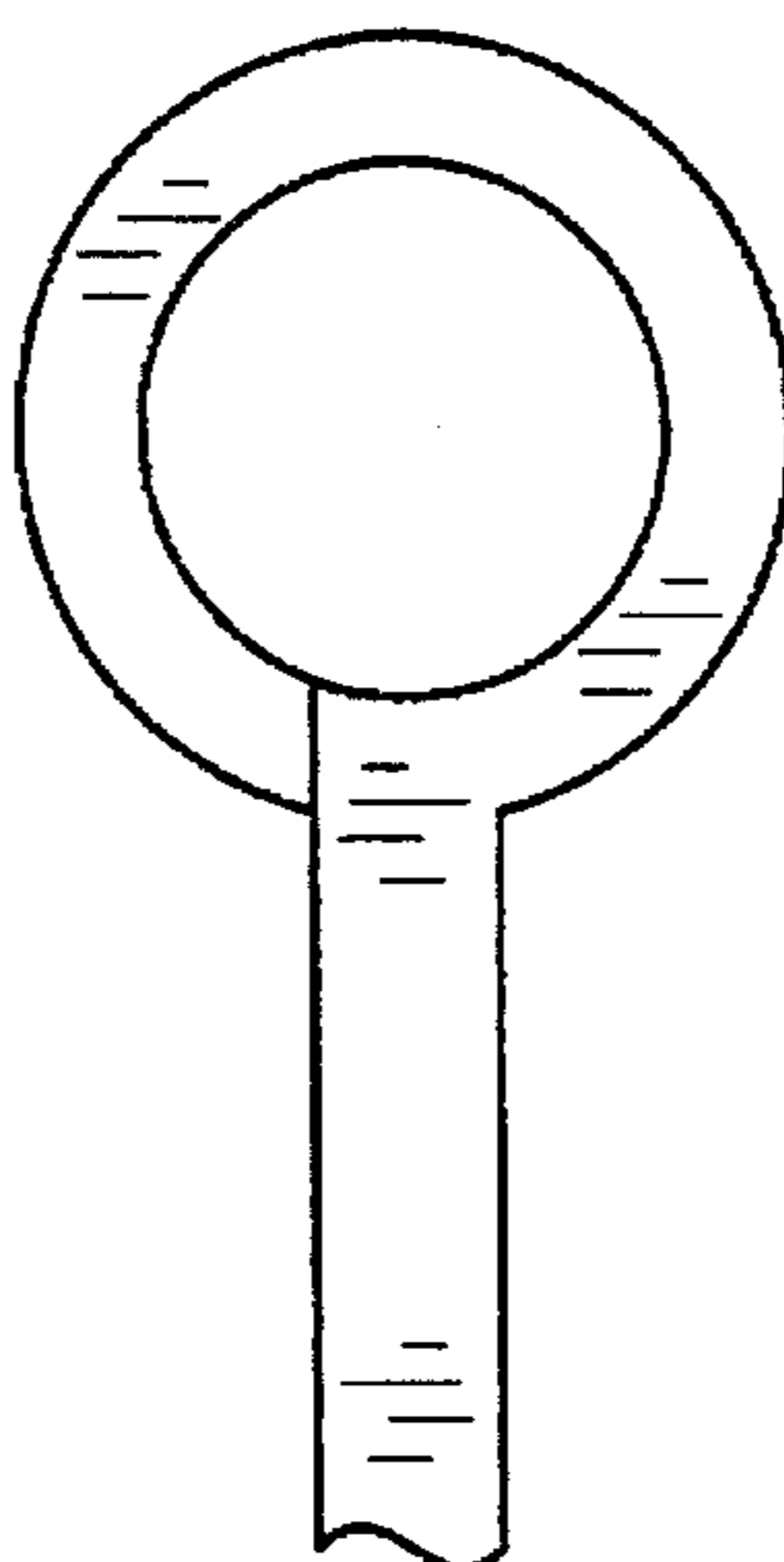


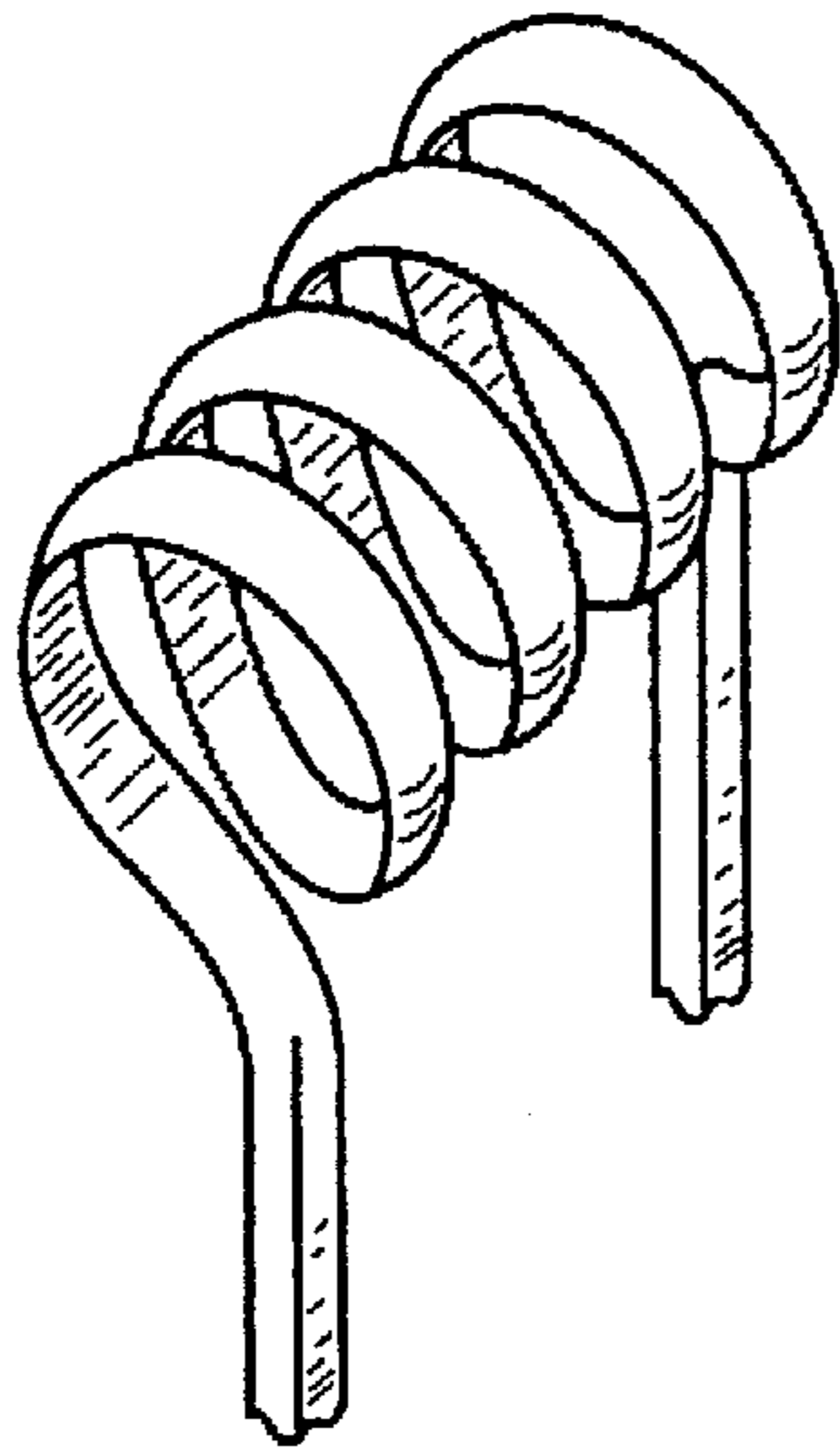

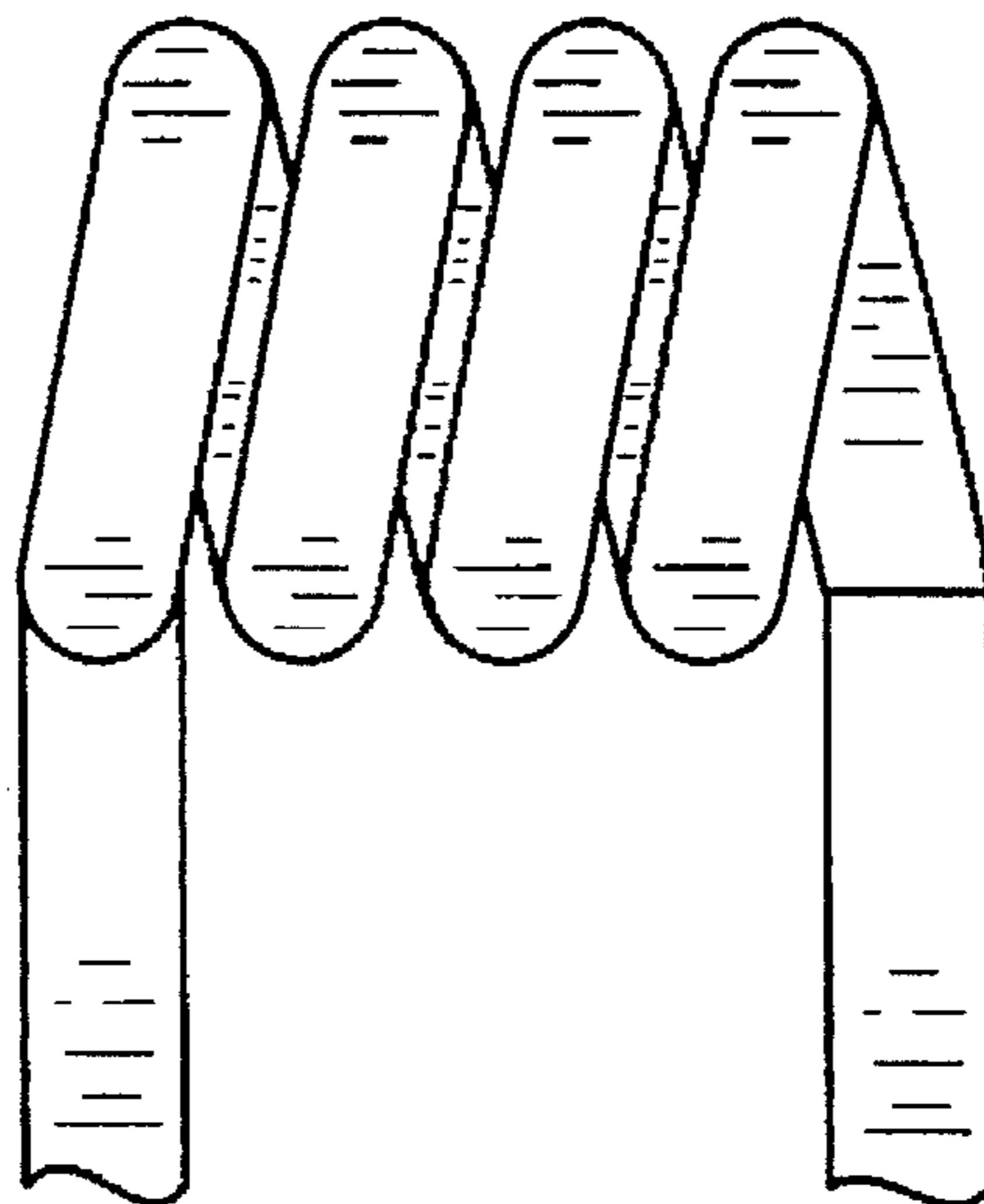

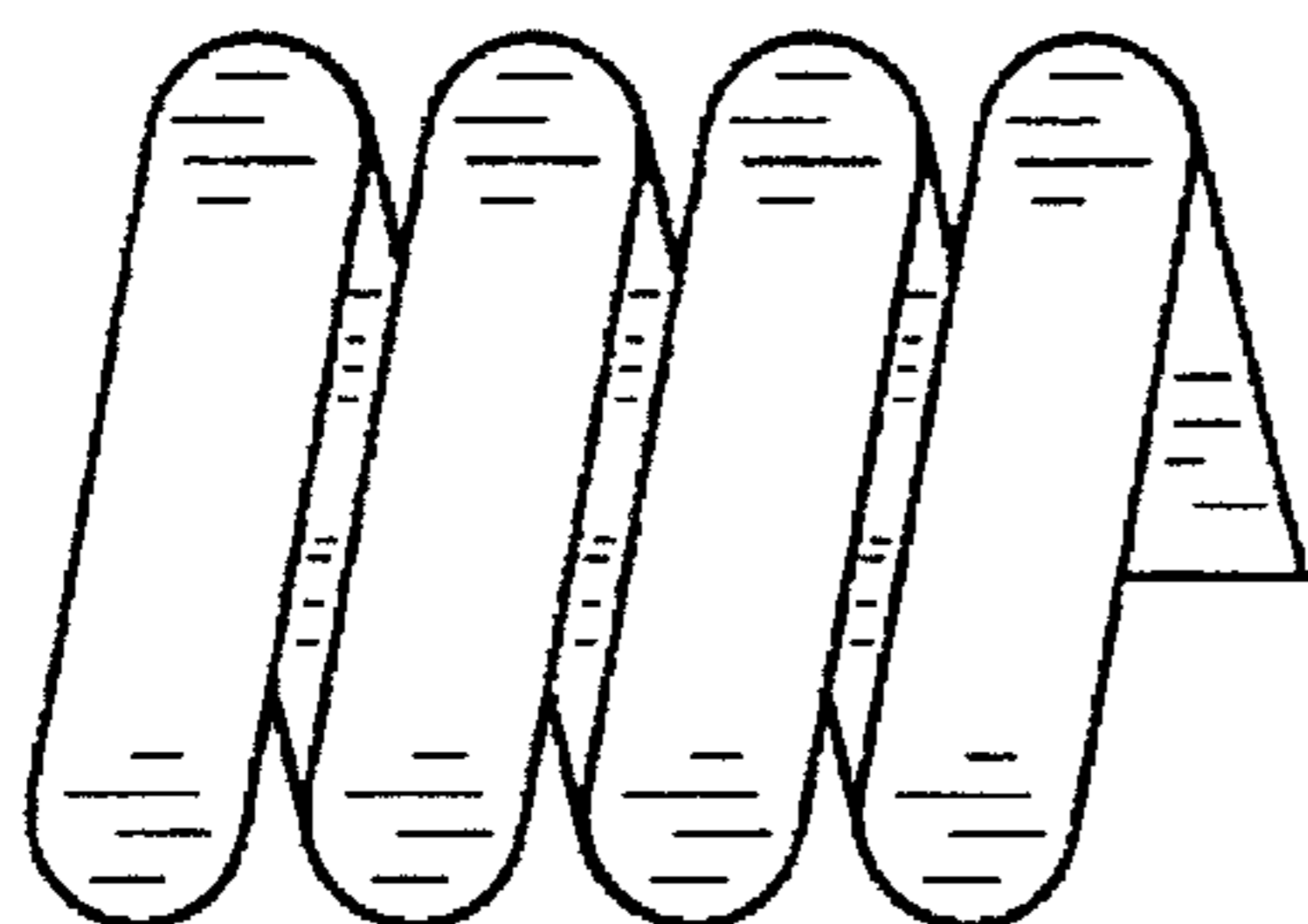

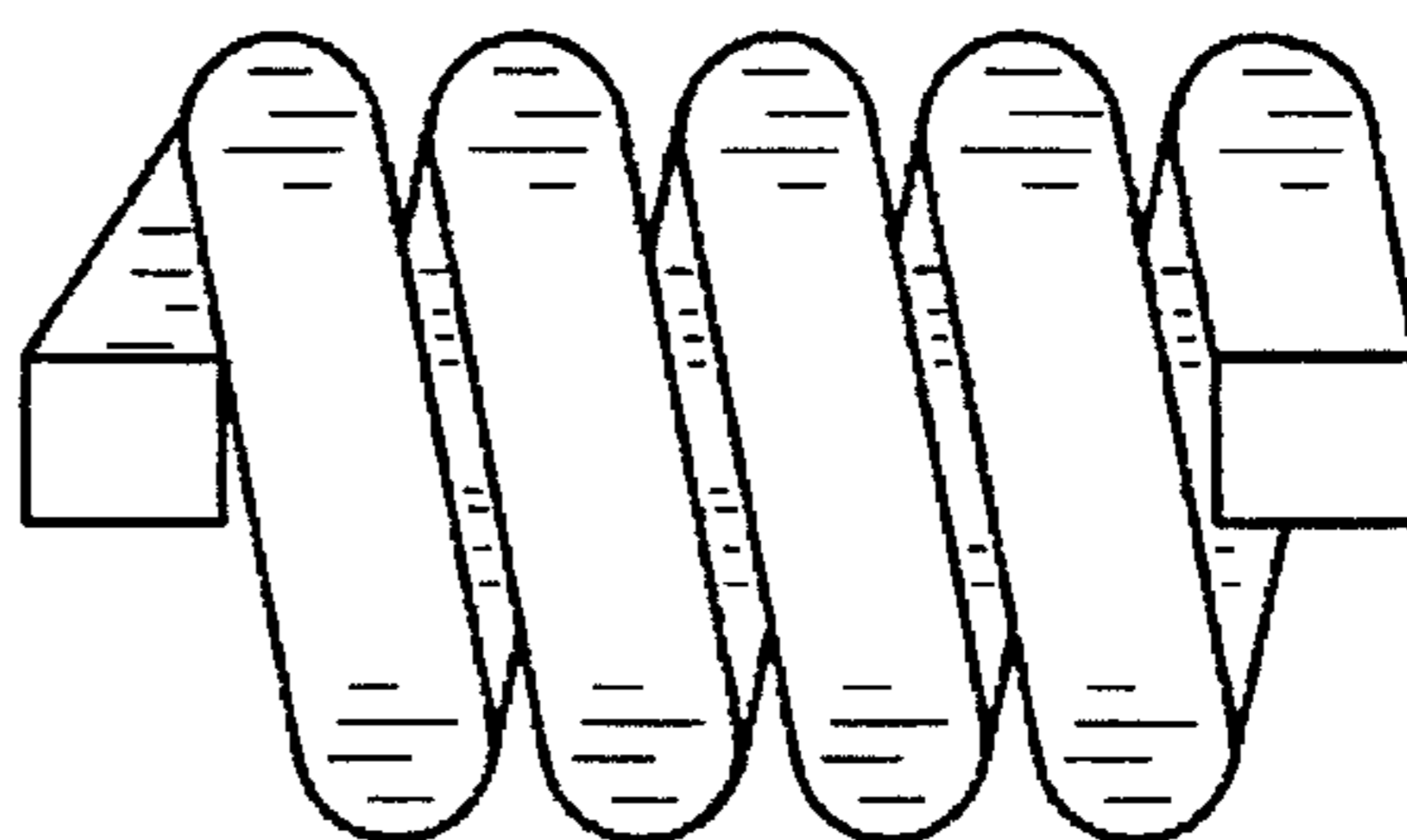

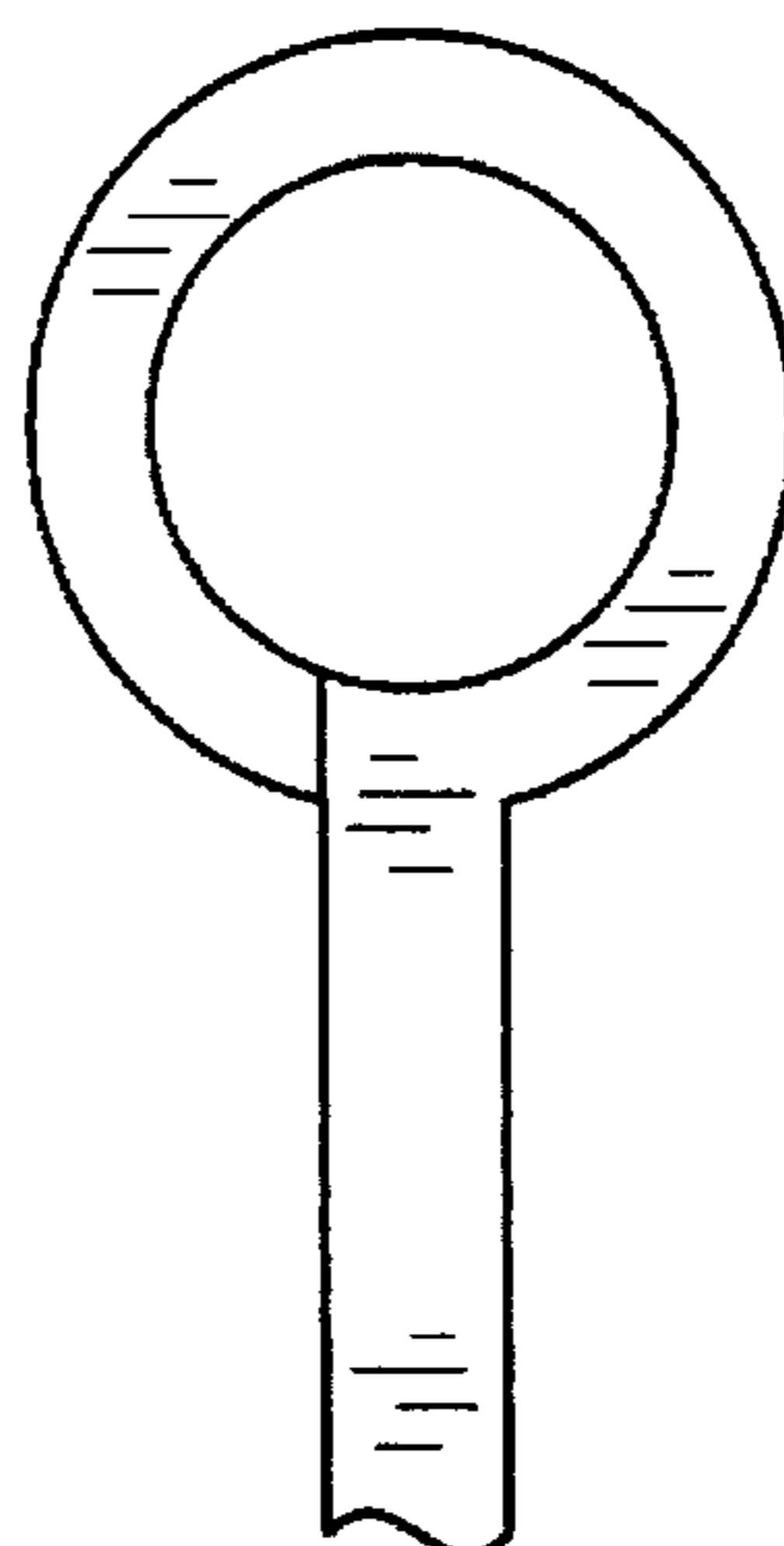

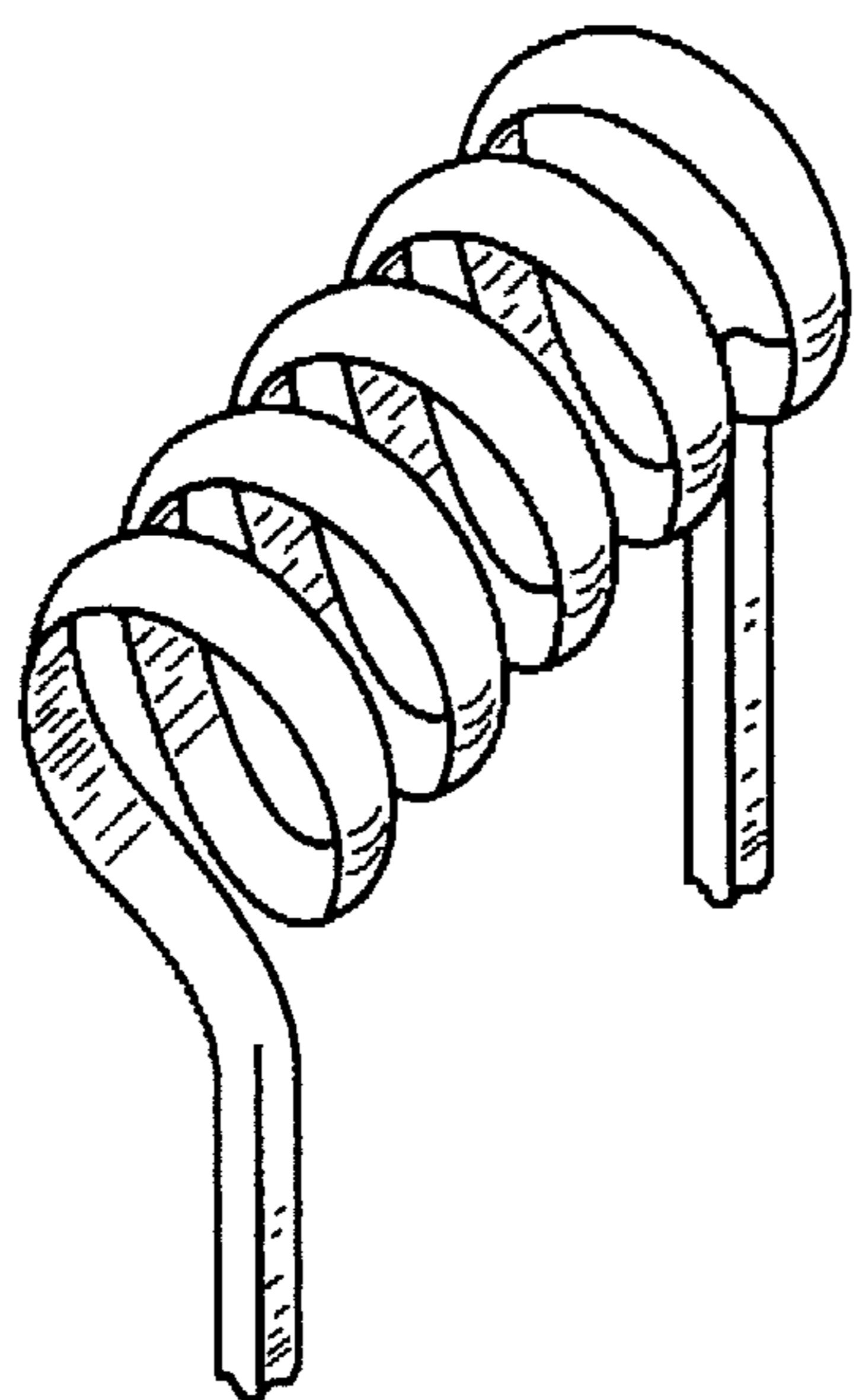

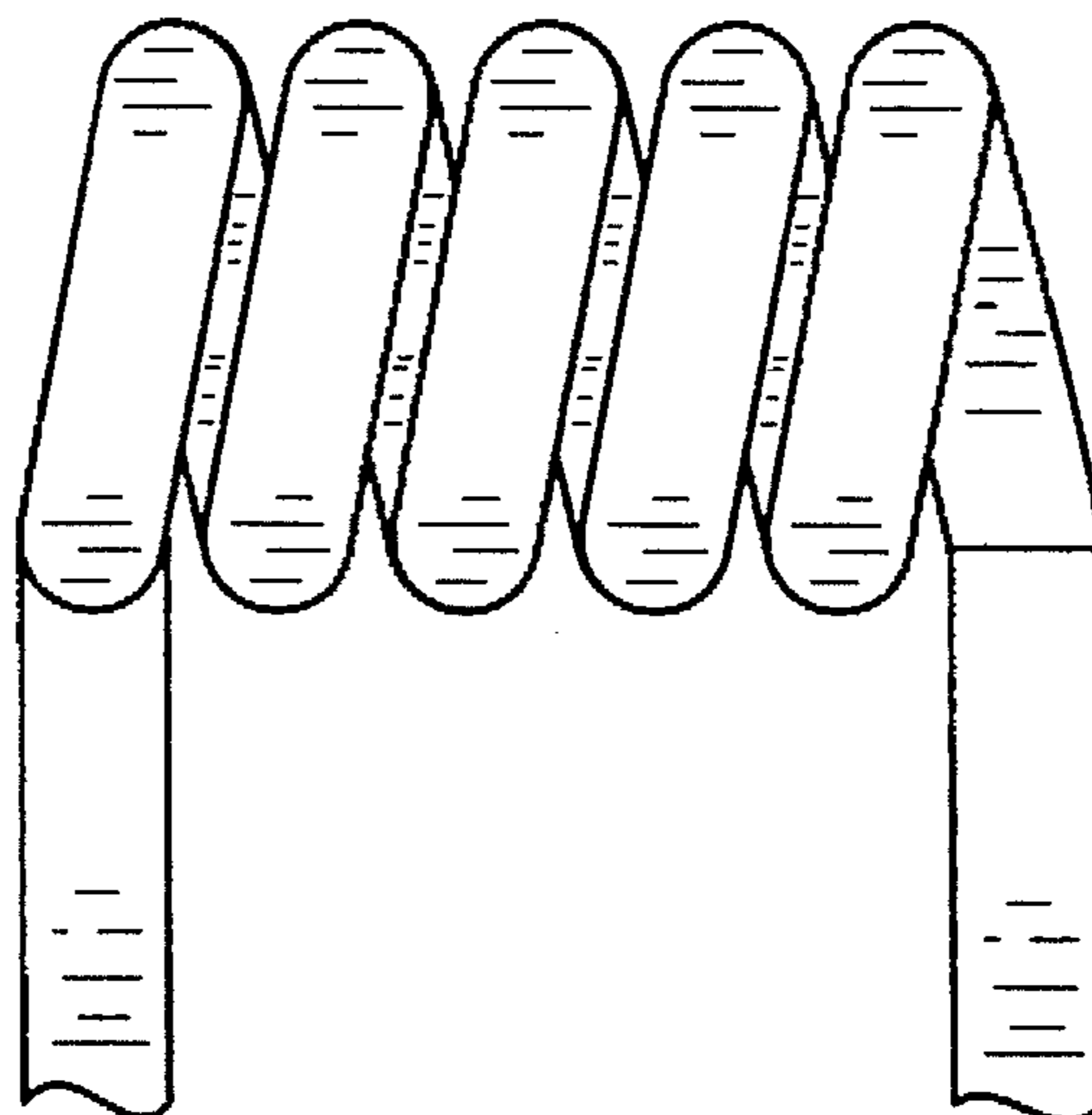




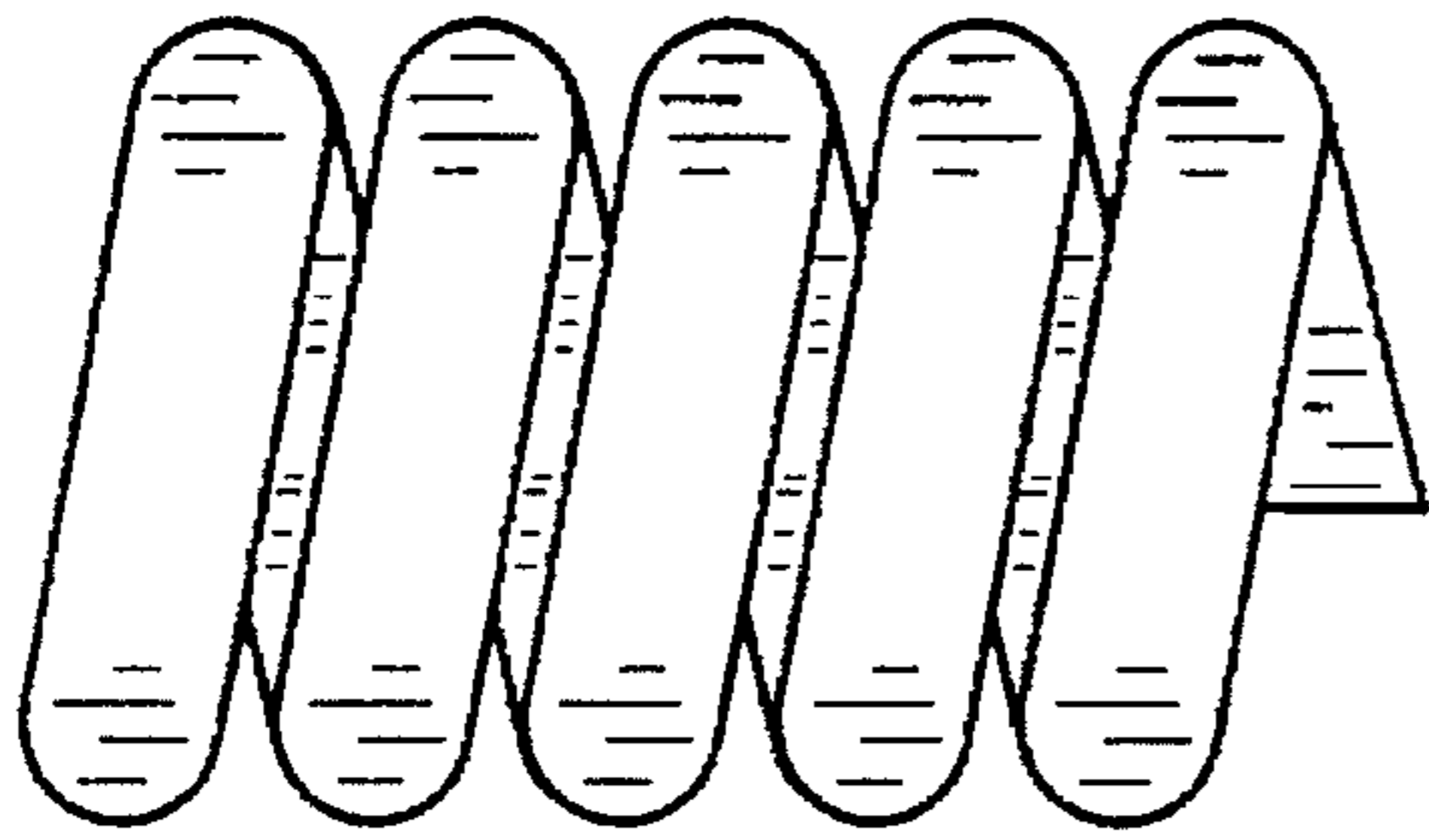

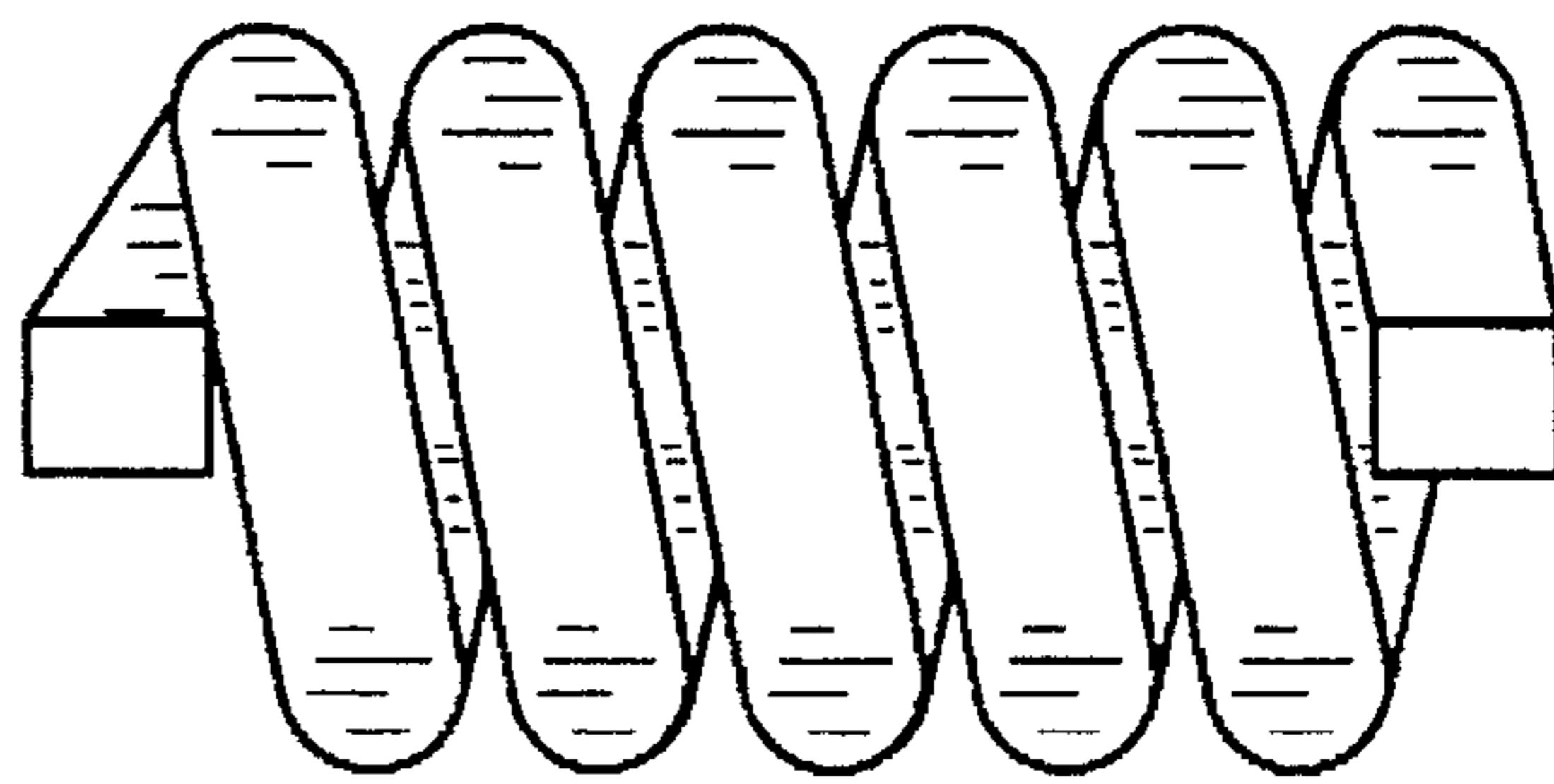




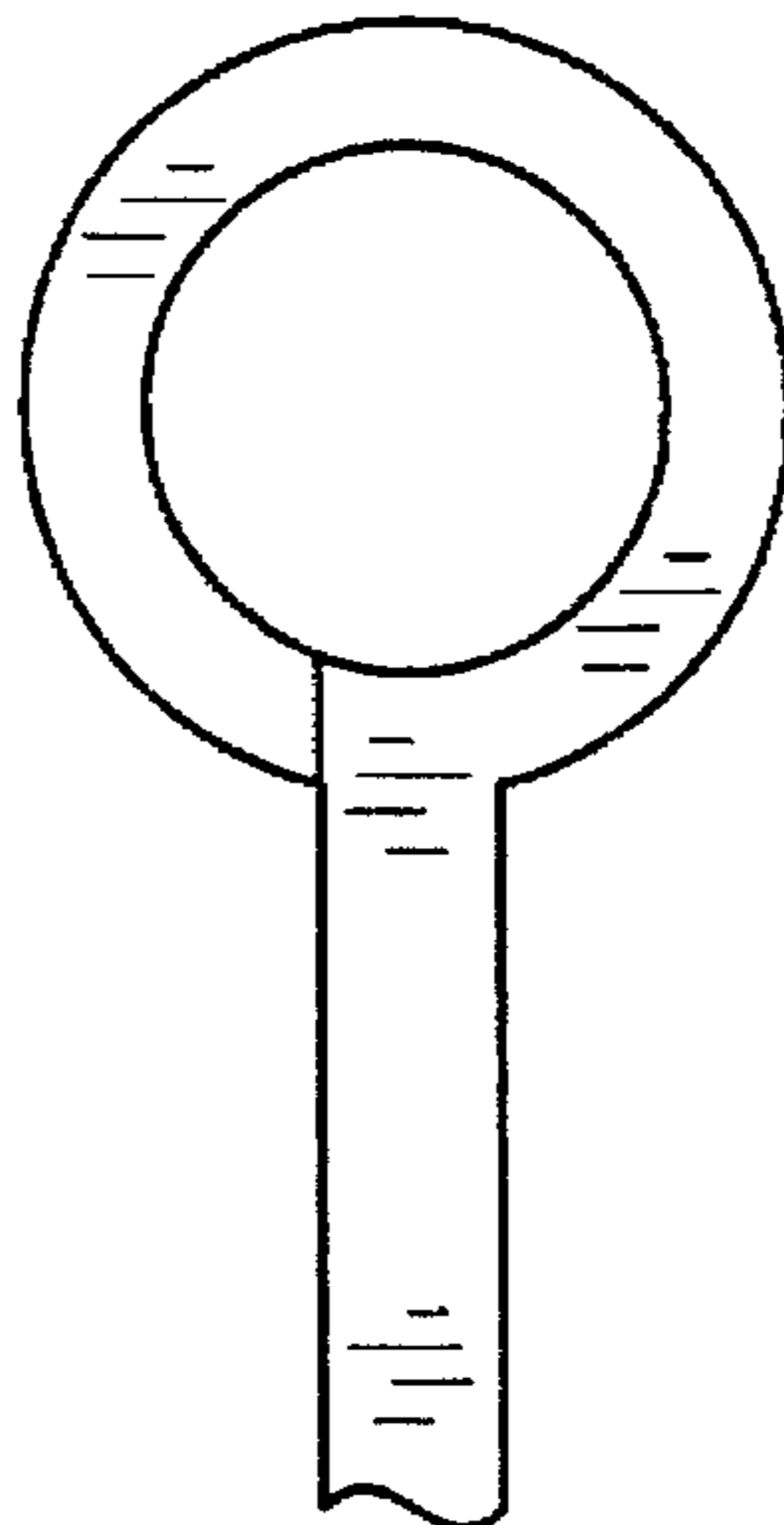


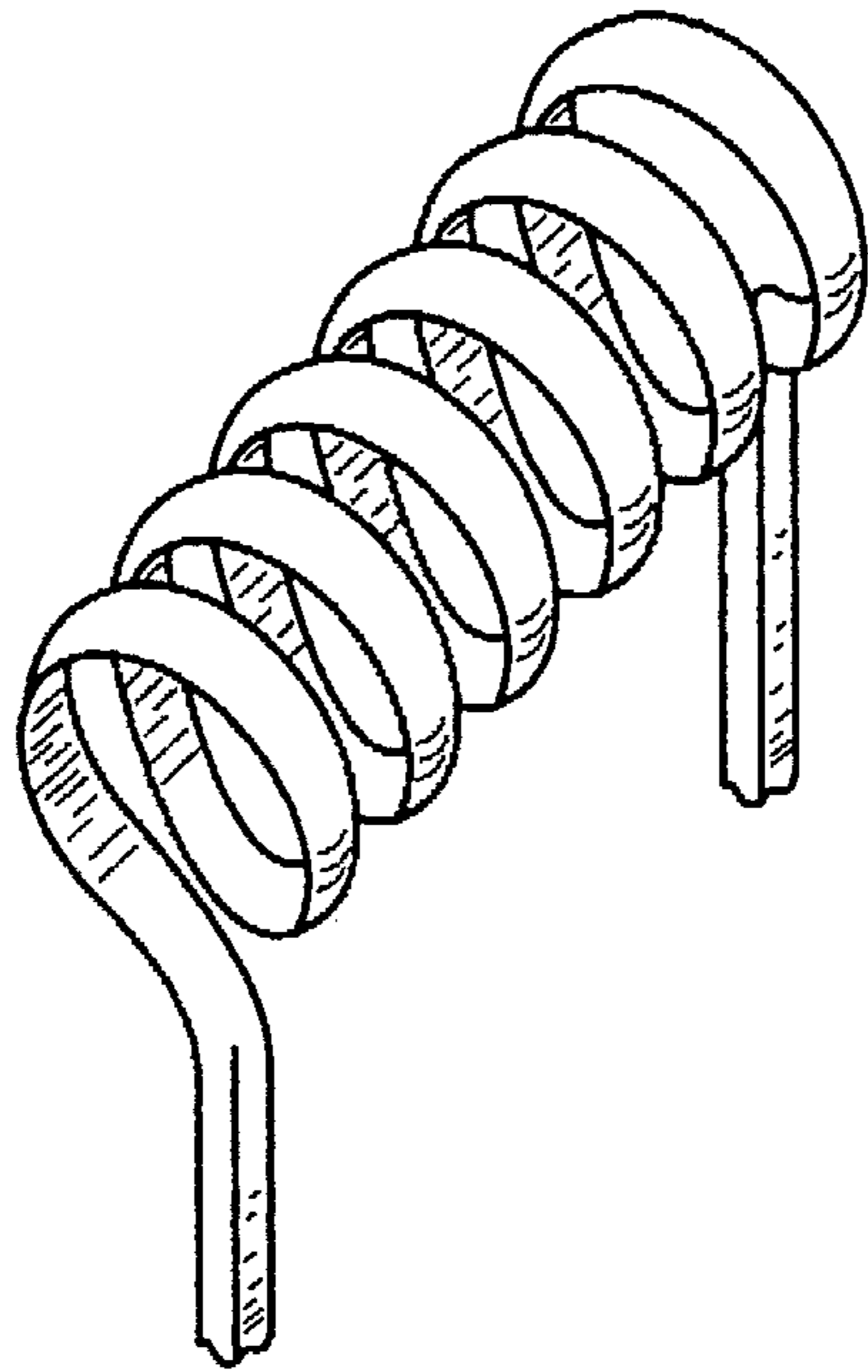

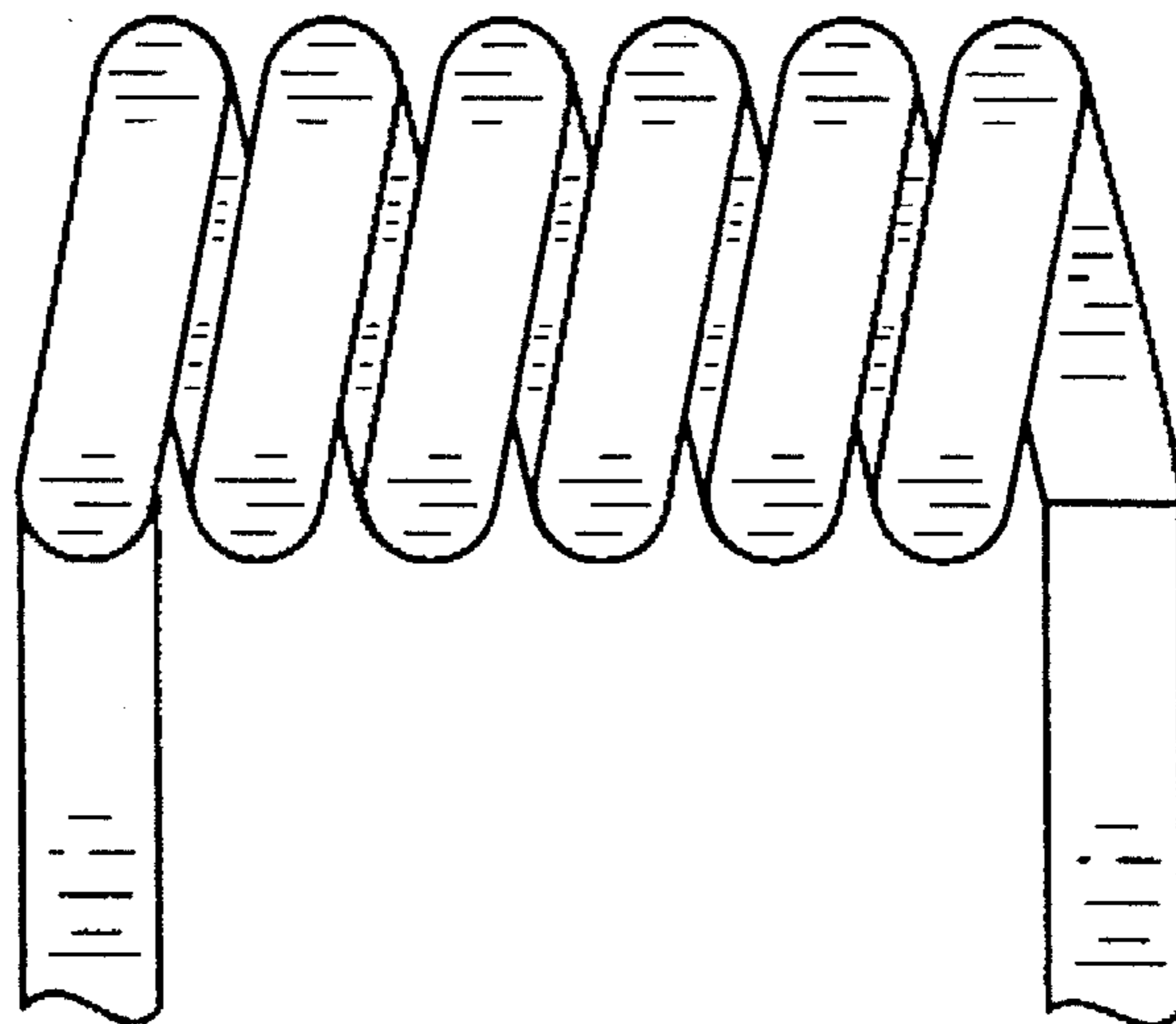

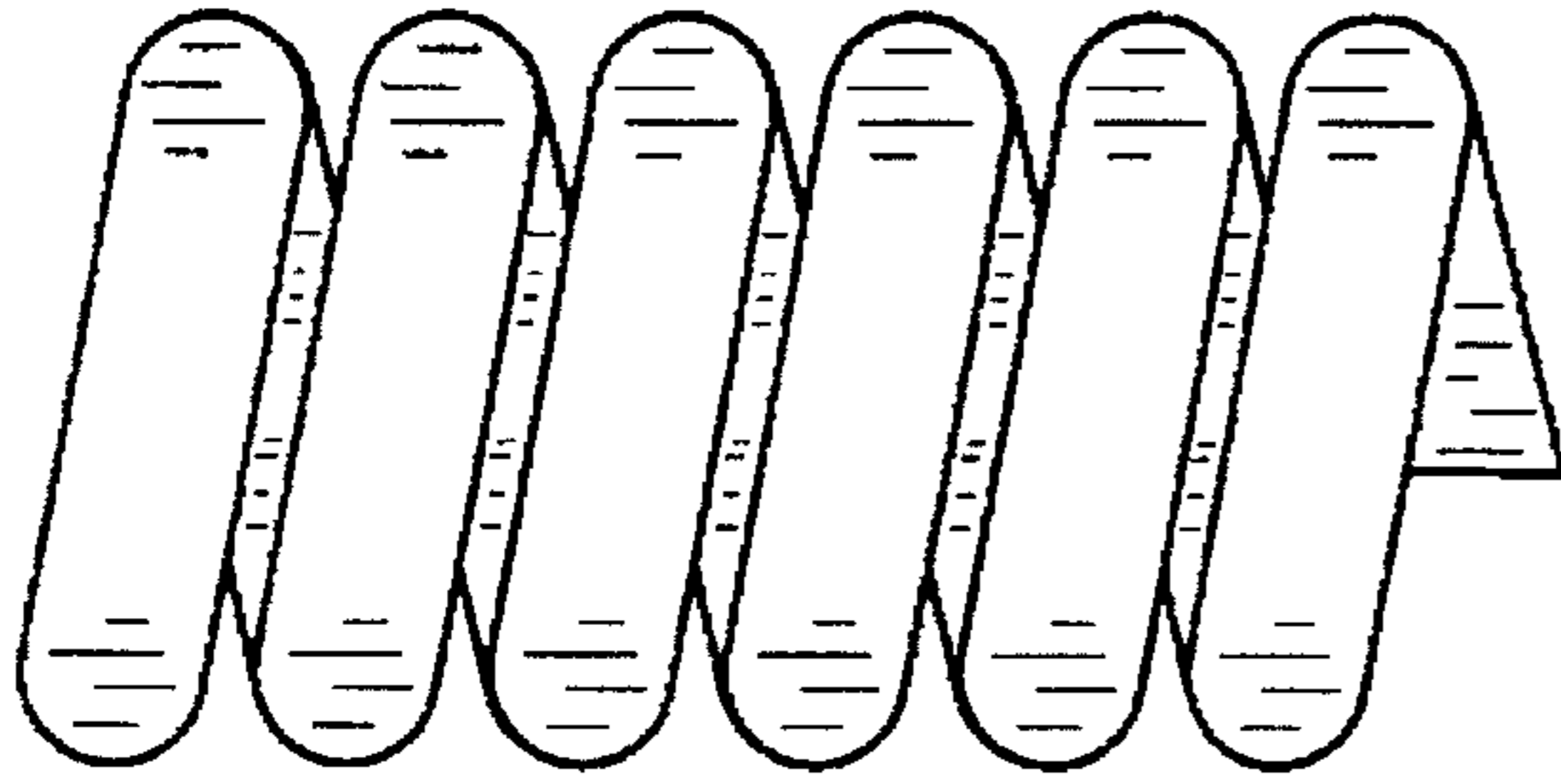

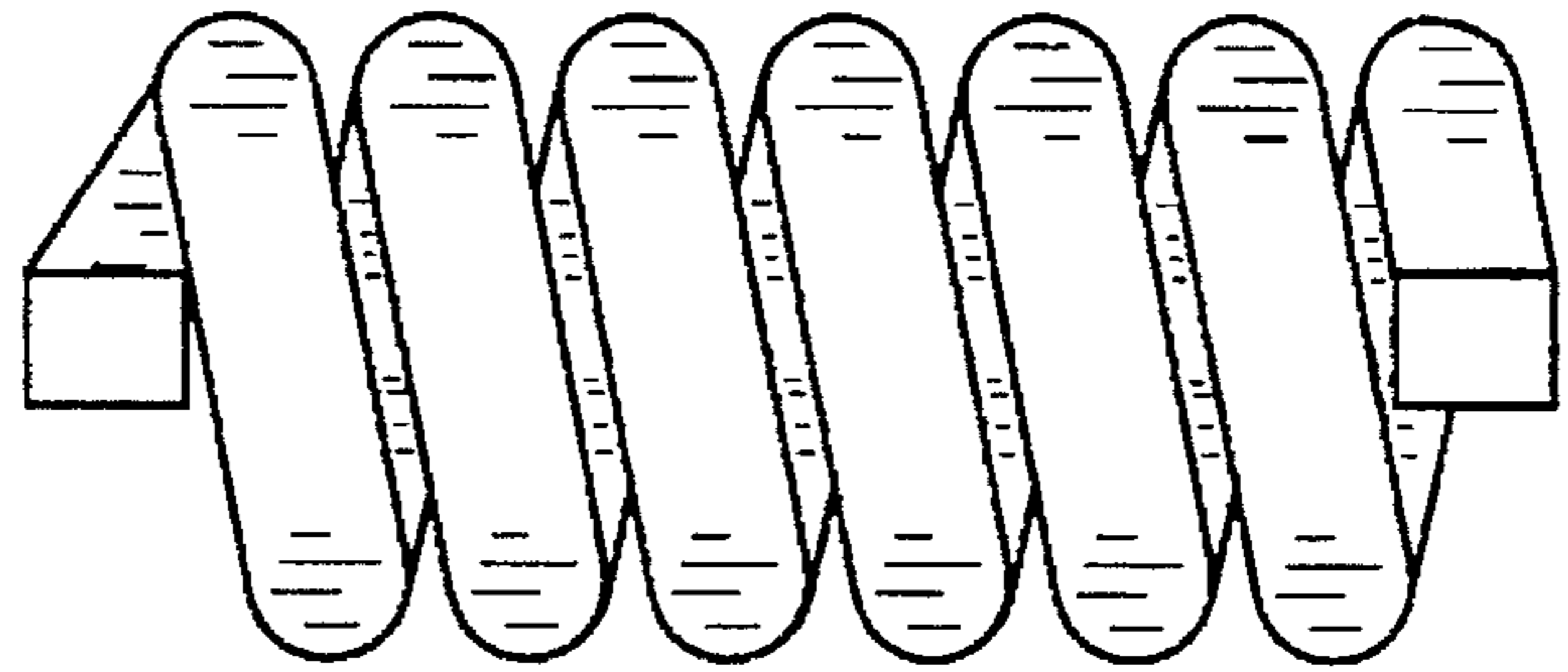
