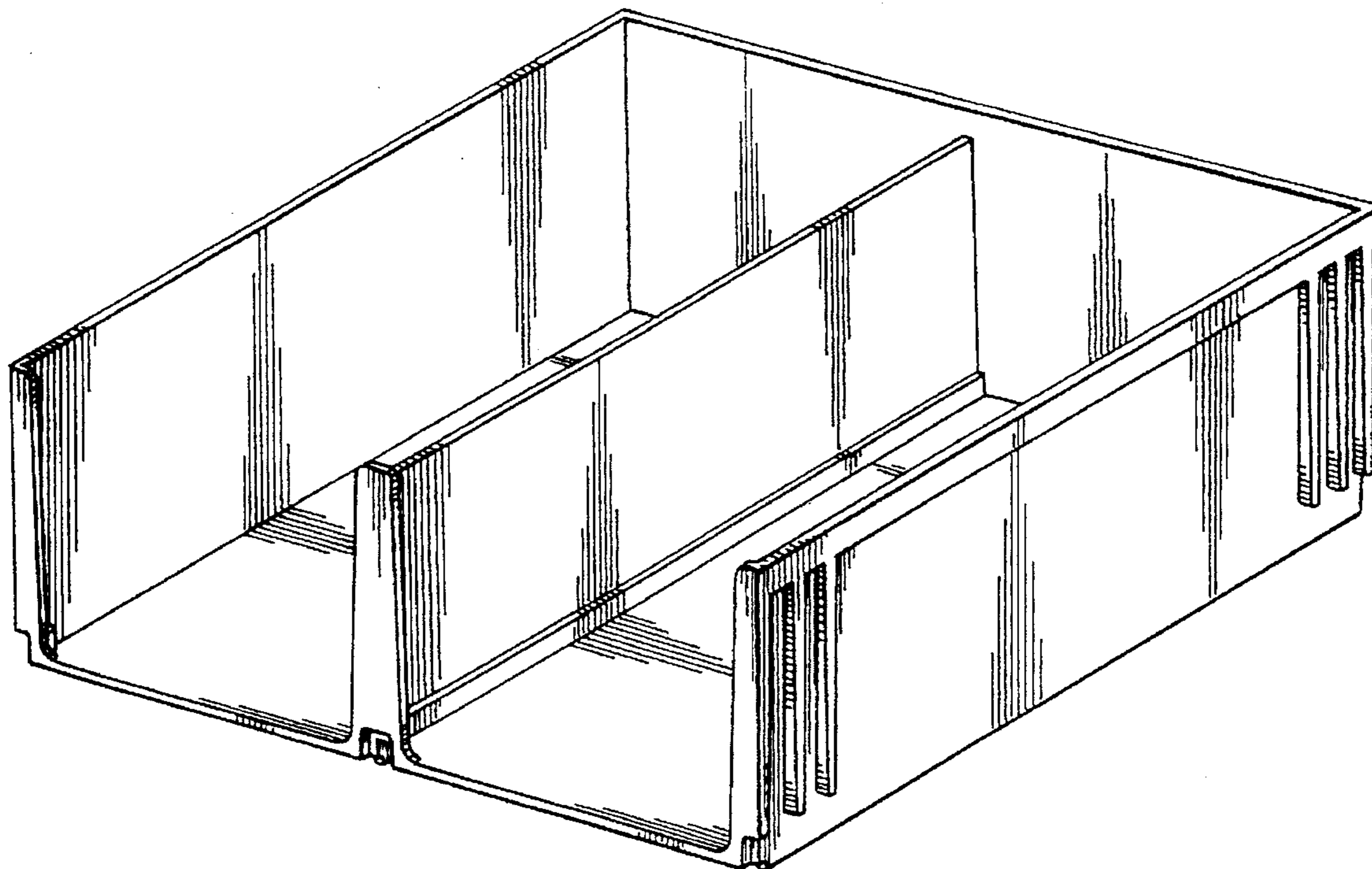
[57] **CLAIM**

The ornamental design for a stackable bin, as shown and described.

DESCRIPTION

FIG. 1 is a front, top right-side perspective view of a stackable bin showing my new design; FIG. 2 is an enlarged front elevational view of the stackable bin; FIG. 3 is a right-side elevational view thereof, the left-side being a mirror image thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

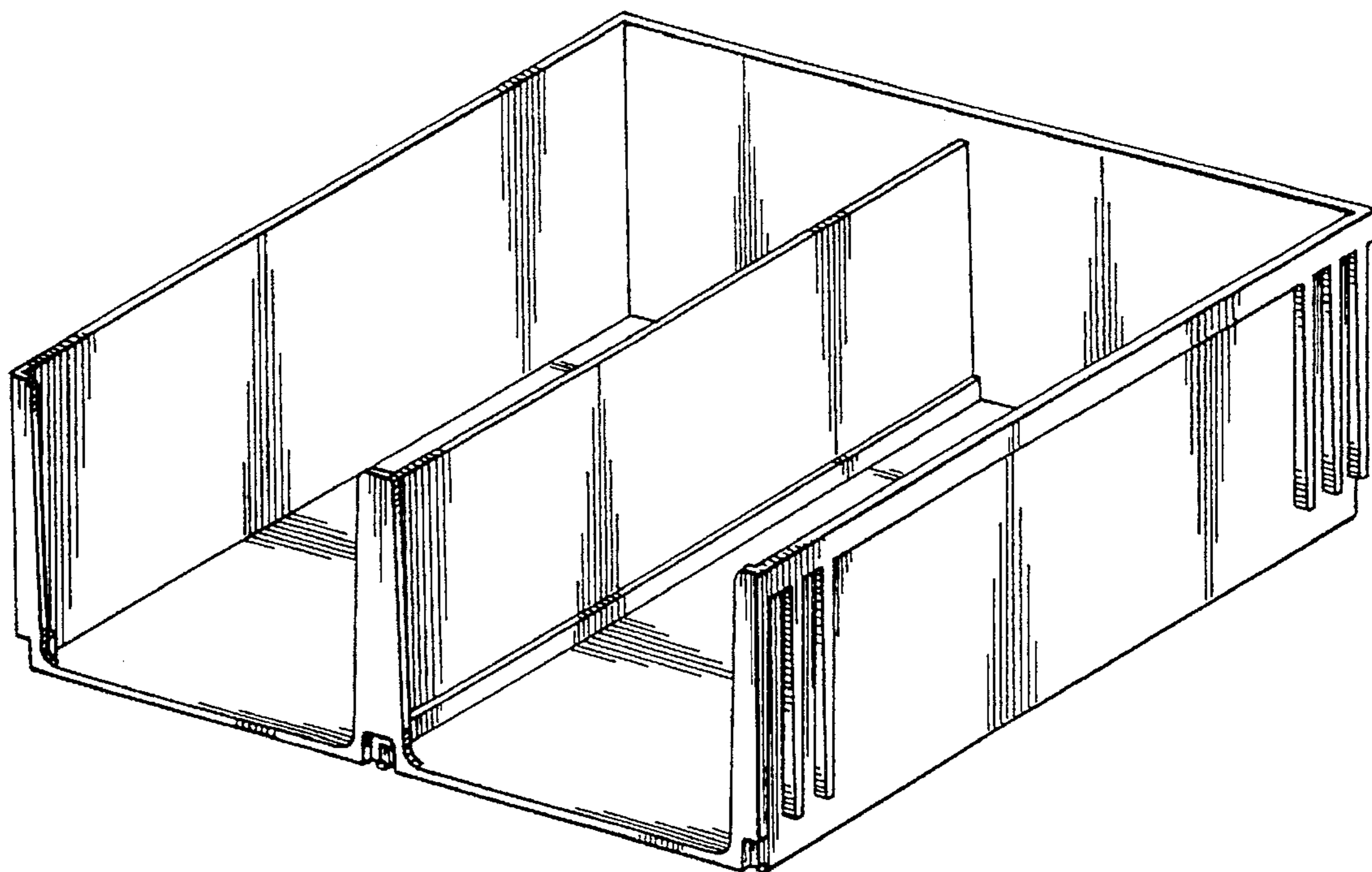

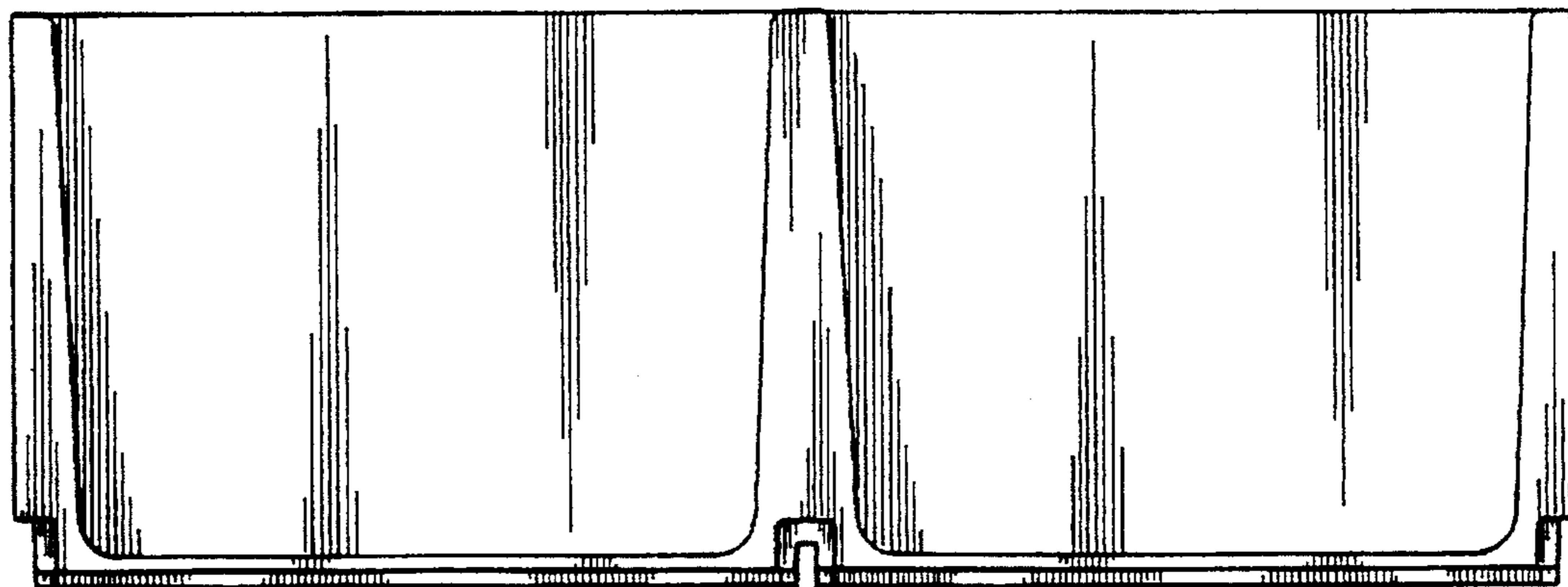

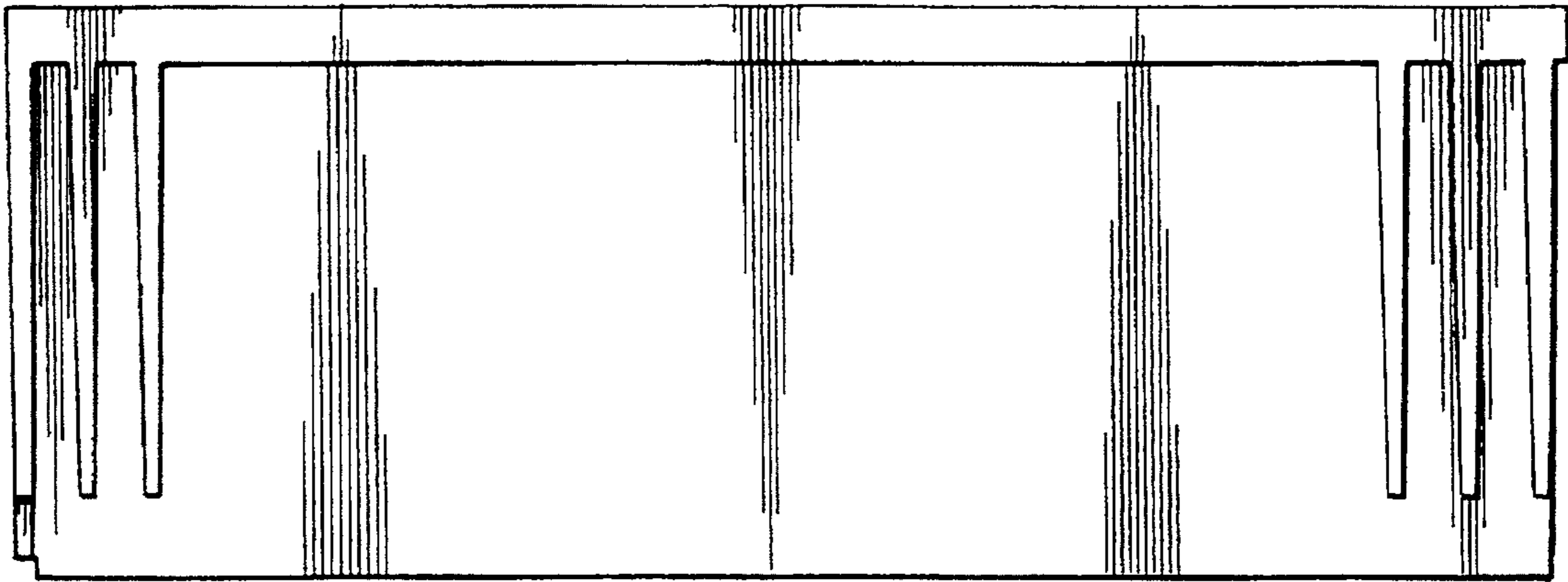

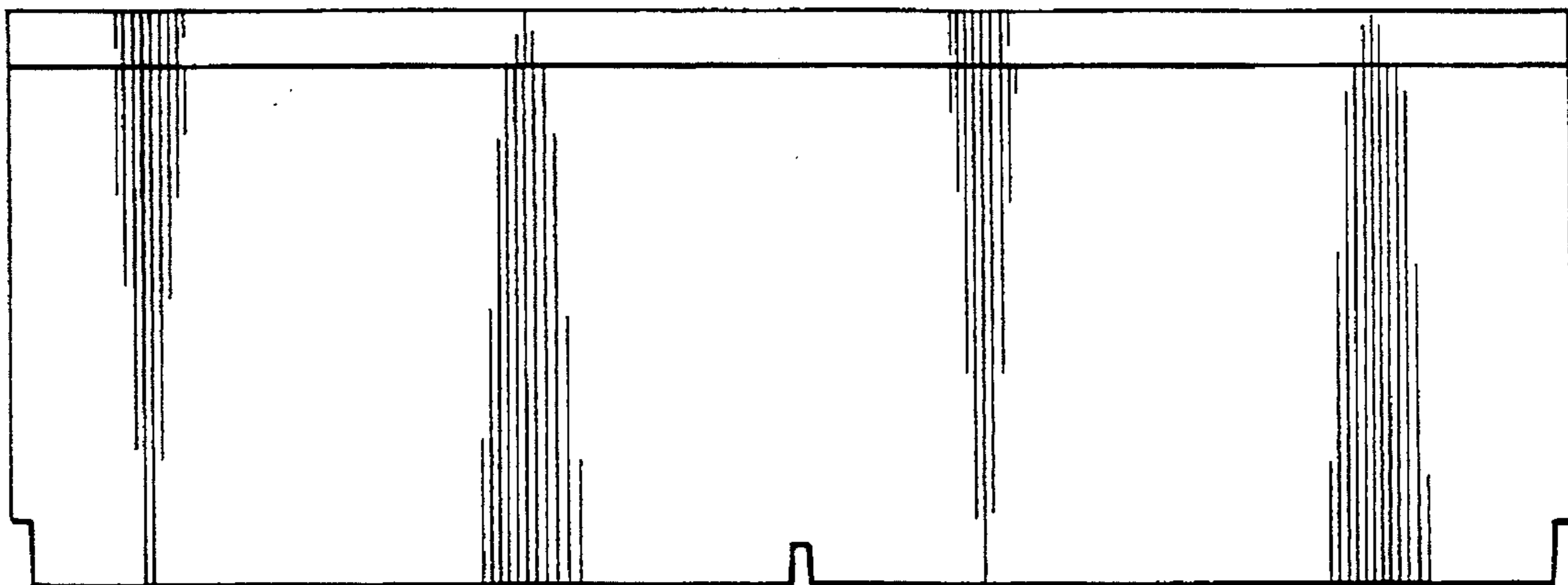

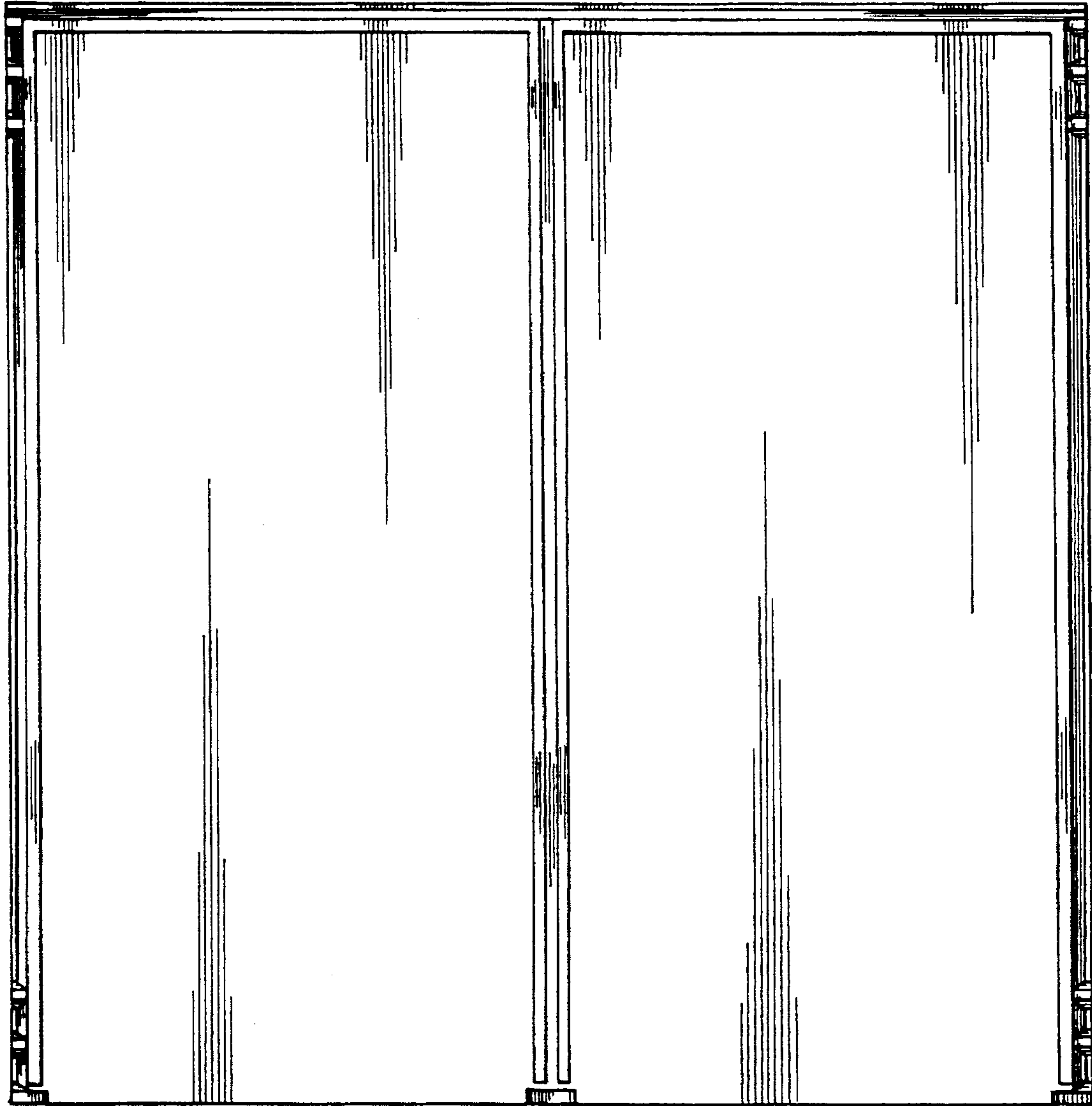
