and described.

DESCRIPTION

FIG. 1 is a top elevational view of body shaped pillow
showing our new design. The bottom elevational view of
FIG. 1 is a mirror image of FIG. 1;
FIG. 2 is a rear elevational view of FIG. 1;
FIG. 3 is a front elevational view of FIG. 1;
FIG. 4 is a right side elevational view of FIG. 1;
FIG. 5 is a left side elevational view of FIG. 1; and,
FIG. 6 is a sectional view taken along line 6—6 of FIG. 1.

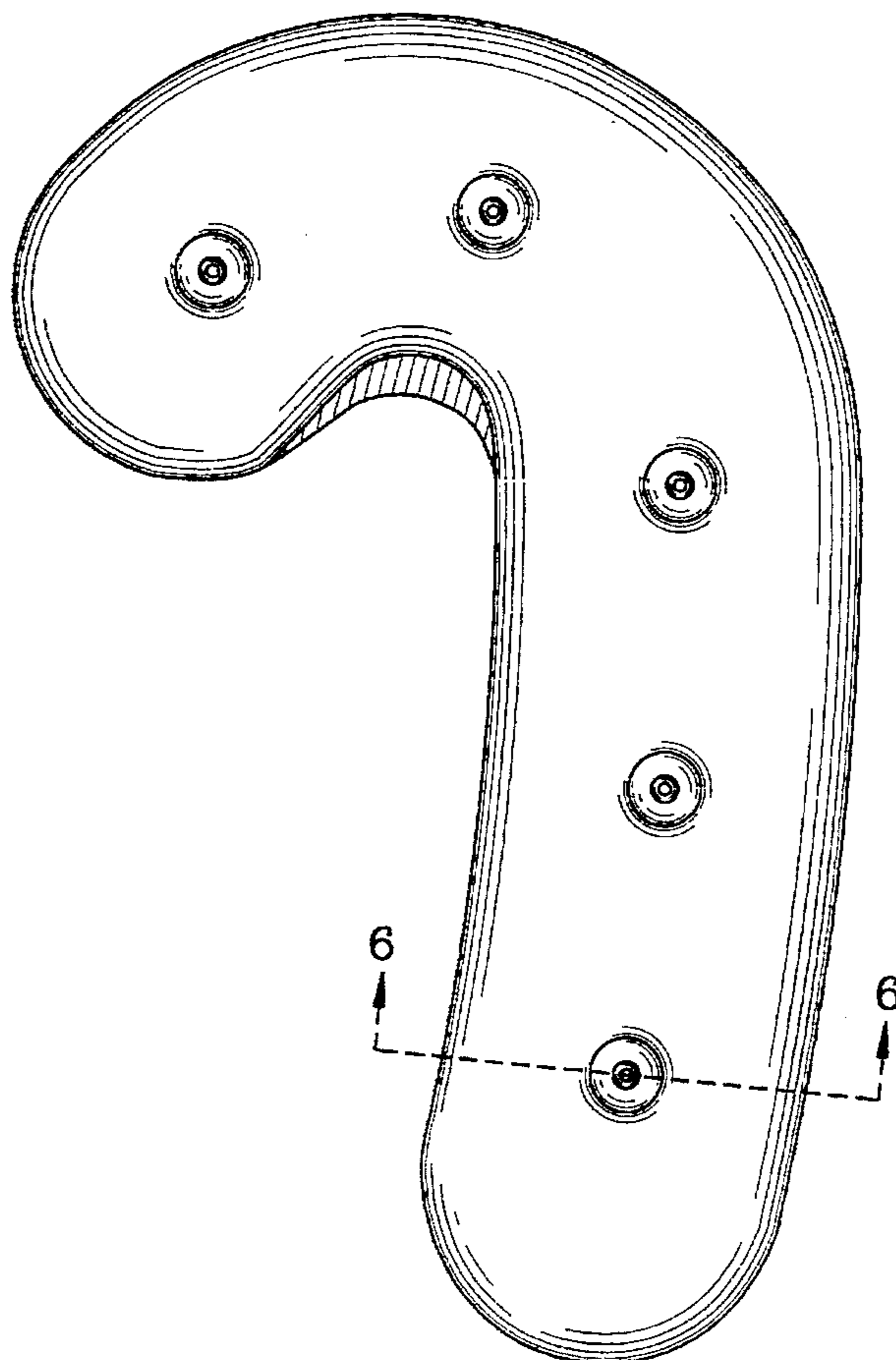

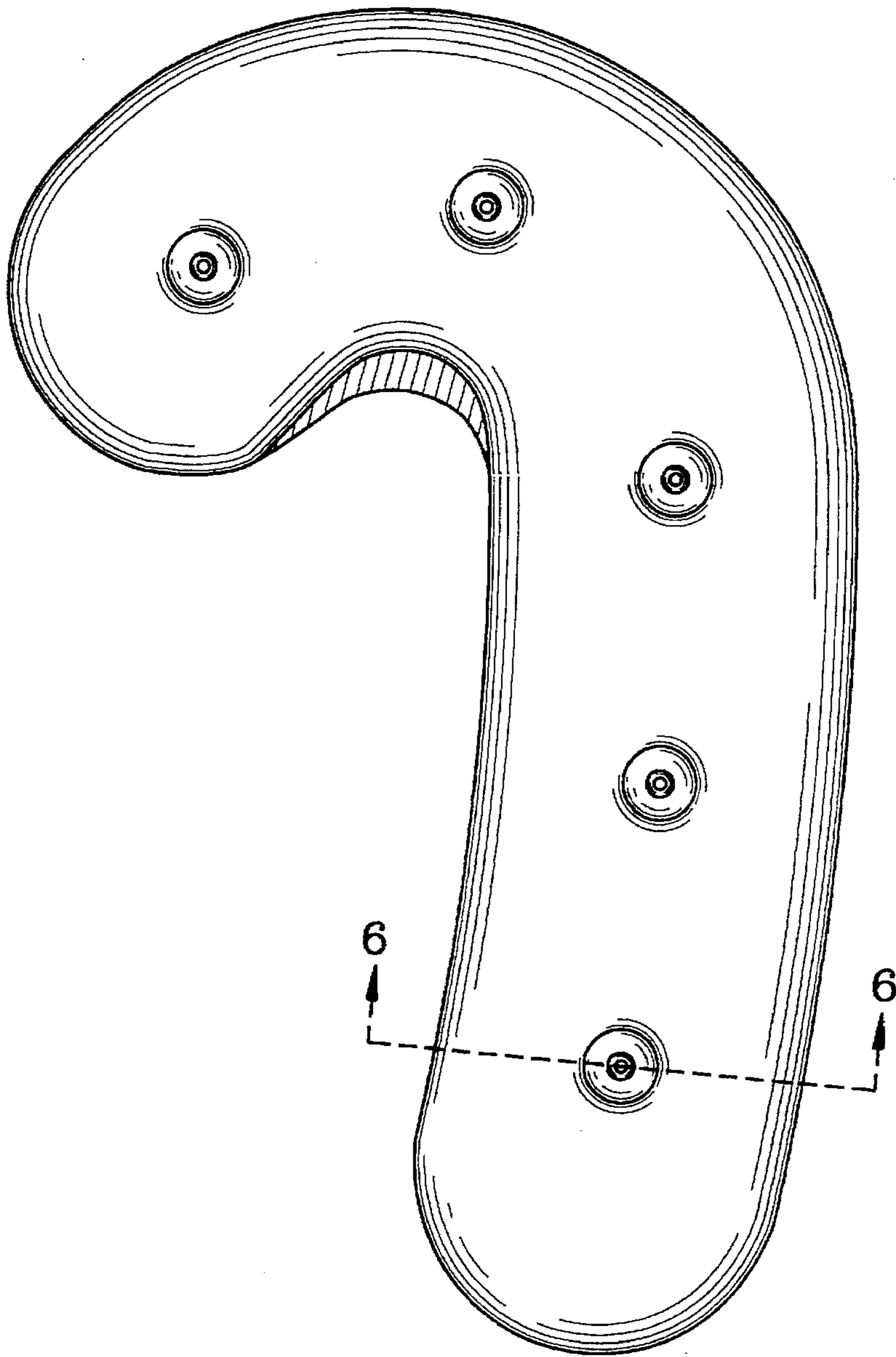

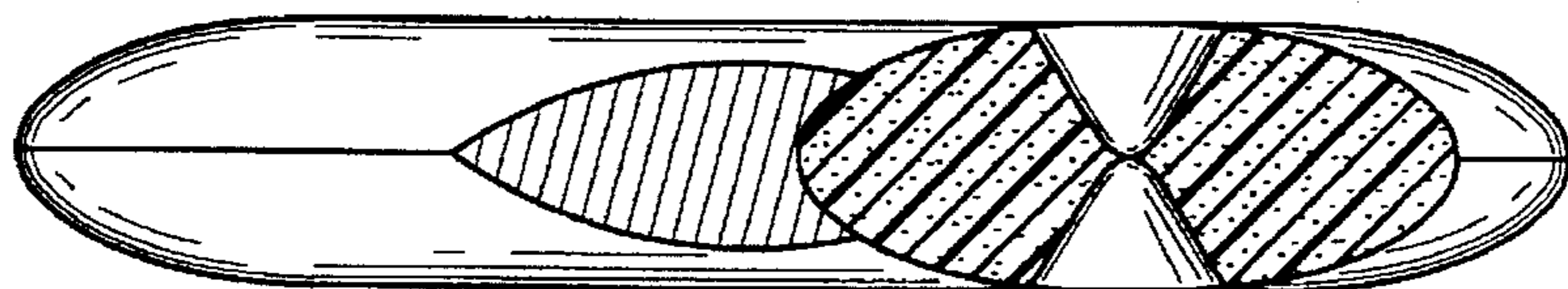

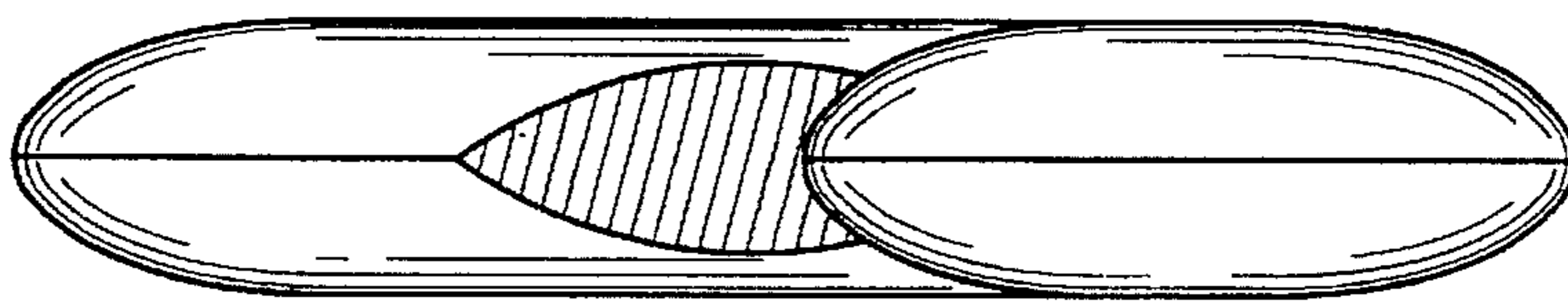

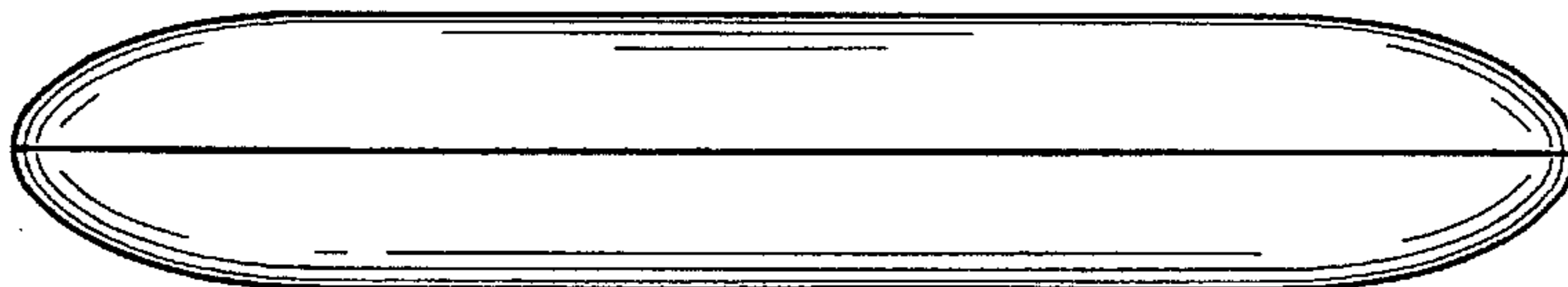

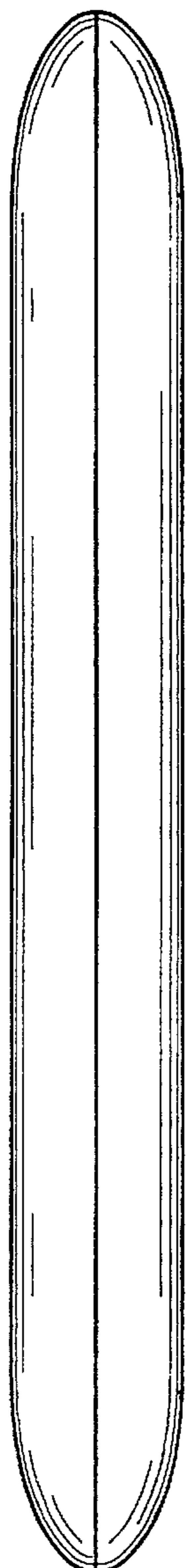
