The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container showing my new design;

FIG. 2 is a front elevational view of the container shown on an enlarged scale, the rear elevational view is the same;

FIG. 3 is a side elevational view of the container on the larger scale, the opposite side elevational view is the same;

FIG. 4 is a top plan view of the container on the larger scale; and,

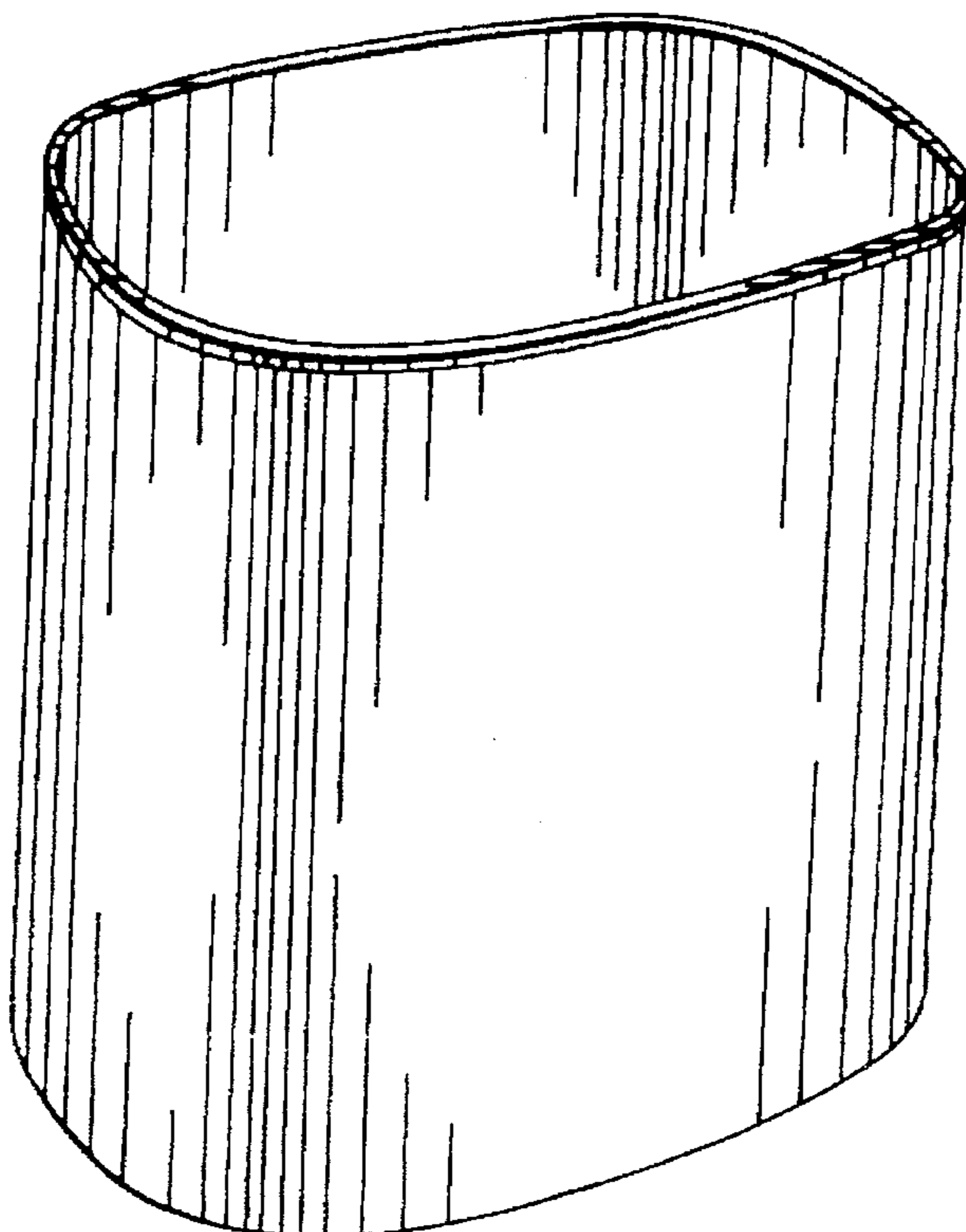
FIG. 5 is a bottom plan view of the container on the larger scale.

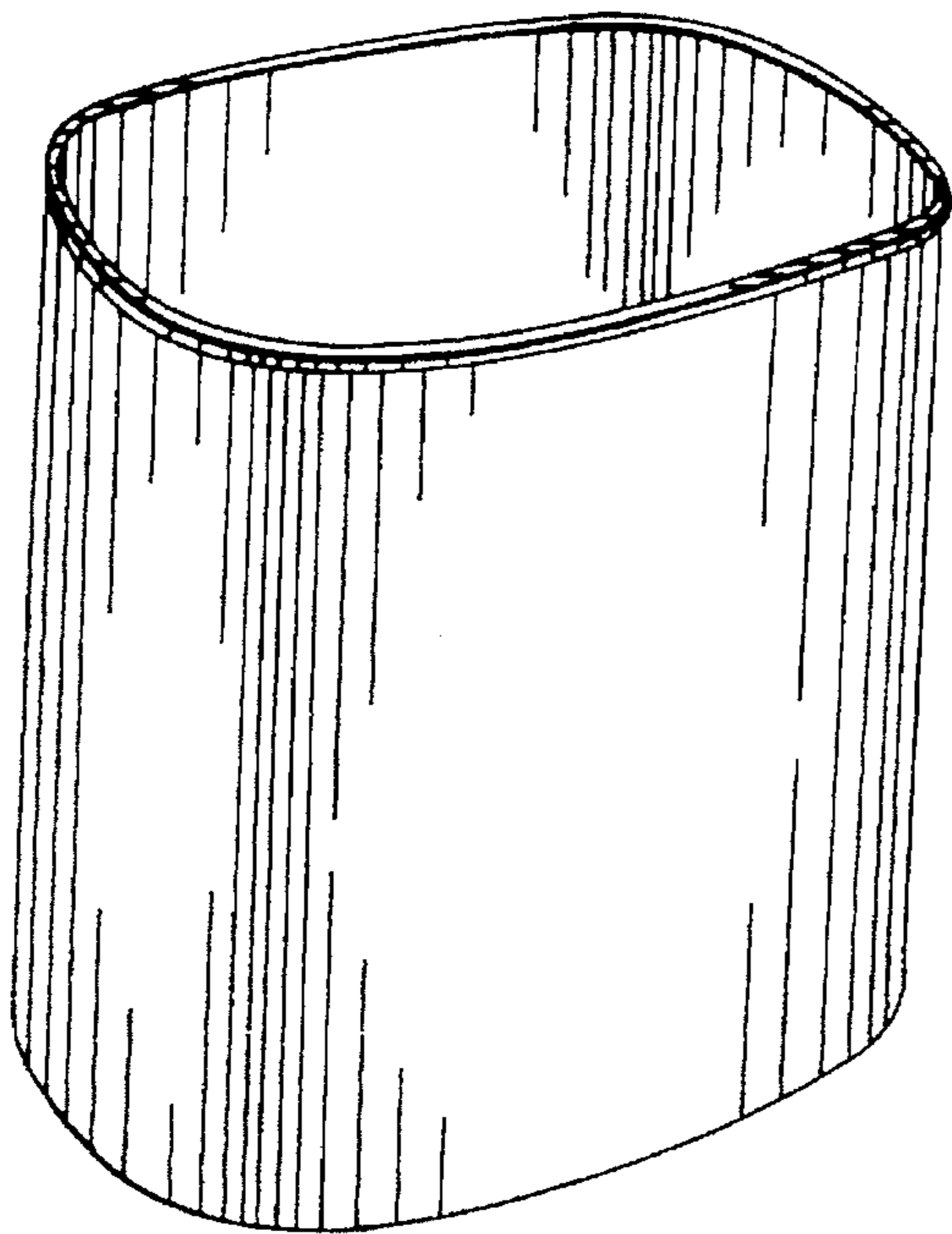

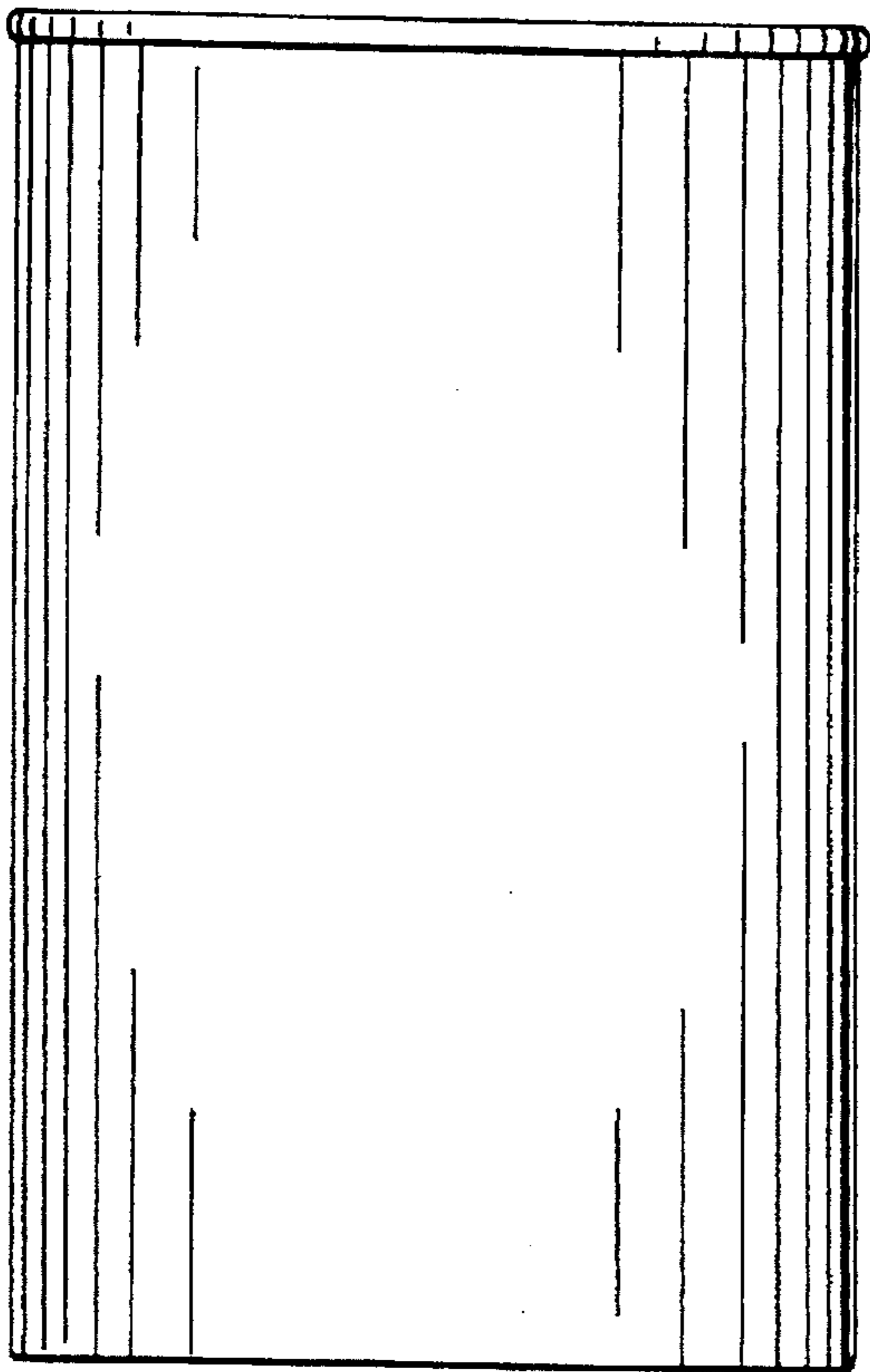

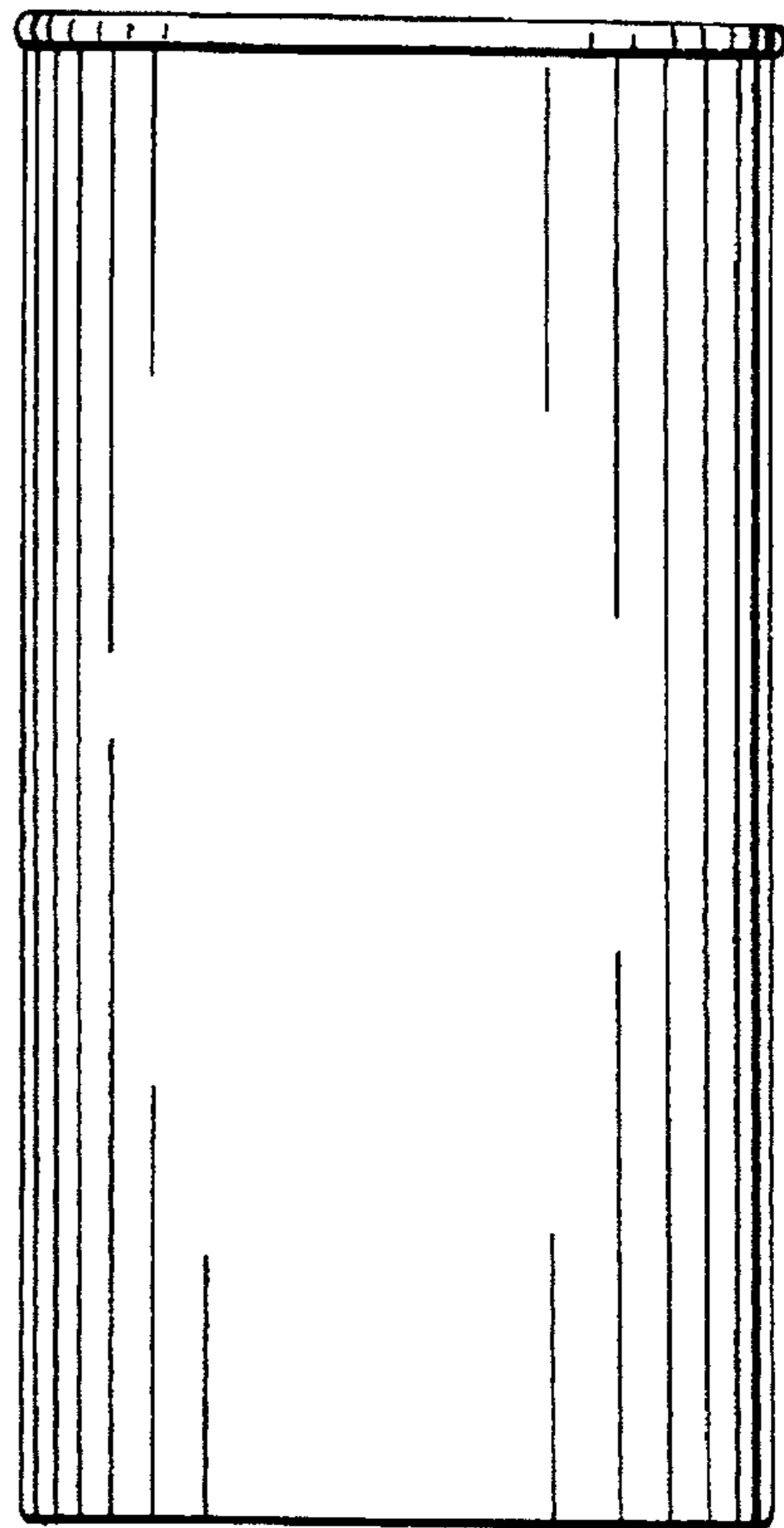

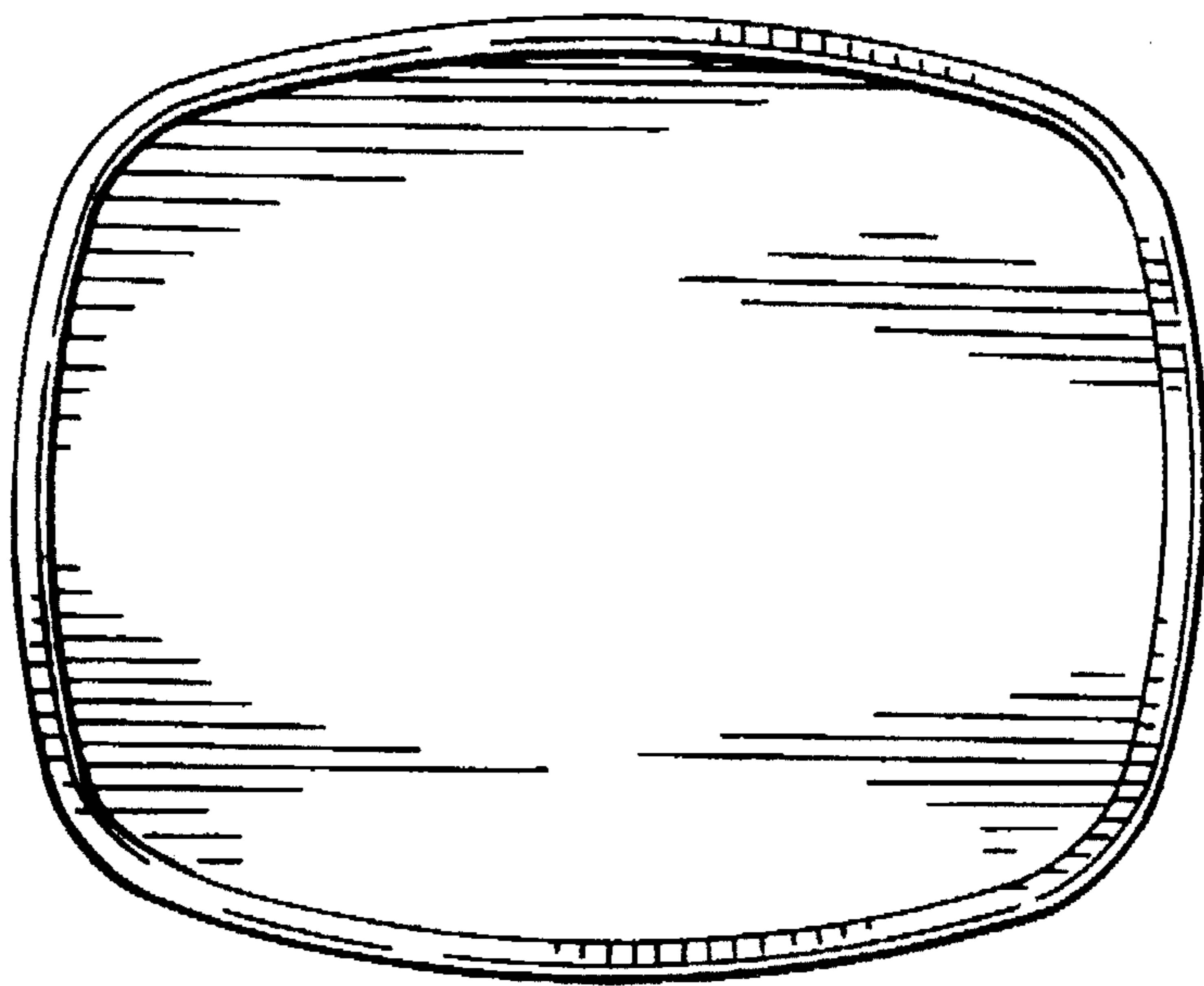

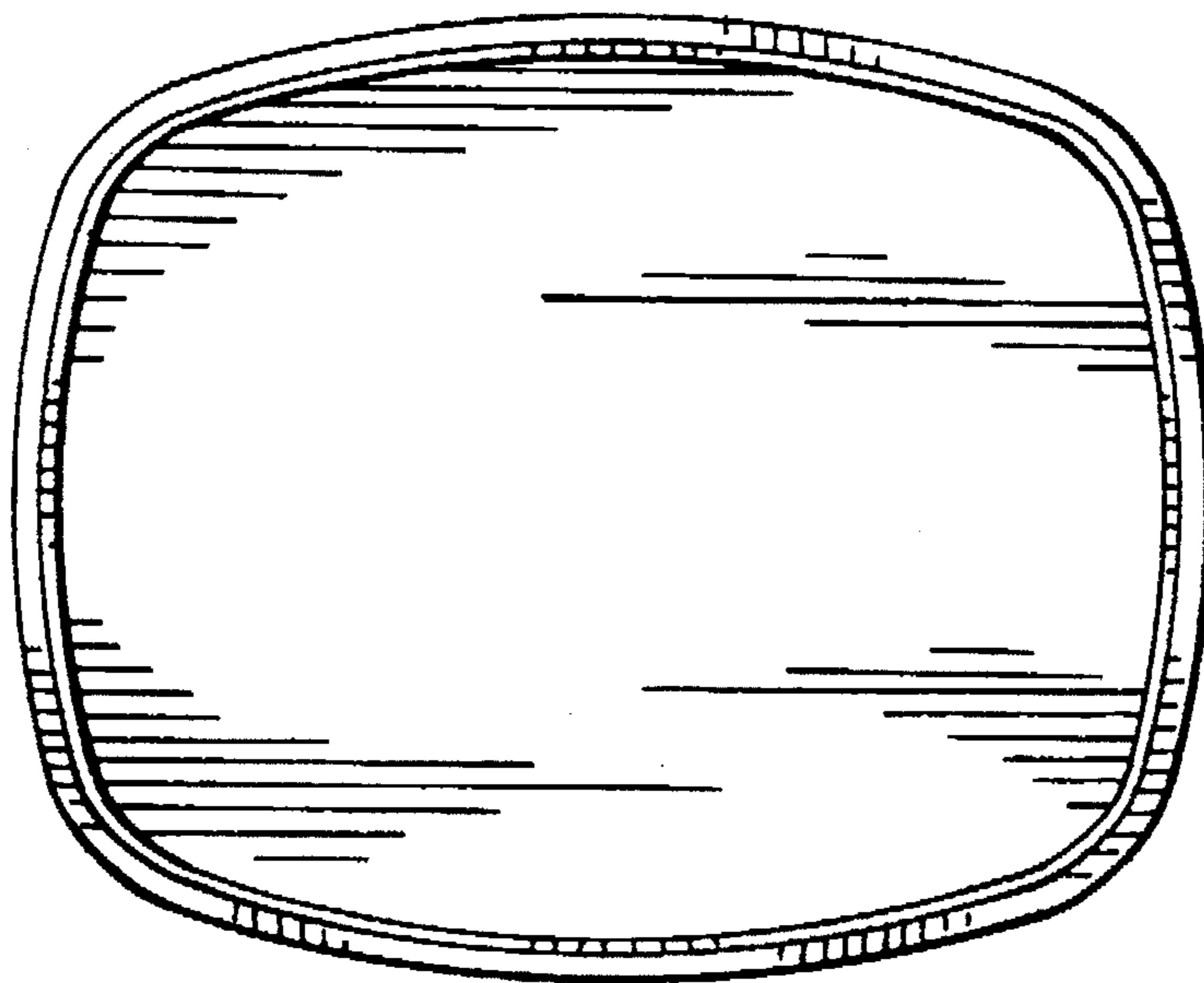
