The new ornamental design for a letter opener, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a letter opener showing my new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a right side elevational view thereof; and,
 FIG. 5 is a left side elevational view thereof.
 The undisclosed bottom plan view opposite of FIG. 1 is a mirror image thereof.

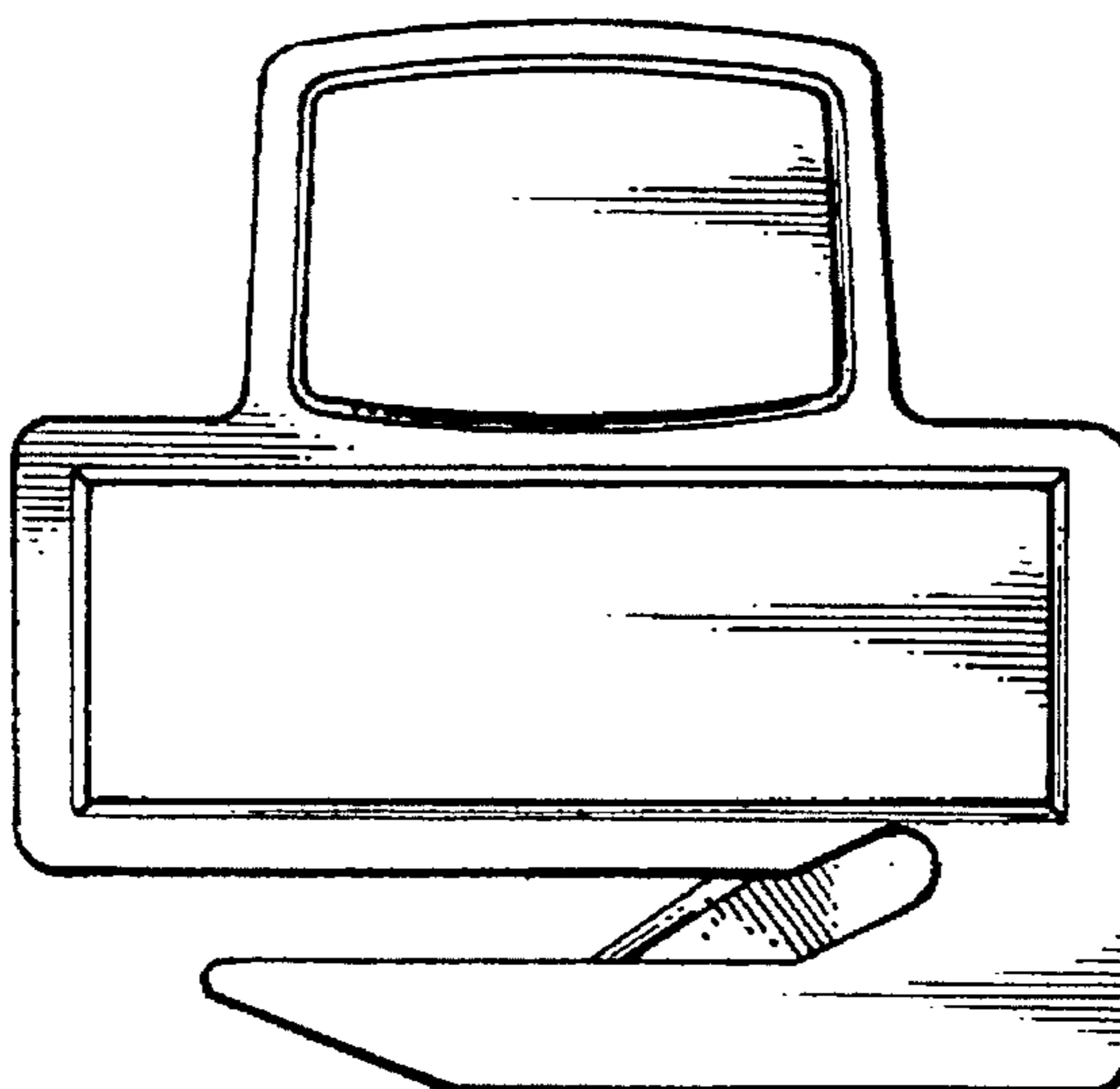

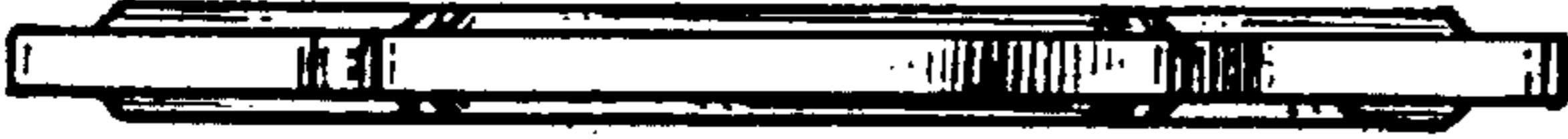

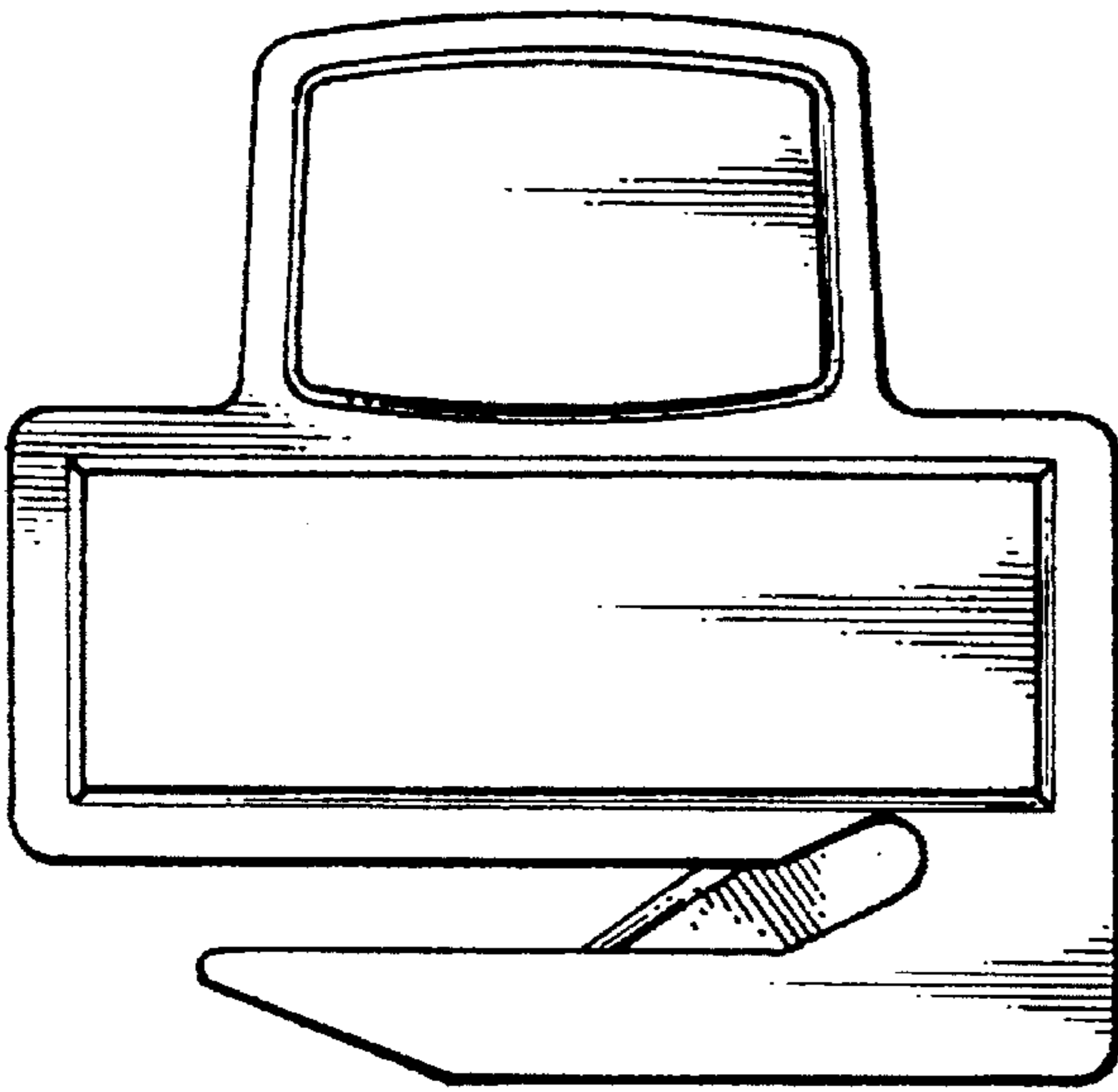
