The ornamental design for a corner planter, as shown and described.

### DESCRIPTION

FIG. 1 is a rear perspective view of a corner planter showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is an end elevation thereof, both ends appearing the same;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a front perspective view thereof.  
The broken line showing of the plant and portions of the walls is for illustrative purposes only and form no part of the claimed design.

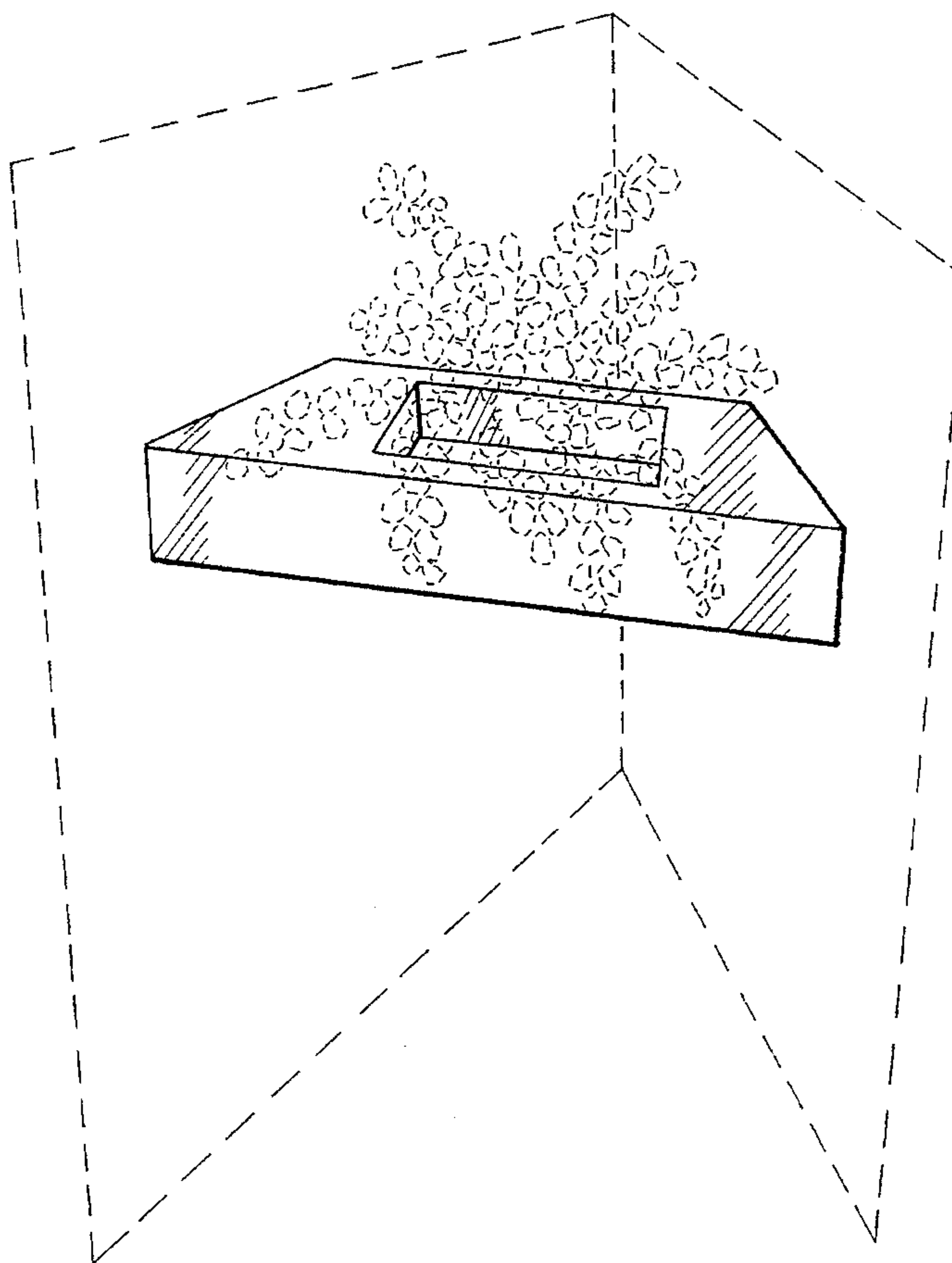

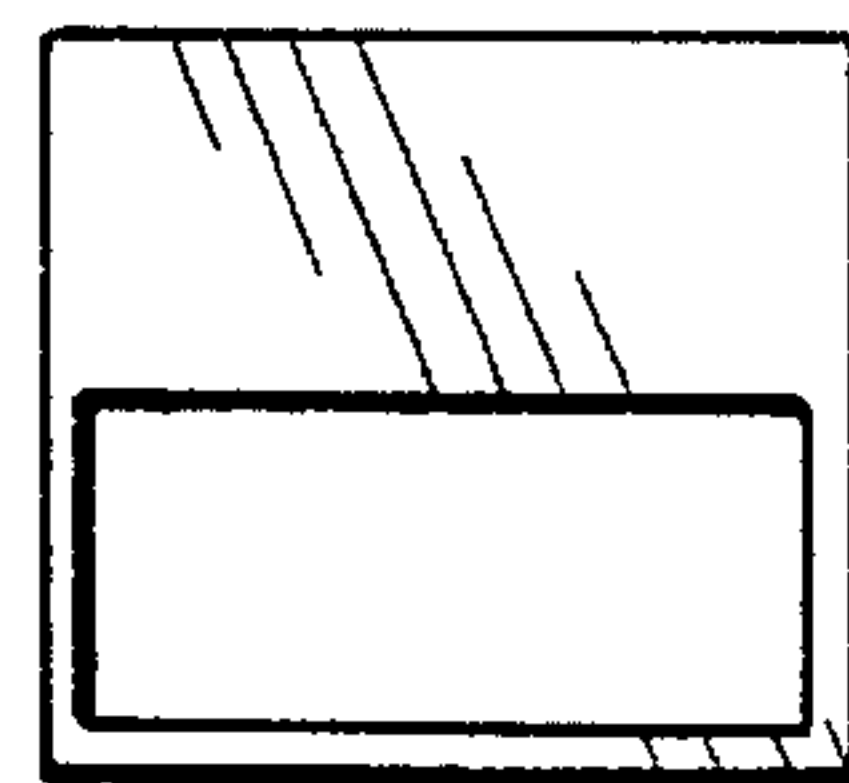
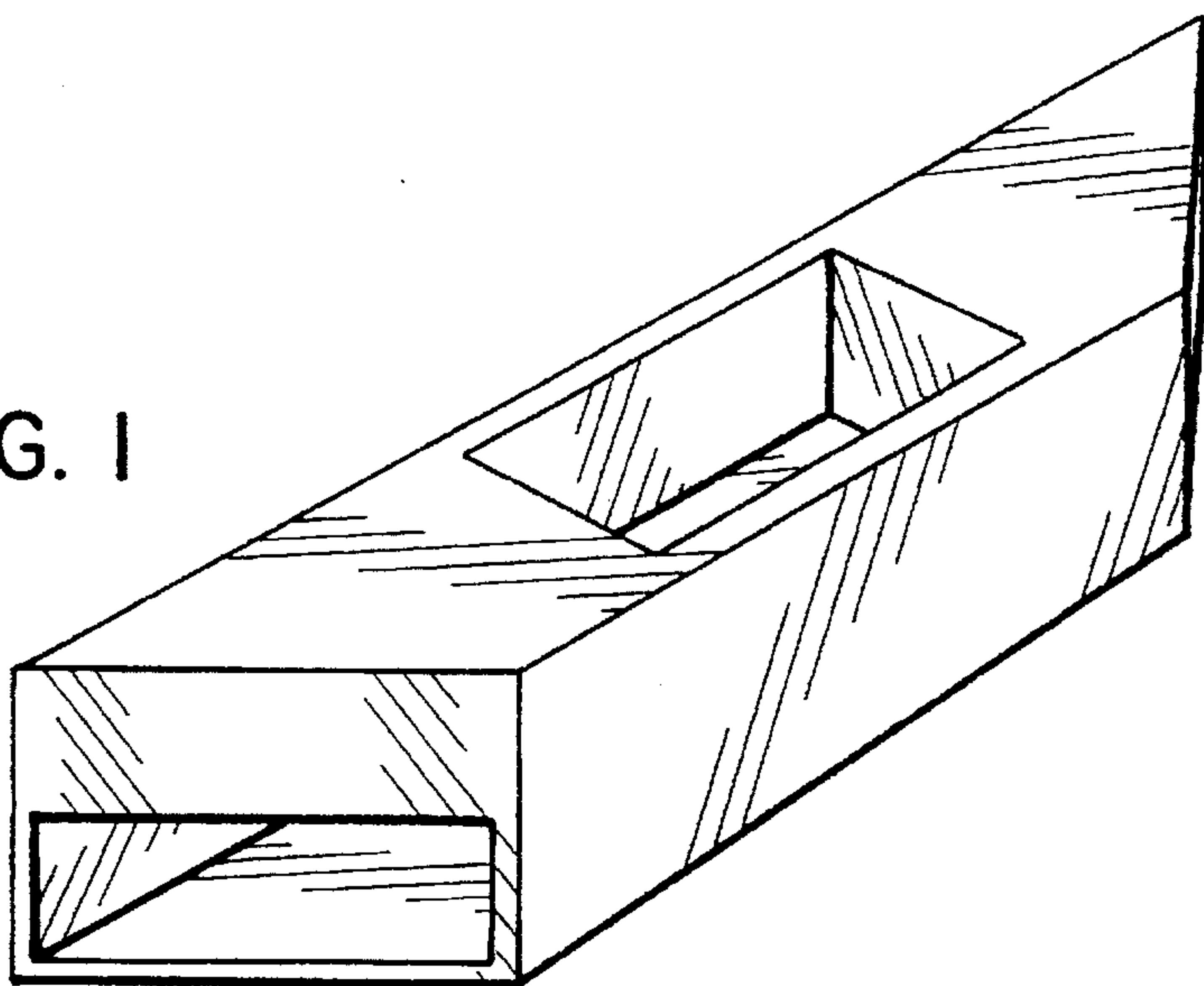

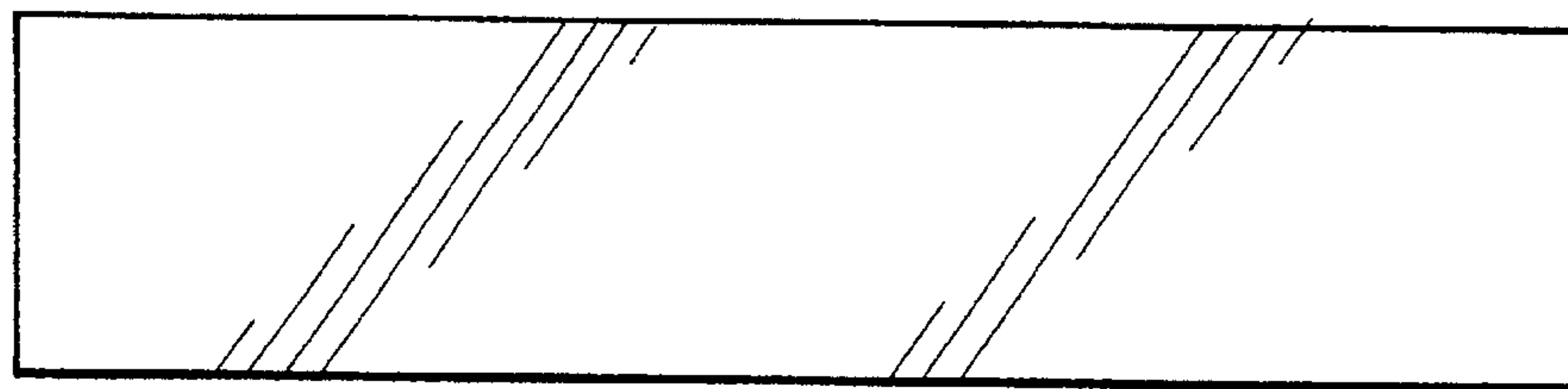

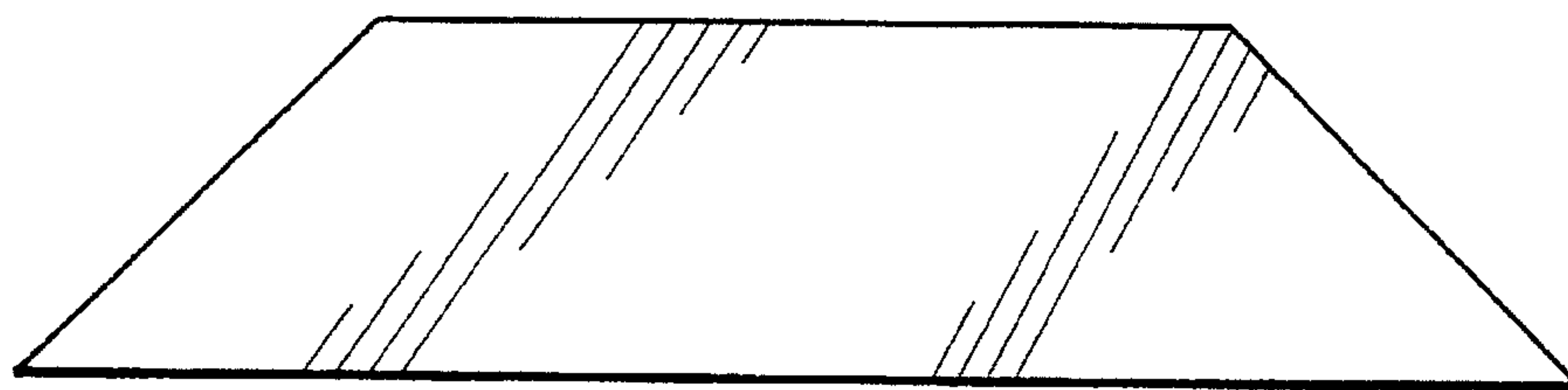

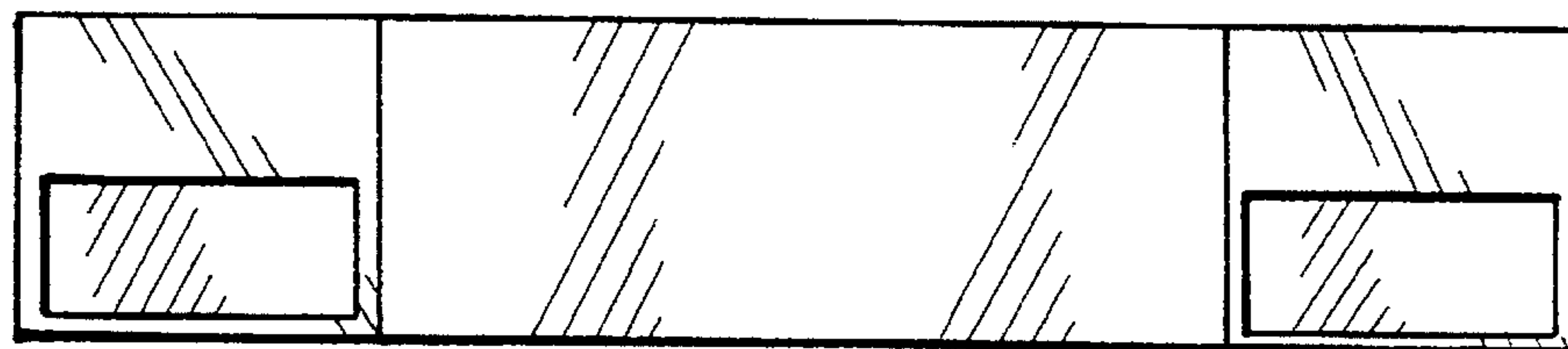

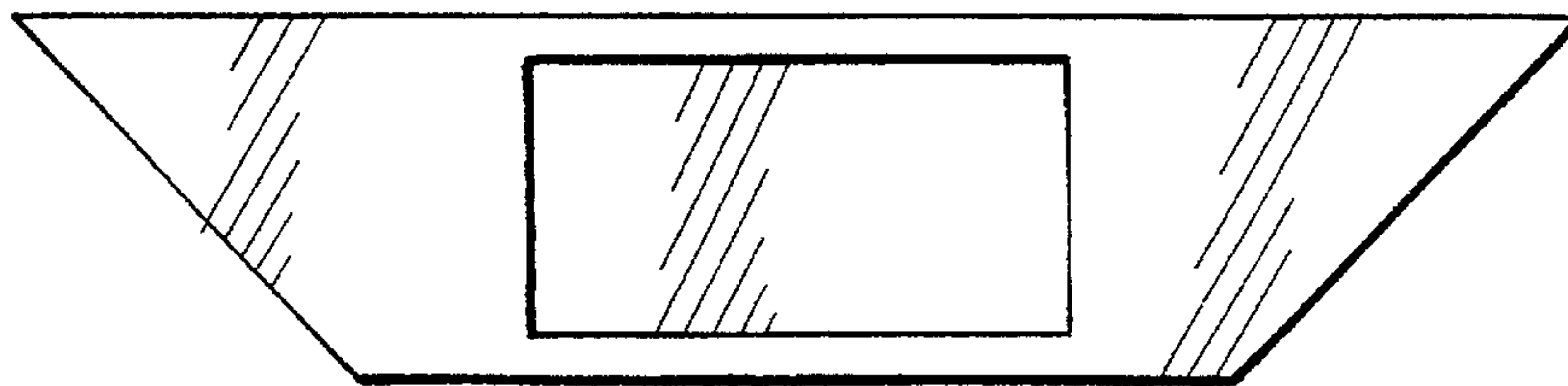

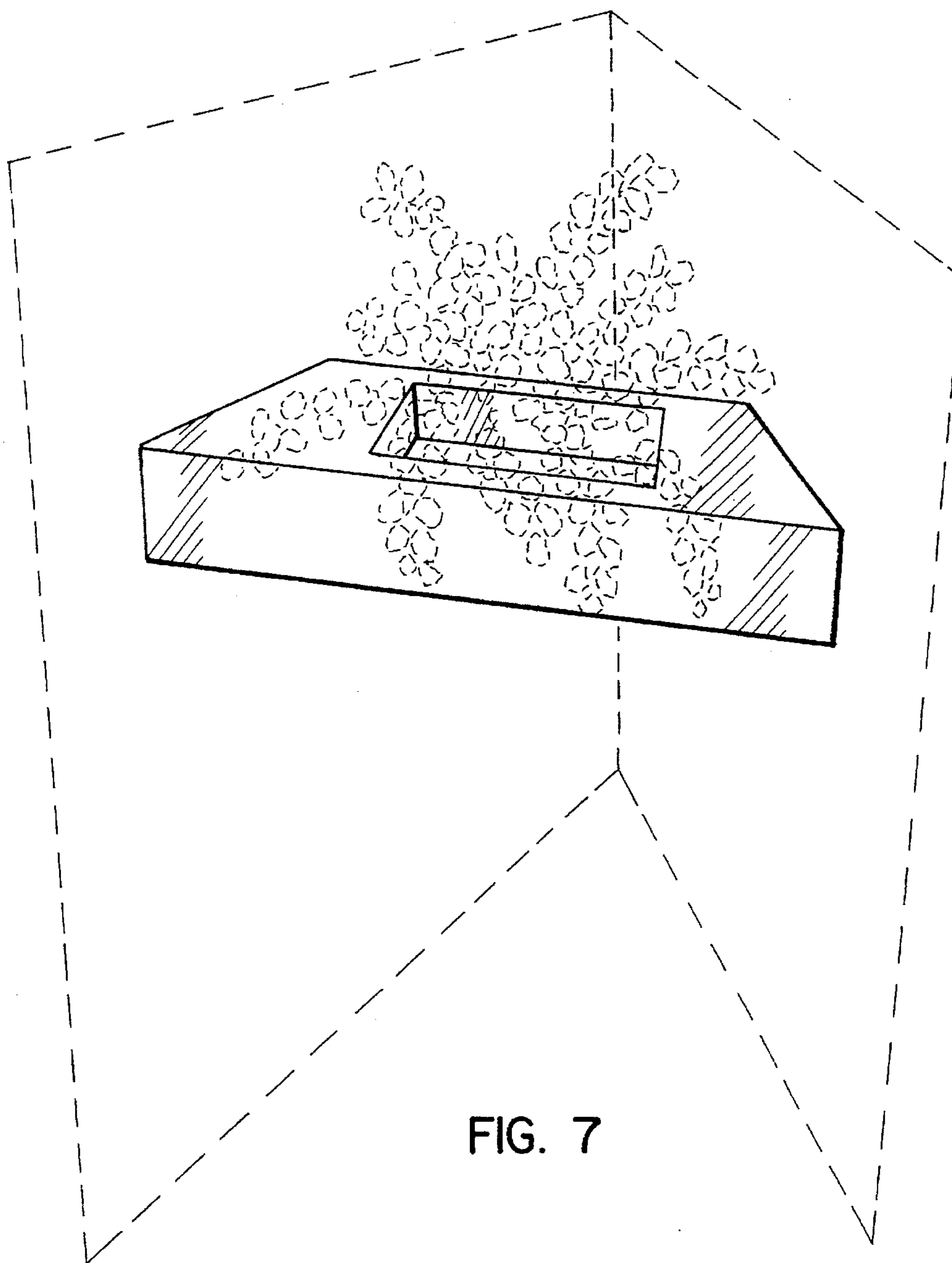
