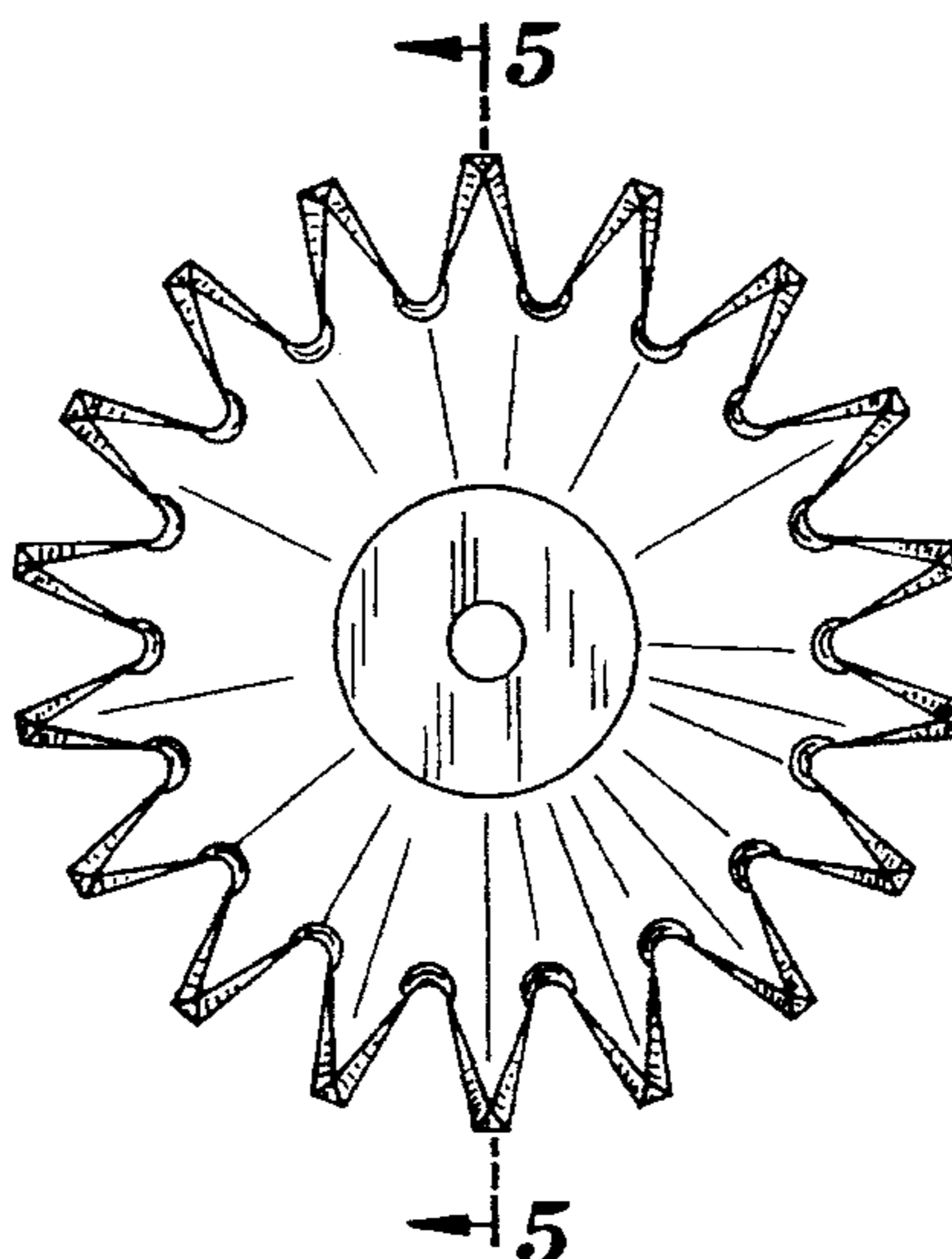

DESCRIPTION

FIG. 1 is a front elevational view of the finger press wheel of my new design;
 FIG. 2 is a bottom plan view thereof, the top plan view is a mirror image thereof;
 FIG. 3 is a rear elevational view thereof;

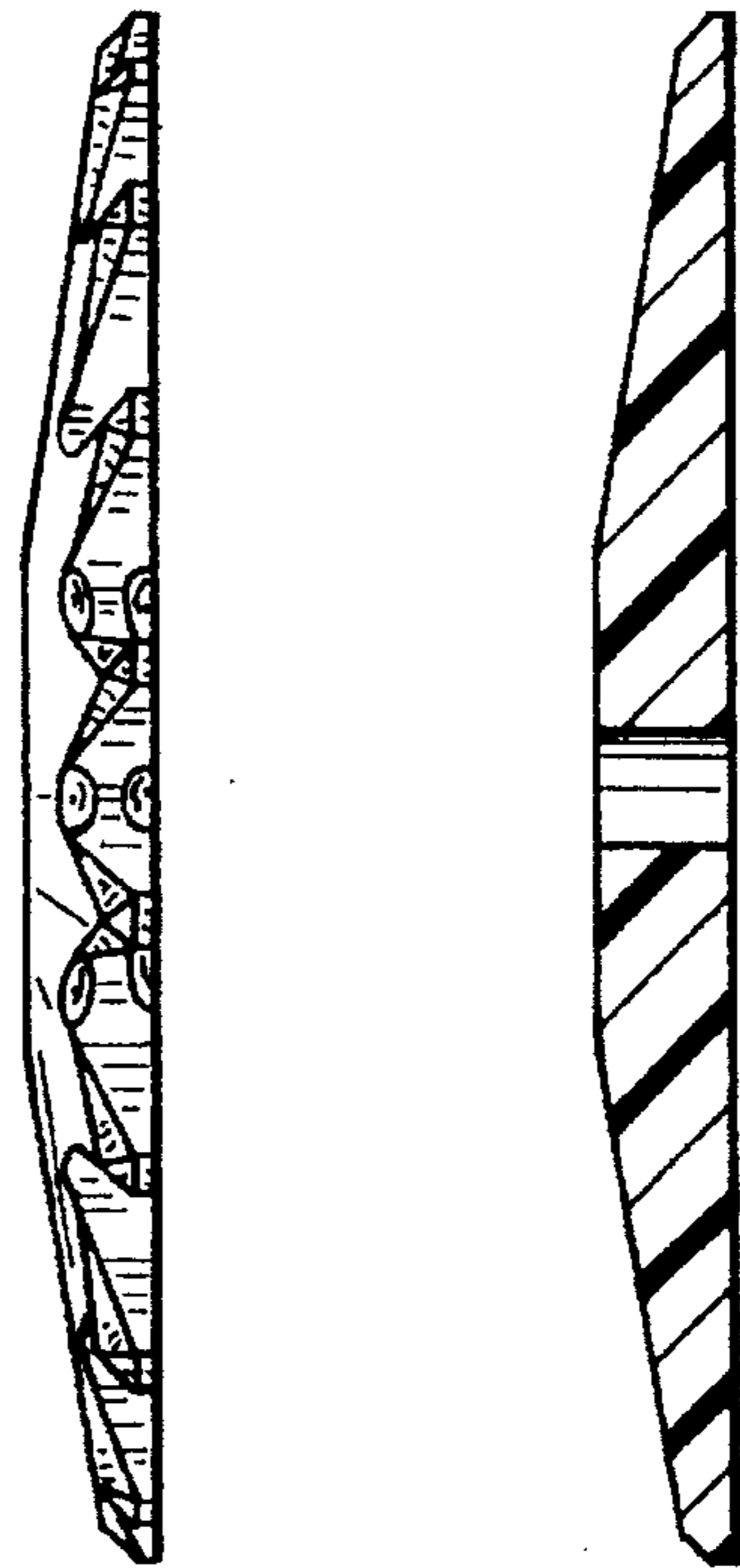


FIG. 4 FIG. 5

 FIG. 4 is a side elevational view of the right side thereof, the side elevational view of the left side is a mirror image thereof;
 FIG. 5 is a sectional view taken along the line 5—5 of FIG. 1;
 FIG. 6 is a front elevational view of a second embodiment of the design;
 FIG. 7 is a bottom plan view of FIG. 6, the top plan view is a mirror image thereof;
 FIG. 8 is a rear elevational view of FIG. 6;

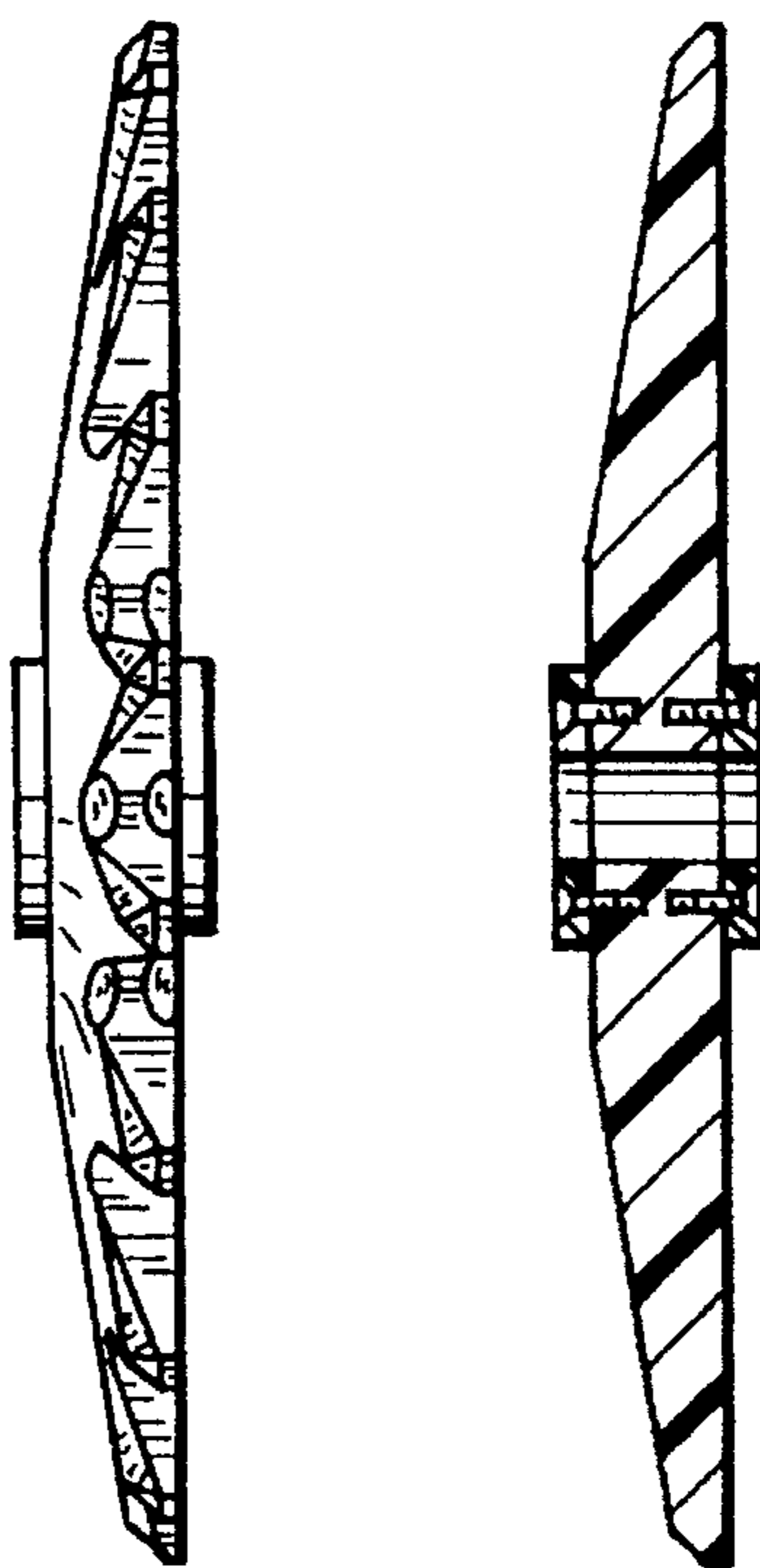


FIG. 9 FIG. 10

 FIG. 9 is a side elevational view of the right side of FIG. 6, the side elevational view of the left side of FIG. 6 is a mirror image thereof; and,
 FIG. 10 is a sectional view taken along the line 10—10 of FIG. 6.

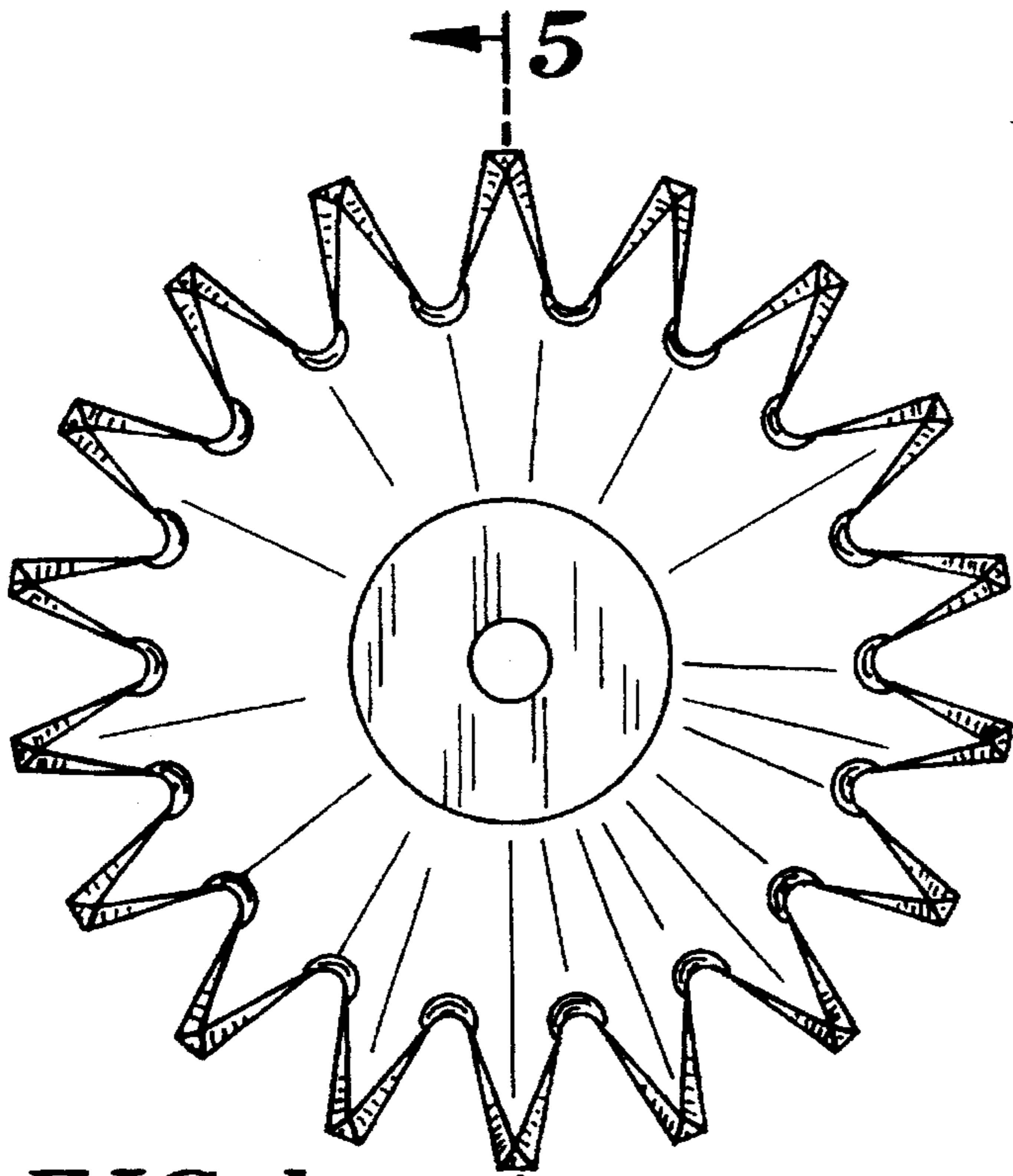

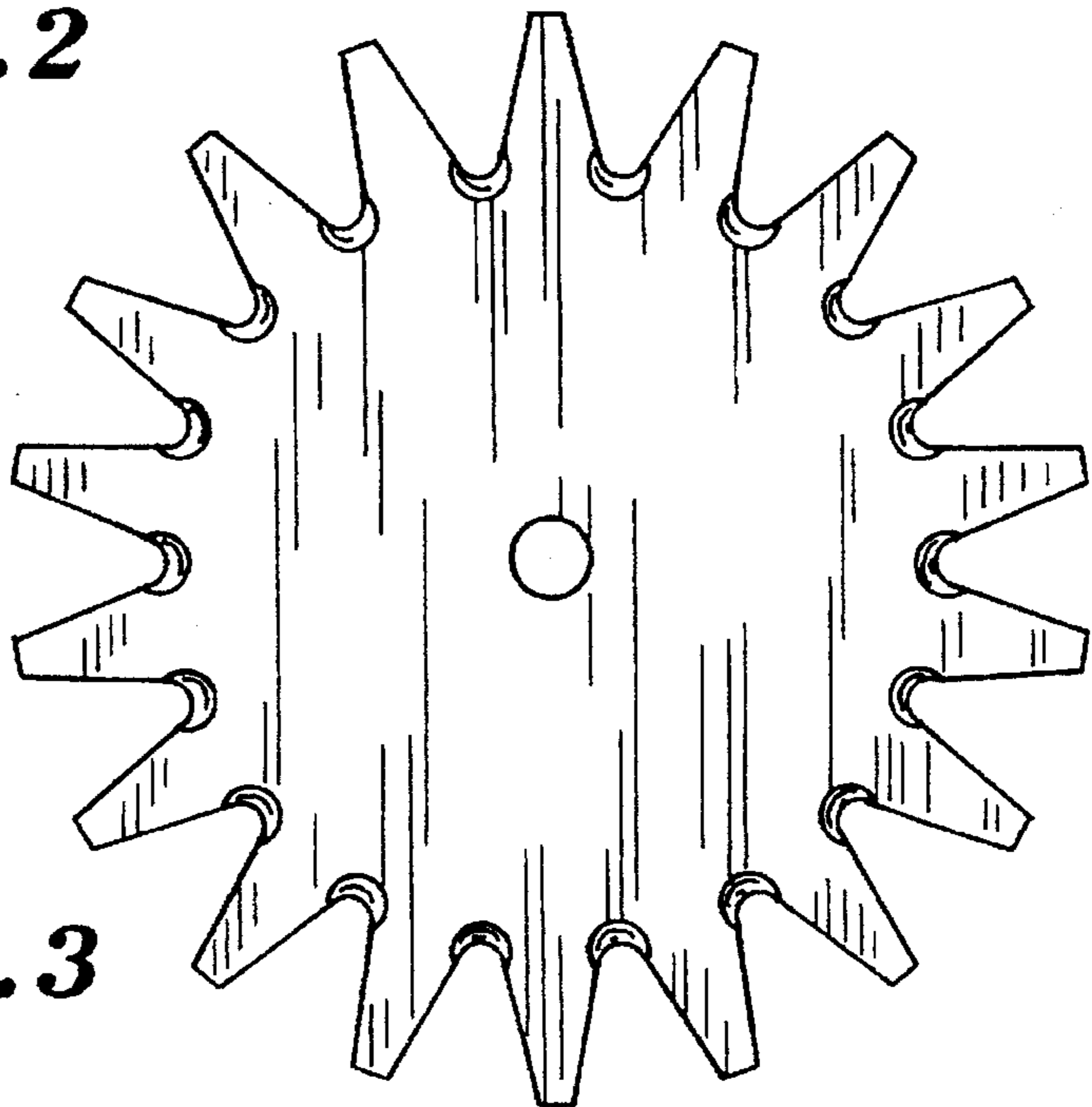

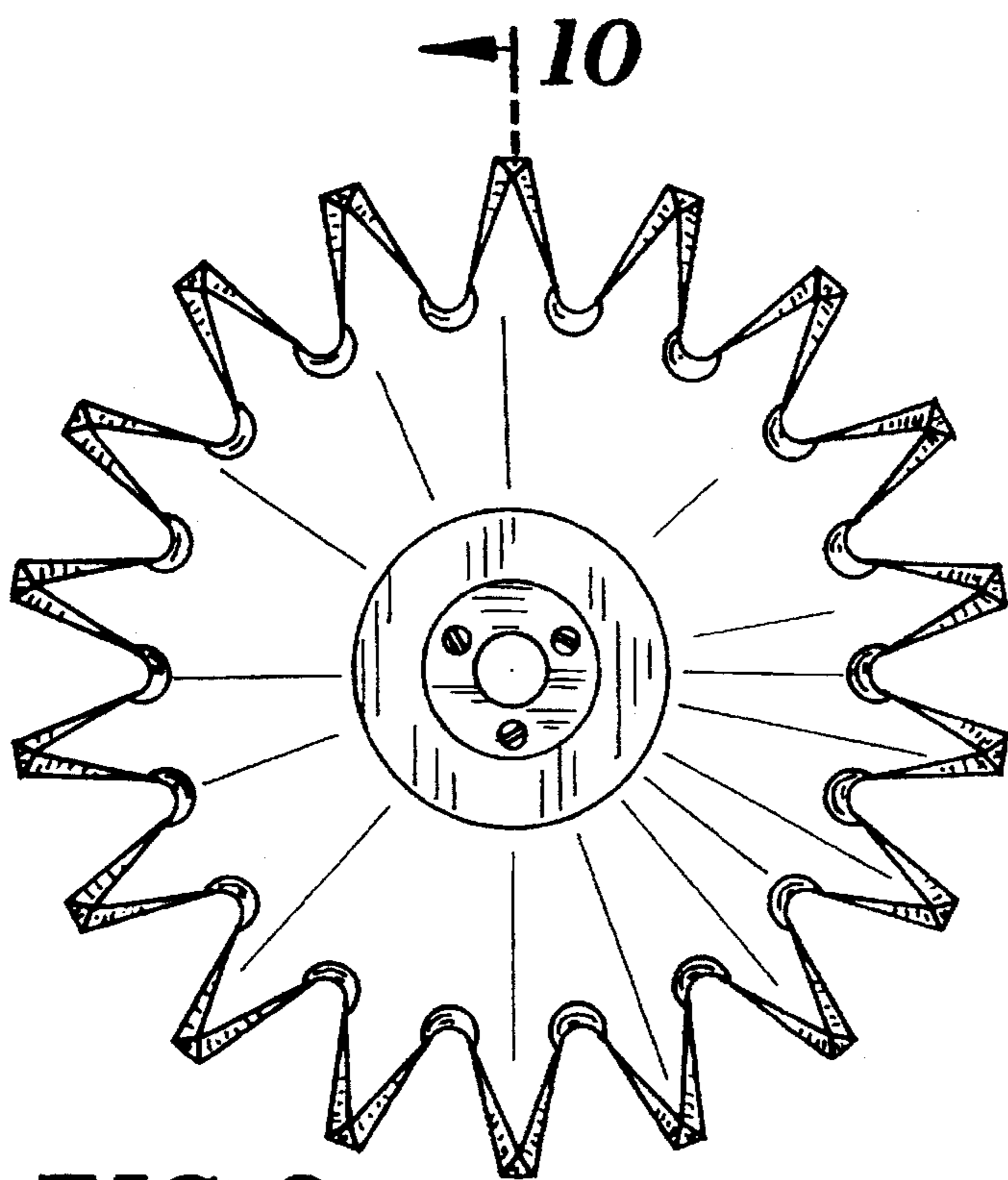

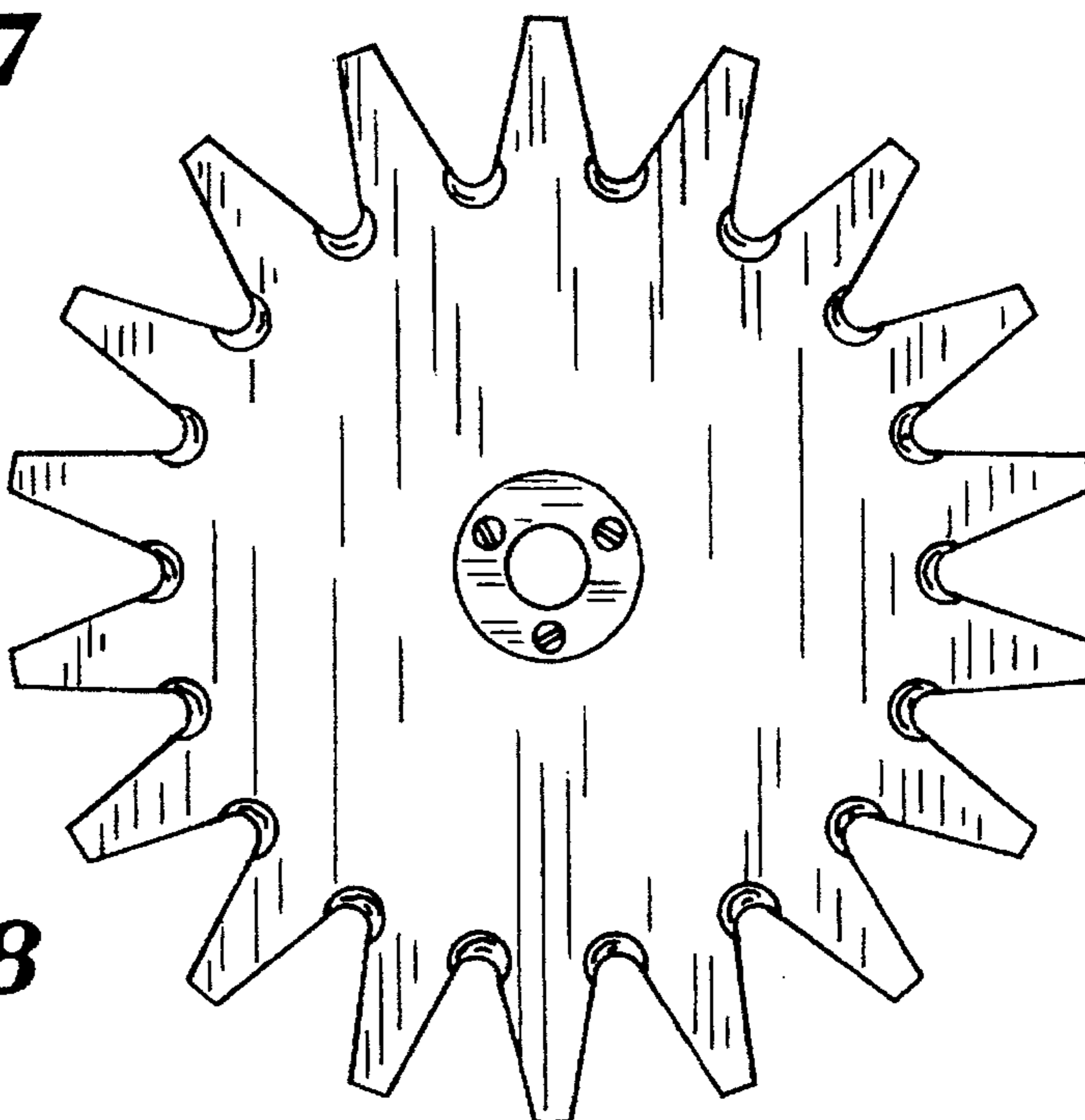
