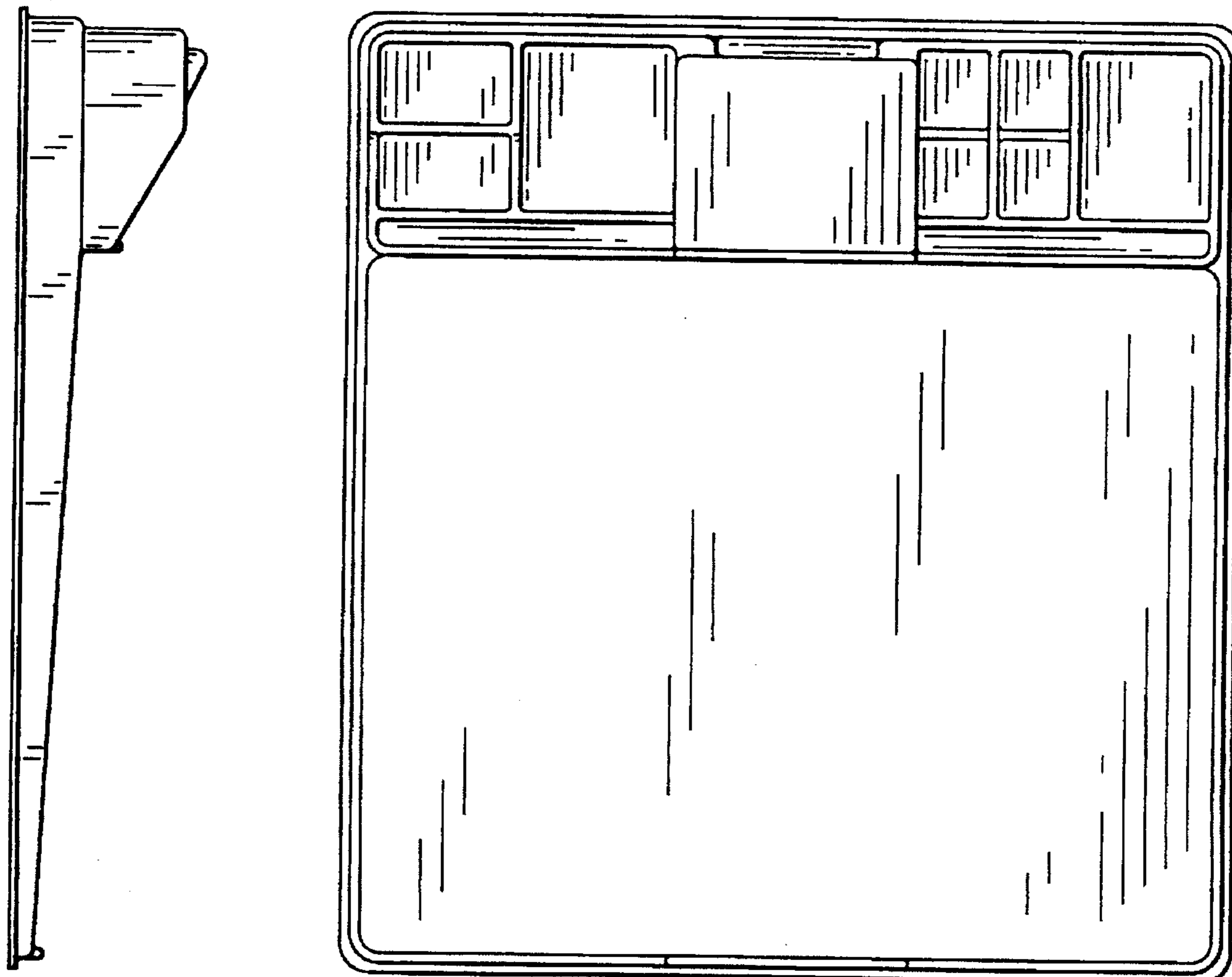

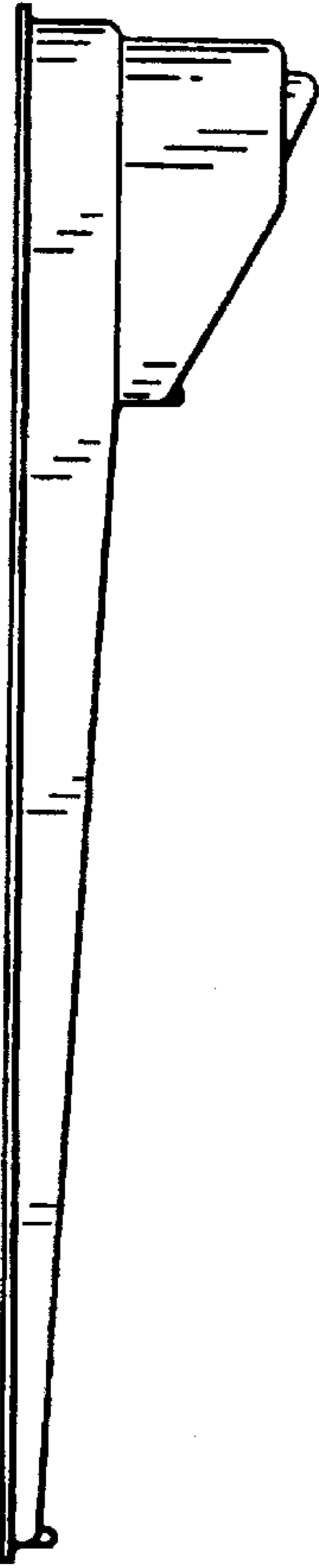
The ornamental design for a combined writing tablet and storage tray, as shown and described.

**DESCRIPTION**

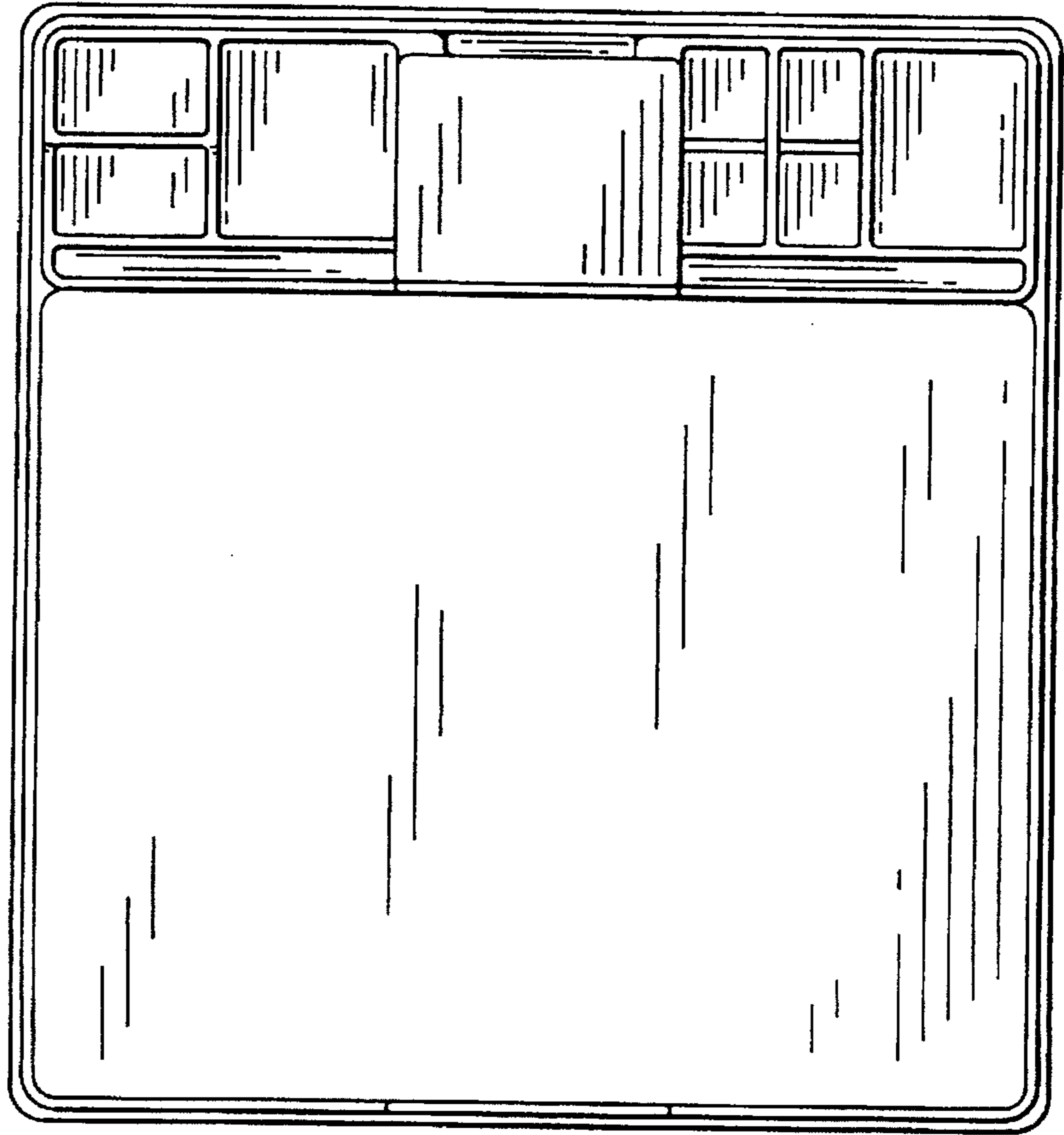
FIG. 1 is a top plan view showing my new design;

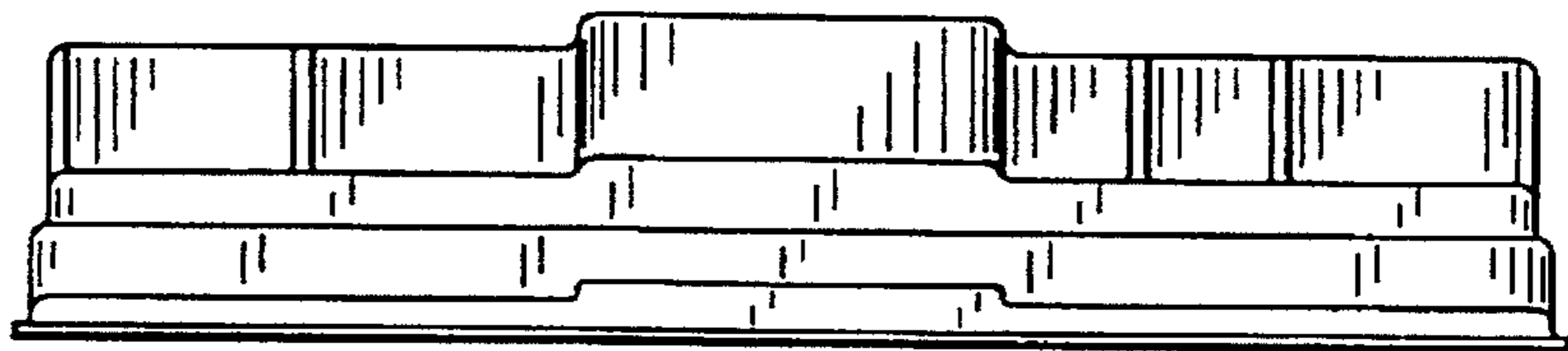




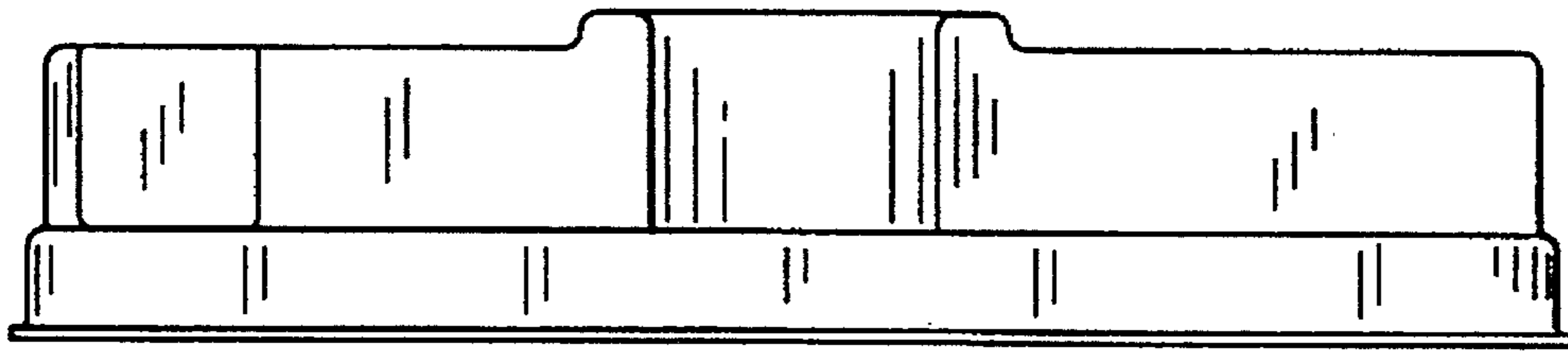

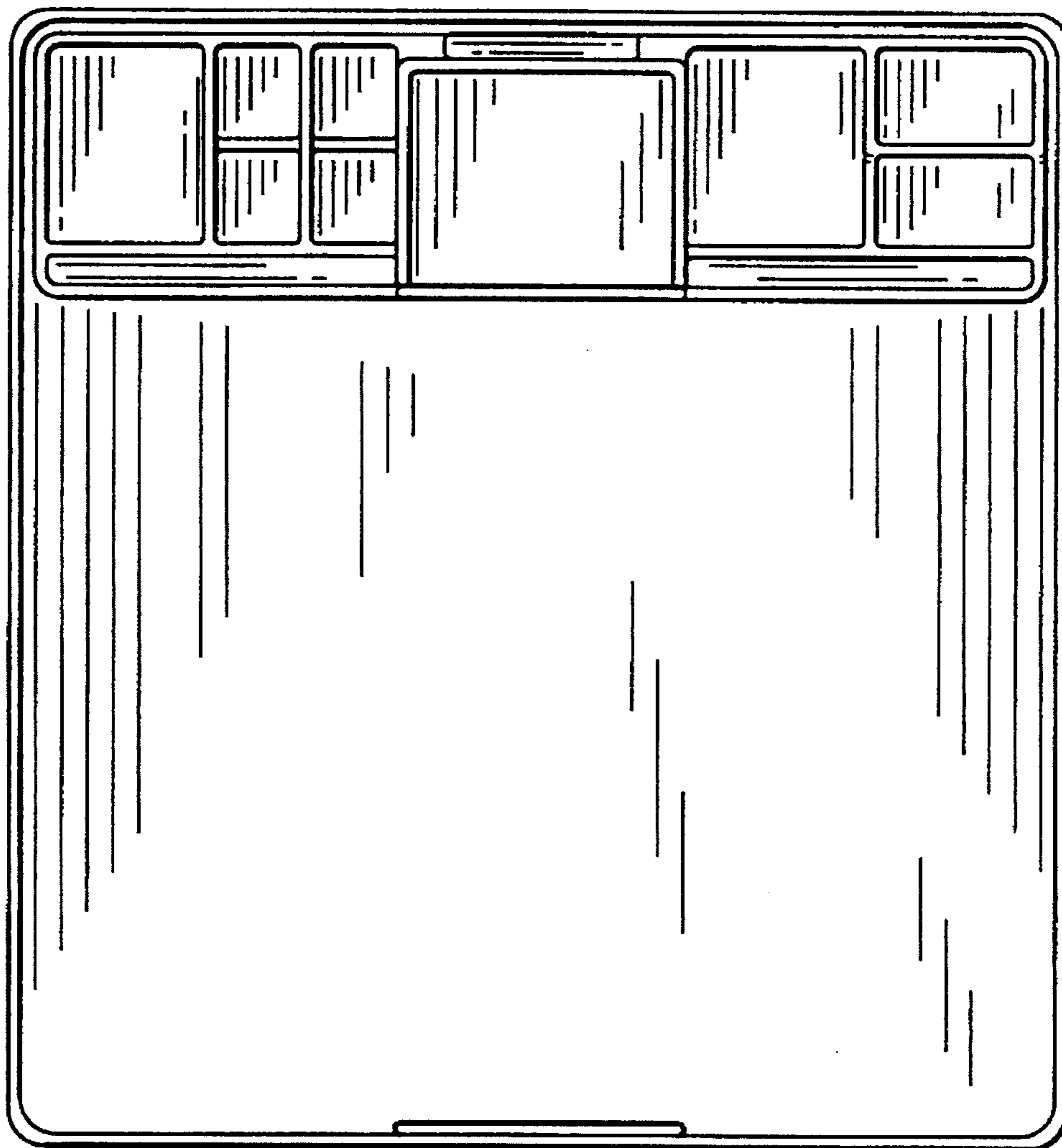

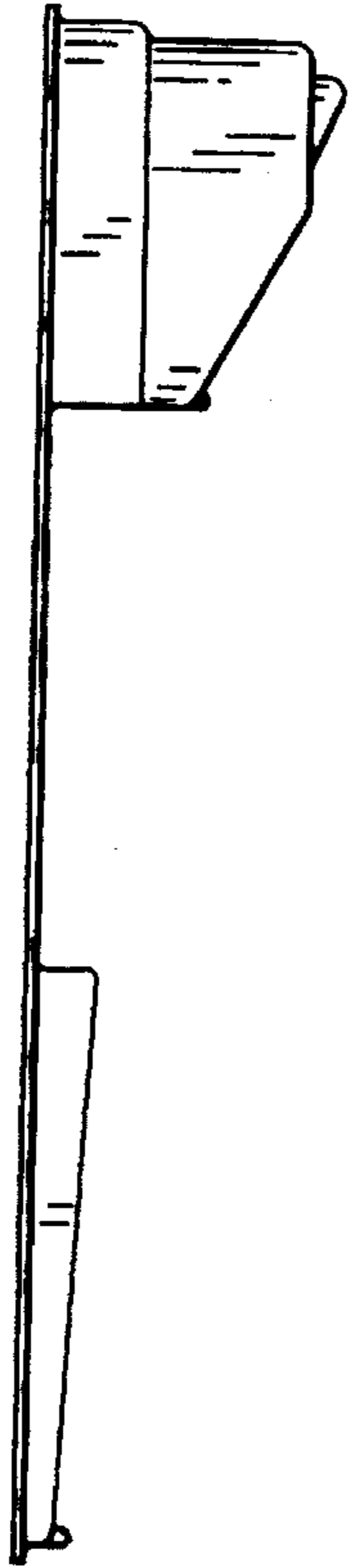

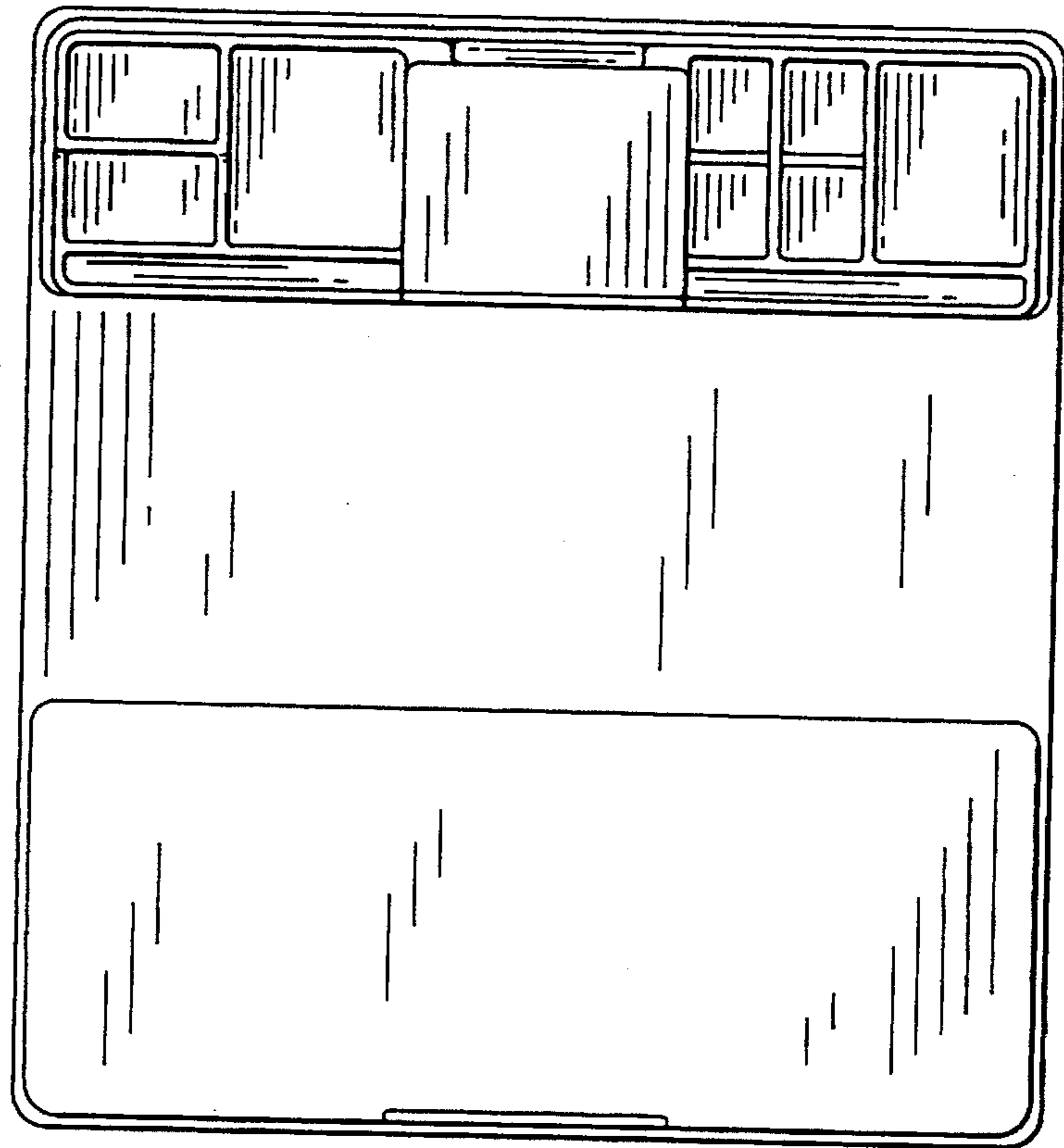

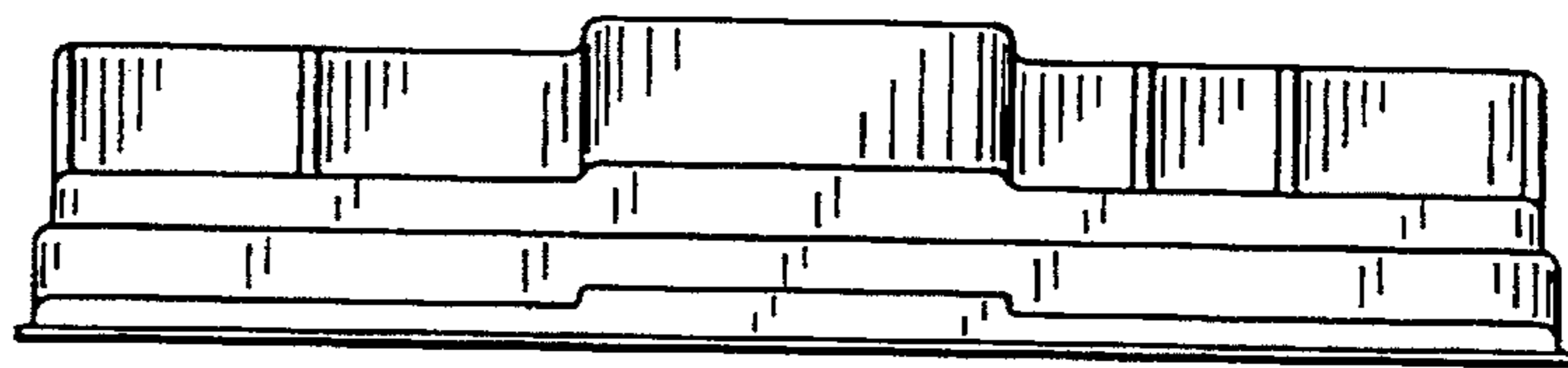

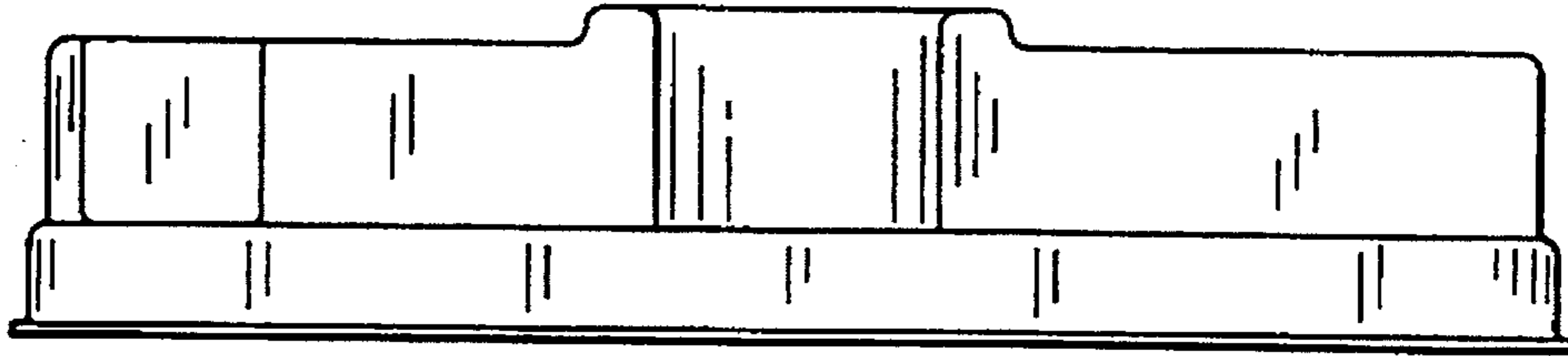

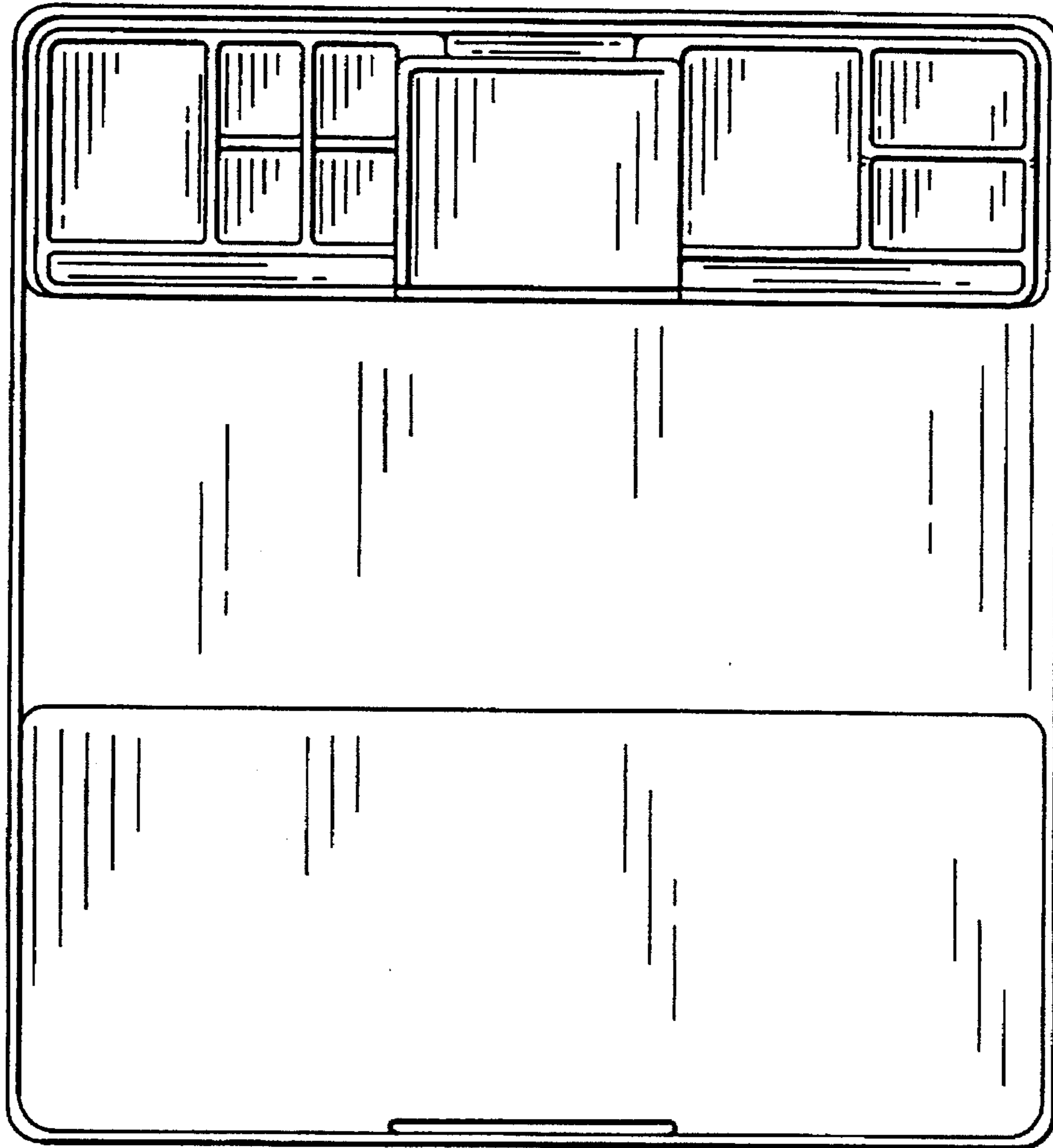
