### [57] CLAIM

The ornamental design for a golf club head, as shown and described.

### DESCRIPTION

FIG. 1 is a top, left perspective view of a golf club head showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right side elevational view thereof;

FIG. 7 is a left side elevational view of a second embodiment of FIG. 1;

FIG. 8 is a right side elevational view of the embodiment of FIG. 7;

FIG. 9 is a bottom plan view of the embodiment of FIG. 7;

FIG. 10 is a front elevational view of a third embodiment of FIG. 1;

FIG. 11 is a rear elevational view of the embodiment of FIG. 10;

FIG. 12 is a bottom plan view of the embodiment of FIG. 10;

FIG. 13 is a left side elevational view of a fourth embodiment of FIG. 1;

FIG. 14 is a right side elevational view of the embodiment of FIG. 13;

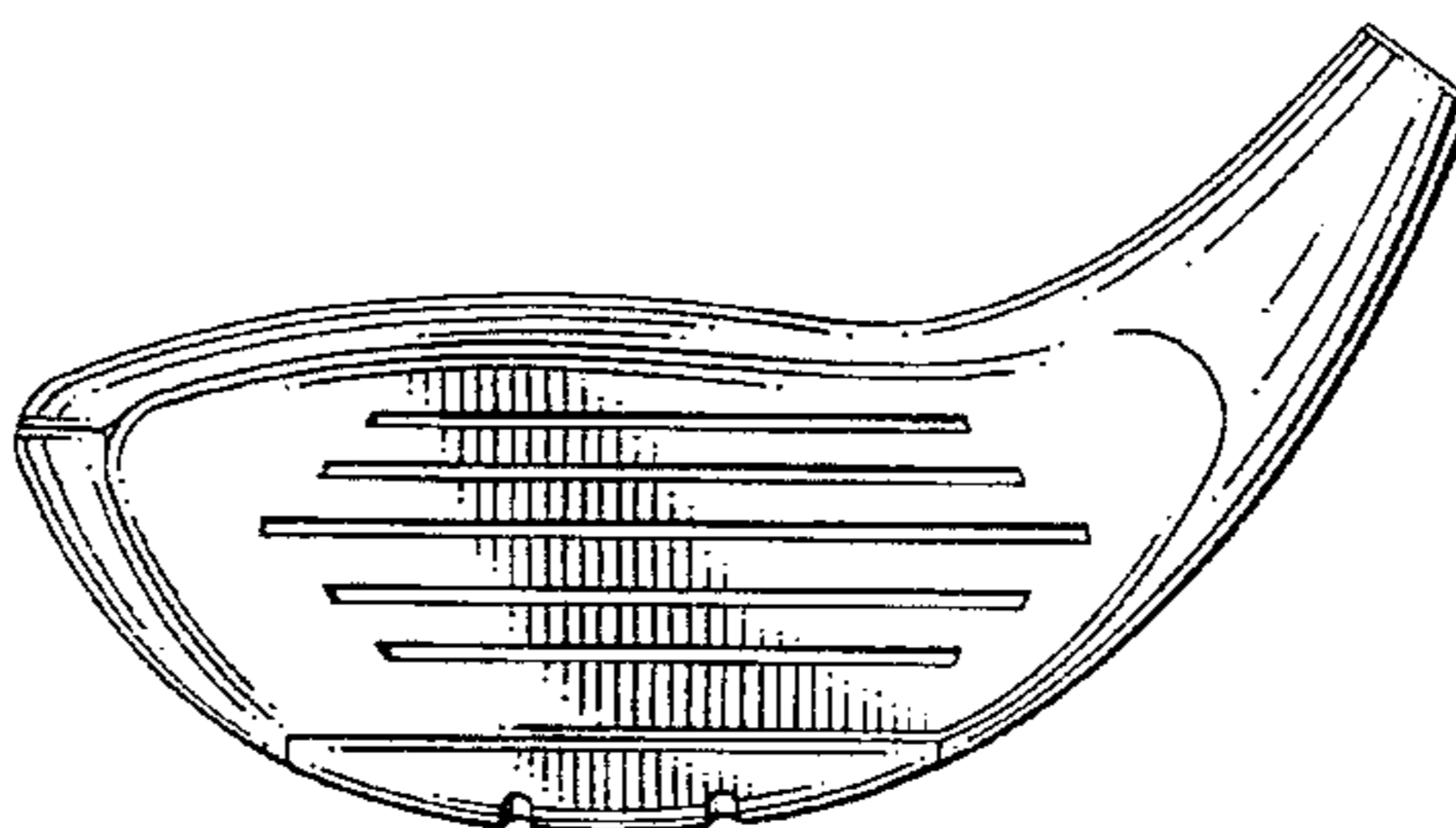
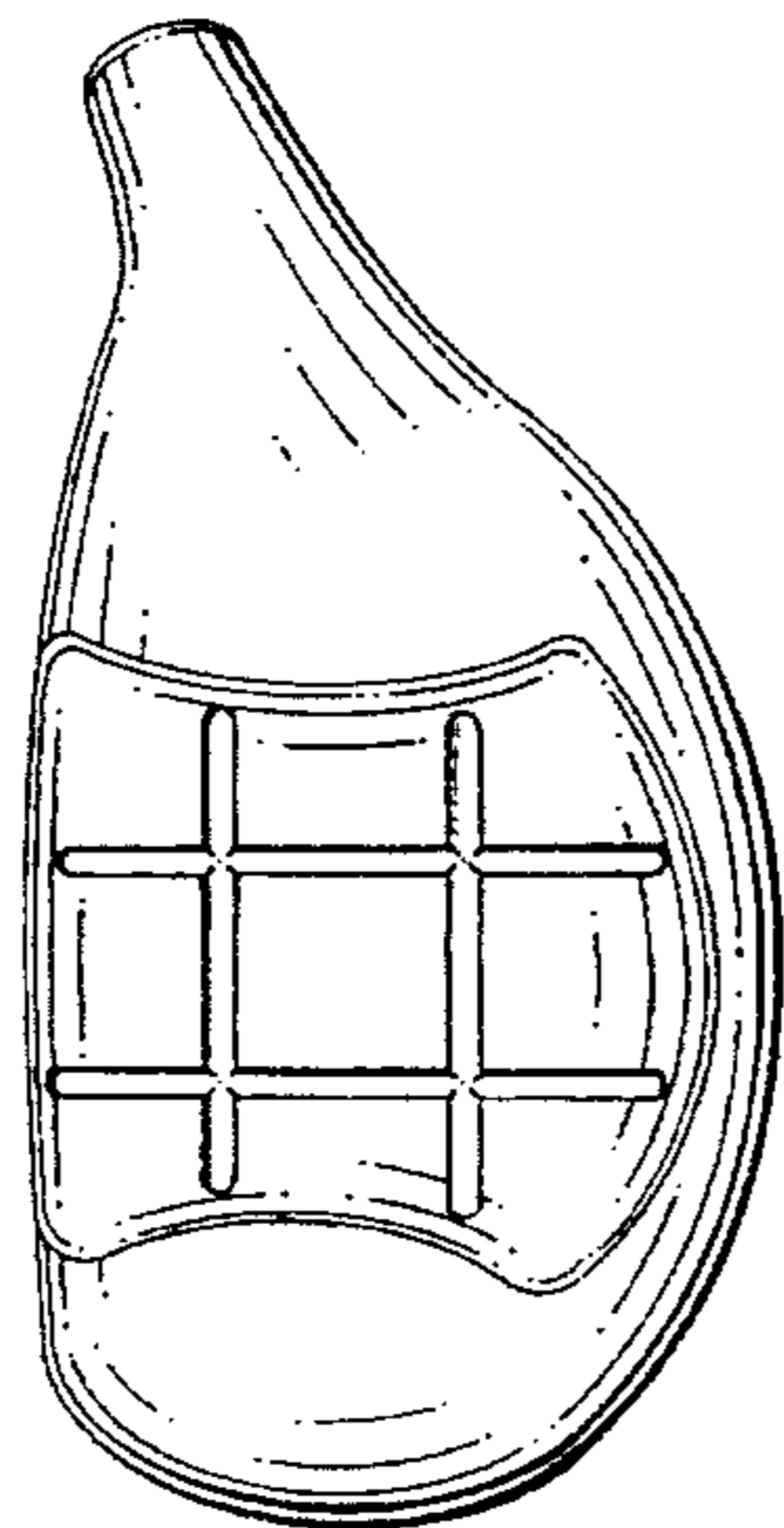
FIG. 15 is a bottom plan view of the embodiment of FIG. 13;

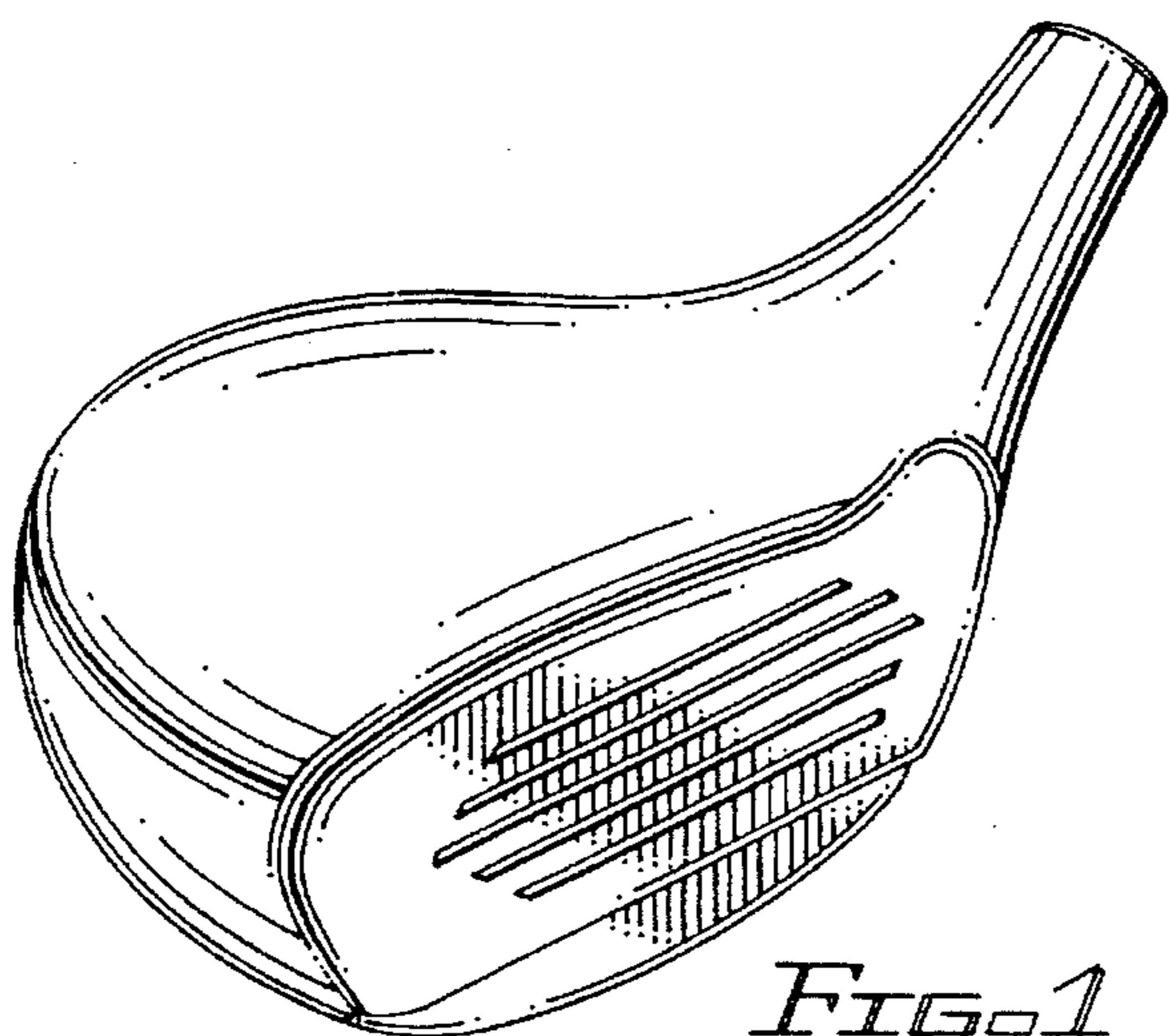

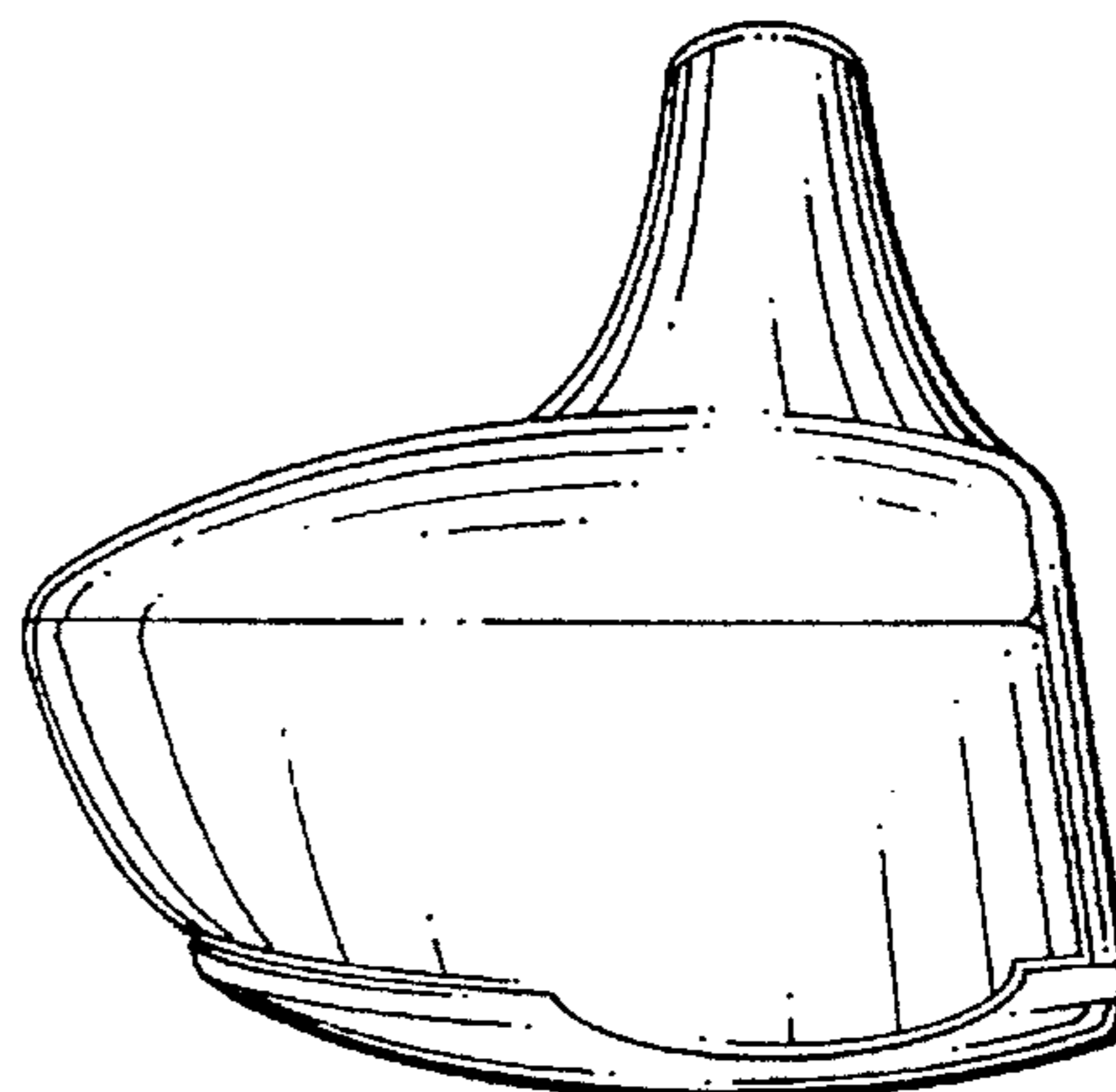

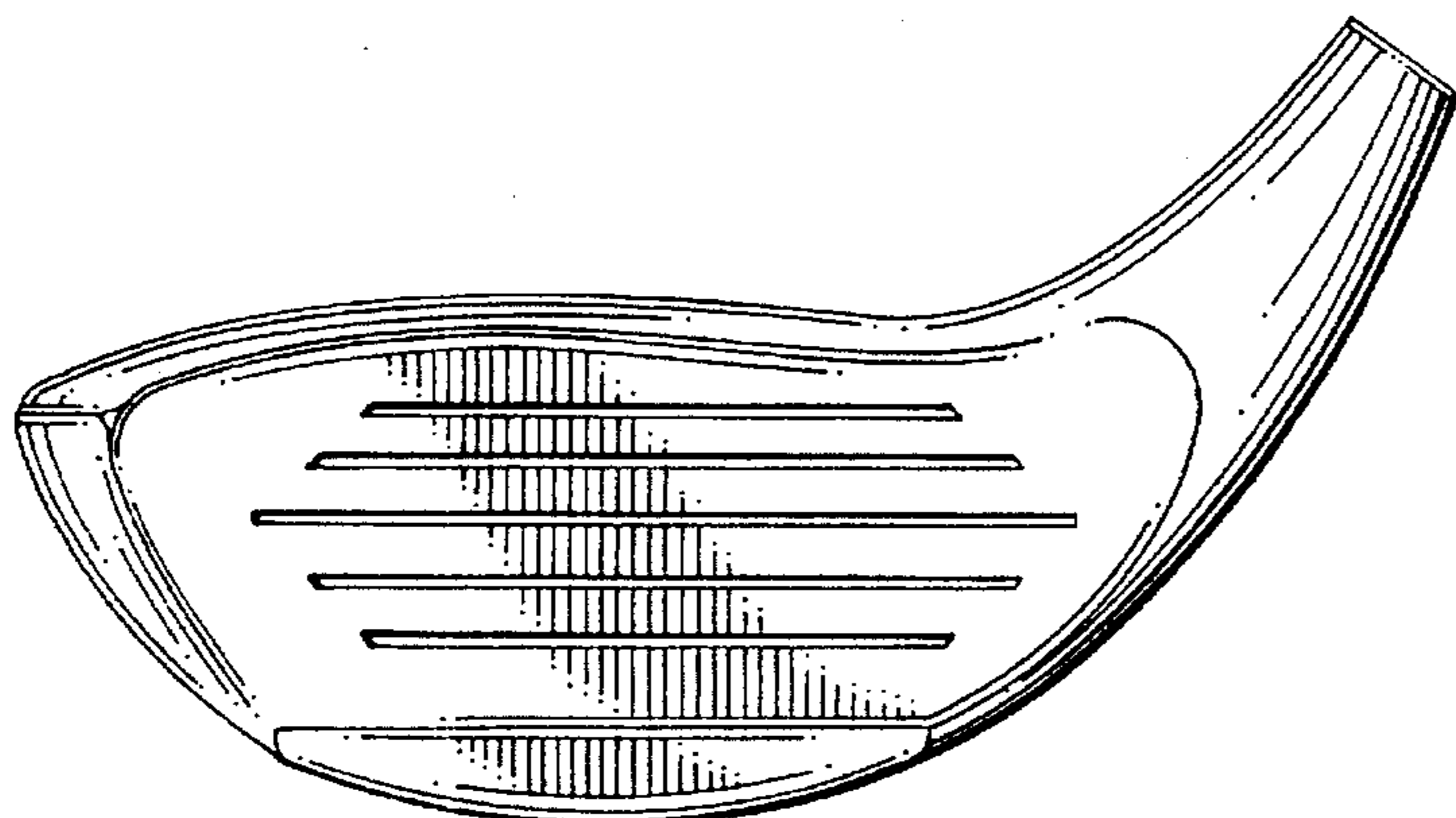

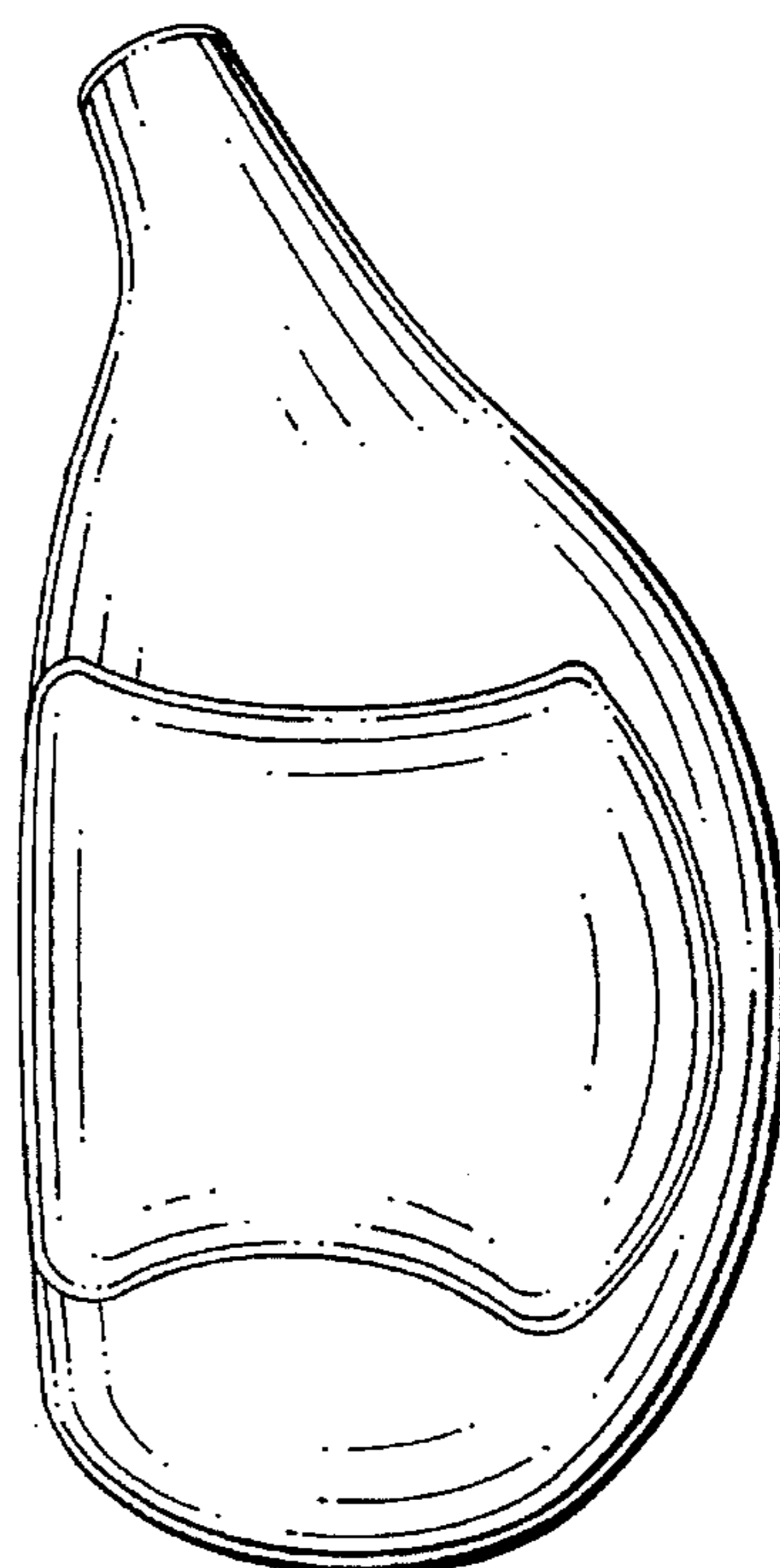

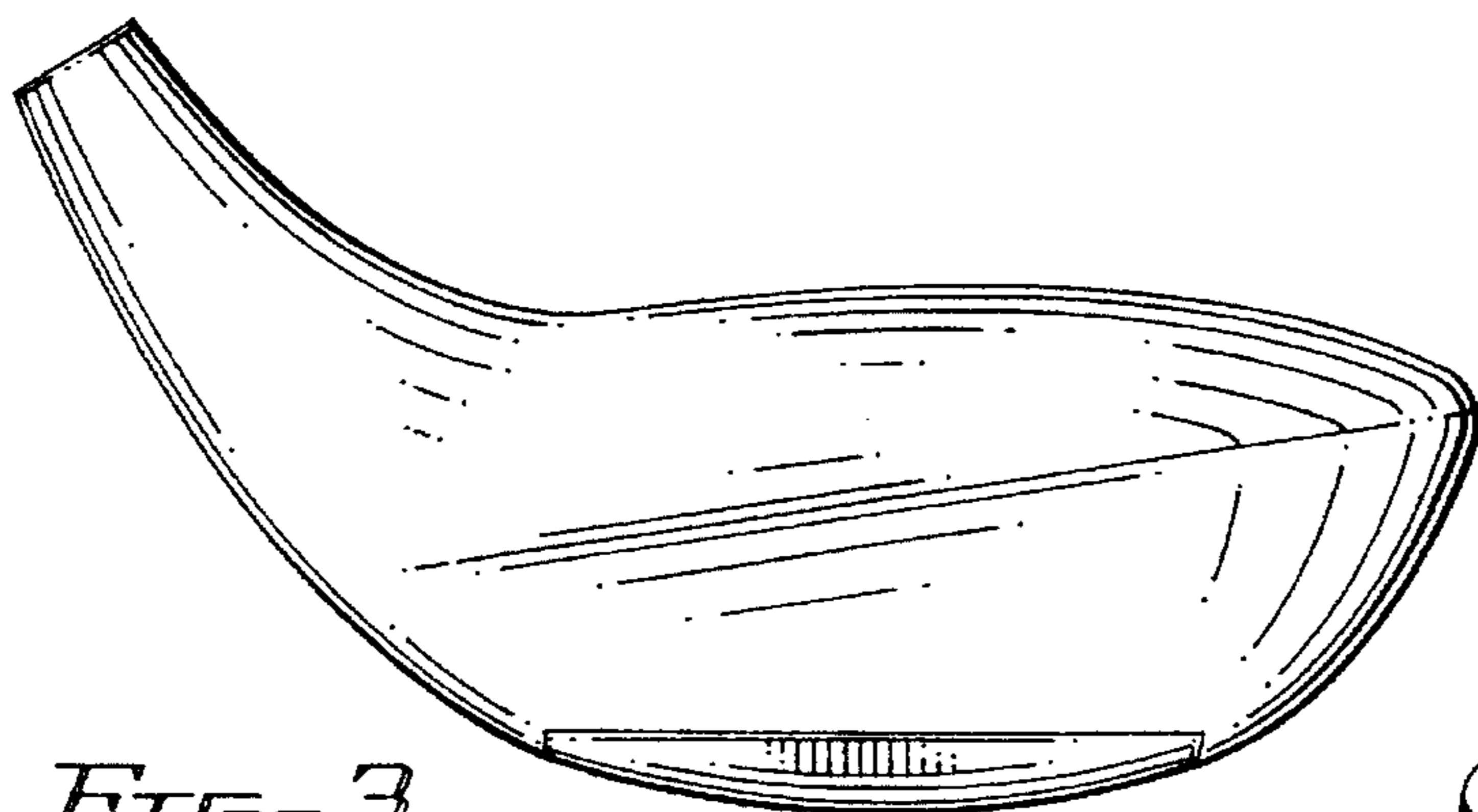

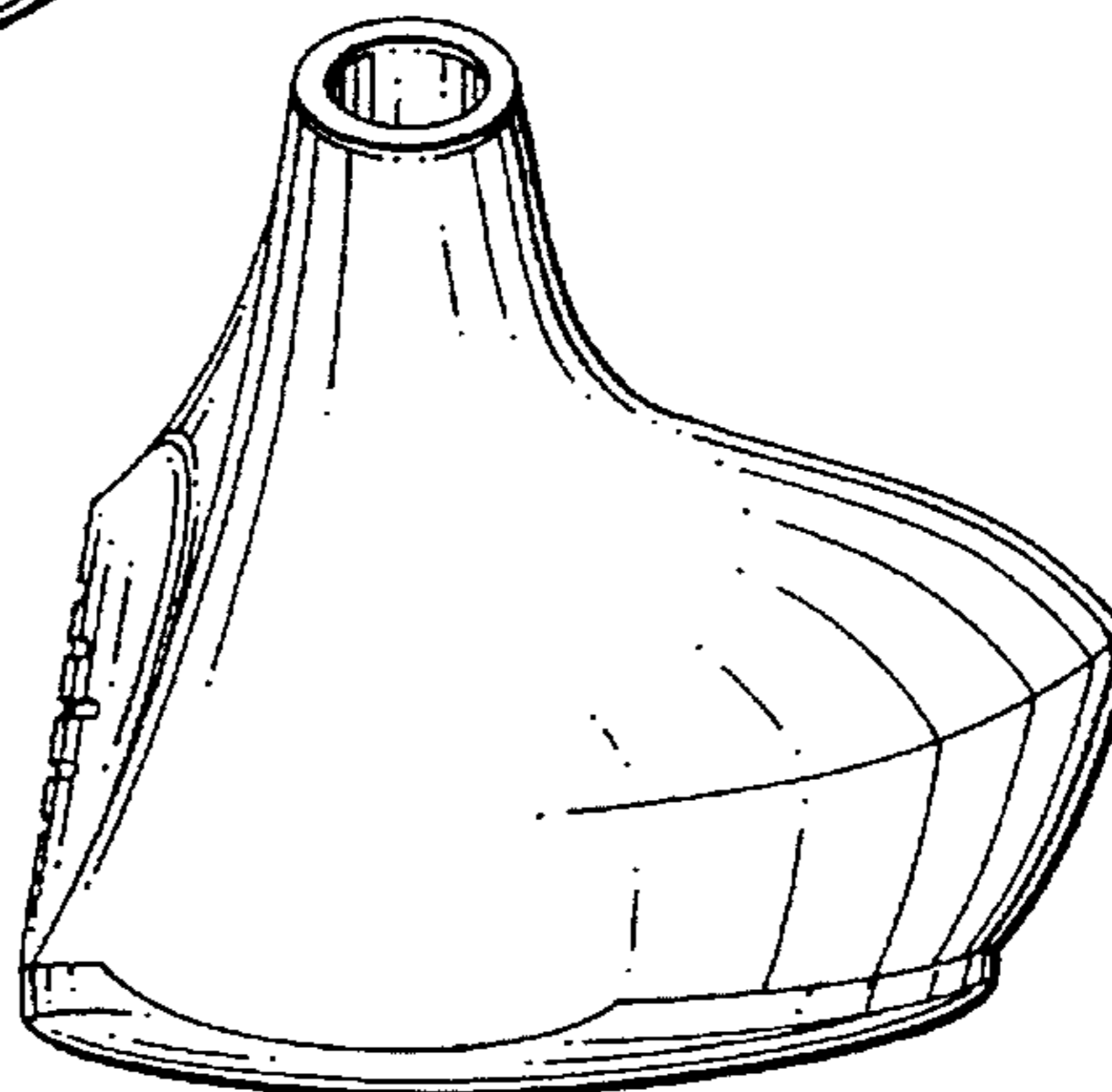

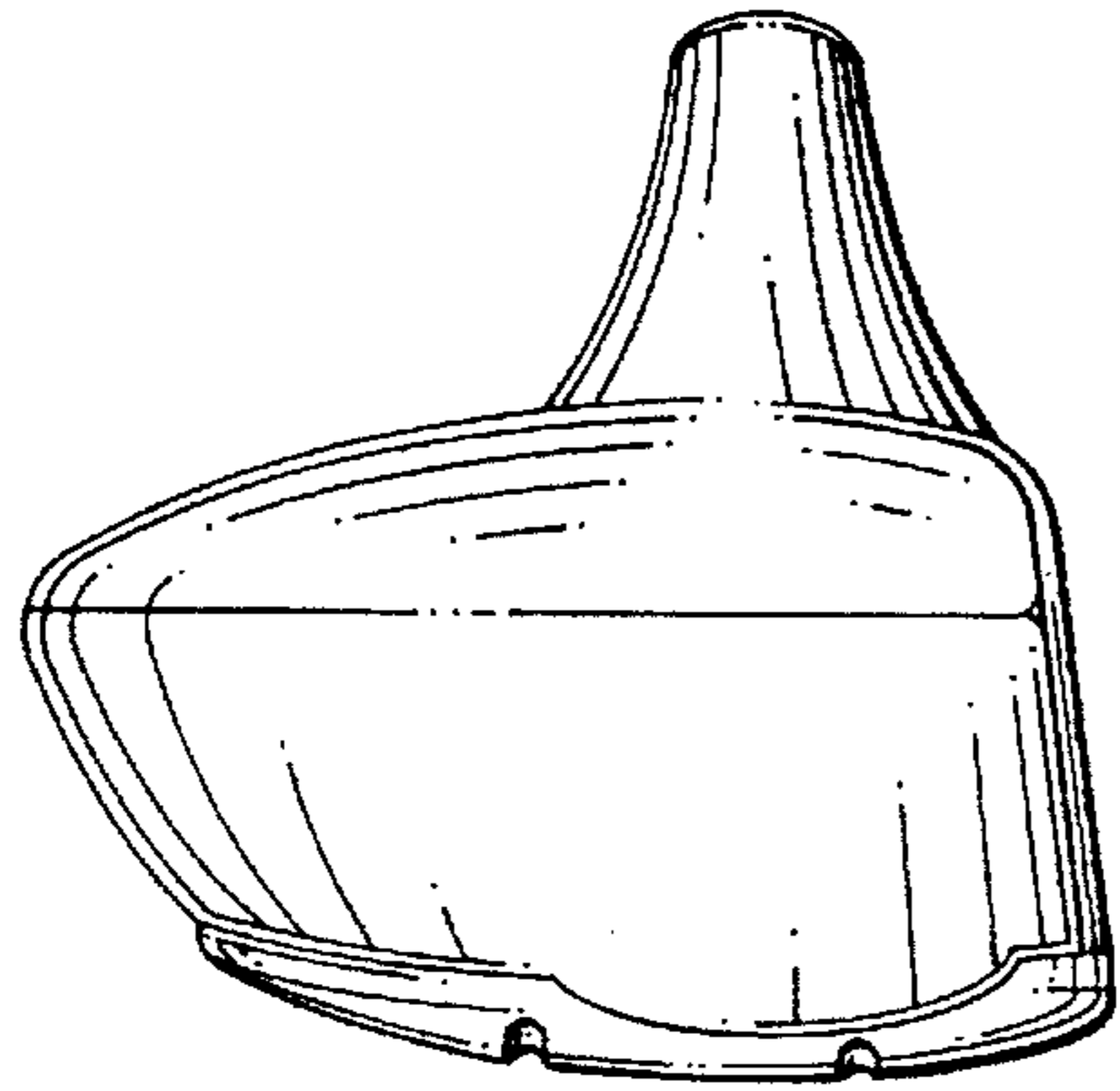

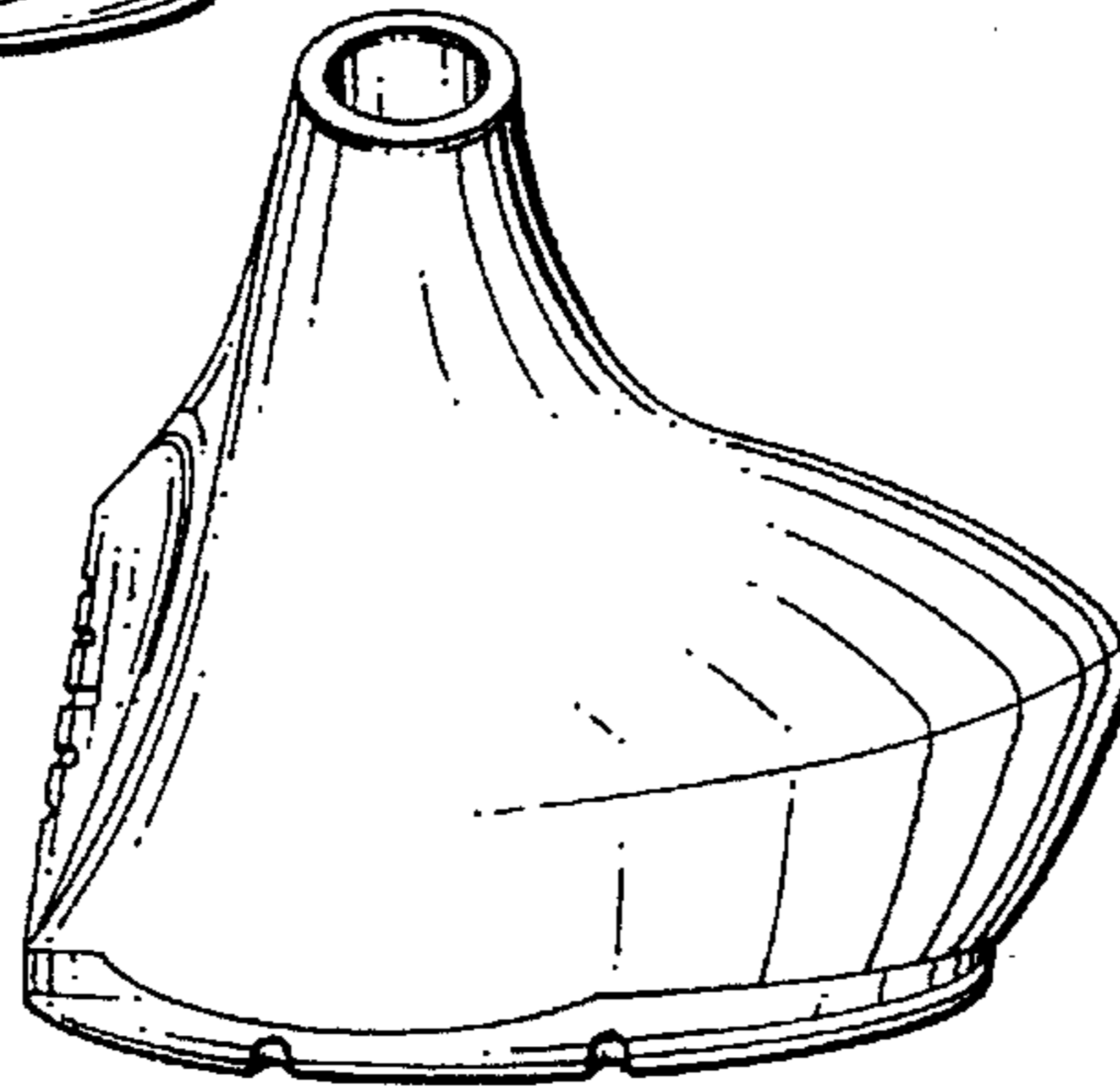

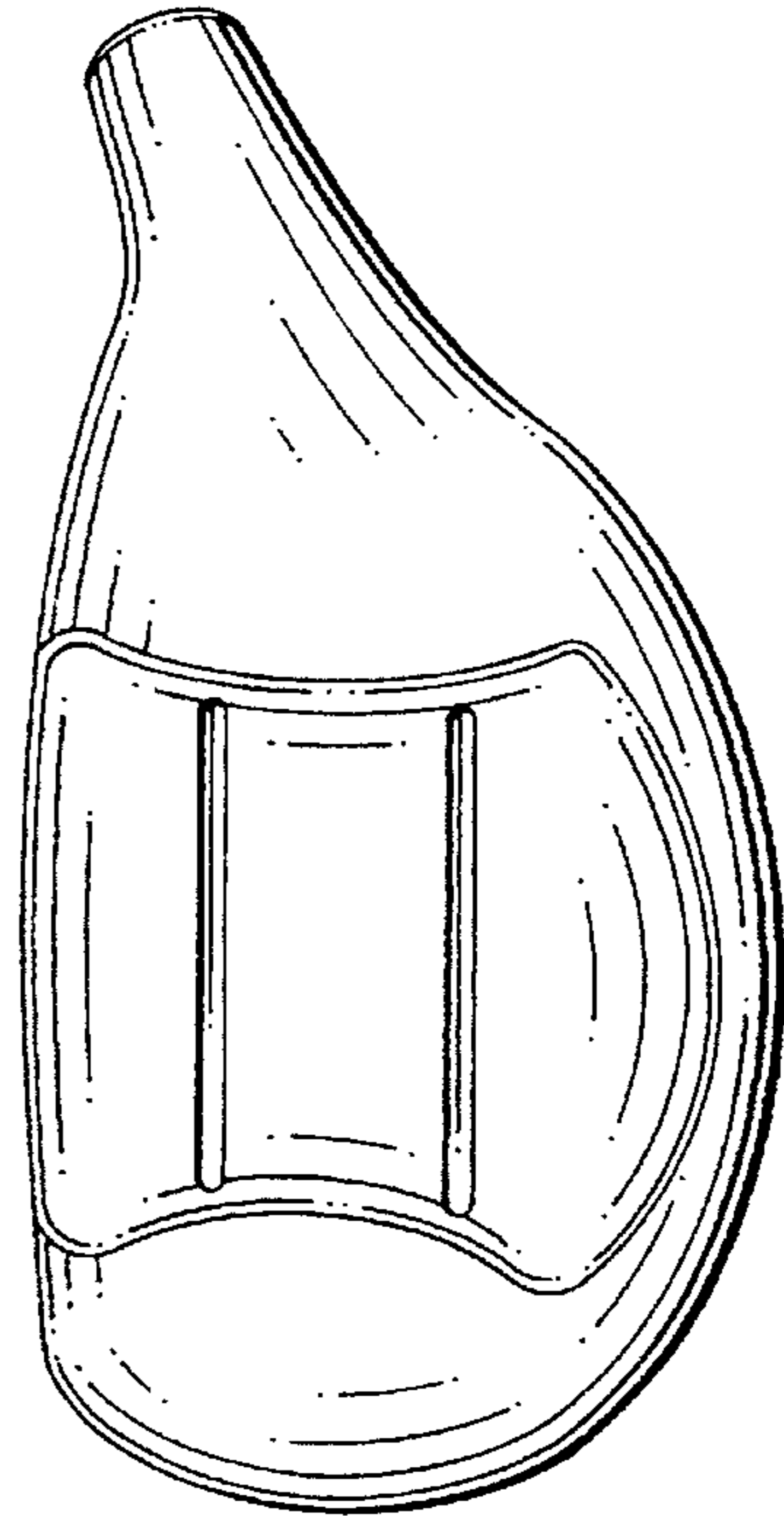

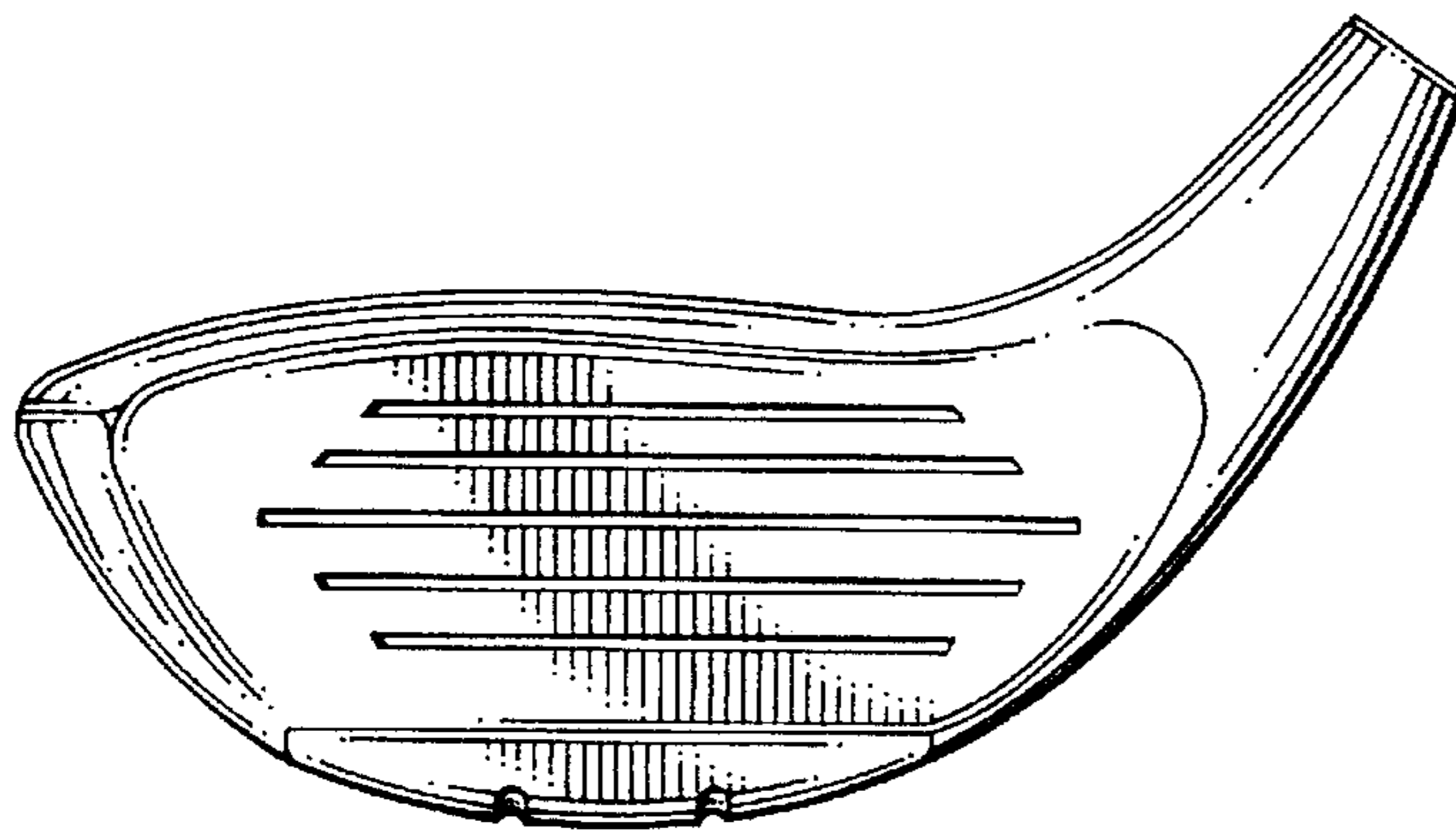

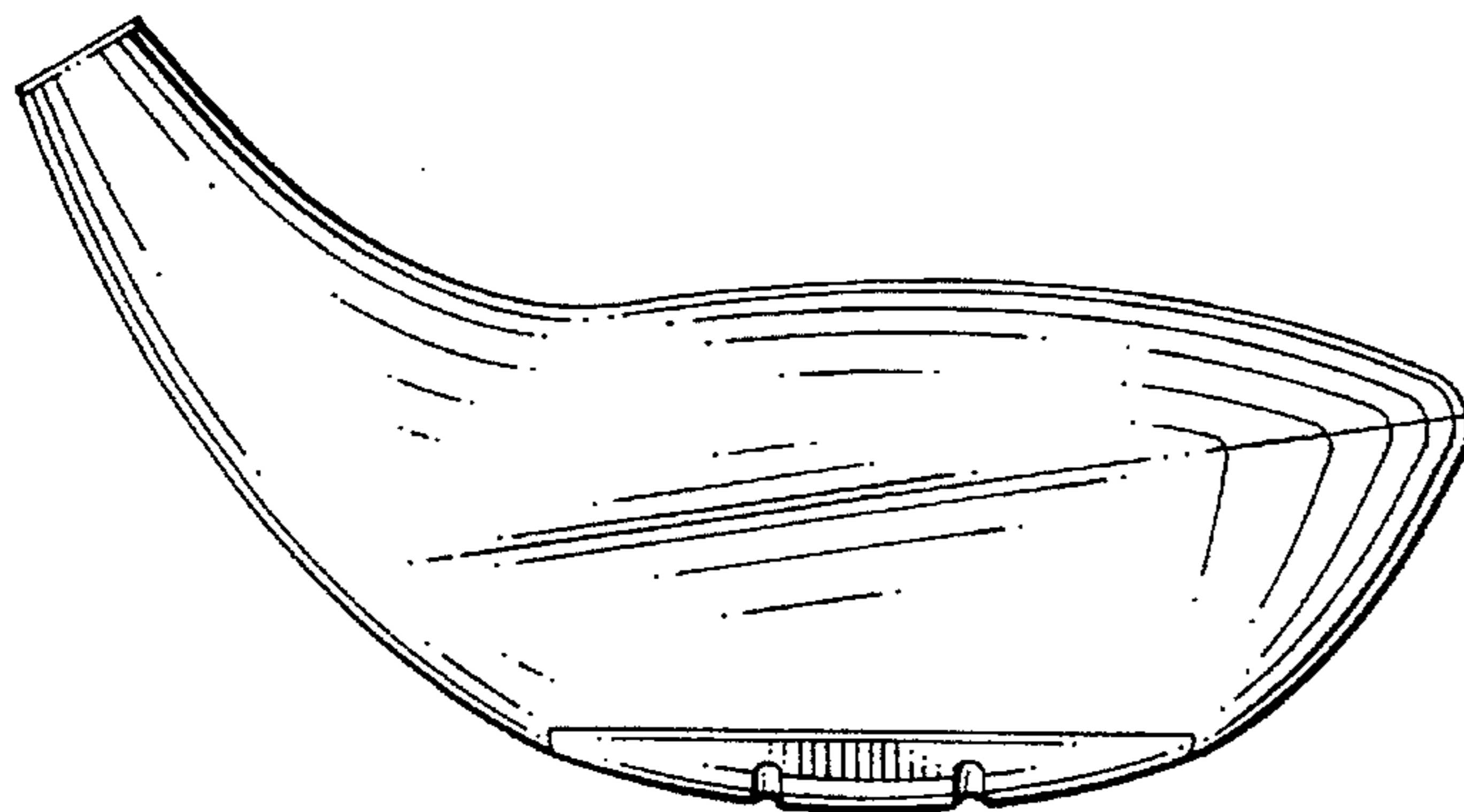

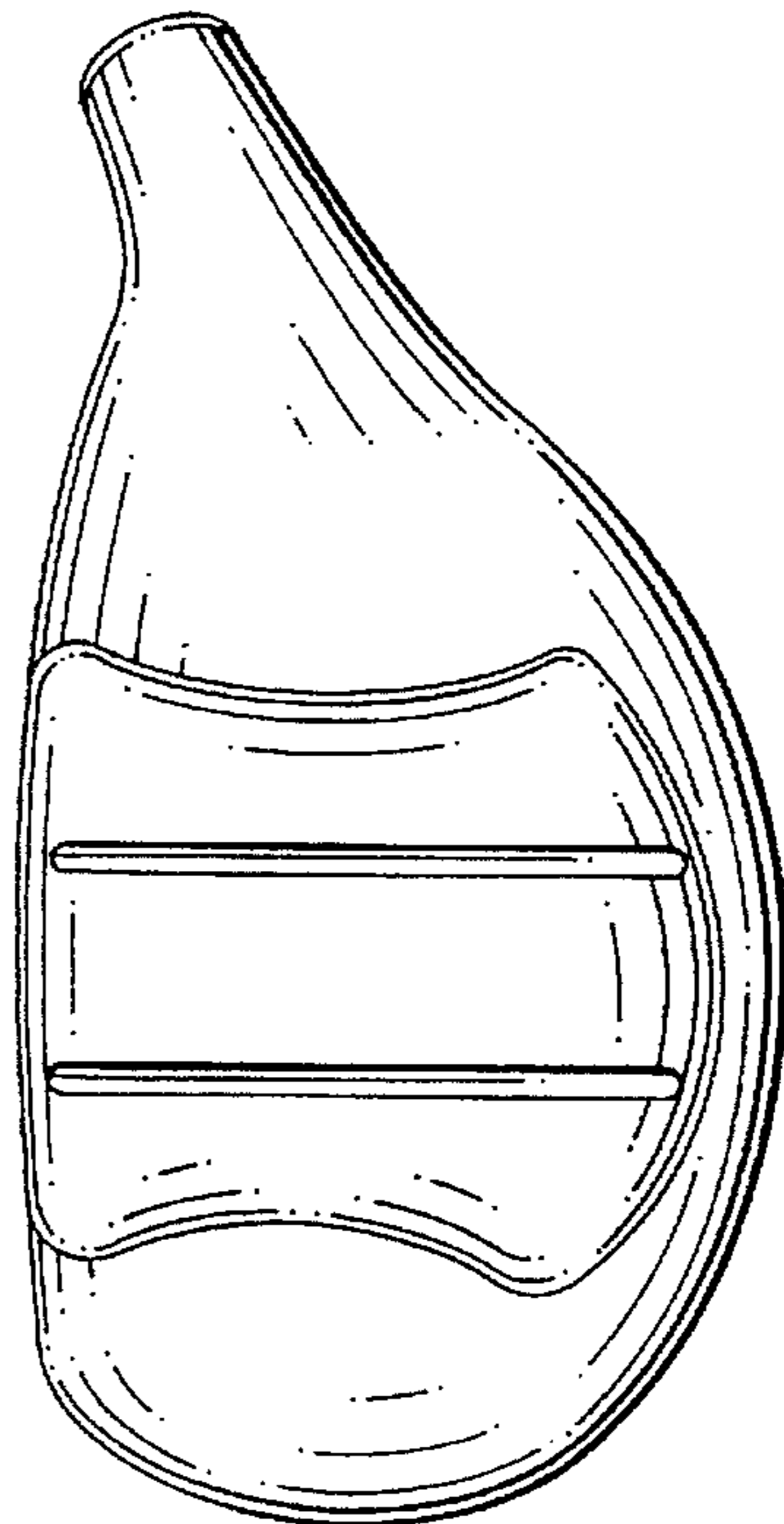
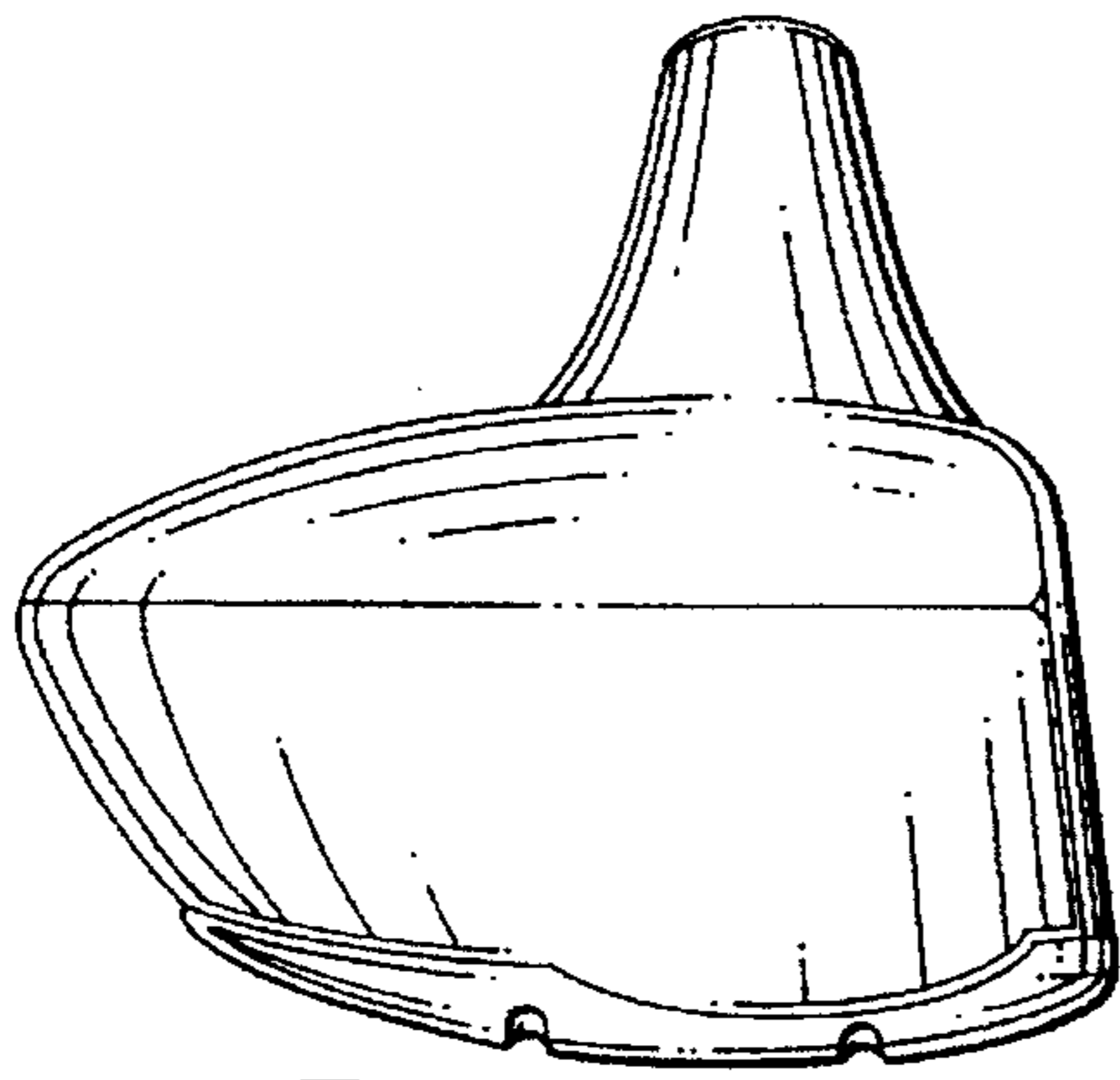
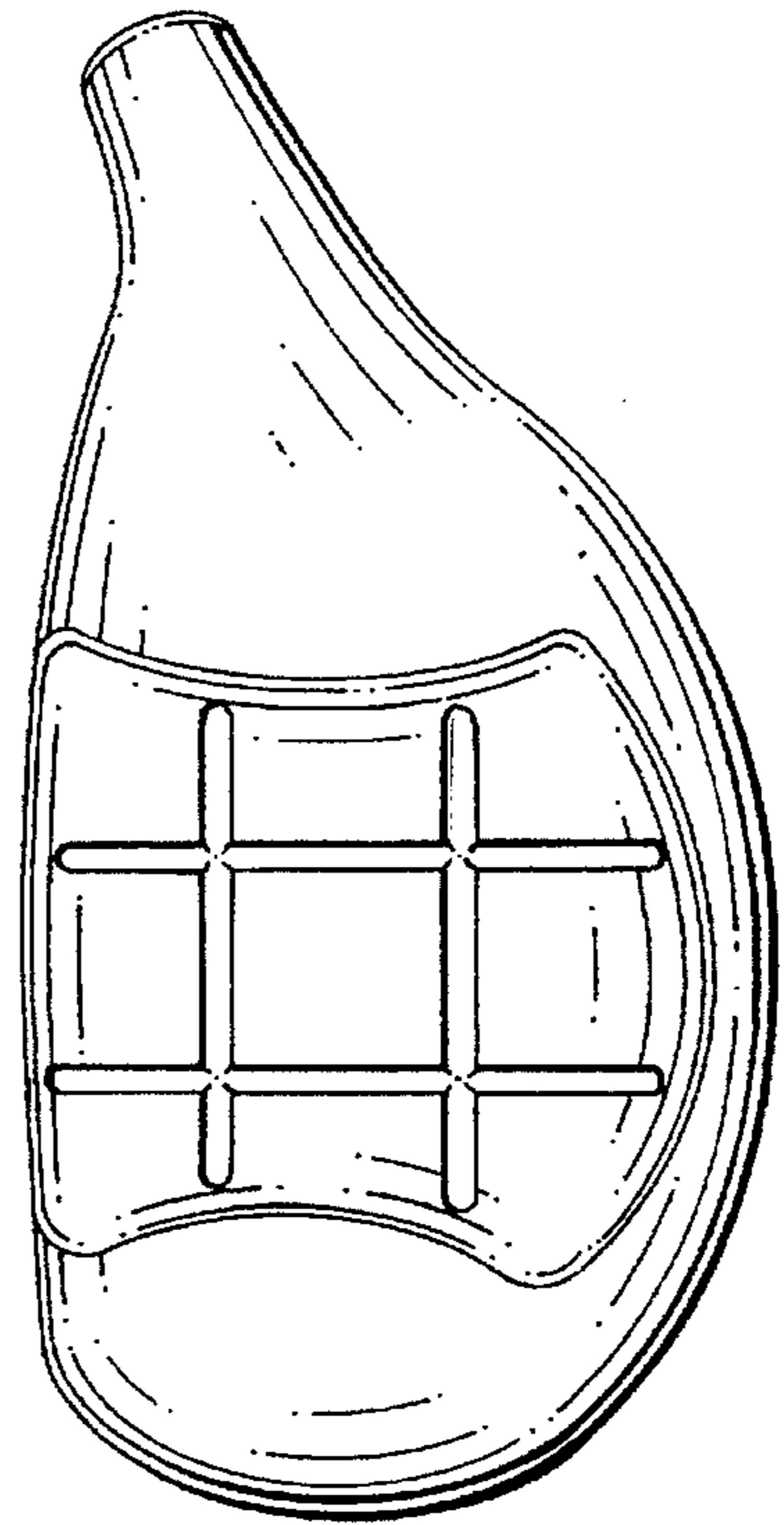


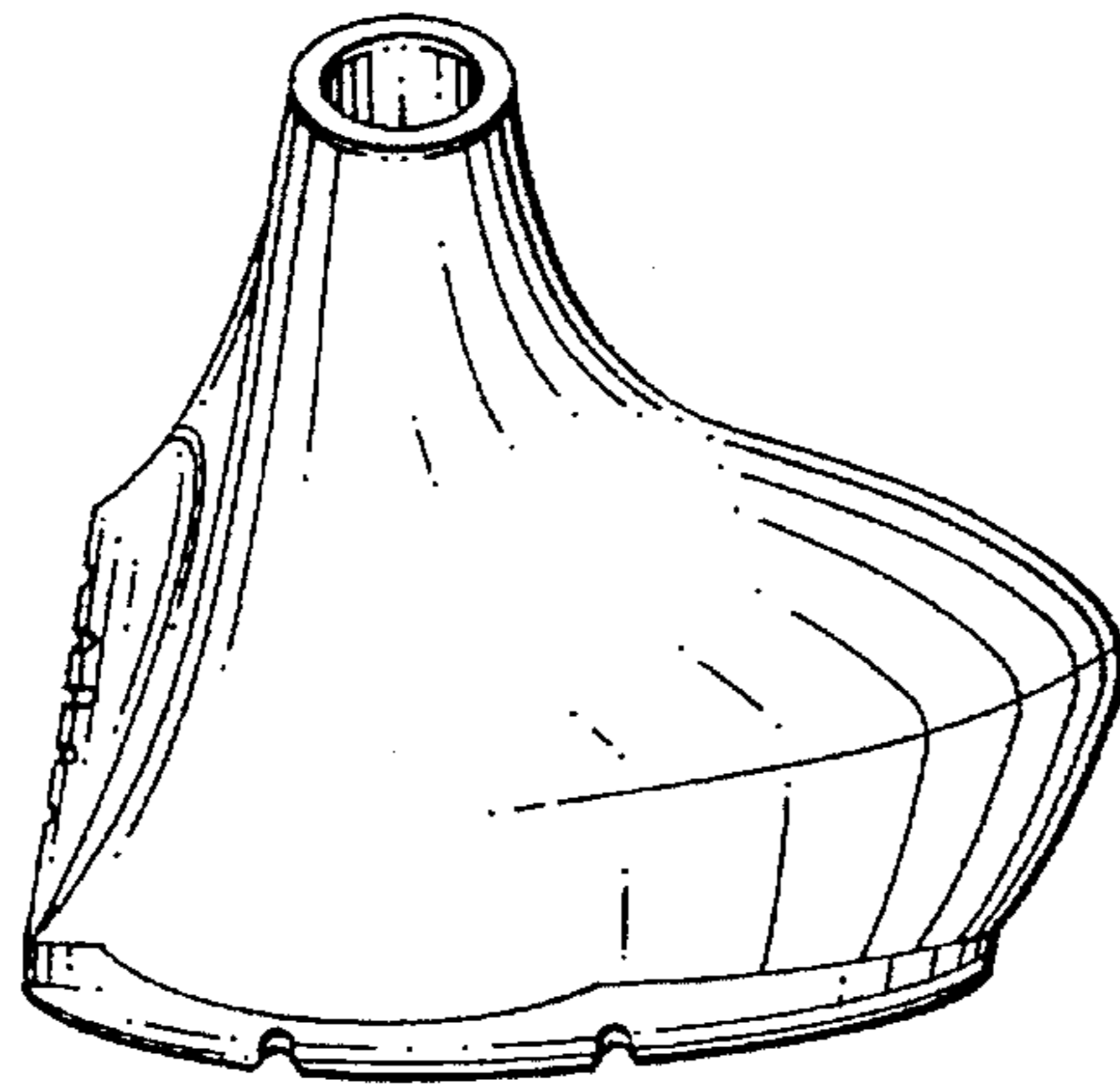

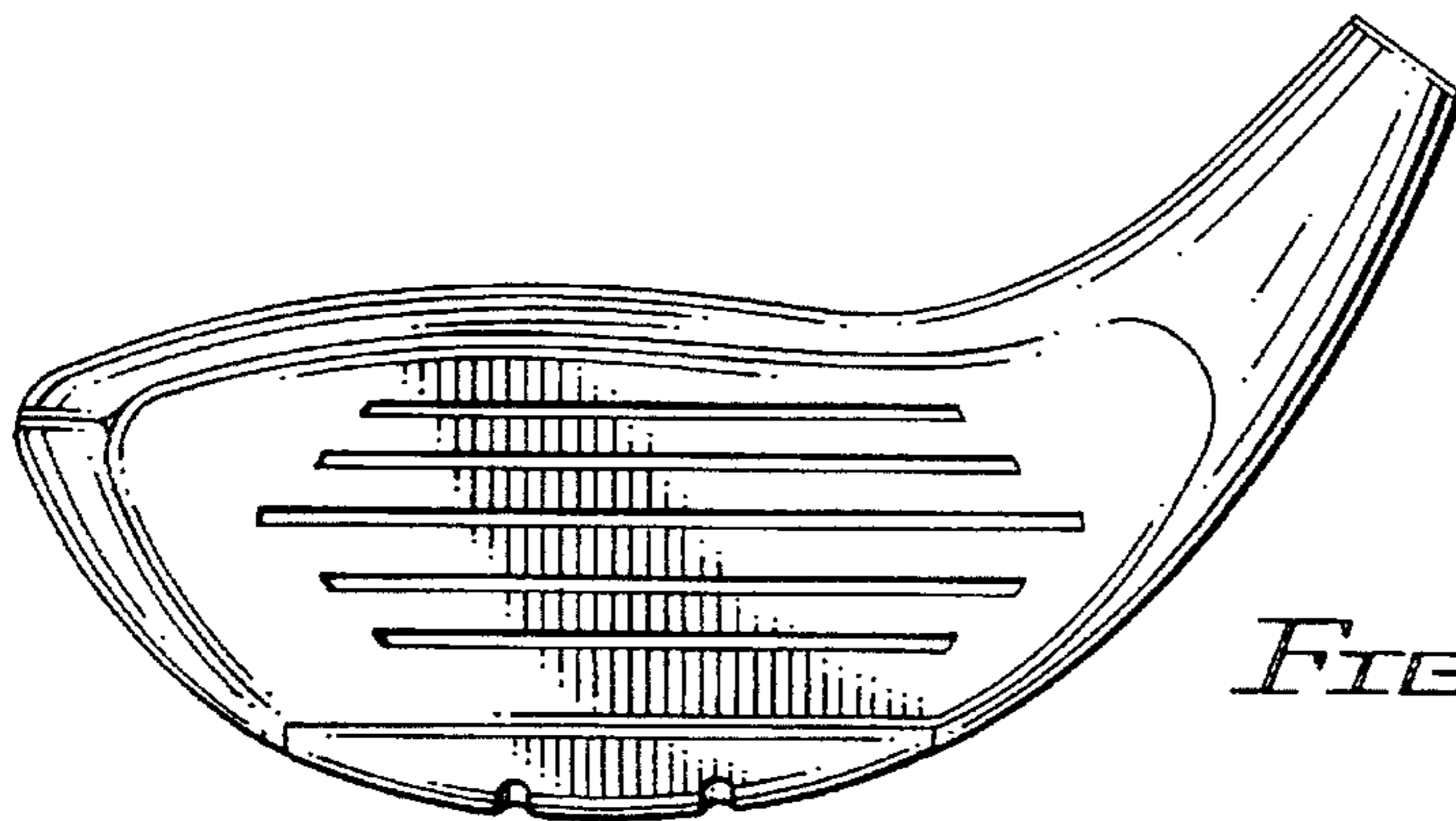

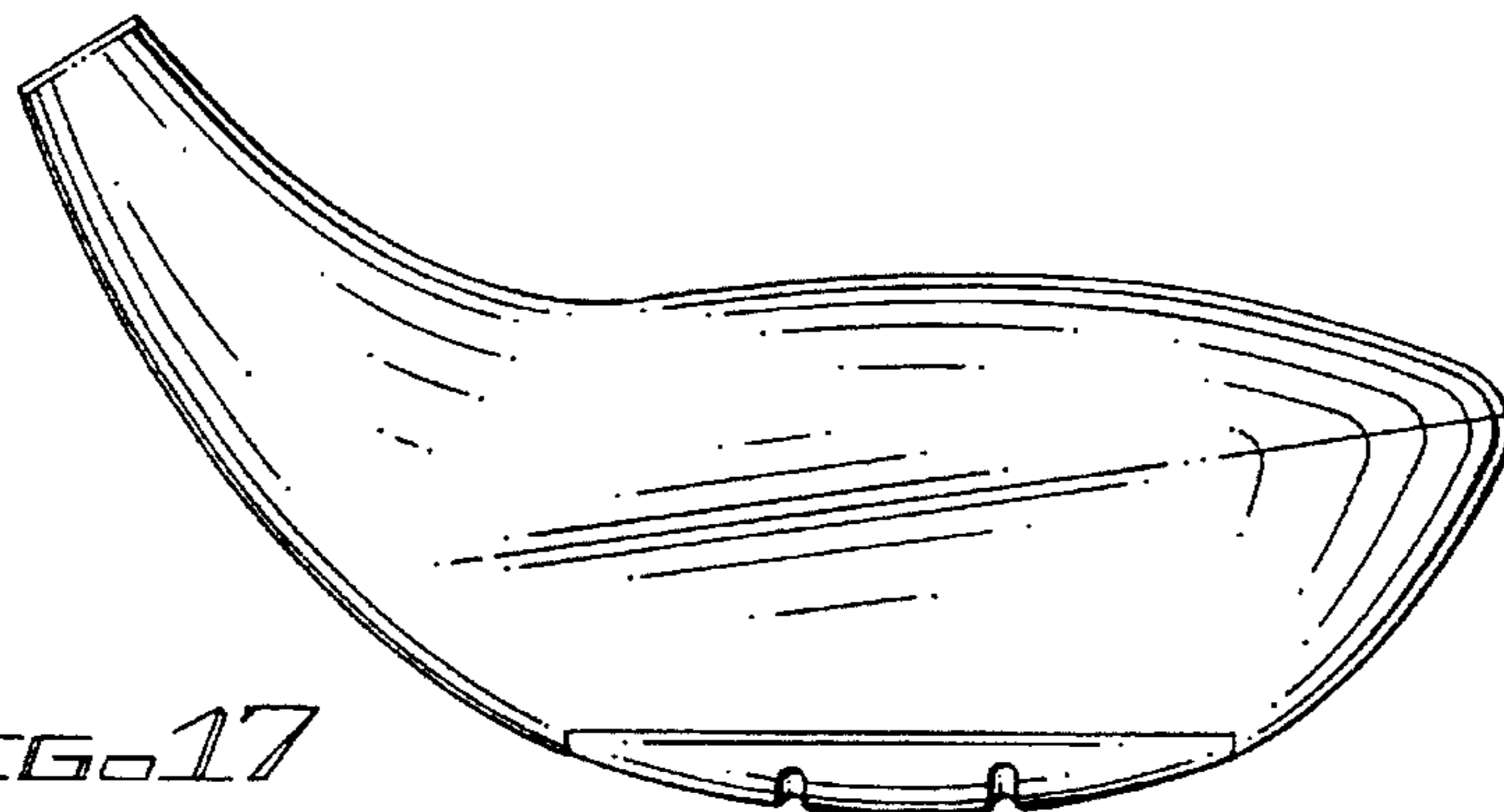
