FIG. 2 is a perspective front view, showing the securing member in an encircling position approximating its position in use;

FIG. 3 is a perspective view showing the infant protection sleep wrap in a position of use, the mattress and infant shown in dotted lines are for illustrative purposes only forming no part of the present design;

FIG. 4 is a perspective rear view of the infant protective sleep wrap;

FIG. 5 is a perspective front view of the infant protective sleep wrap in a position of use;

FIG. 6 is a side elevation view of the infant protective sleep wrap;

FIG. 7 is a side elevation view of the infant protective sleep wrap, with the securing member in an encircling position;

FIG. 8 is an end elevation view of the infant protective sleep wrap, with the securing member in an encircling position; and,

FIG. 9 is an end elevation view of the infant protective sleep wrap.

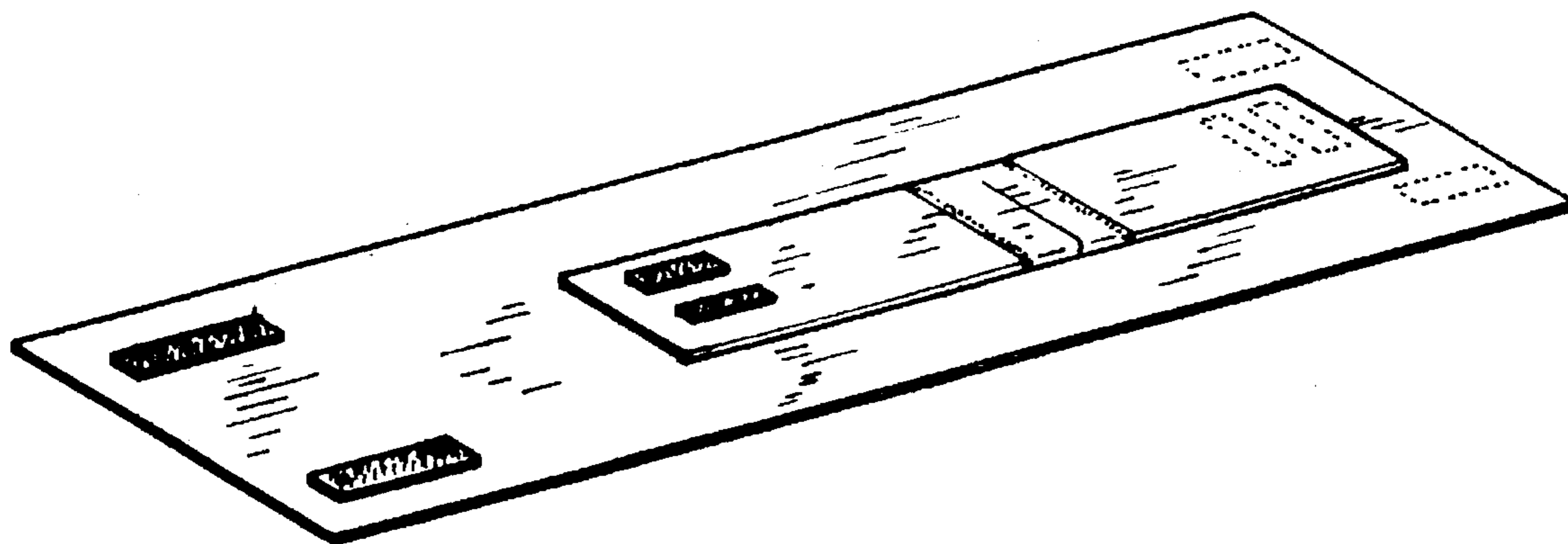

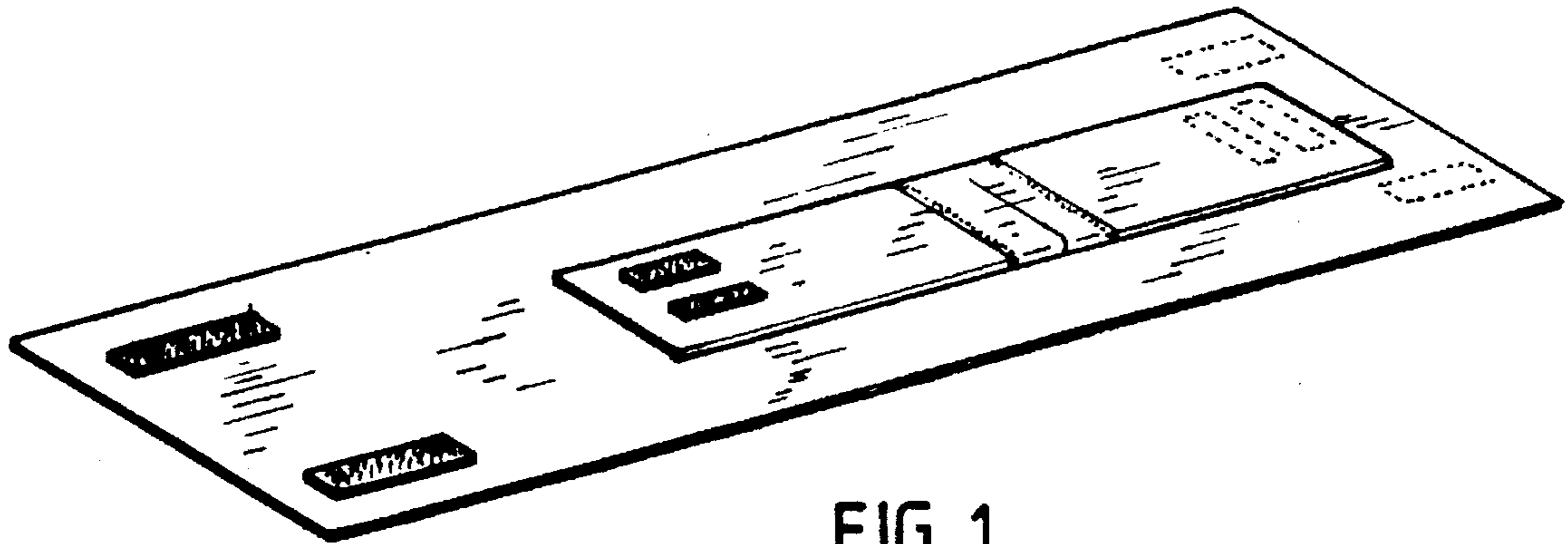

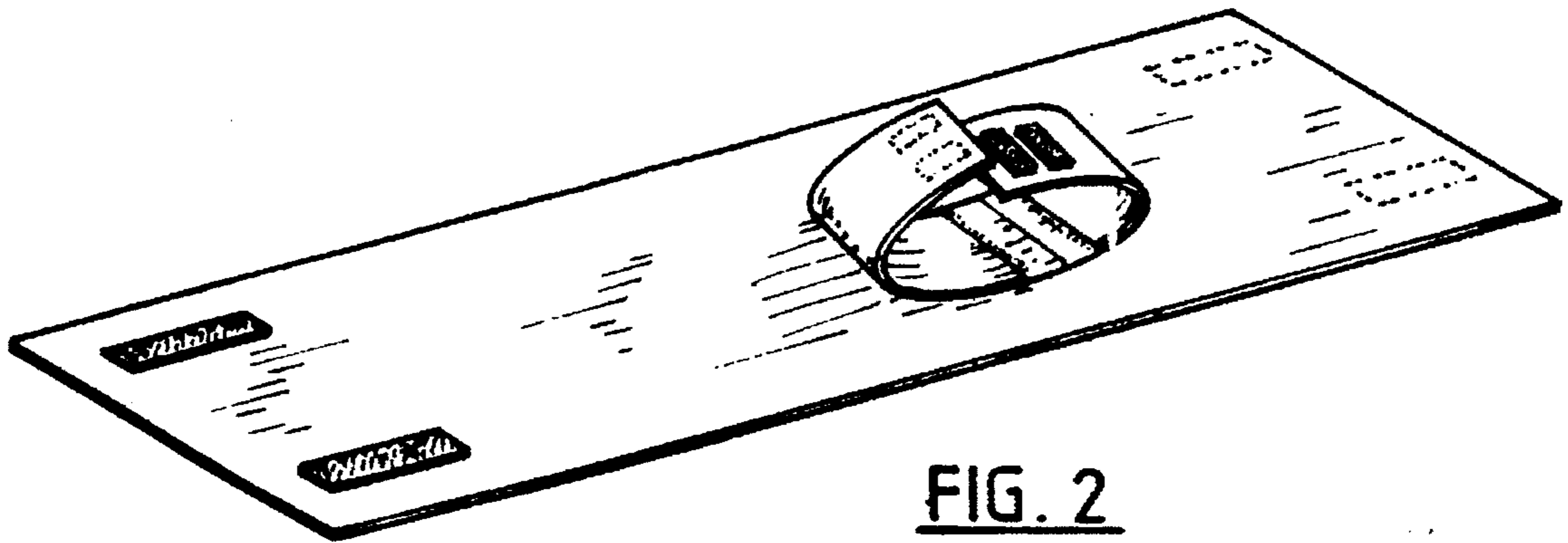

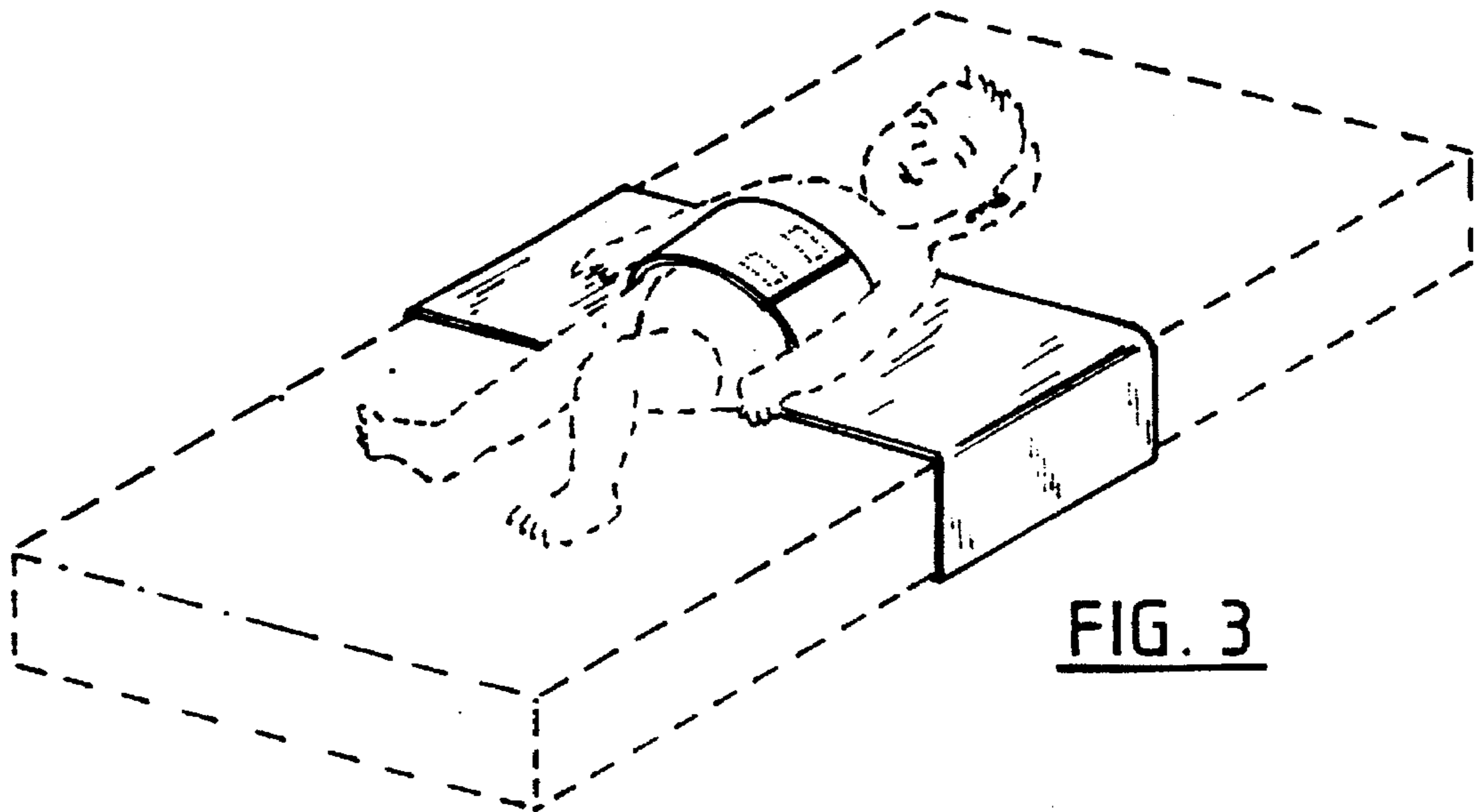

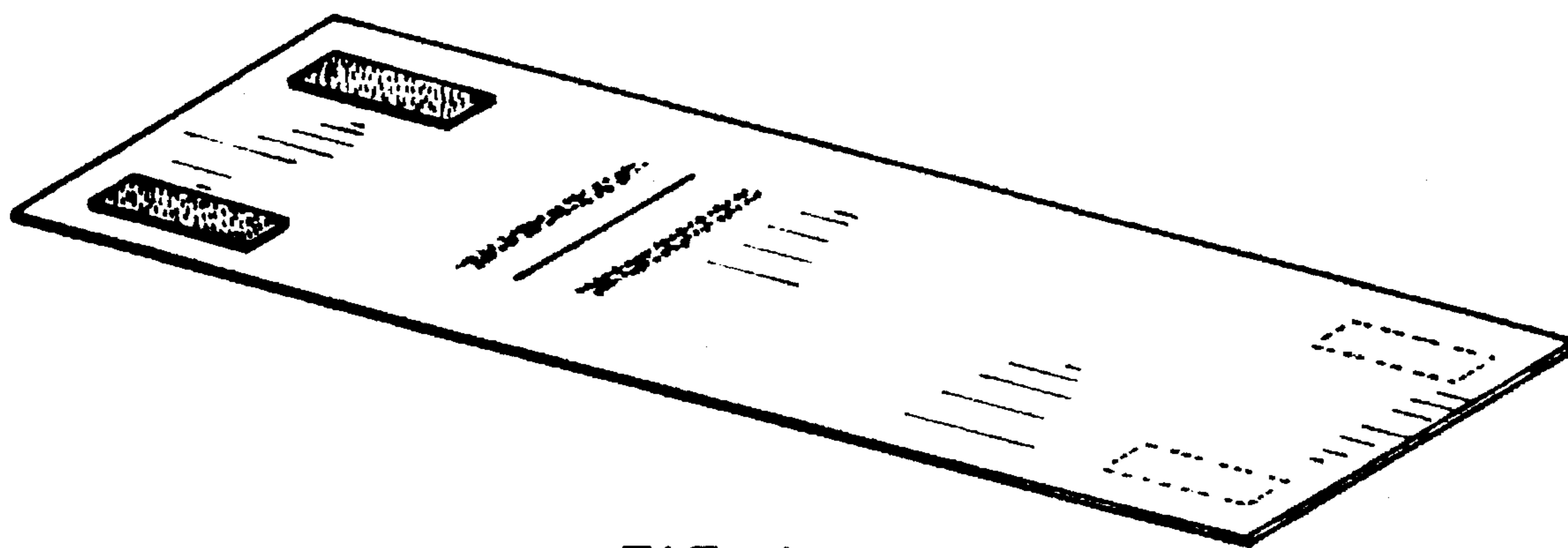

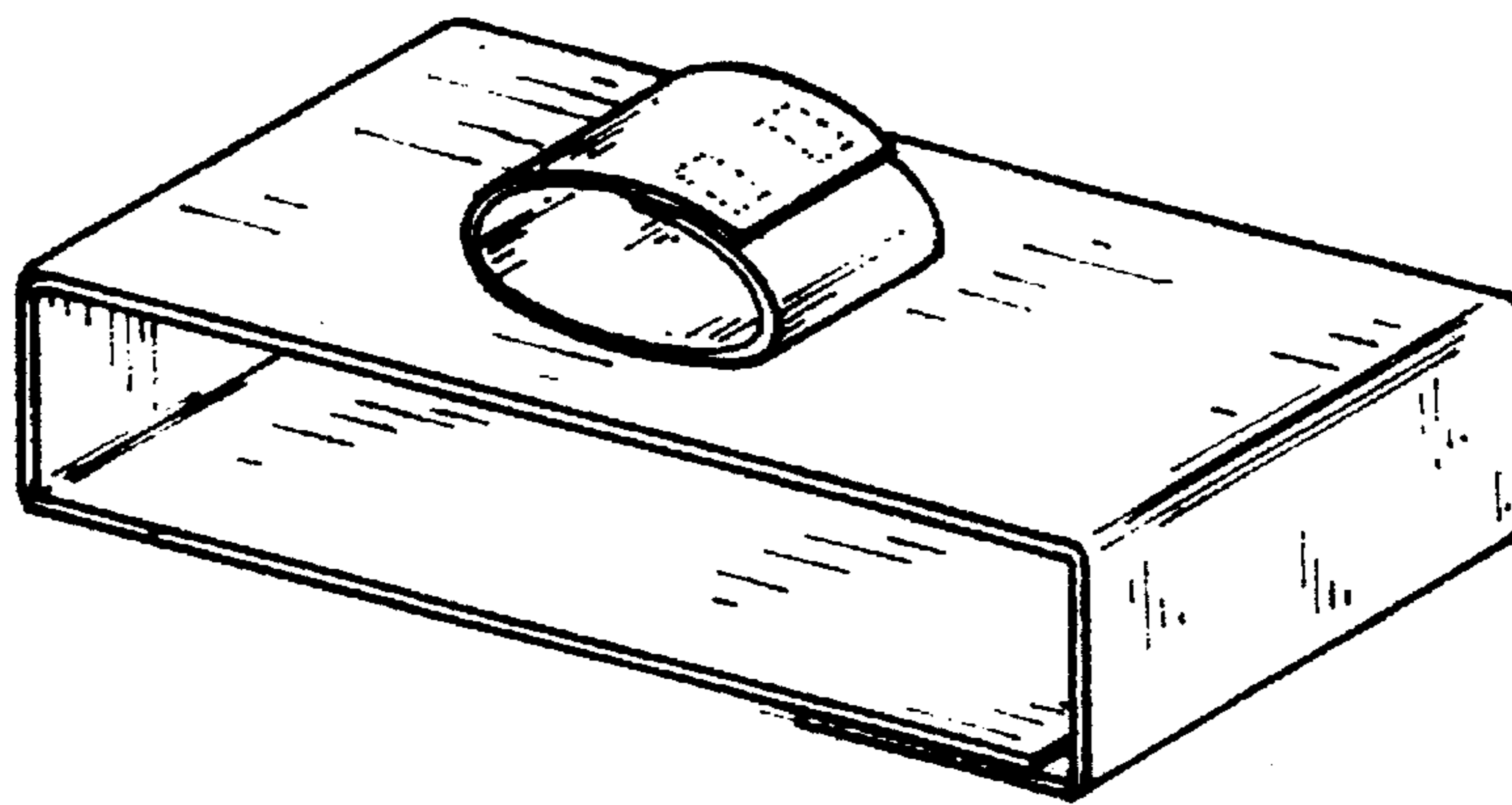

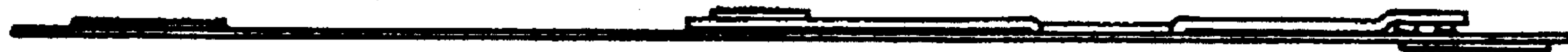

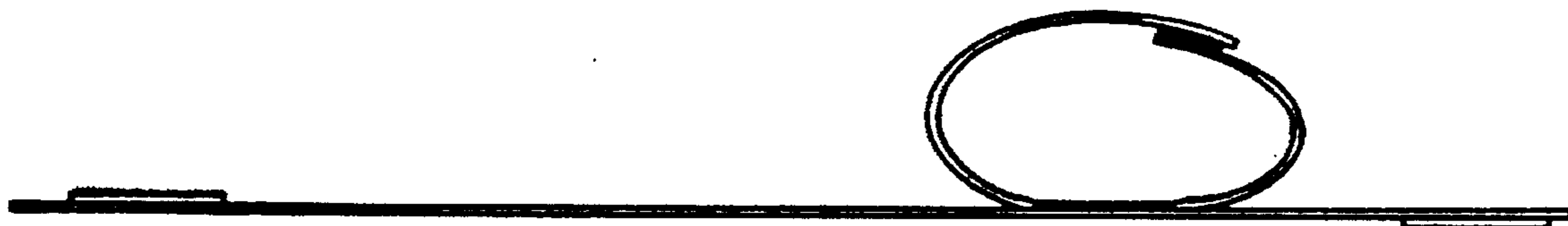

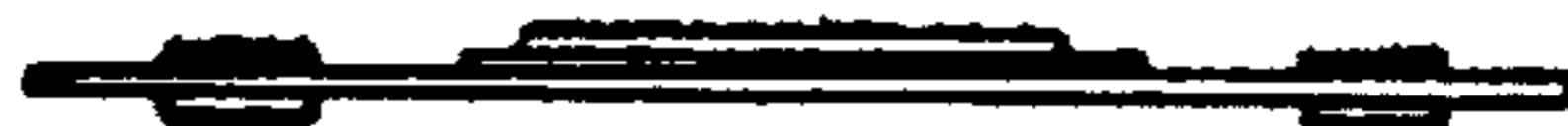

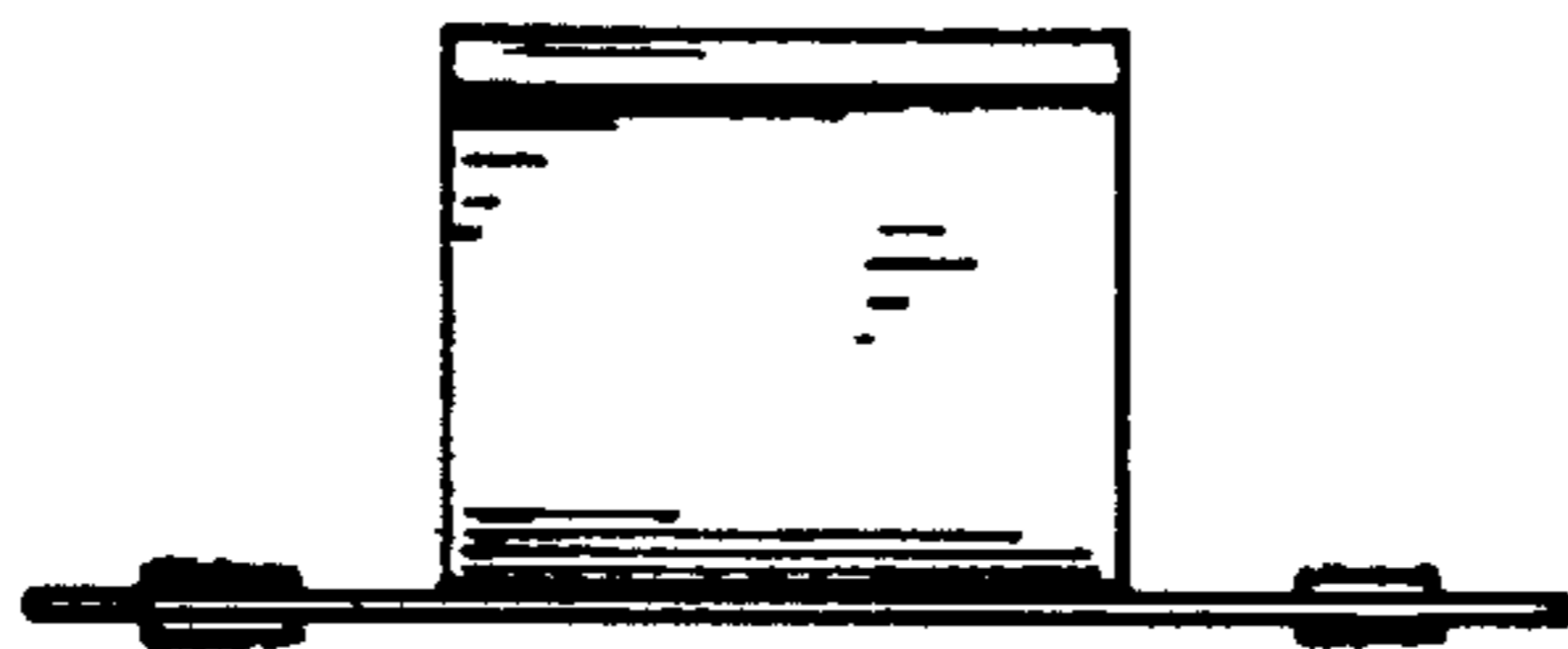
